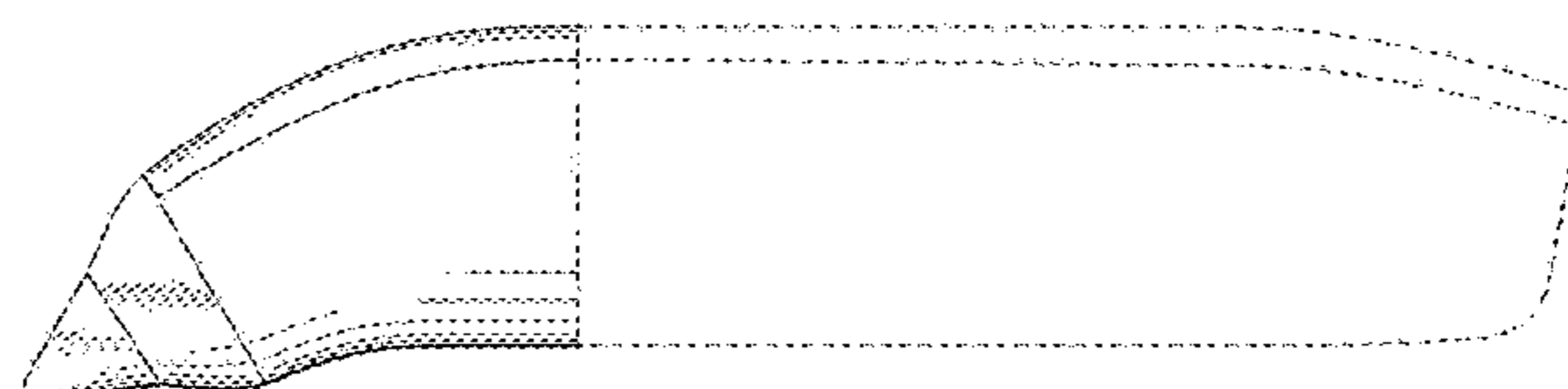
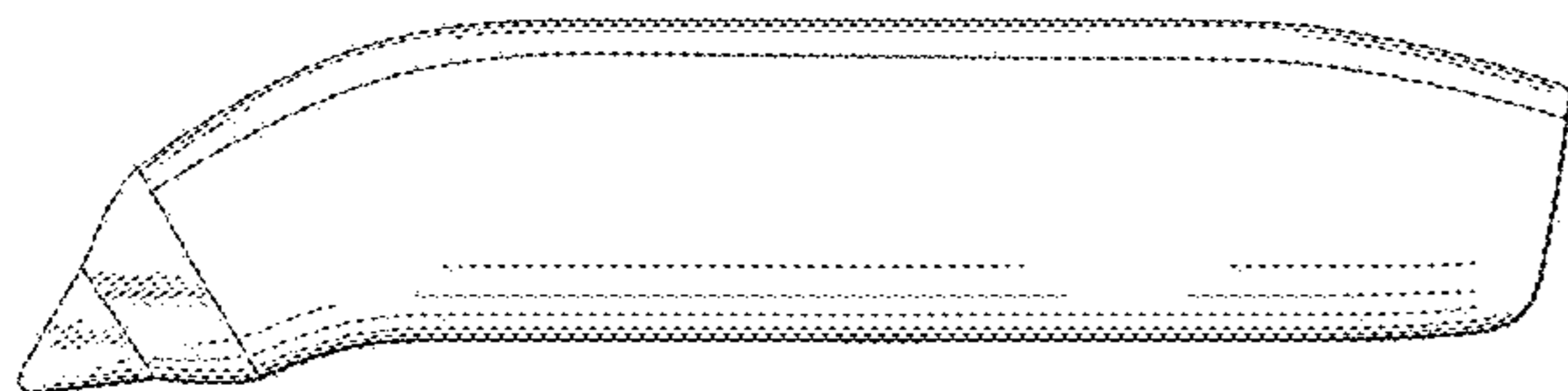
The ornamental design for a moxibustion instrument, as shown and described.

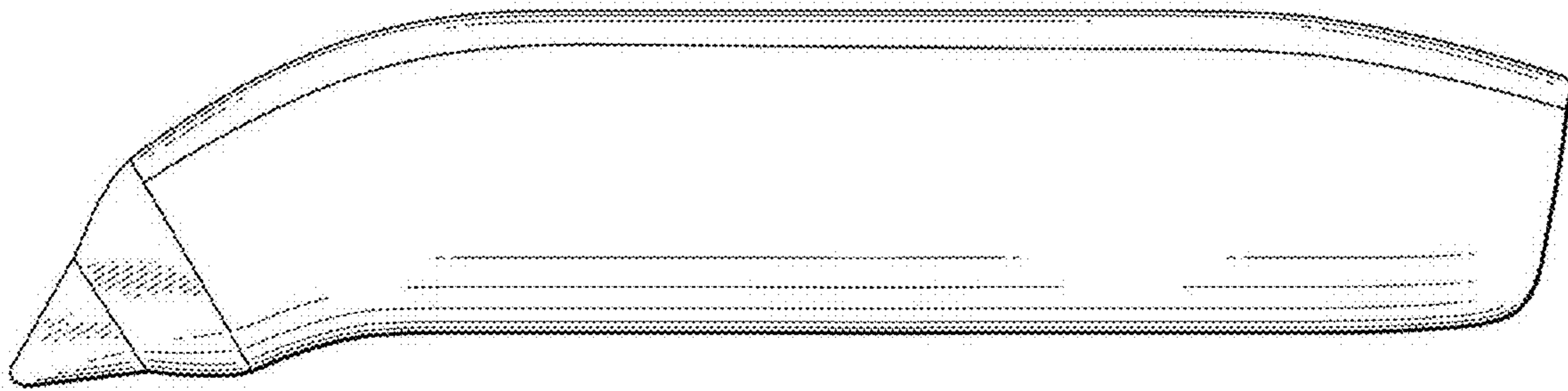

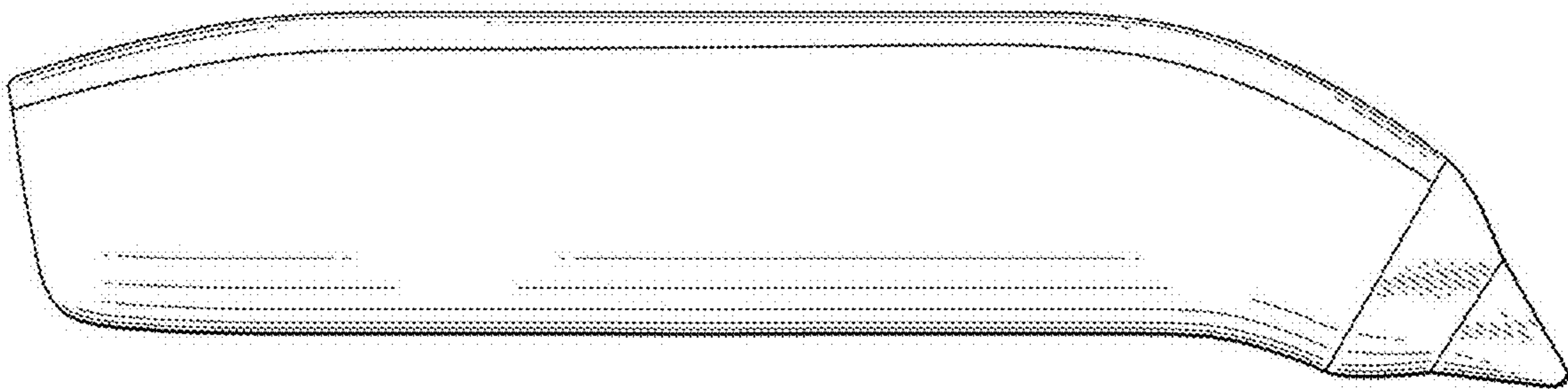

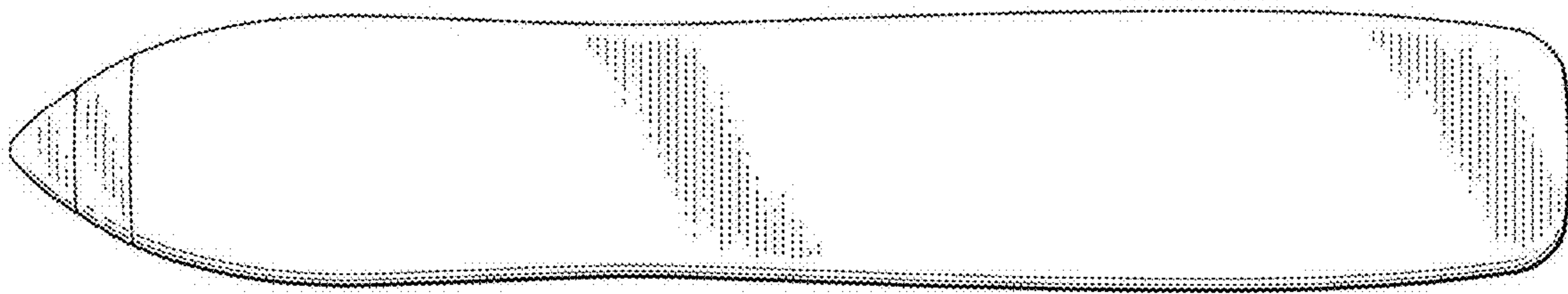

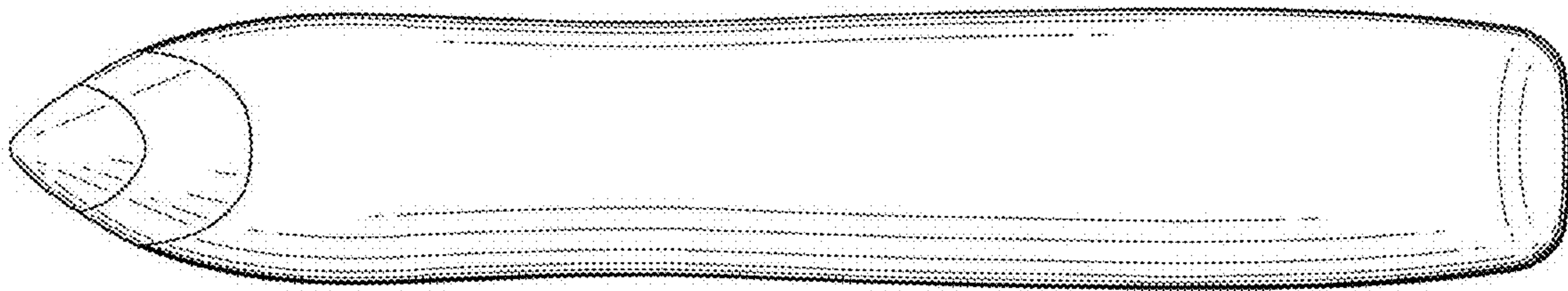

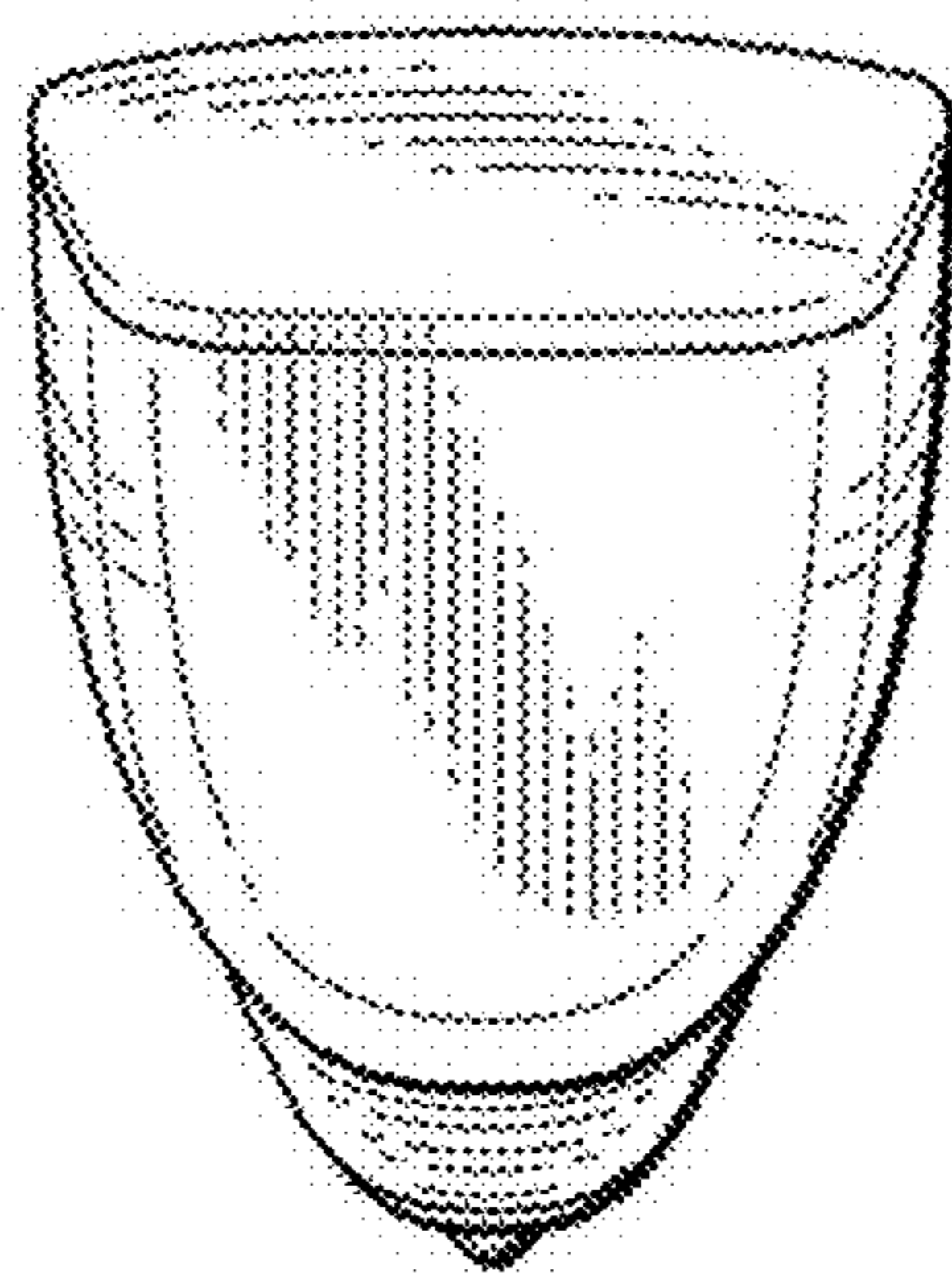

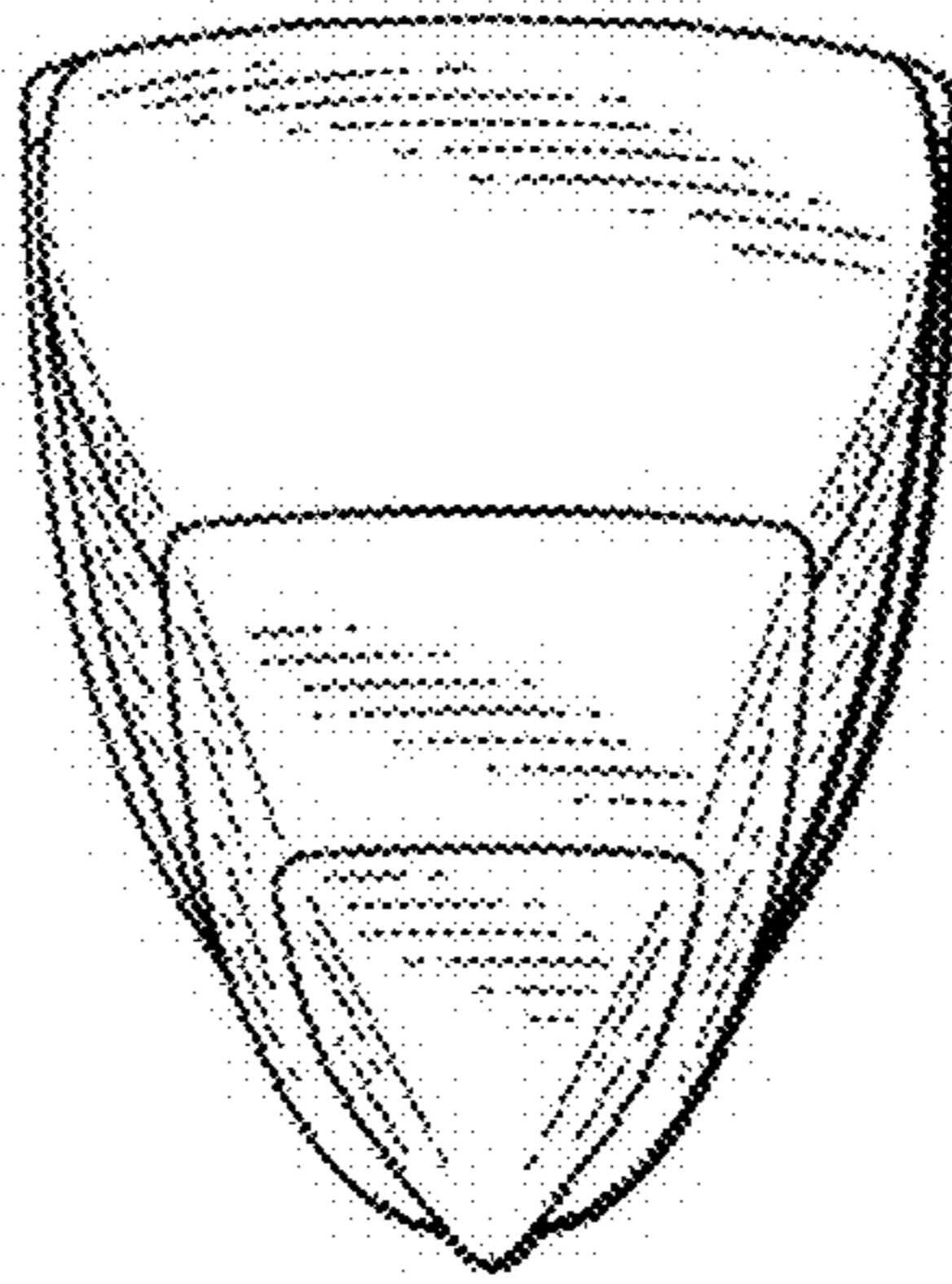

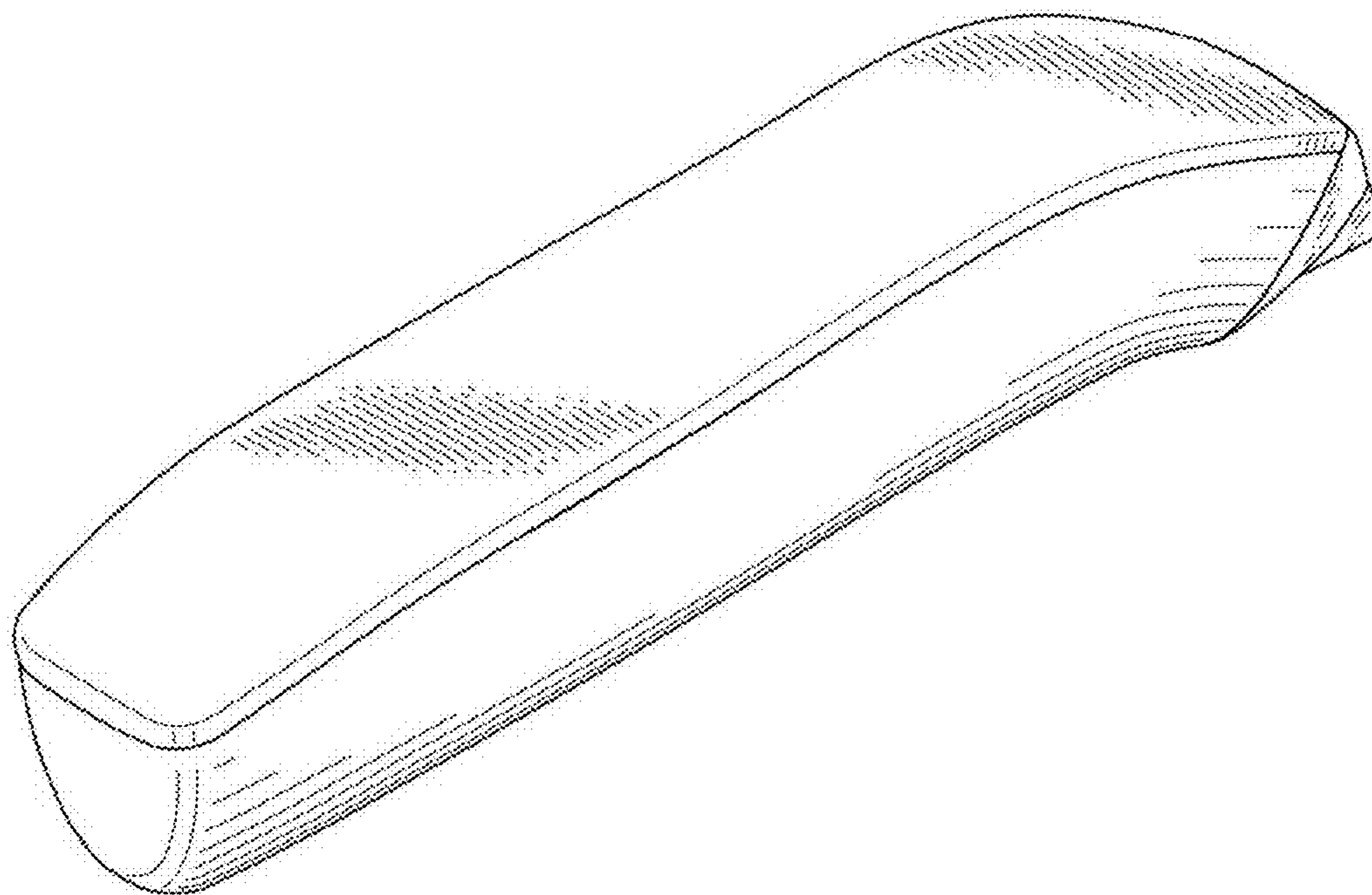

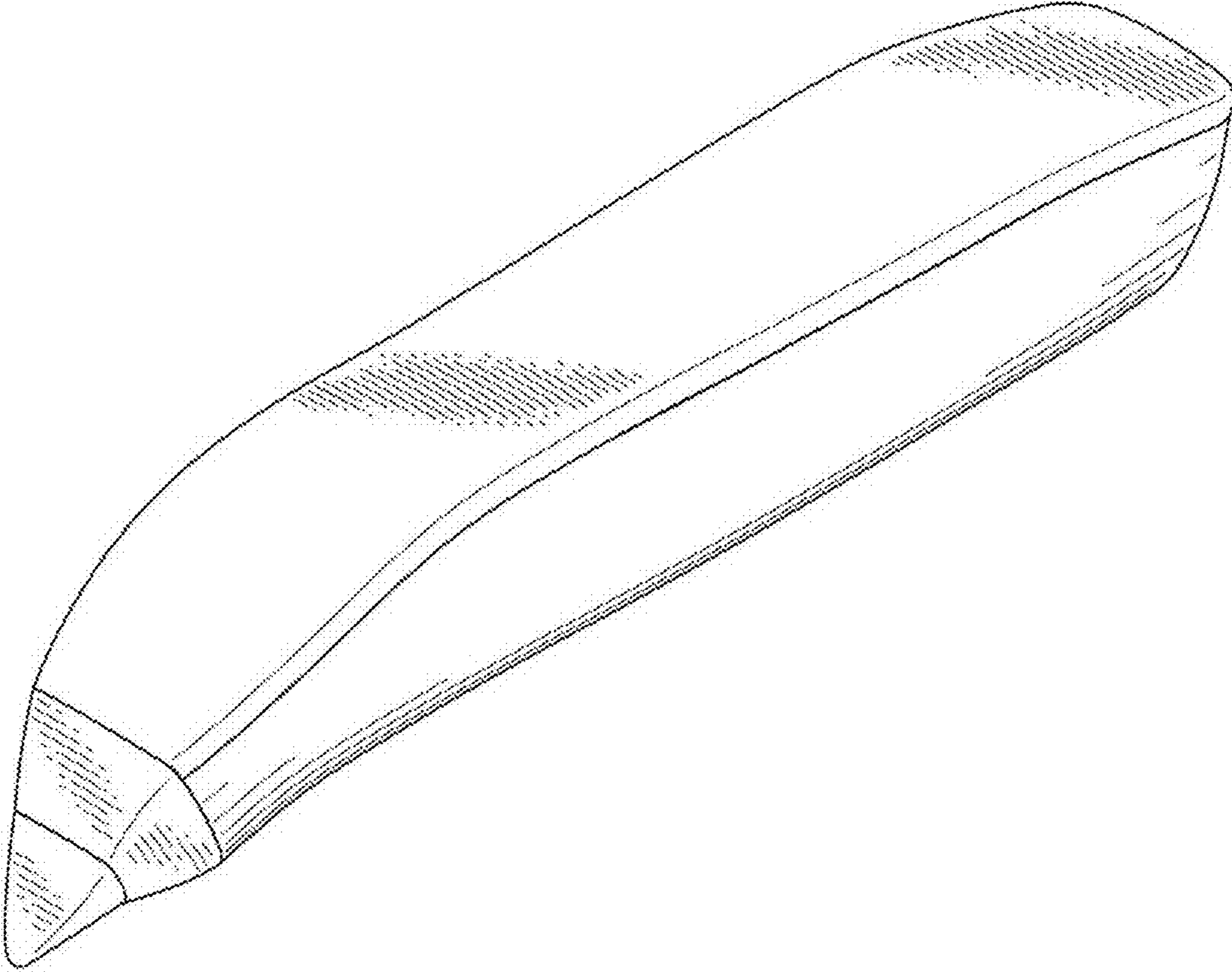

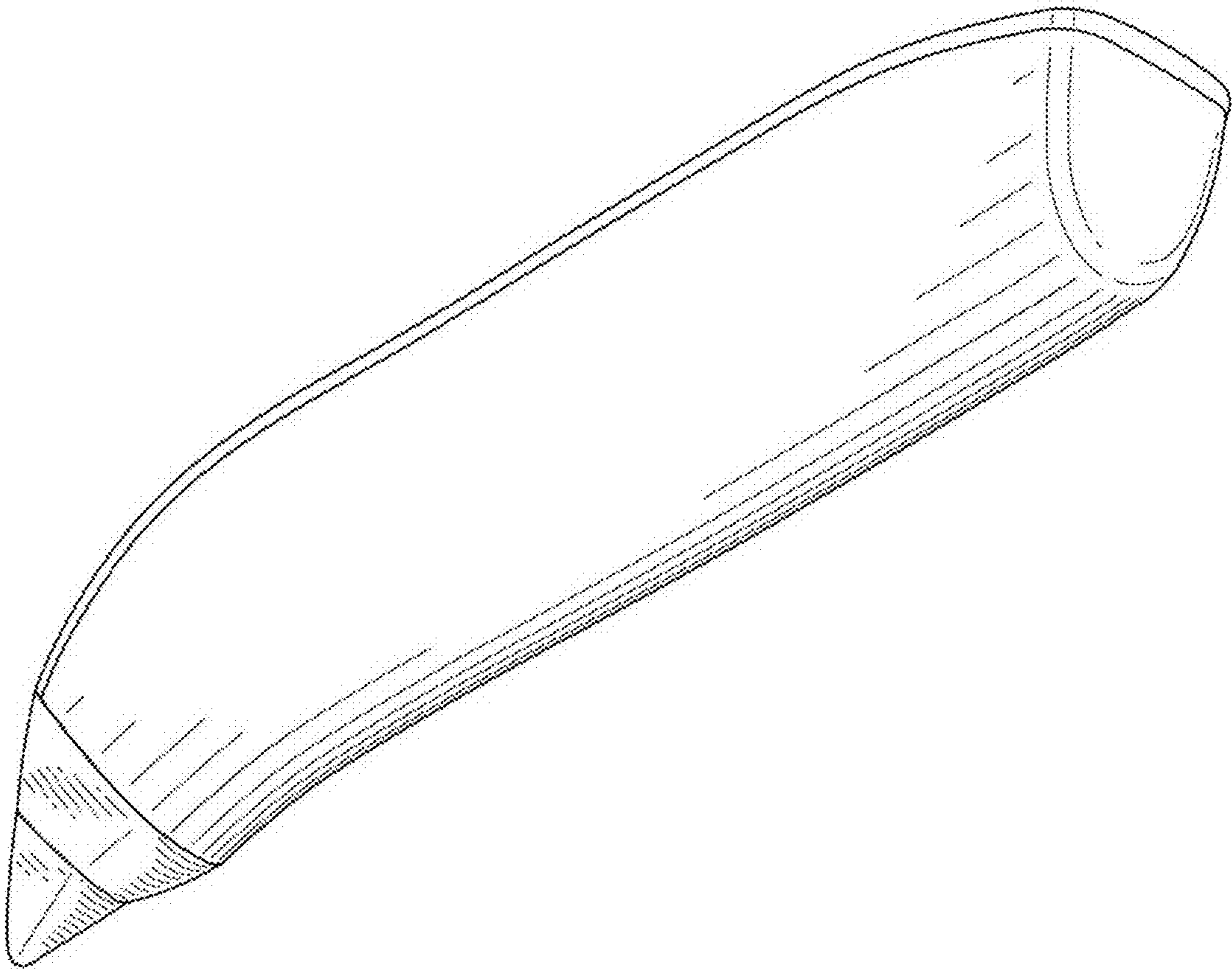

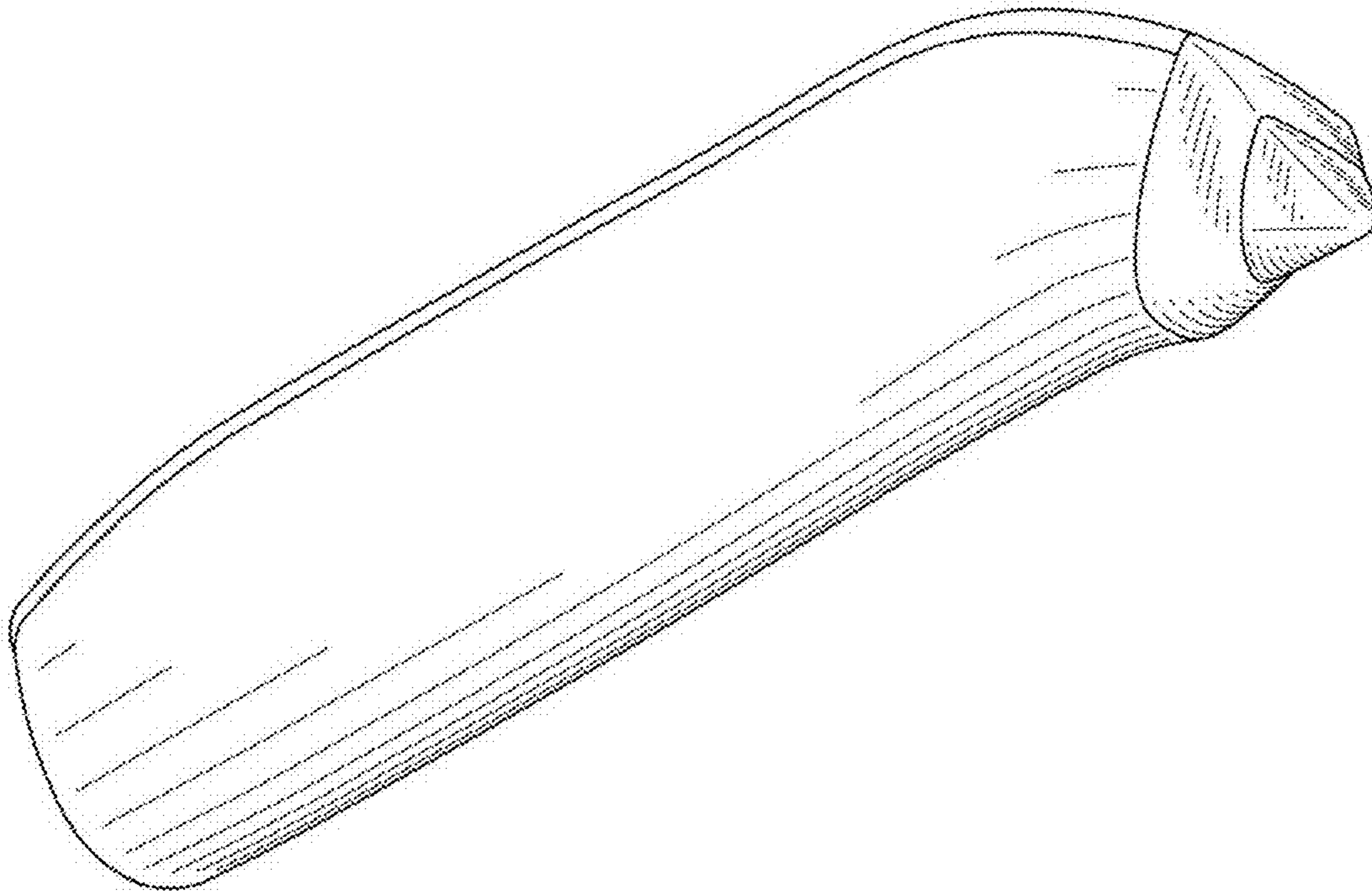

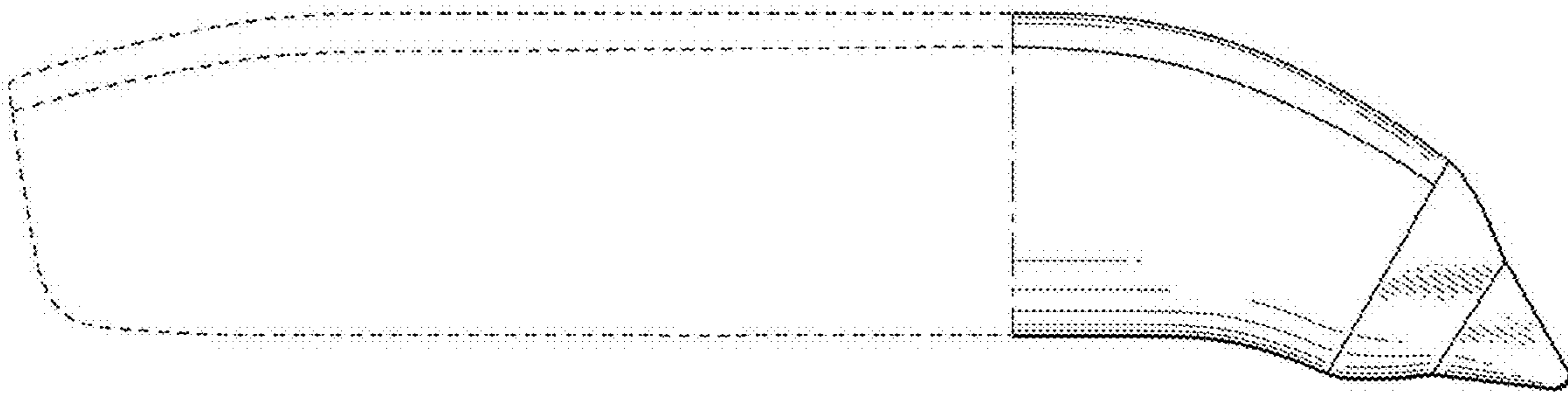

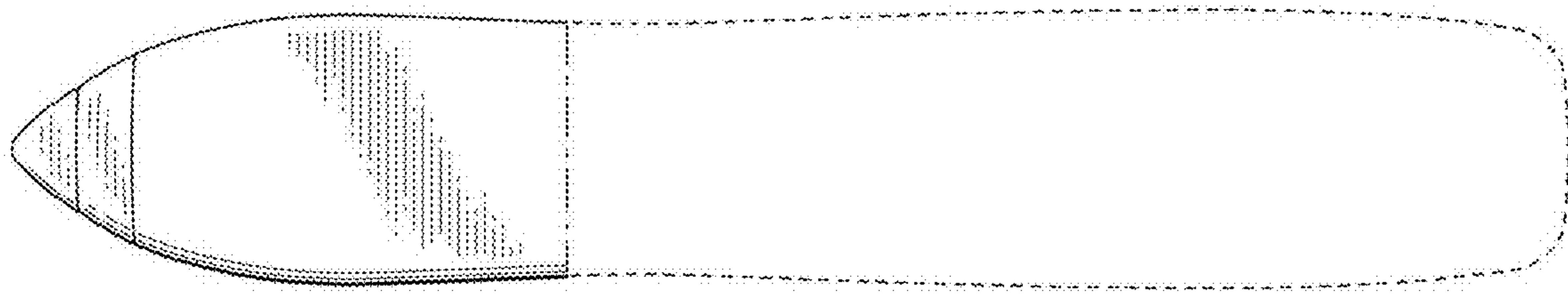

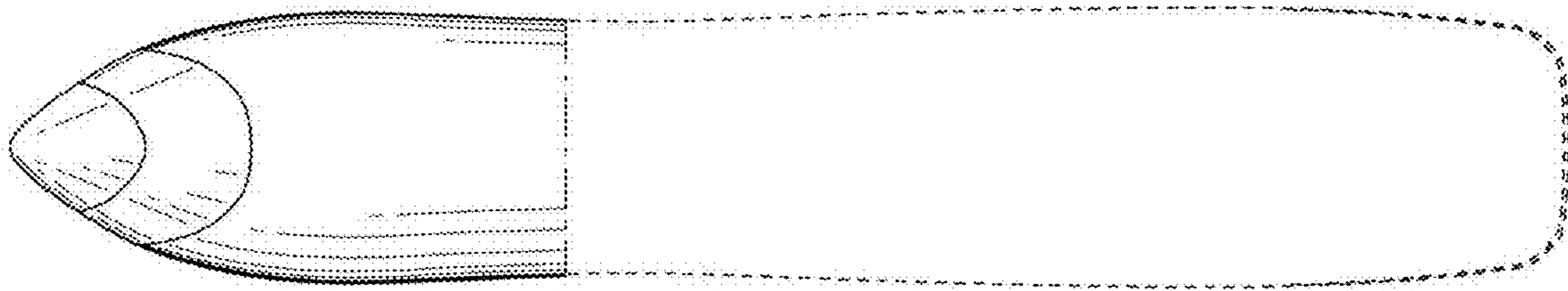

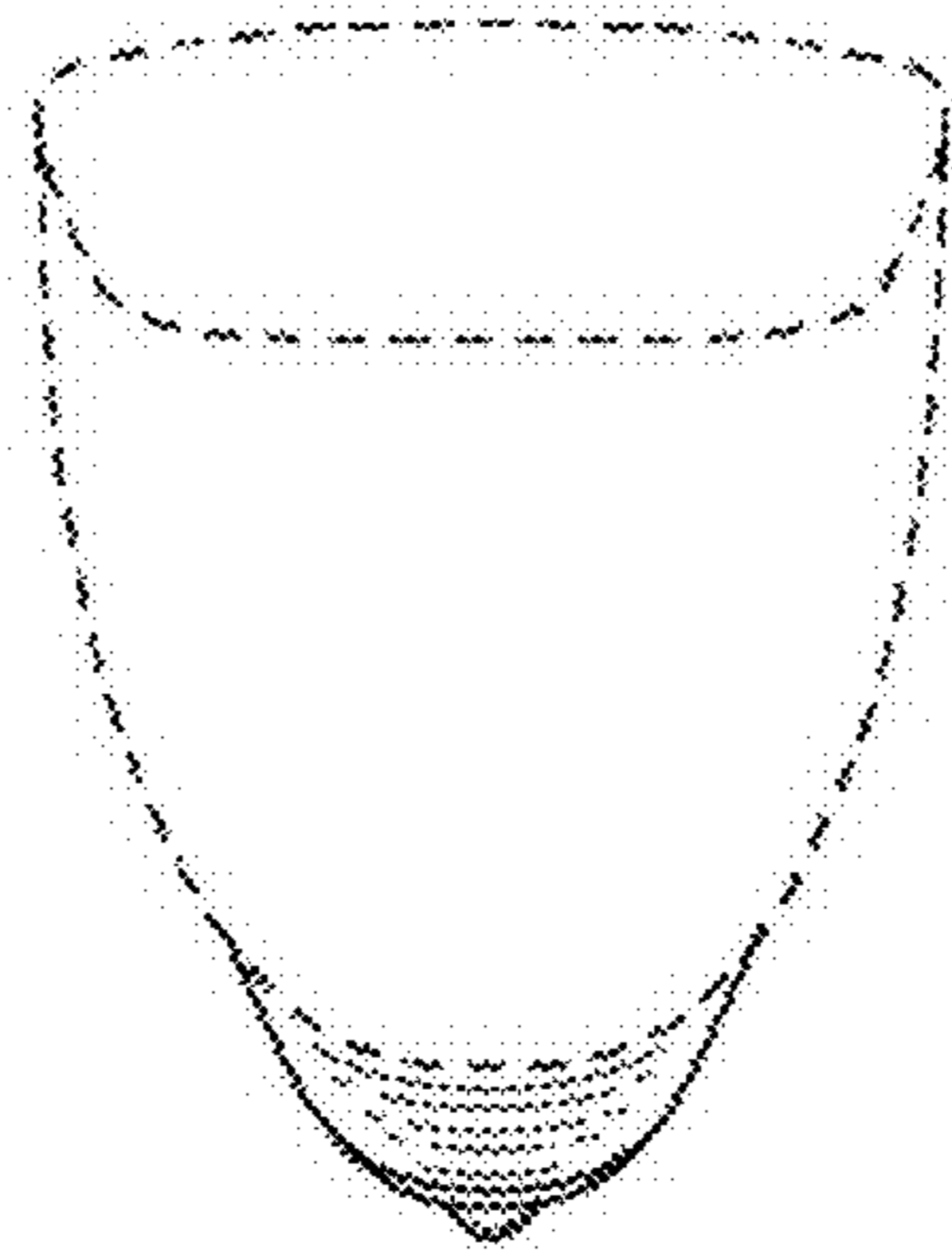

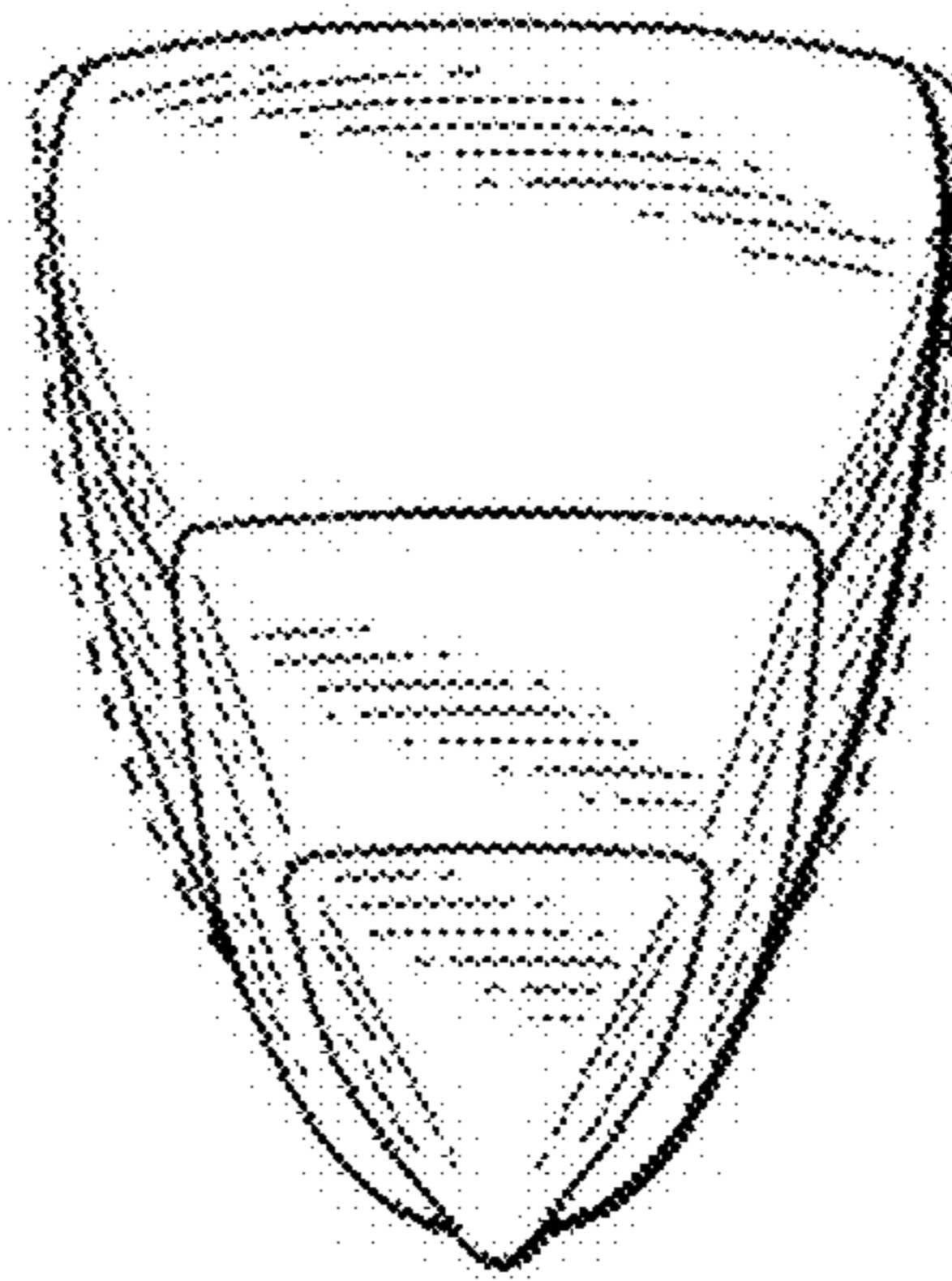

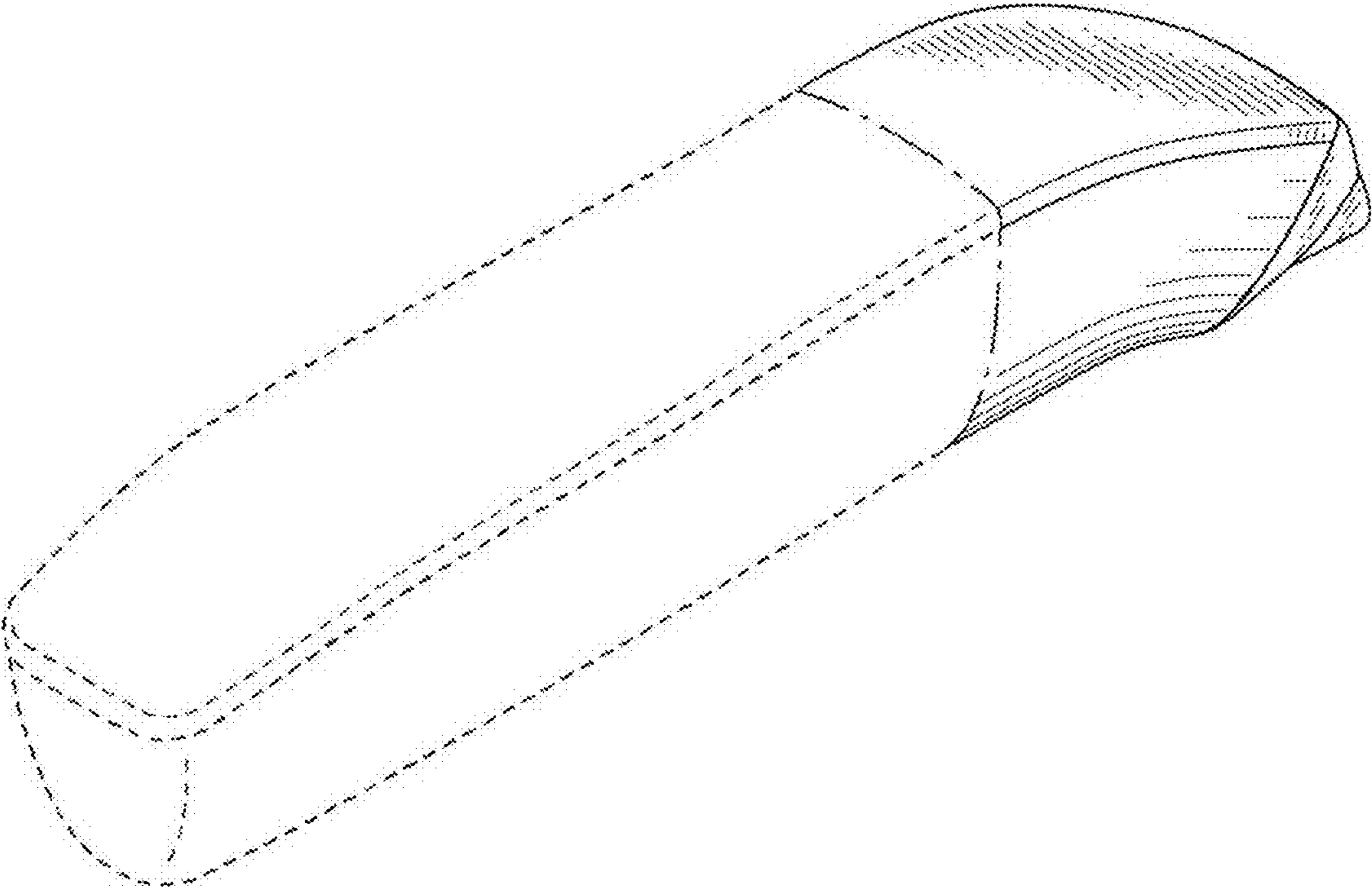

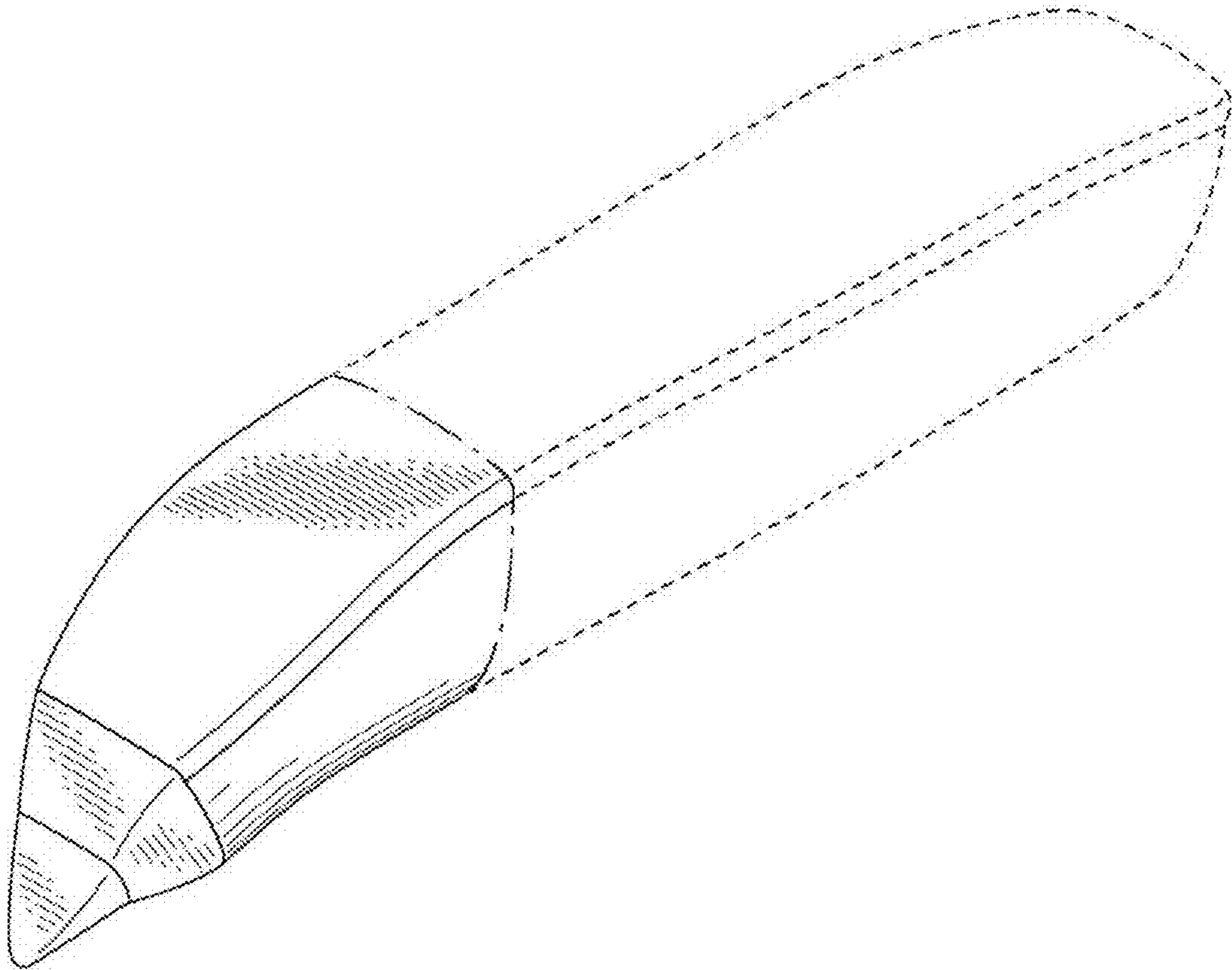
