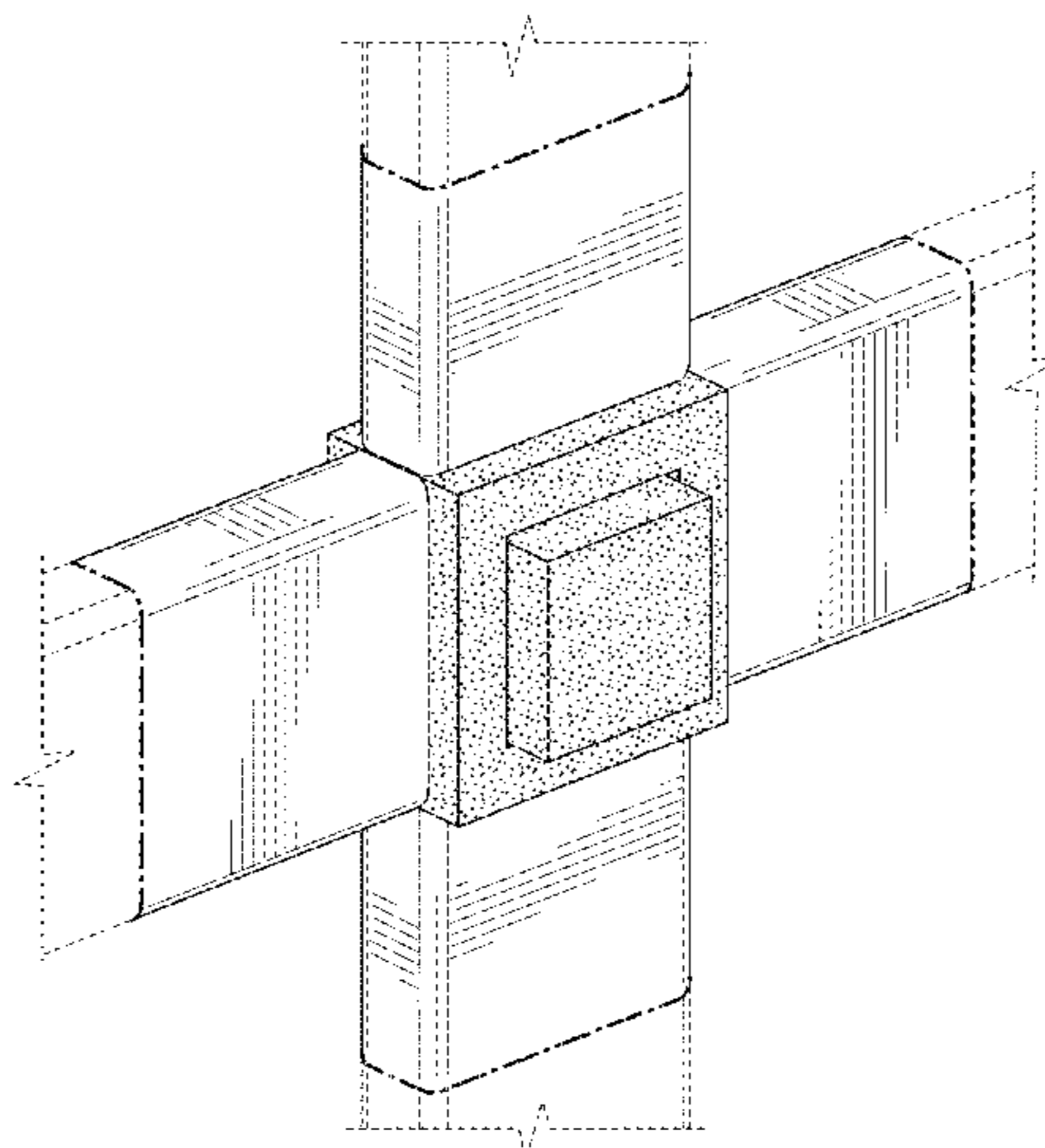


FIG. 17 is a perspective view of an insert for positioning between window panes showing still yet another embodiment of the new design in use with a window.

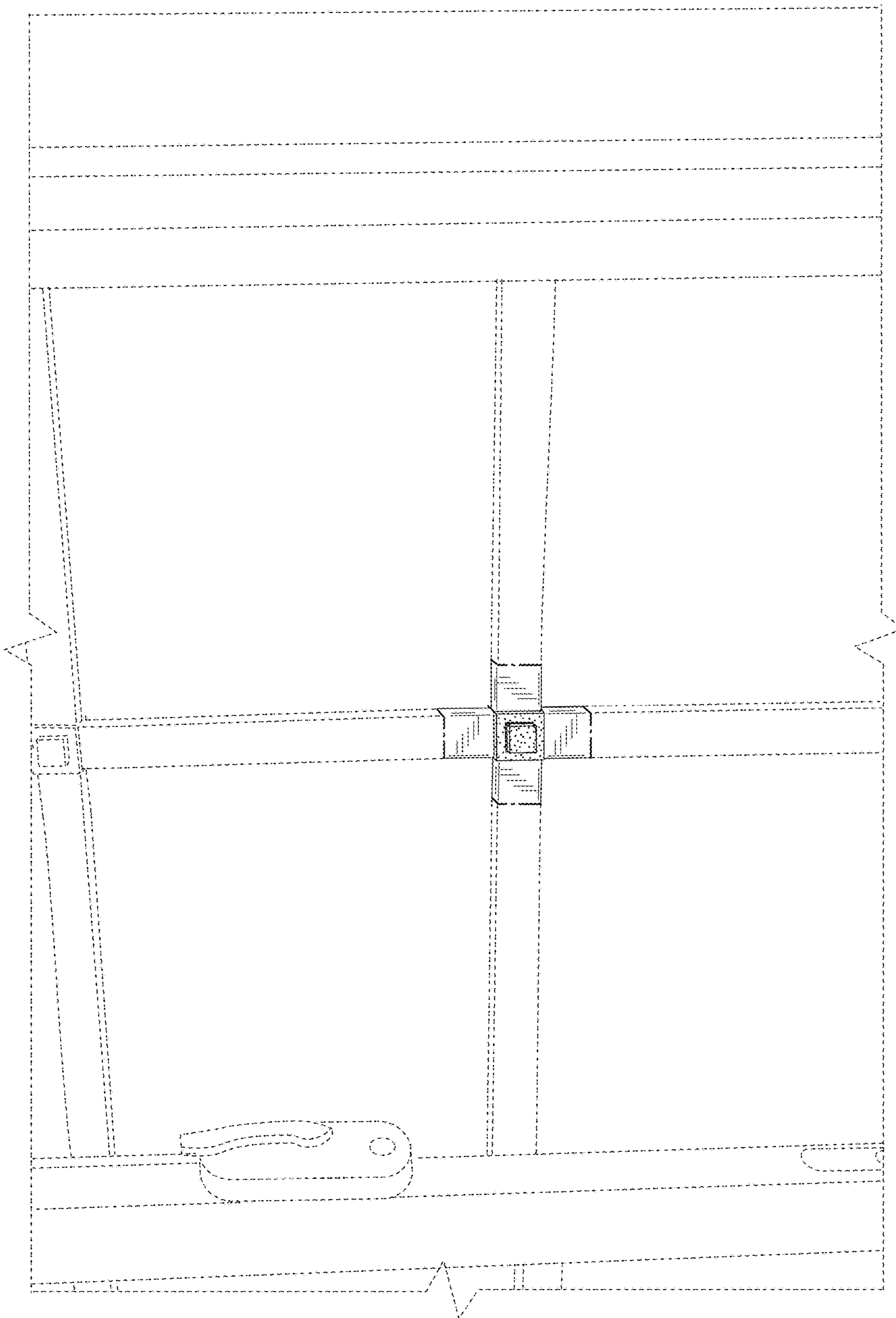

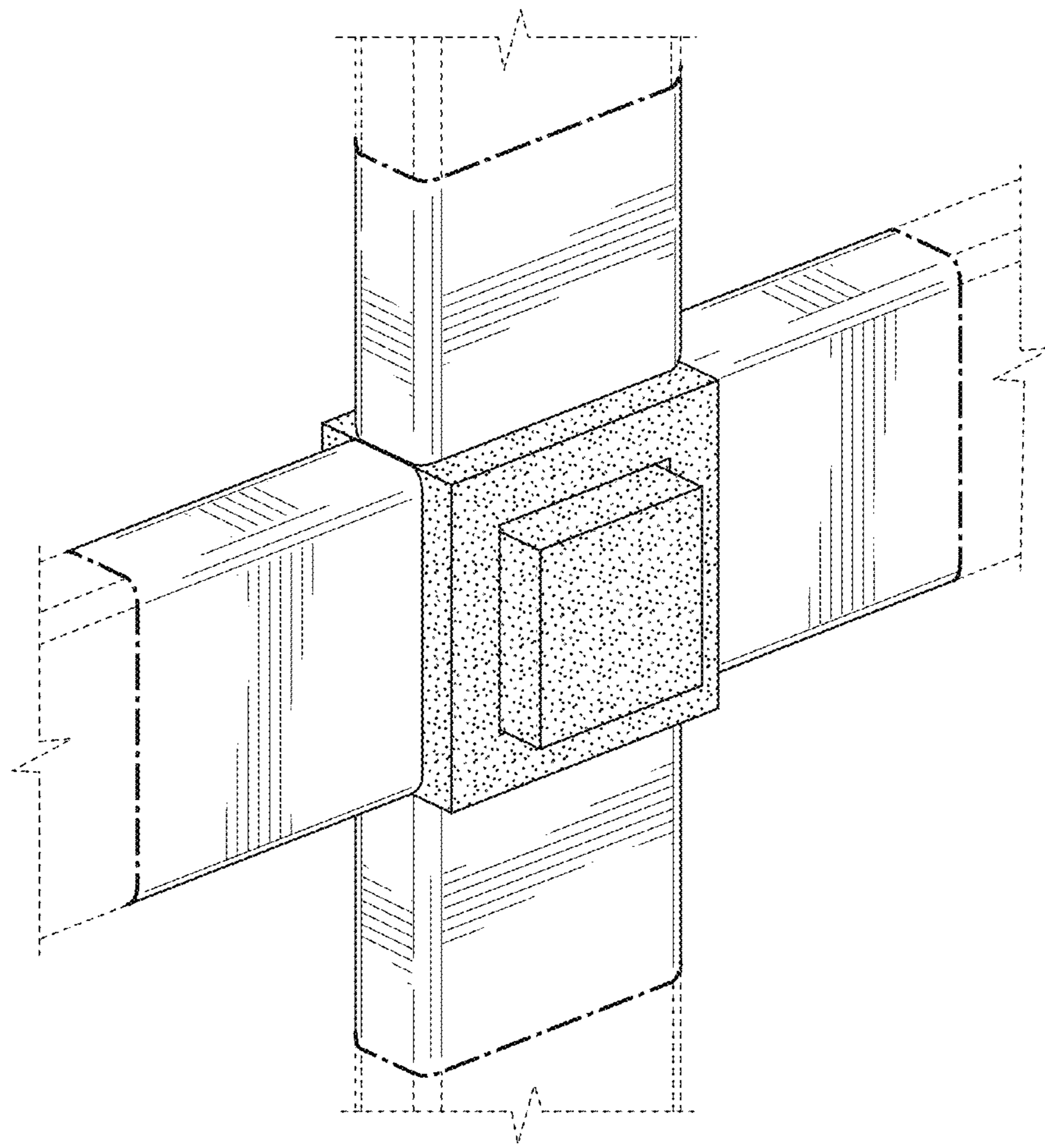
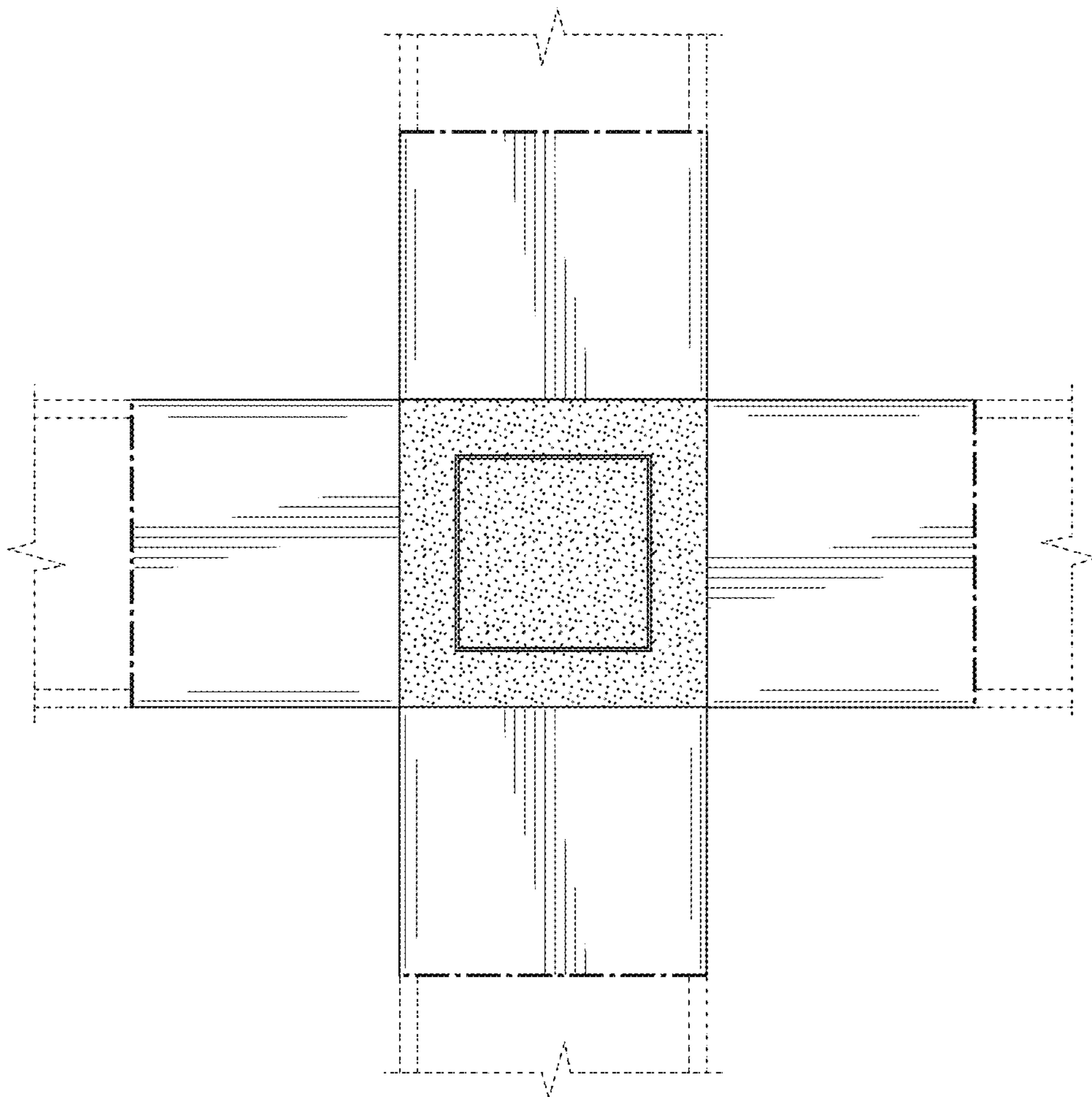
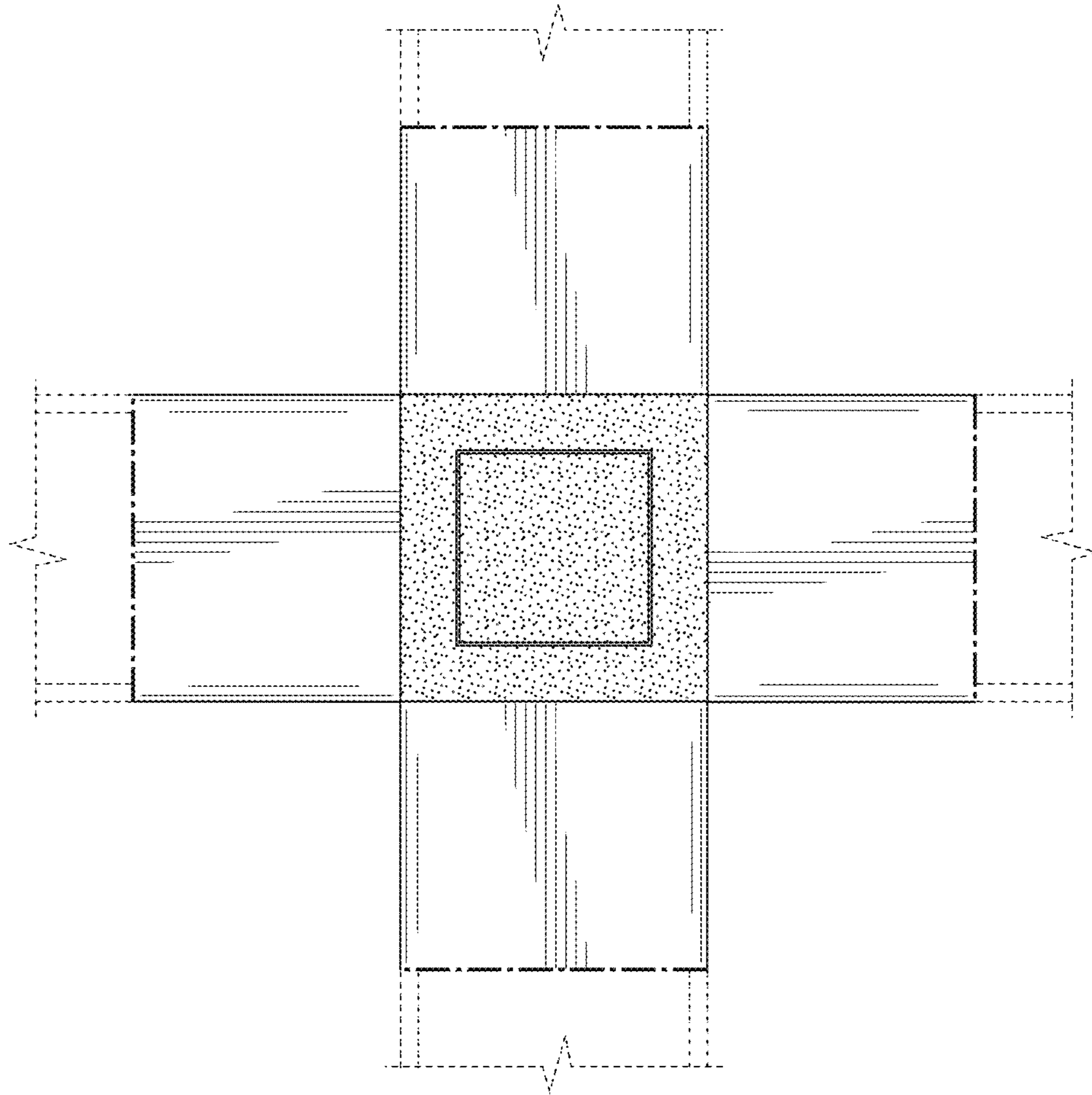

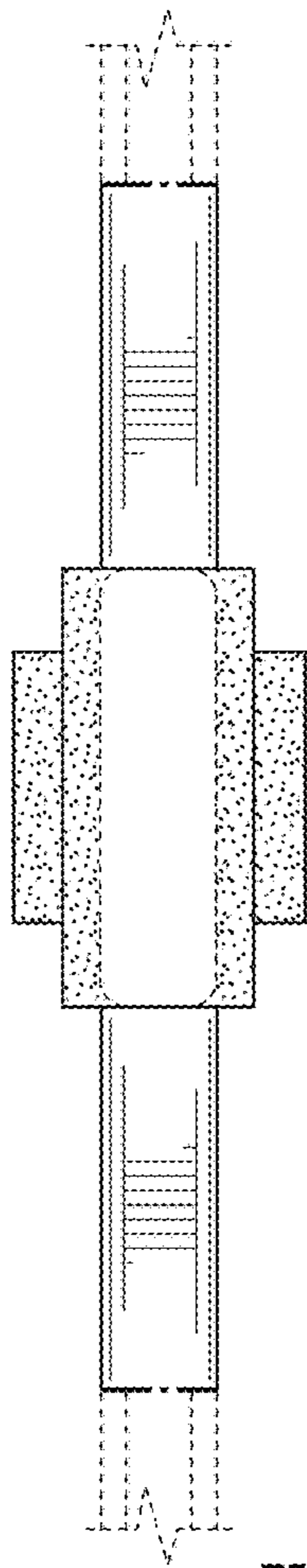

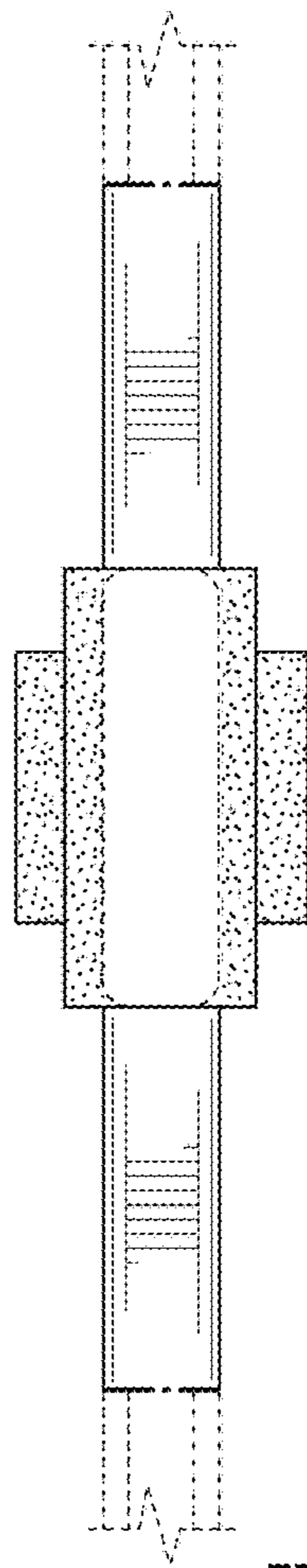

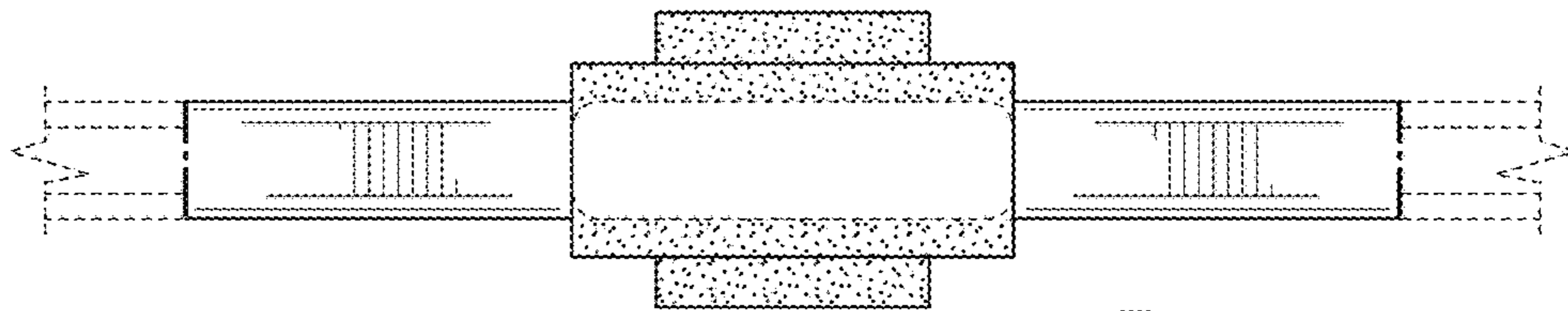

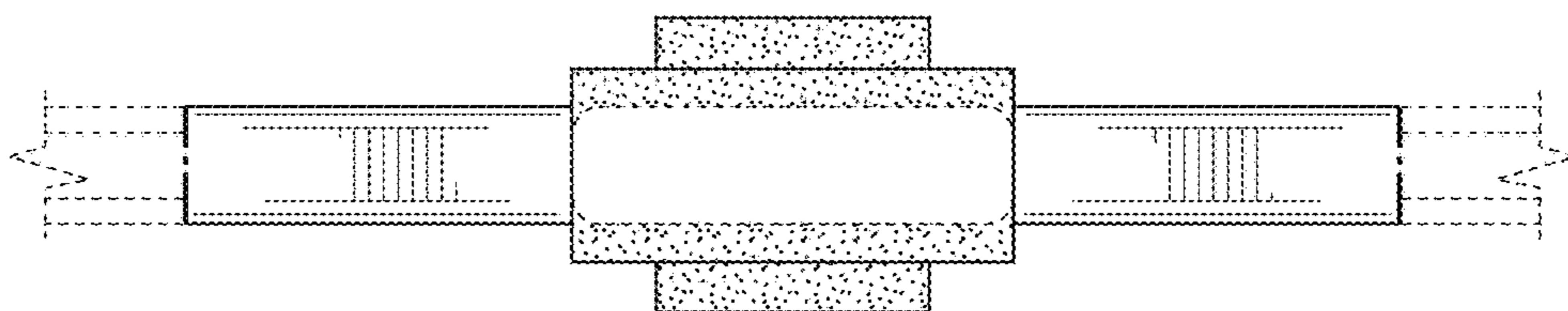

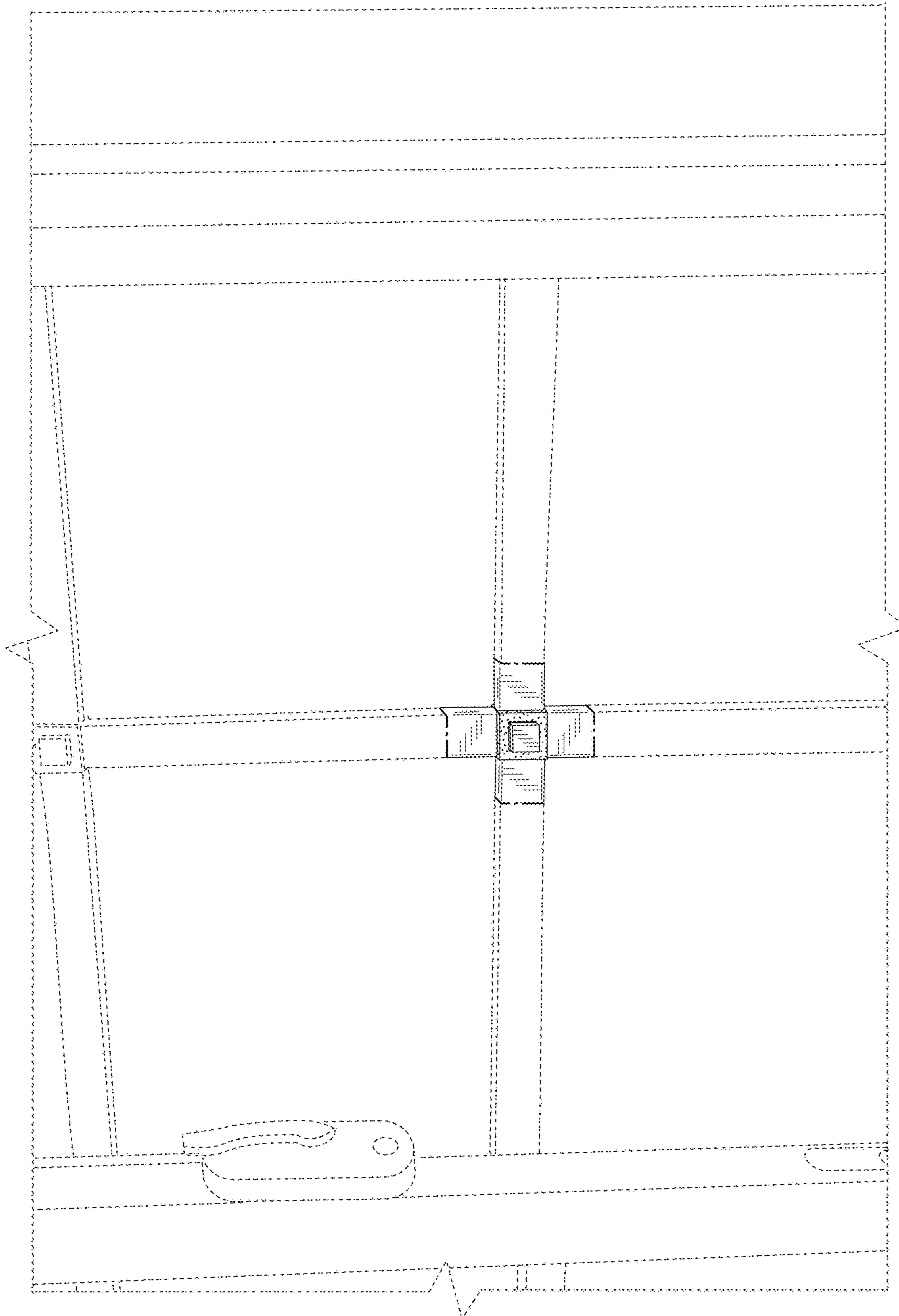
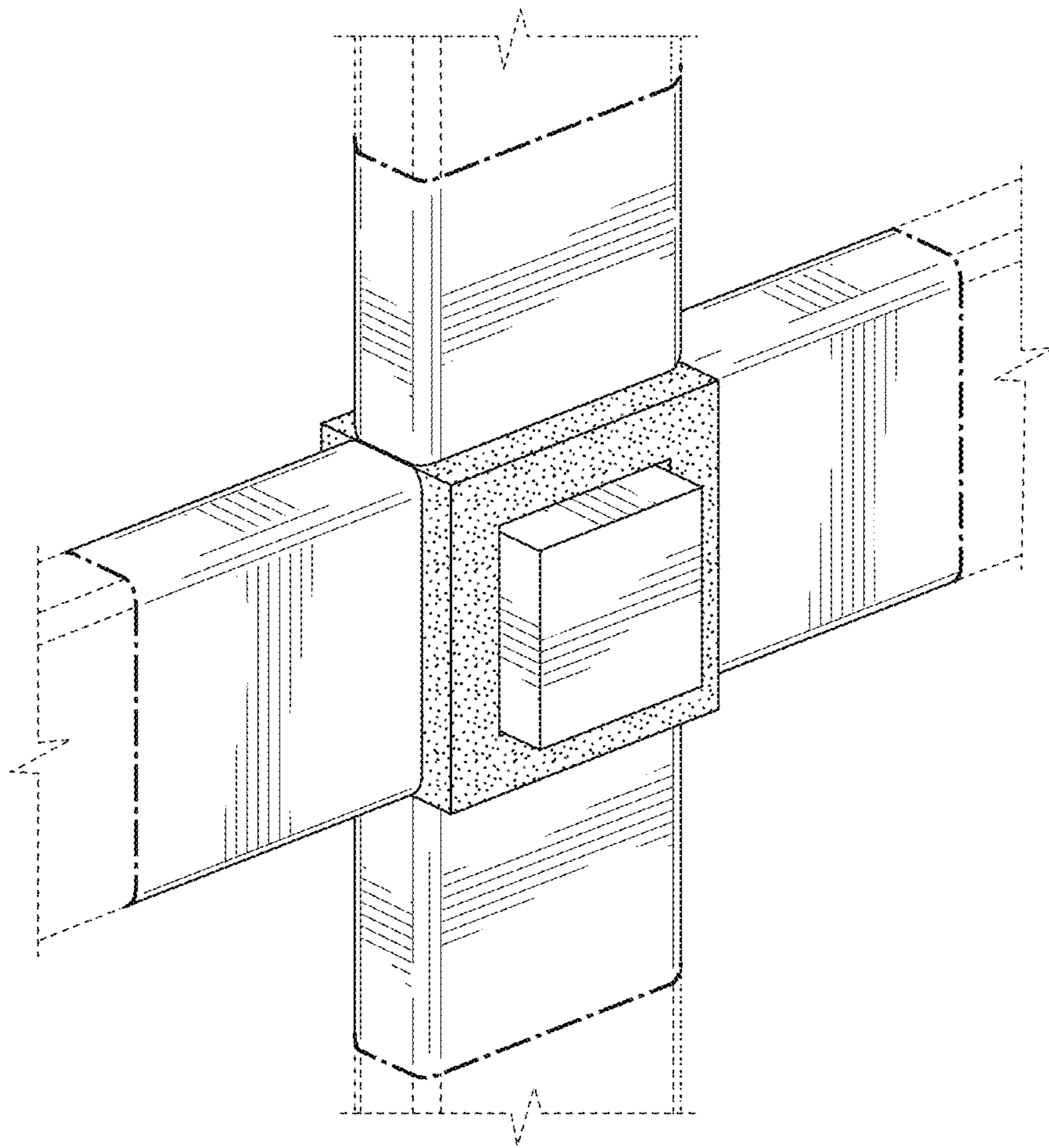
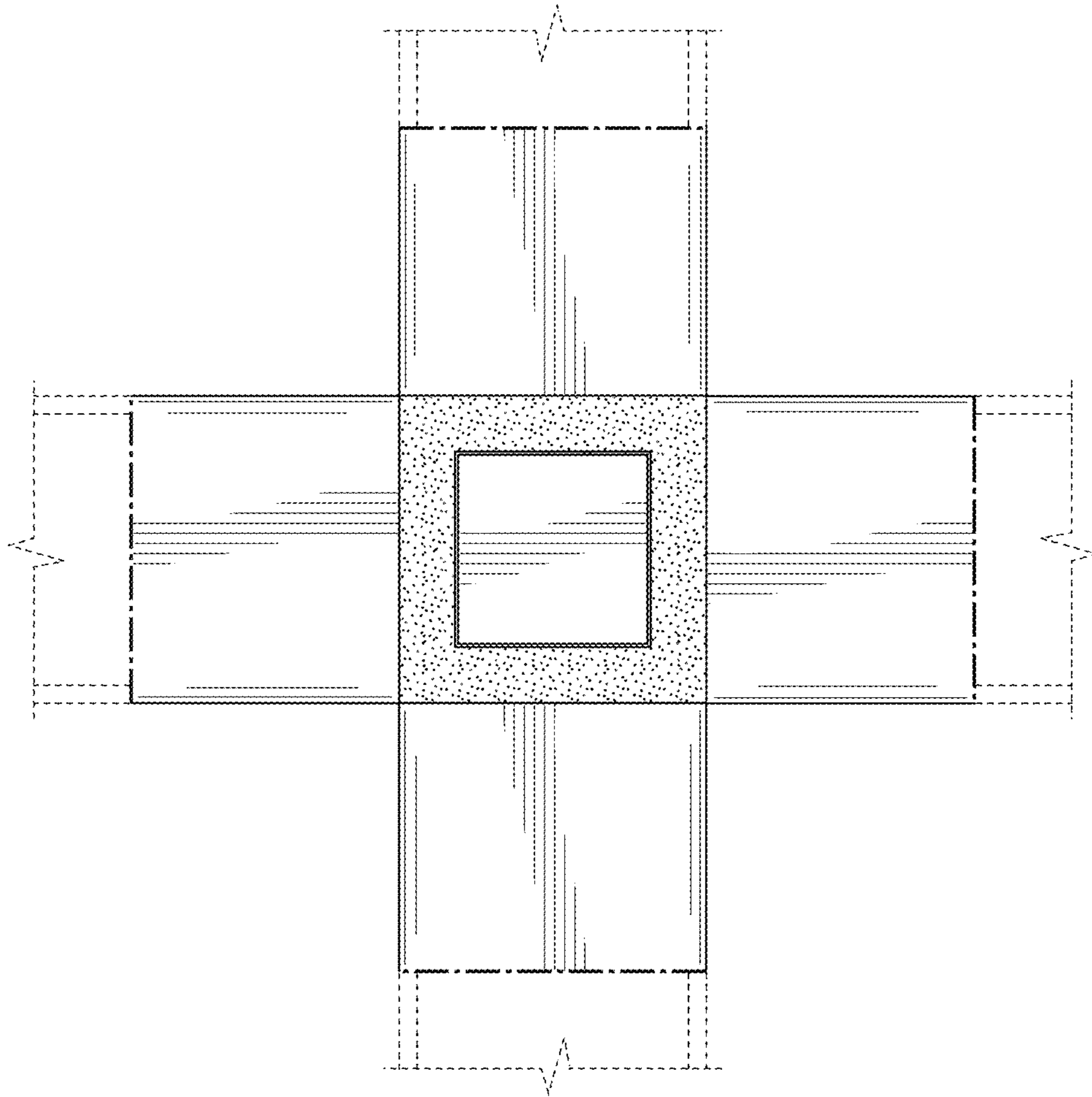

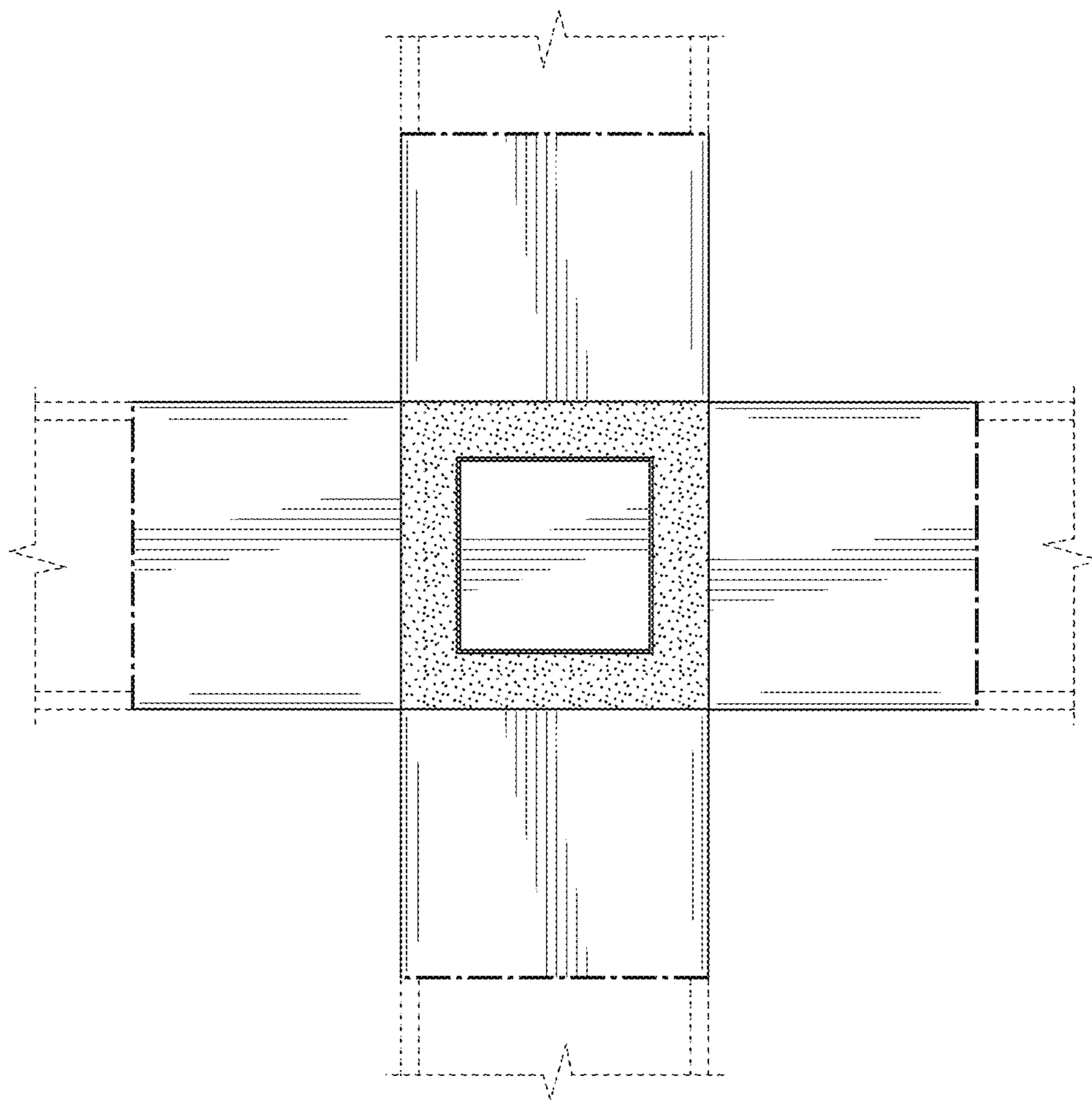

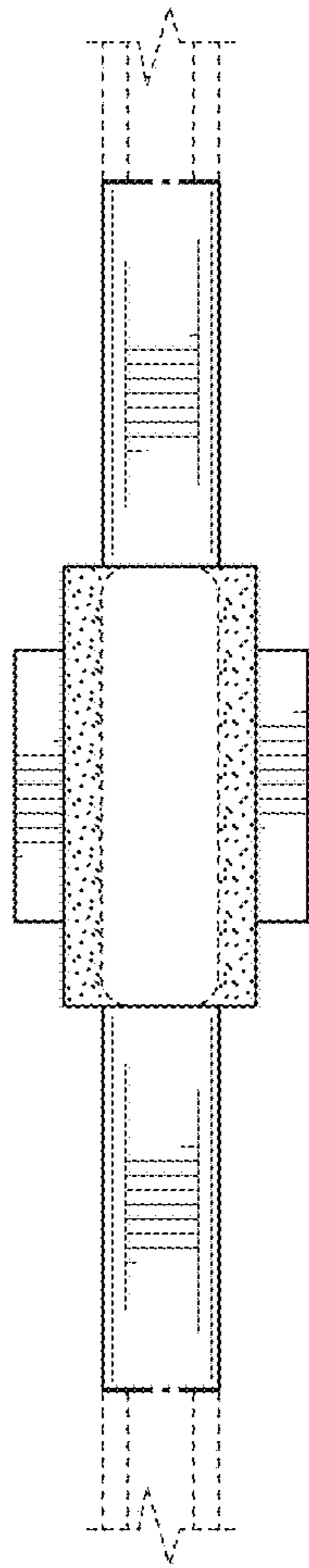

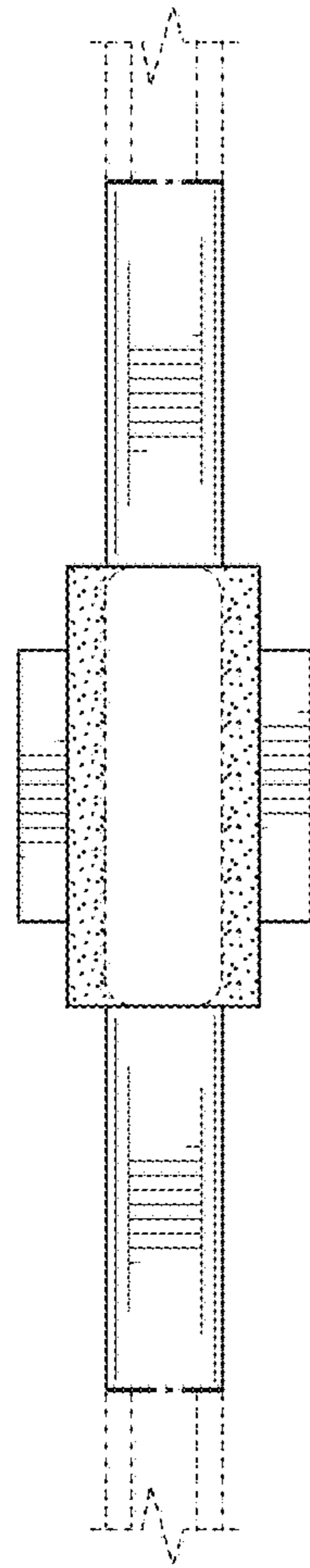

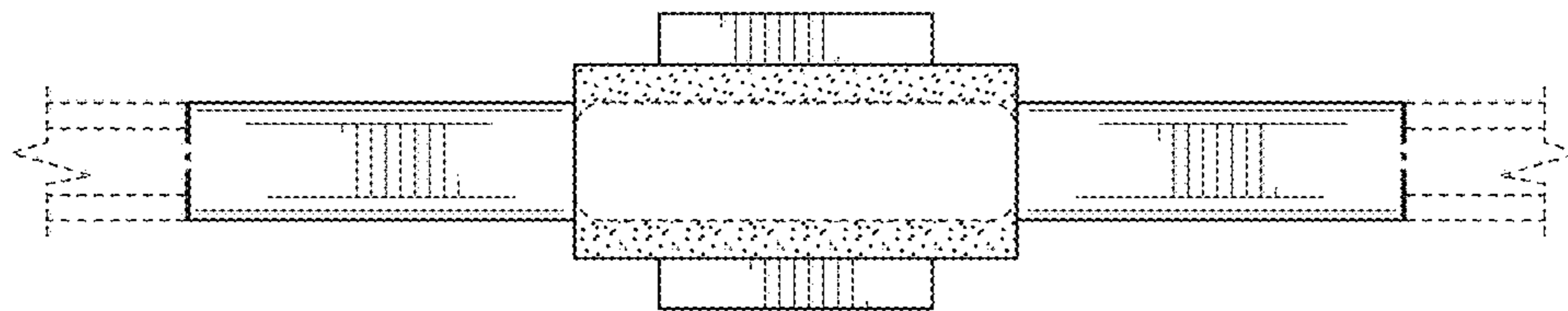

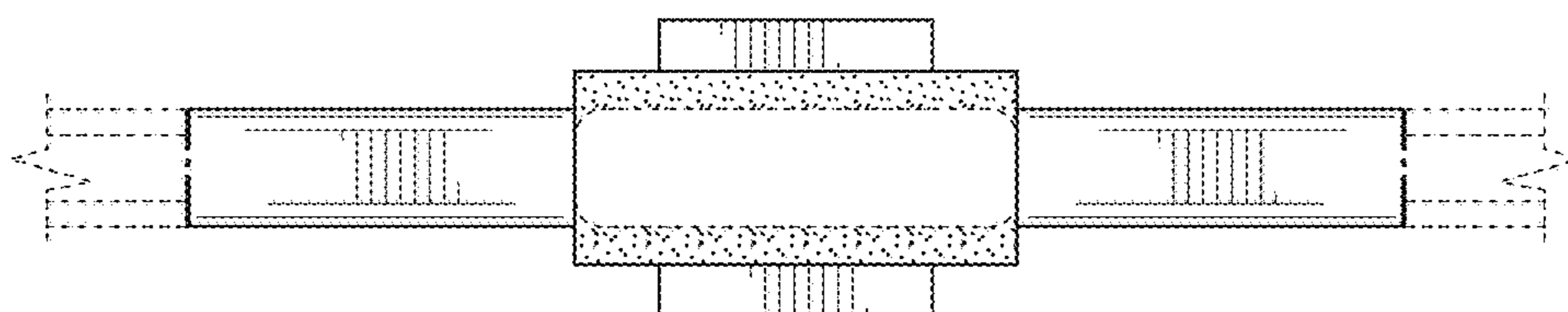

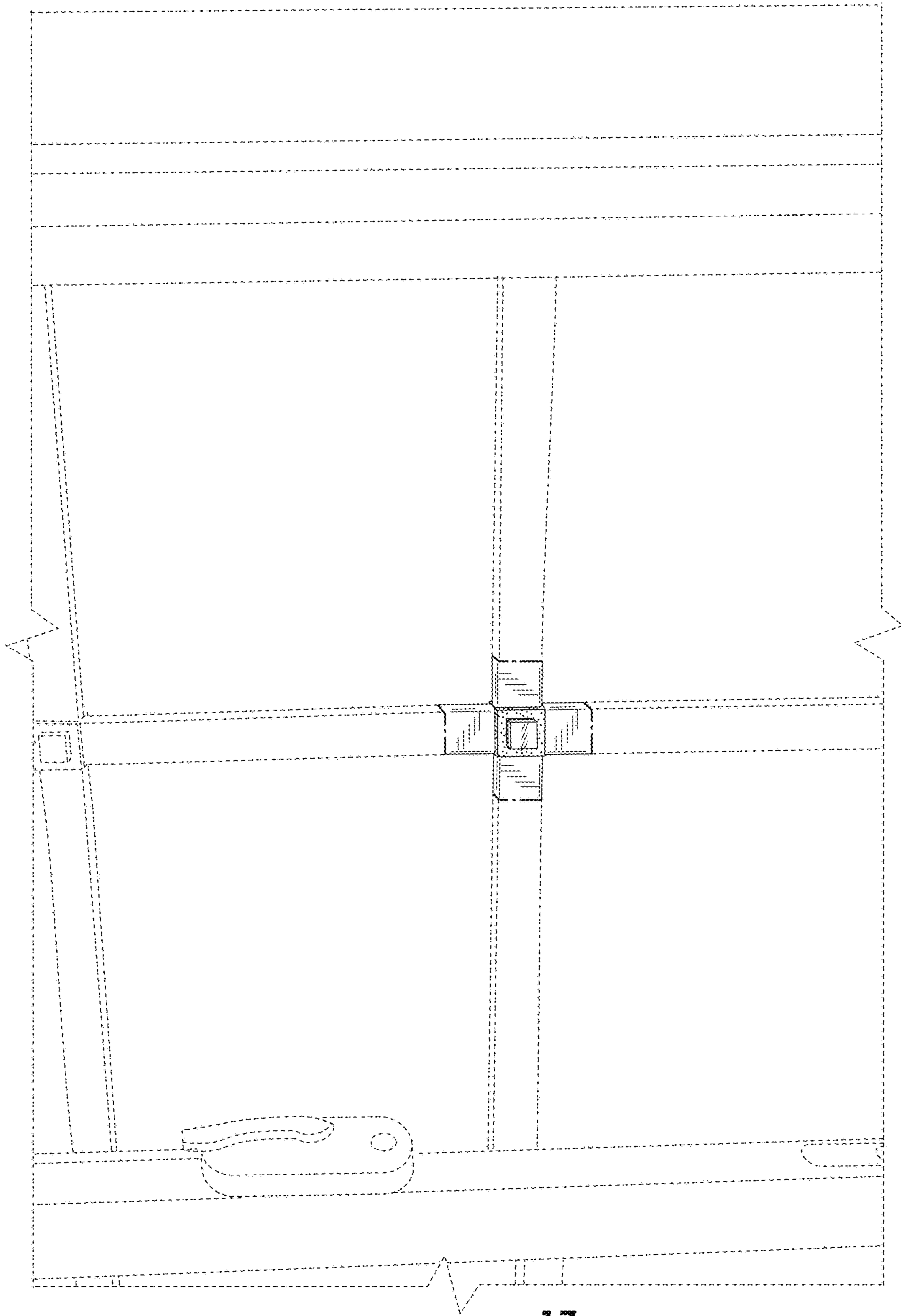
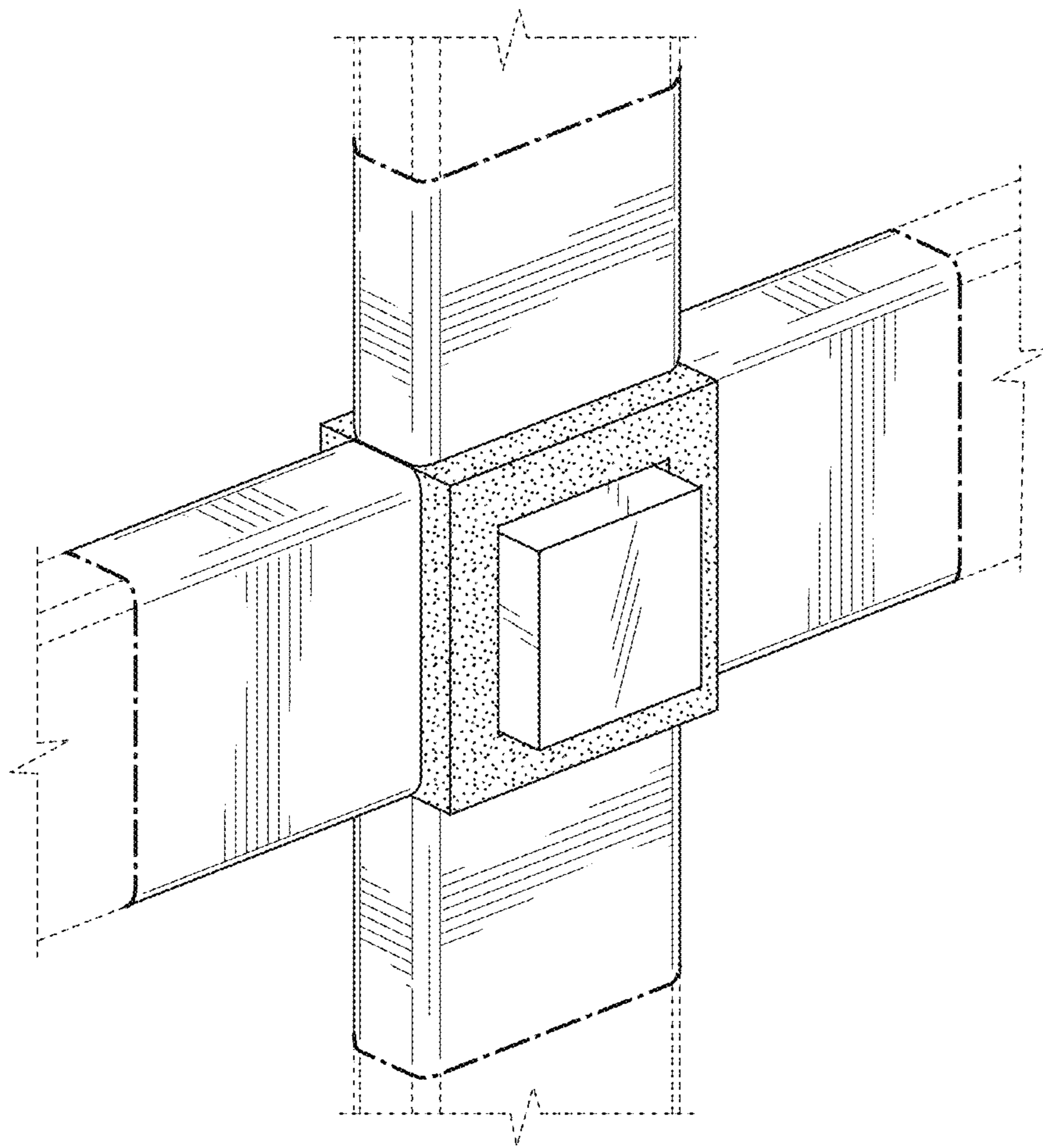

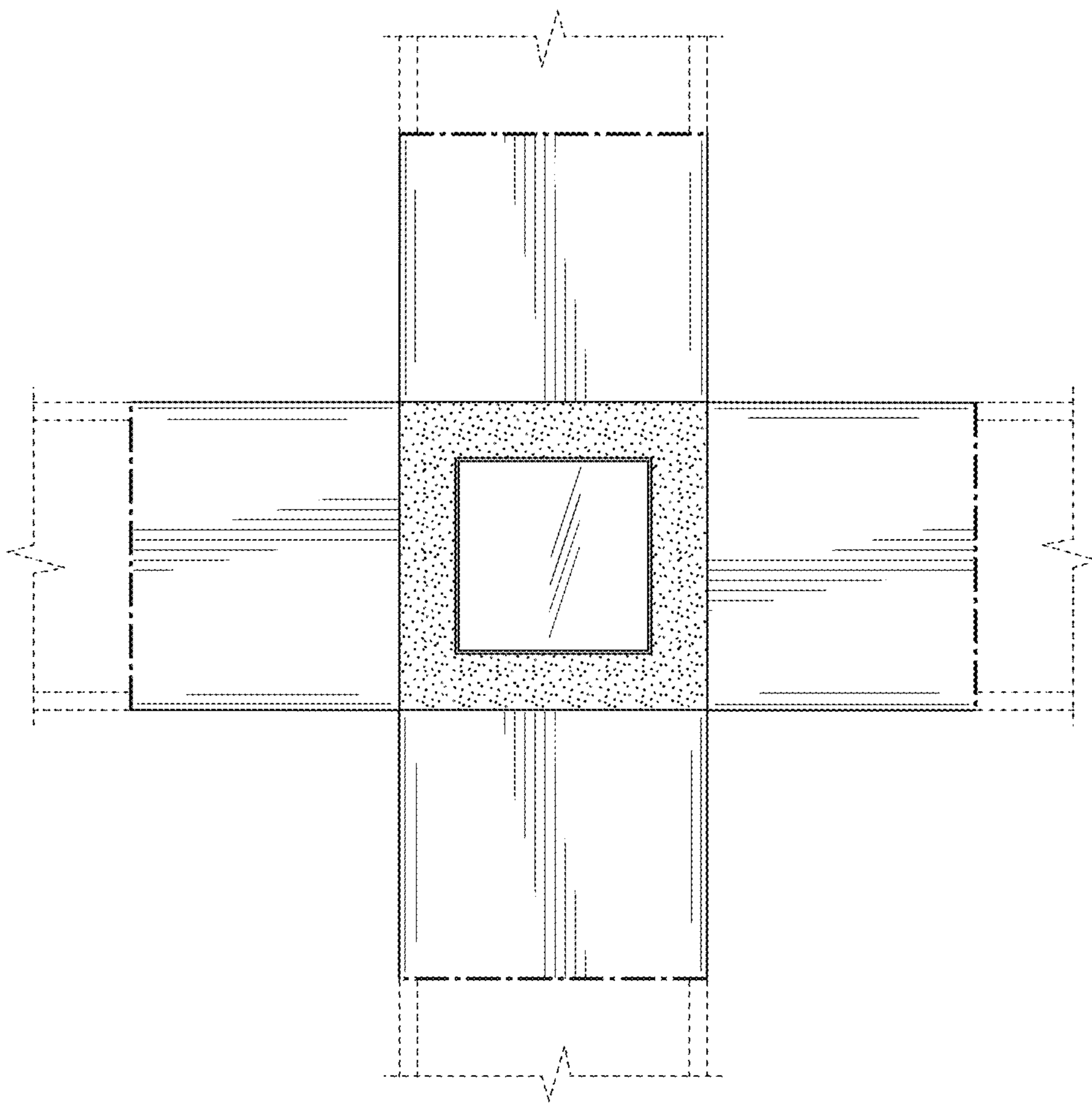
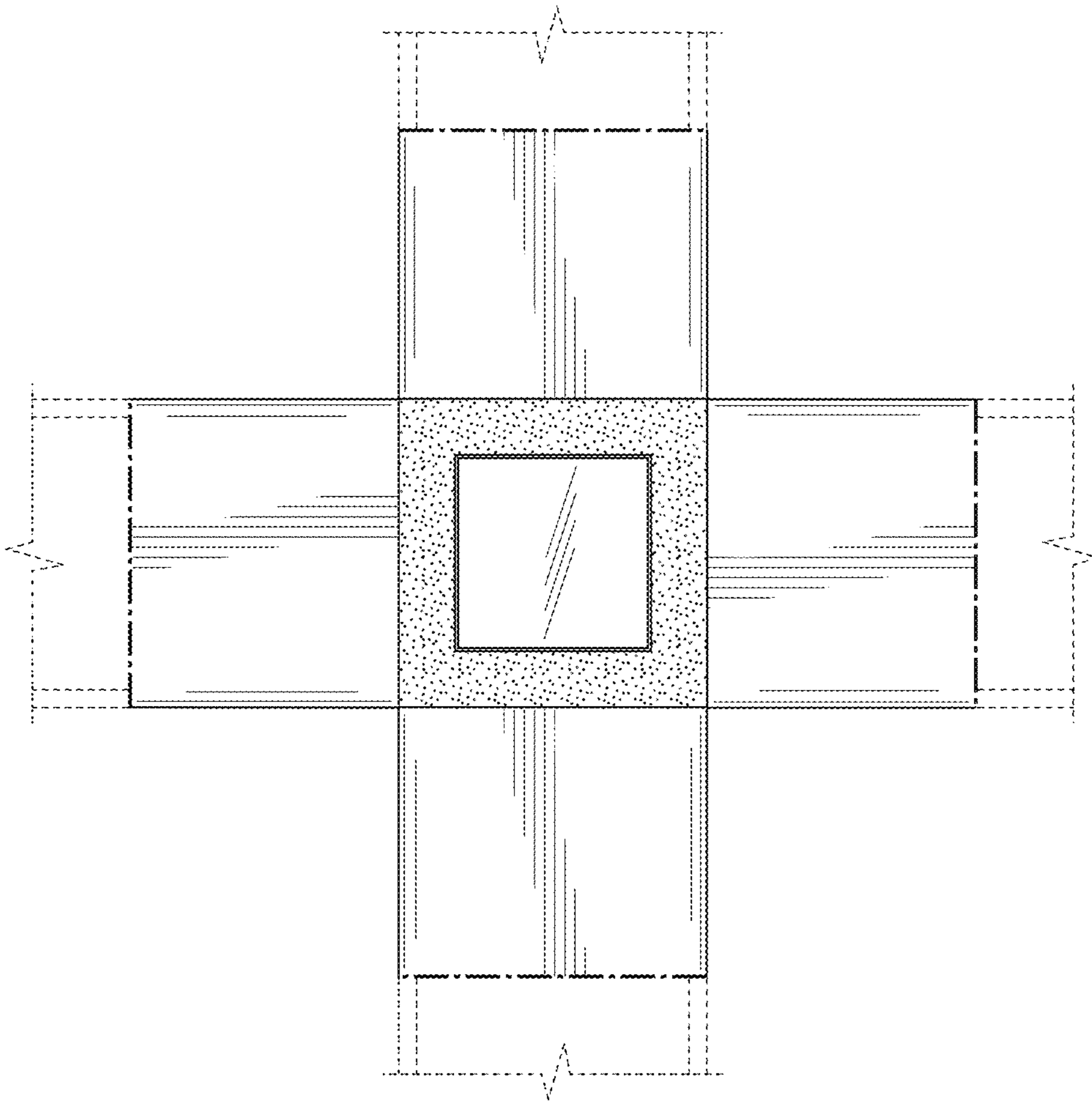

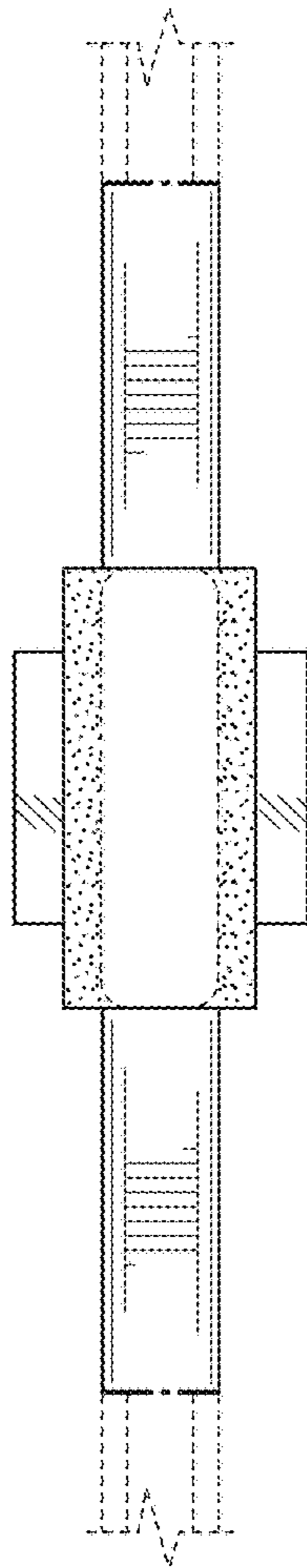

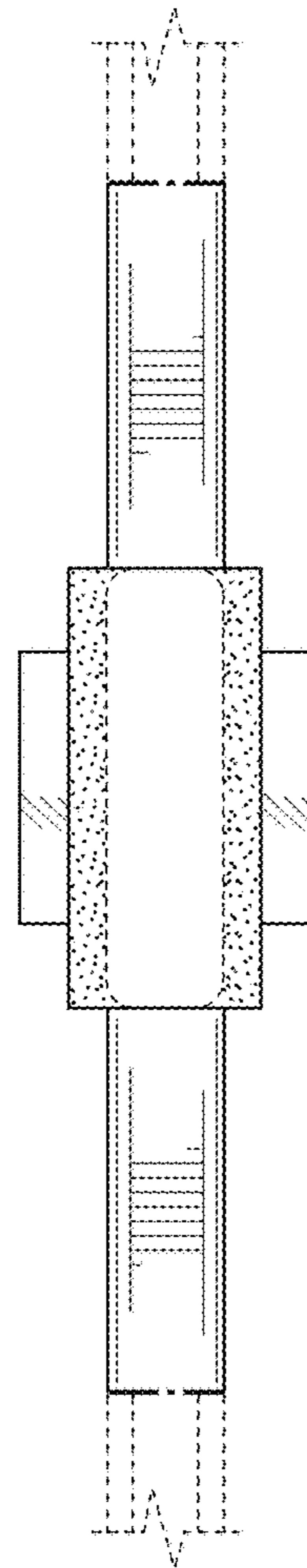

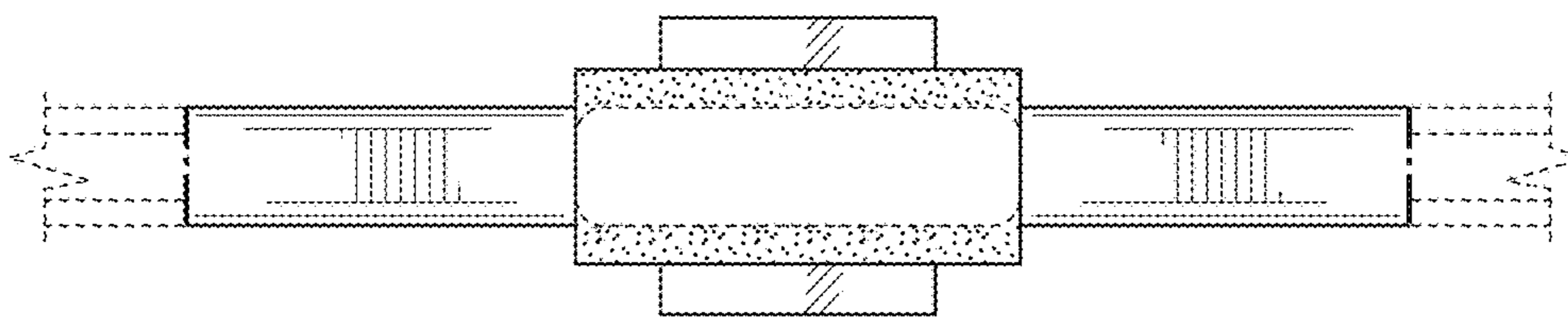

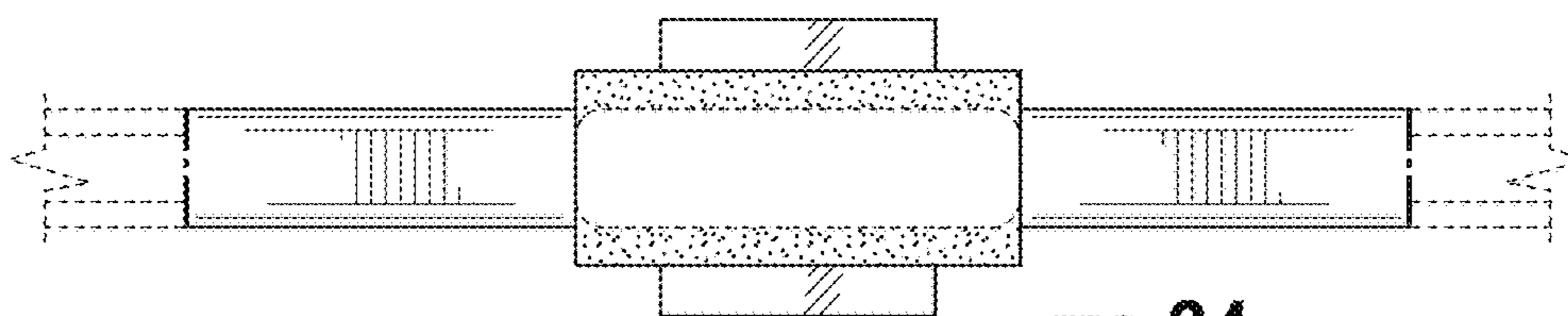

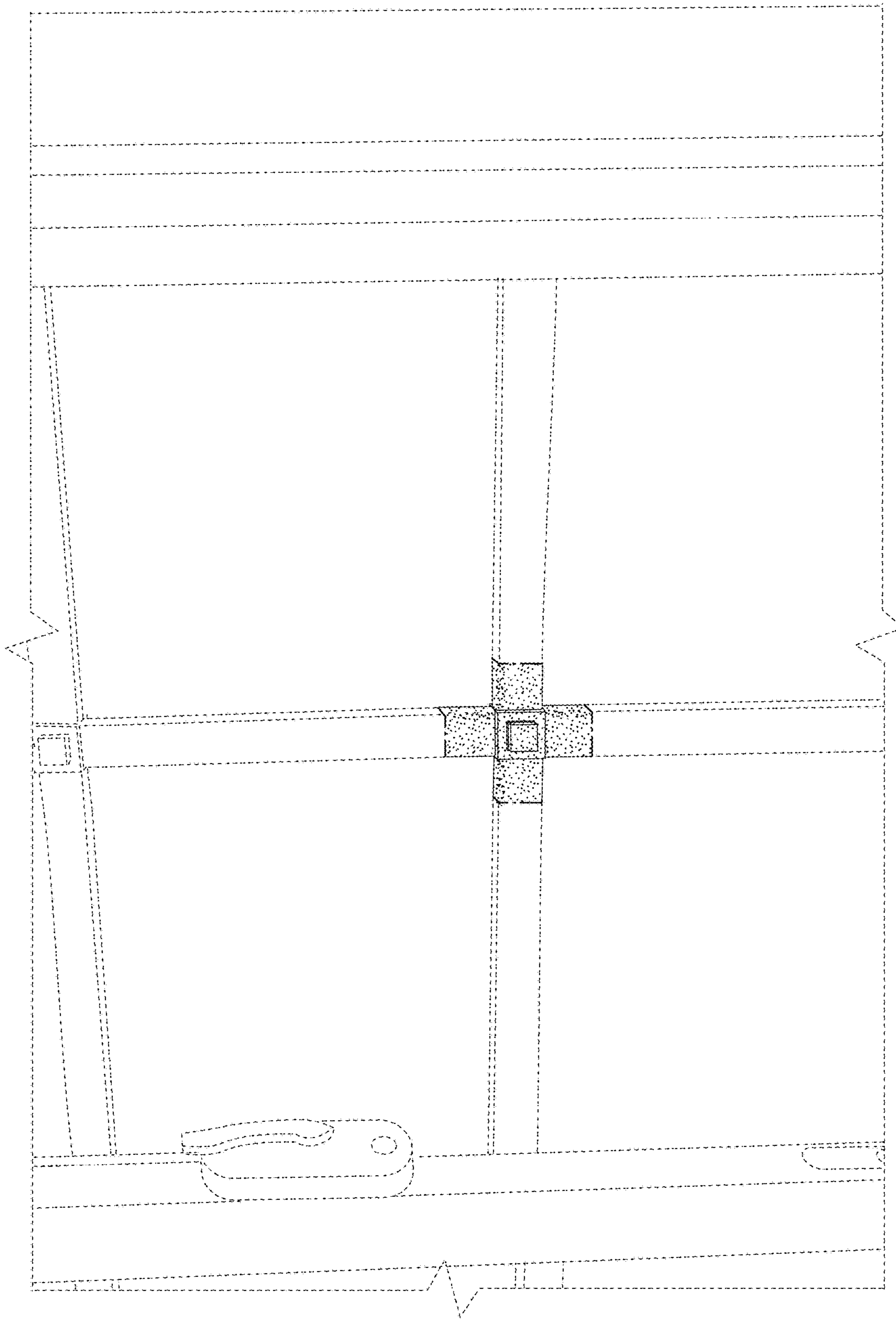

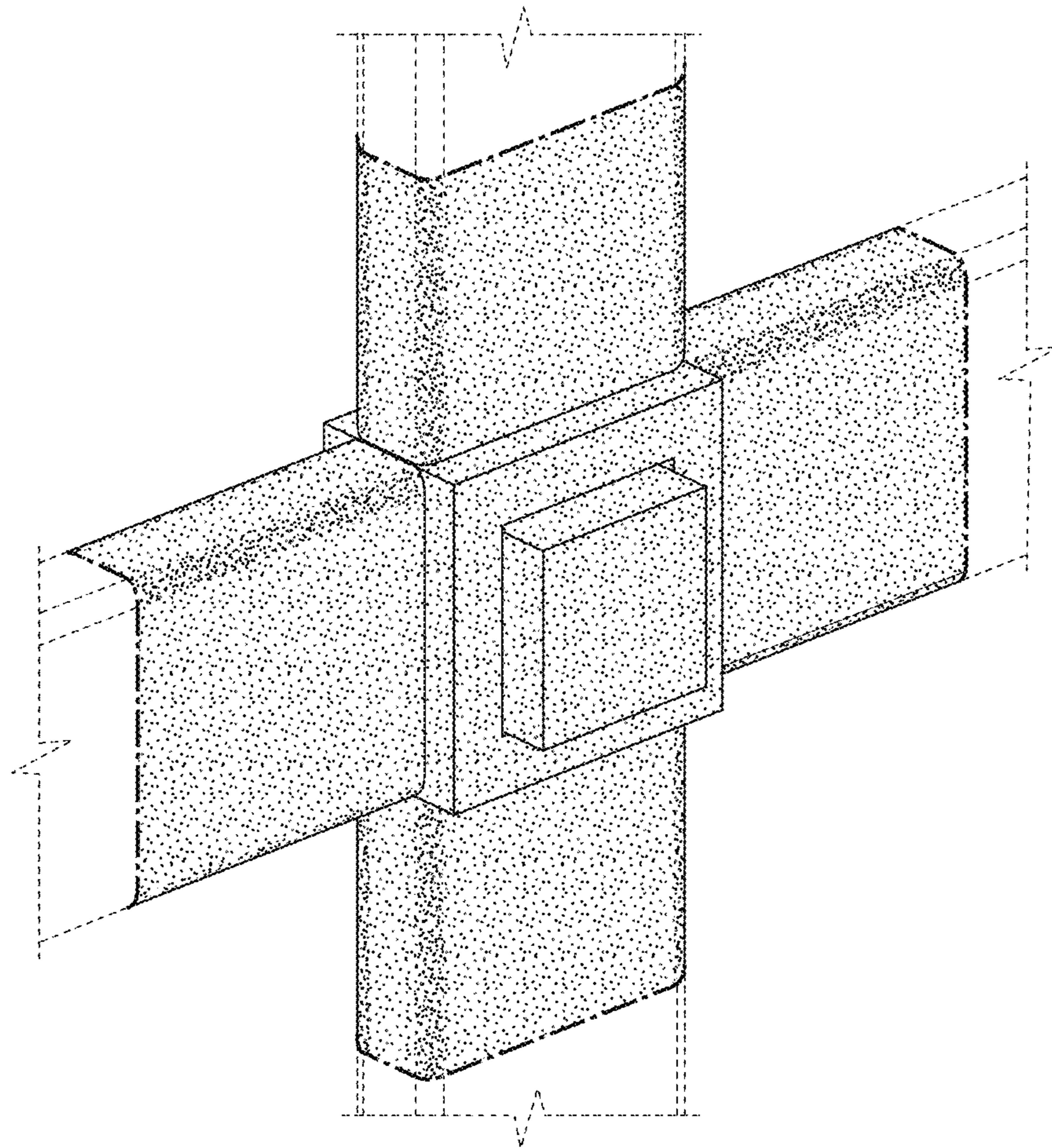
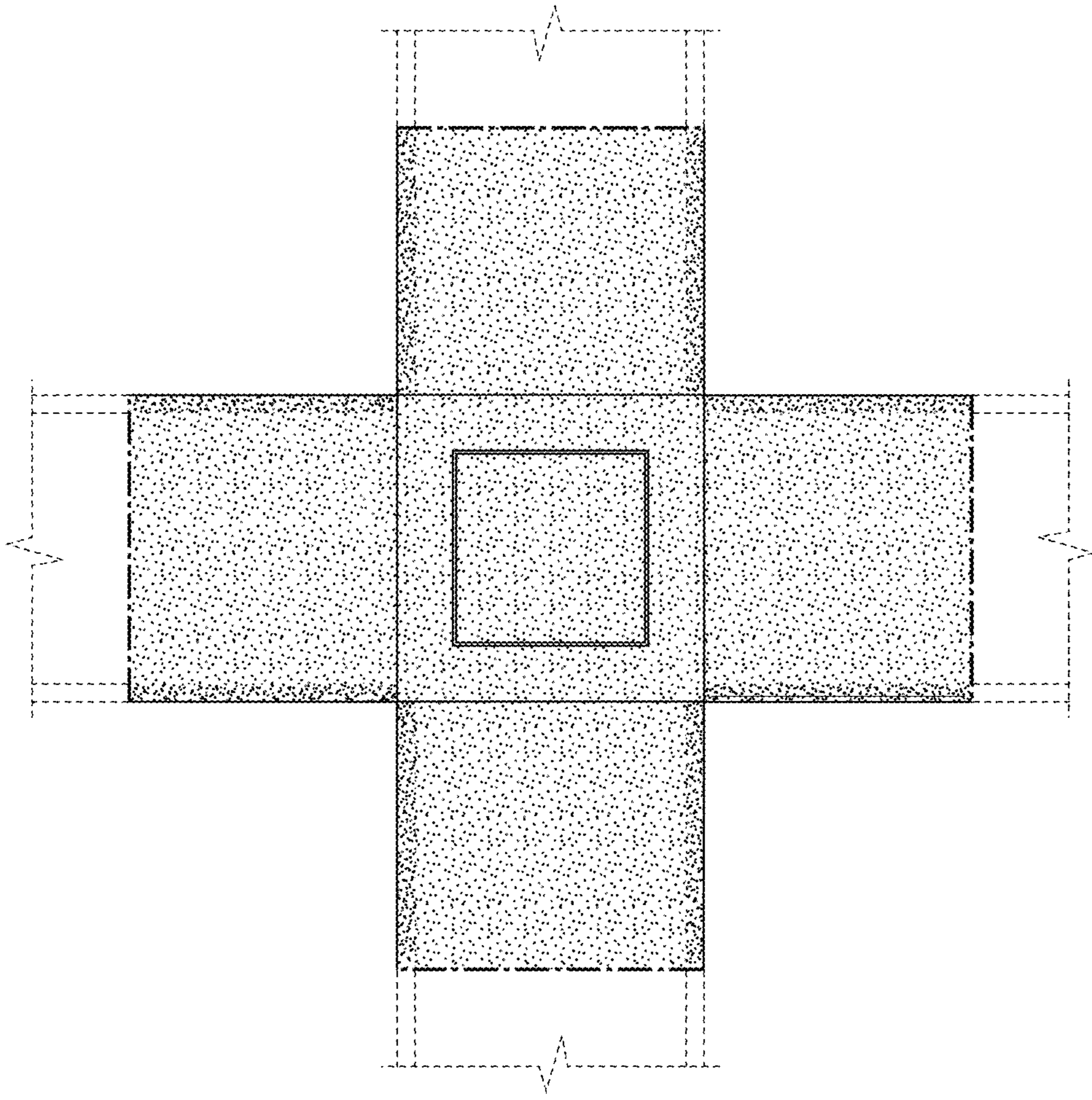
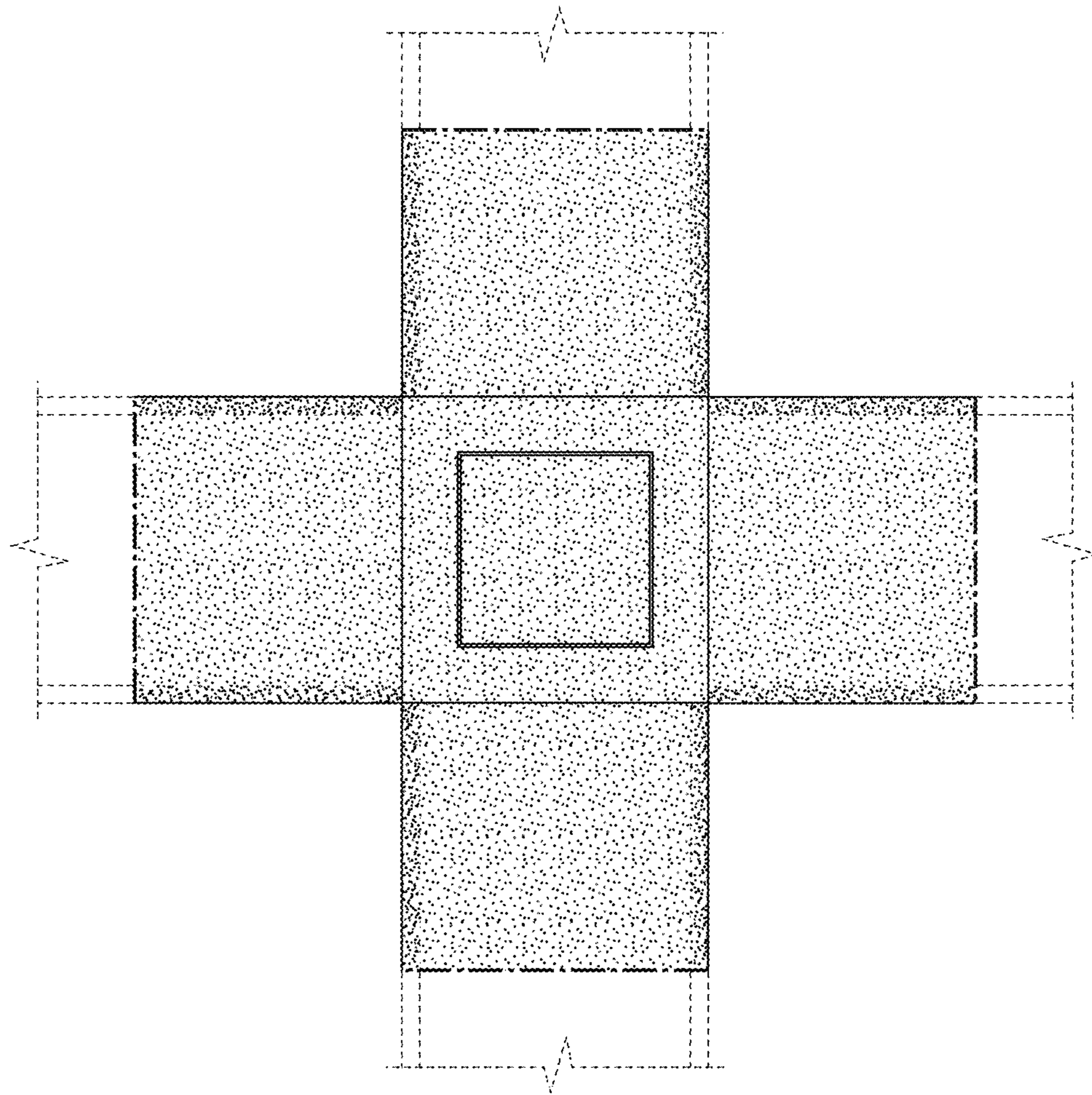

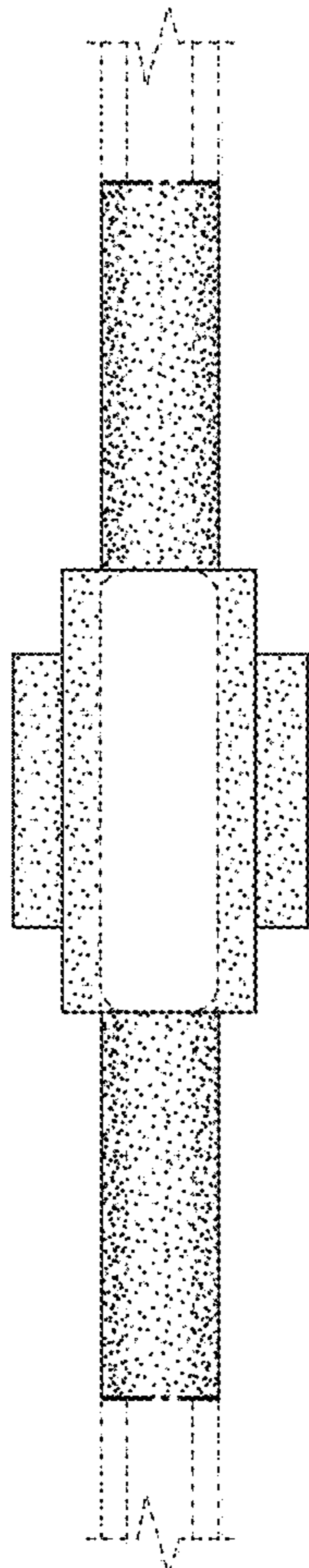

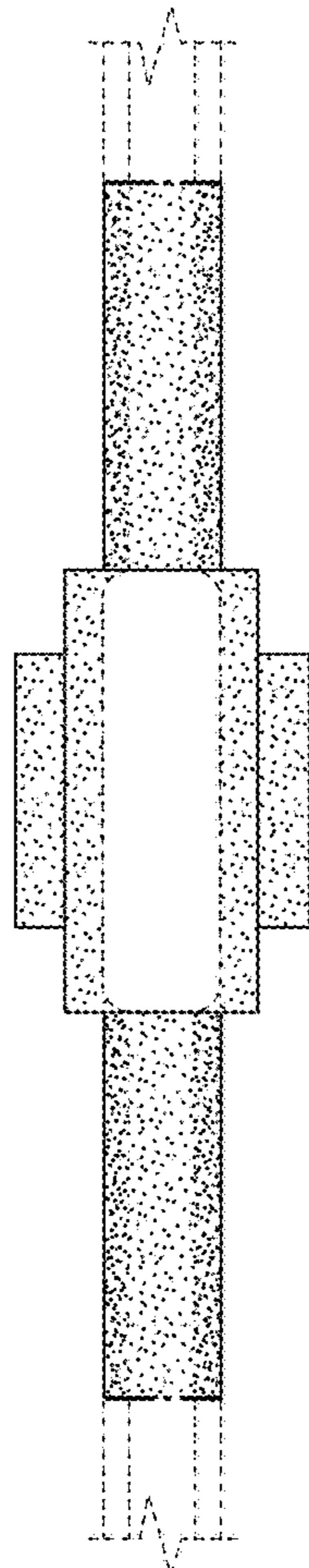

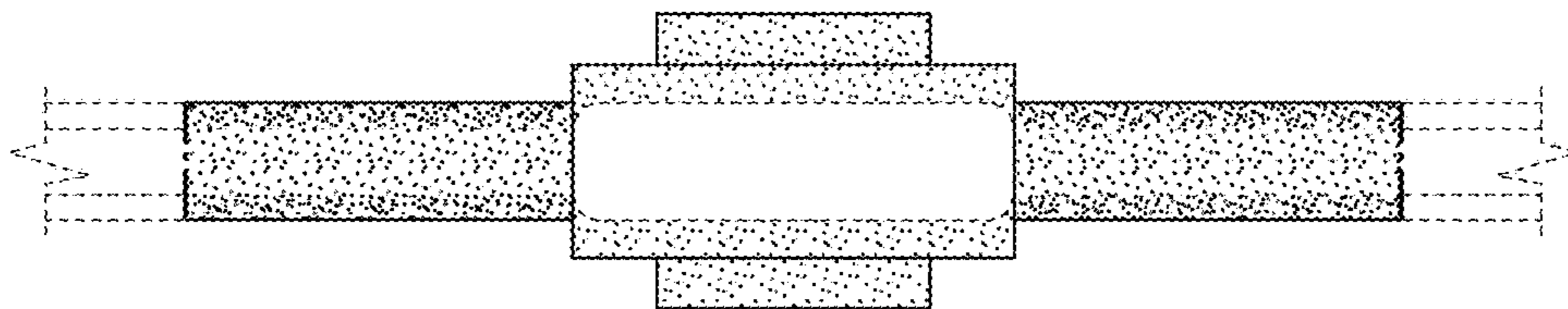

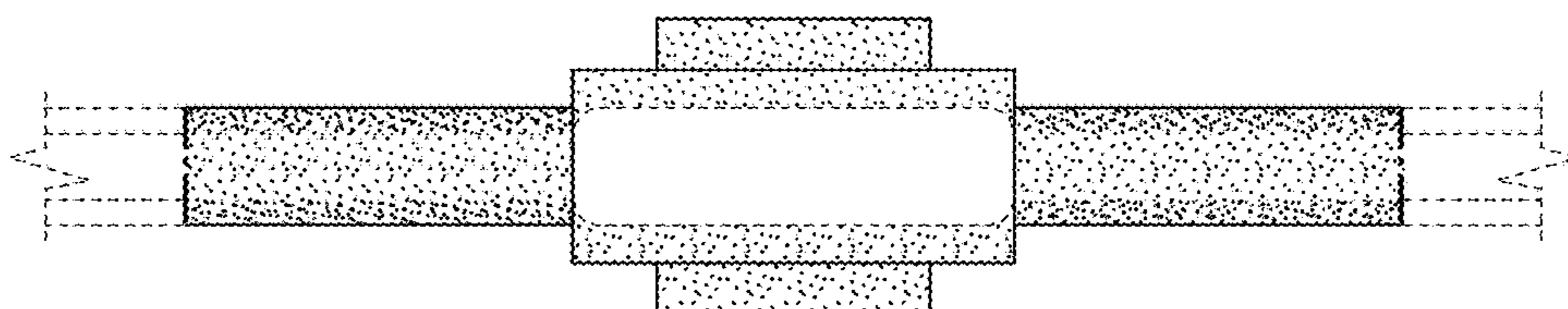

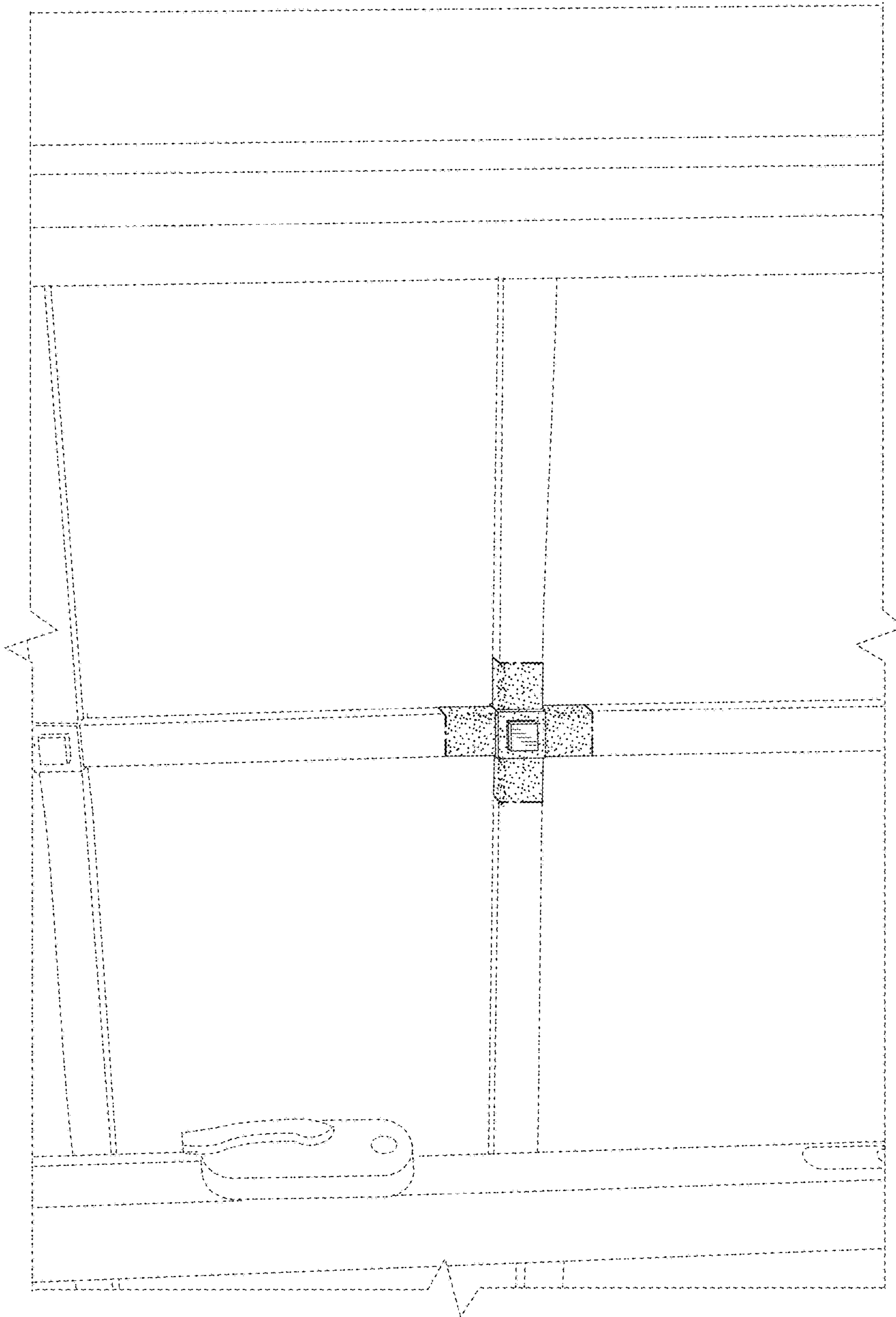

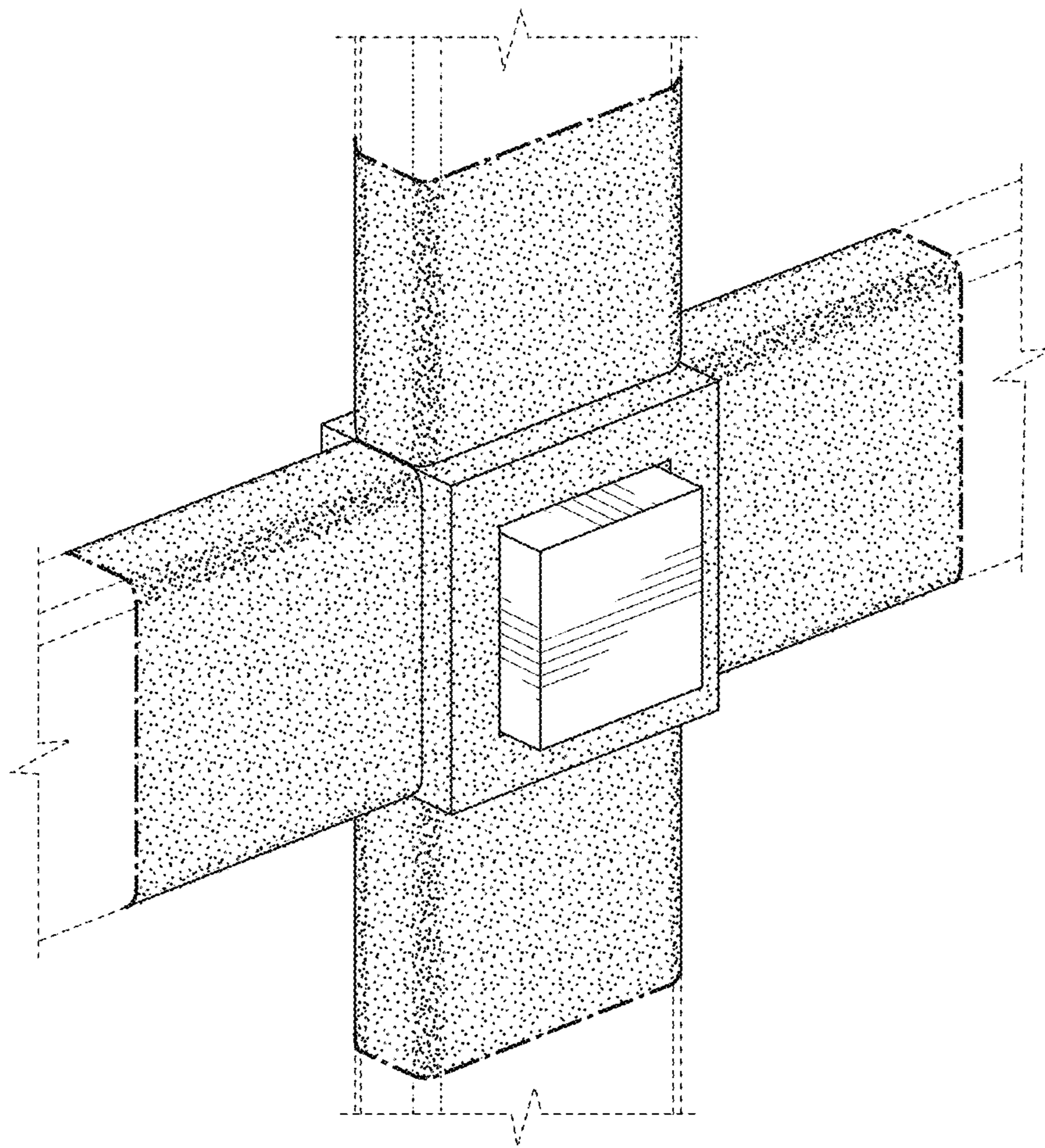
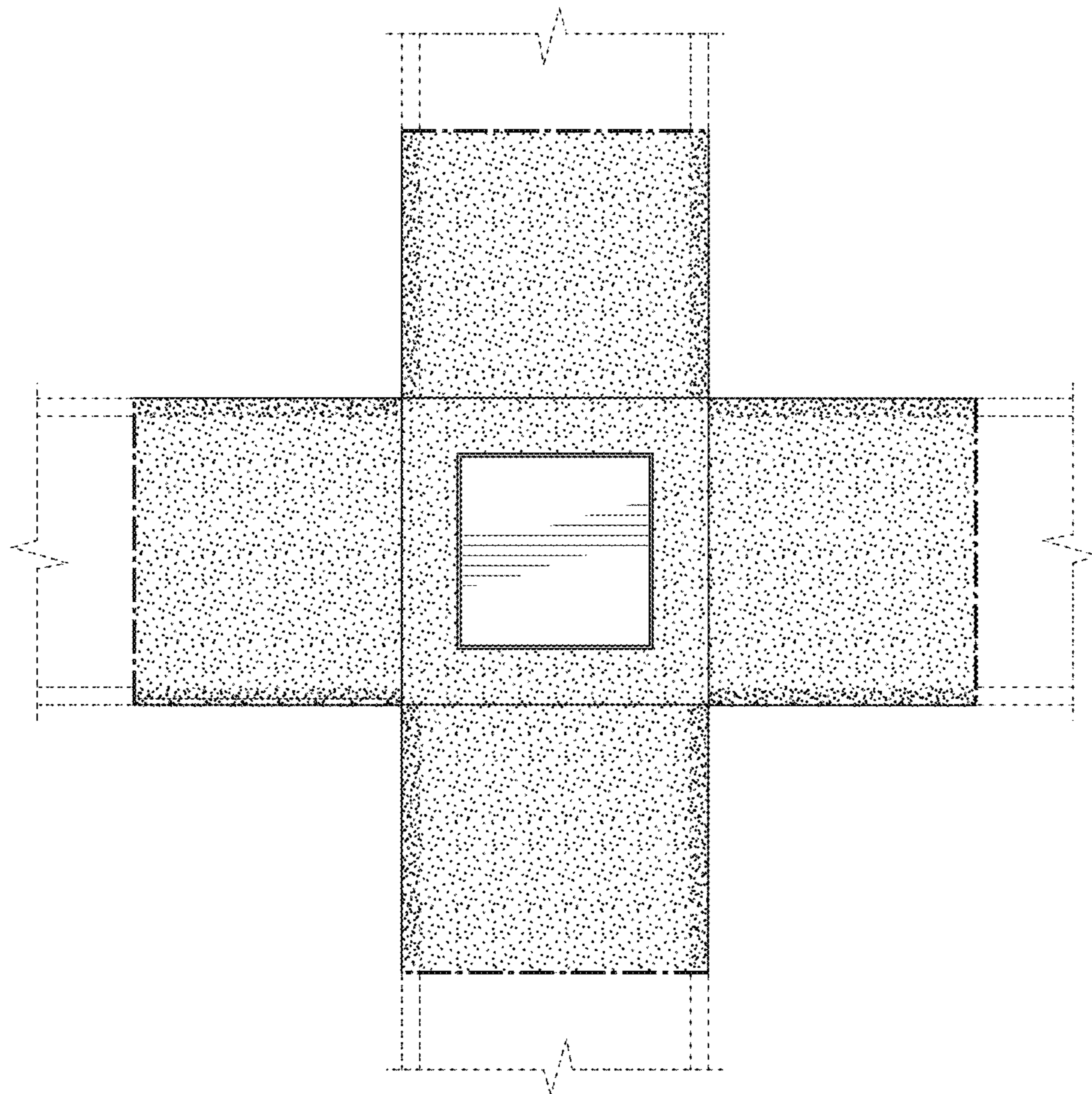
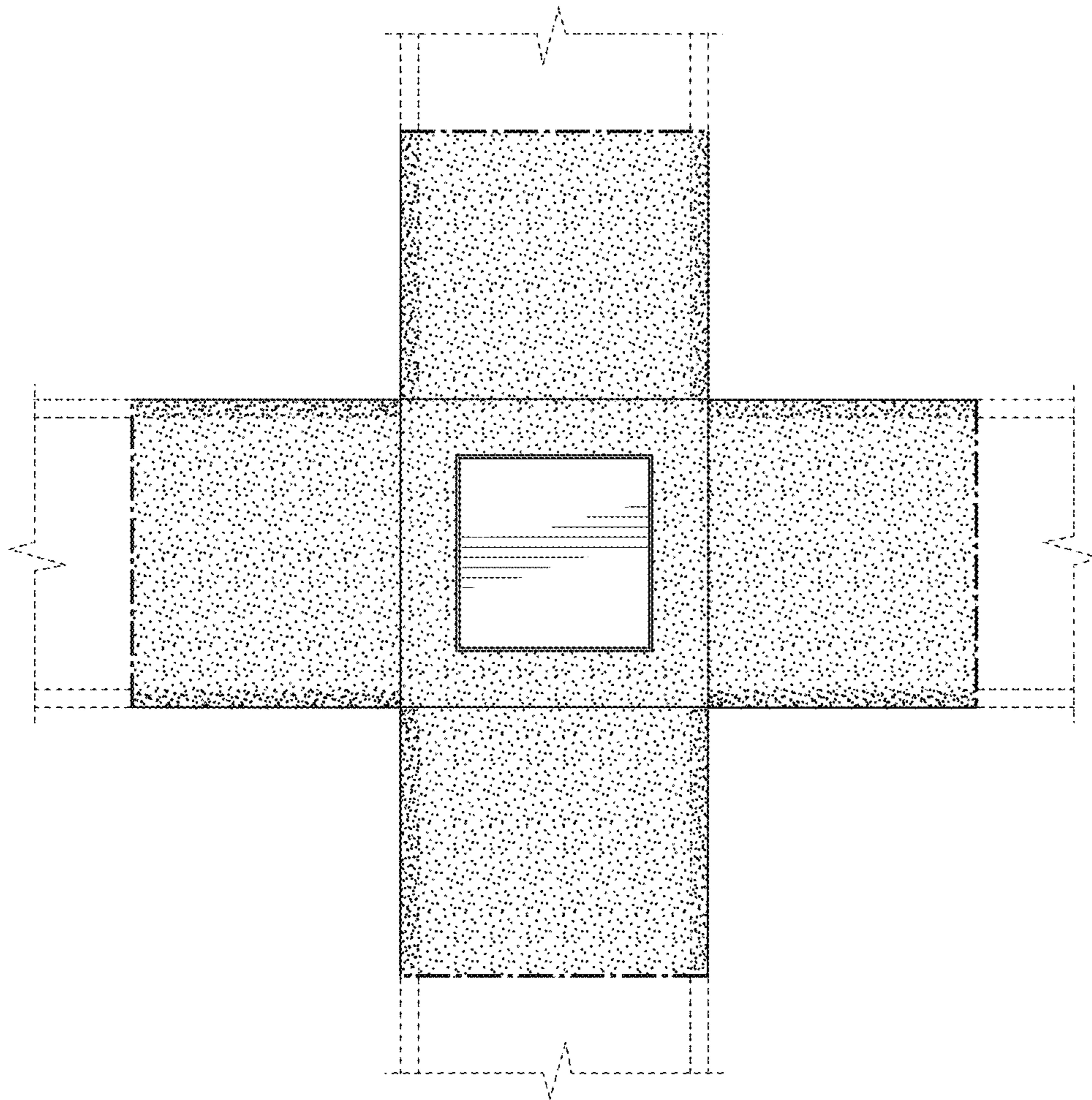

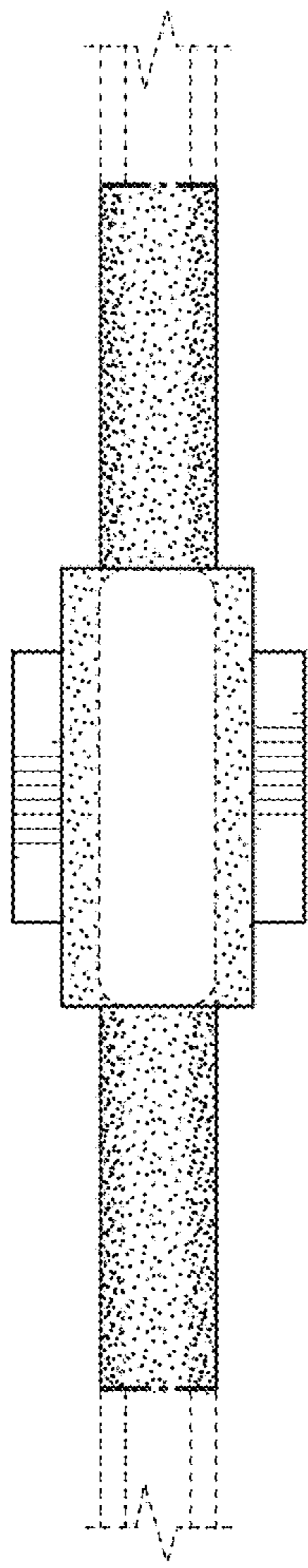




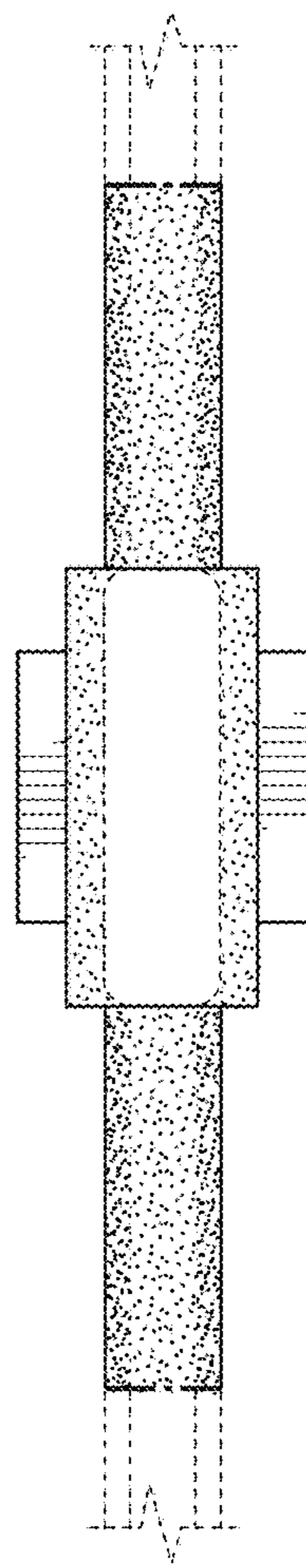

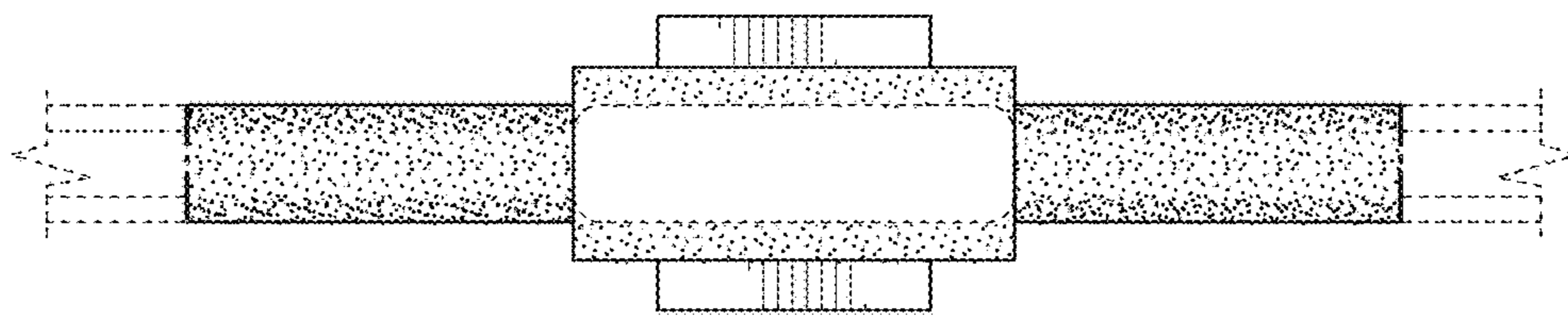

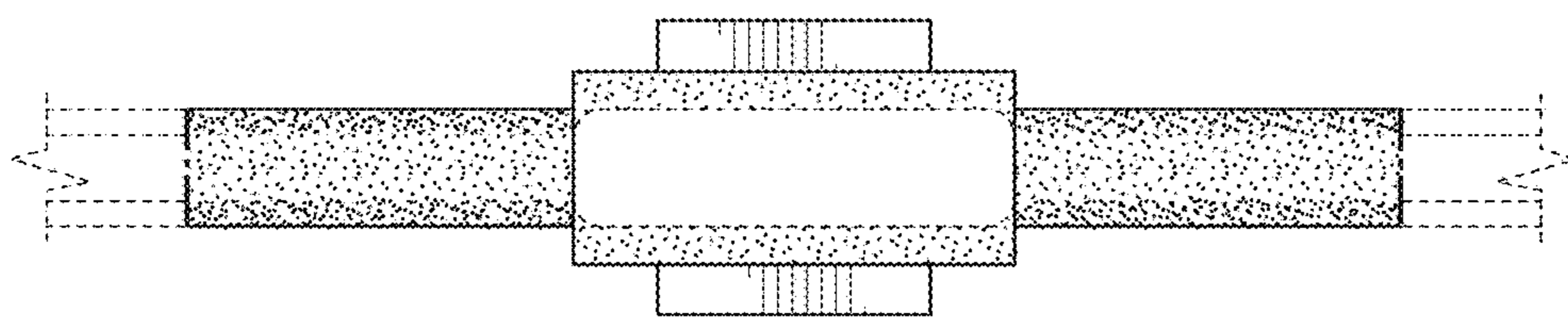
