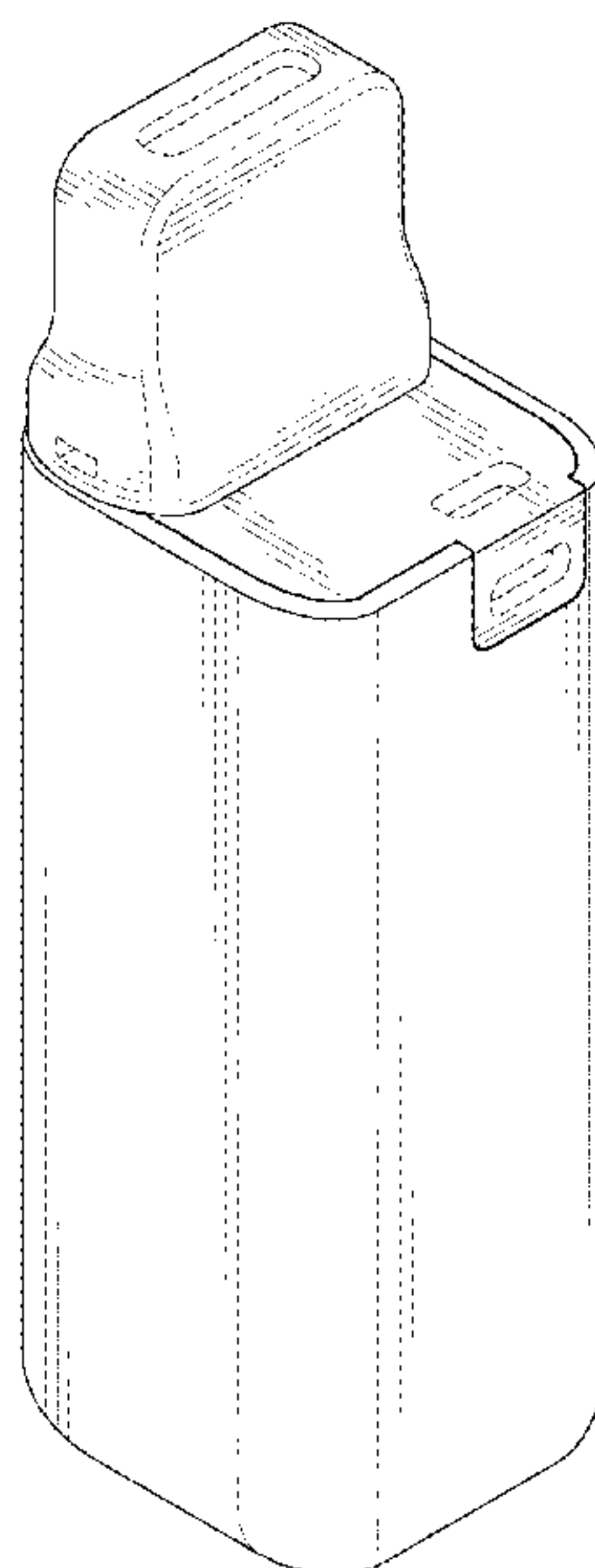
(57) **CLAIM**

I claim the ornamental design for an electronic cigarette, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of an electronic cigarette showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left elevational view thereof;  
FIG. 5 is a right elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken line is included for the purpose of showing environmental structure and forms no part of the claimed design.

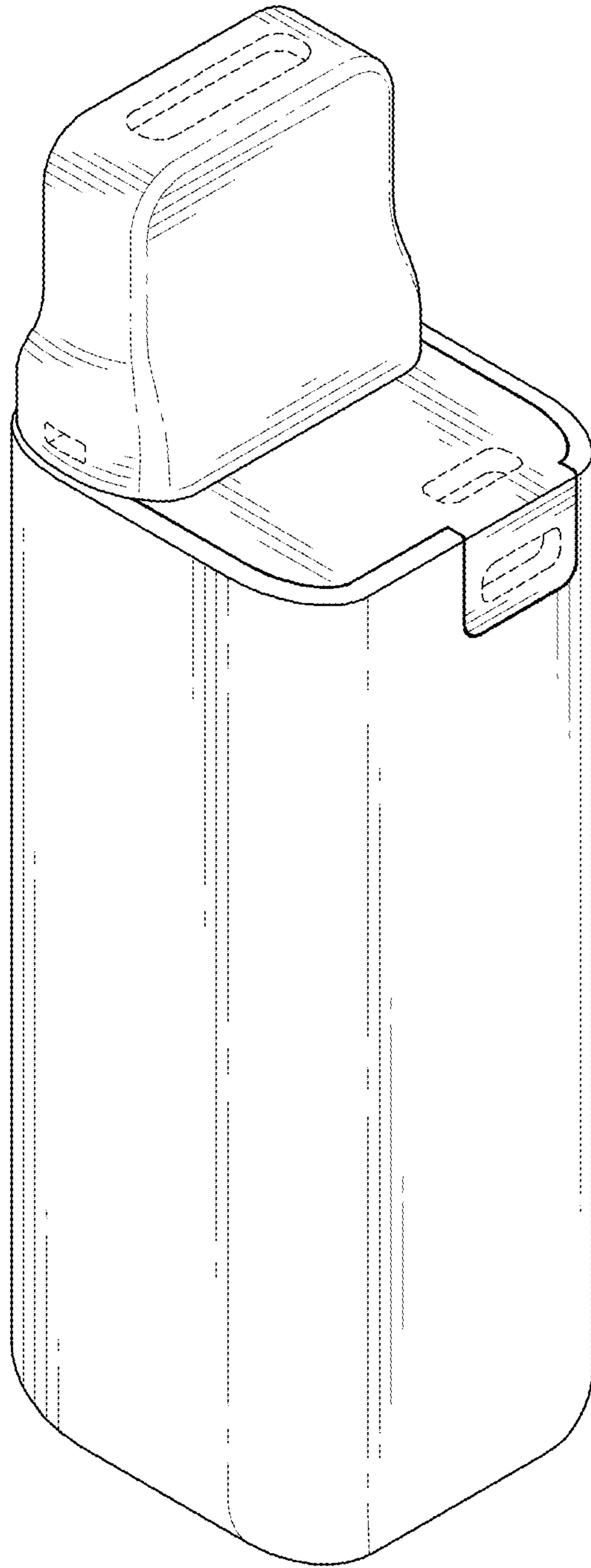

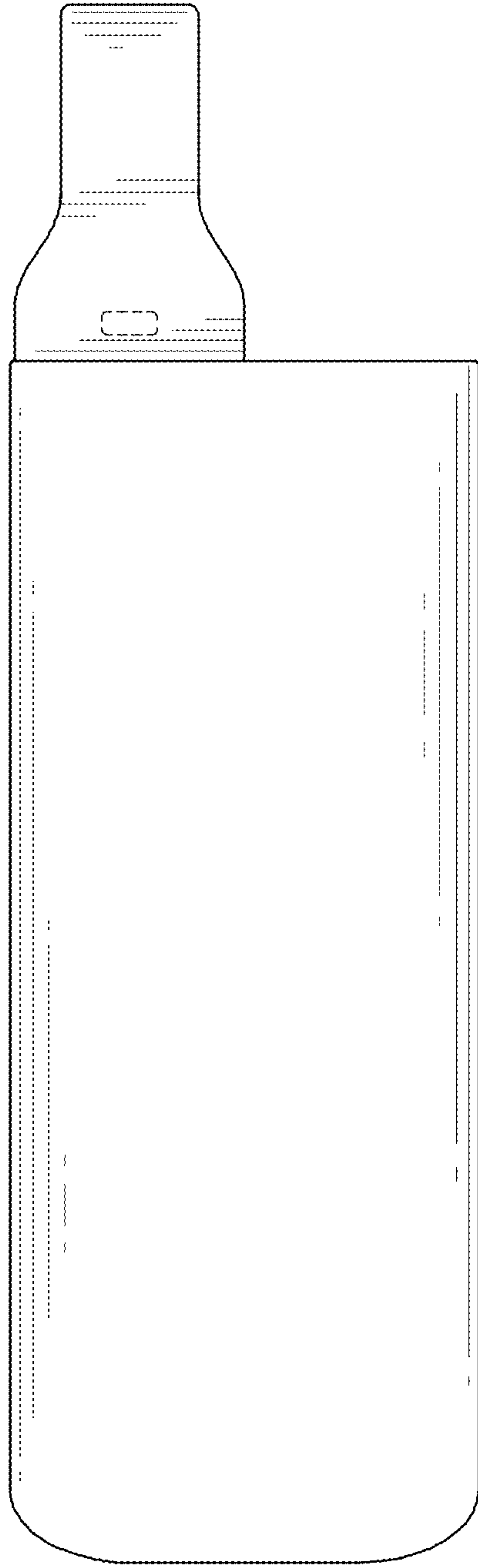

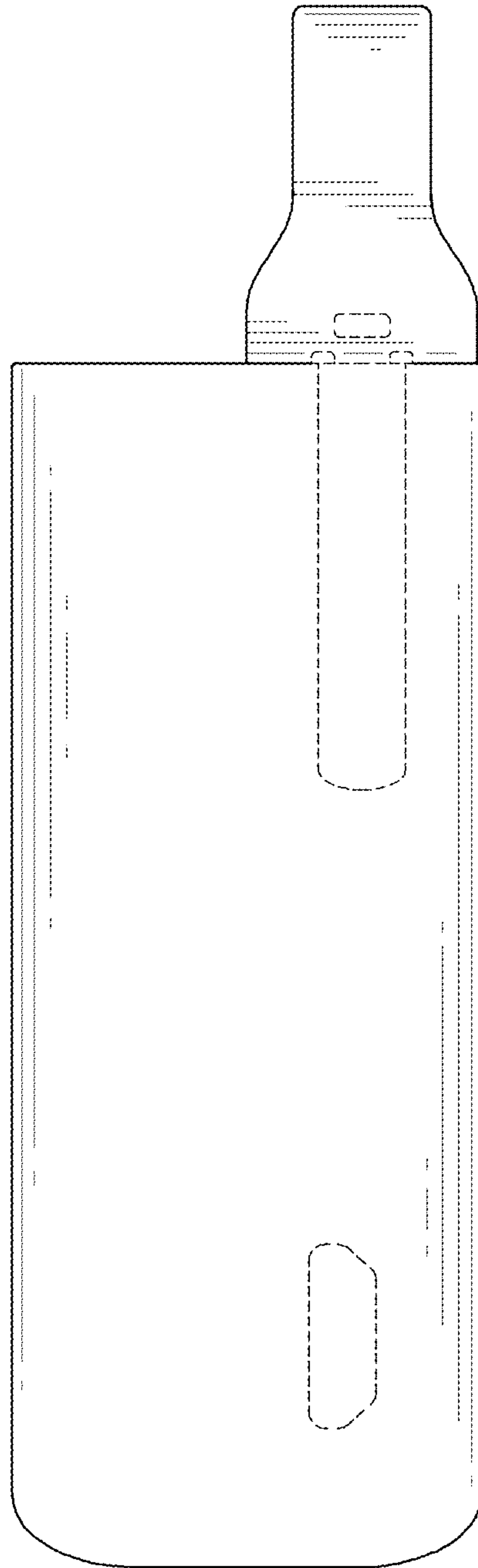

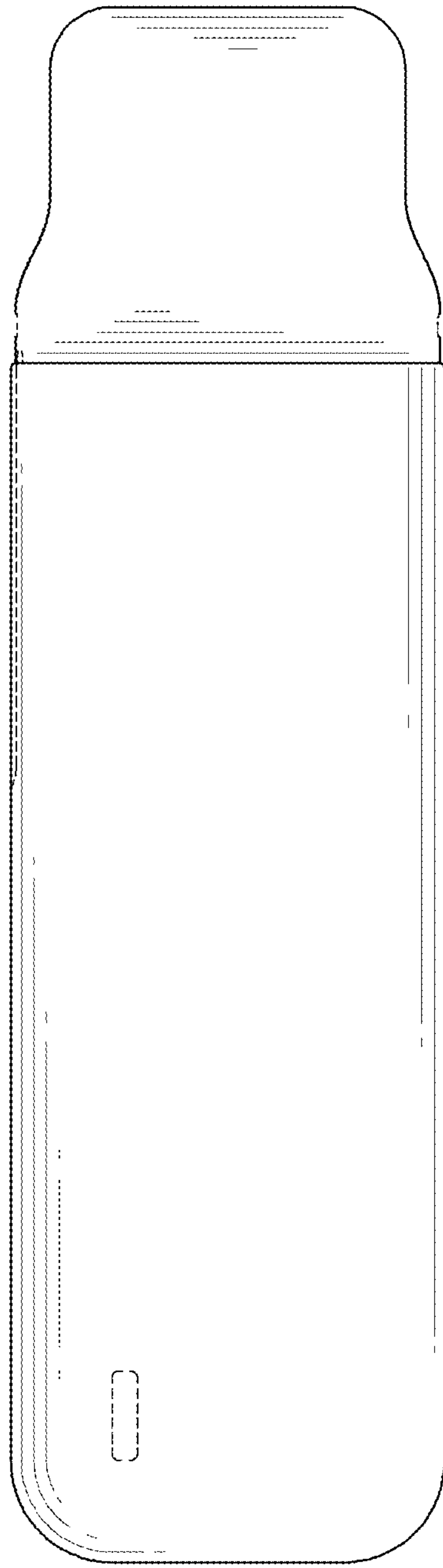

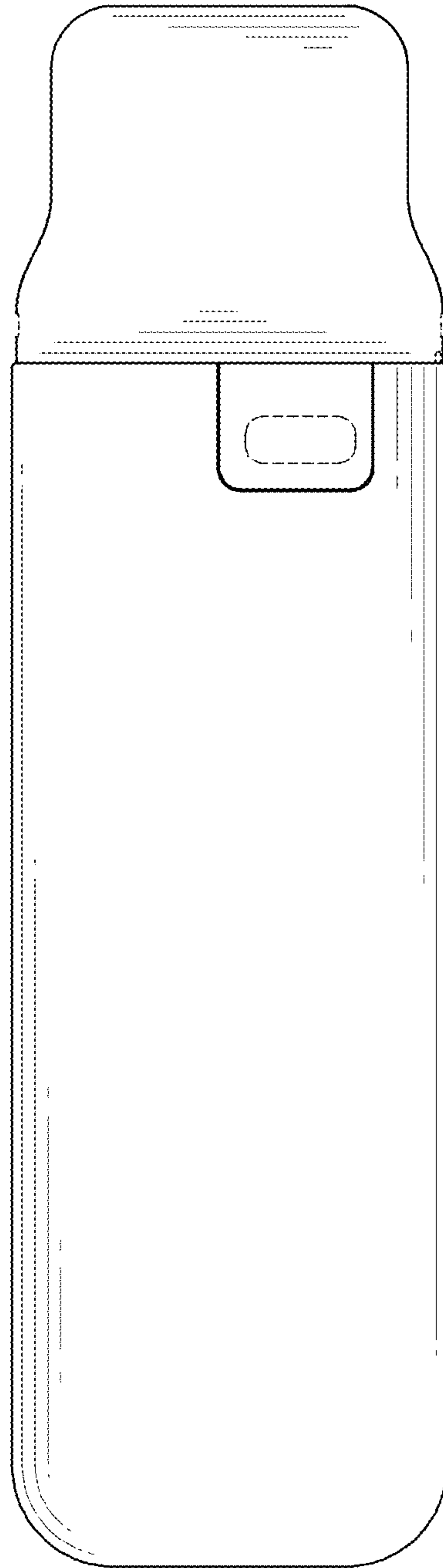

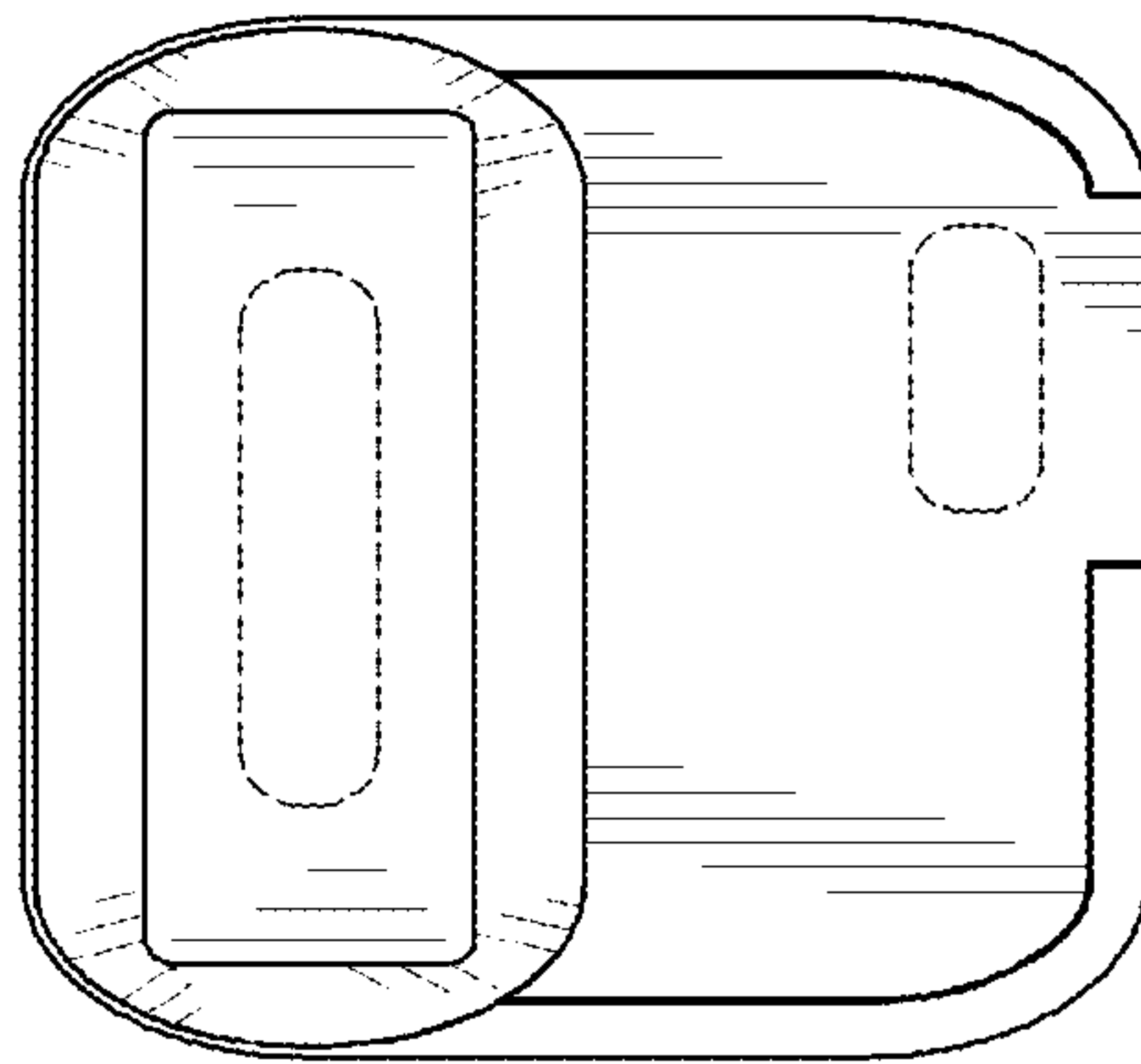

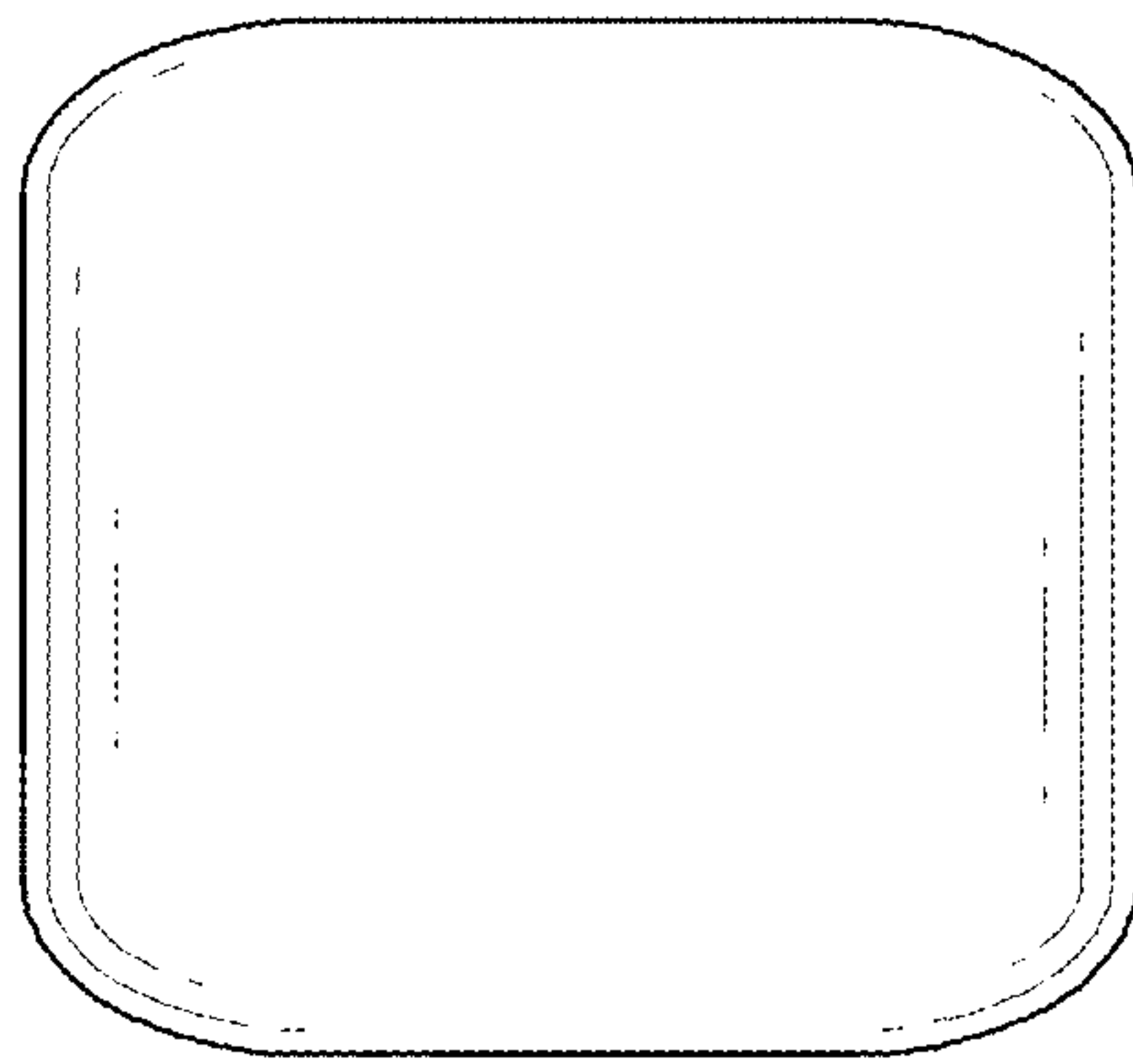
