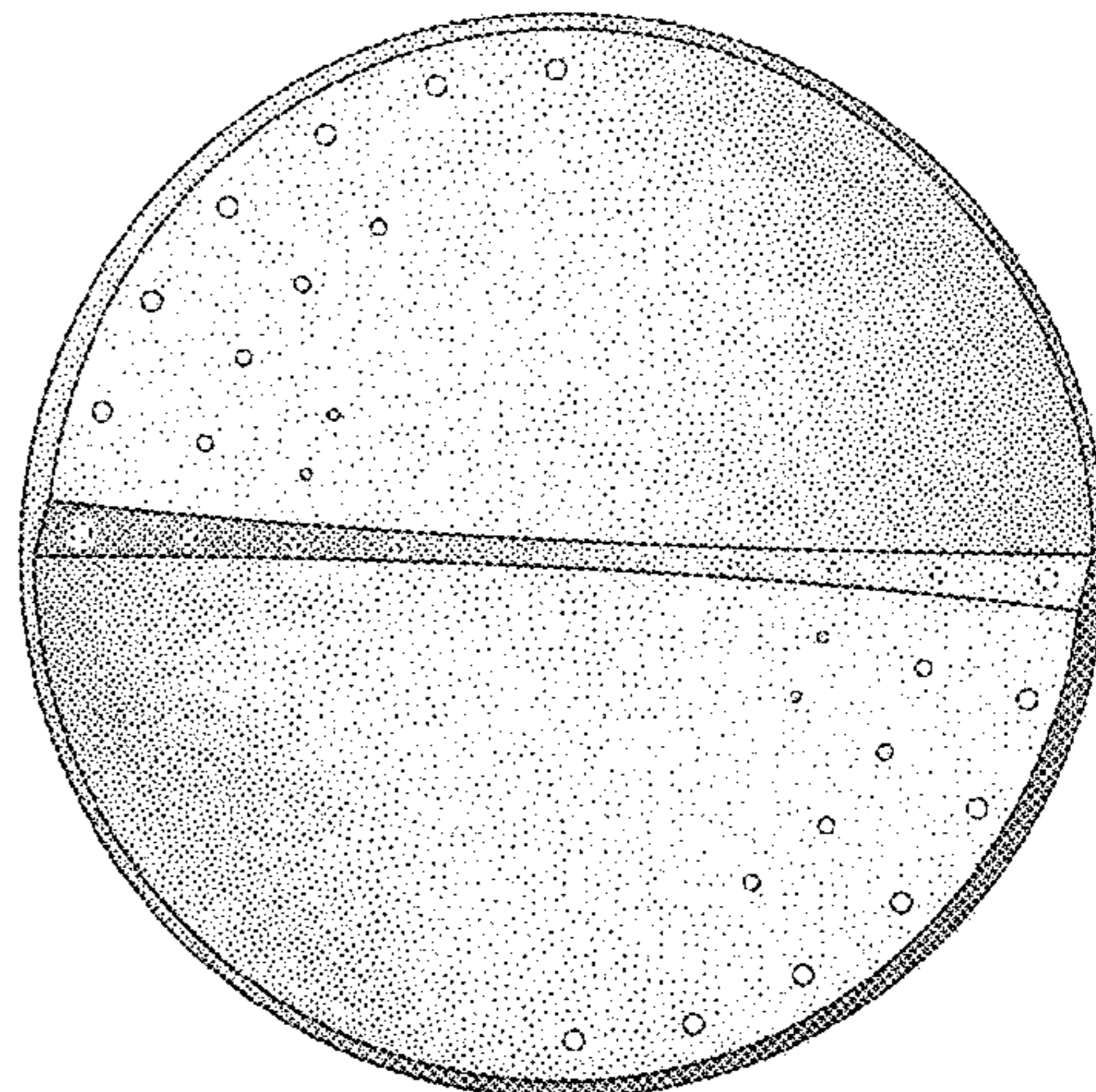
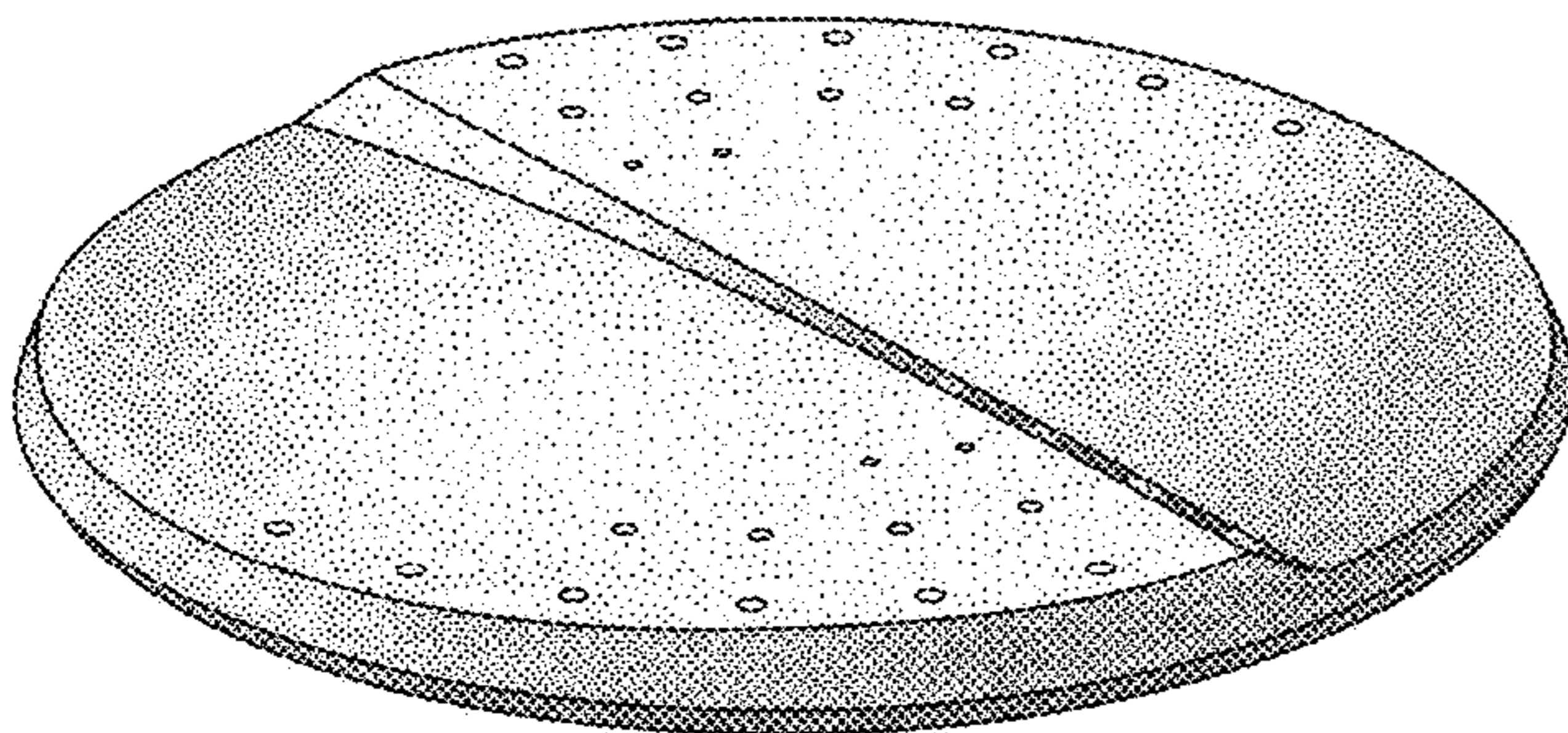
(57) **CLAIM**

The ornamental design for a sprayer for dishwasher, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view for a sprayer for dishwasher  
showing our new design, which is illustrated in an exem-  
plary location in a dishwasher;  
FIG. 2 is an enlarged perspective view of a sprayer for  
dishwasher;  
FIG. 3 is a front view thereof, the rear view being a mirror  
image thereof;  
FIG. 4 is a right side view thereof, the left side being a mirror  
image thereof; and,  
FIG. 5 is a top view thereof.  
The solid line circles in the claim illustrate holes. The areas  
inside the solid line circles are not part of the claimed design.  
The broken line holes on the article illustrate boundaries of  
the claim and are not part of the claimed design. The  
additional broken lines in FIG. 1 illustrate environment and  
form no part of the claimed design.

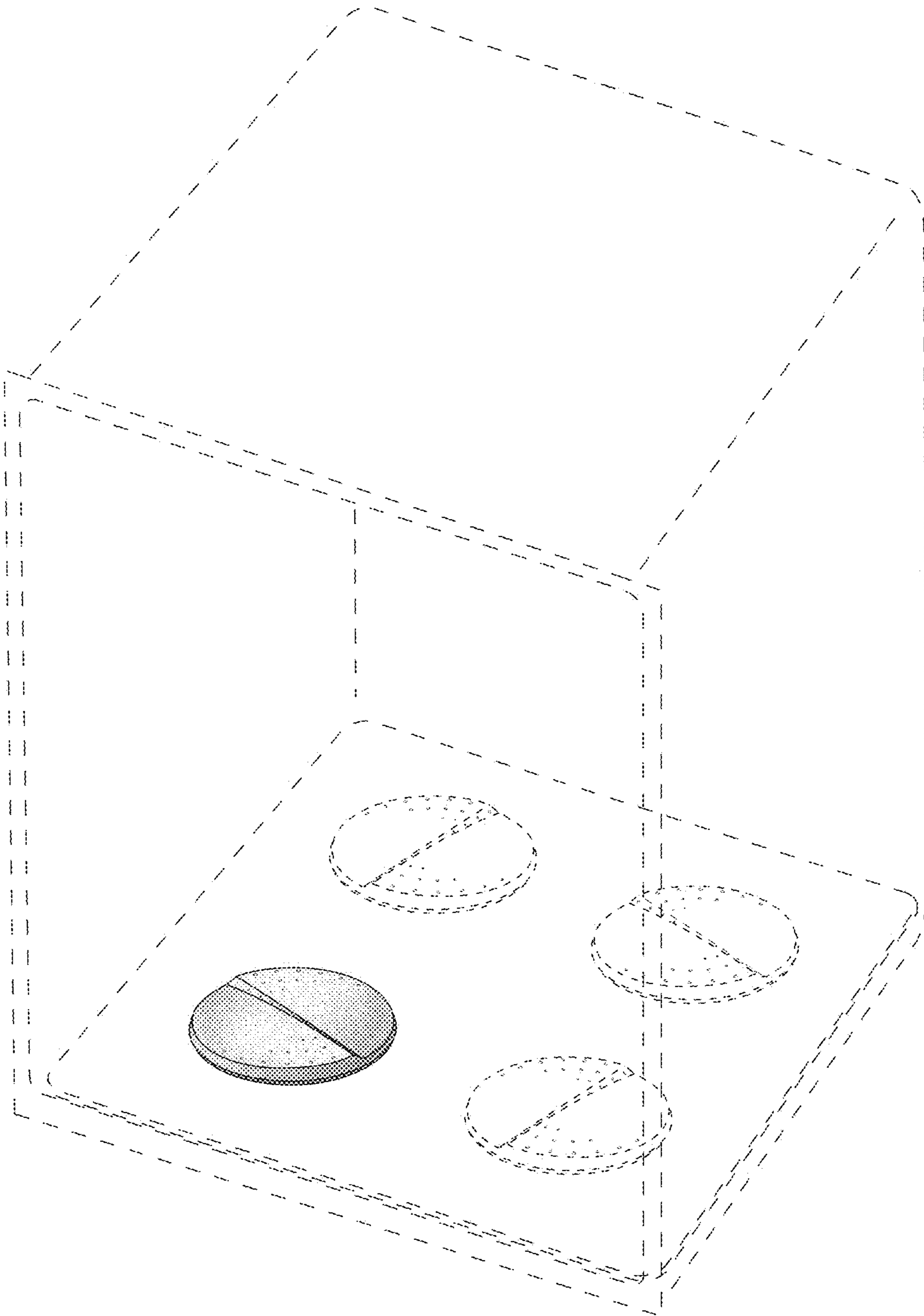

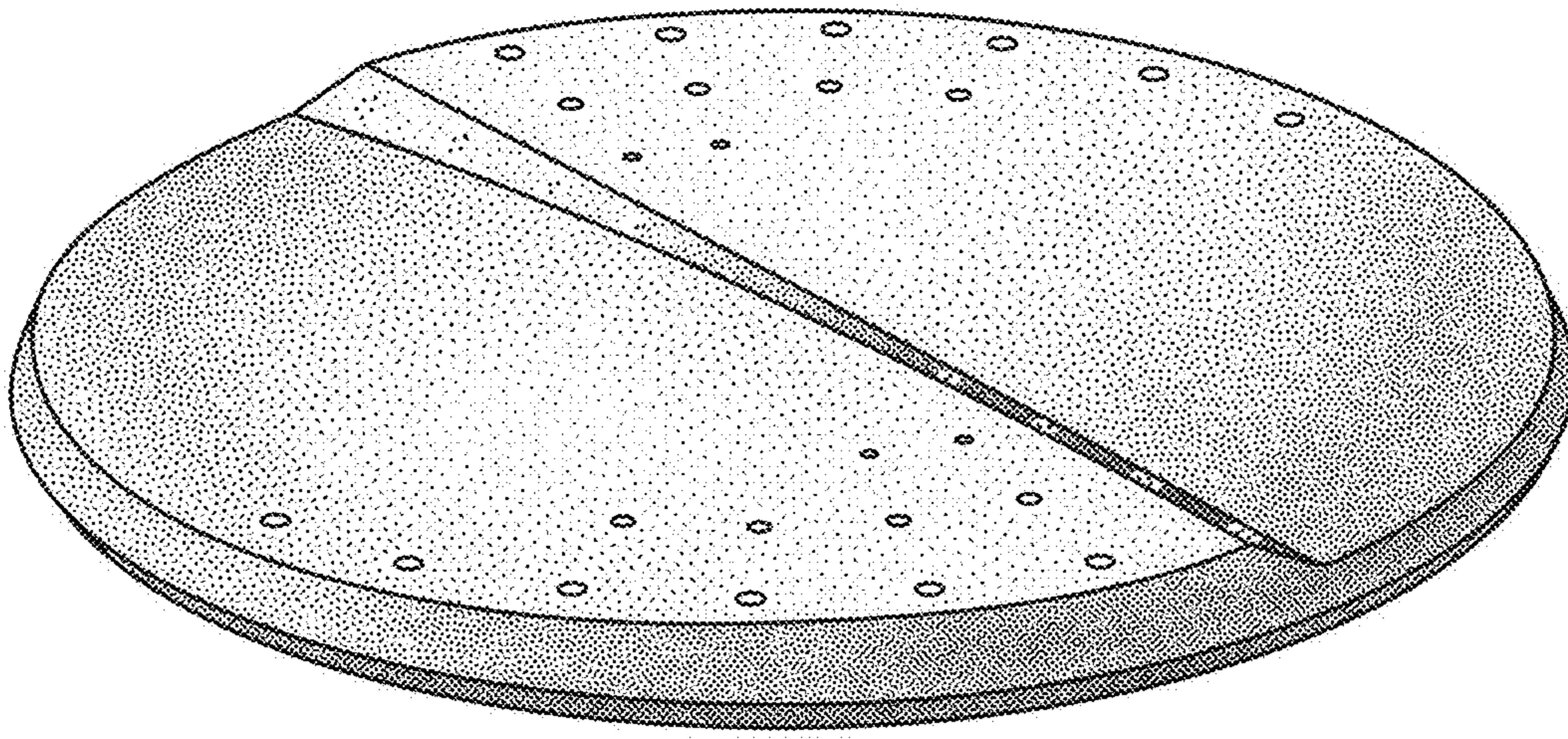

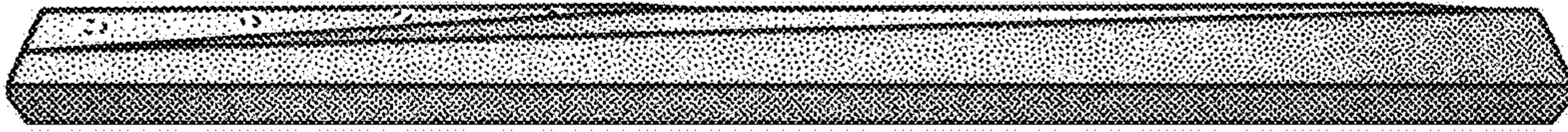

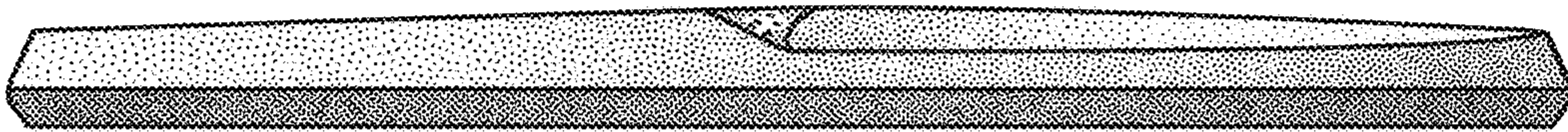

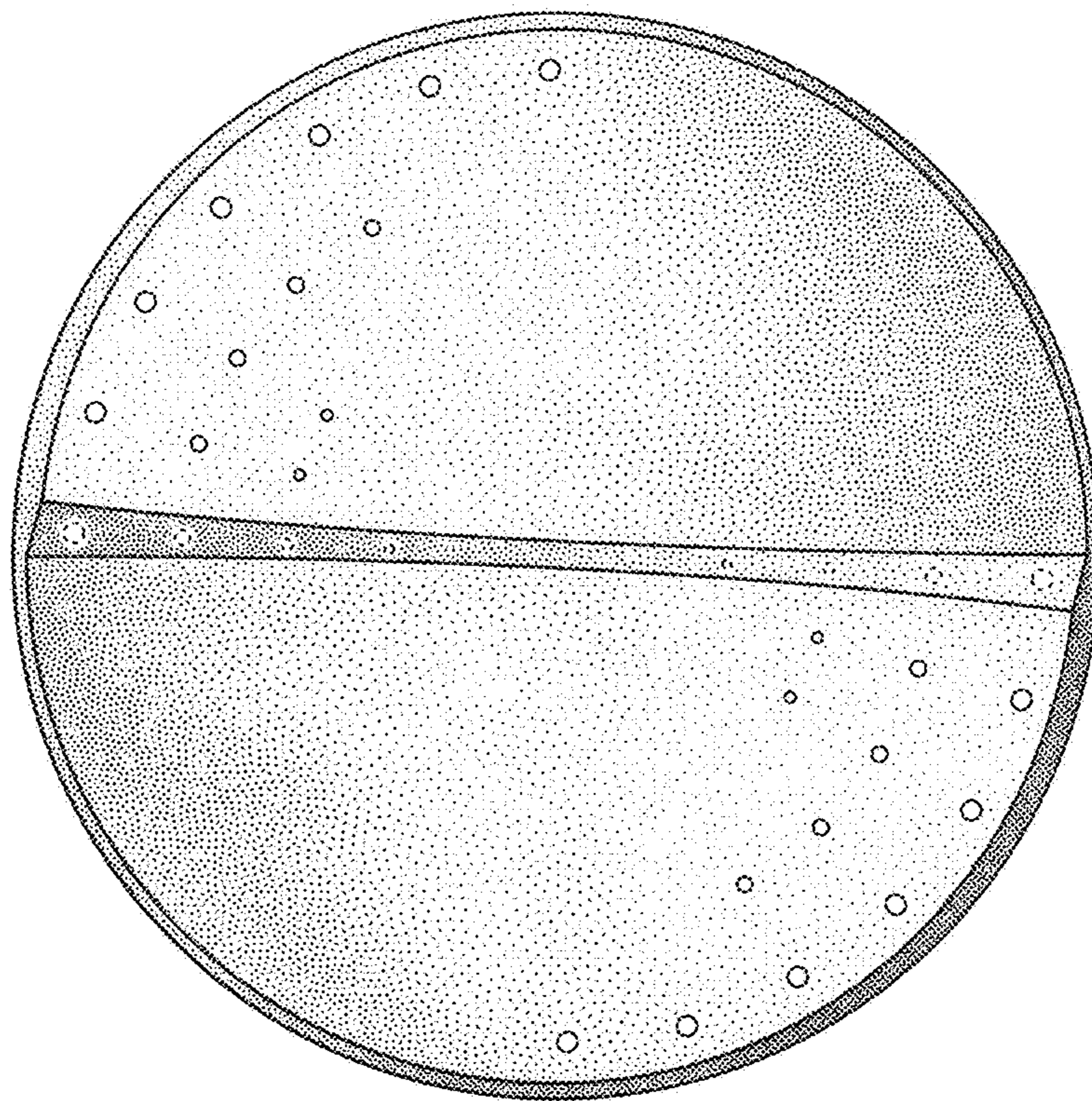
