(57) **CLAIM**

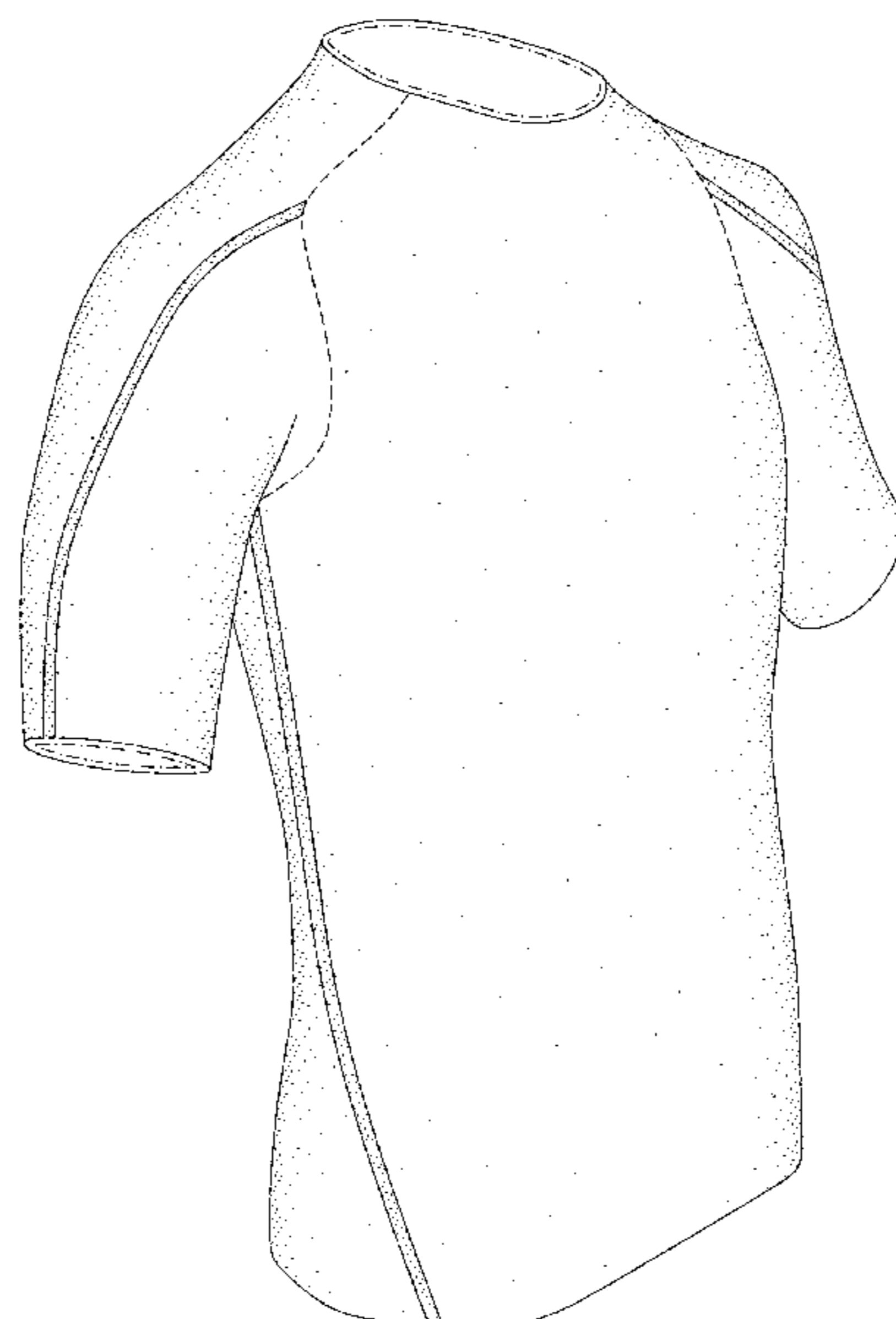
The ornamental design for a garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a garment showing my new design in an in-use configuration;

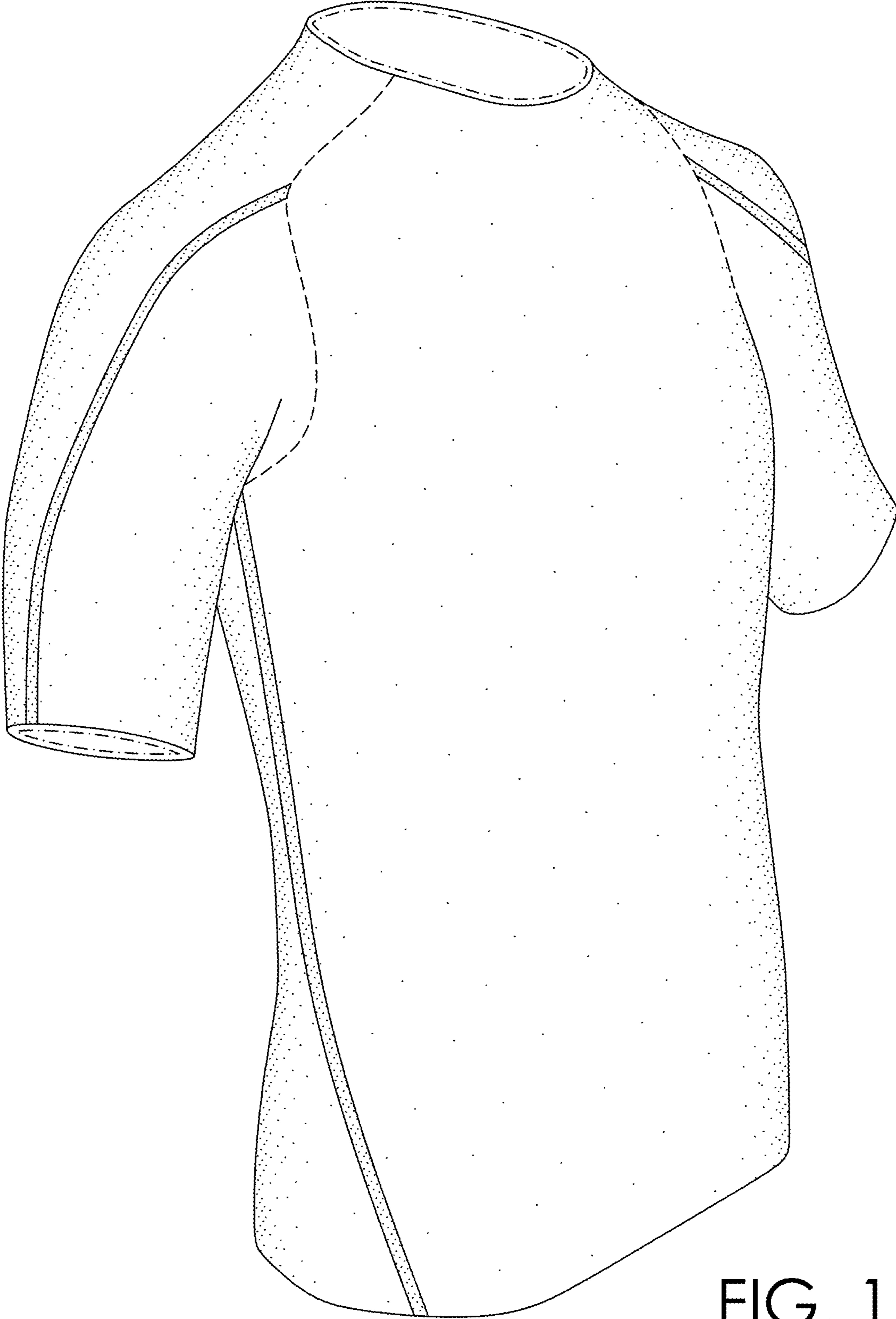

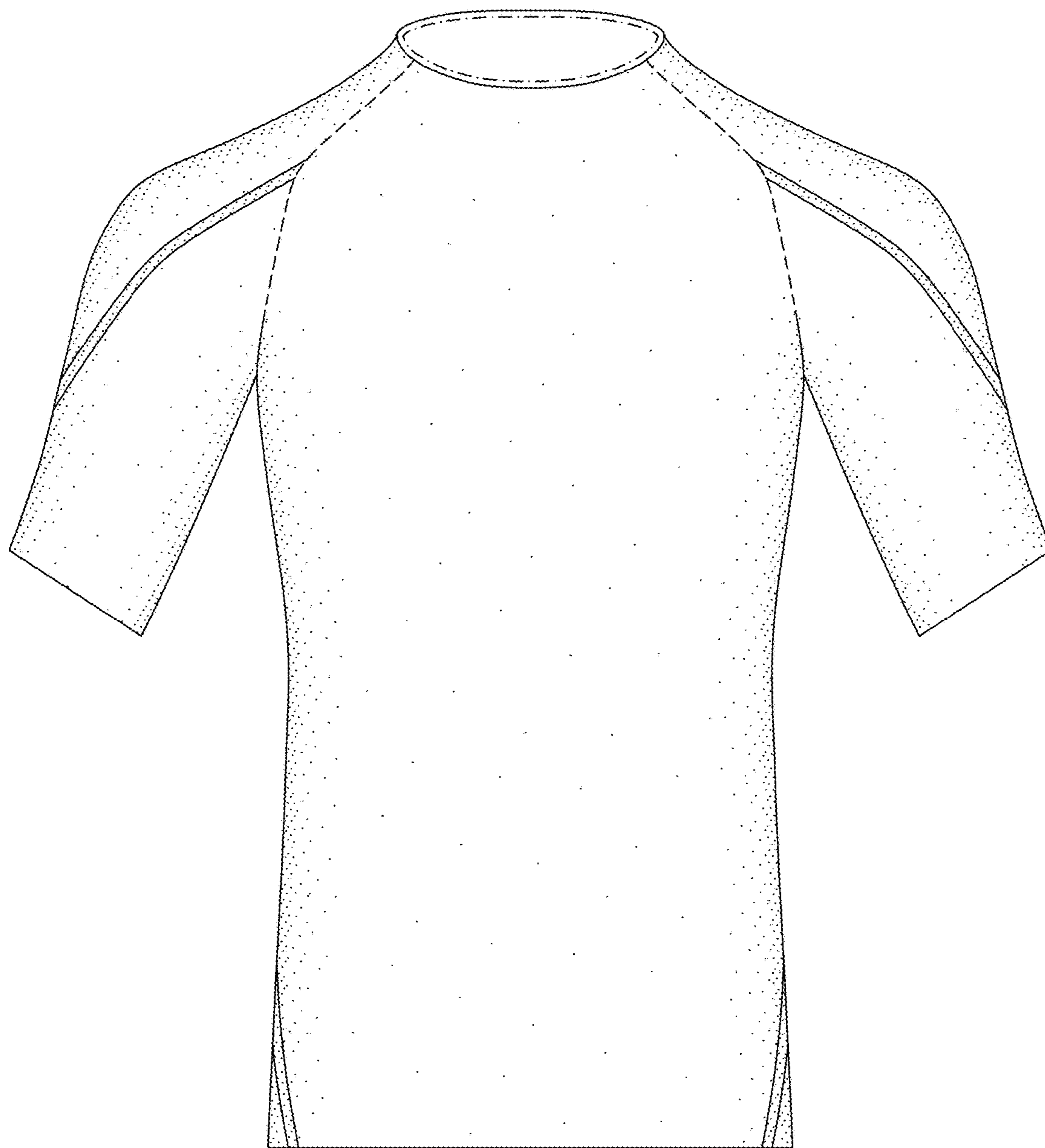

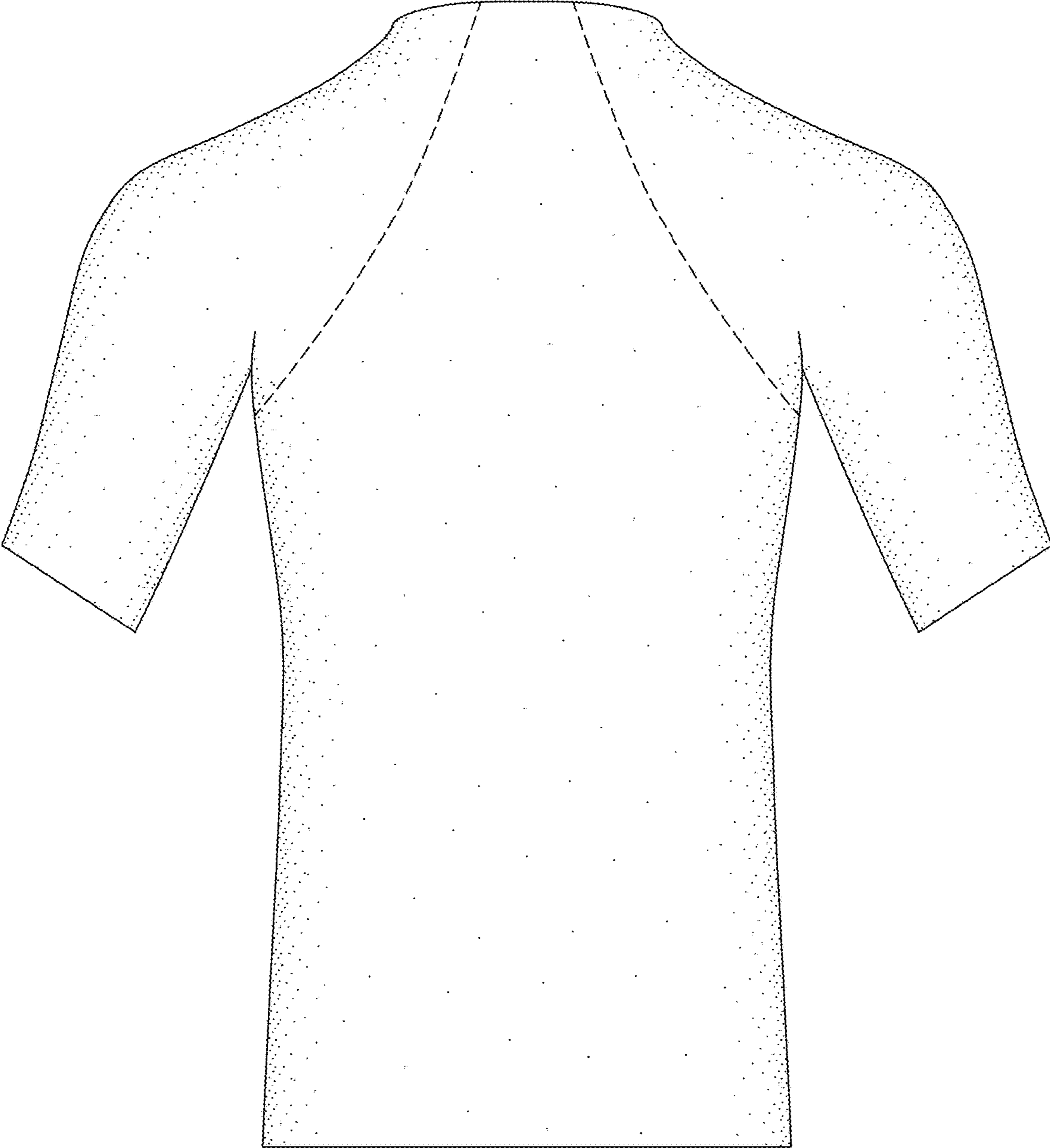

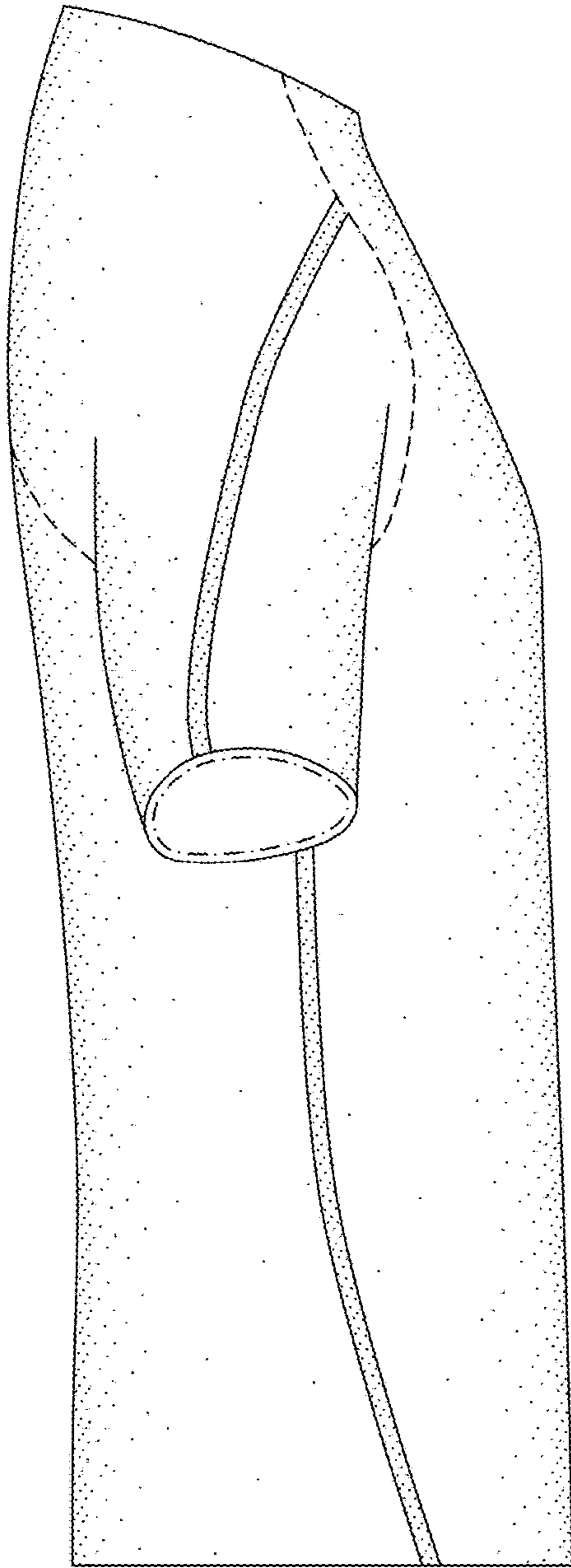

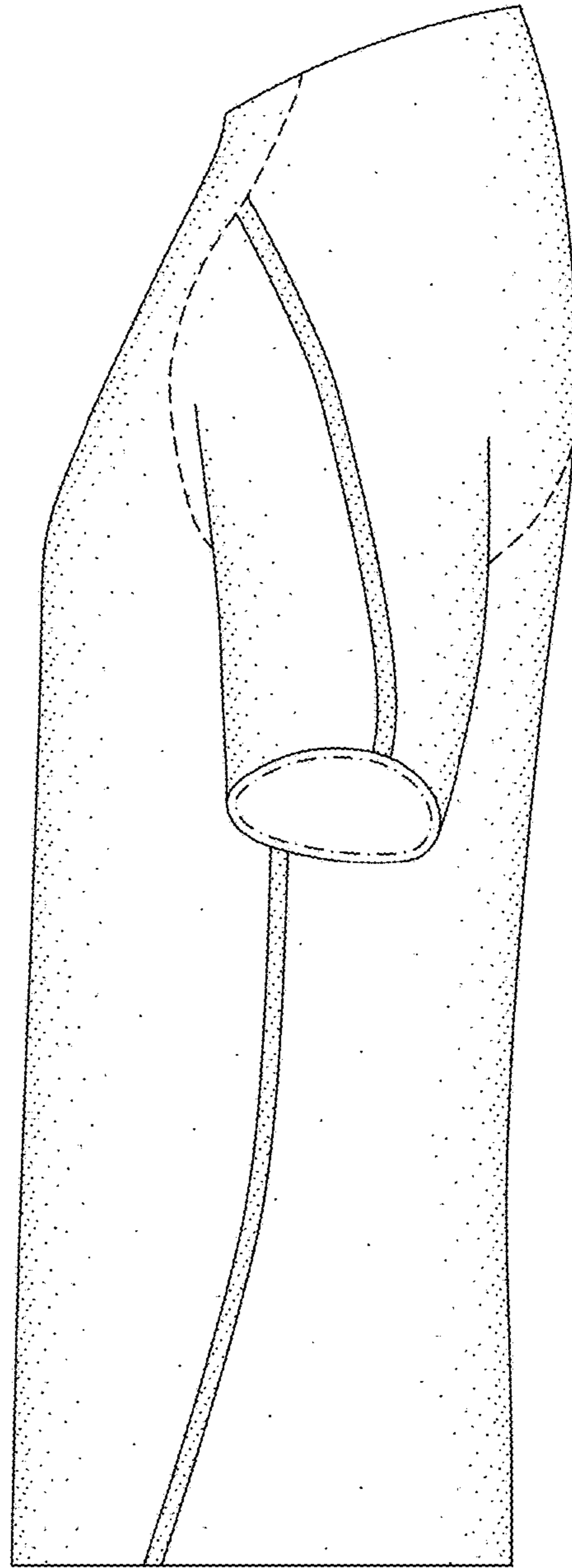

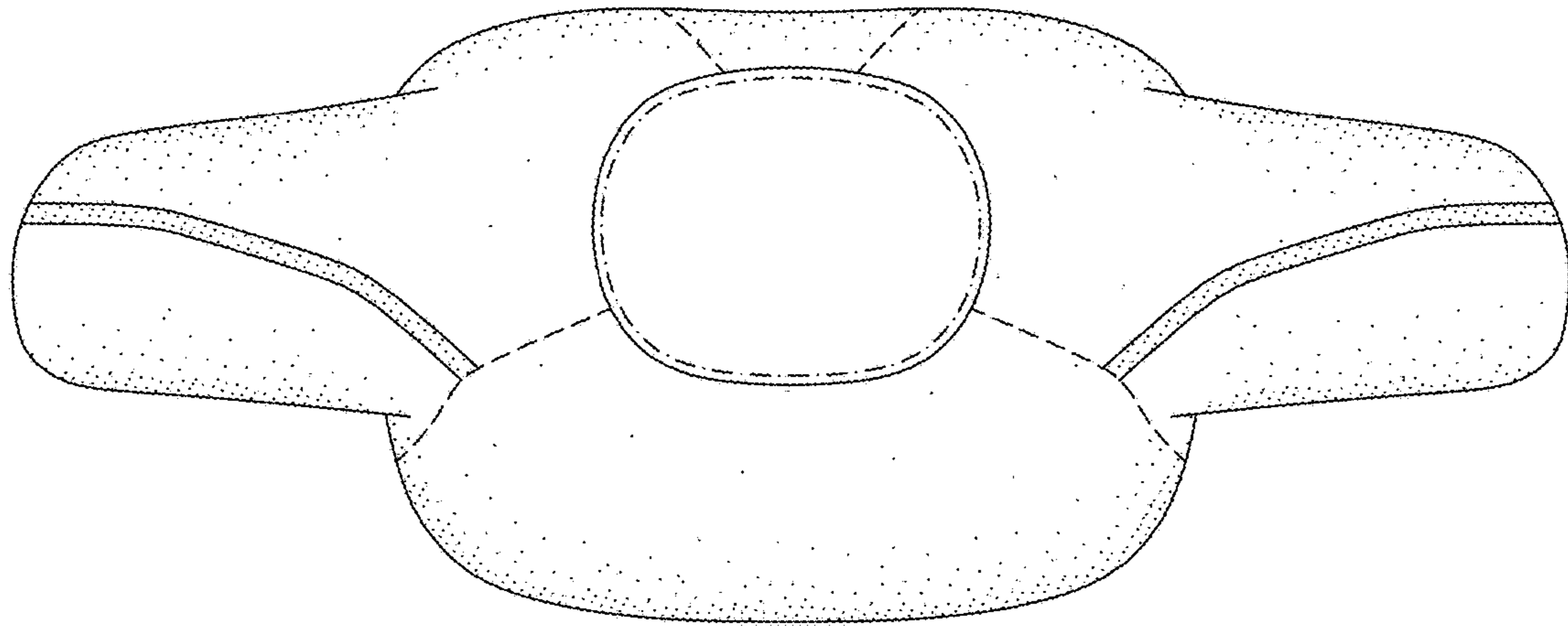

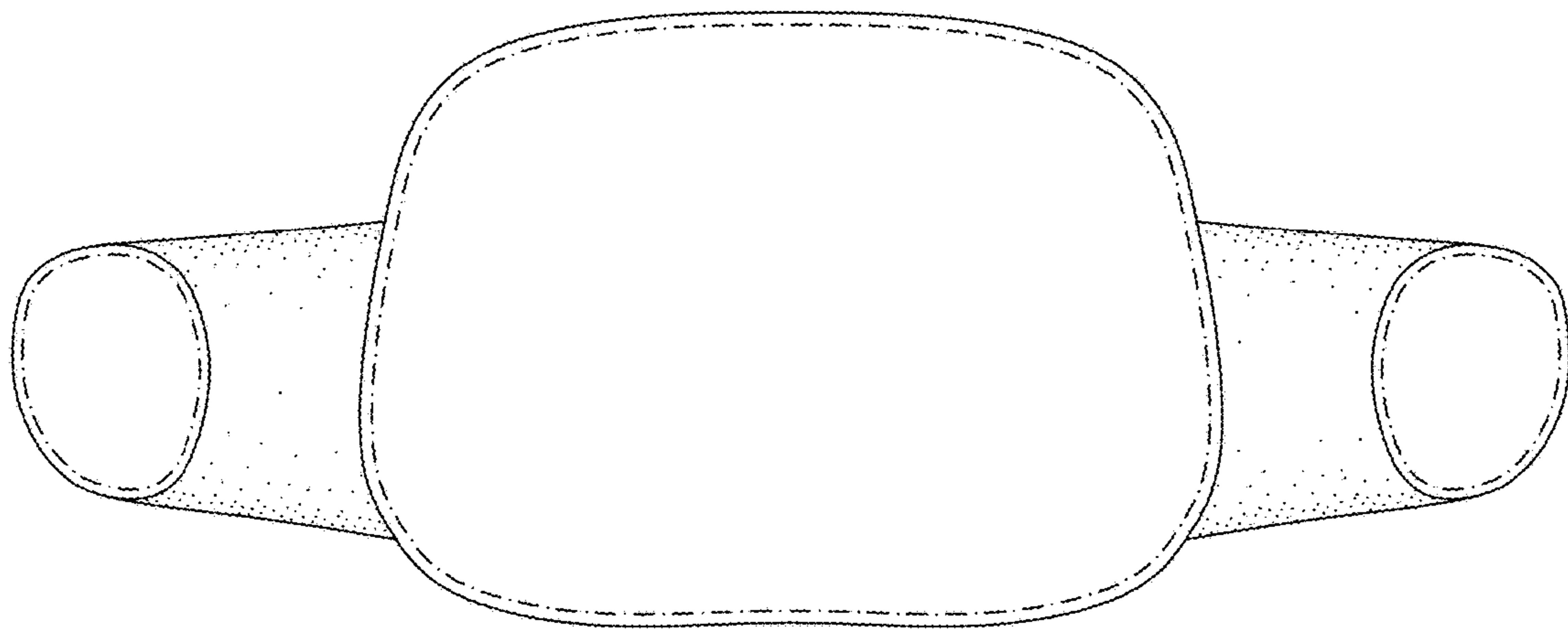
