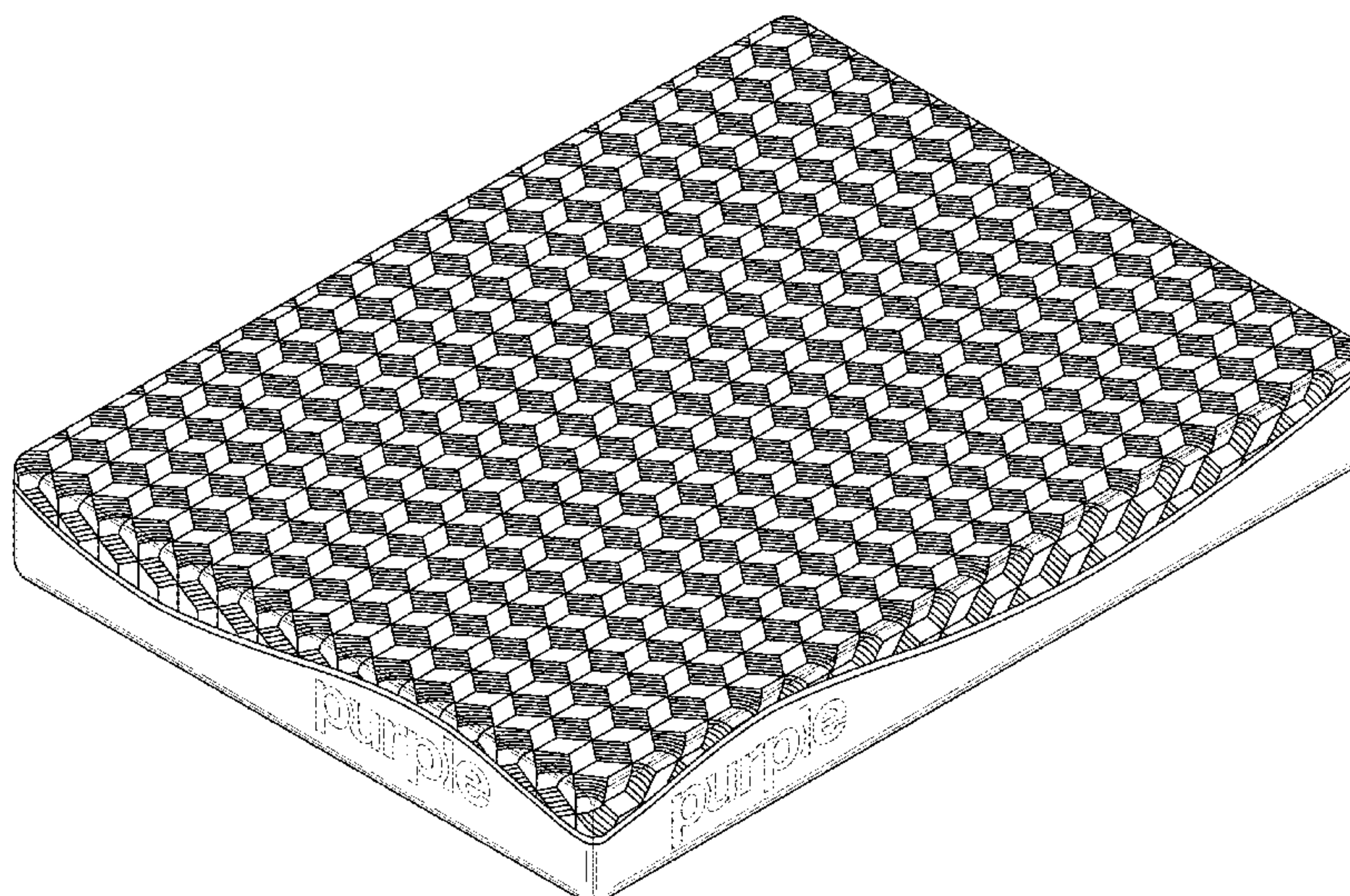
The broken lines shown in the drawings represent portions of the mattress cushion that form no part of the claimed design.

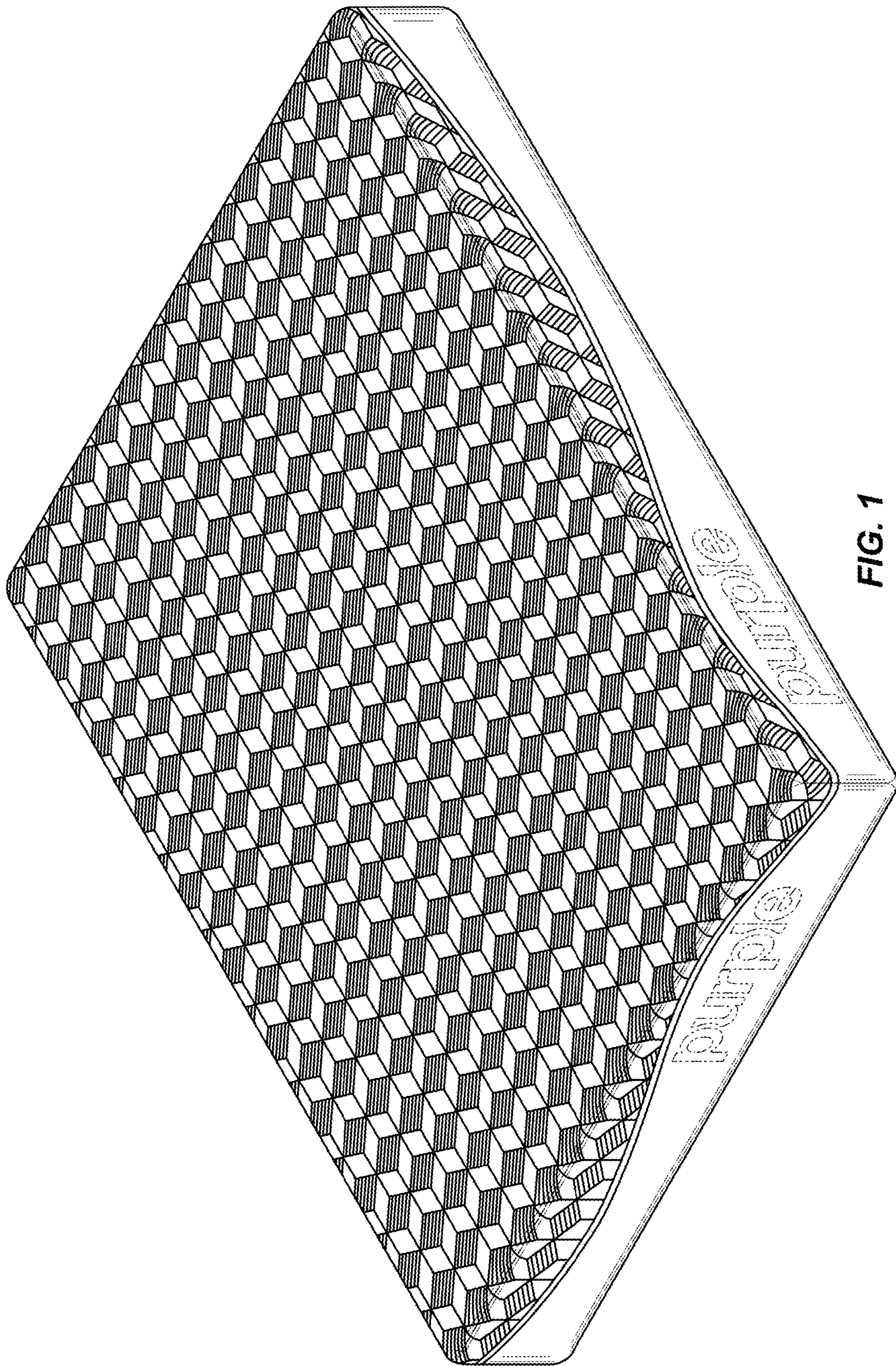

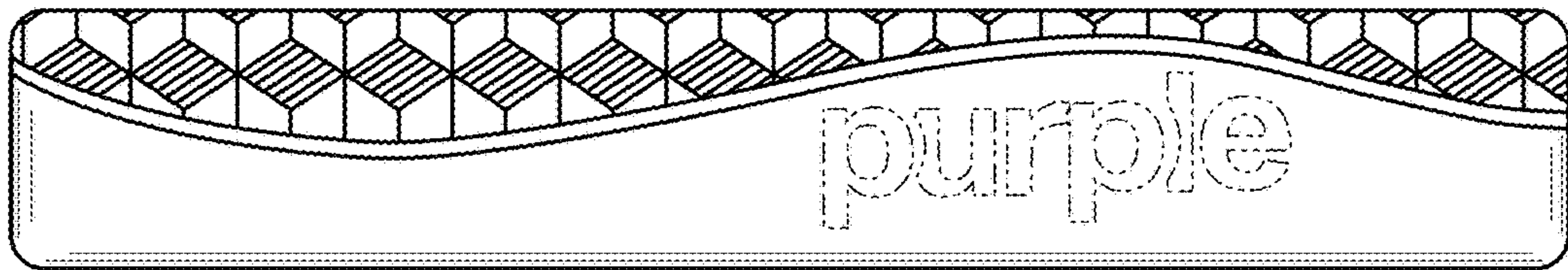

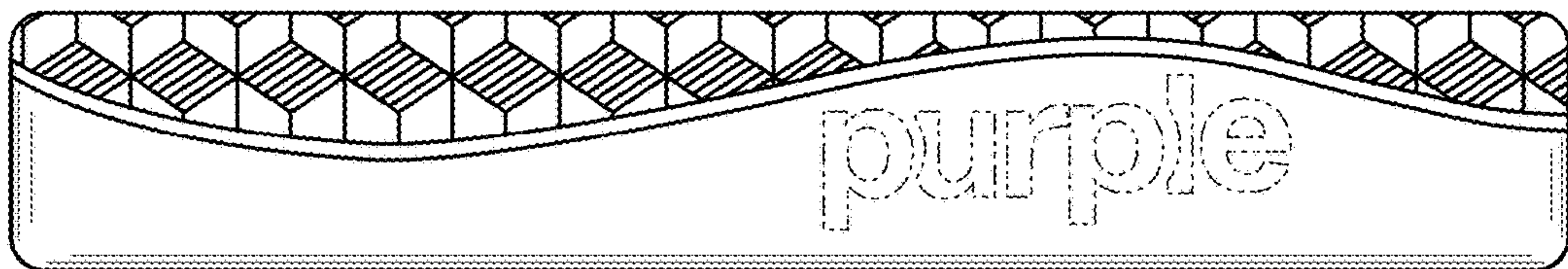

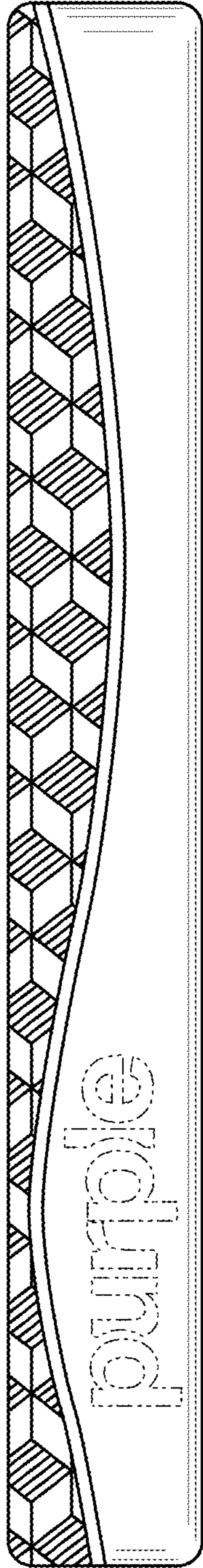

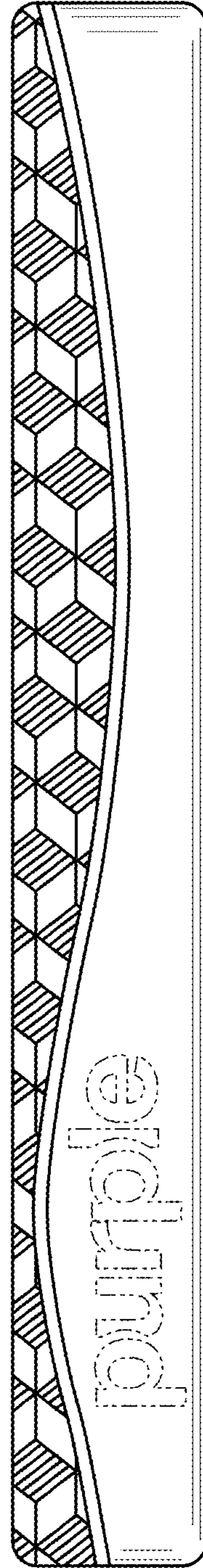

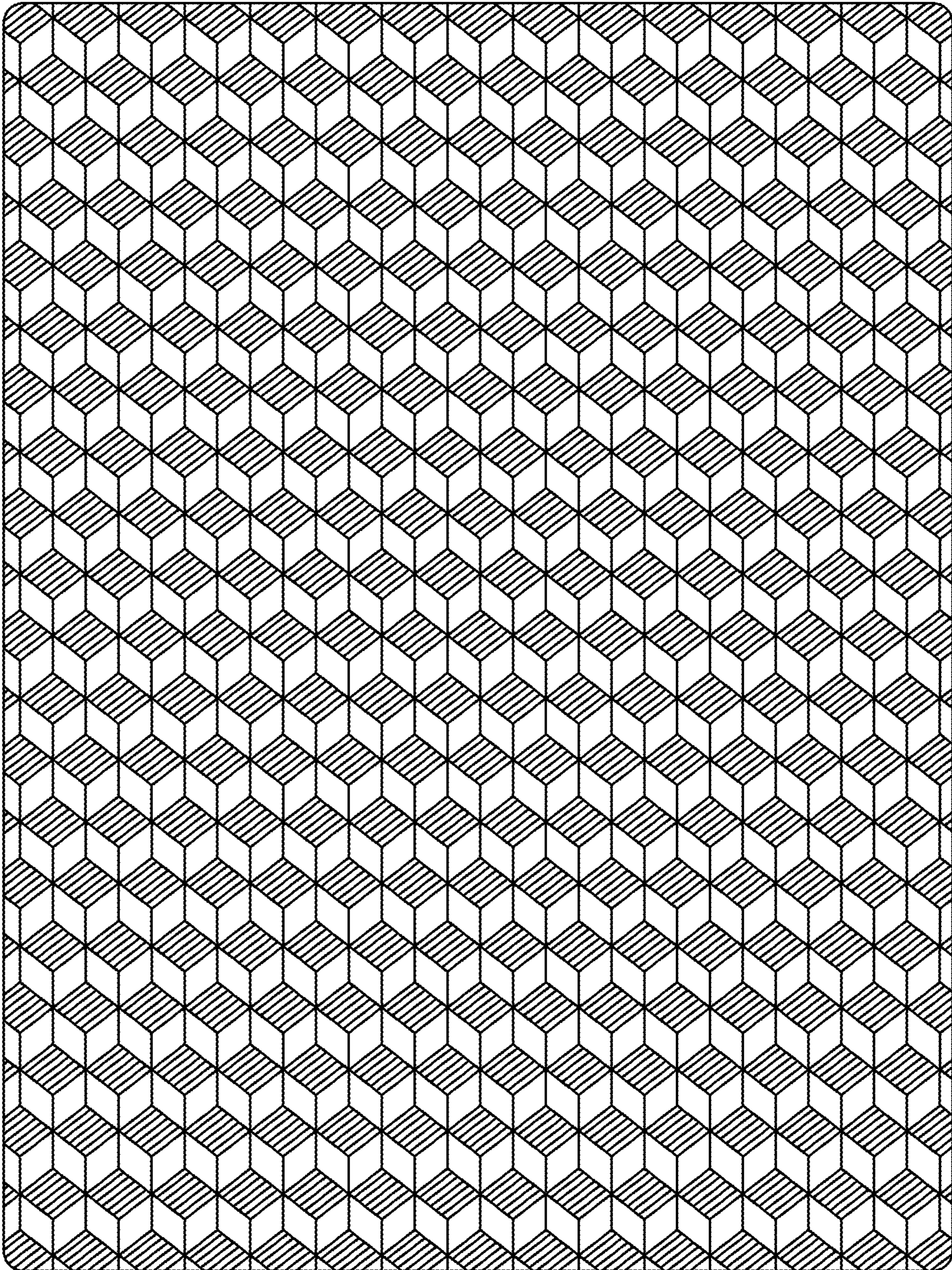

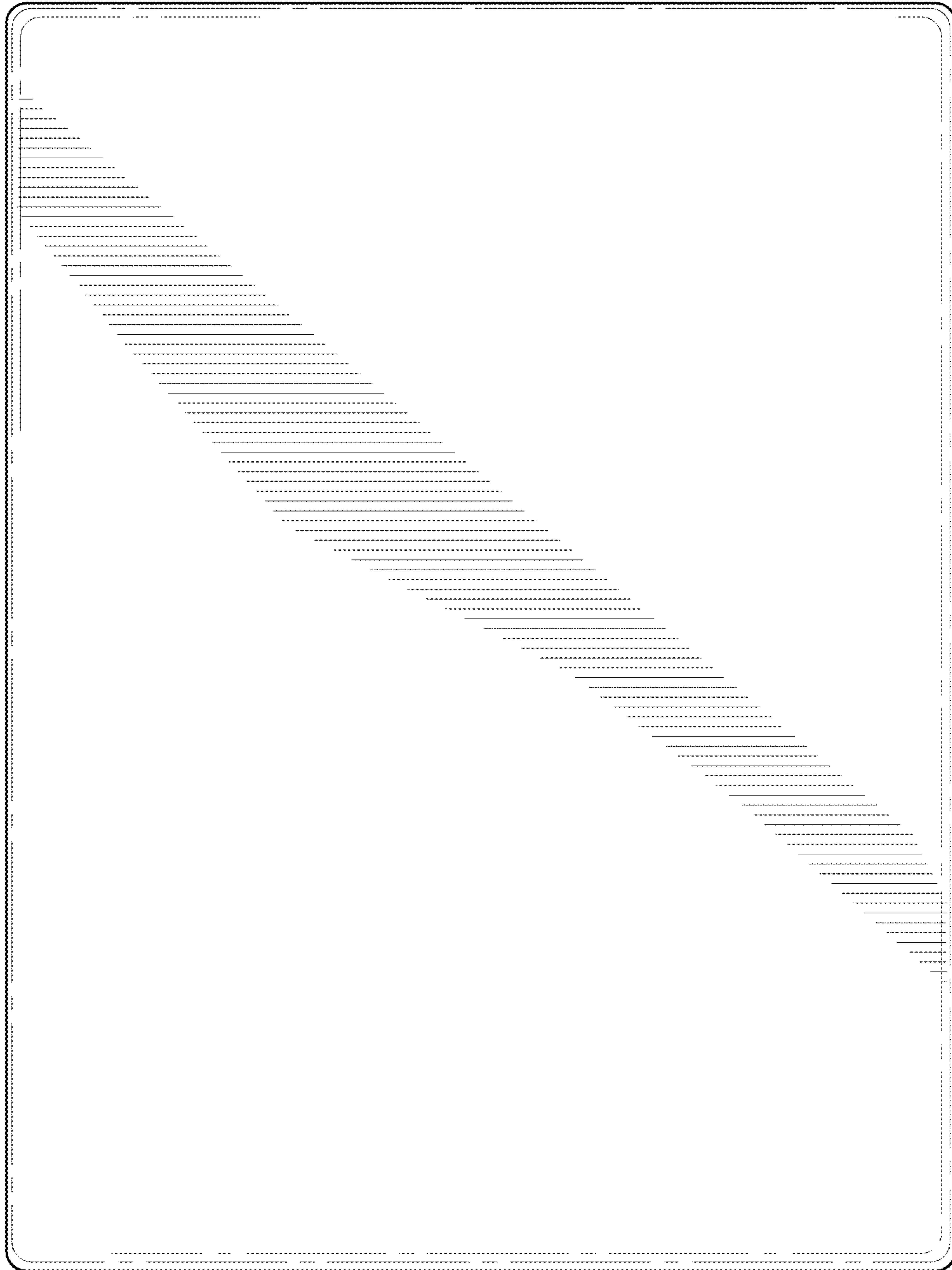
