DESCRIPTION

FIG. 15 is a left side view of FIG. 12;

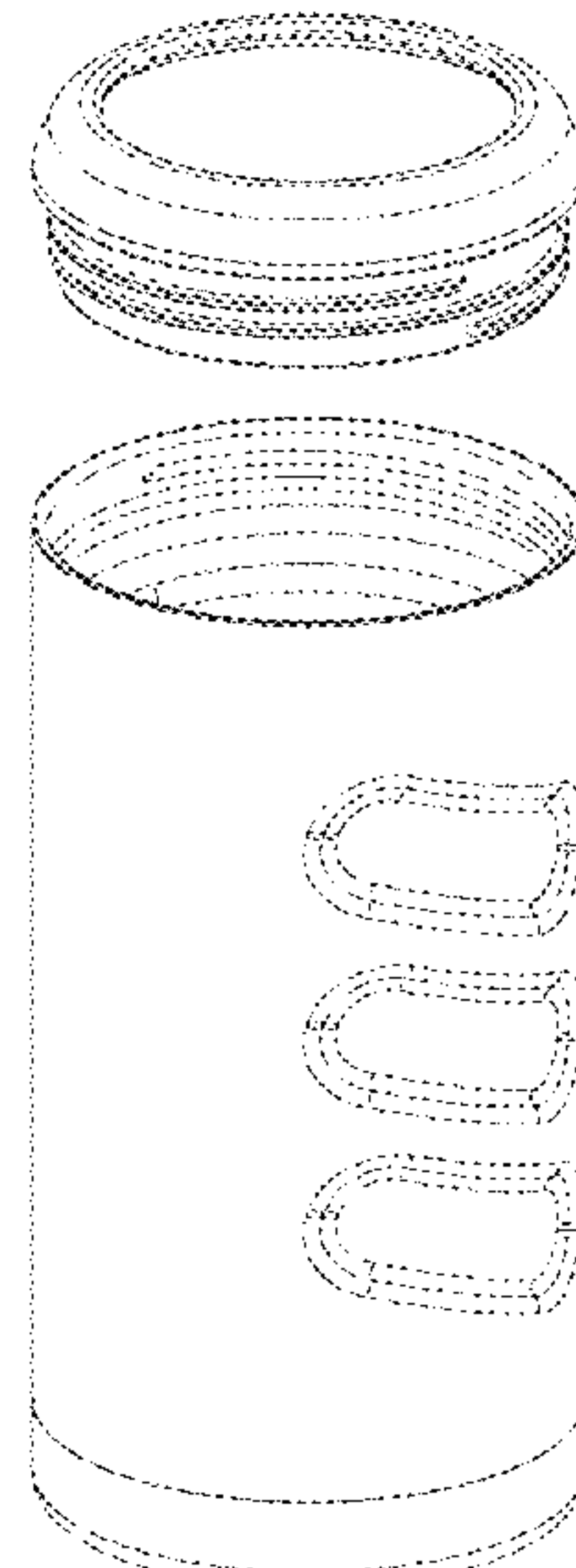
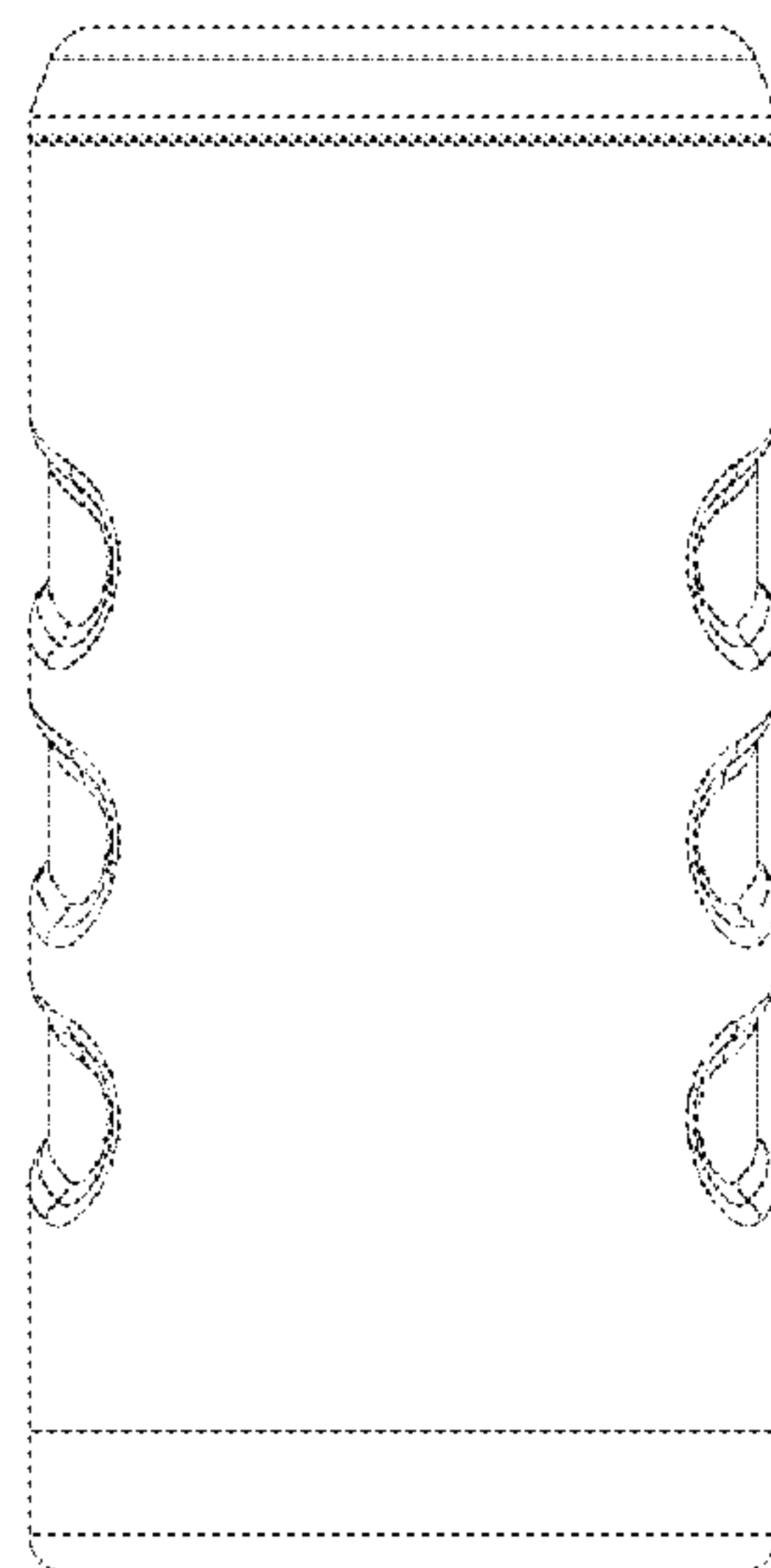
FIG. 16 is a top view of FIG. 12;

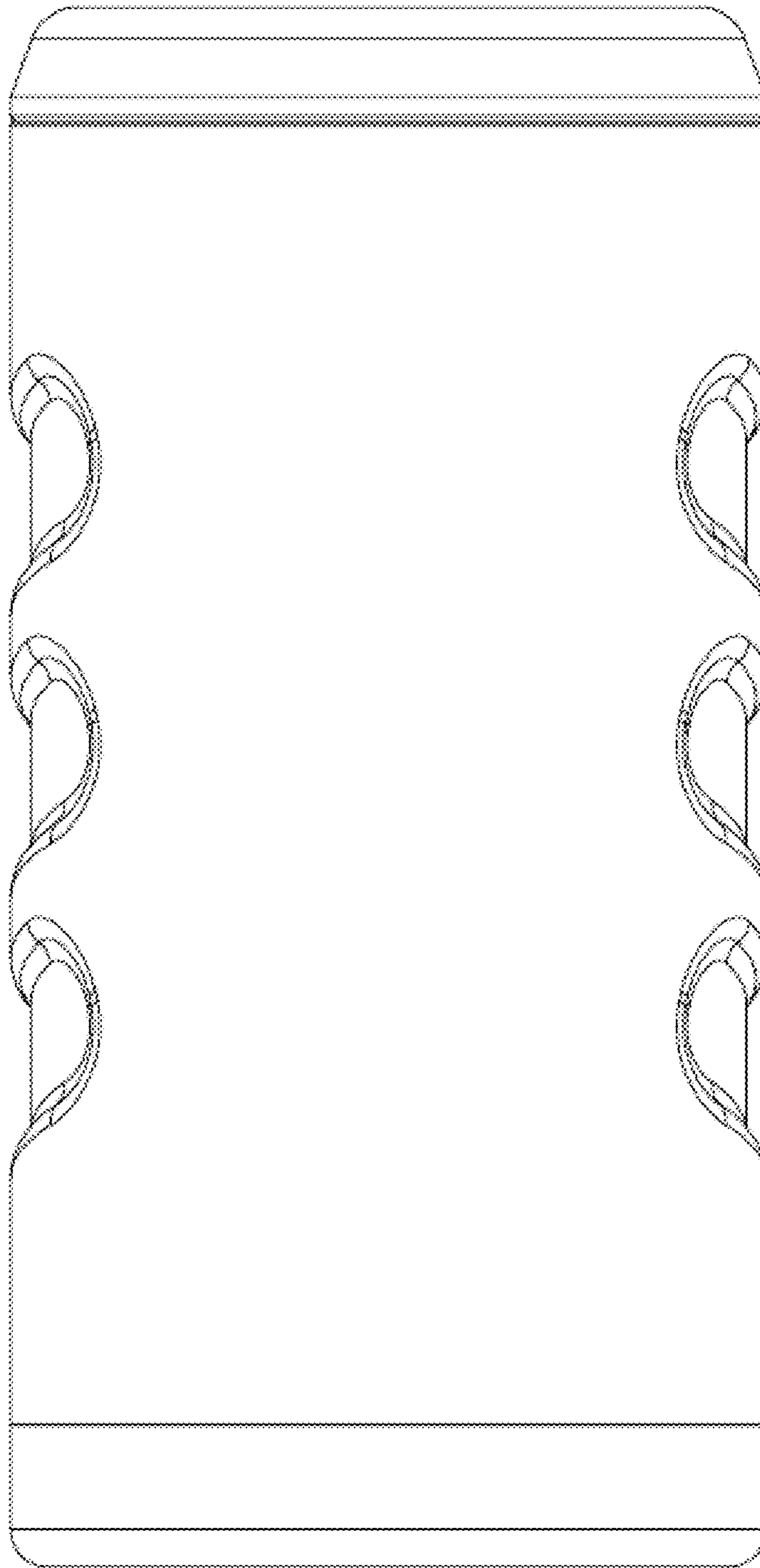

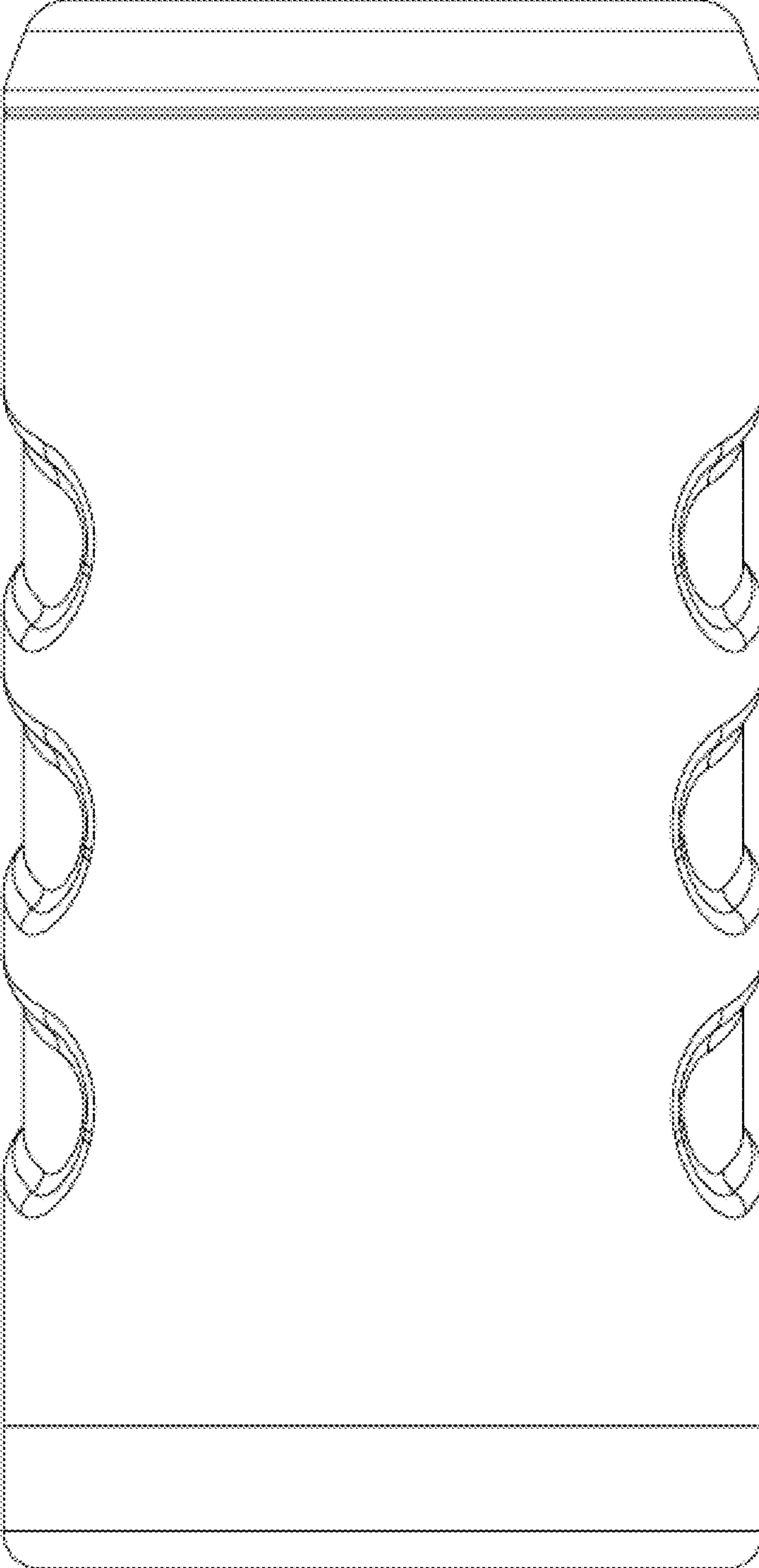

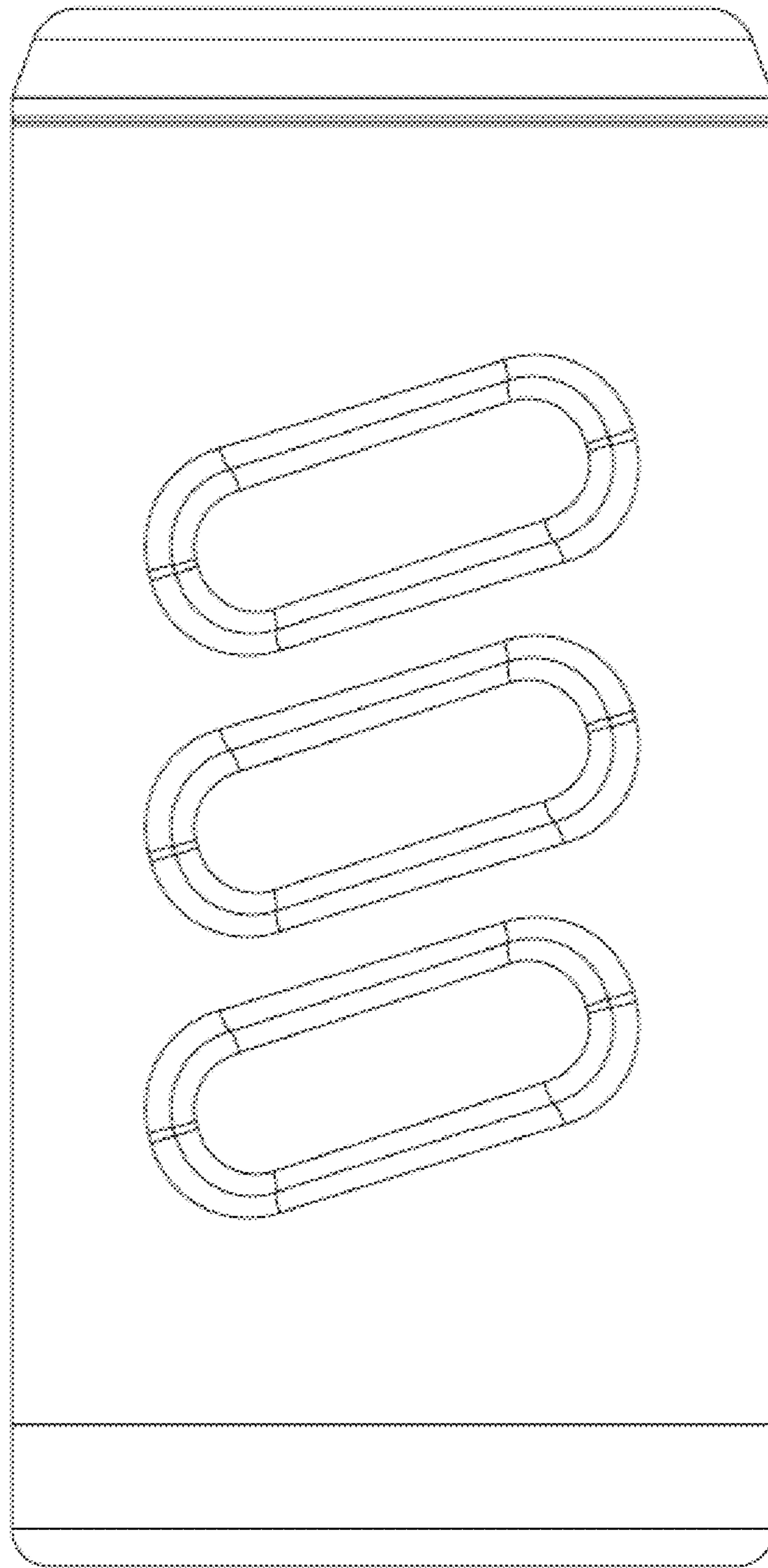

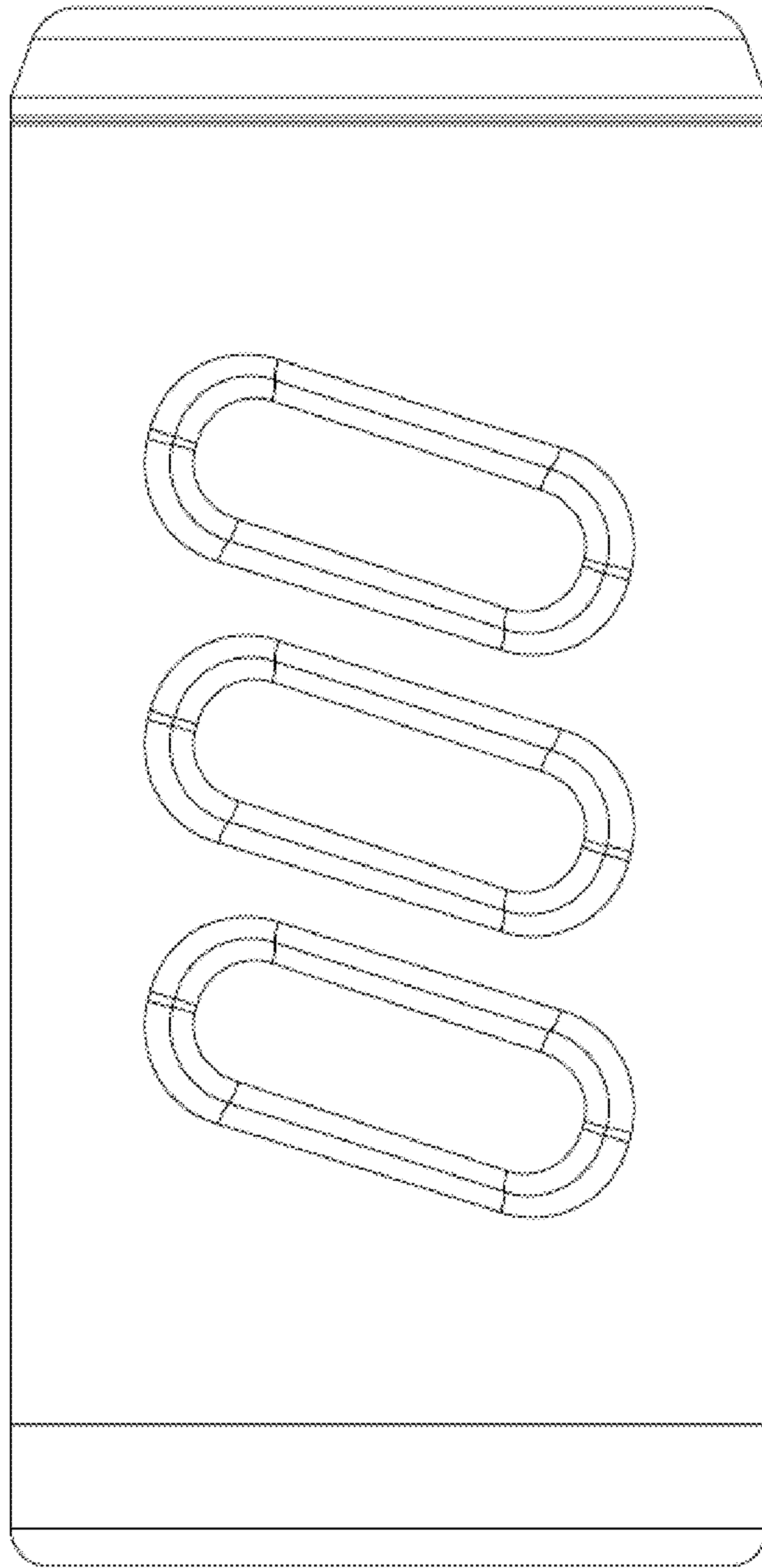

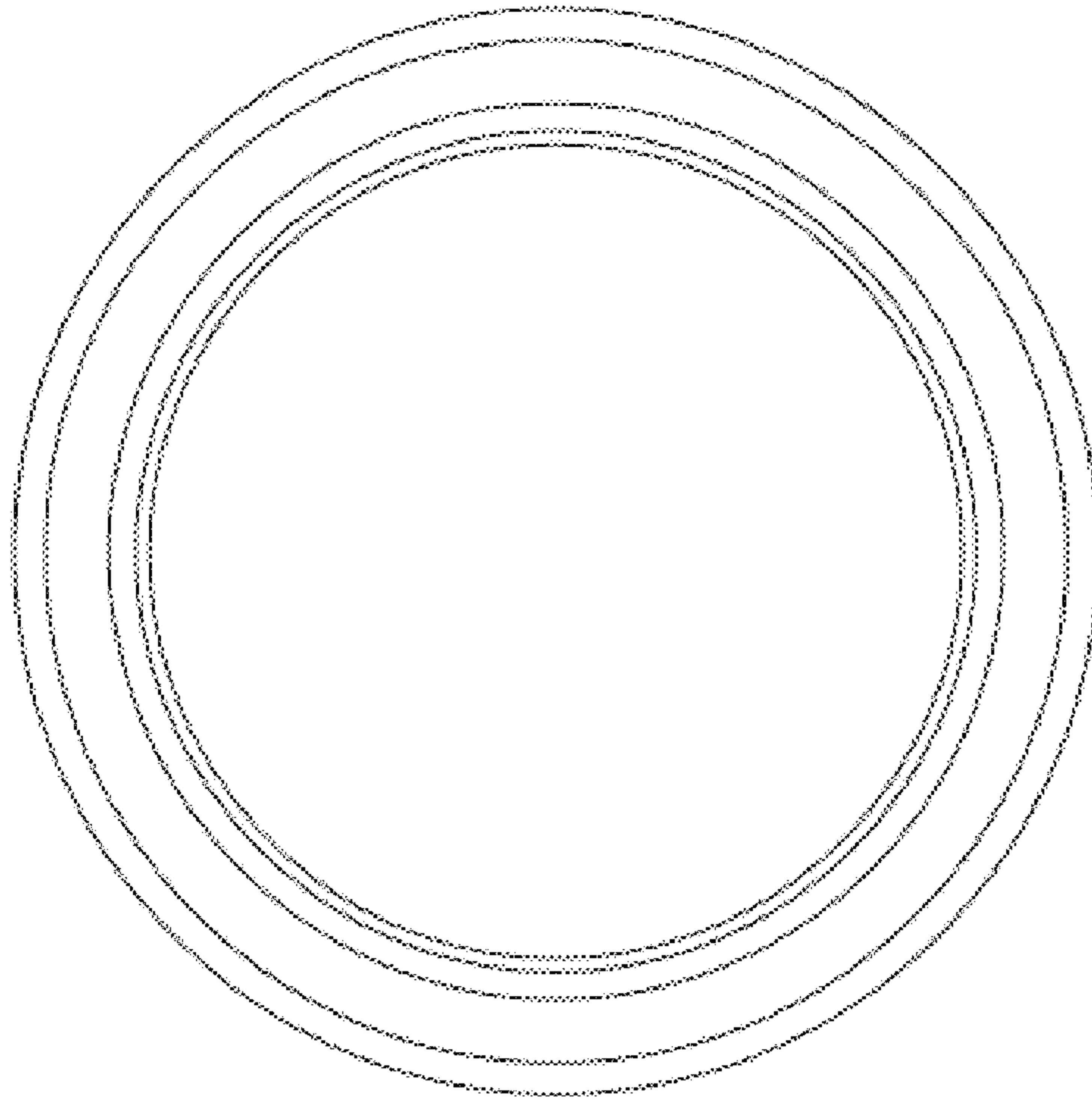

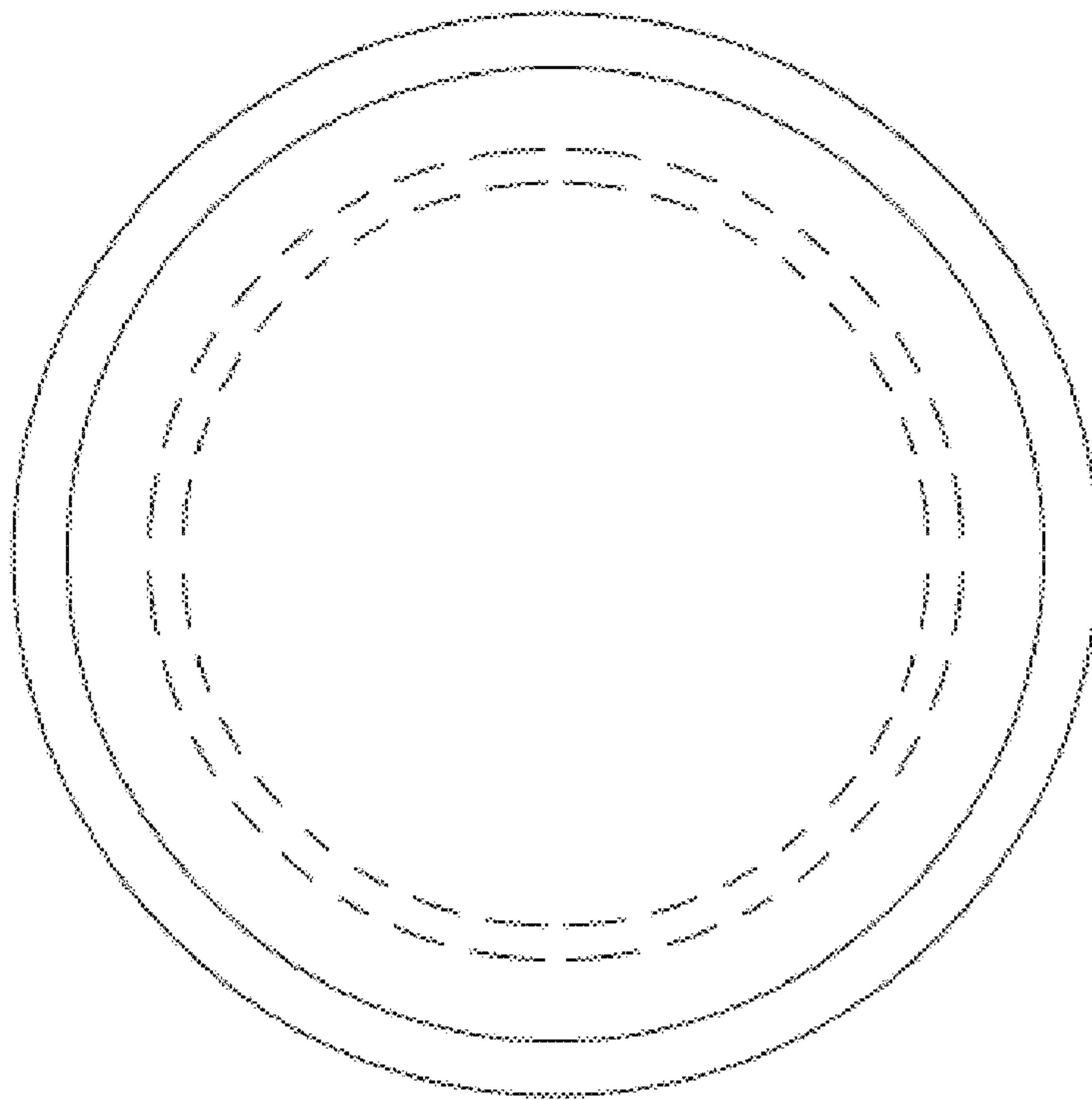

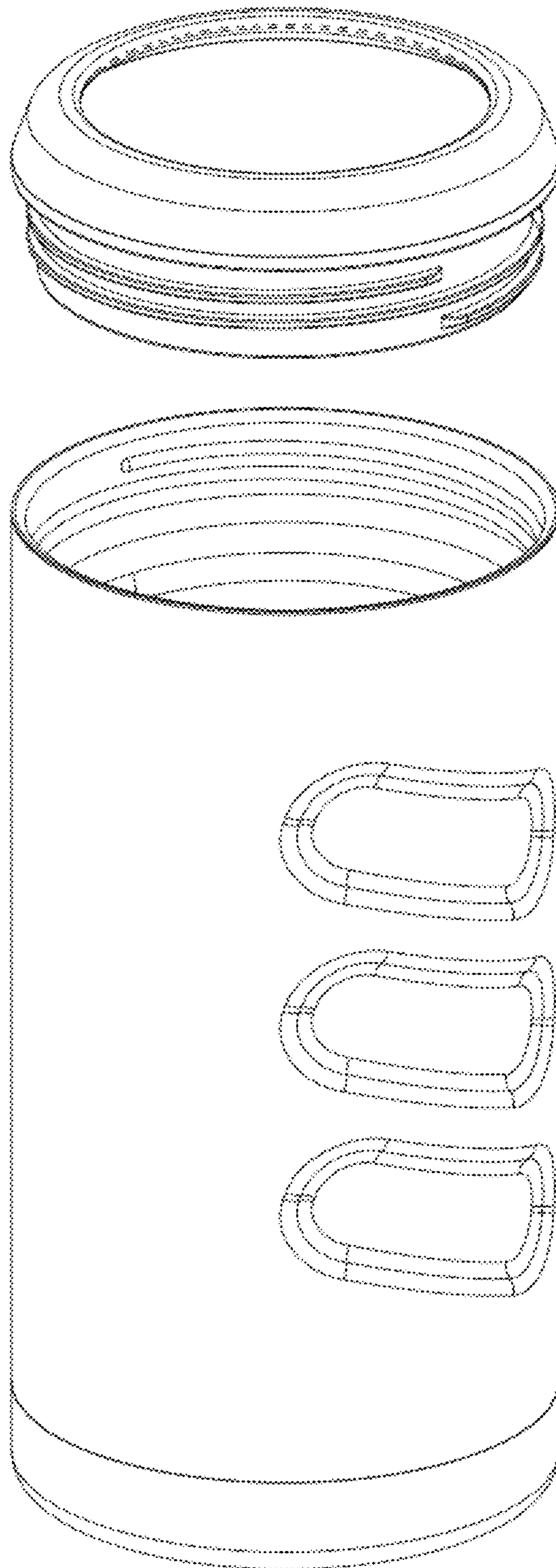

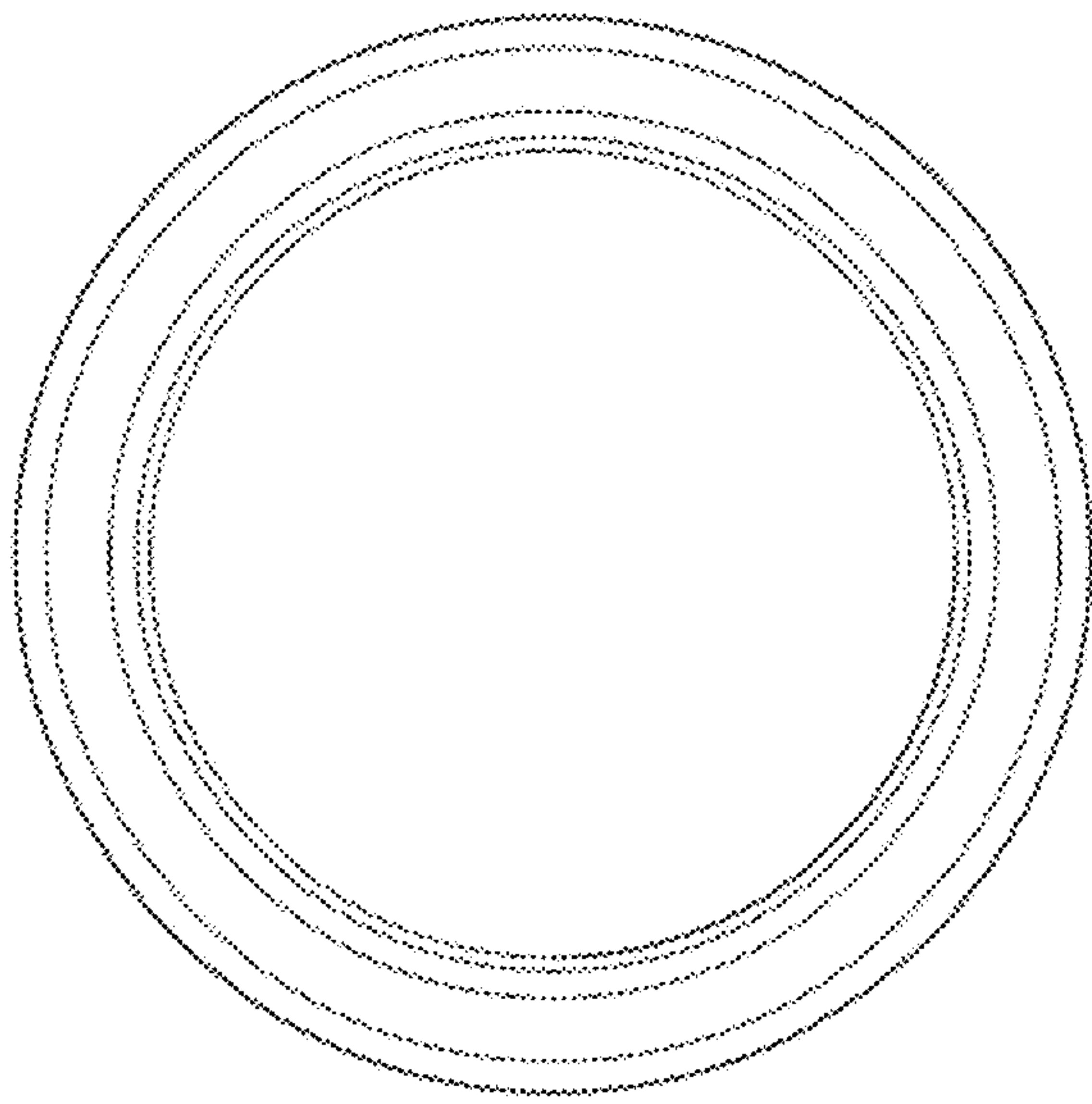

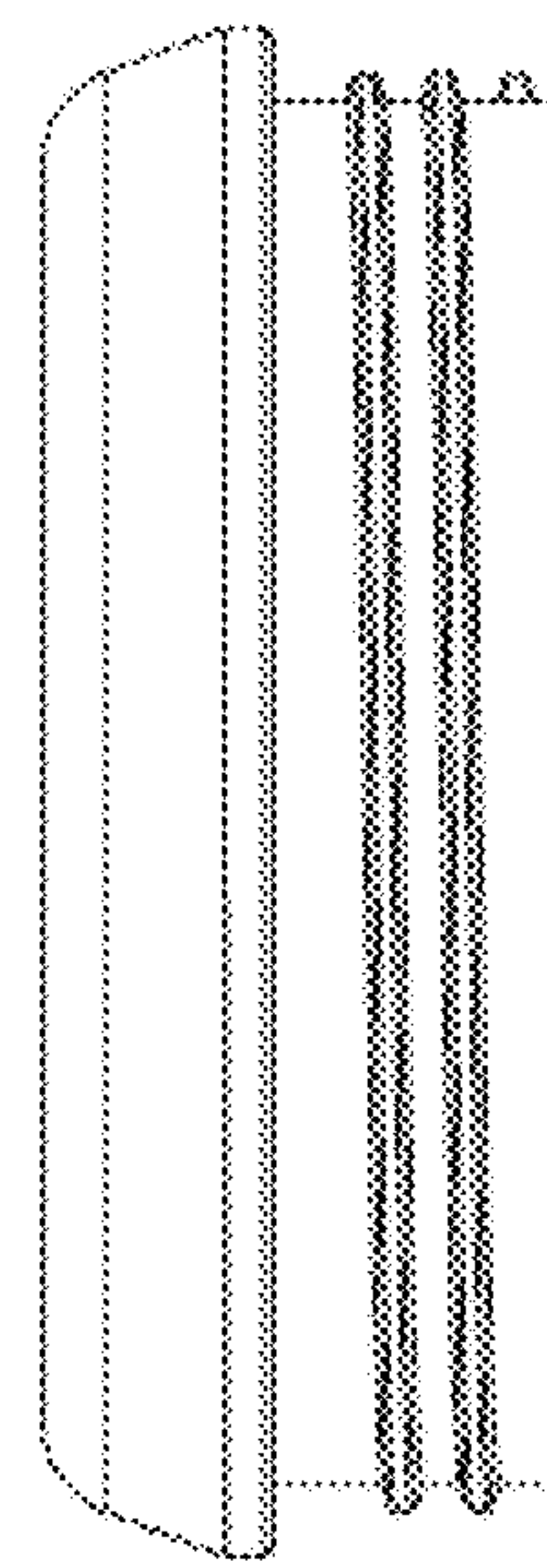

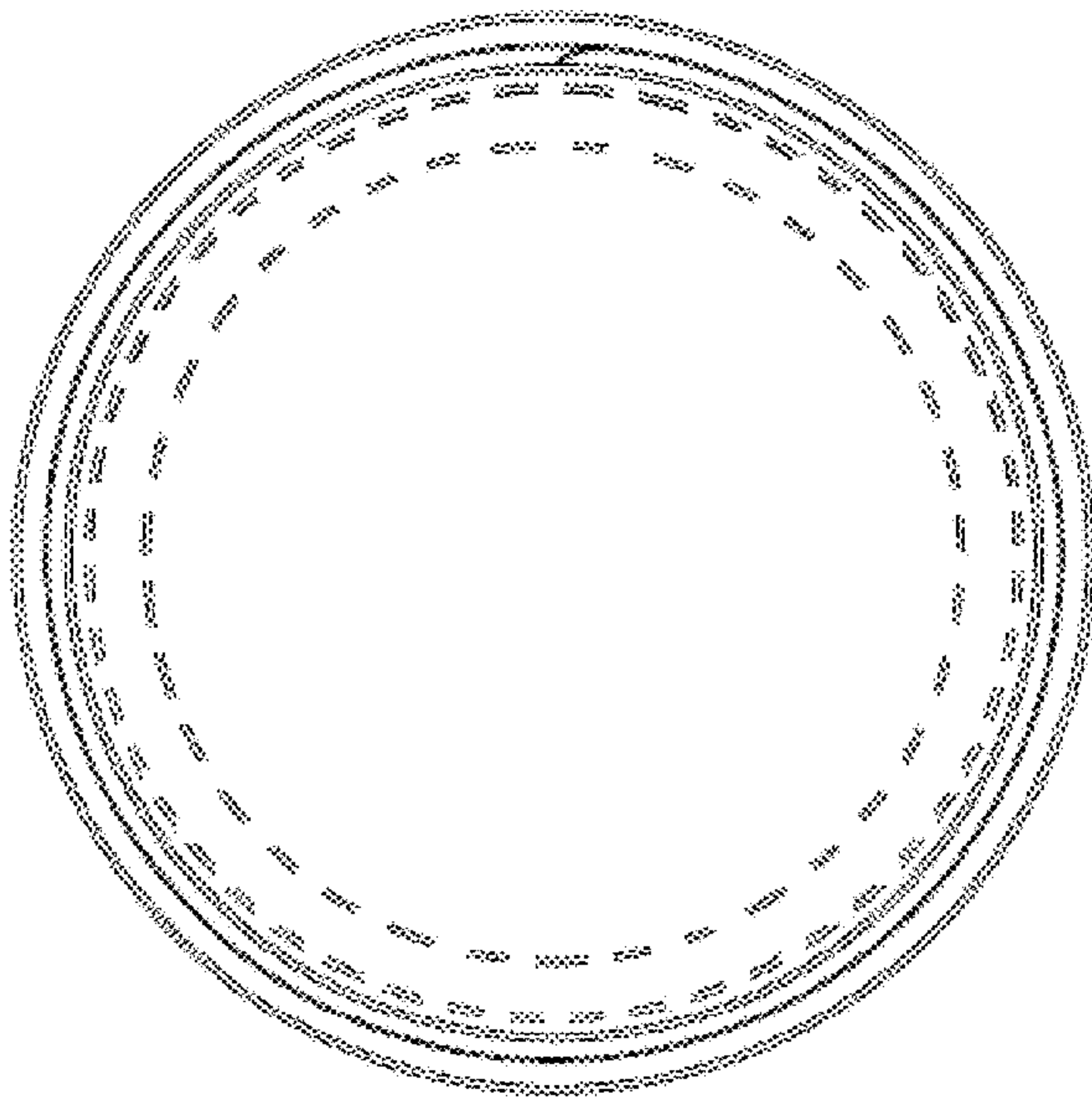

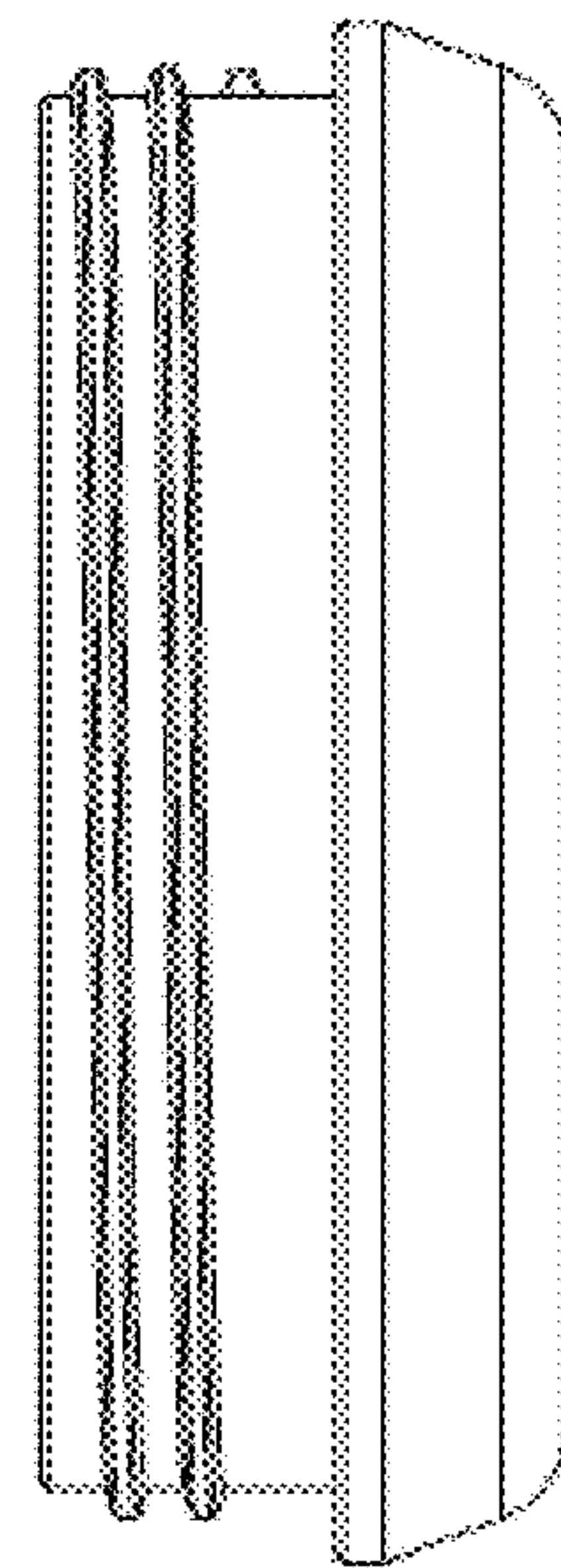

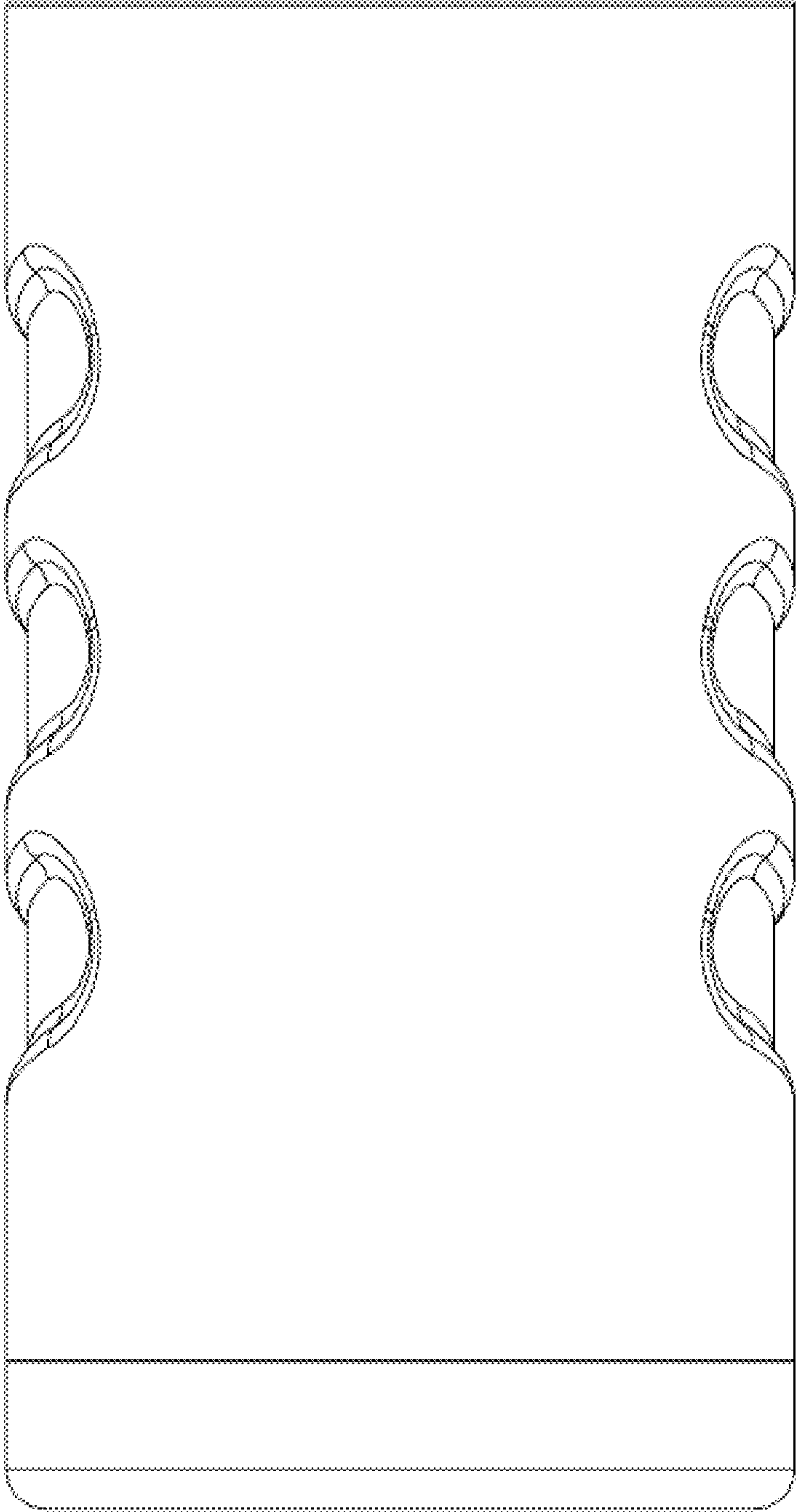

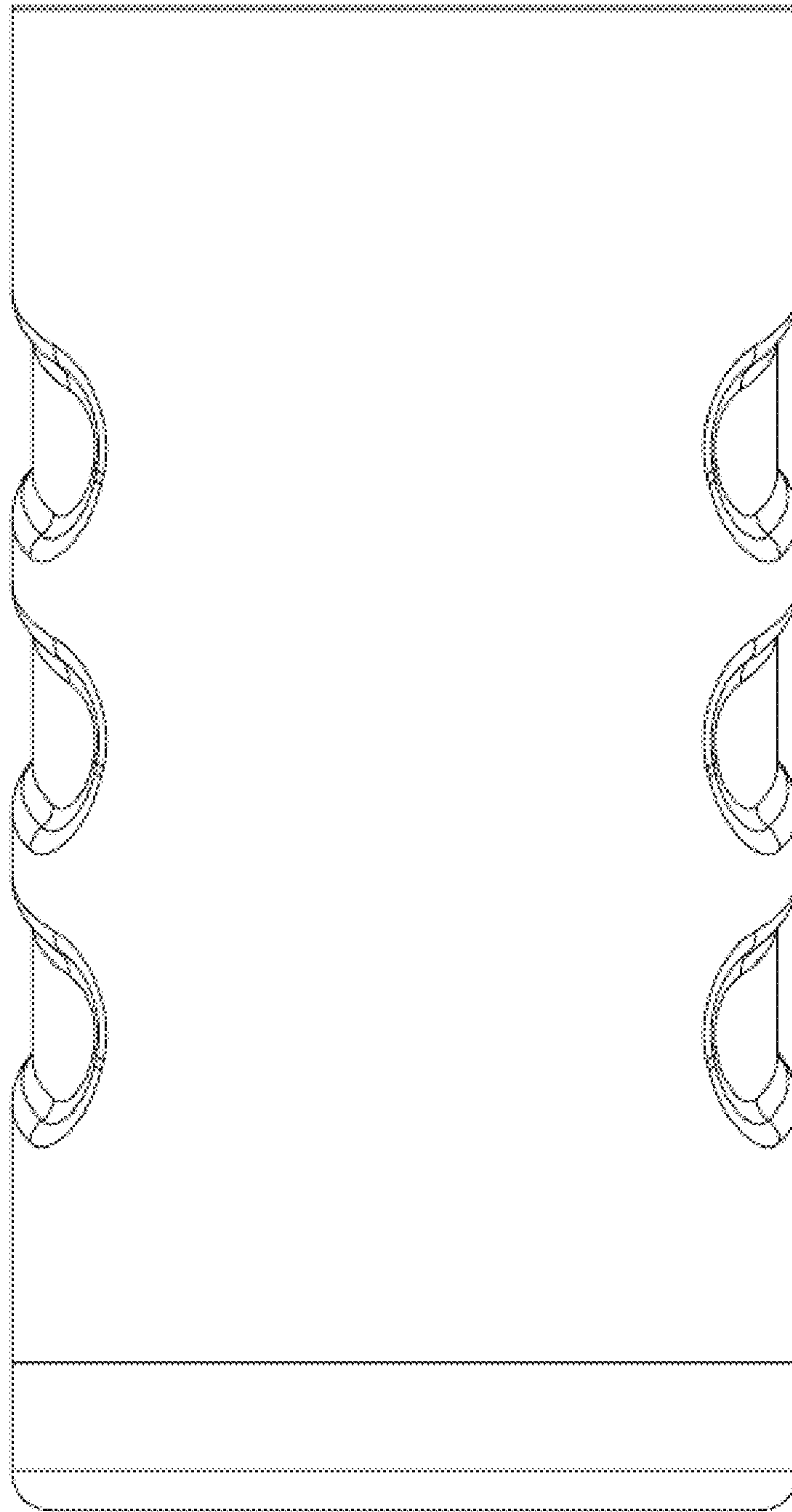

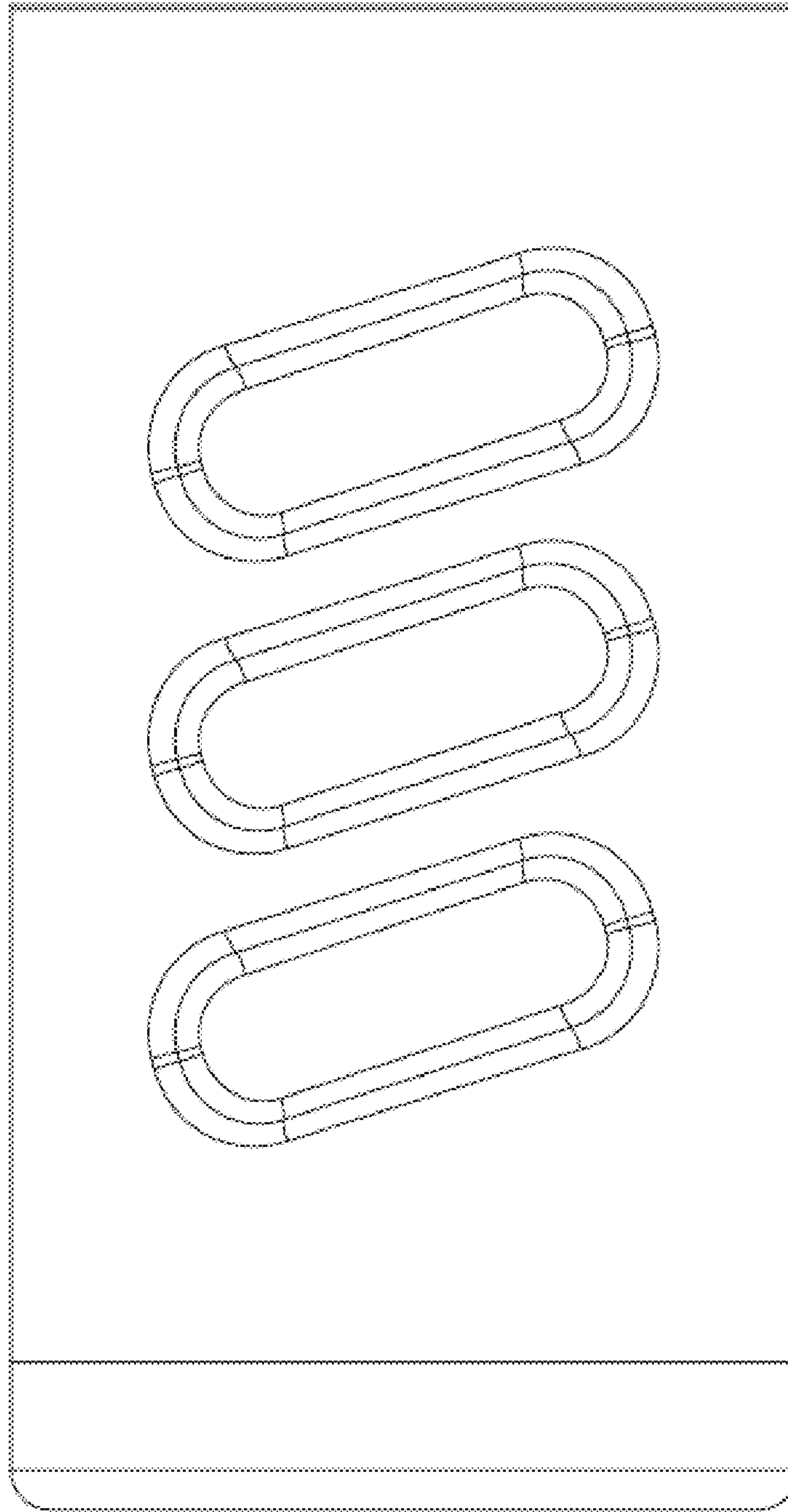

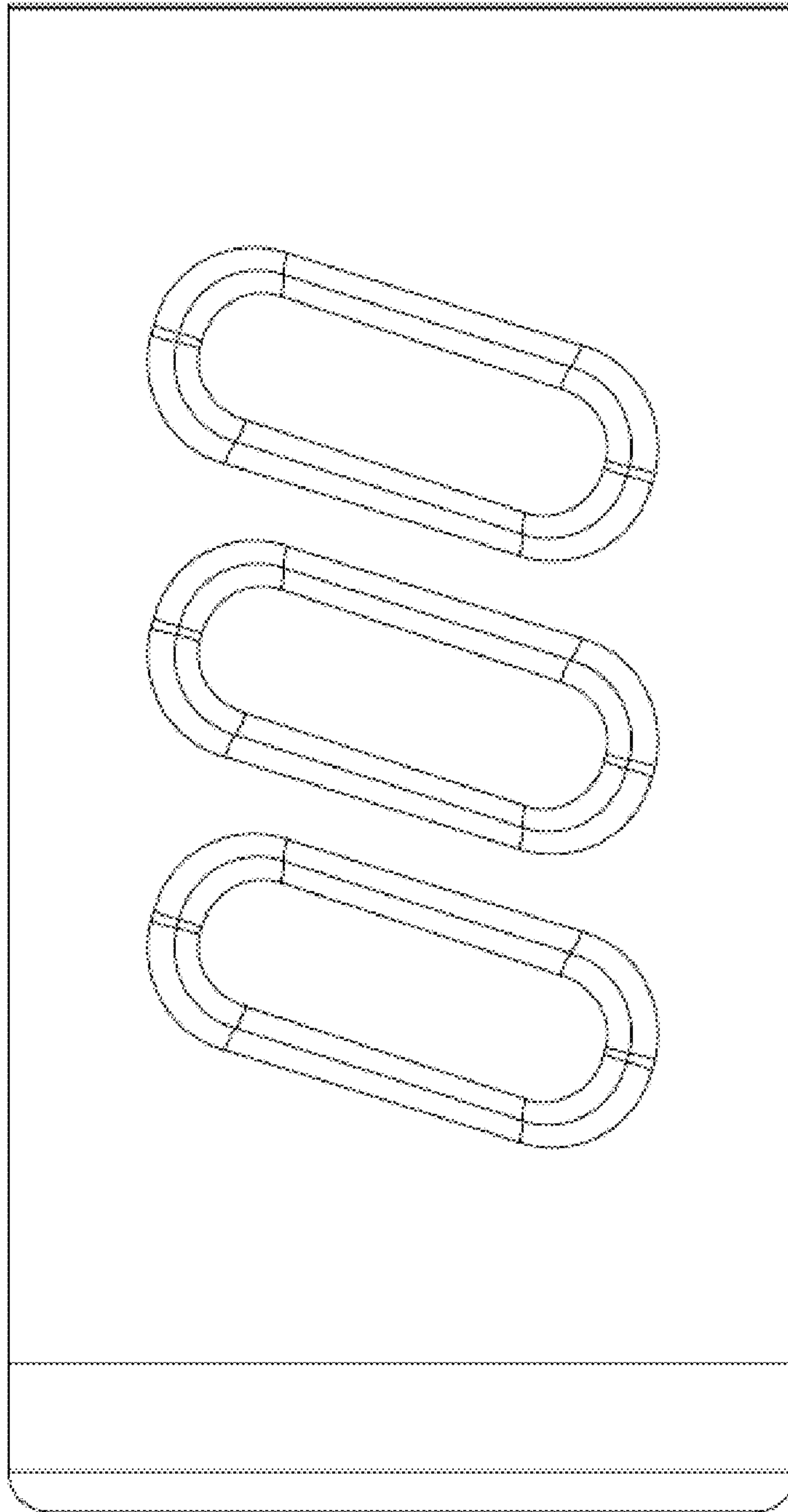

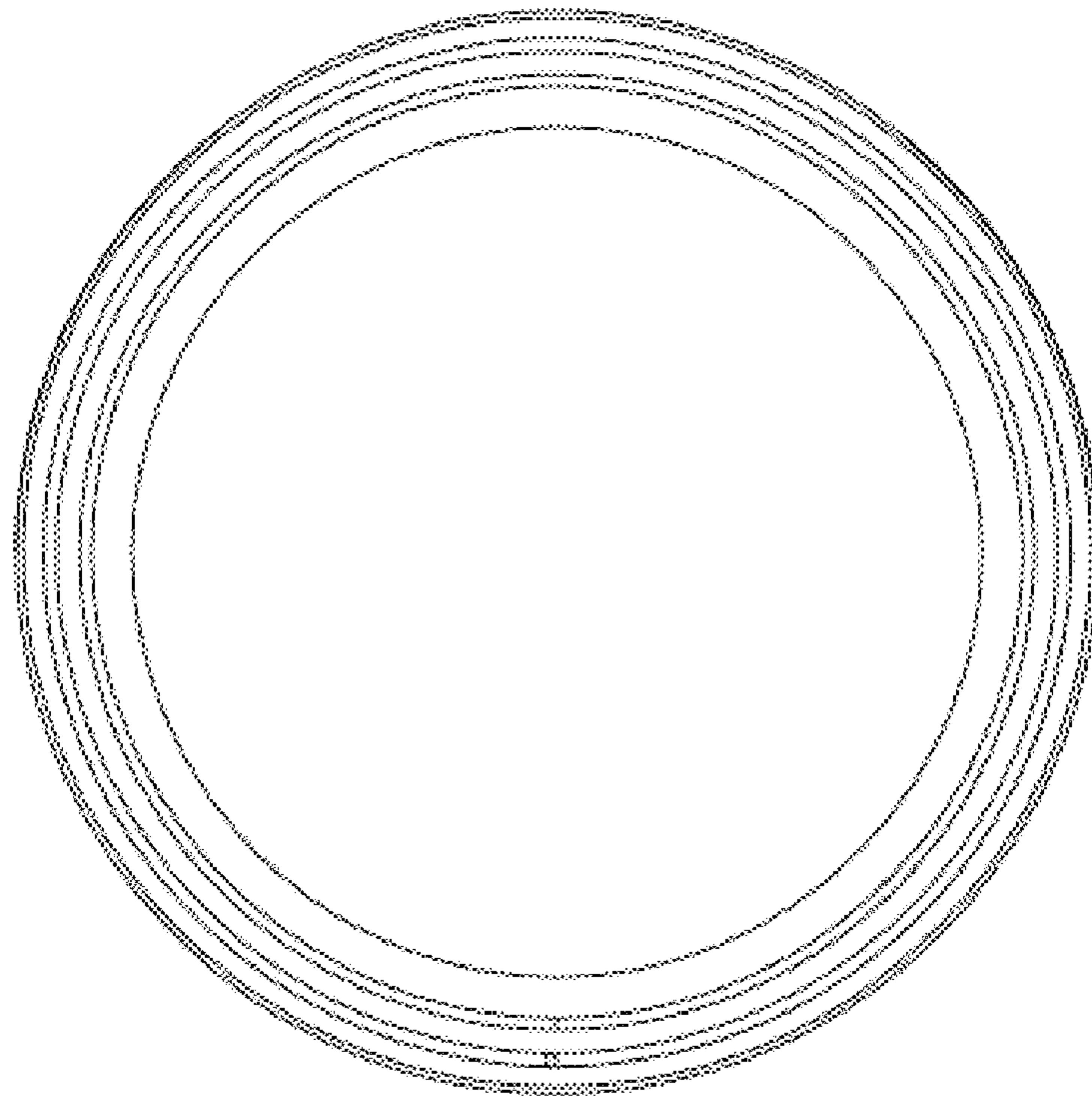

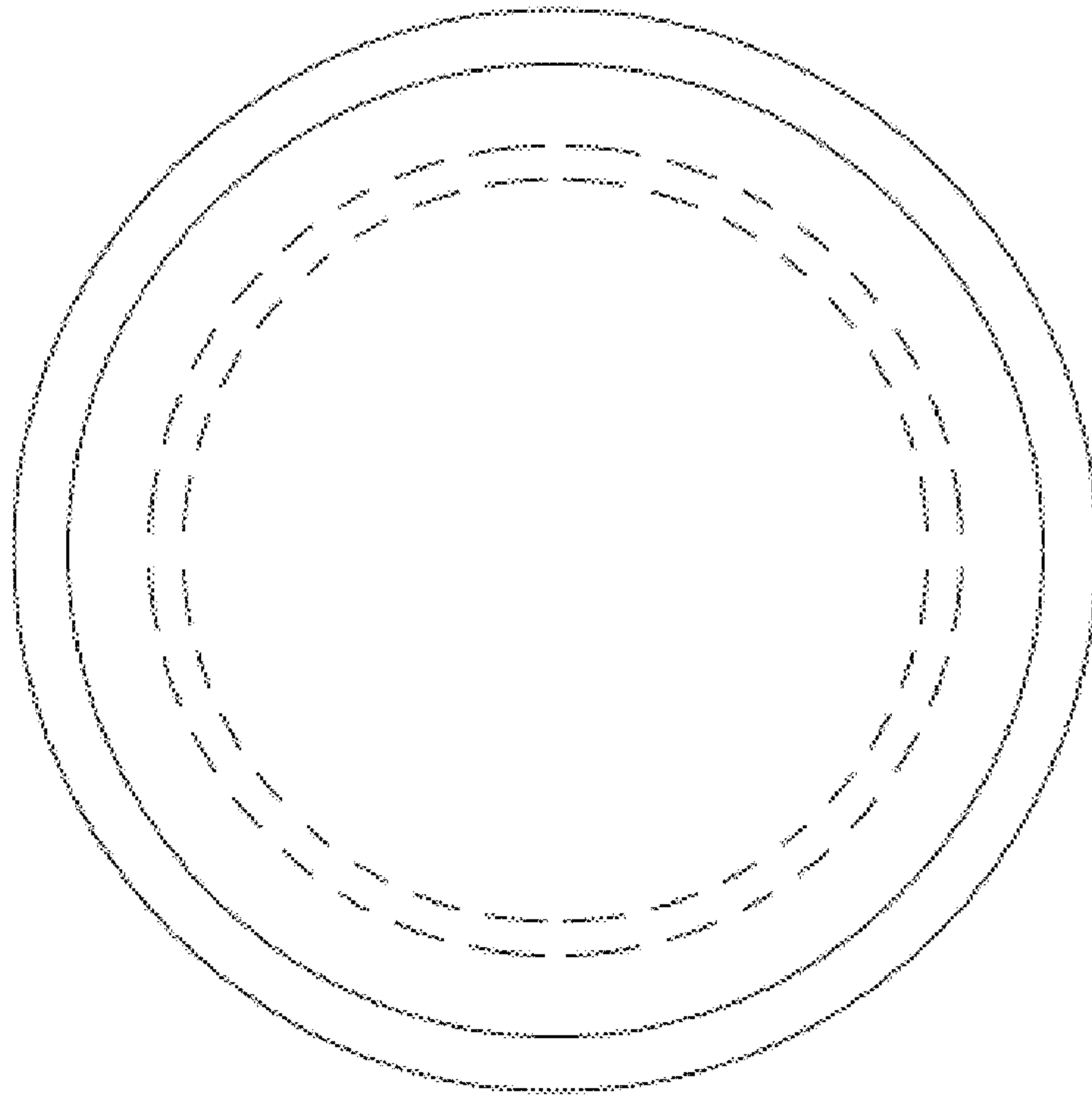

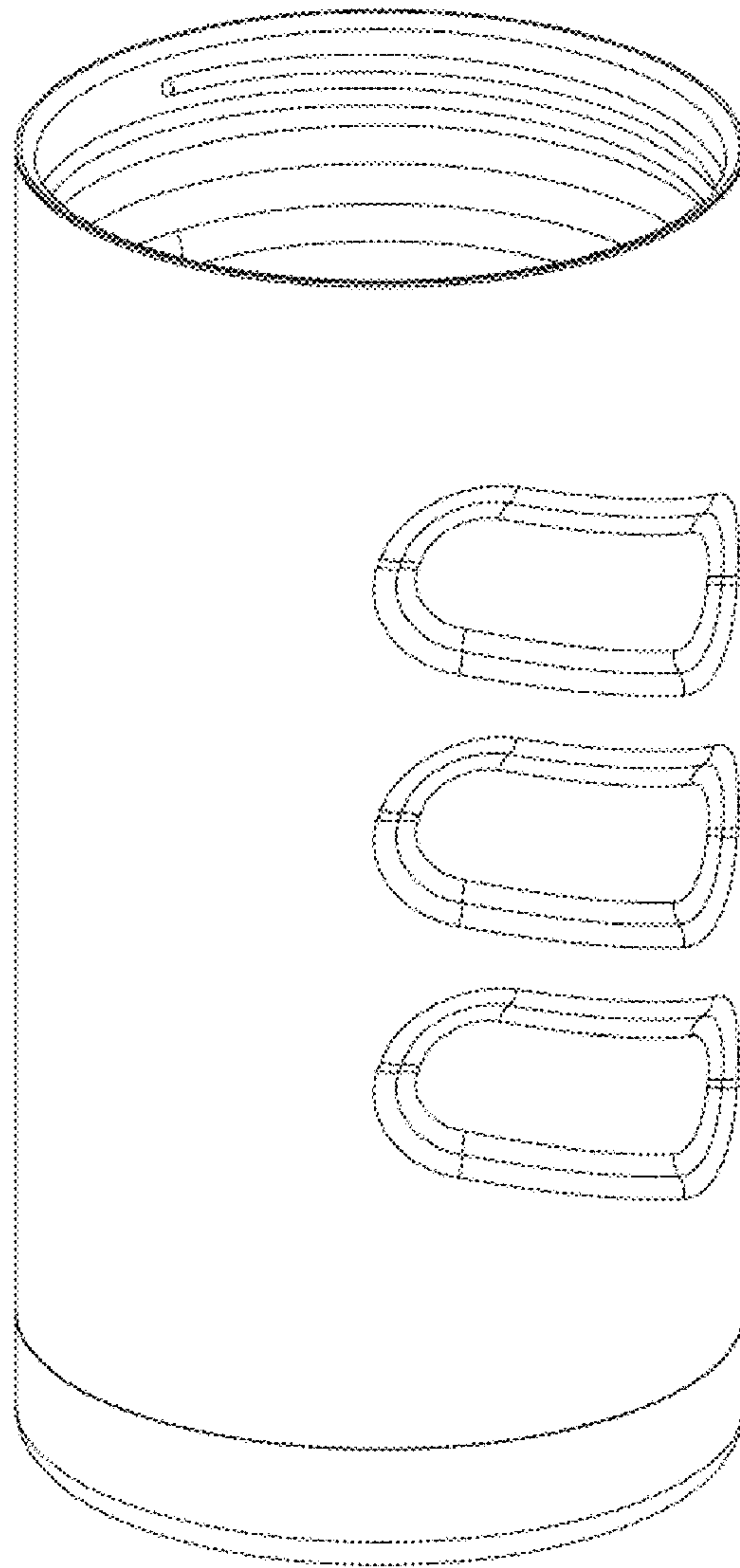
