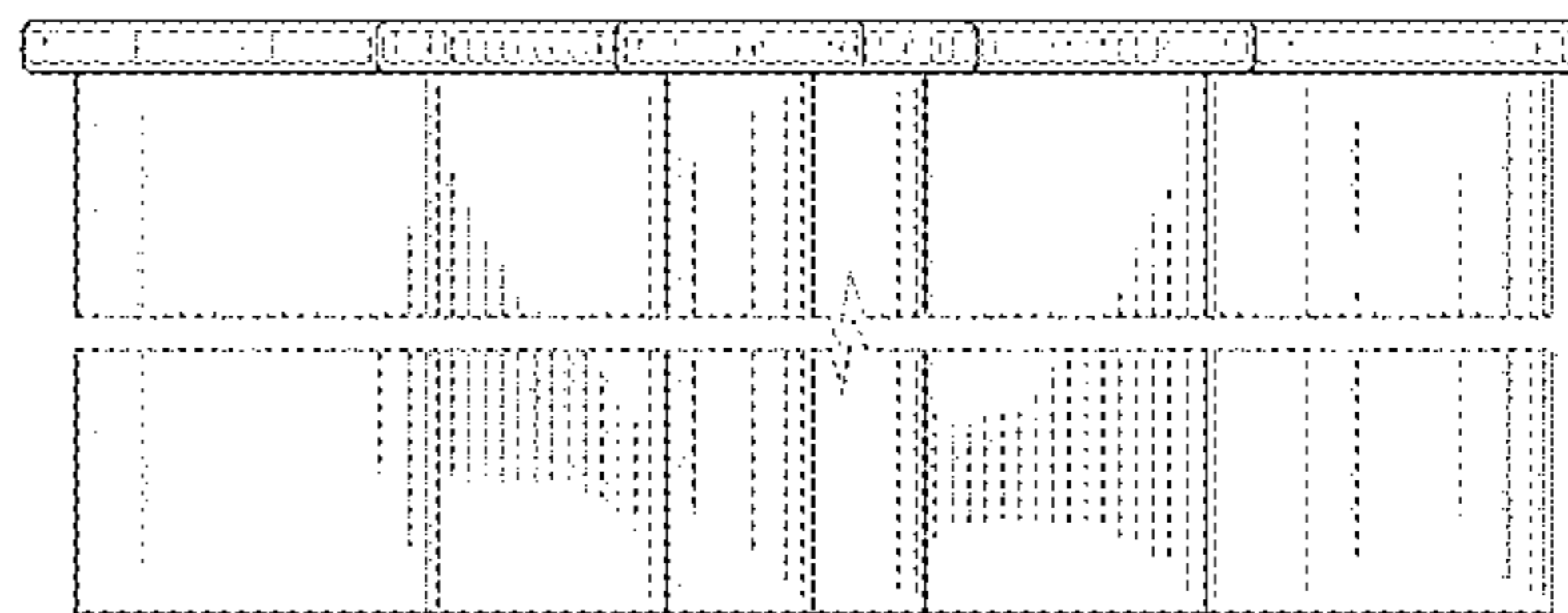
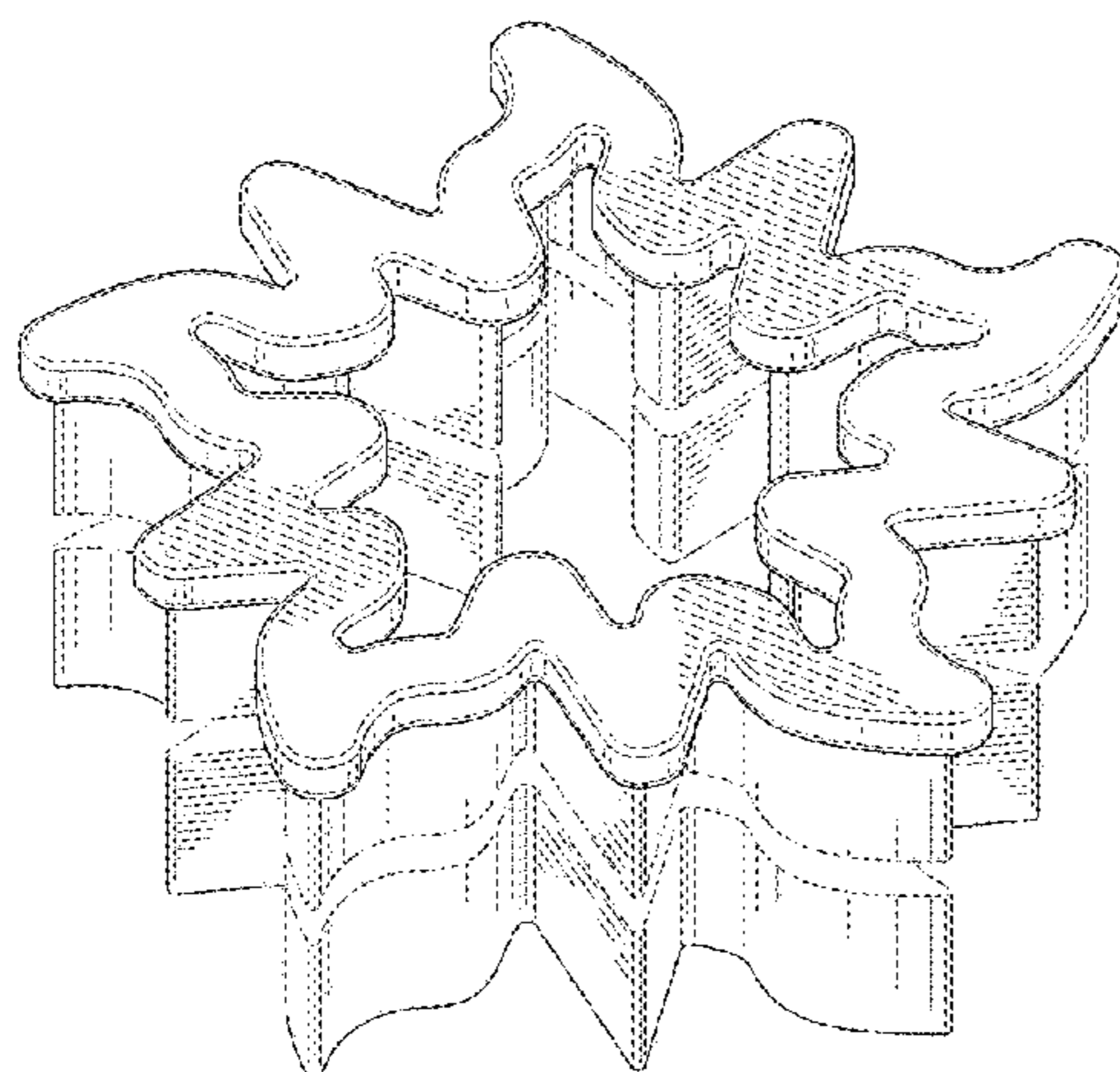
(57) **CLAIM**

The ornamental design for a fruit cutter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a fruit cutter showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a back elevational view thereof;  
FIG. 6 is a right side elevational view thereof; and,  
FIG. 7 is a left side elevational view right view thereof.  
The fruit cutter is shown broken along the length to indicate indeterminate length, with the understanding that the “indeterminate” length portion of the fruit cutter not shown forms

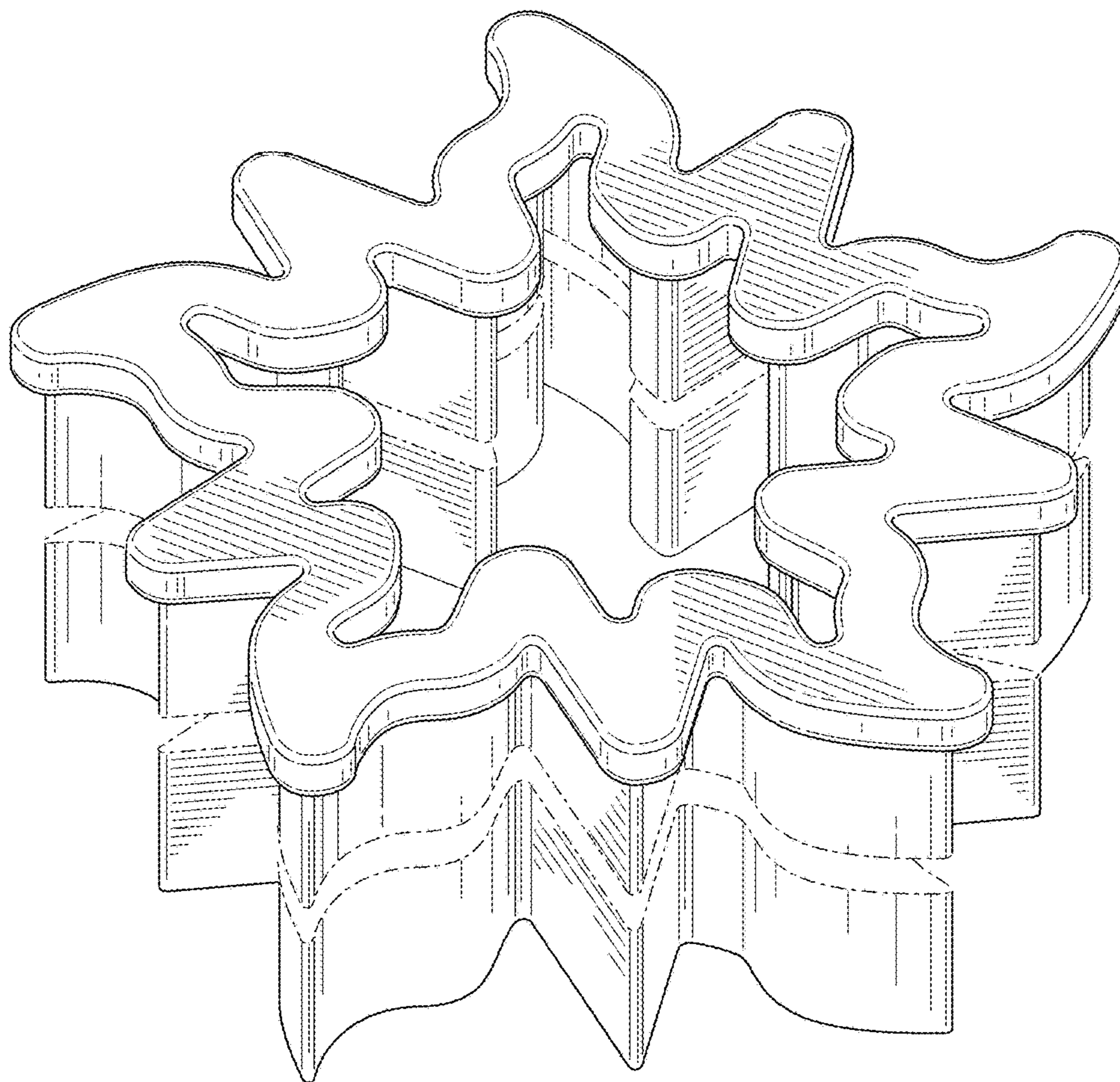

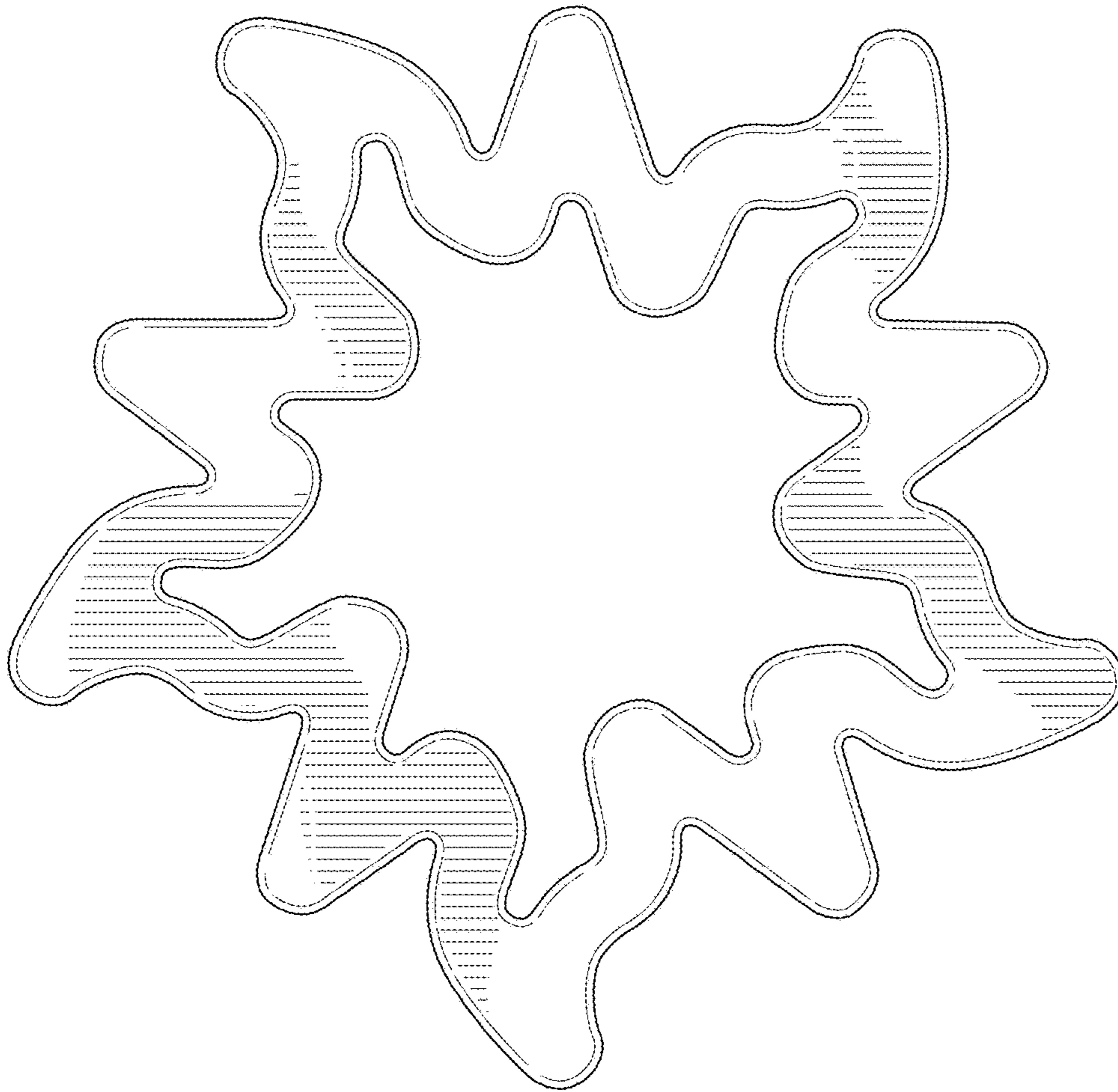

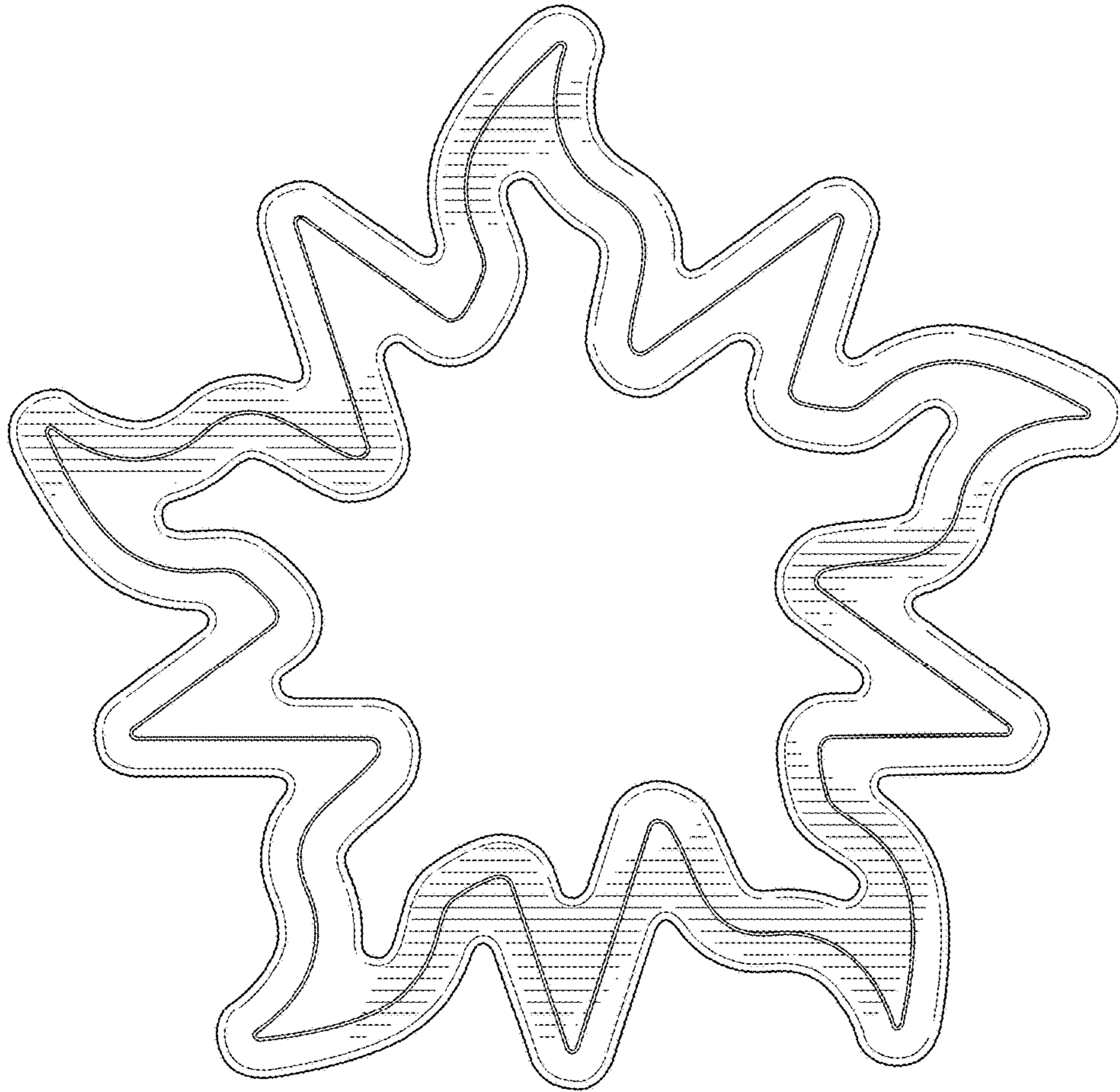

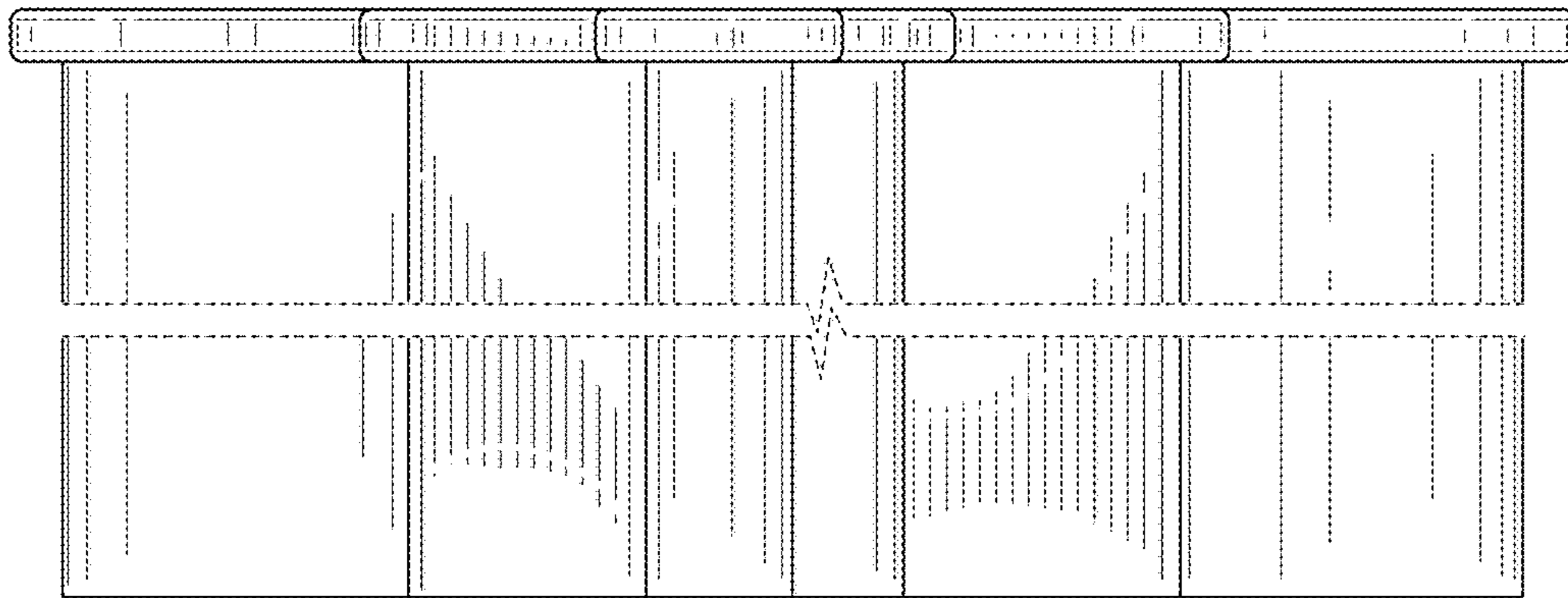

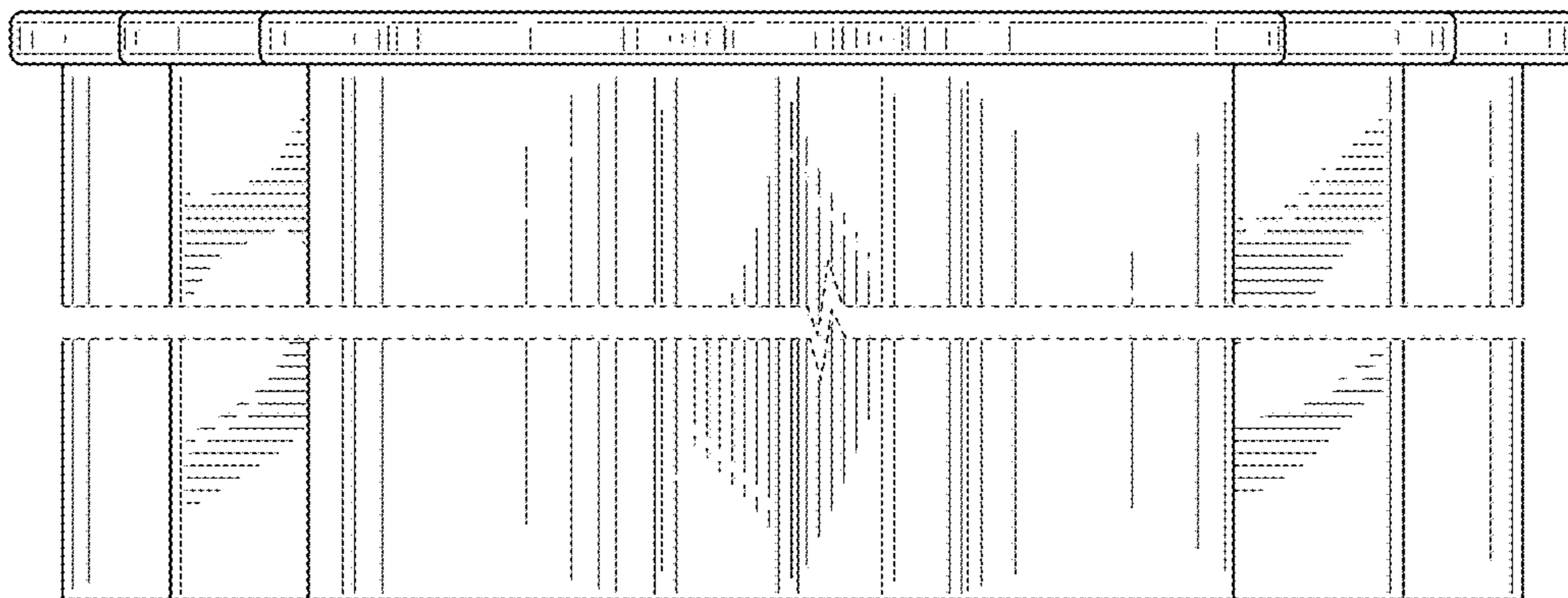

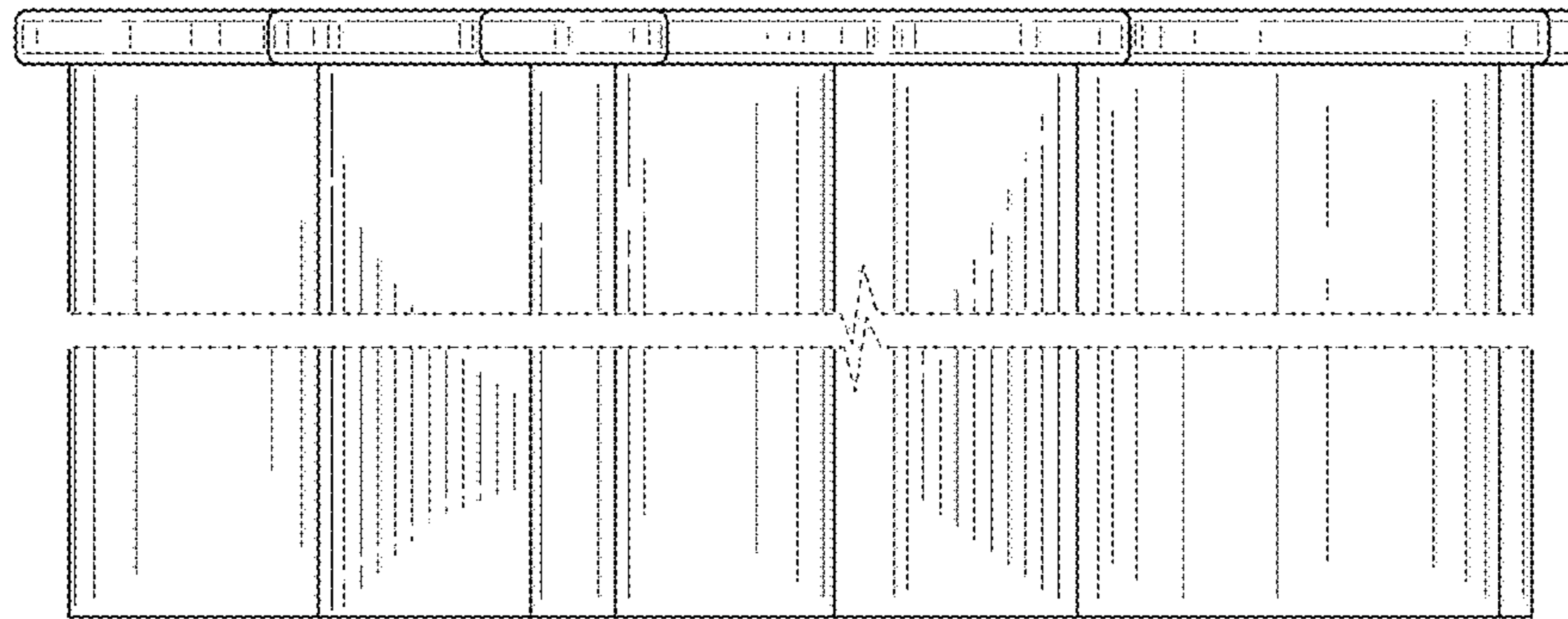

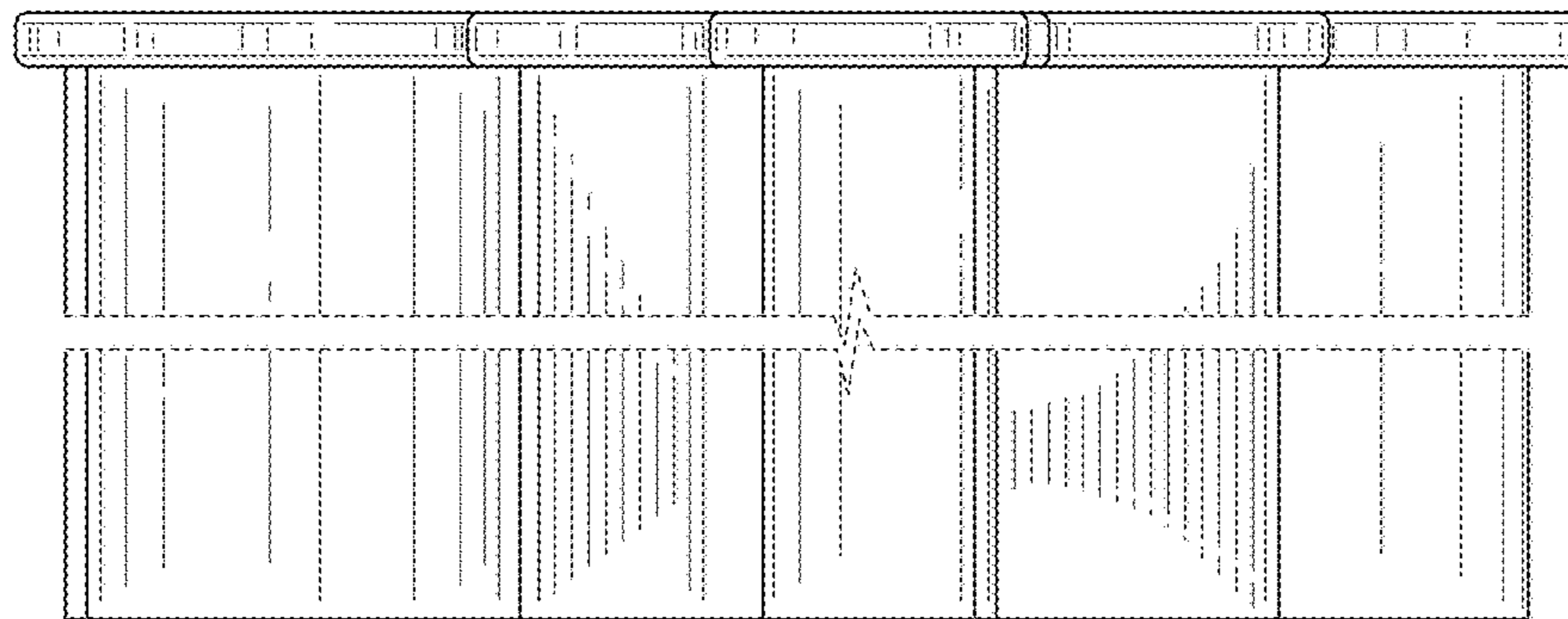
