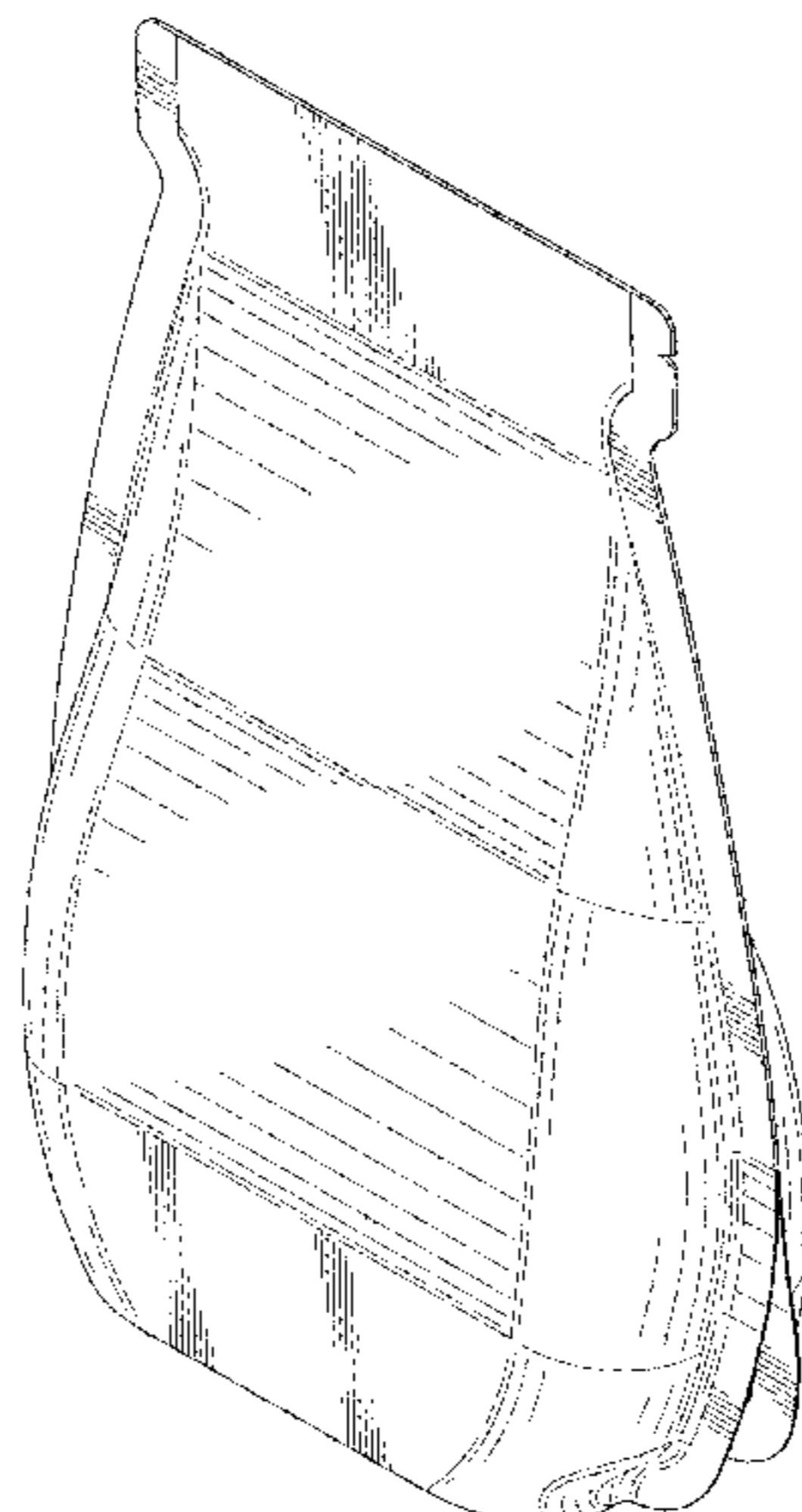
(57) **CLAIM**

The ornamental design for a baby food pouch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the baby food pouch showing our new design;  
FIG. 2 is a bottom-rear perspective view thereof;

FIG. 4 is a right side elevational view, the left side elevational view being a mirror image thereof;

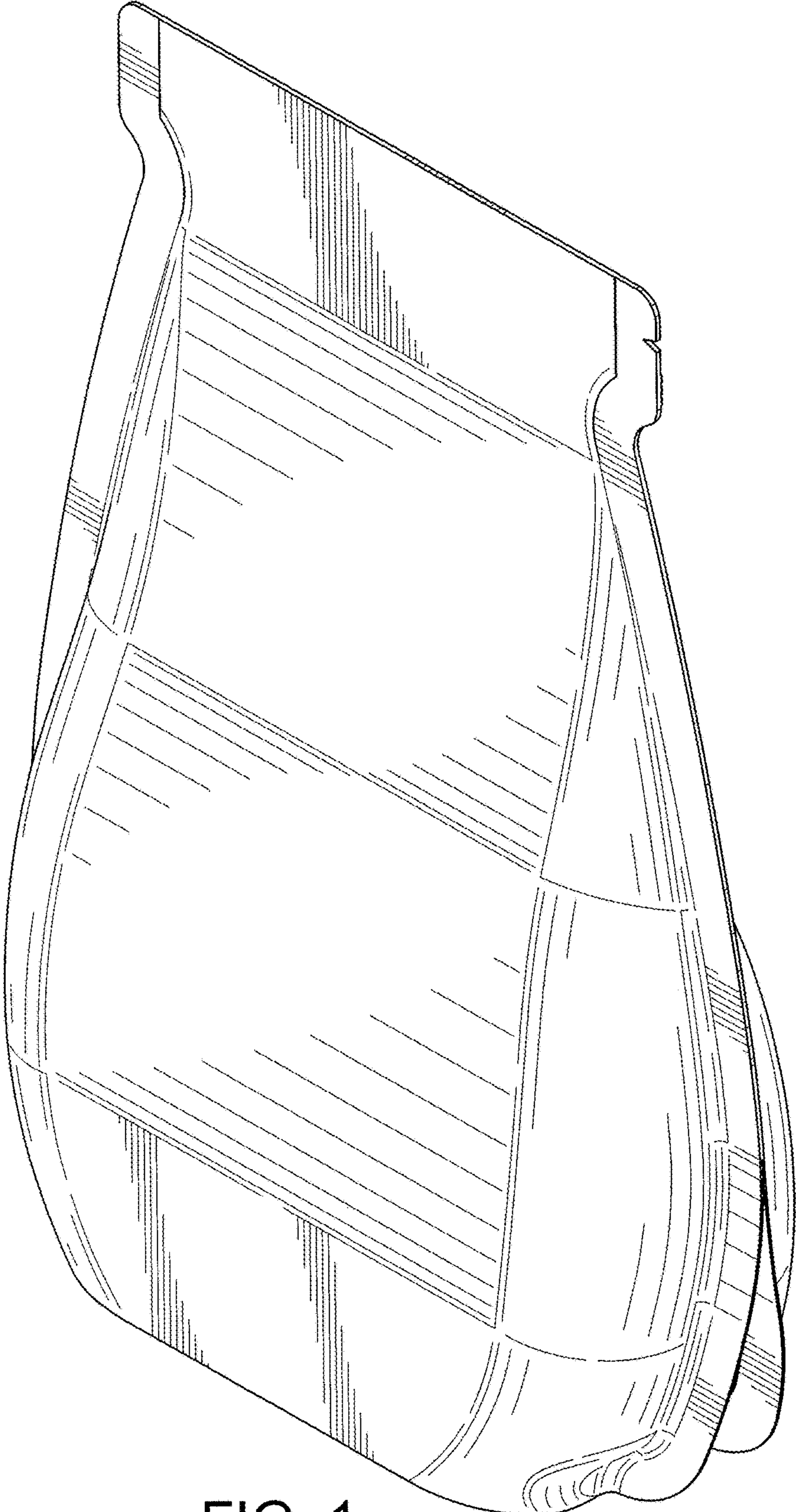

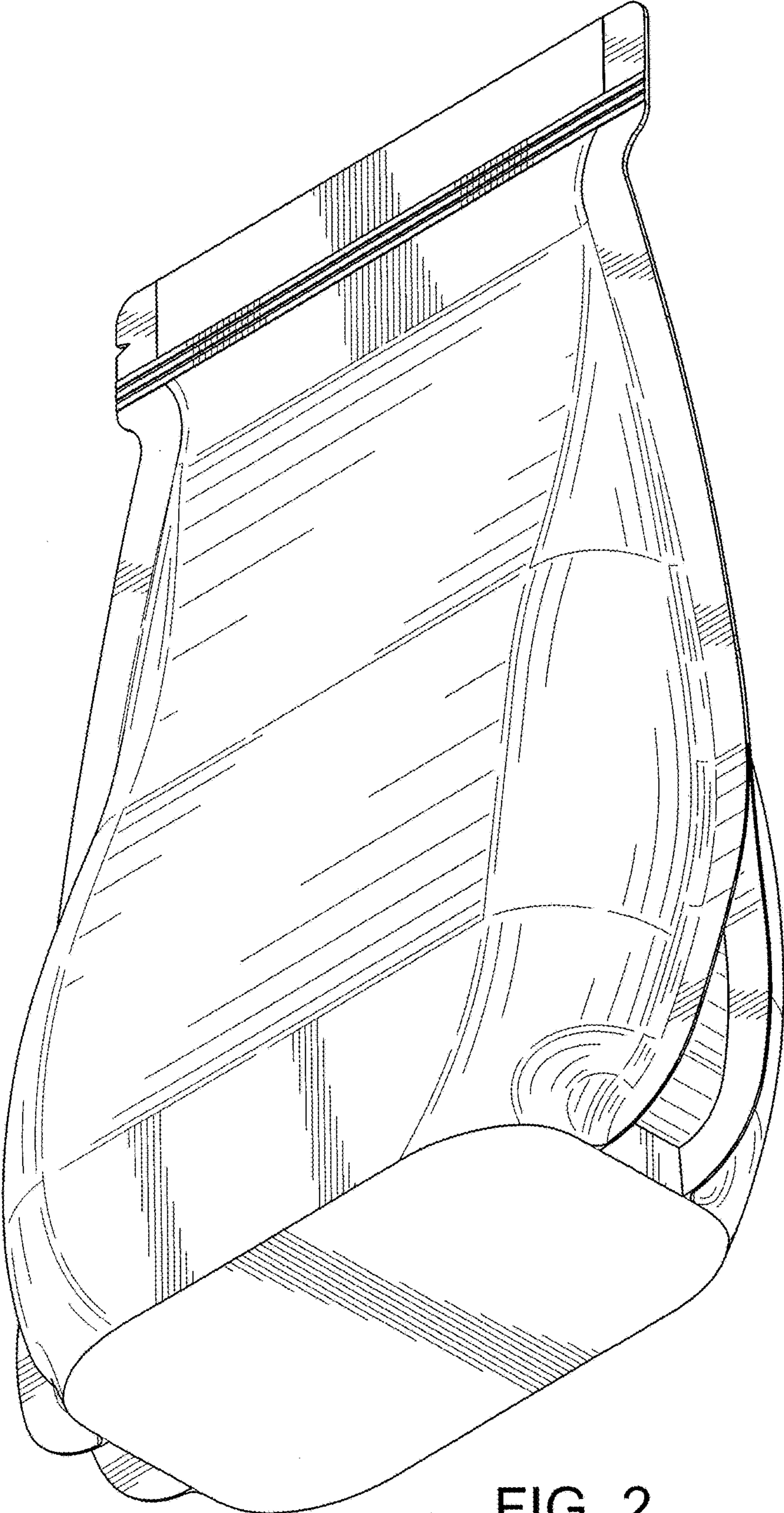

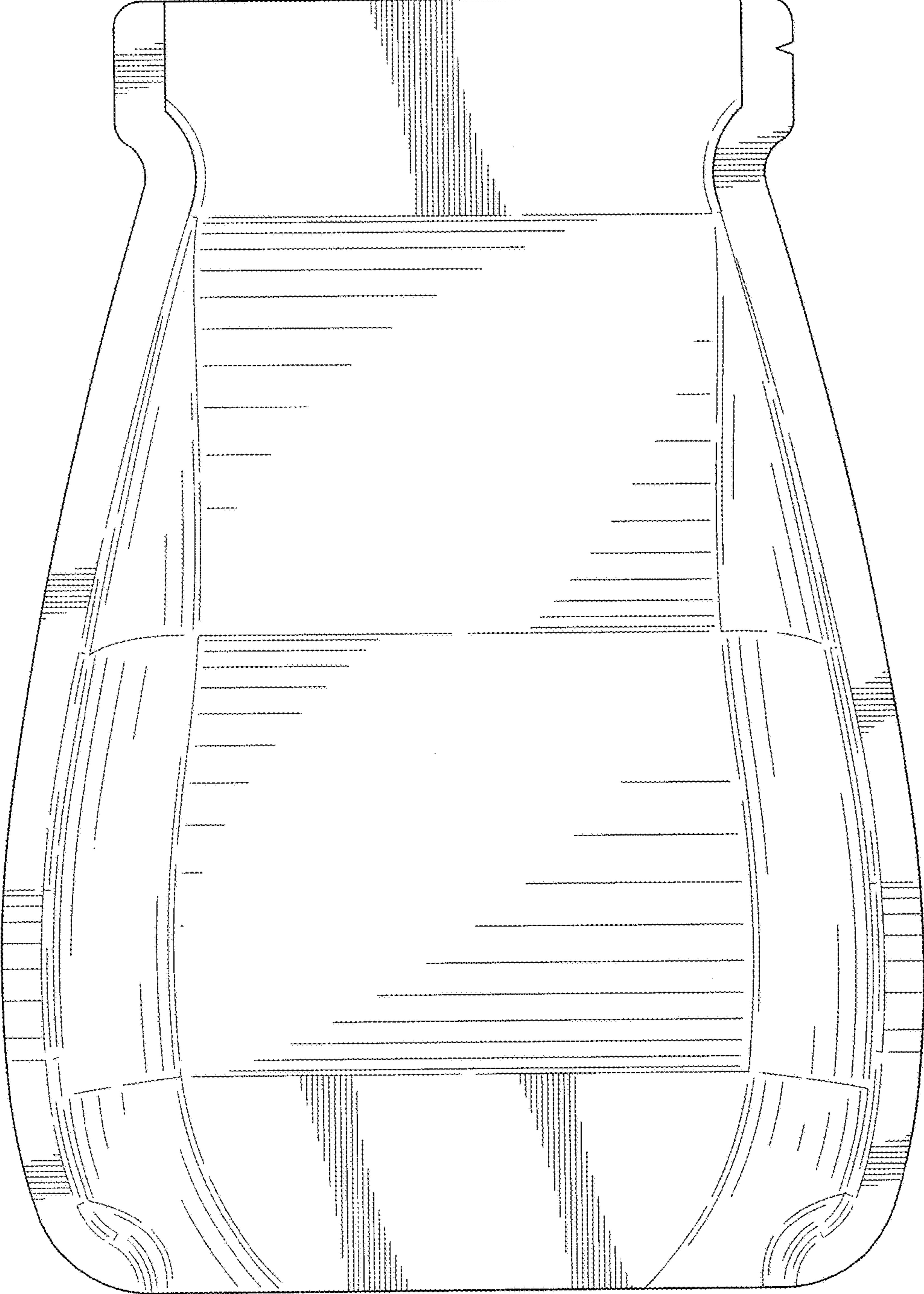

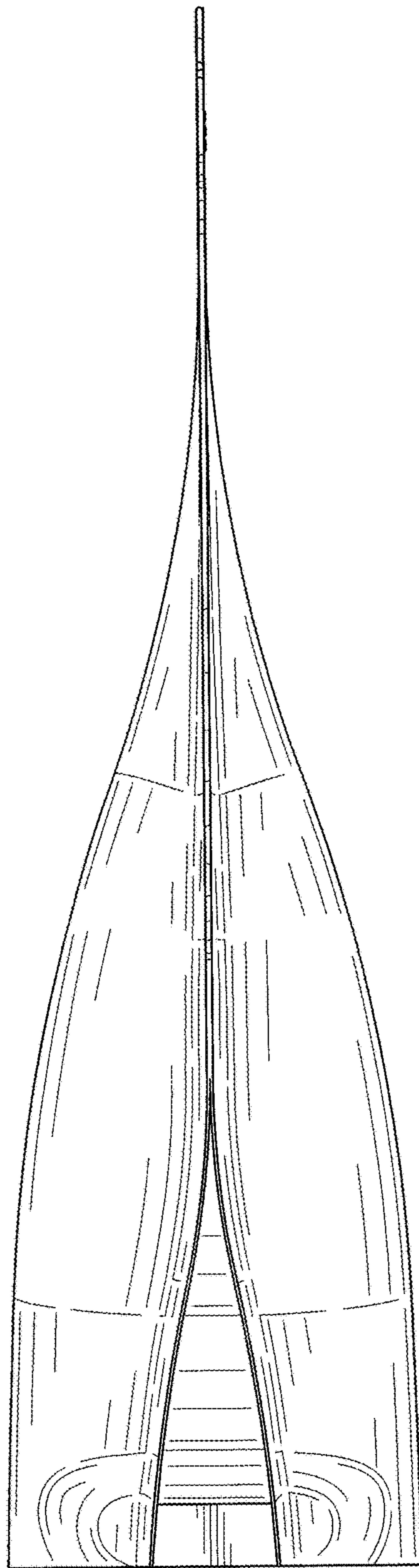

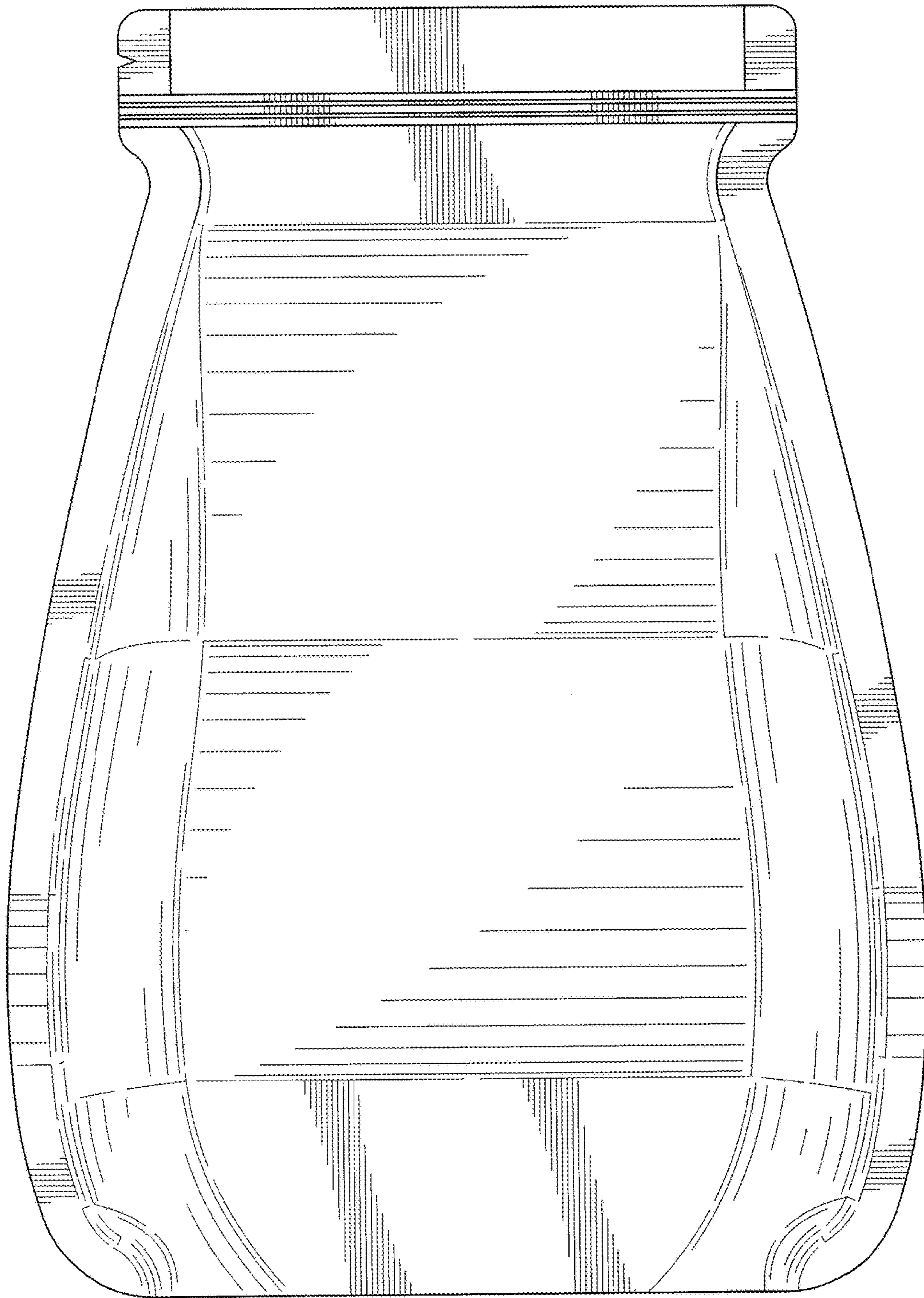

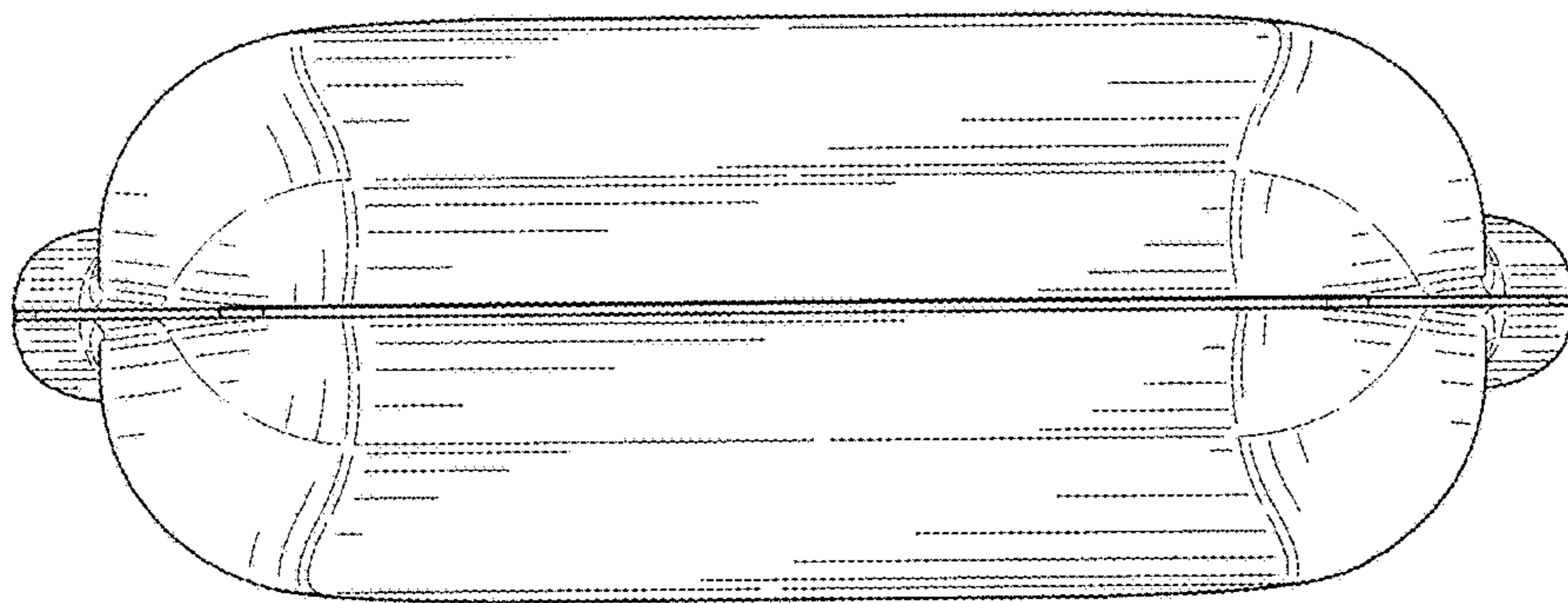

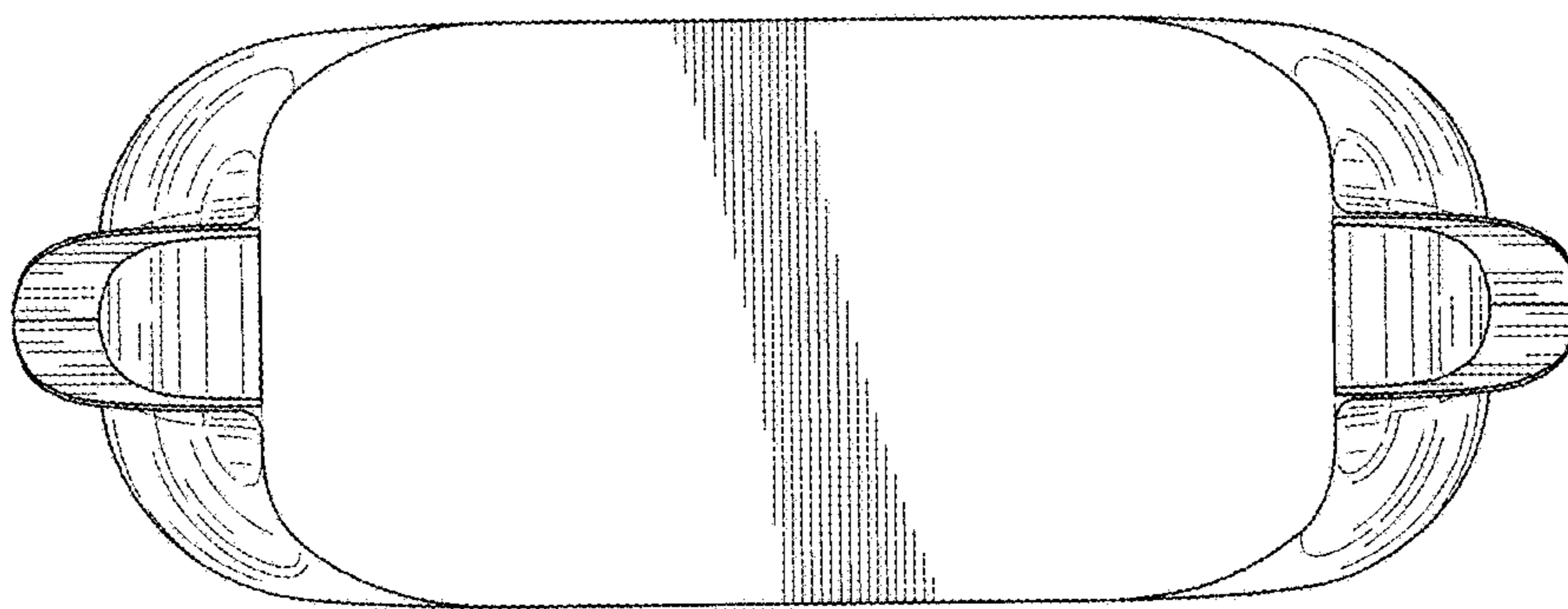
