(57) **CLAIM**

We claim the ornamental design for a front bumper for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view for a “front bumper for an automobile” showing my new design, FIG. 2 is a rear perspective view thereof, FIG. 3 is a front view thereof, FIG. 4 is a rear view thereof, FIG. 5 is a top view thereof, FIG. 6 is a bottom view thereof, FIG. 7 is a left-side view thereof; and, FIG. 8 is a right-side view thereof.

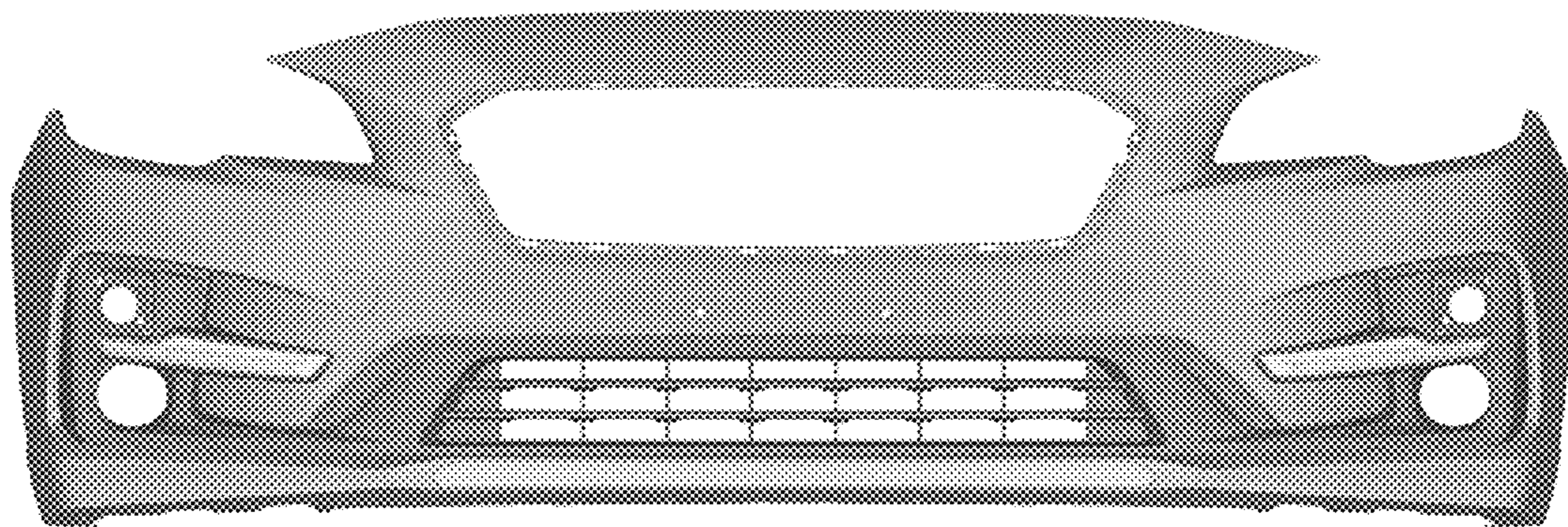

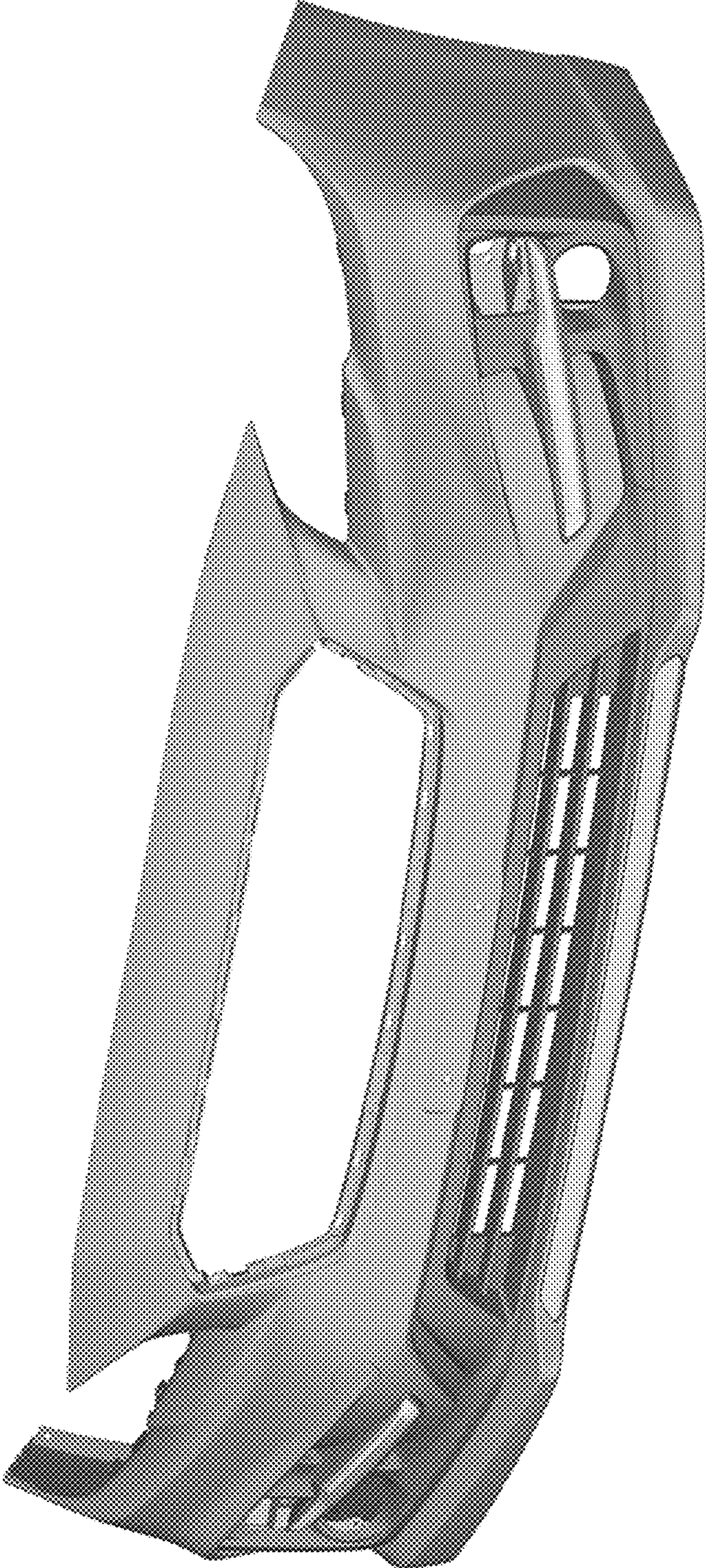

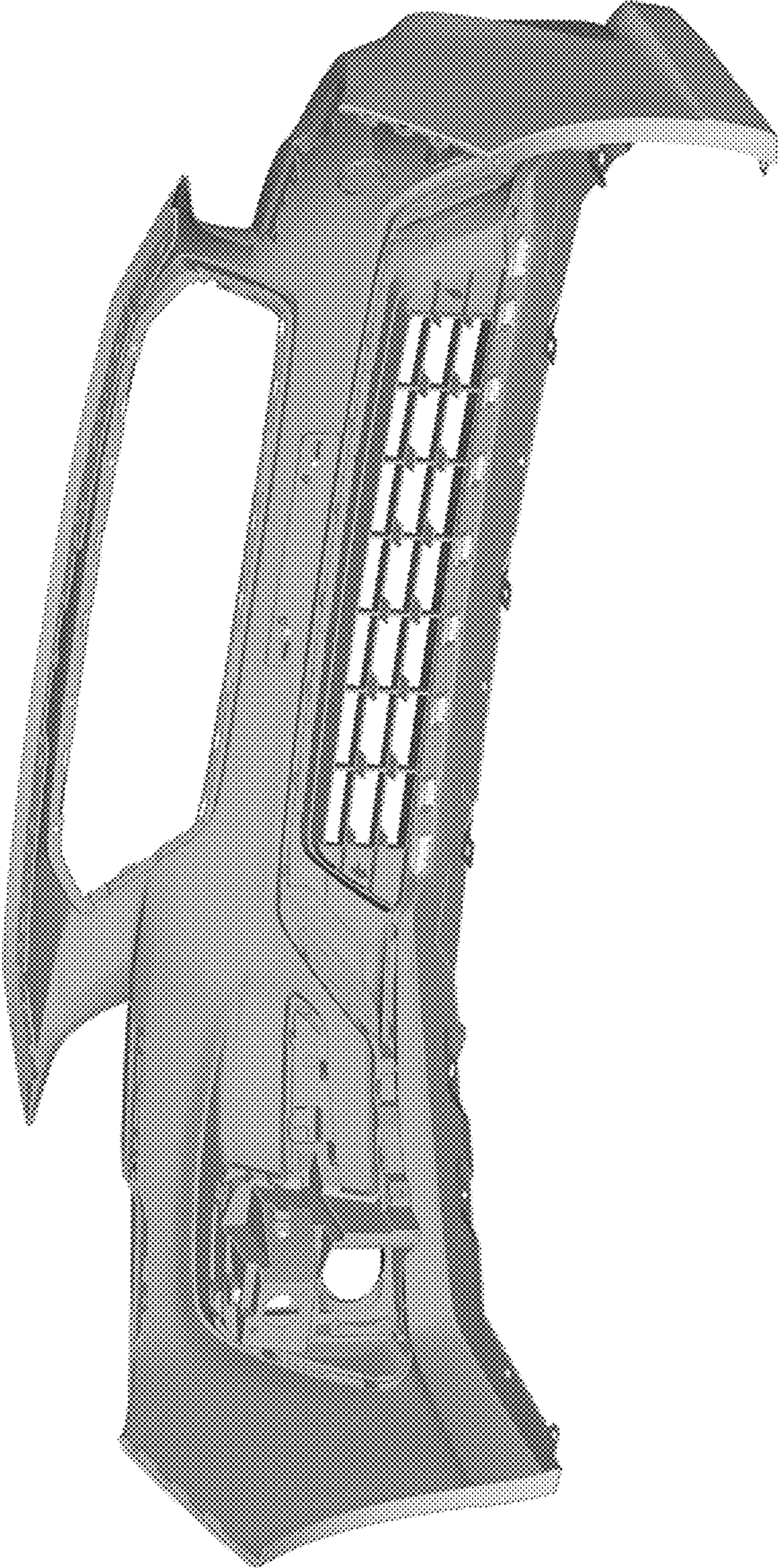

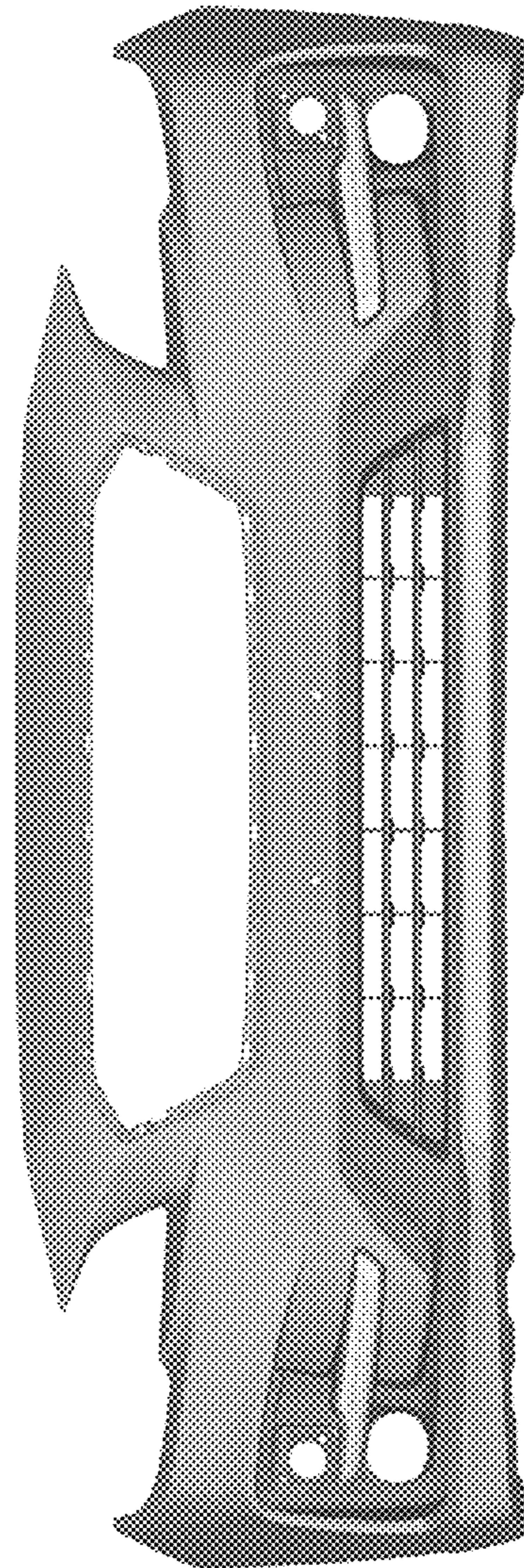

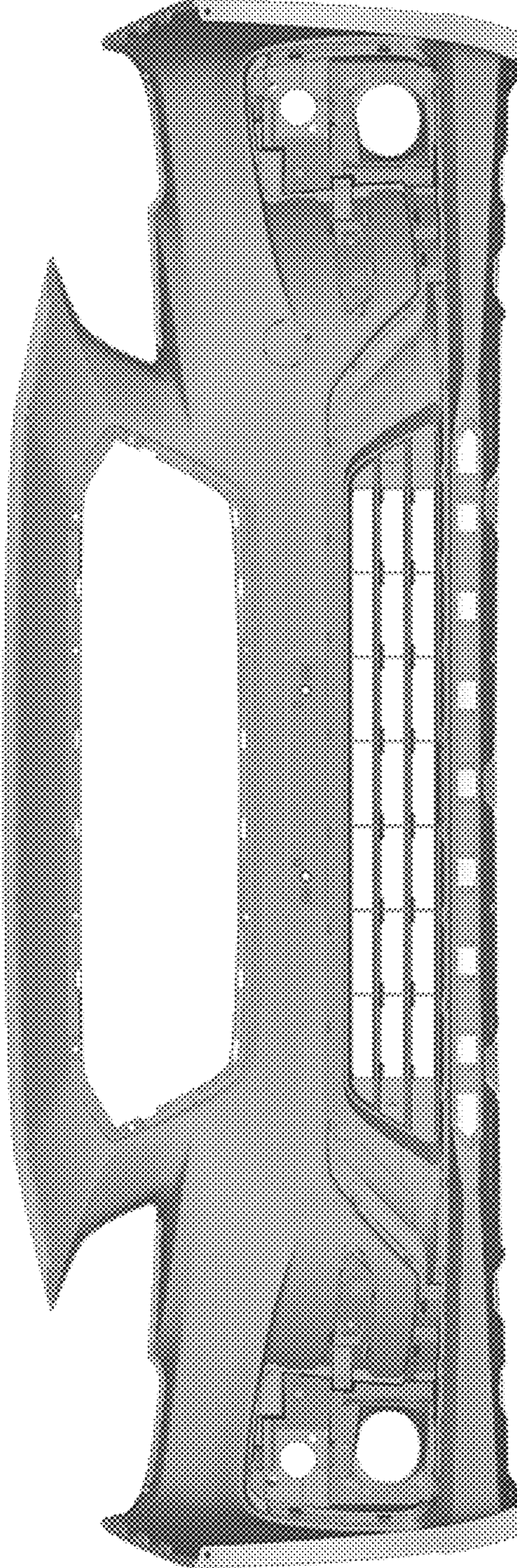

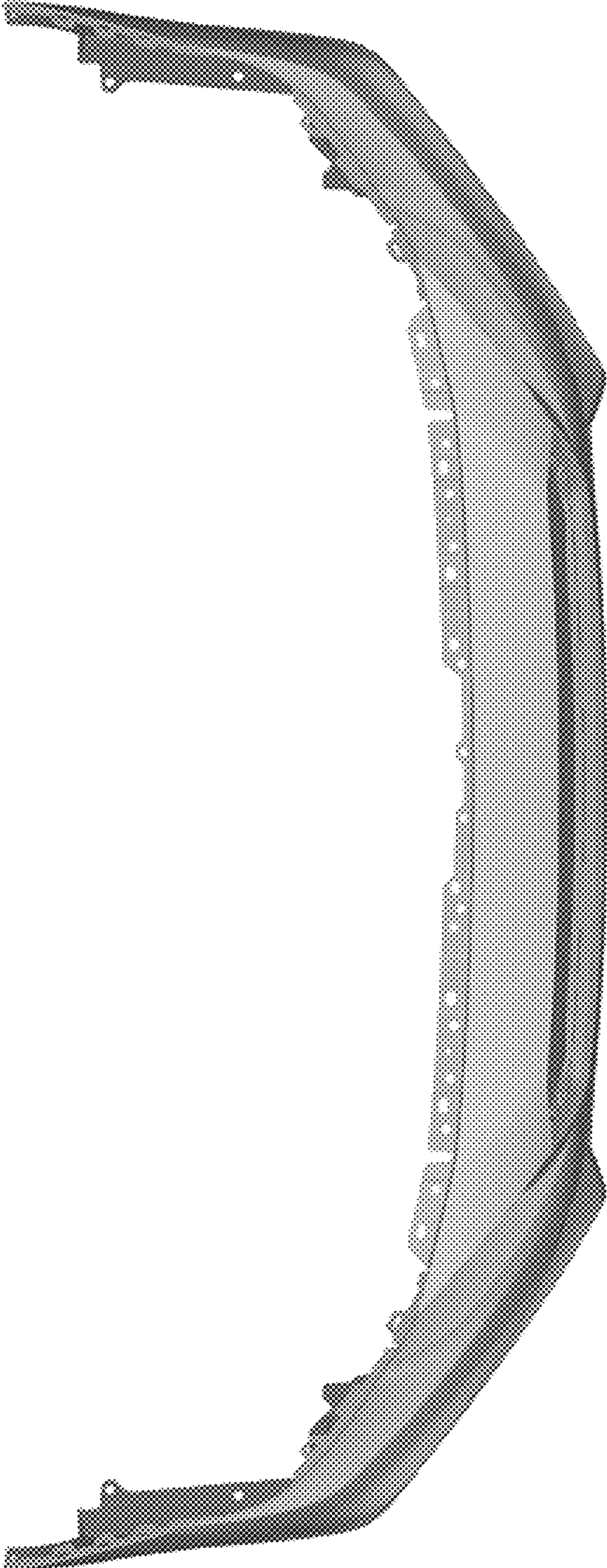

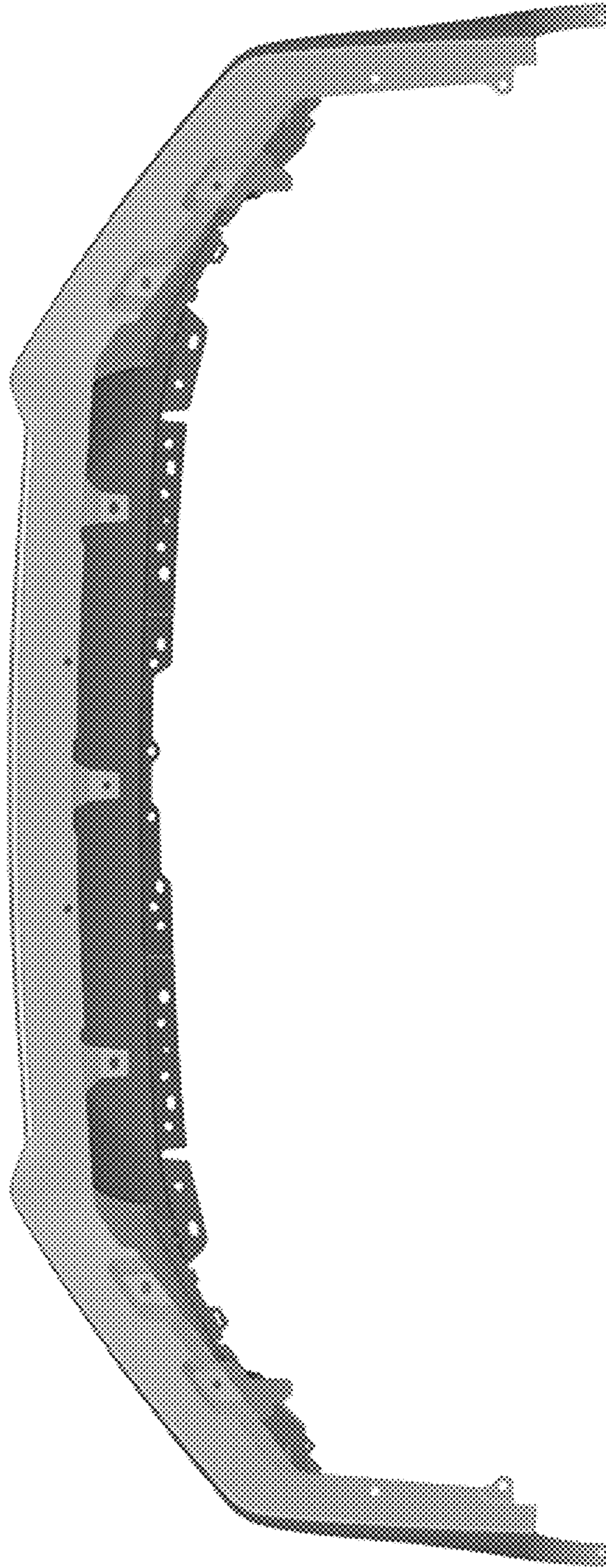

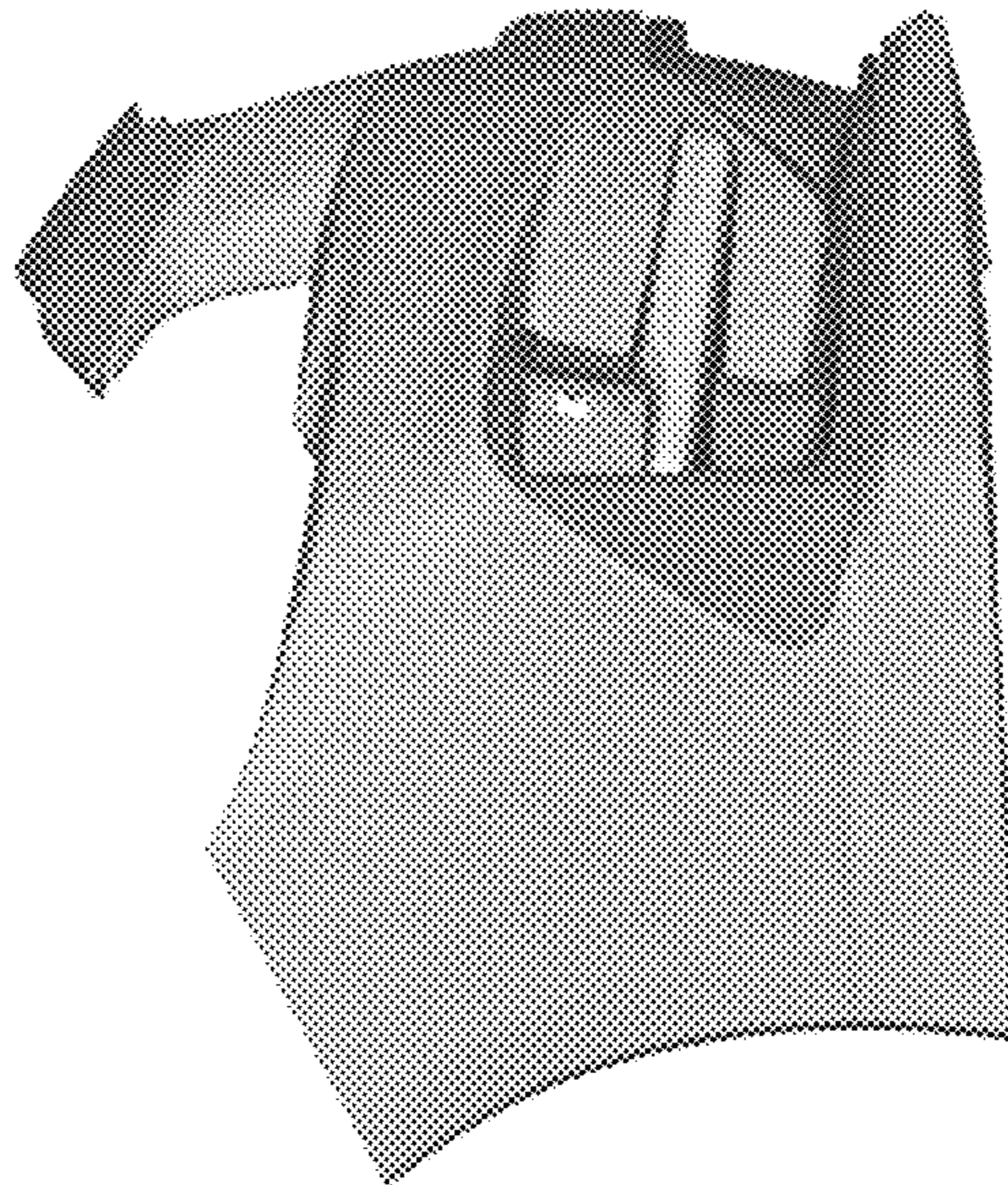
