(57) **CLAIM**

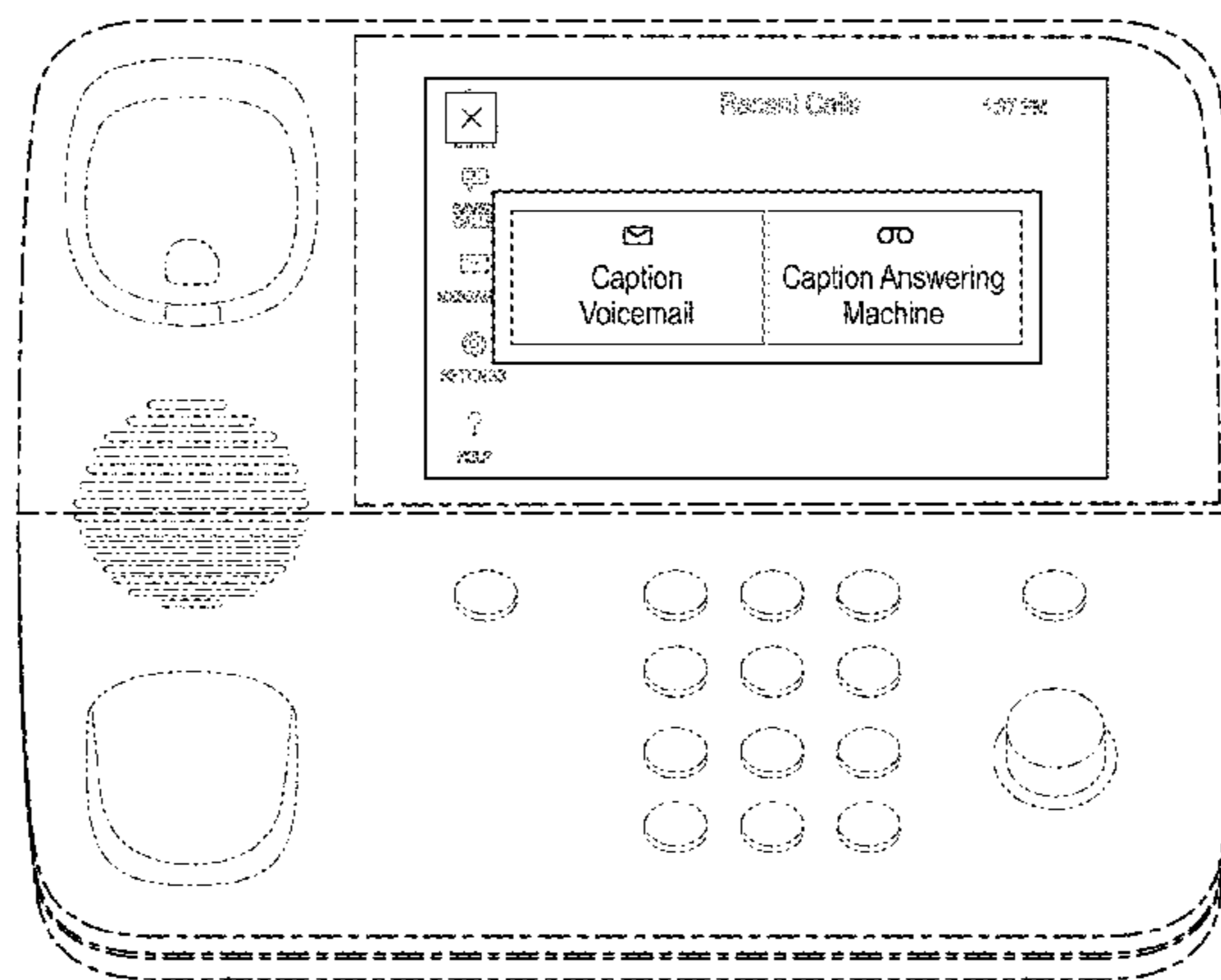
The ornamental design of a display screen or portion thereof of a captioning communication device with graphical user interface, substantially as shown and described.
