(57) **CLAIM**

The ornamental design for a hydraulic cylinder with base tab, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of the hydraulic cylinder with base tab showing my new design. The left side elevational view is a mirror image view of the right side elevational view. The broken lines show a pair of hose couplings which can be mounted to the device. The broken lines are added for environmental purposes and are not part of the claimed design;

FIG. 2 is a side perspective view;

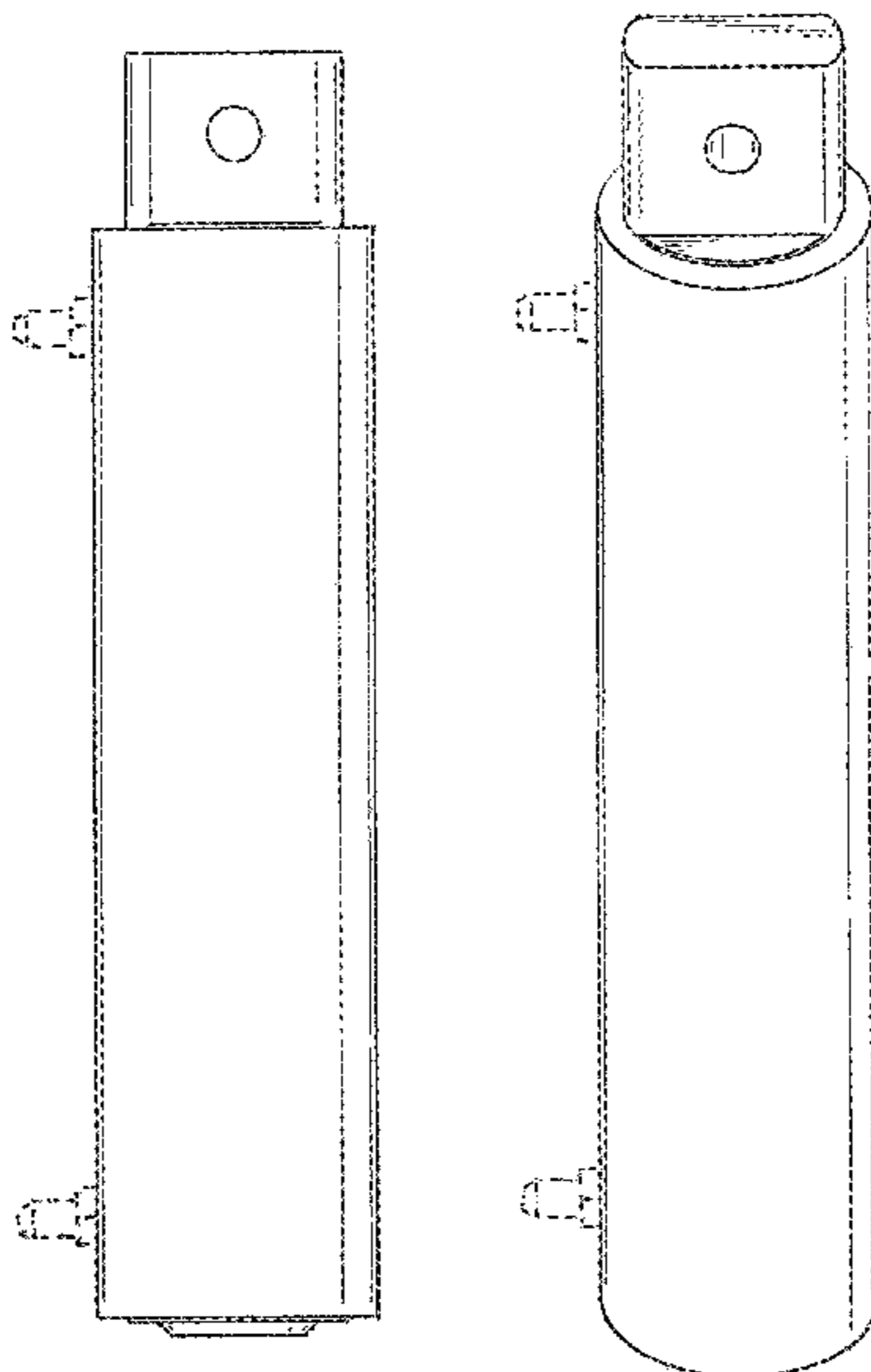

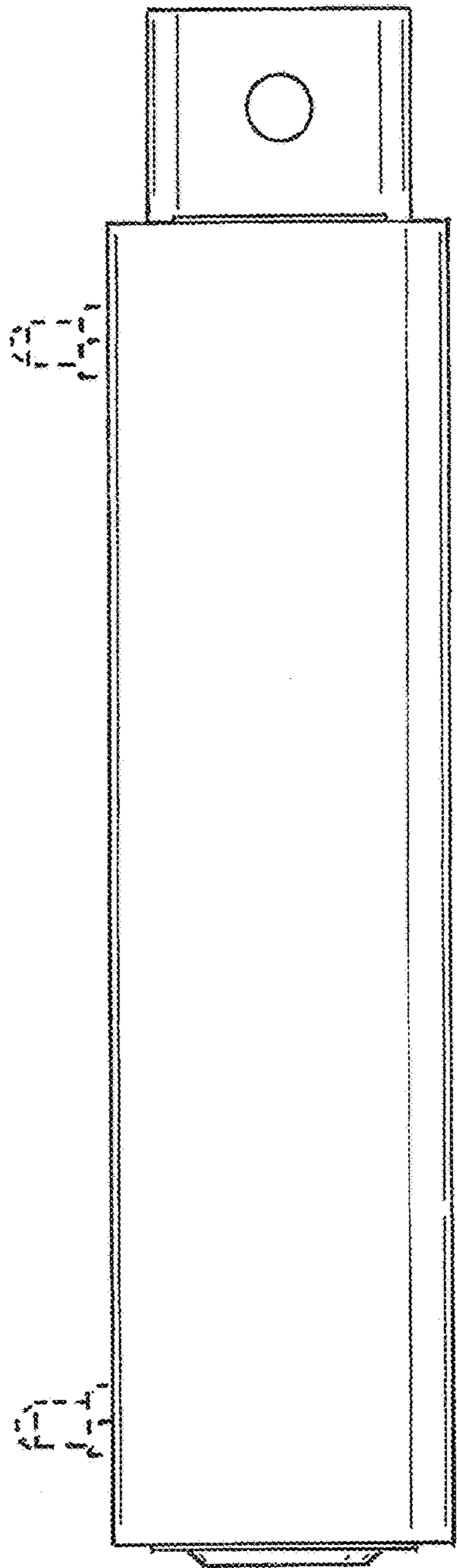

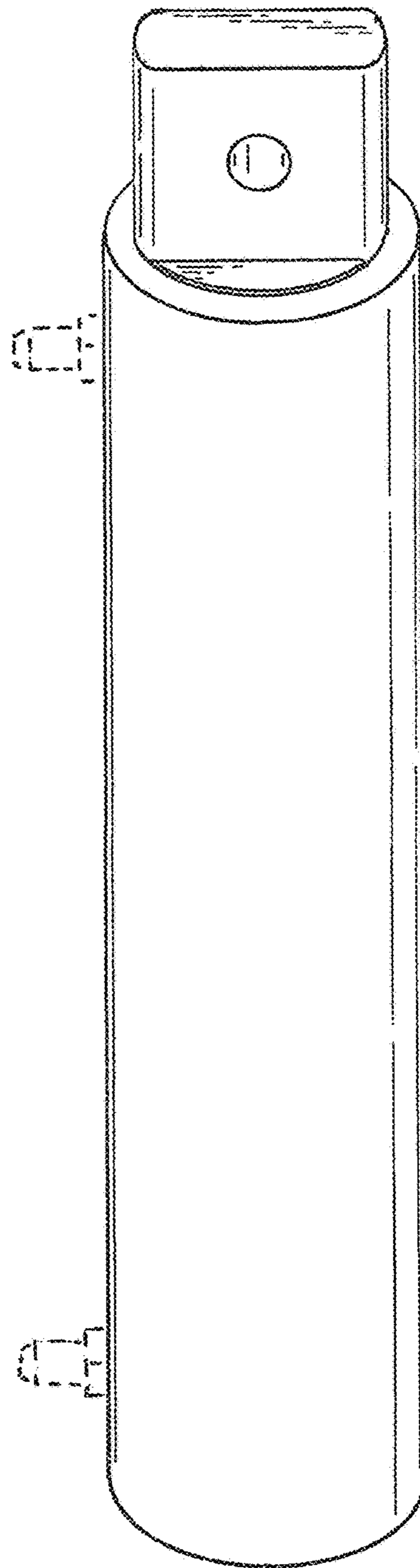

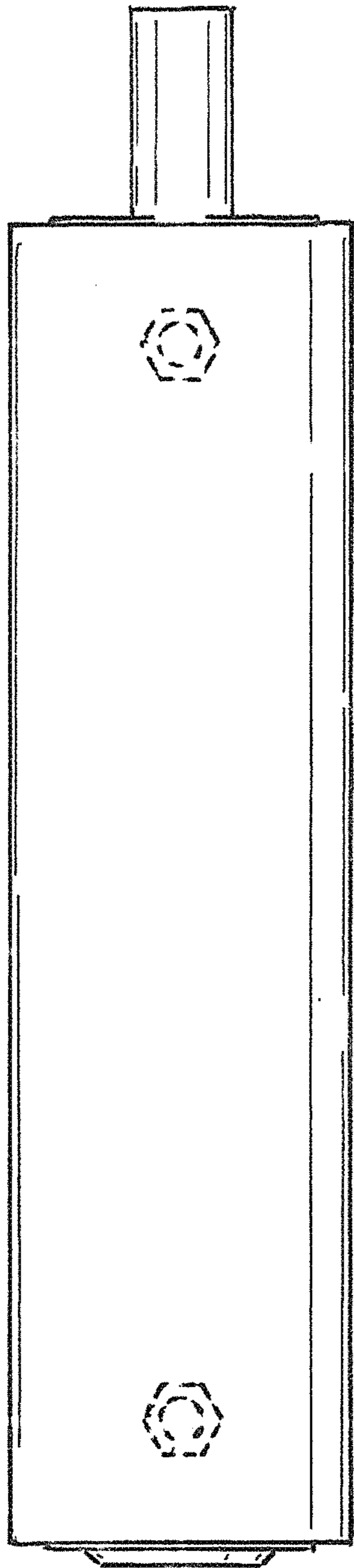

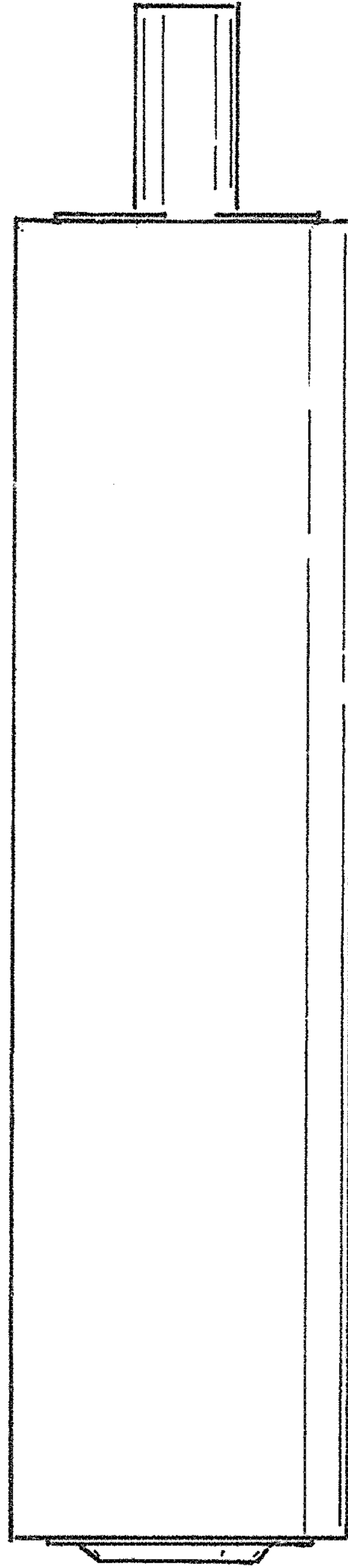

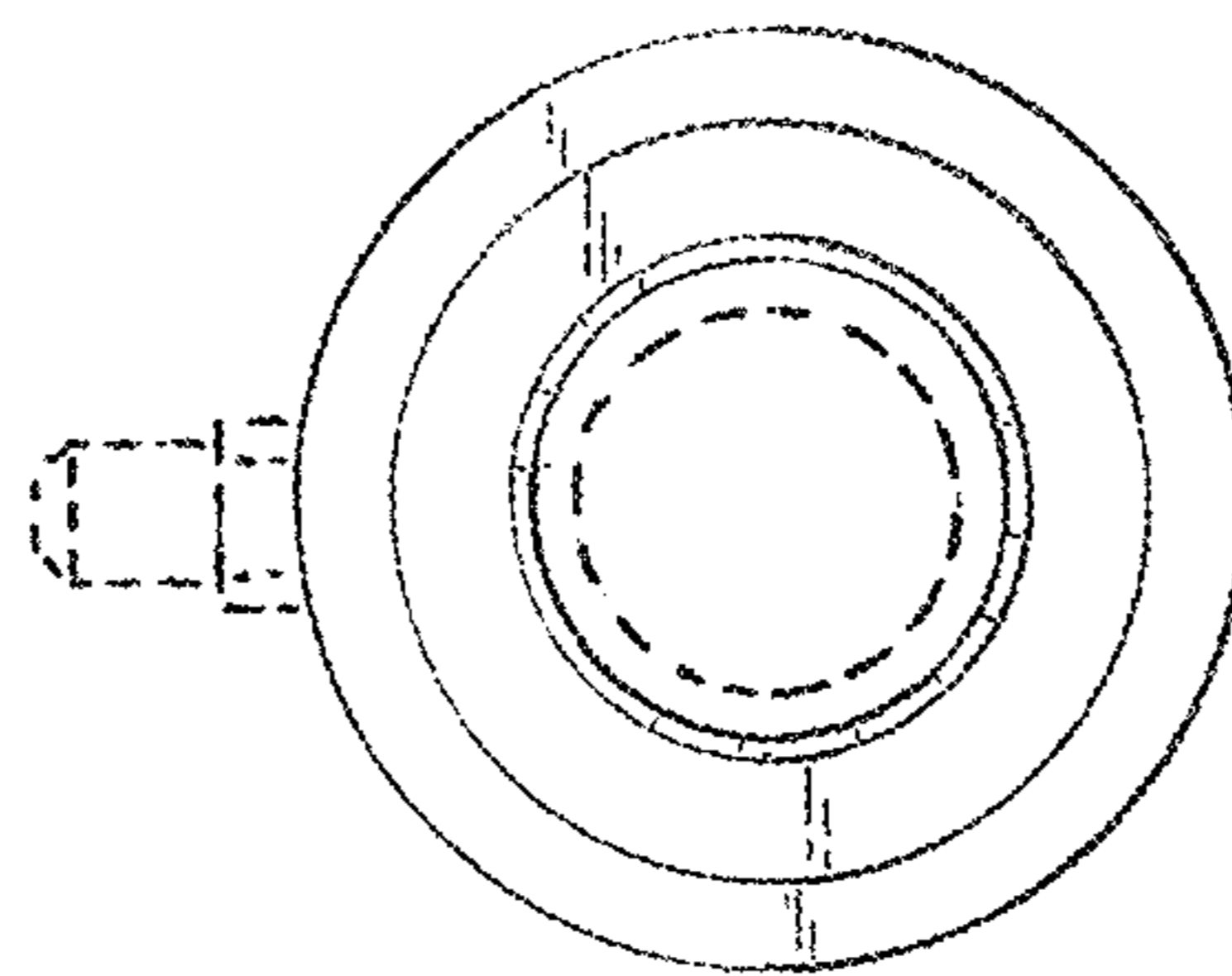
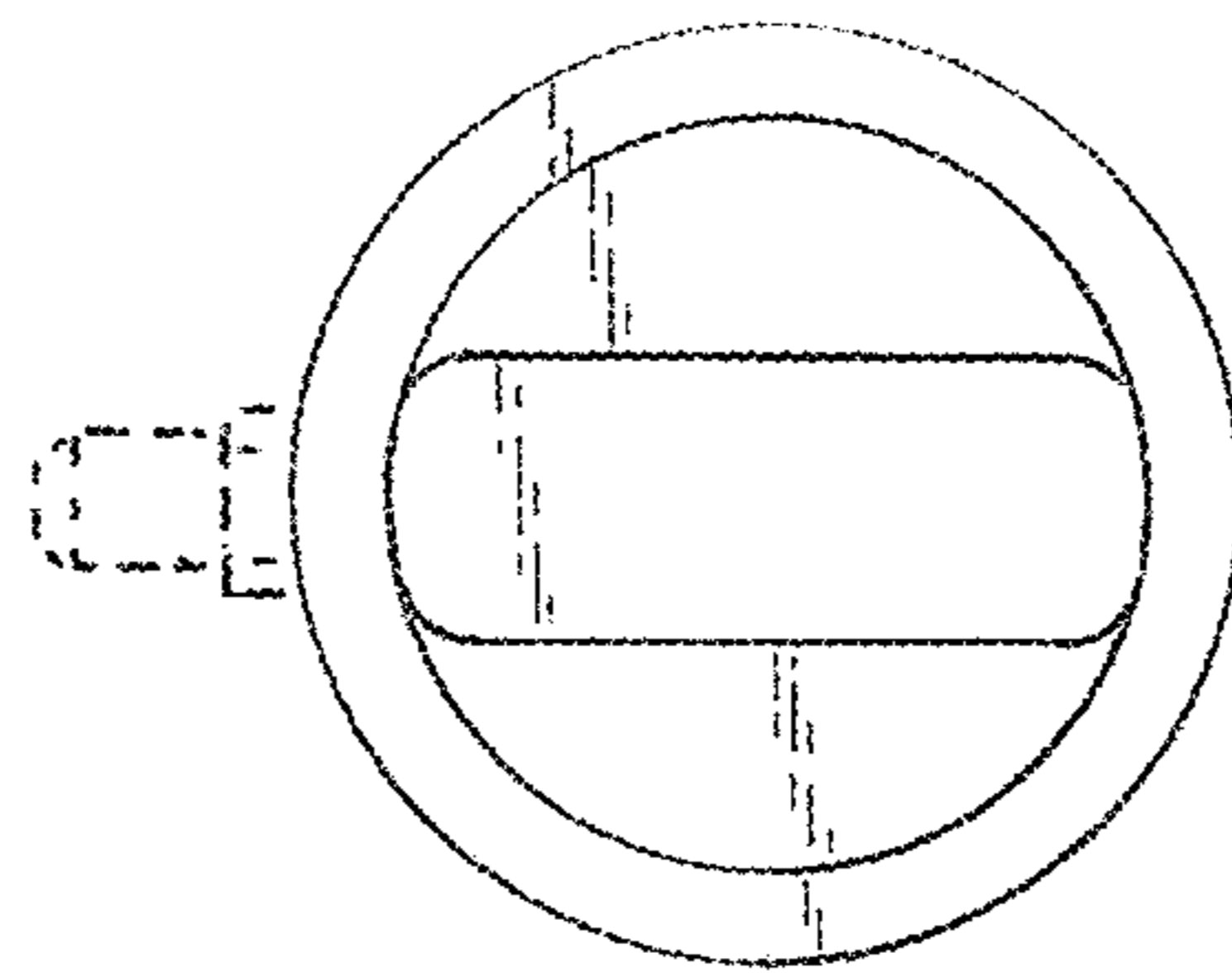
