FIG. 6 is a bottom view thereof.

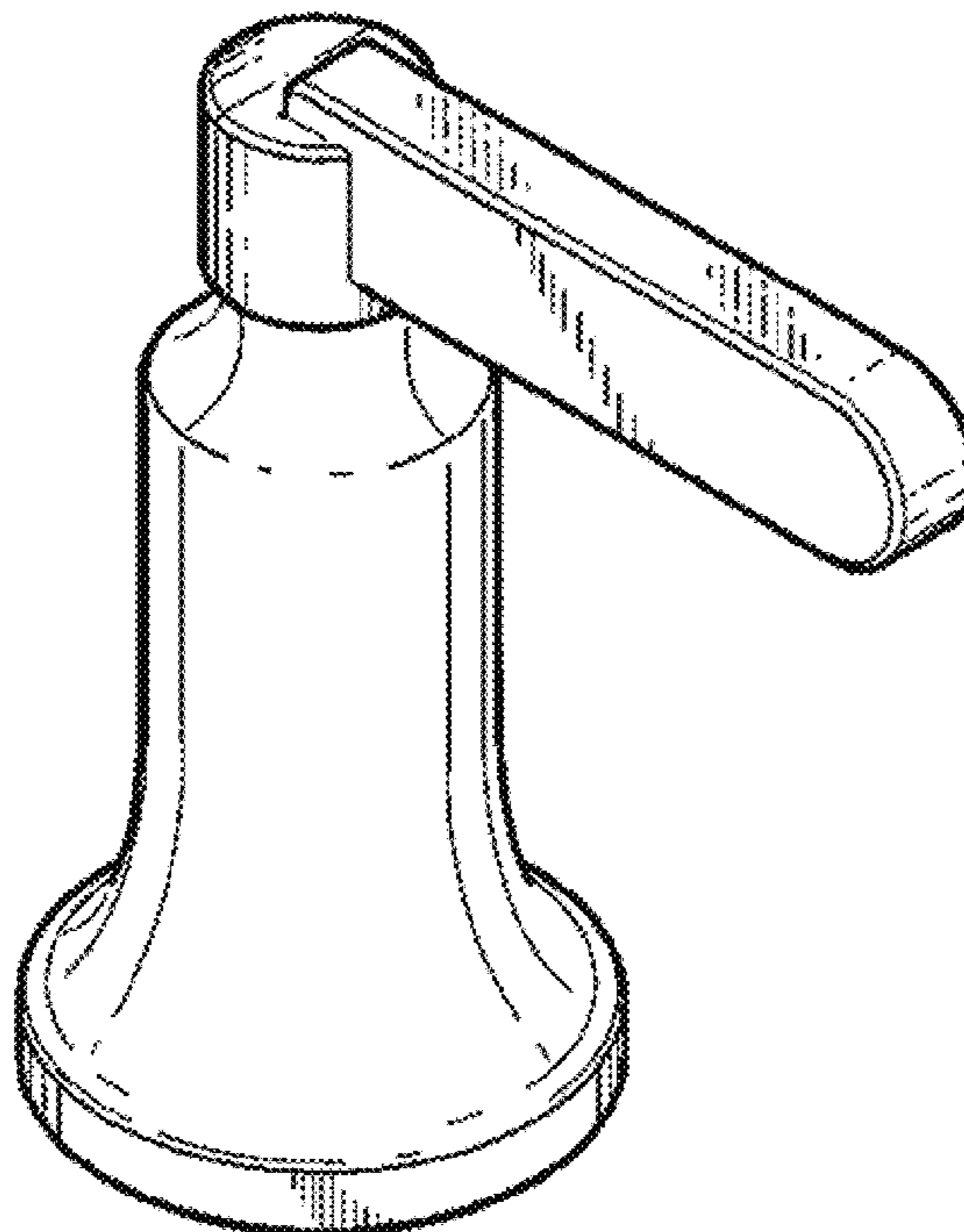
The broken lines showing apertures are included for the

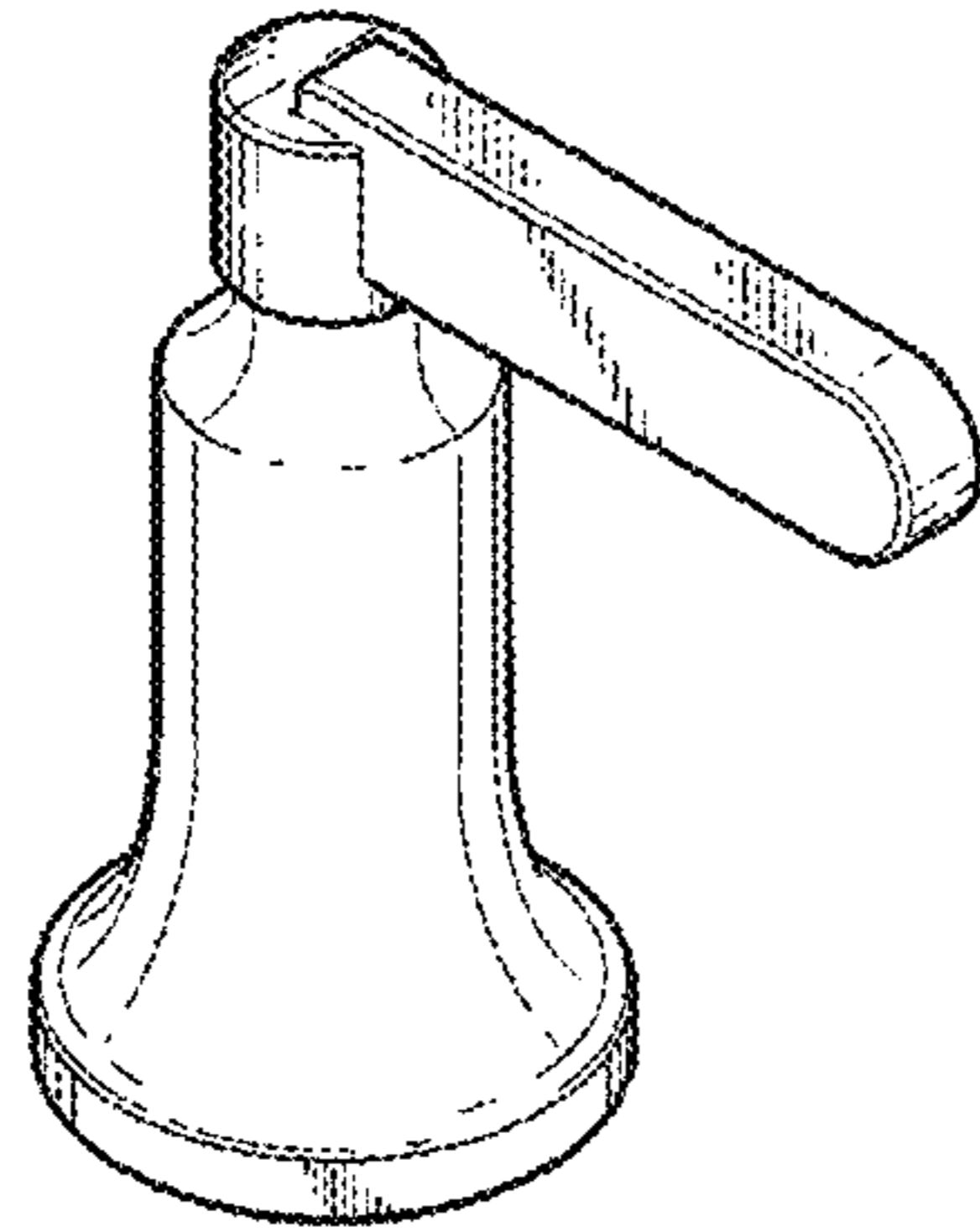

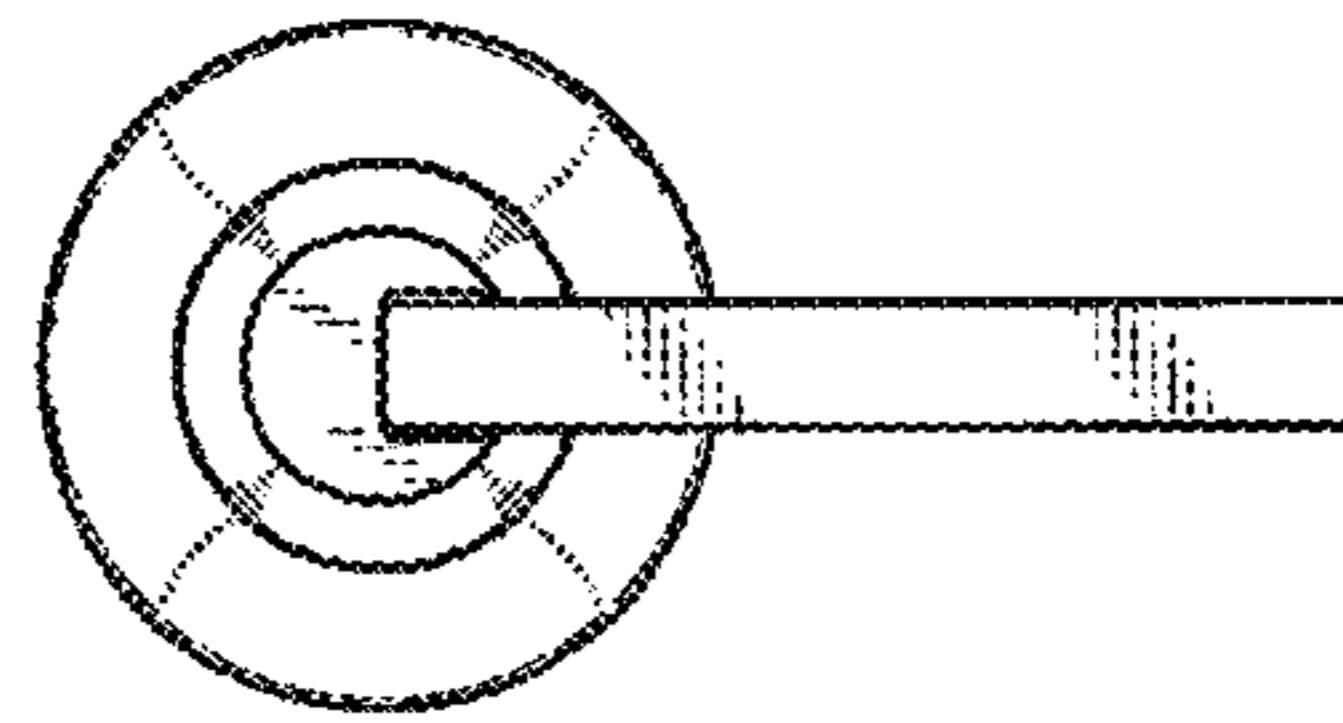

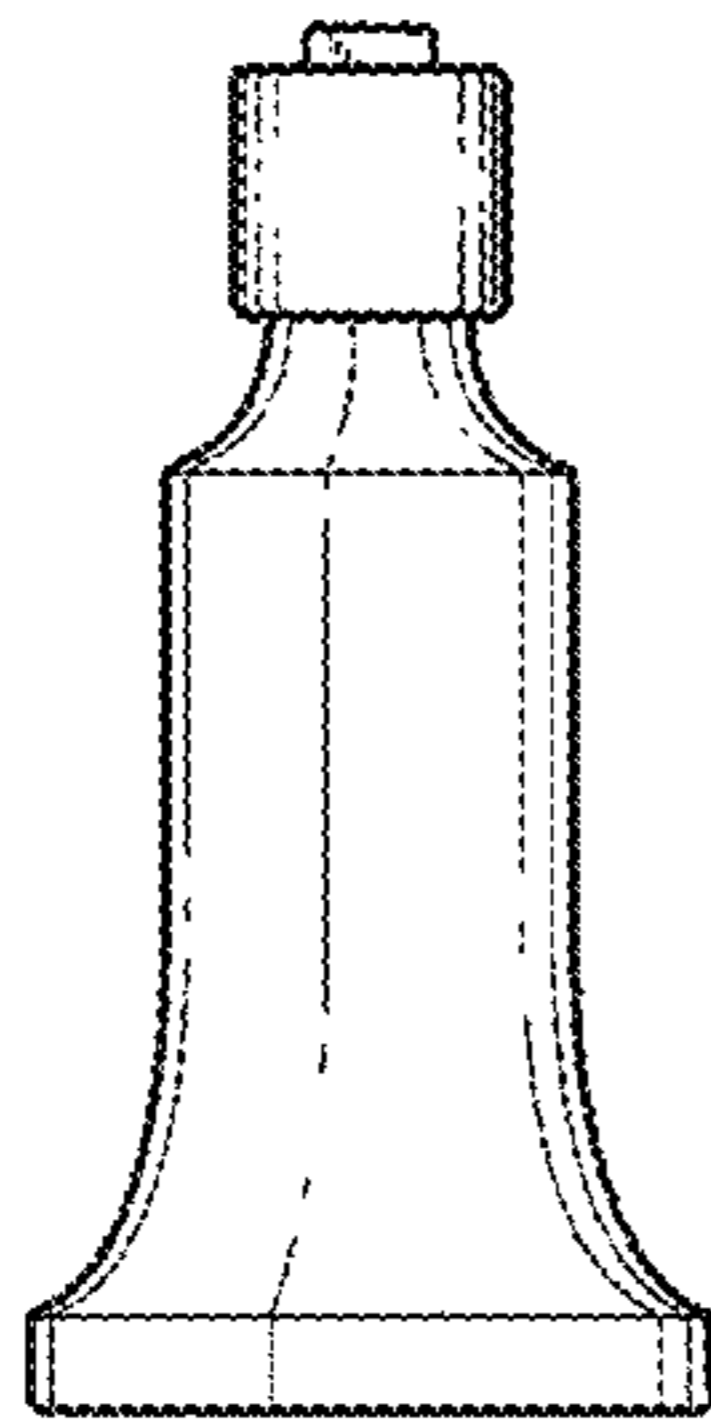

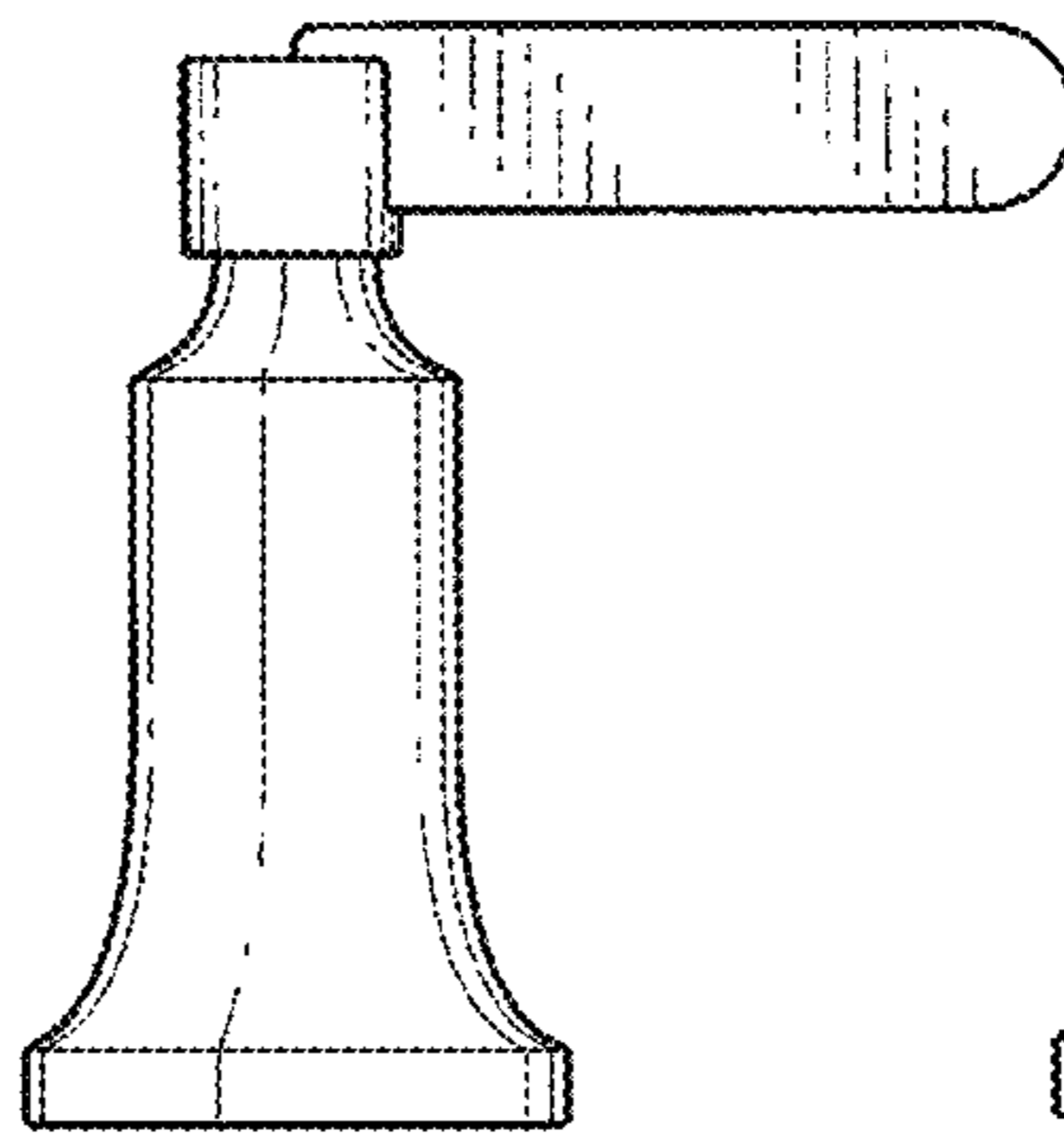

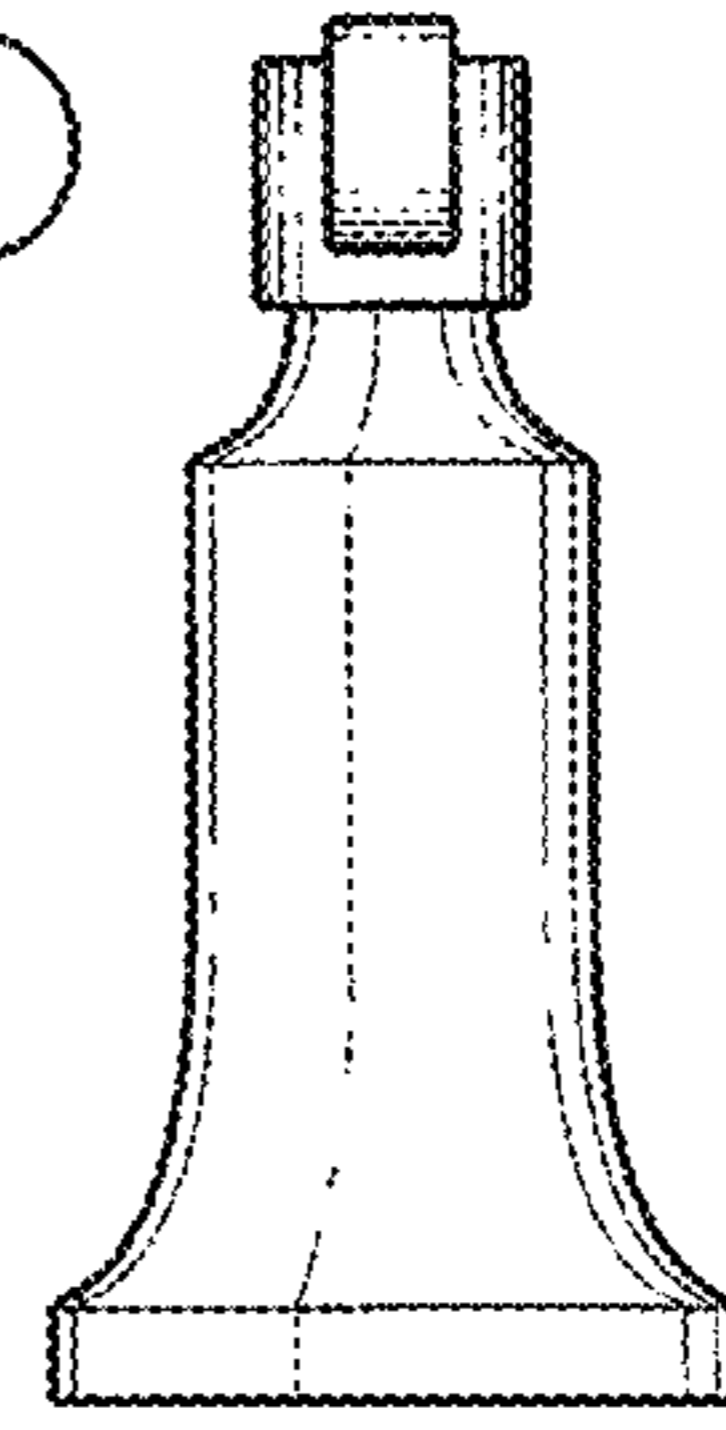

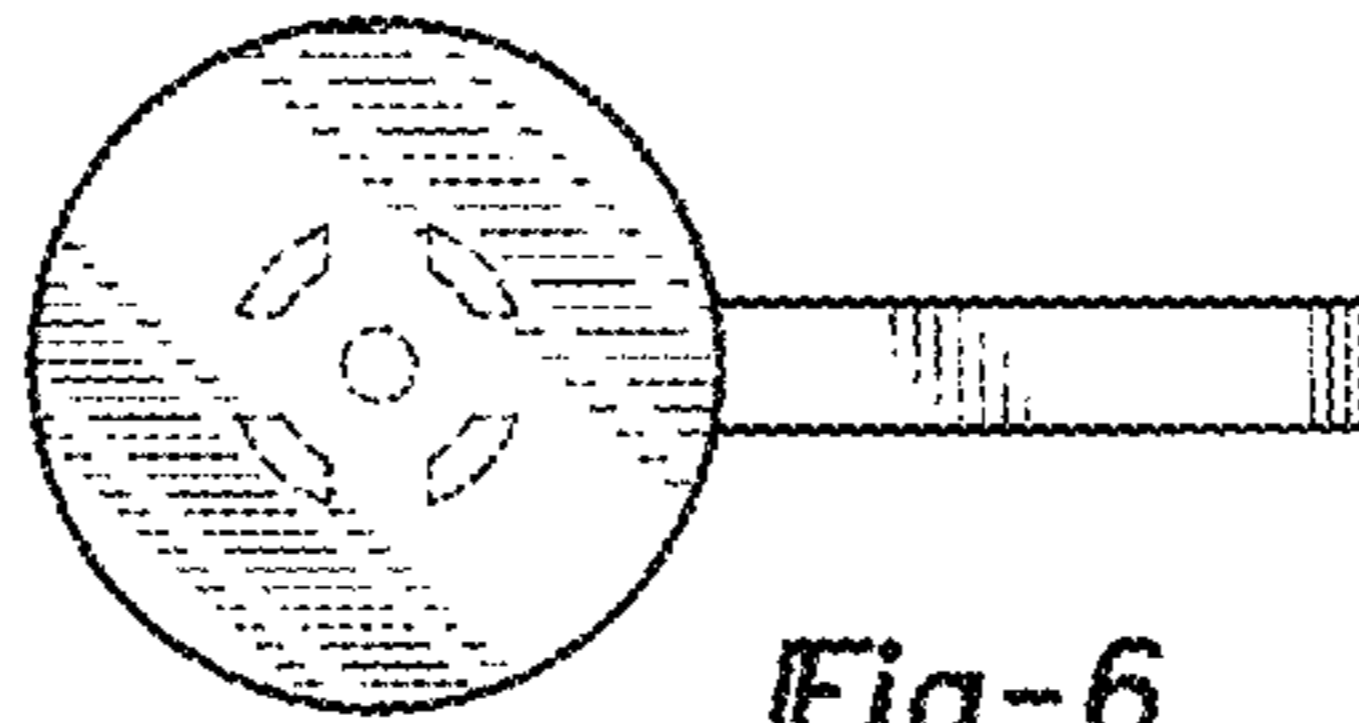
