We claim the ornamental design for a spa exterior, as shown
and described.

DESCRIPTION

FIG. 1 is a front elevation view of the spa exterior showing
my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom elevation view thereof; and,
FIG. 7 is a top perspective view thereof.
The broken lines in FIGS. 5, 6, and 7 represent unclaimed
portions of the spa shell.

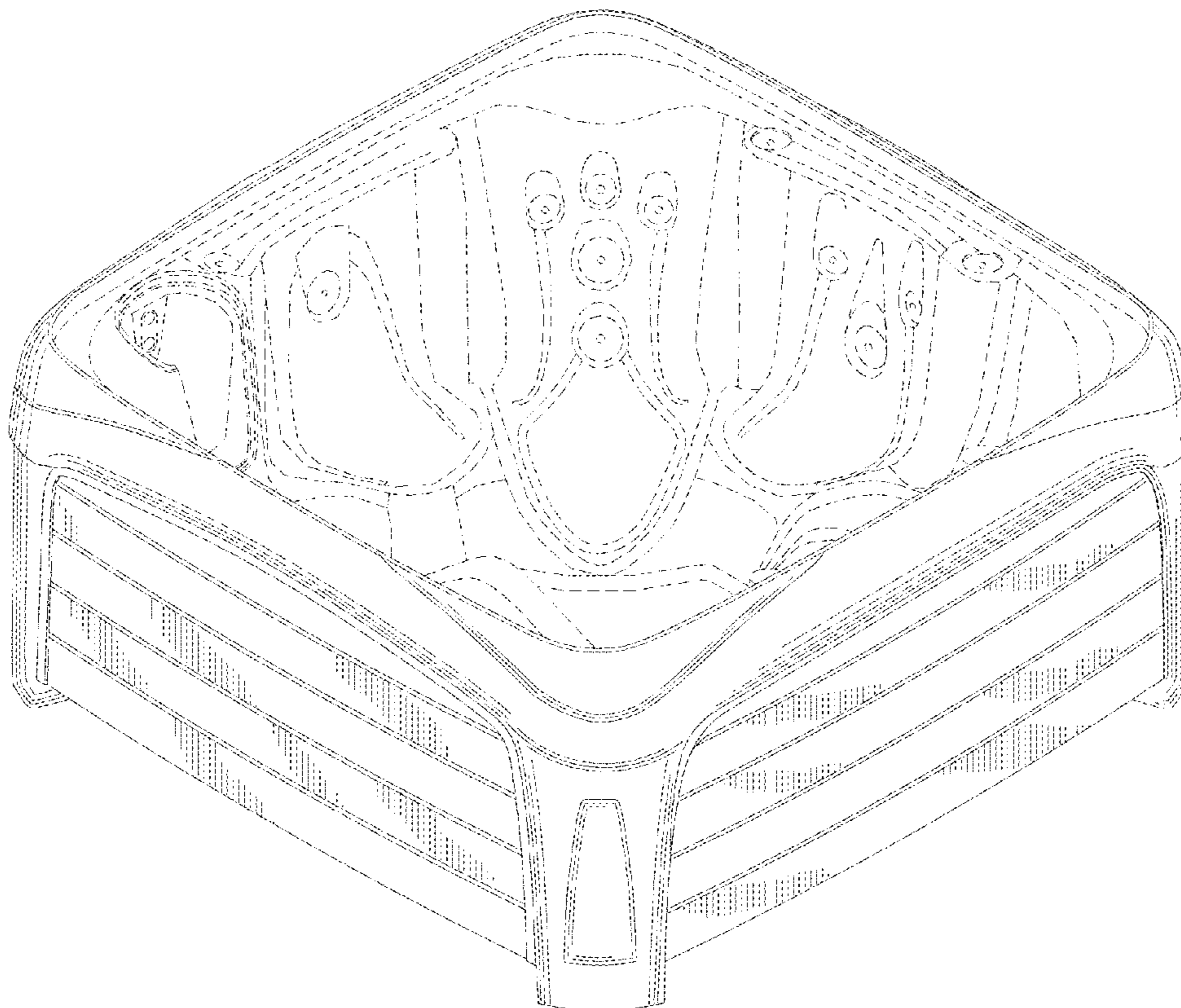

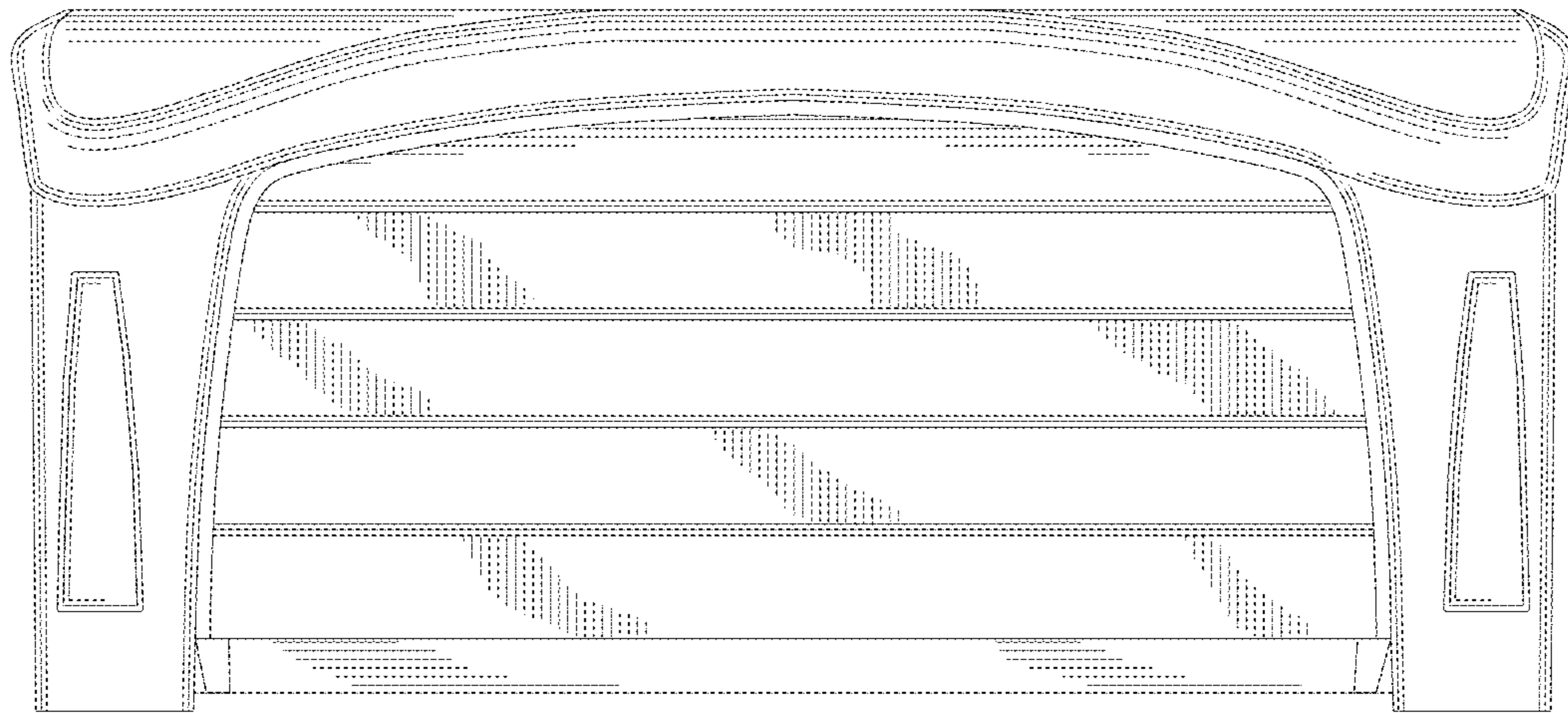

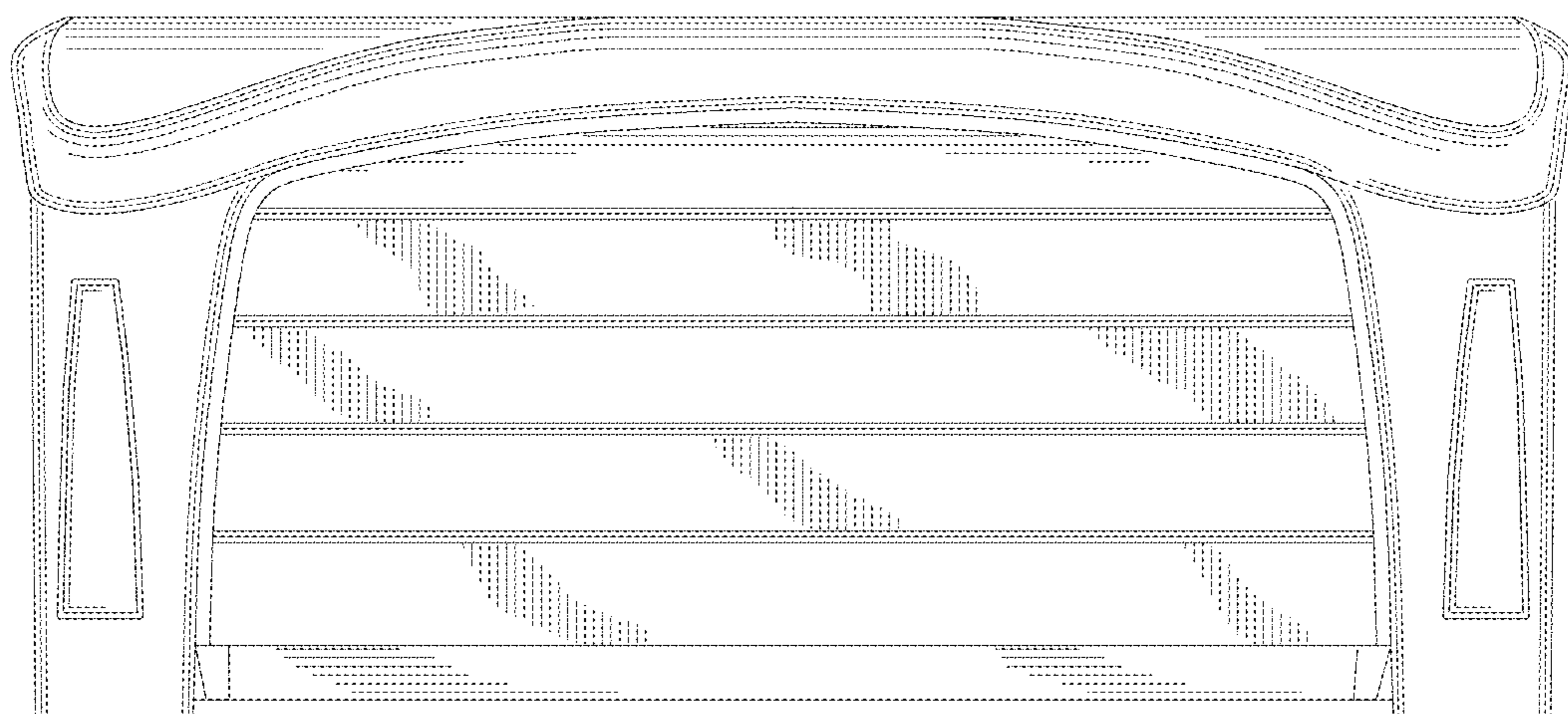

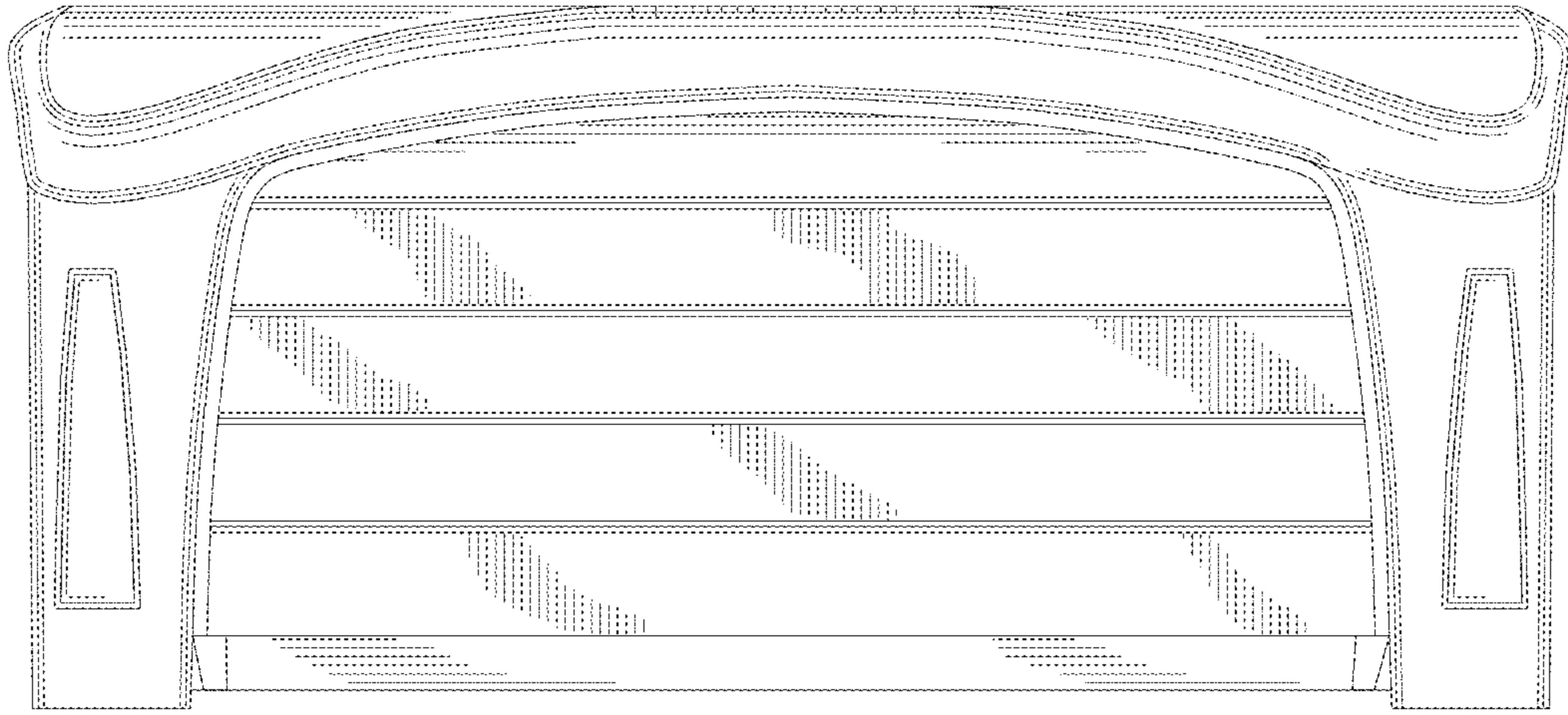

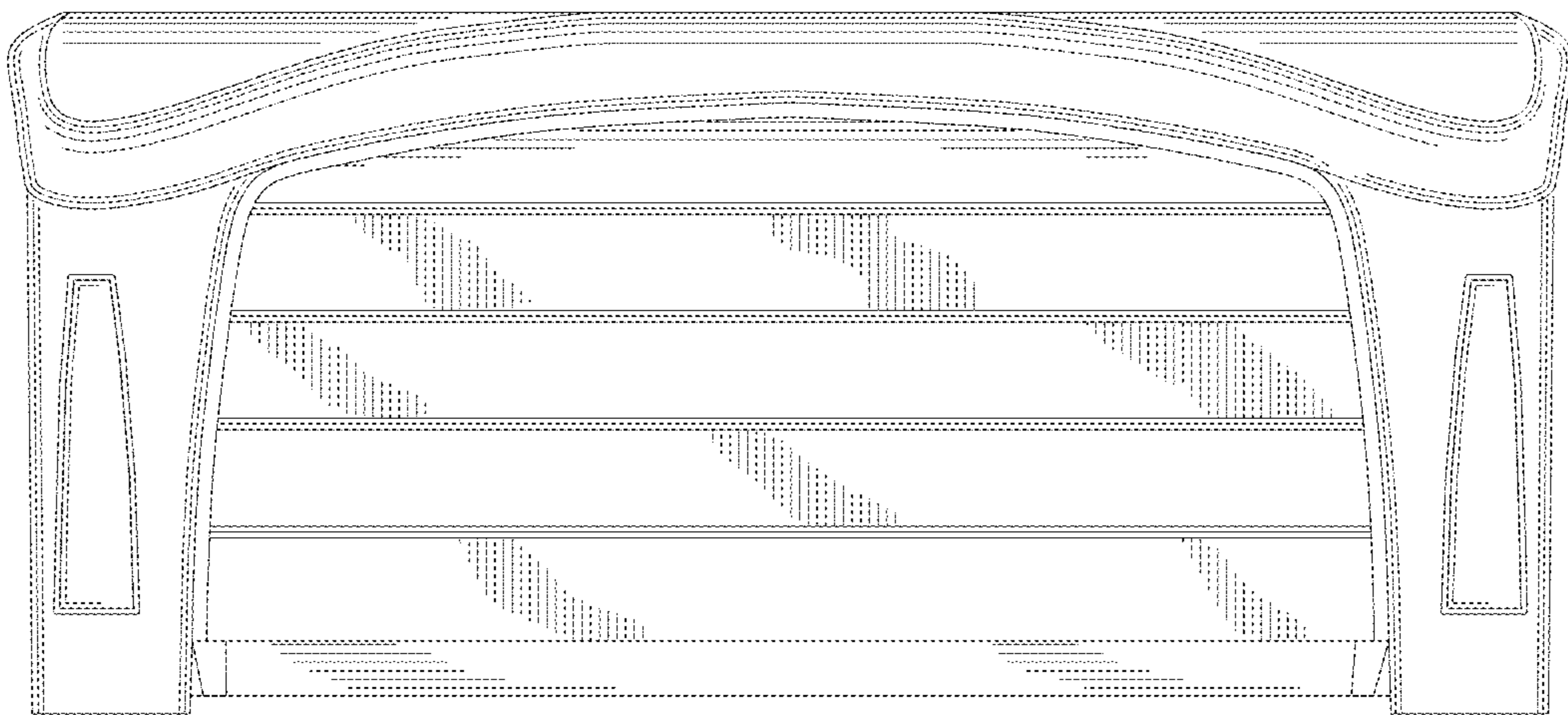

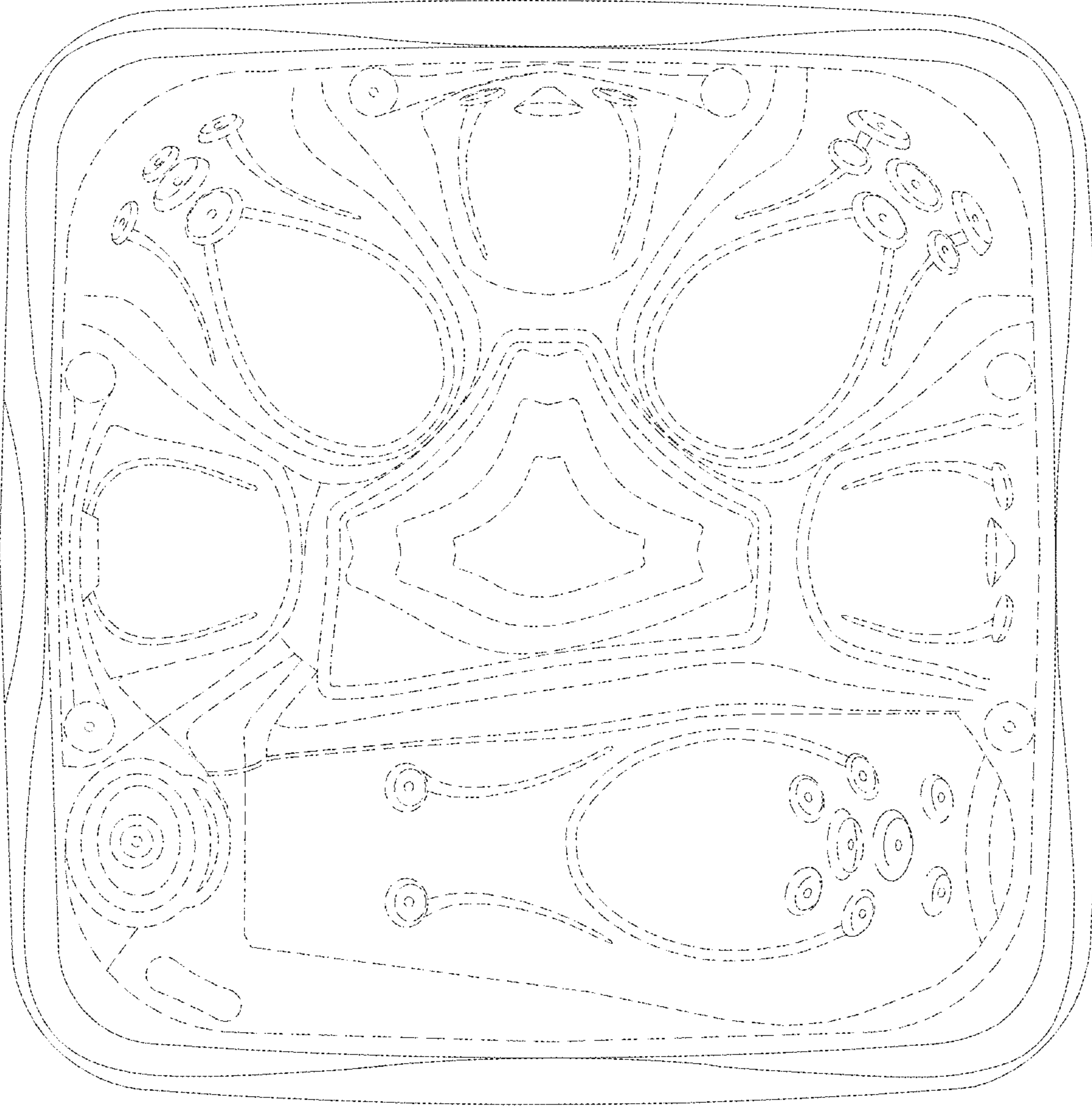

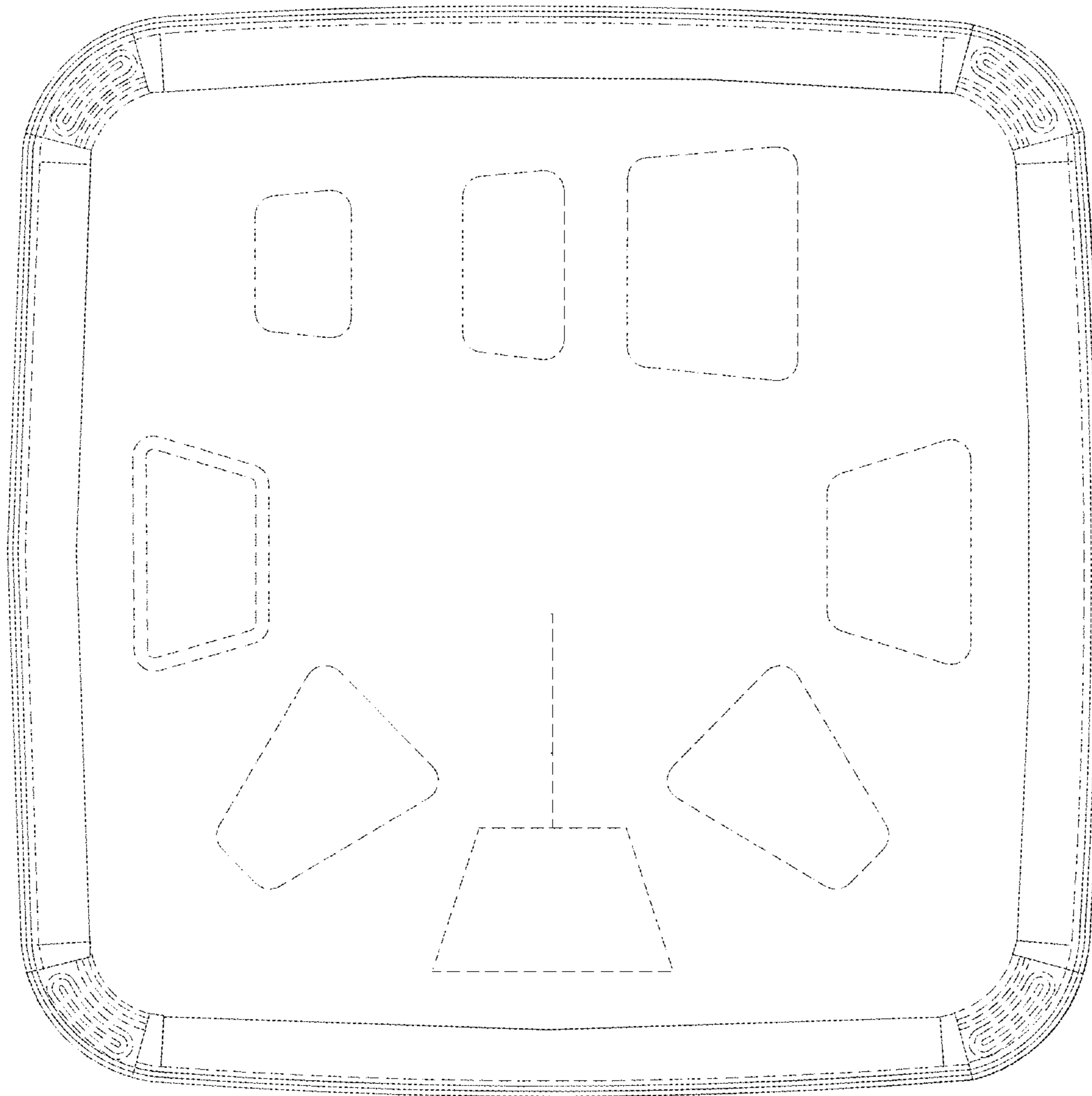
