DESCRIPTION

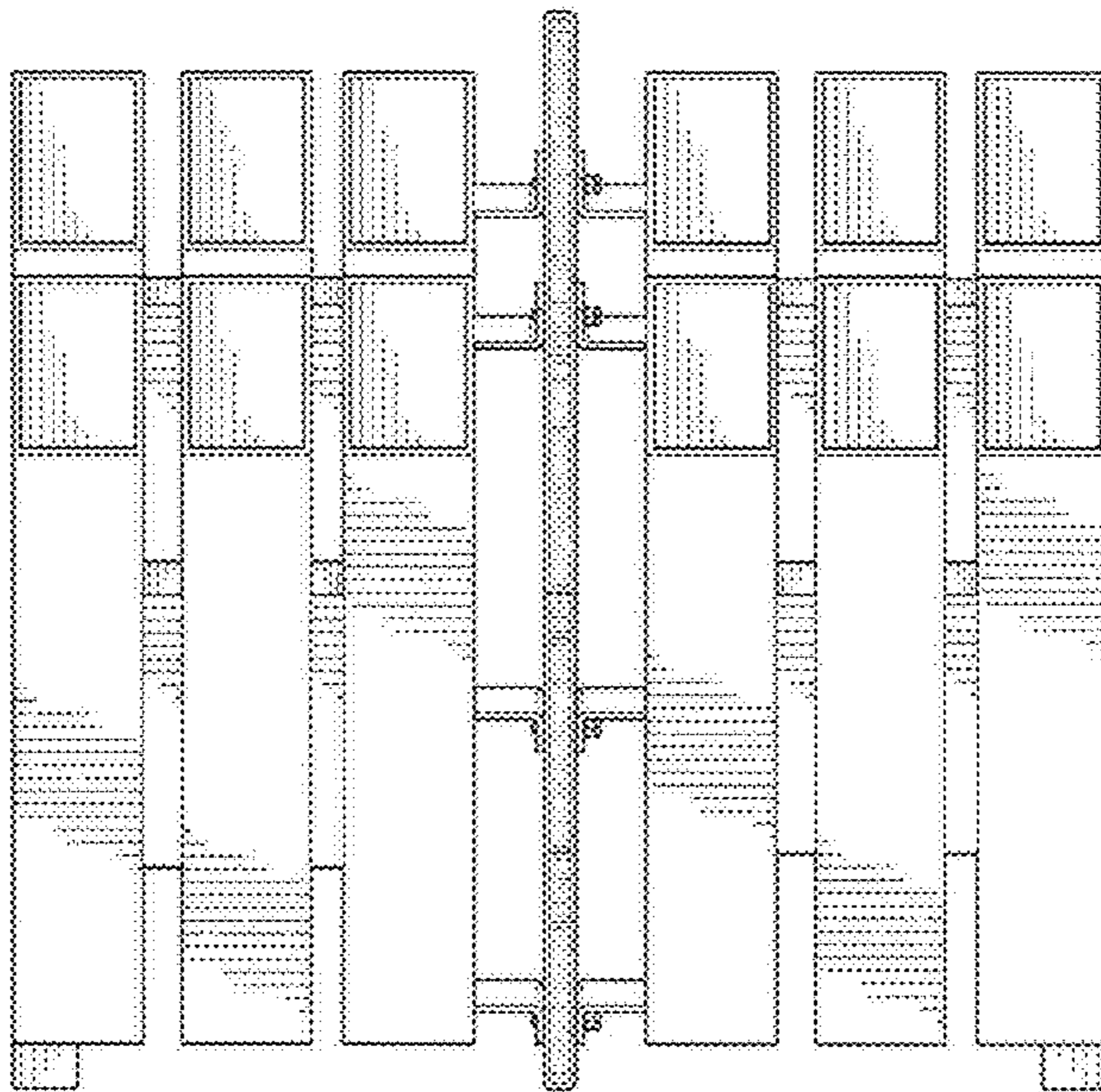

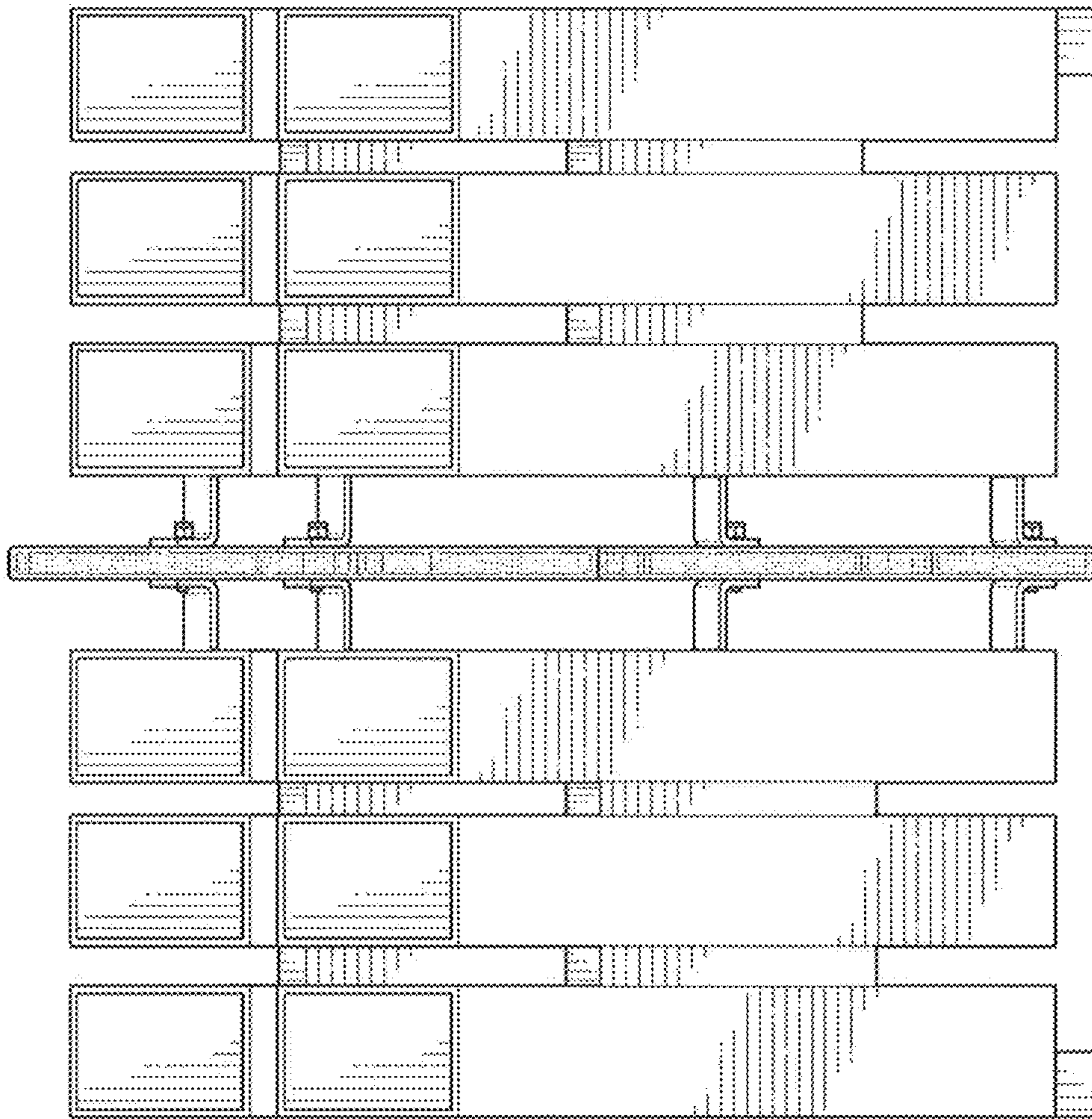

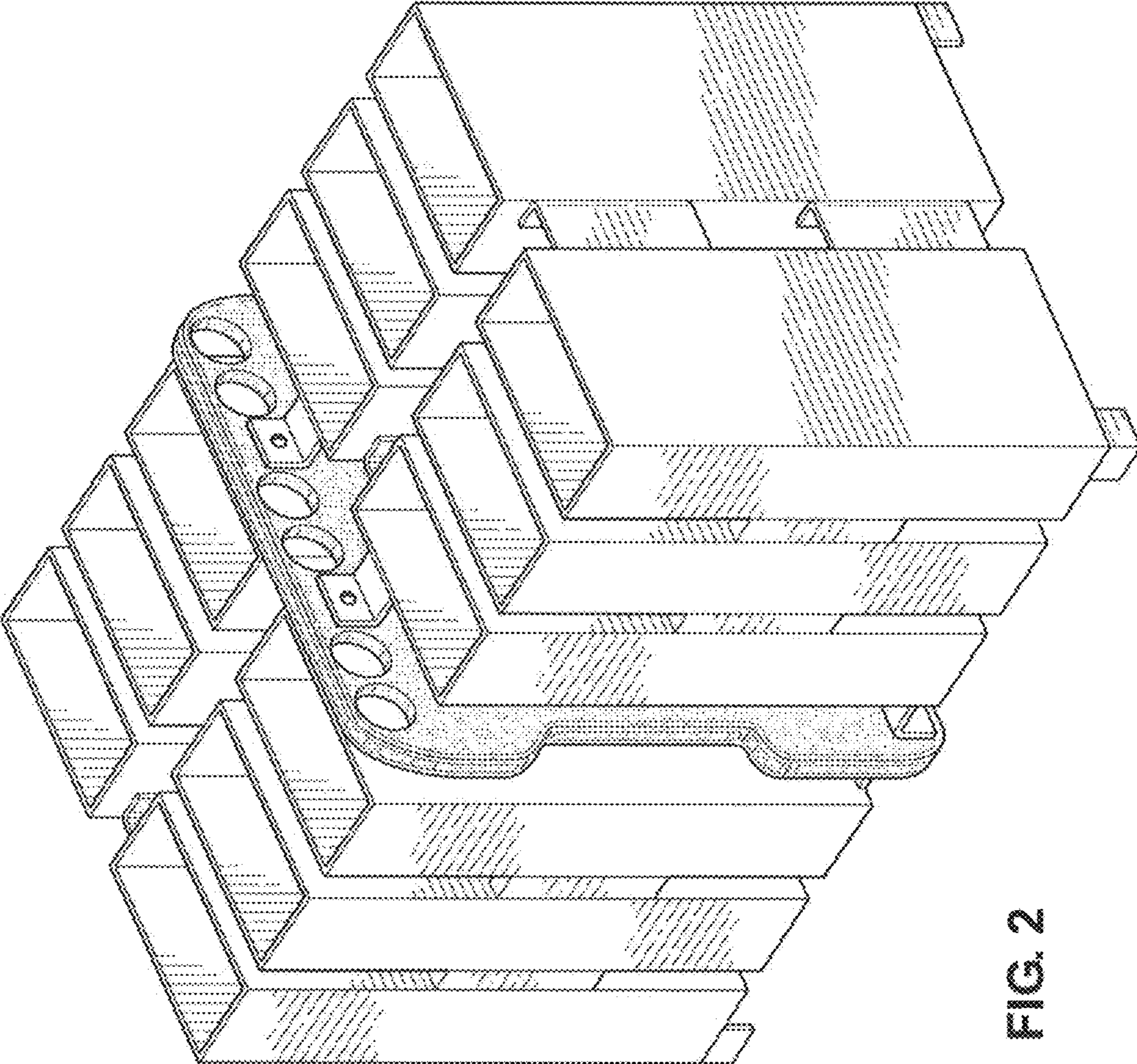

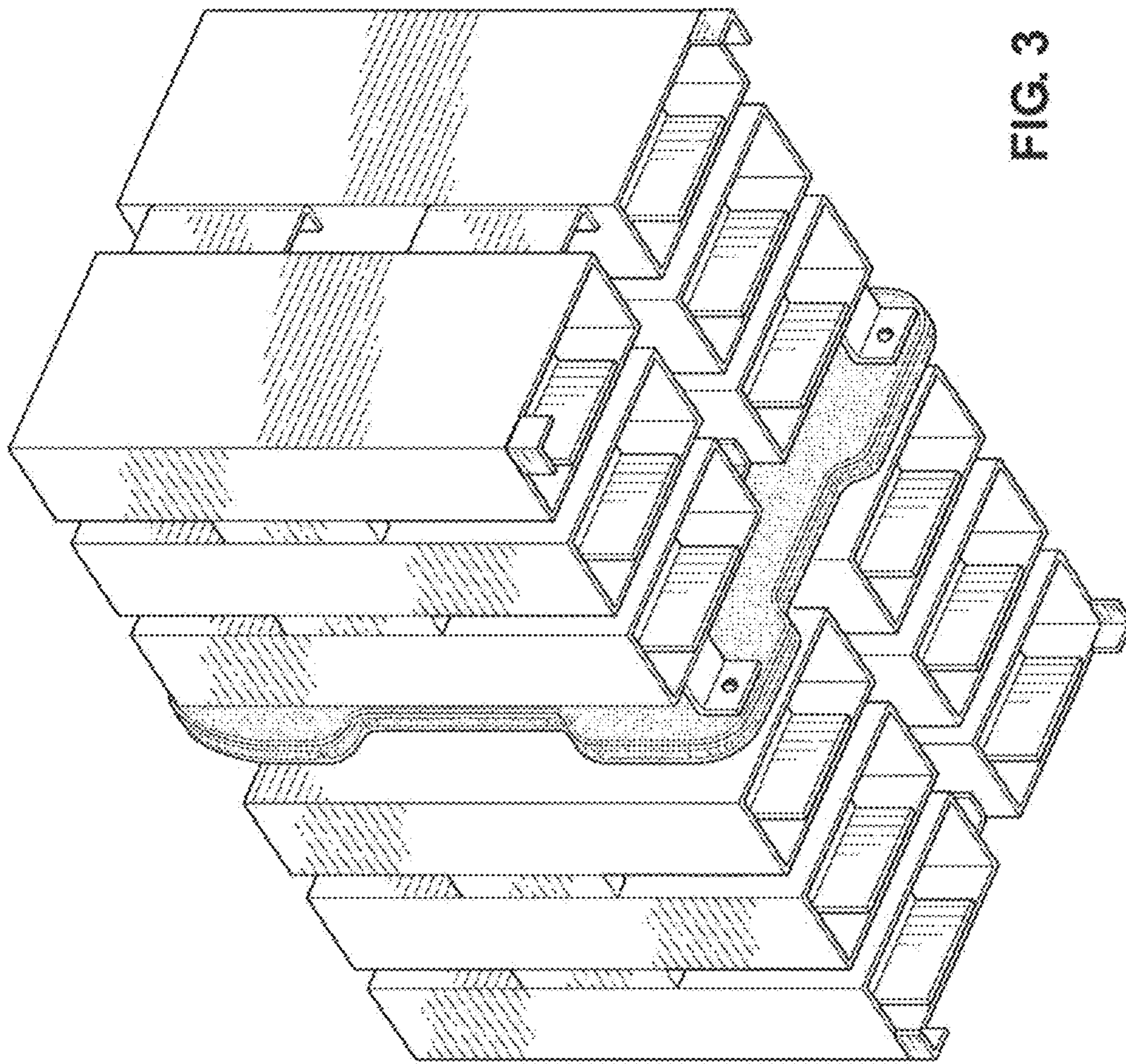

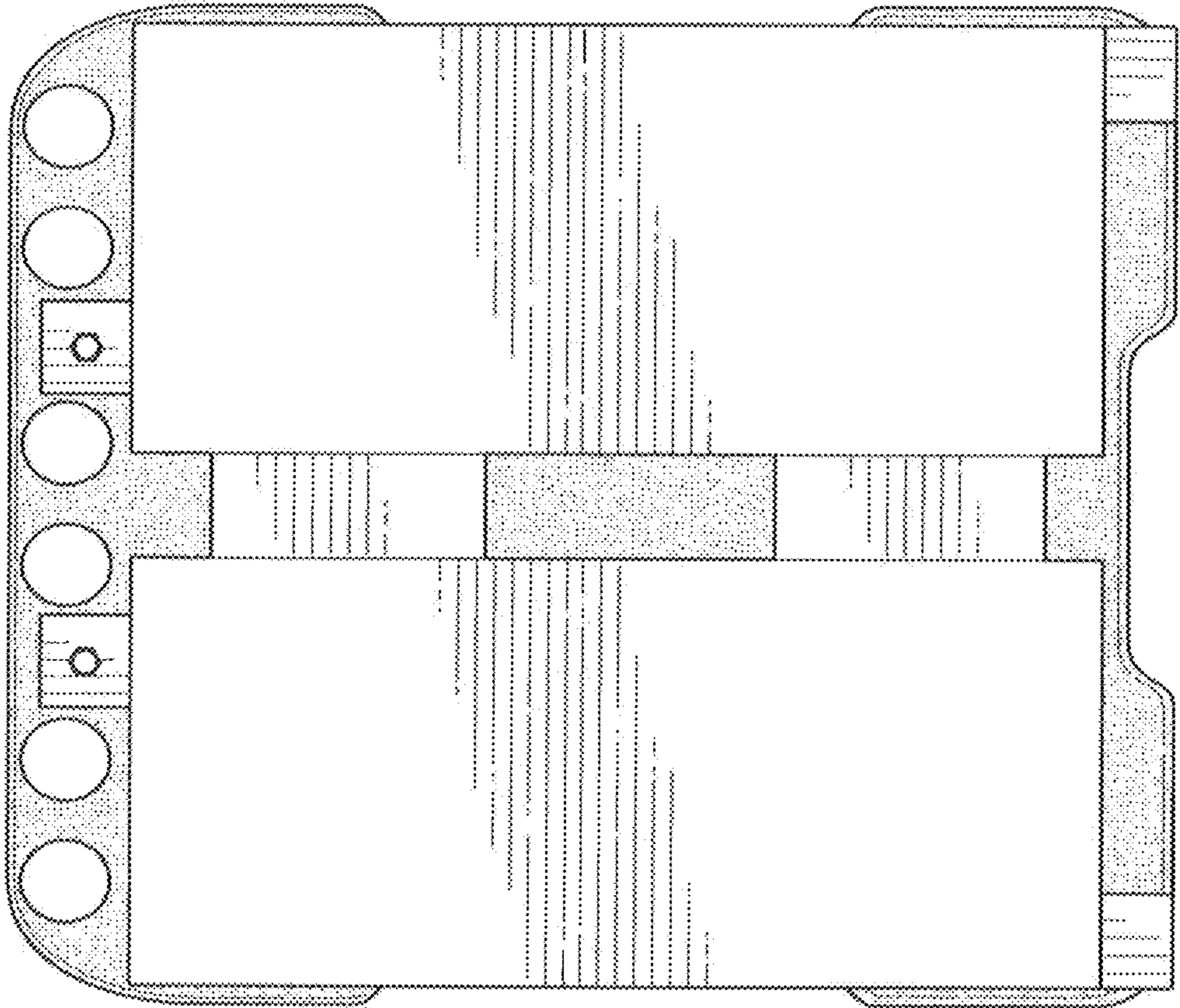

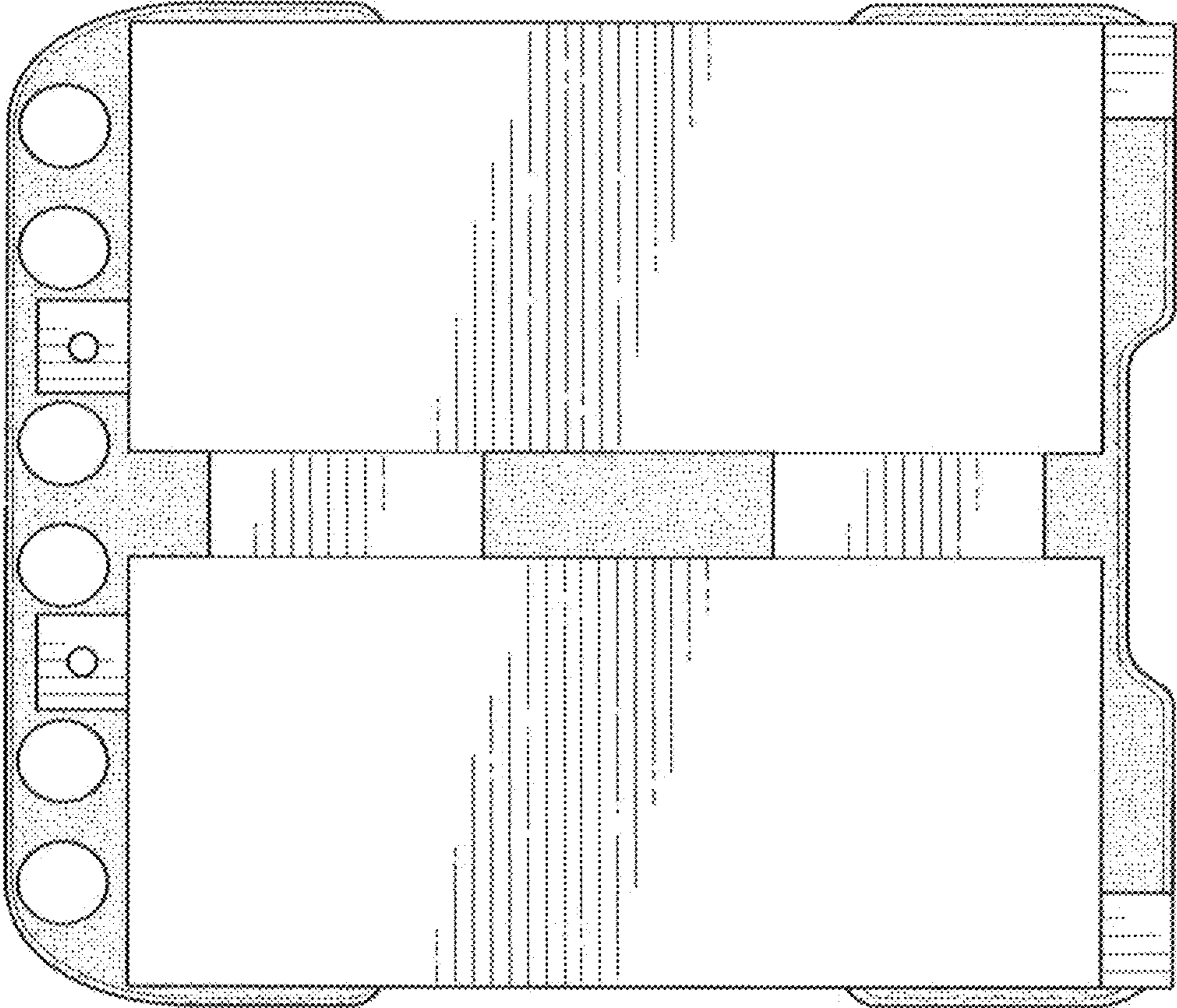

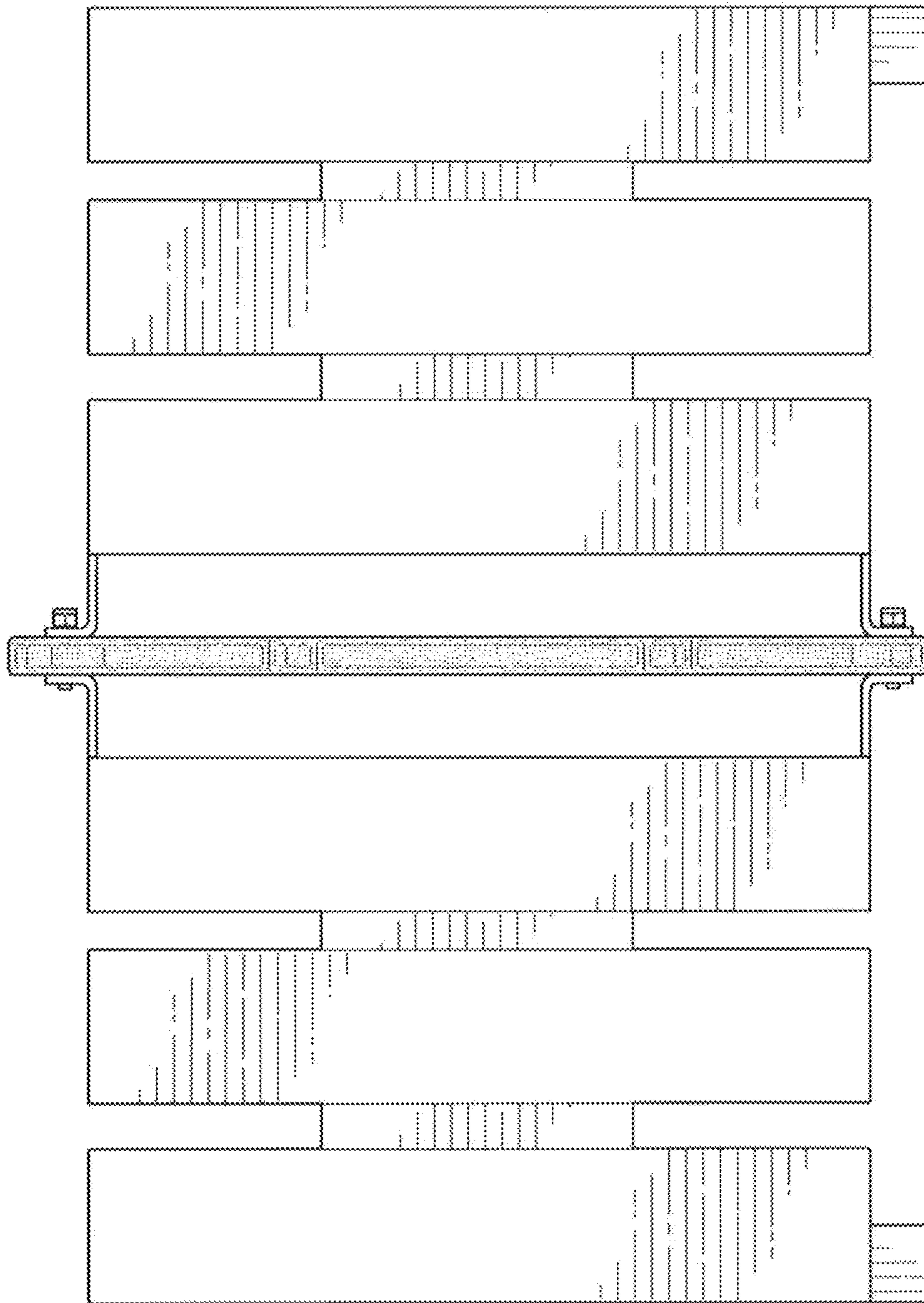

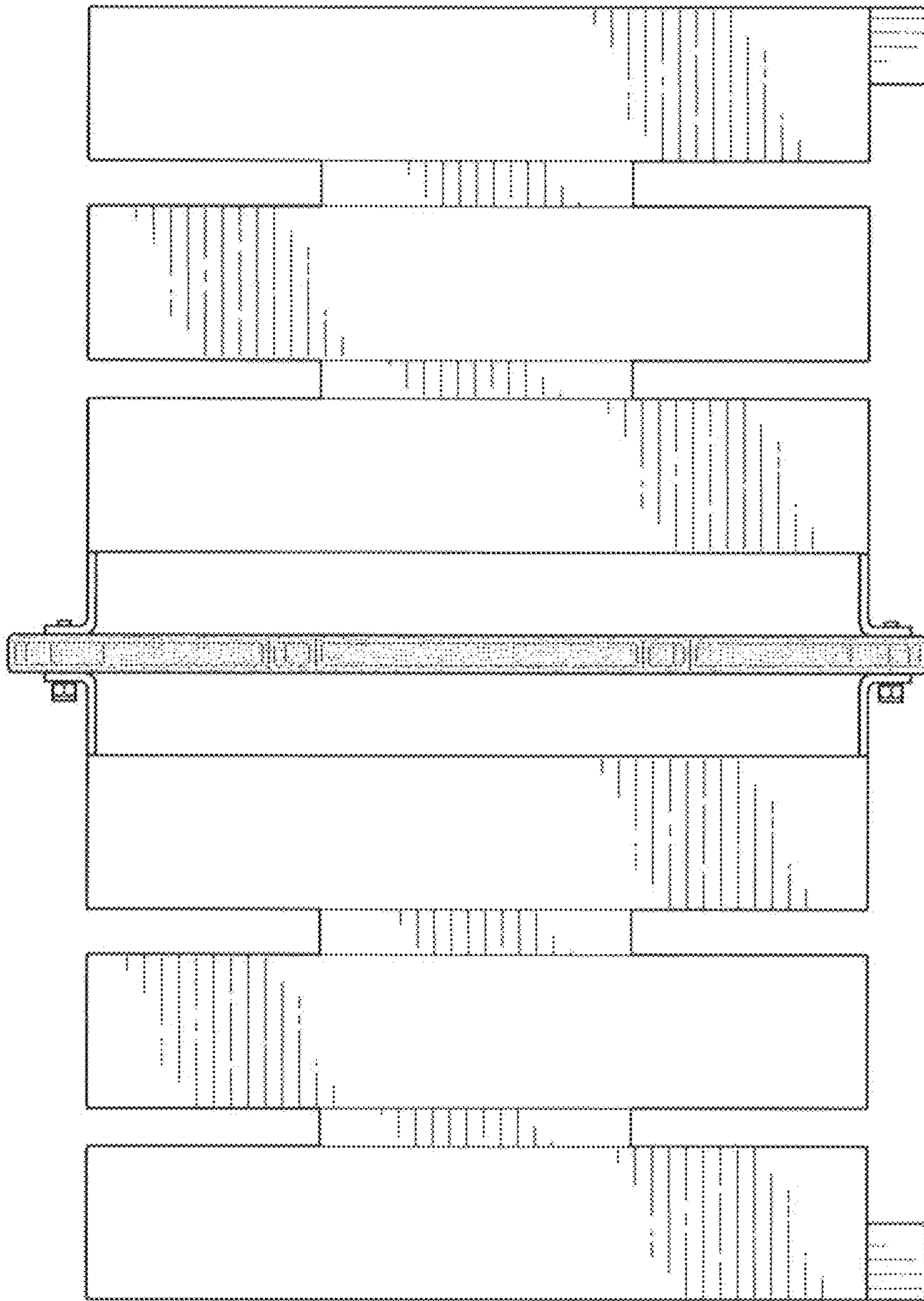

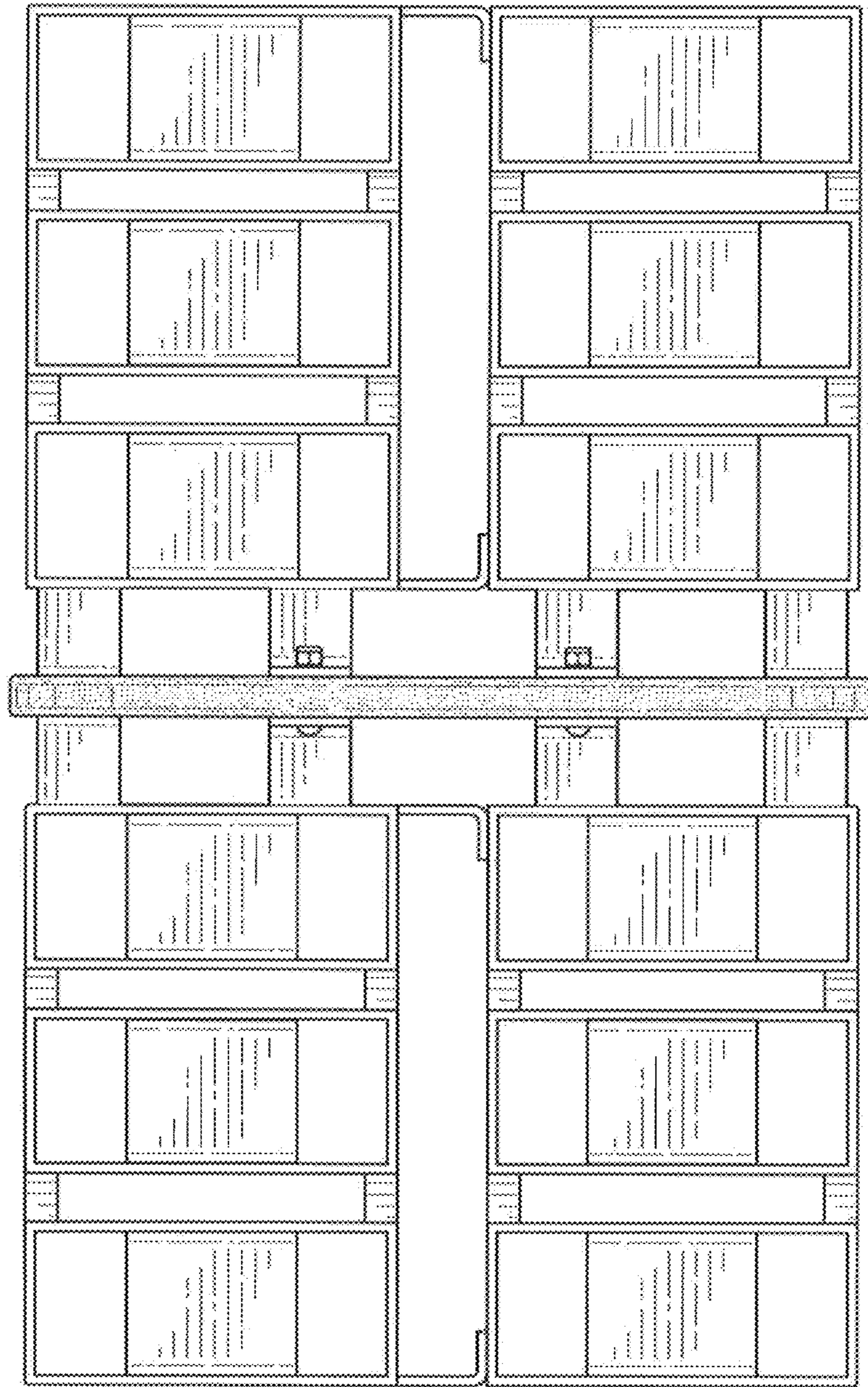

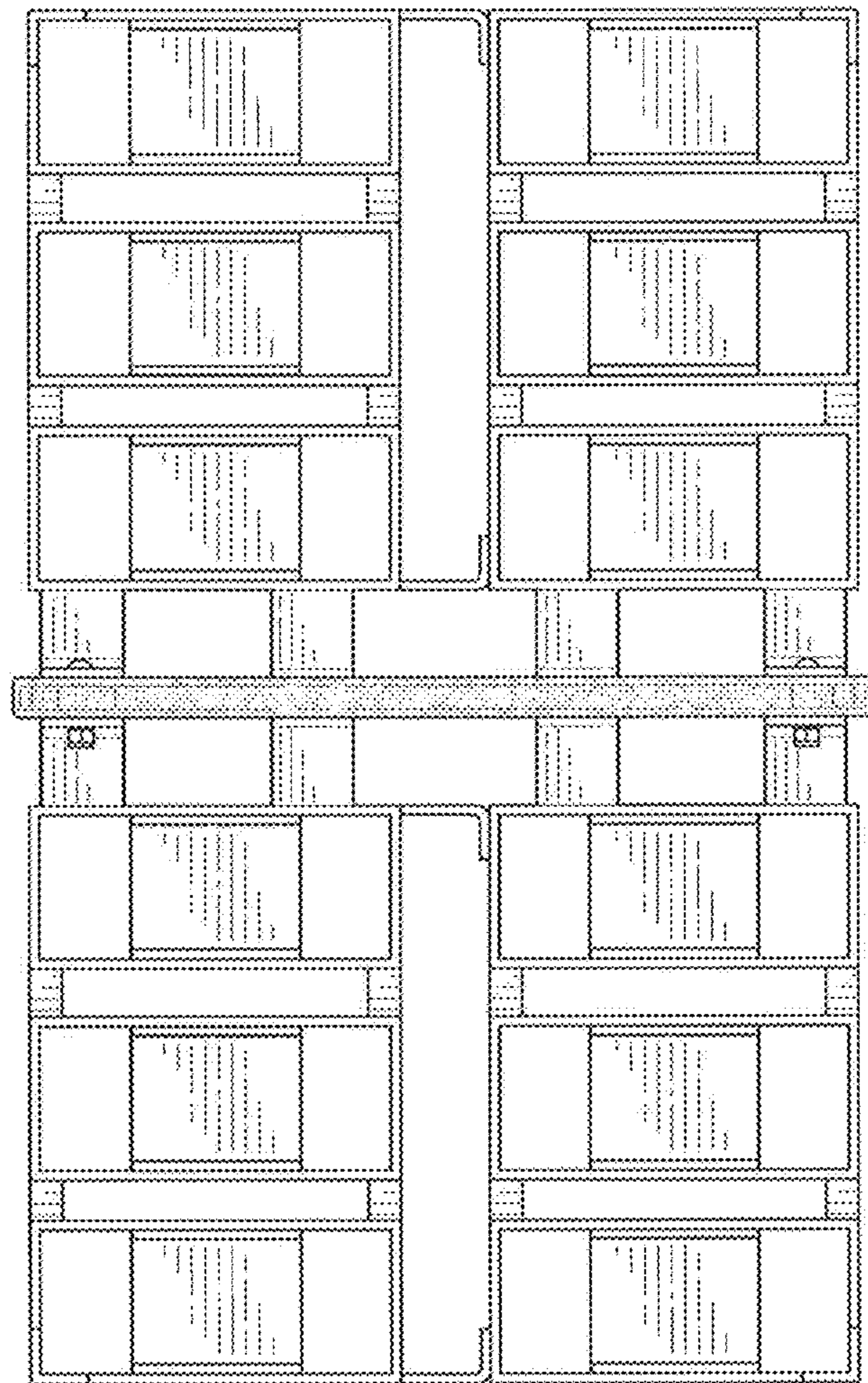
