We claim the ornamental design for an electric clipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electric clipper of the present invention;

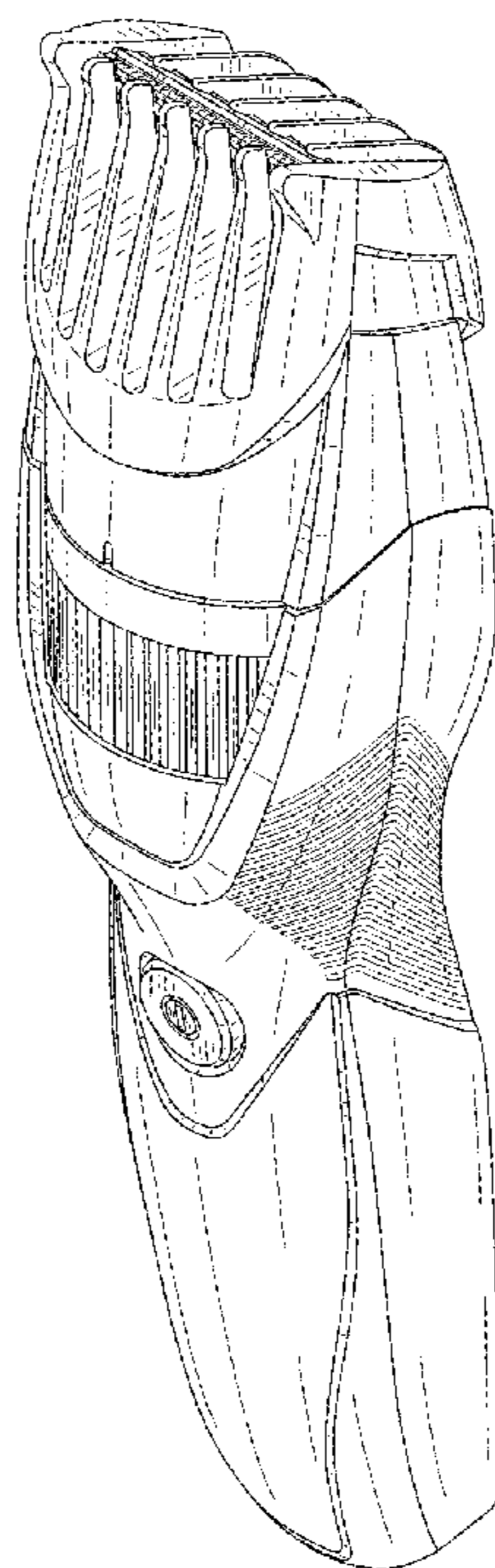

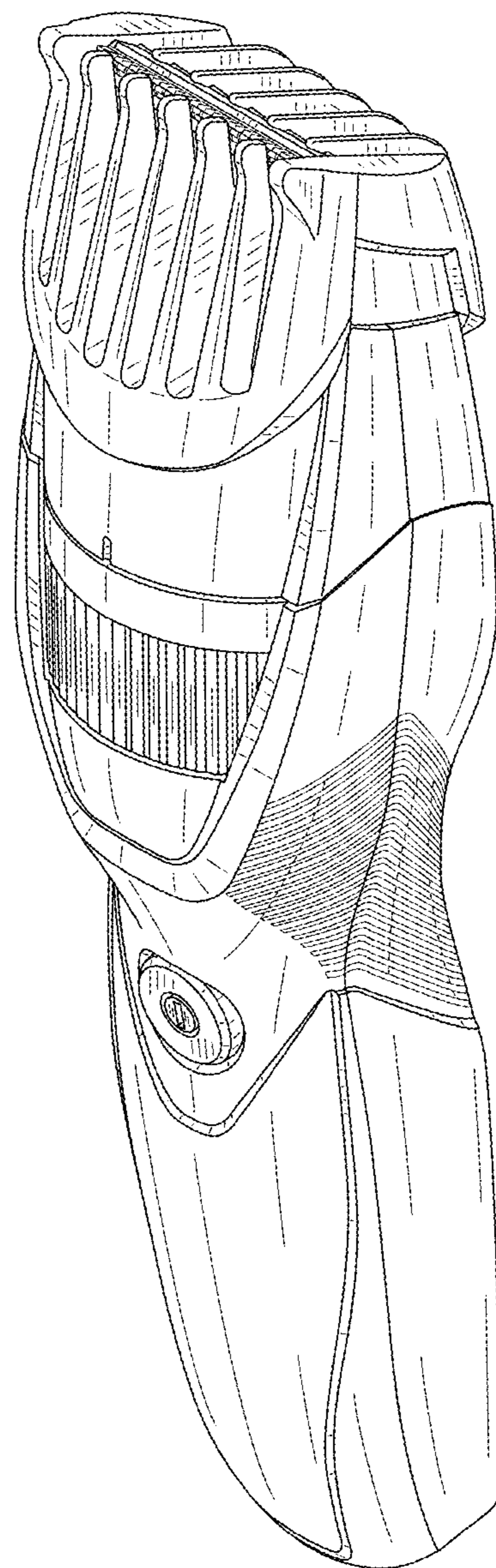

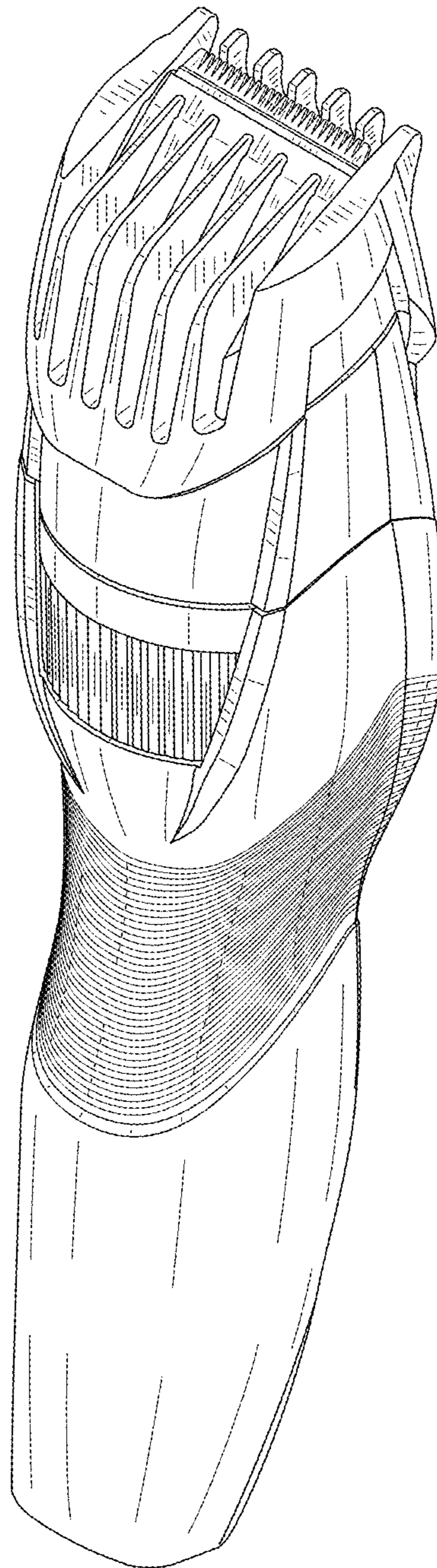

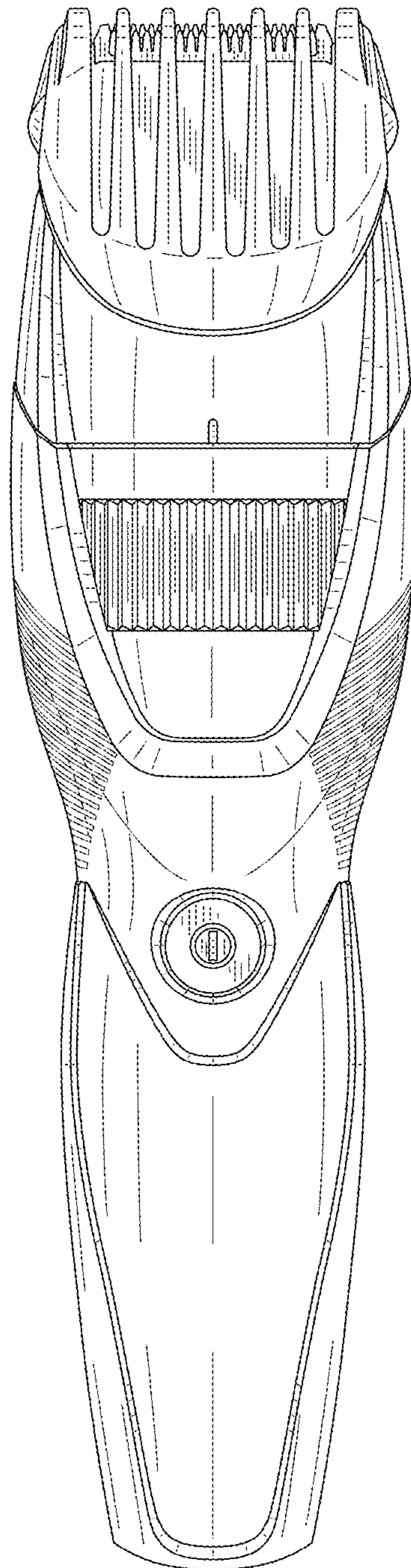

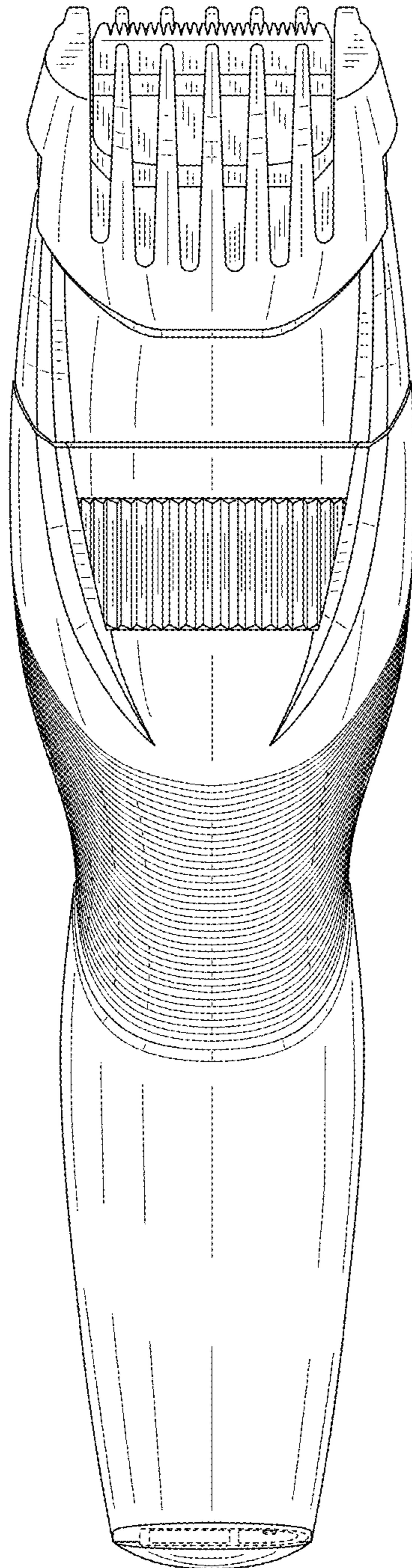

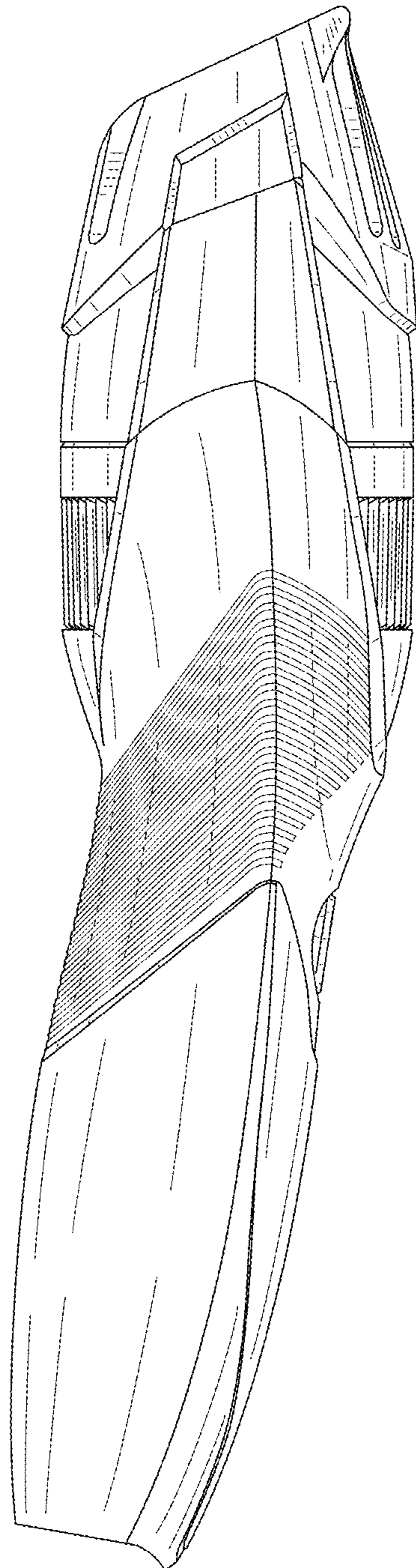

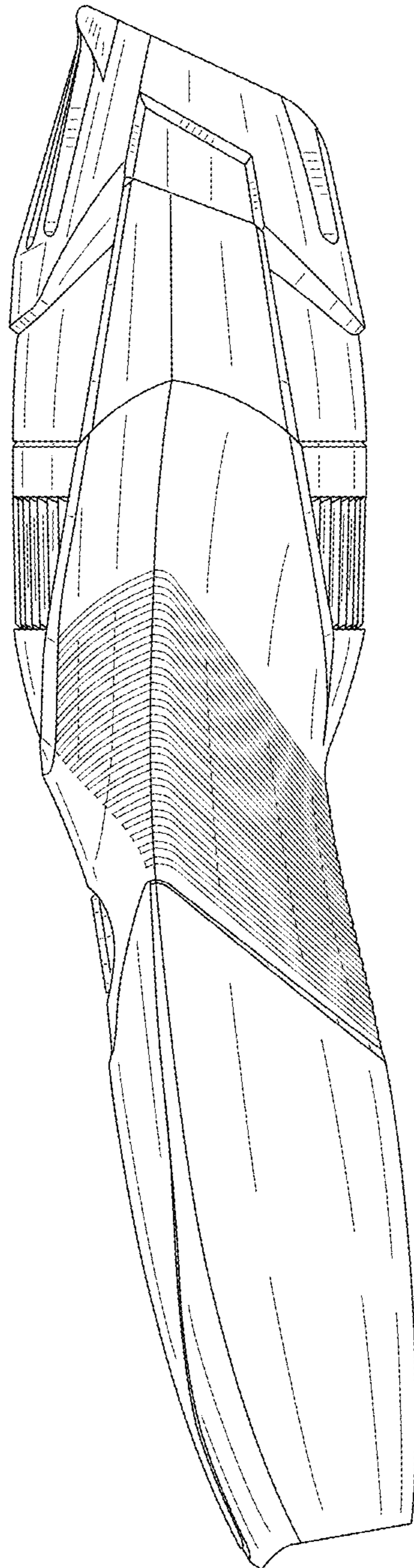

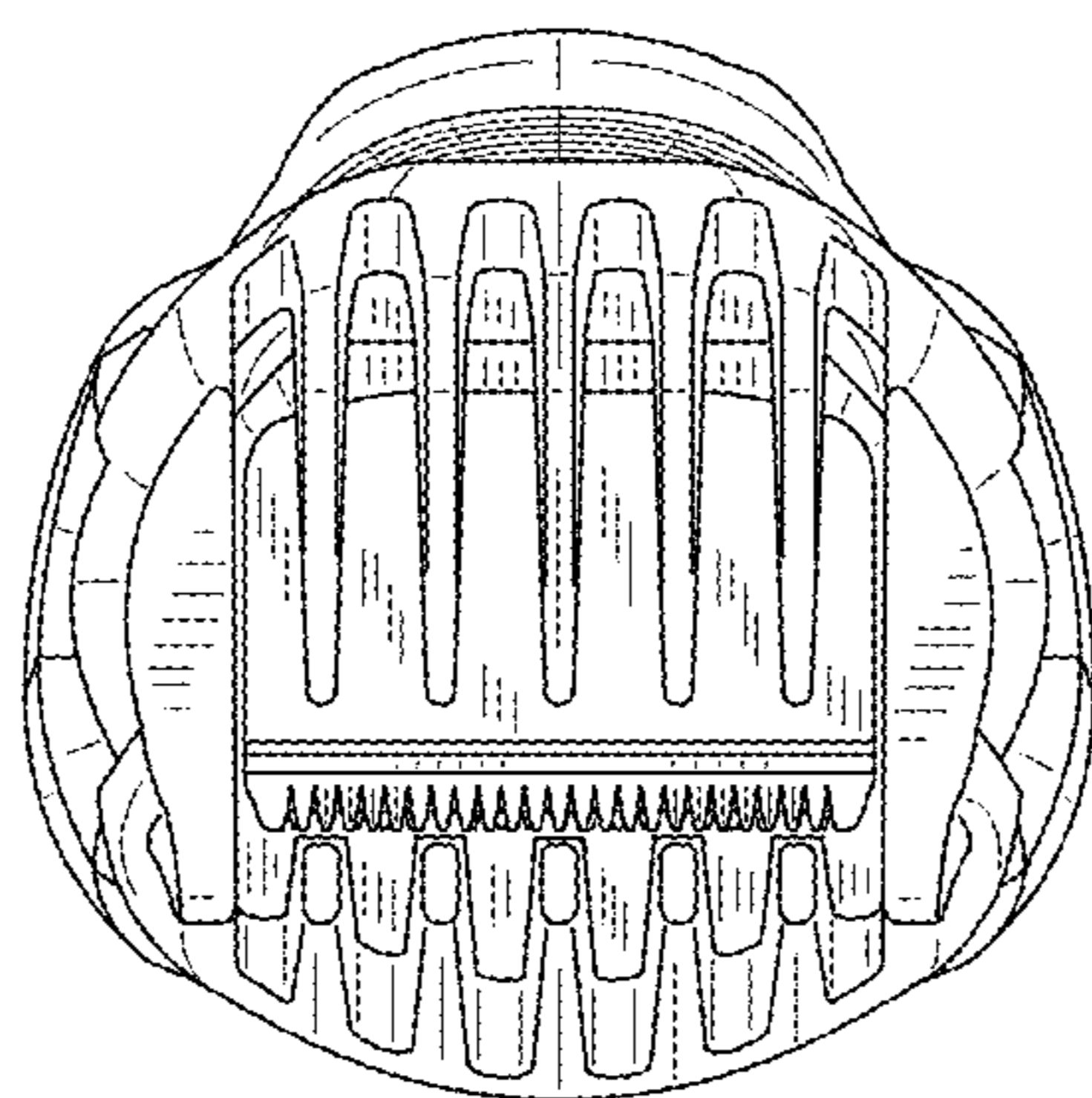
