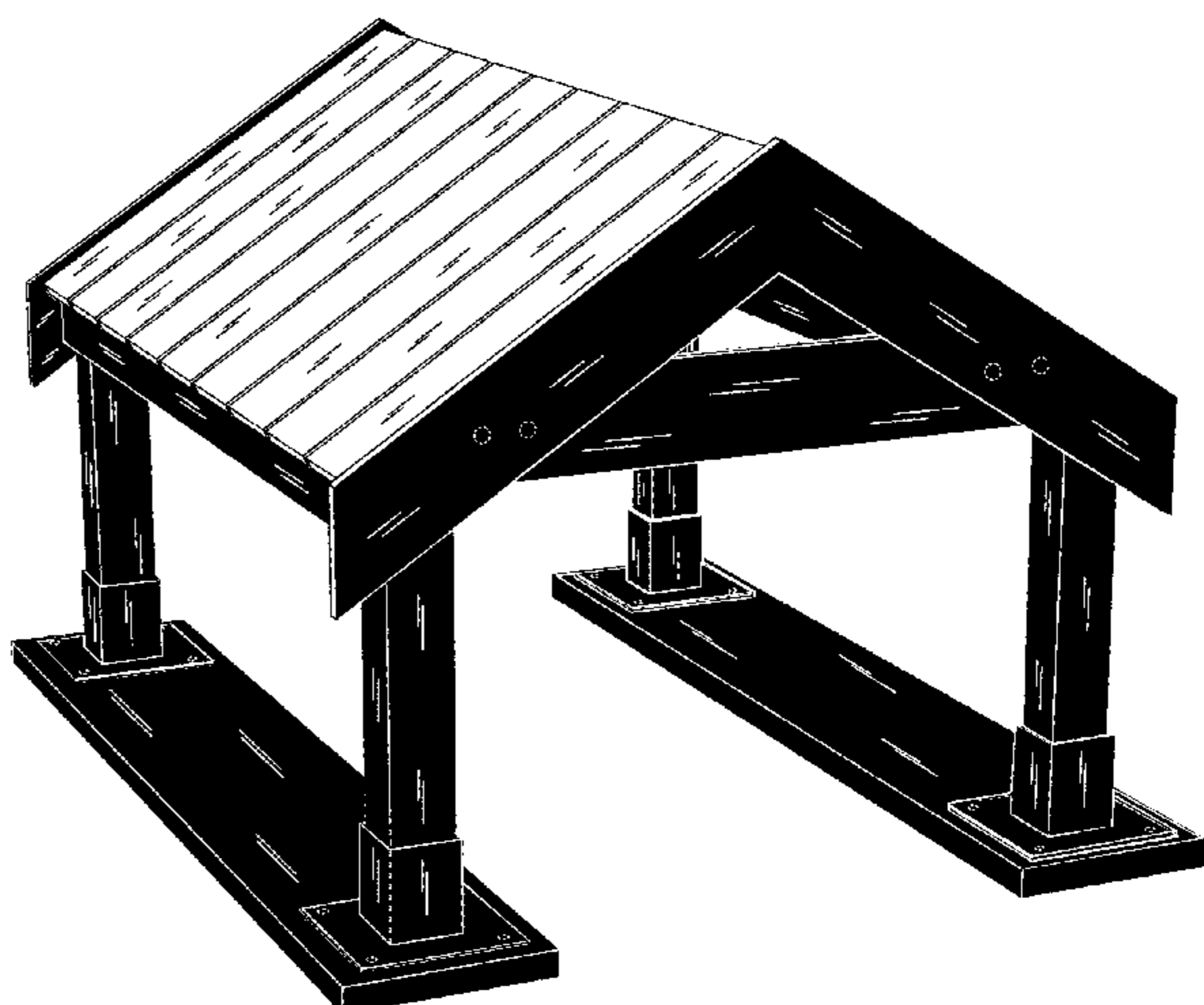
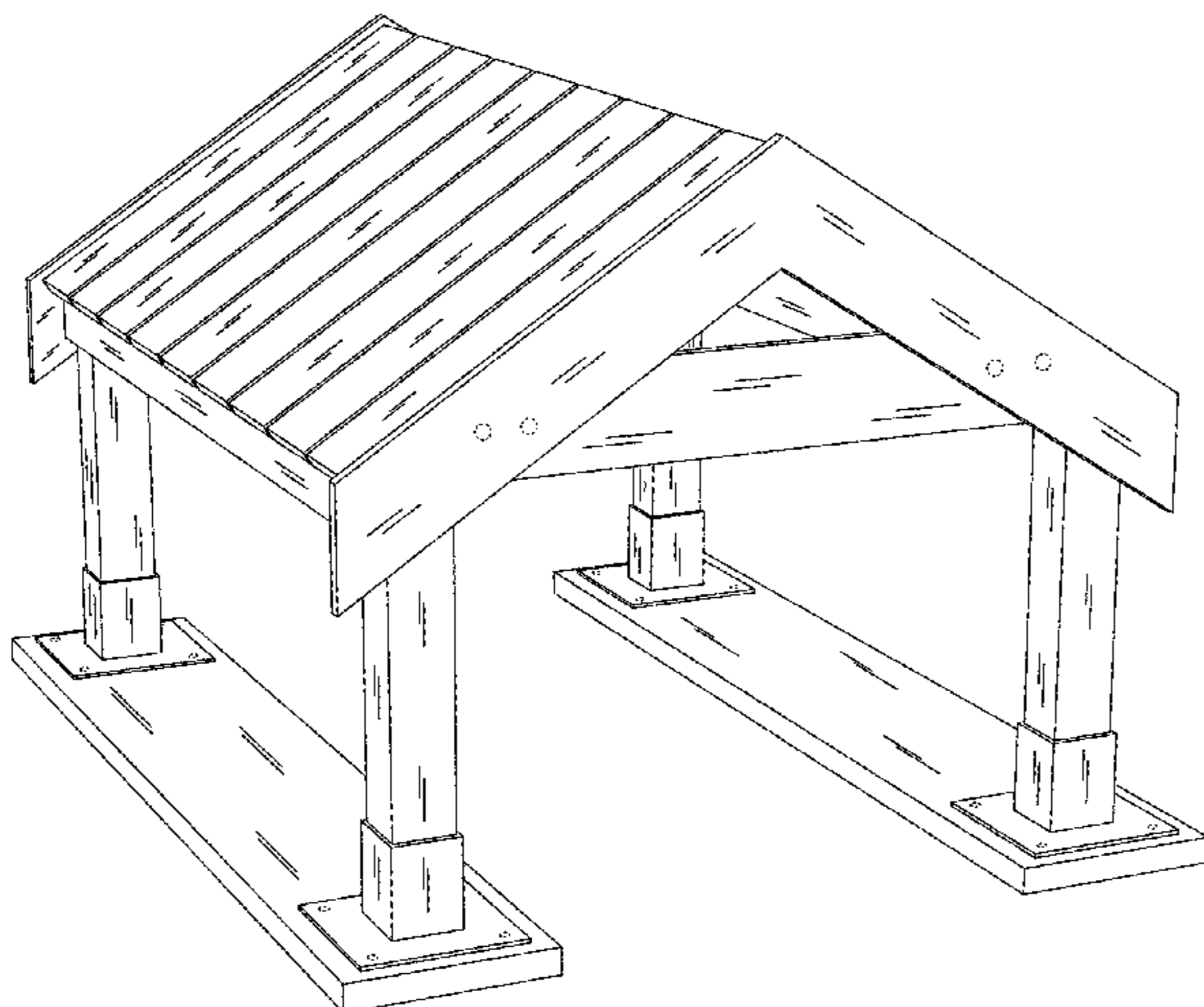
The ornamental design for a pet tunnel house structure, as shown and described.

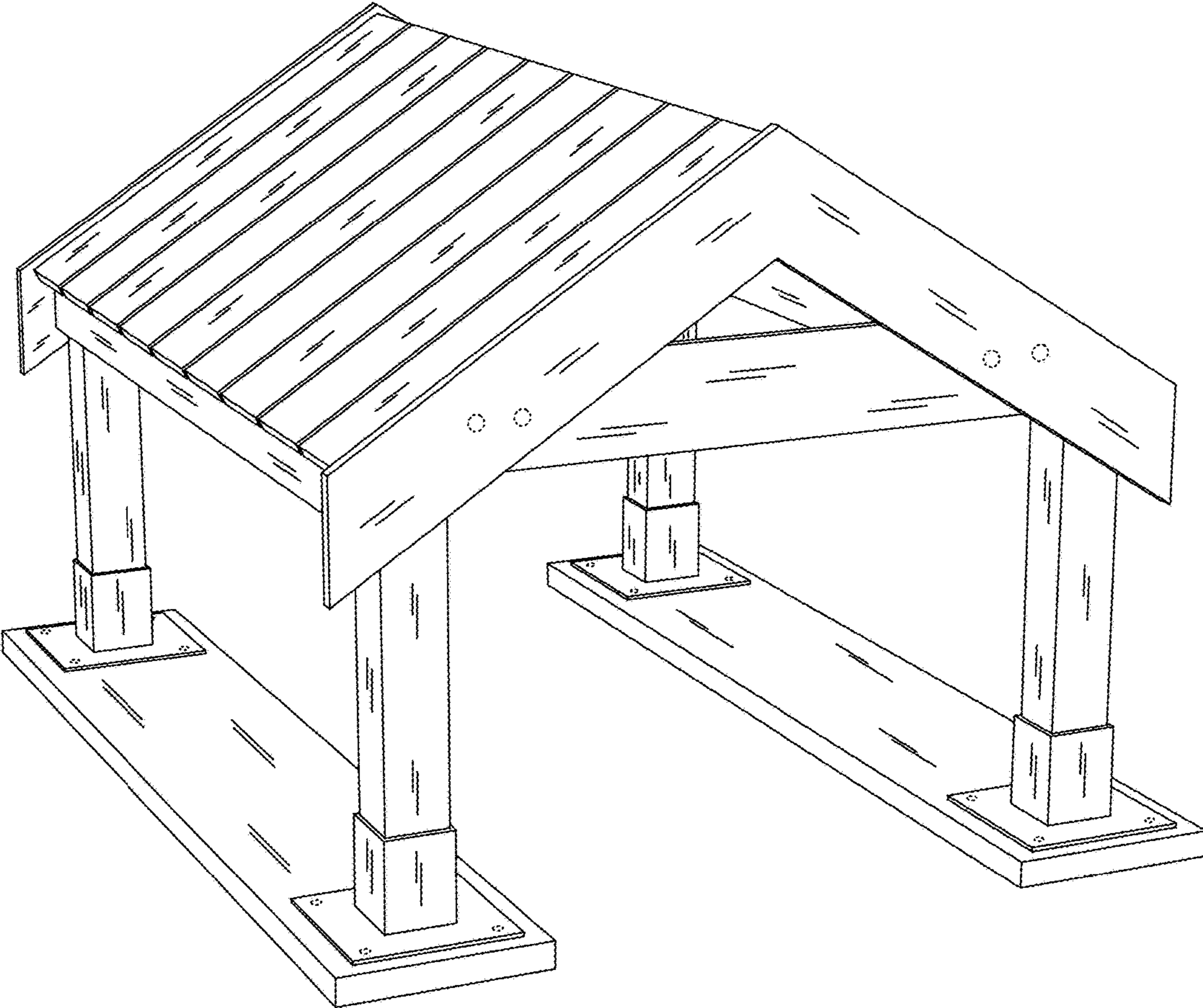

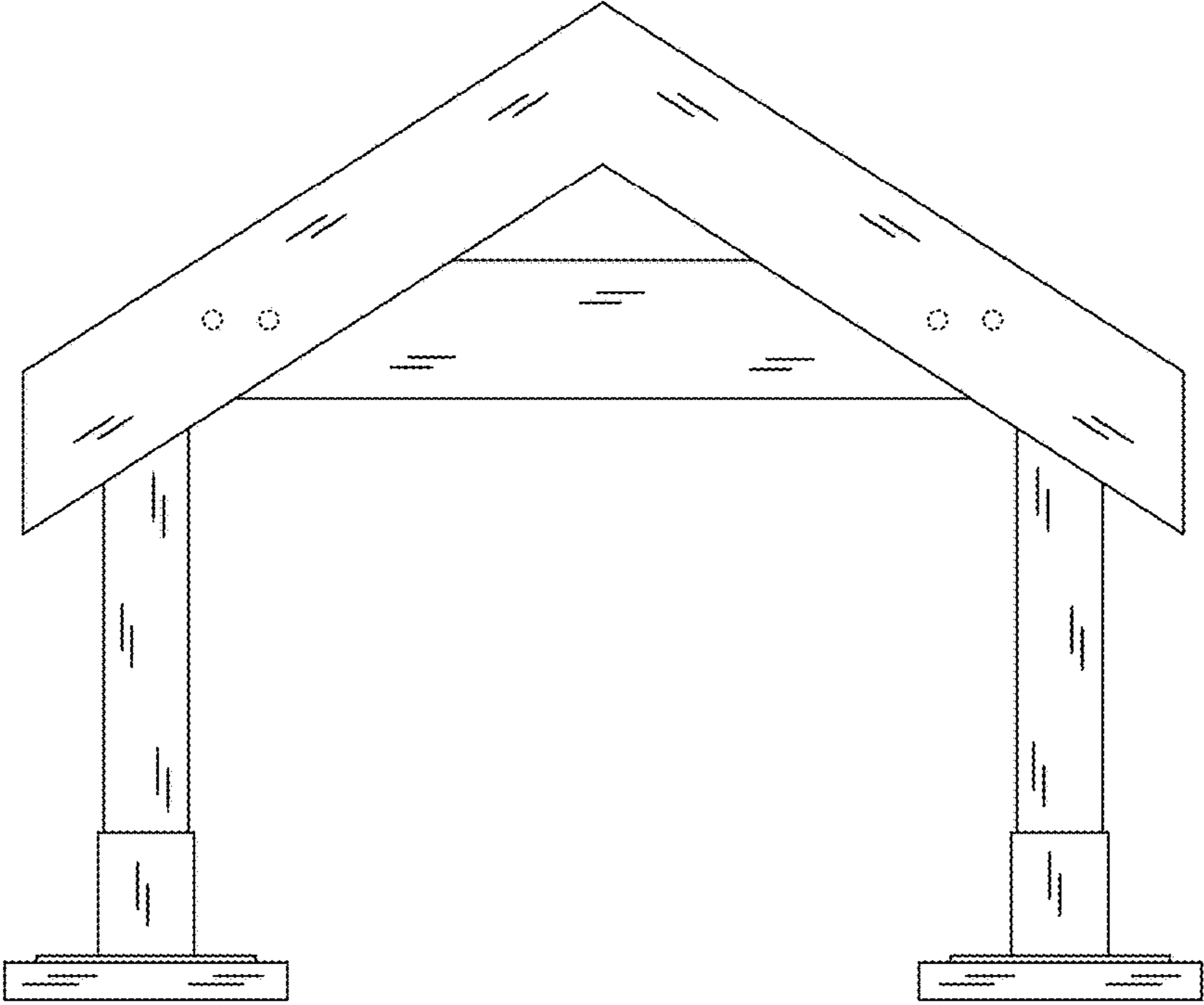

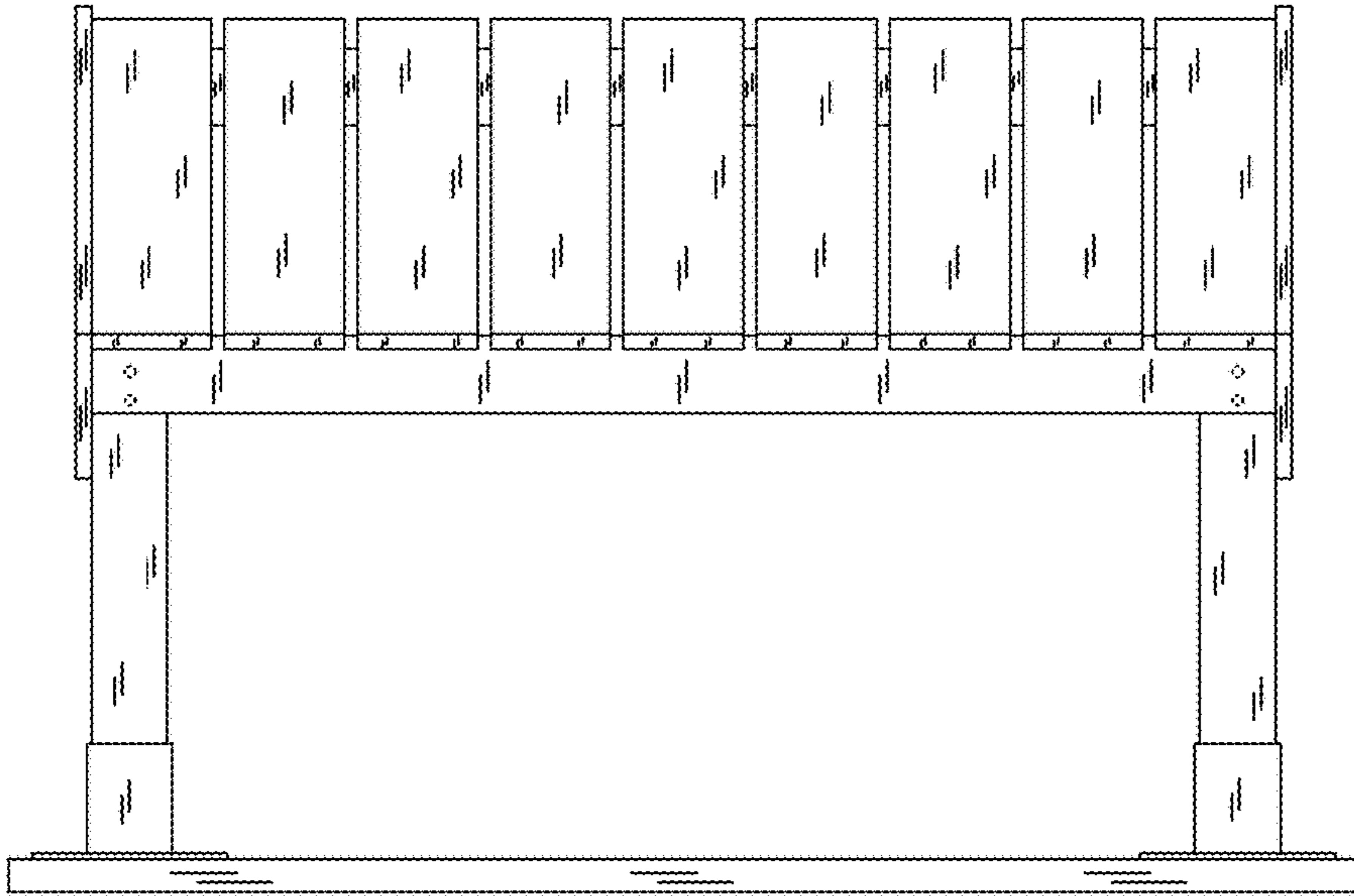

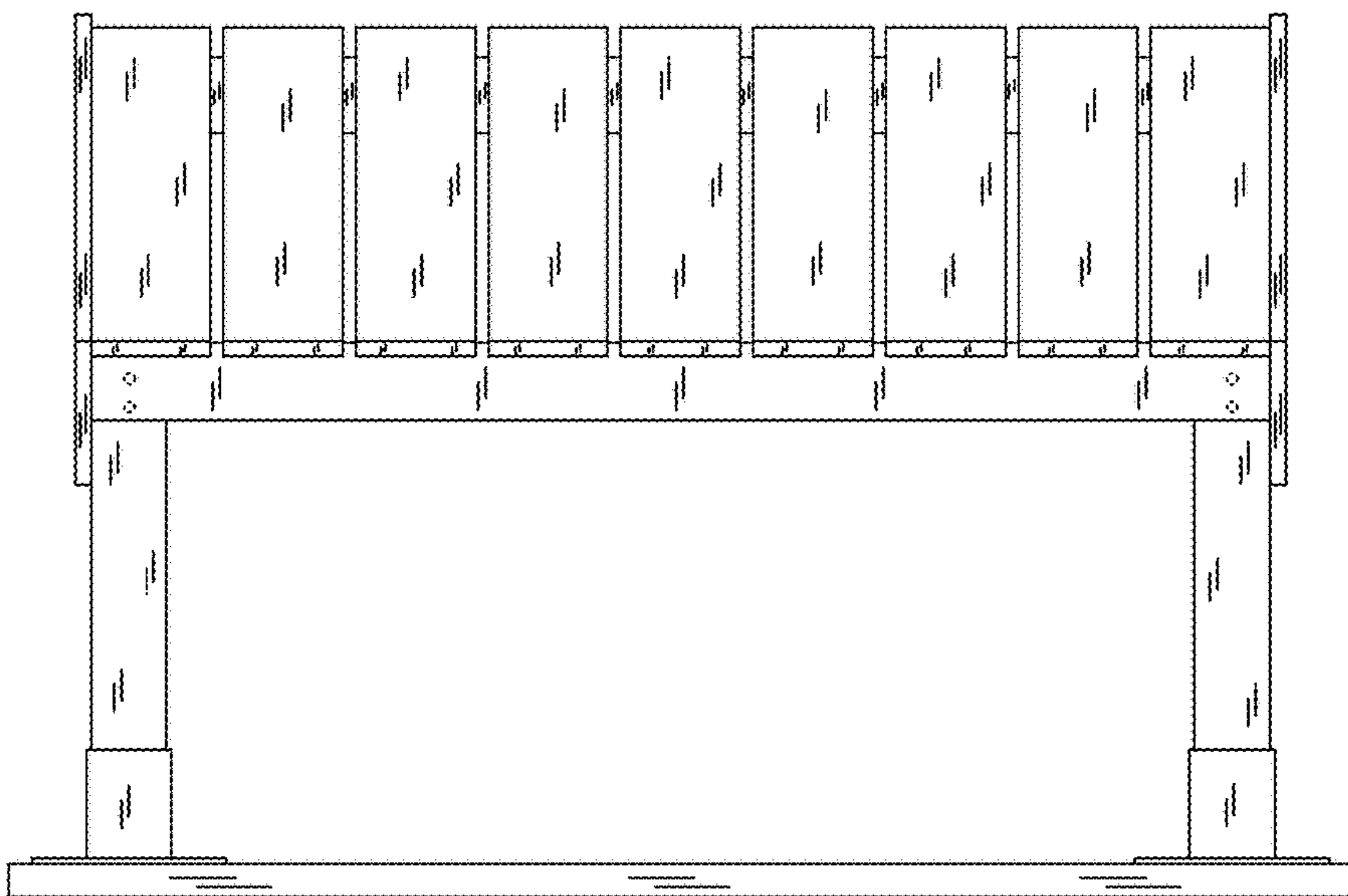

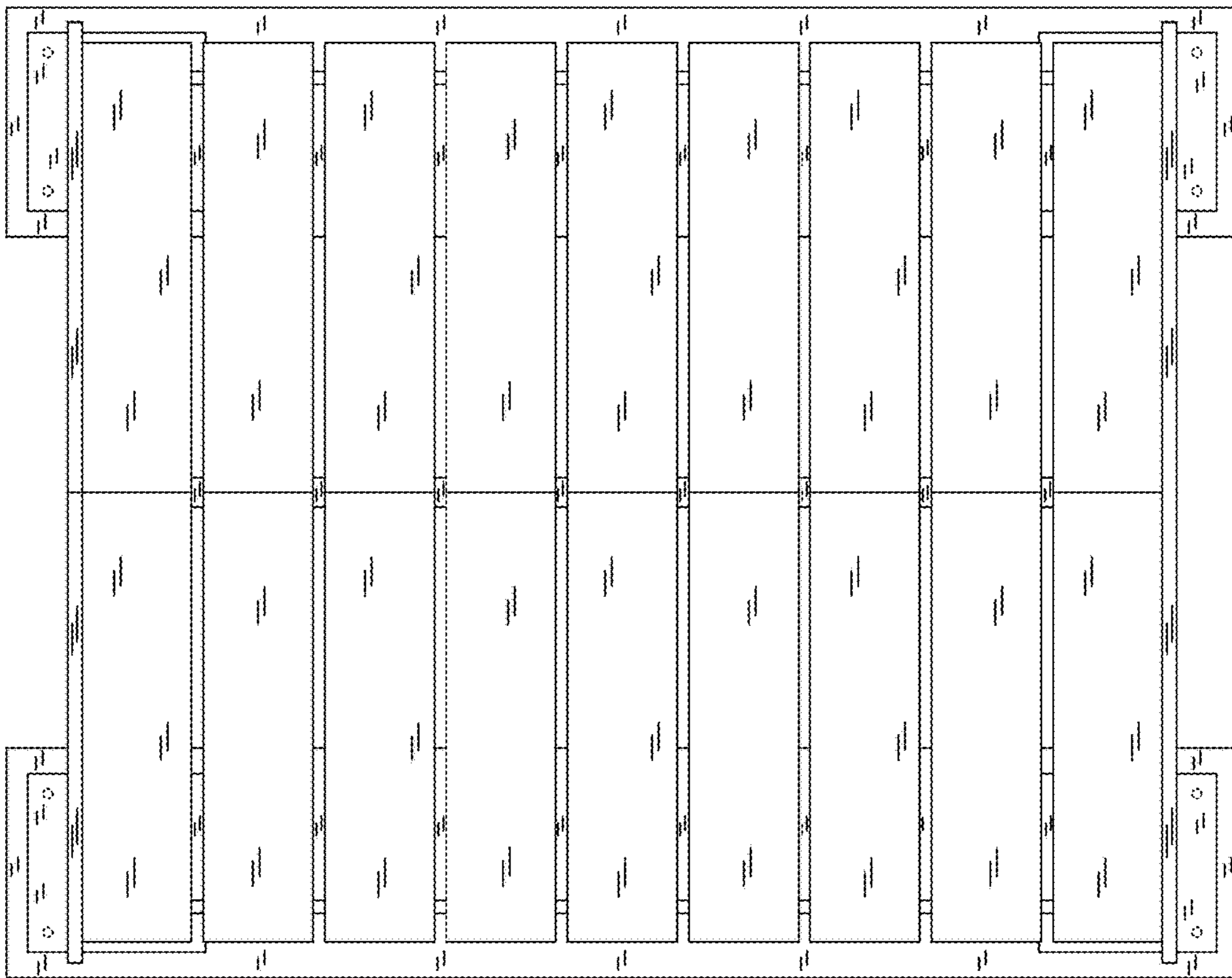

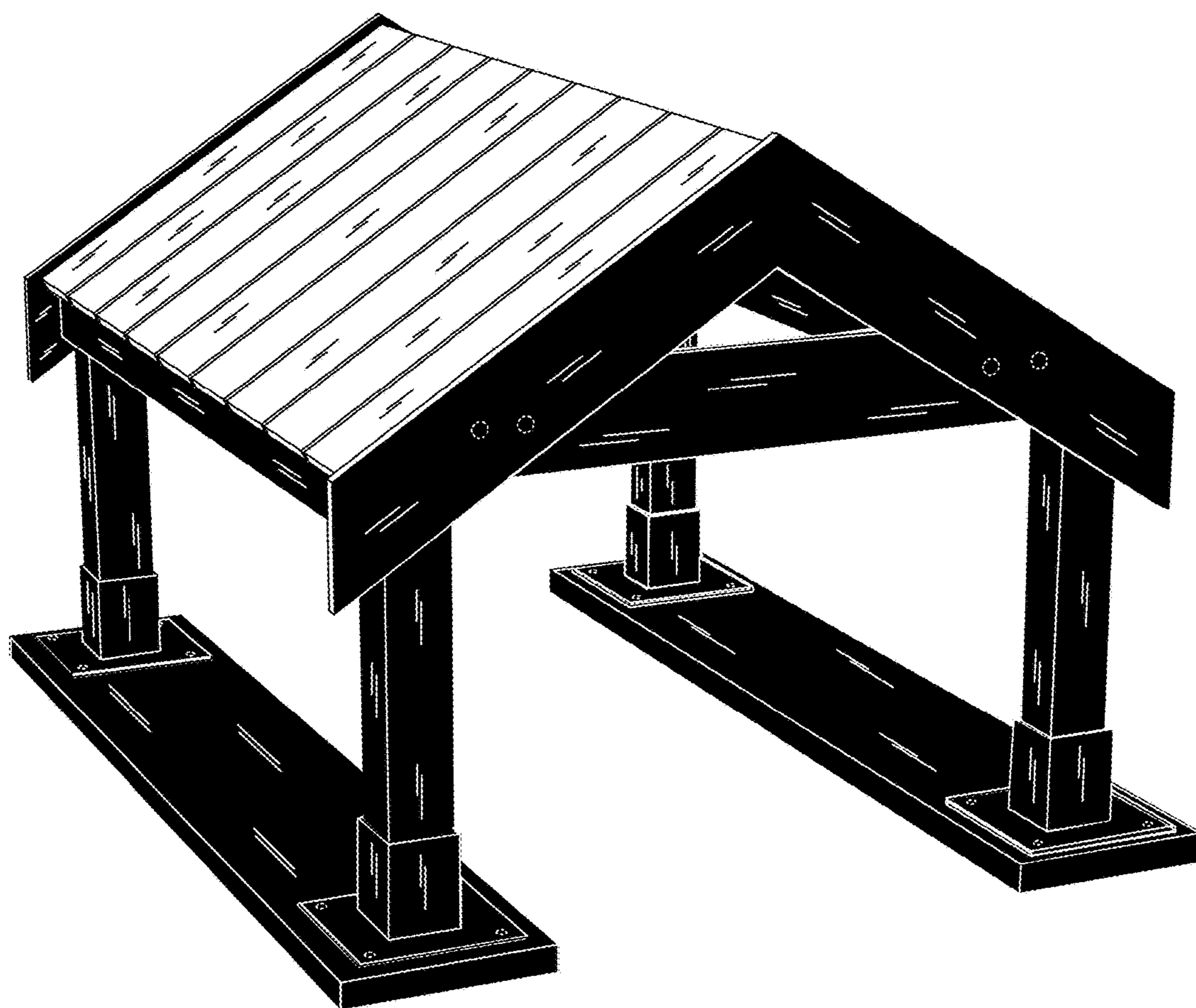

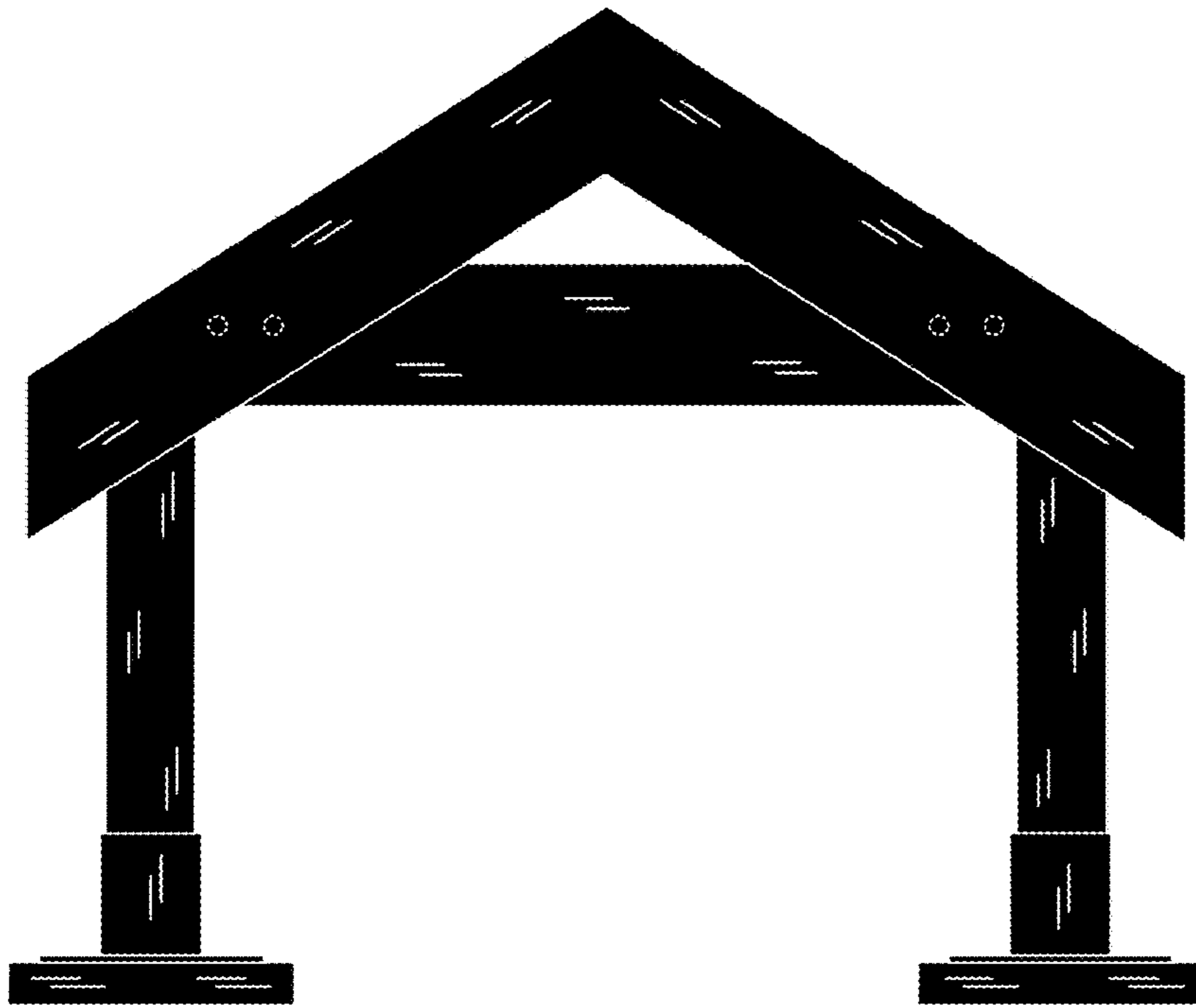

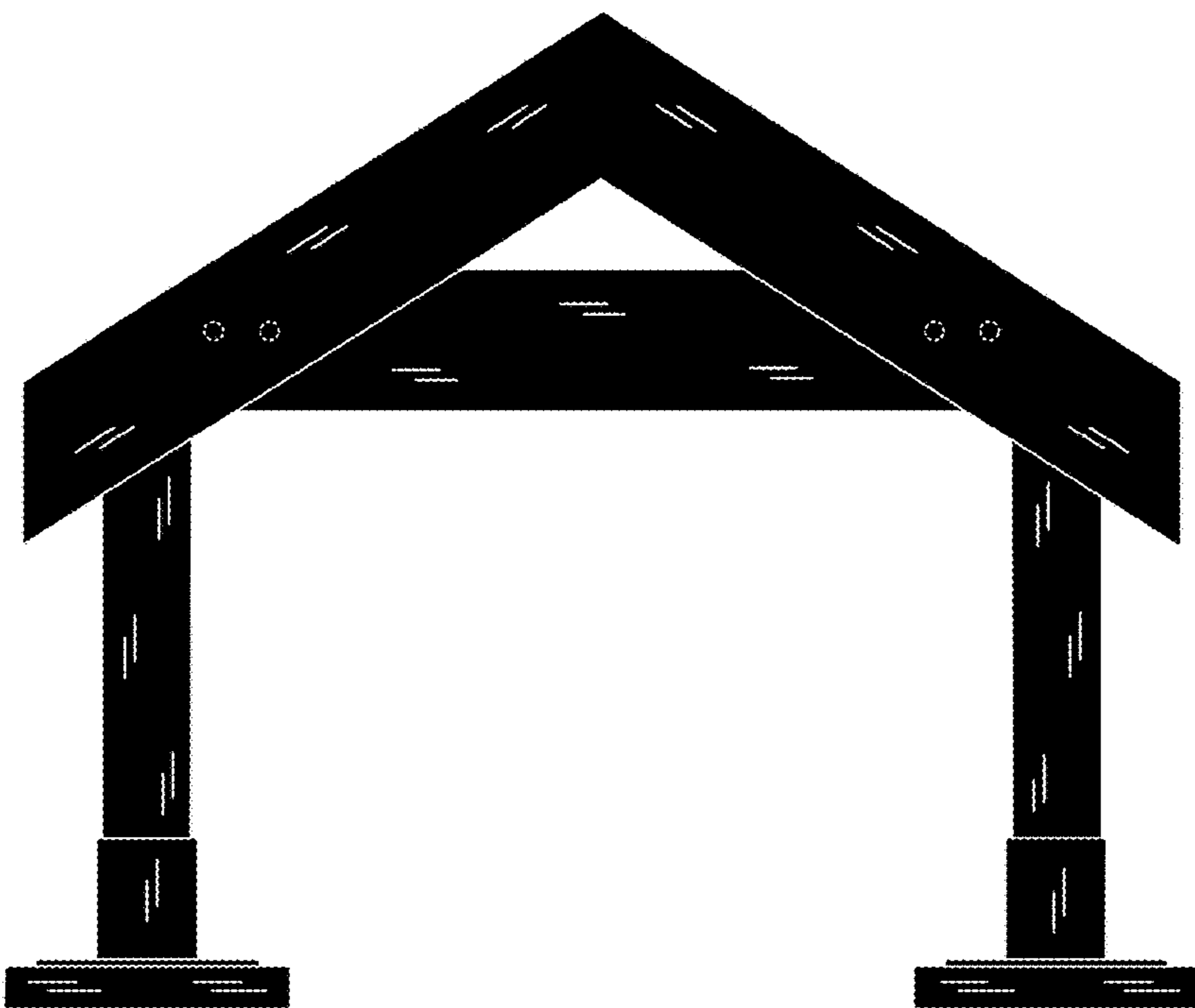

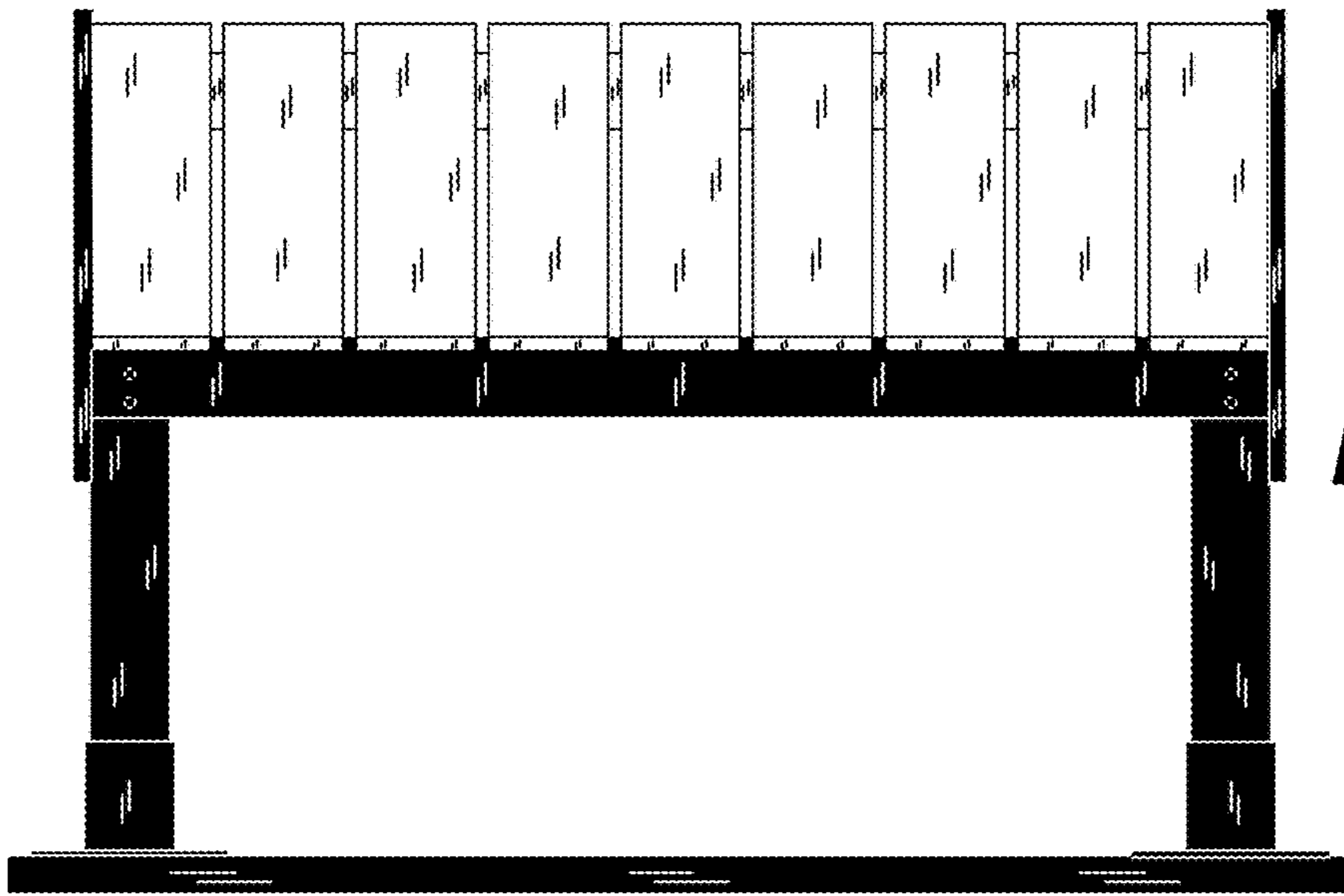

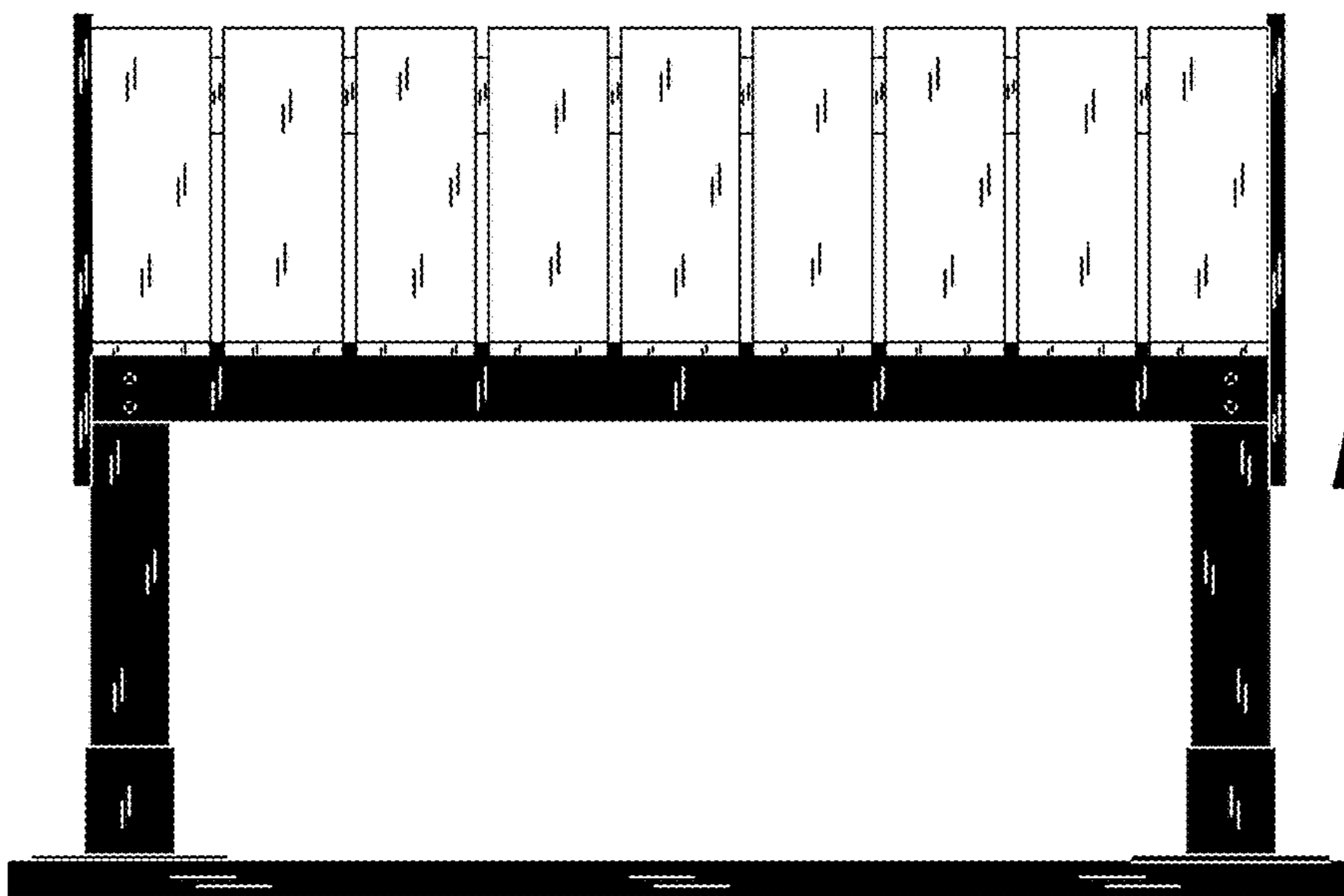

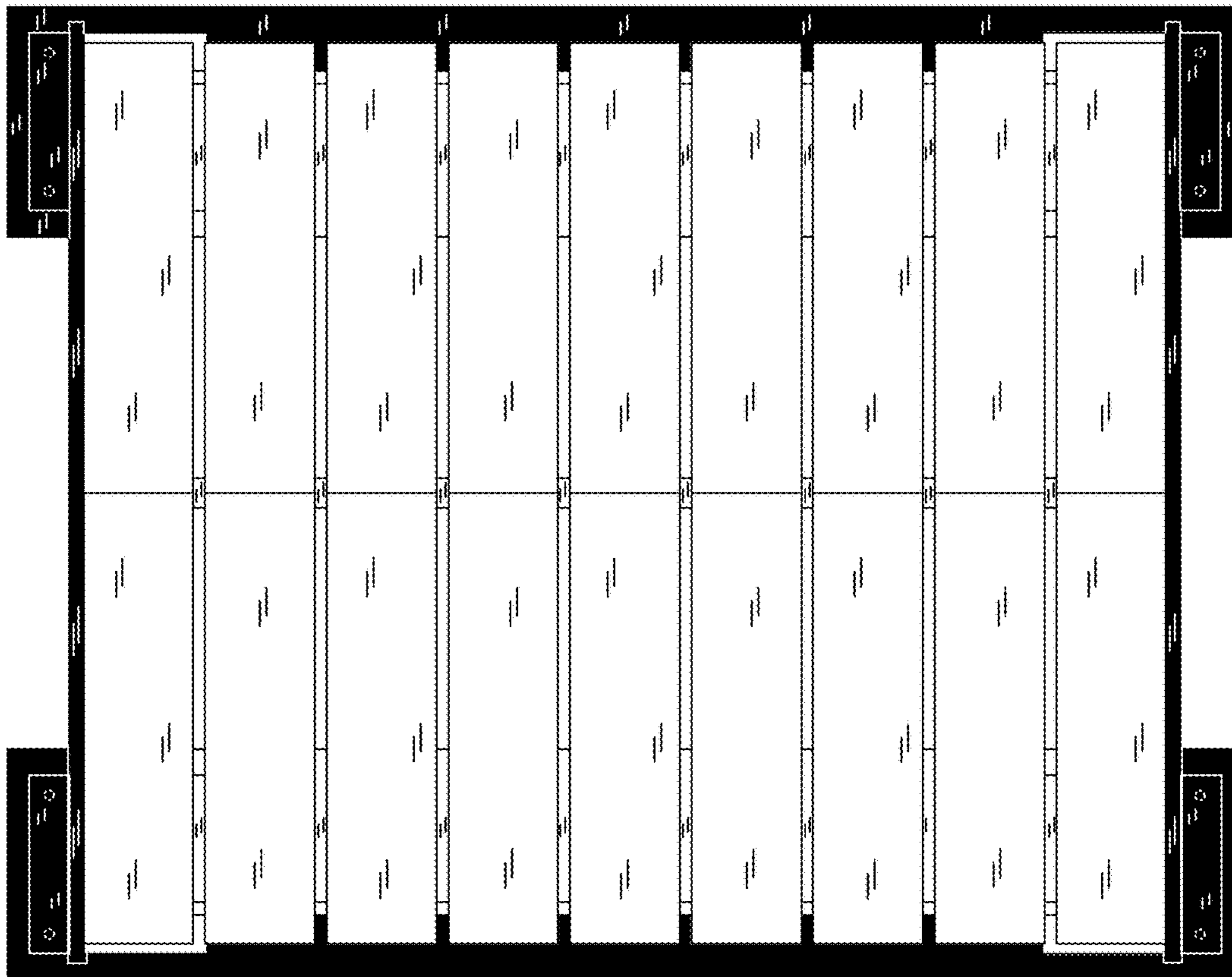
