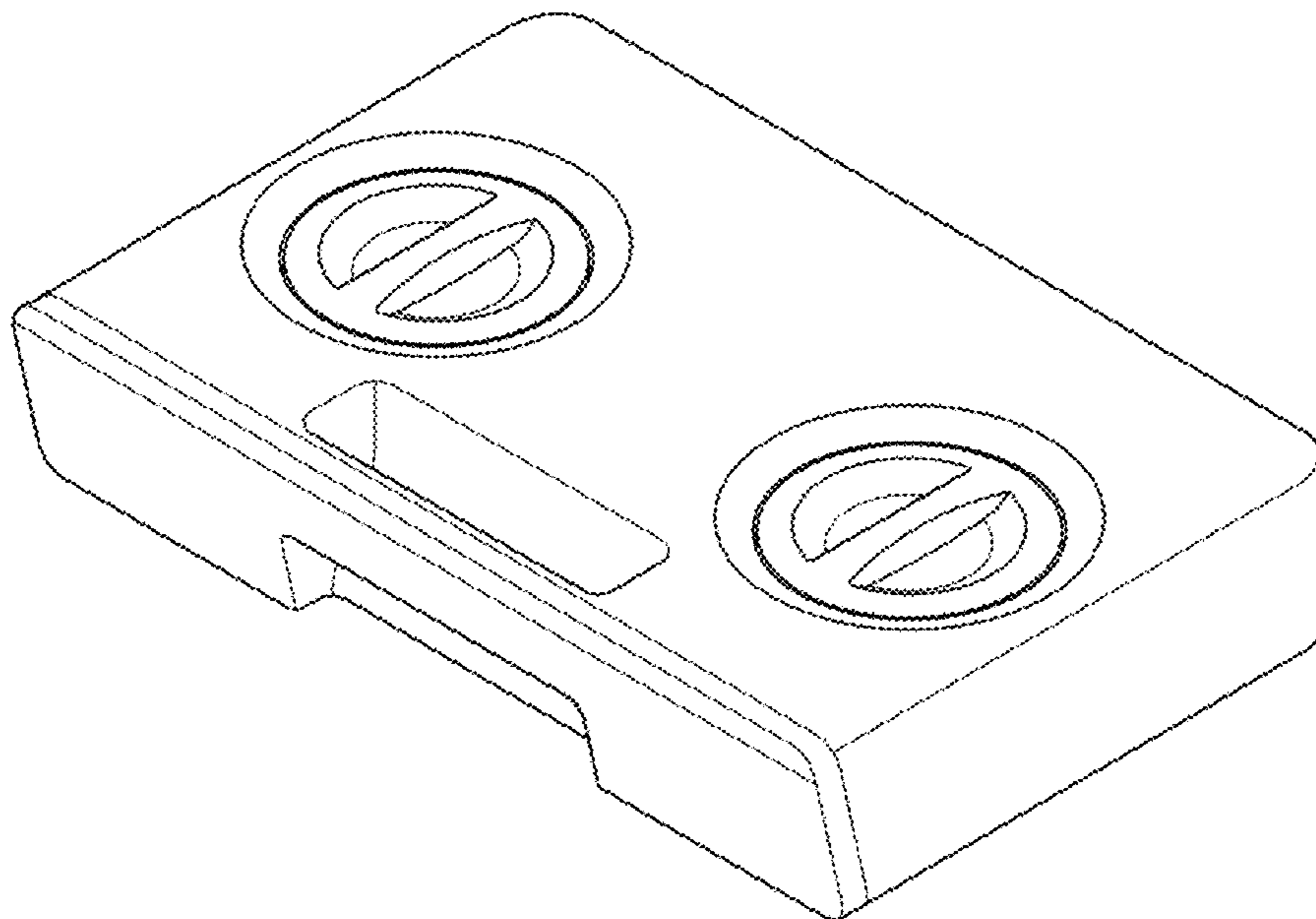

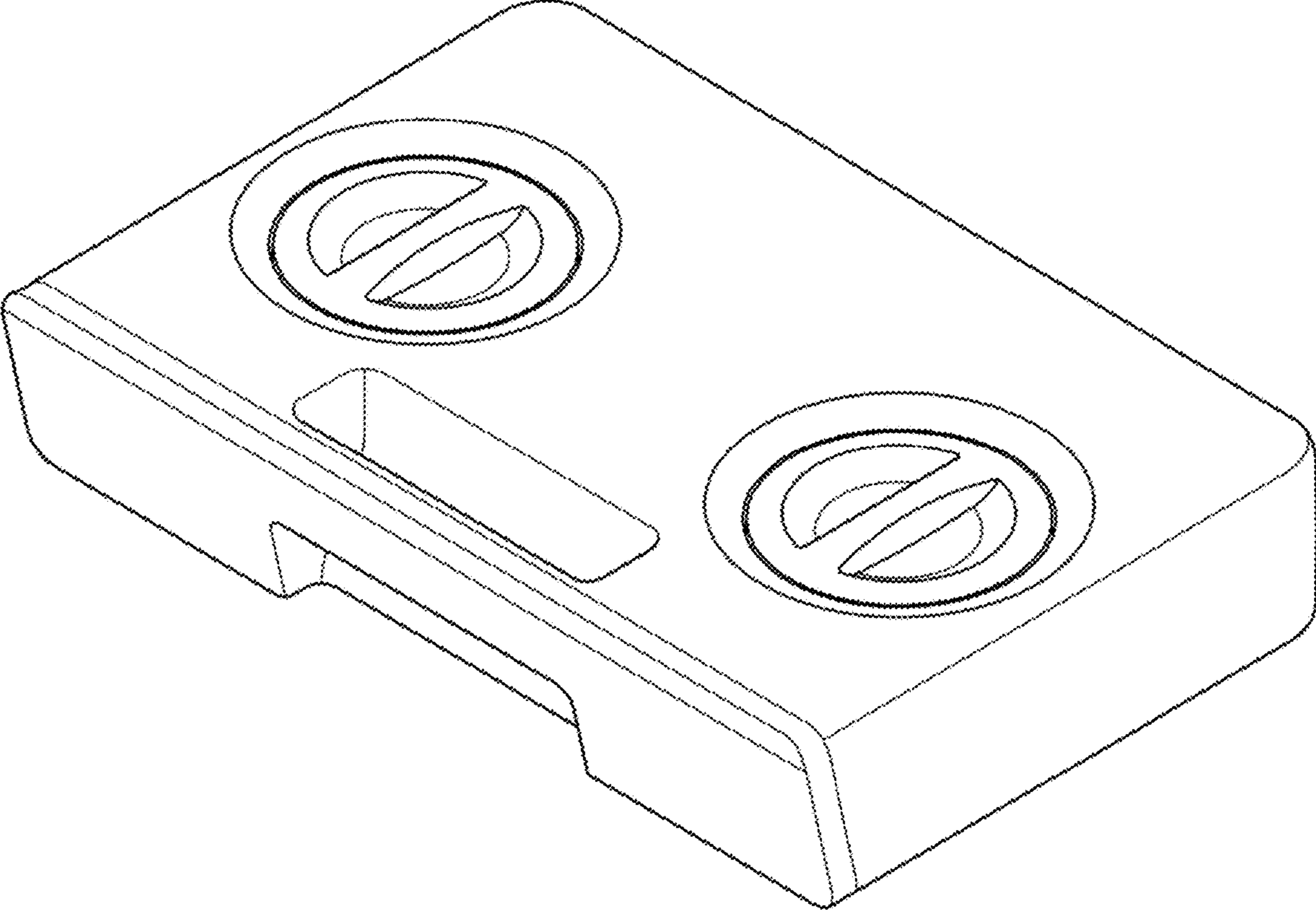
**DESCRIPTION**

FIG. 1.7 is a bottom plan view thereof.

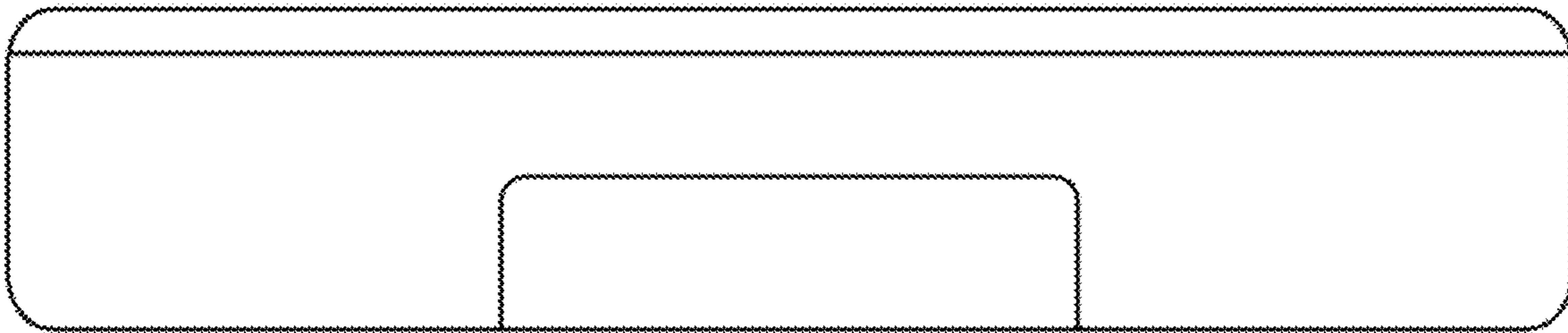

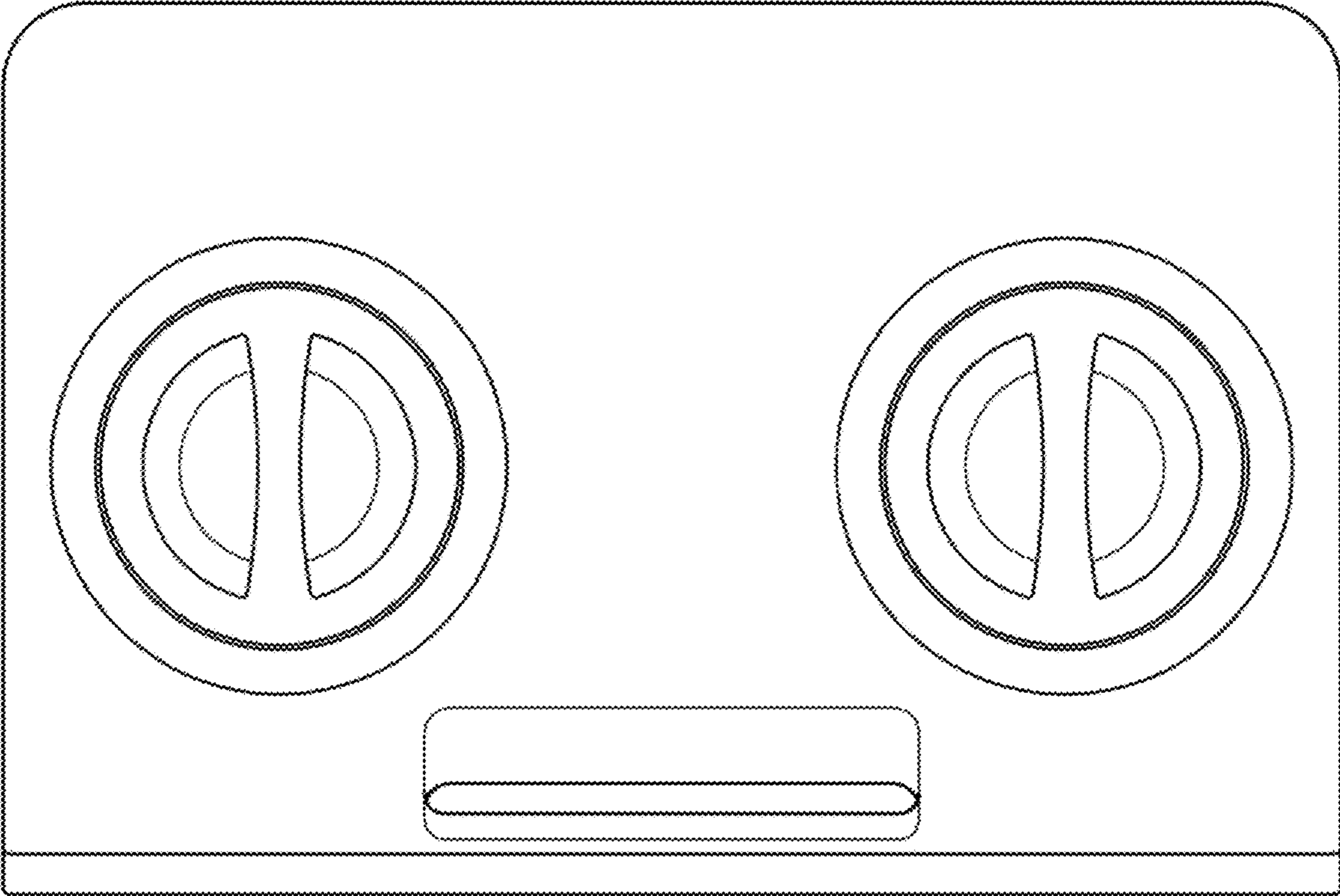
