(57) **CLAIM**

The ornamental design for an article of apparel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an article of apparel in the environment of shorts showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a front perspective view of an alternative embodiment of an article of apparel showing the claimed region of FIGS. 1-3 in the environment of a bra;

FIG. 5 is a front view thereof;

FIG. 6 is a side view thereof;

FIG. 7 is an enlarged view of the claimed region of FIG. 1 shown in isolation from the remainder of the environment thereof;

FIG. 8 is an enlarged view of the claimed region of FIG. 2 shown in isolation from the remainder of the environment thereof;

FIG. 9 is an enlarged view of the claimed region of FIG. 3 shown in isolation from the remainder of the environment thereof;

FIG. 10 is an enlarged perspective view of one of the claimed ornamental elements shown in FIG. 7 in isolation to show the features in detail thereof;

FIG. 11 is an enlarged top view thereof;

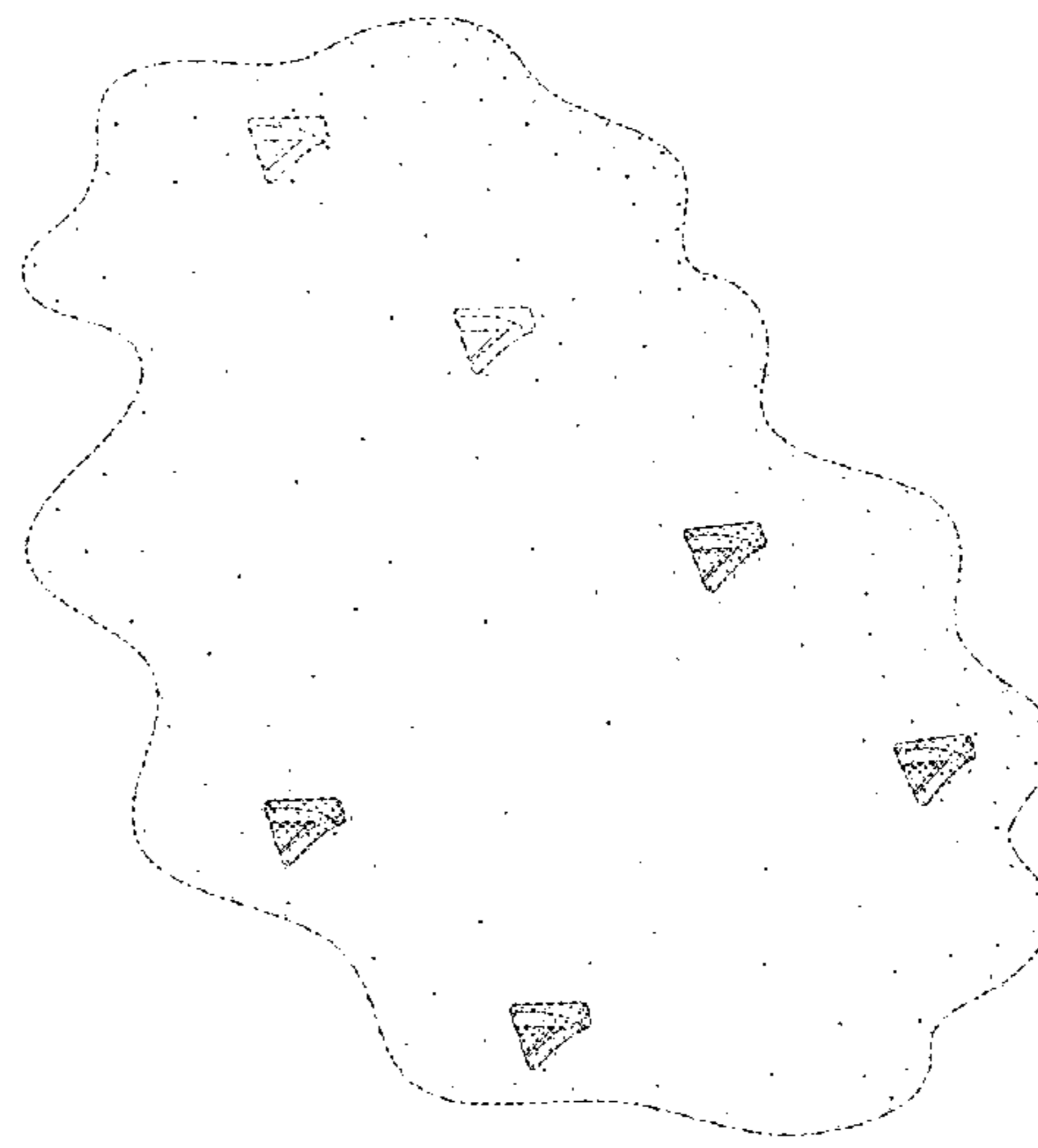
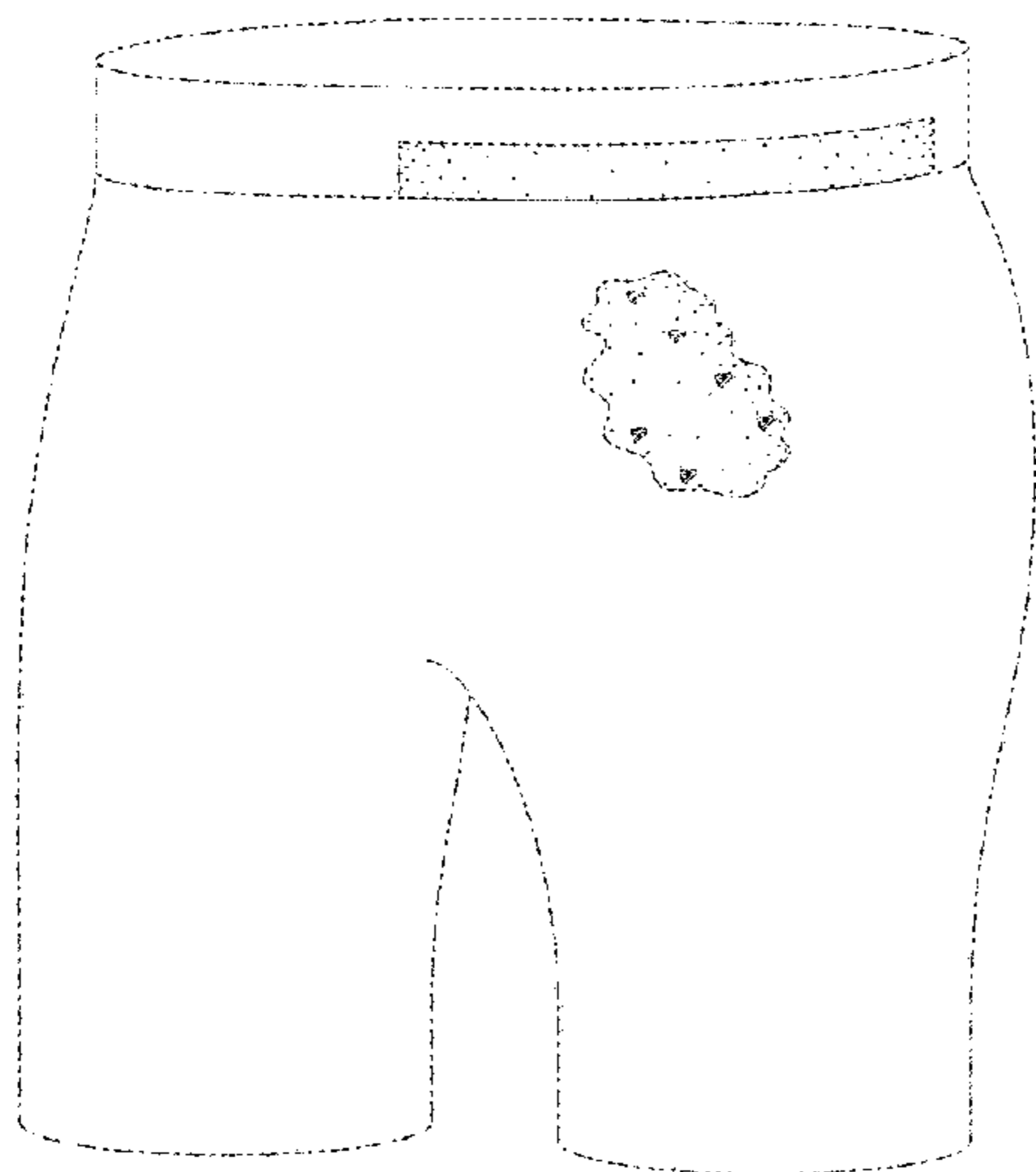
FIG. 12 is an enlarged side view thereof;

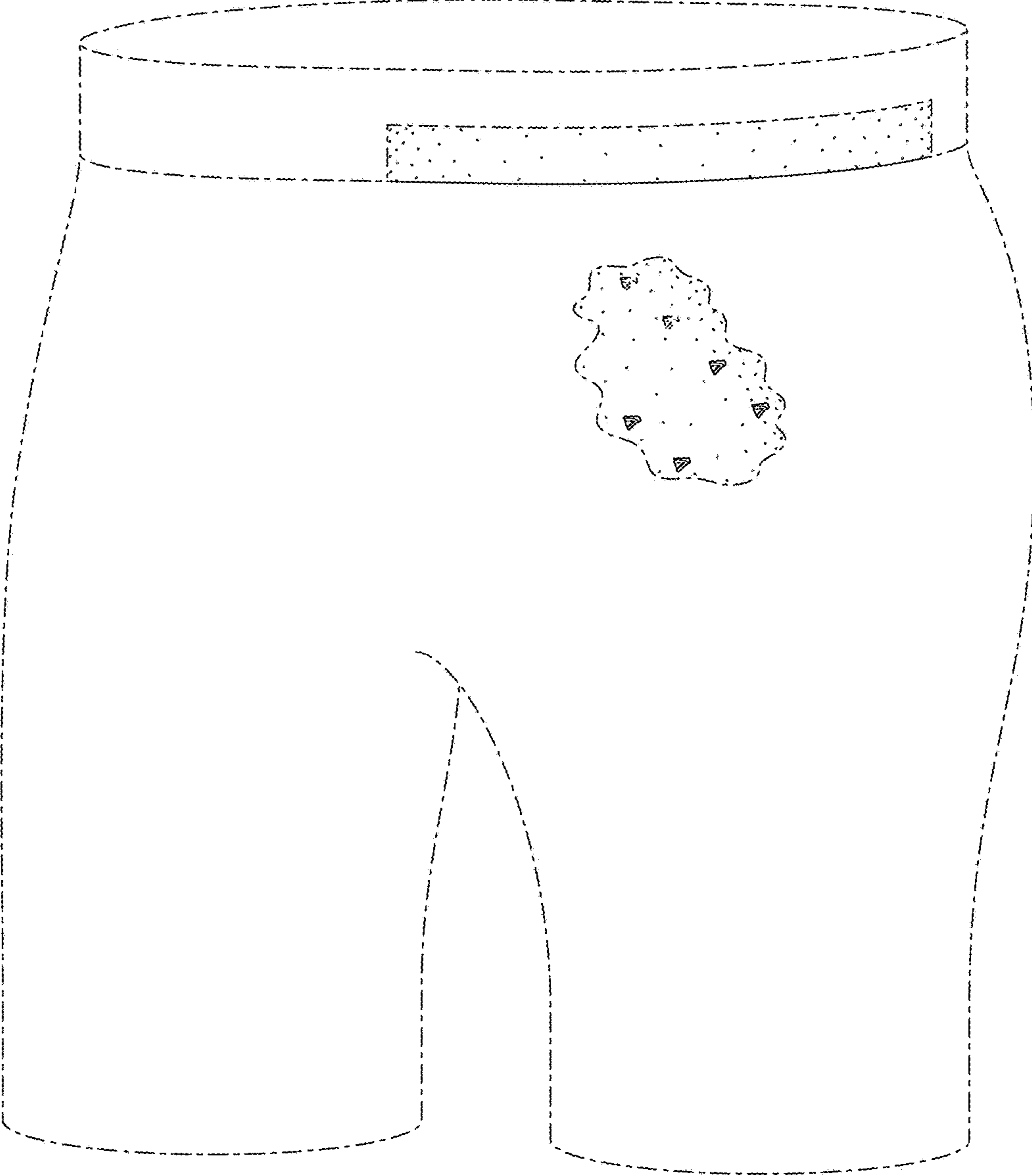

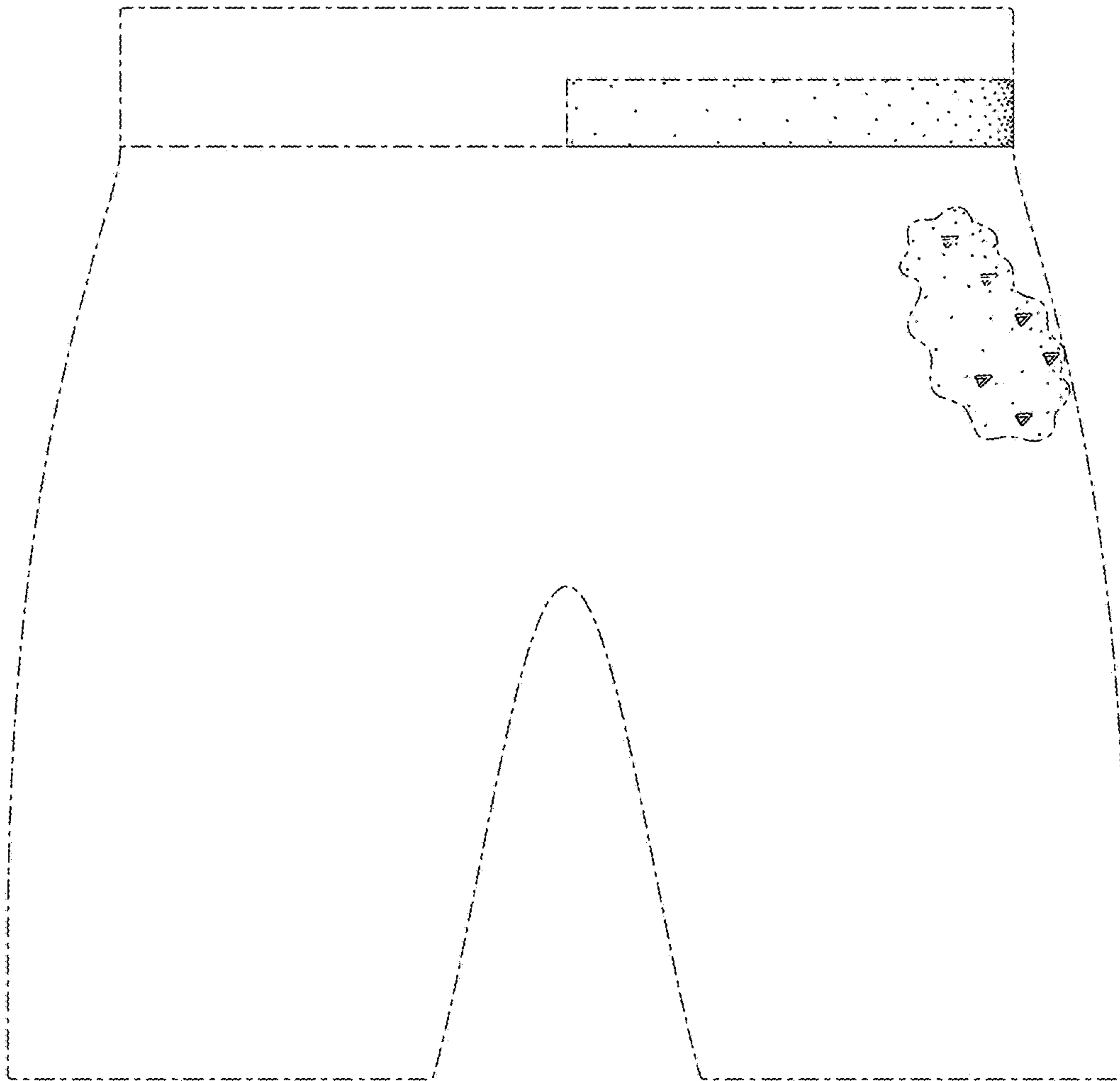

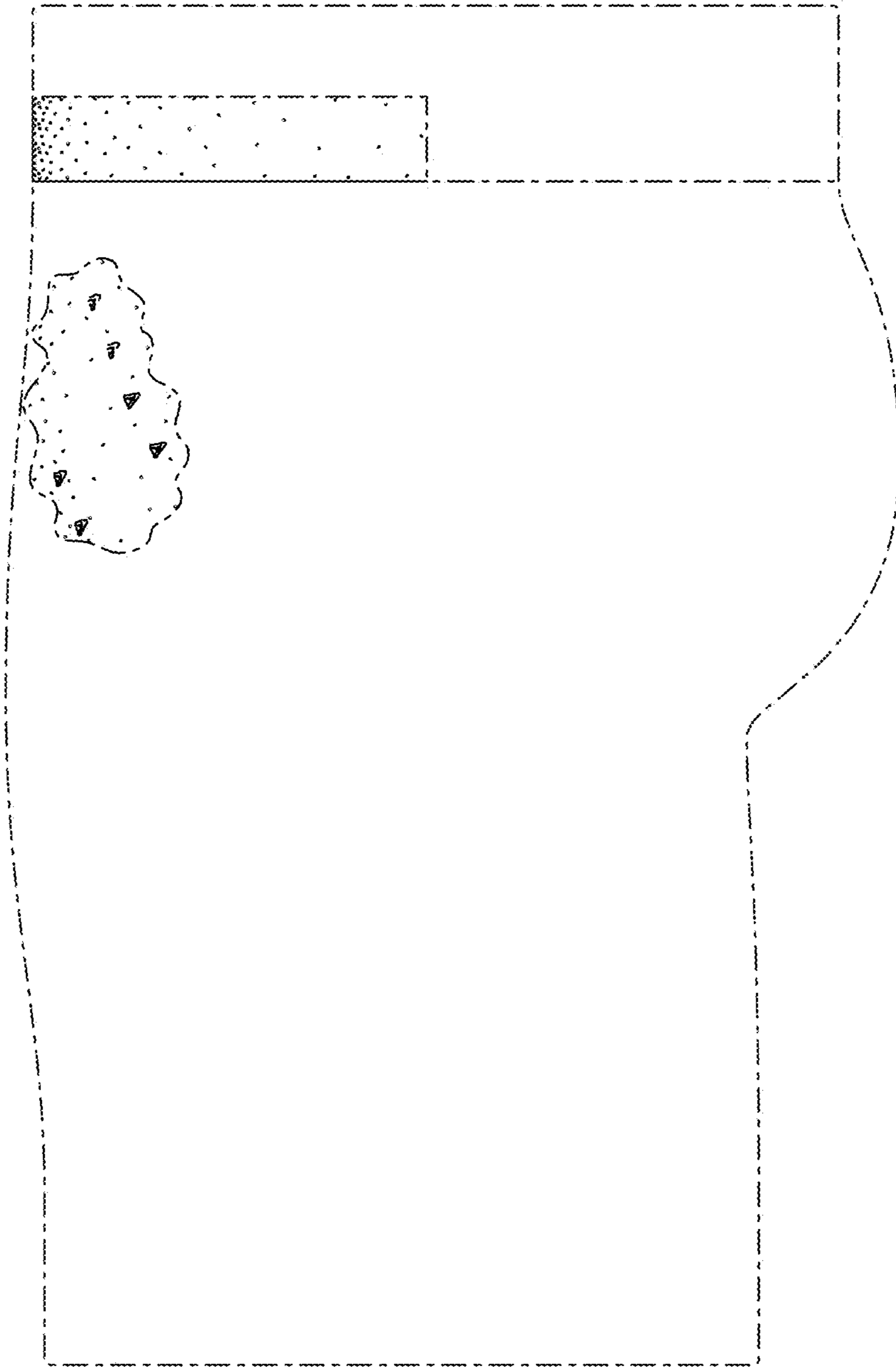

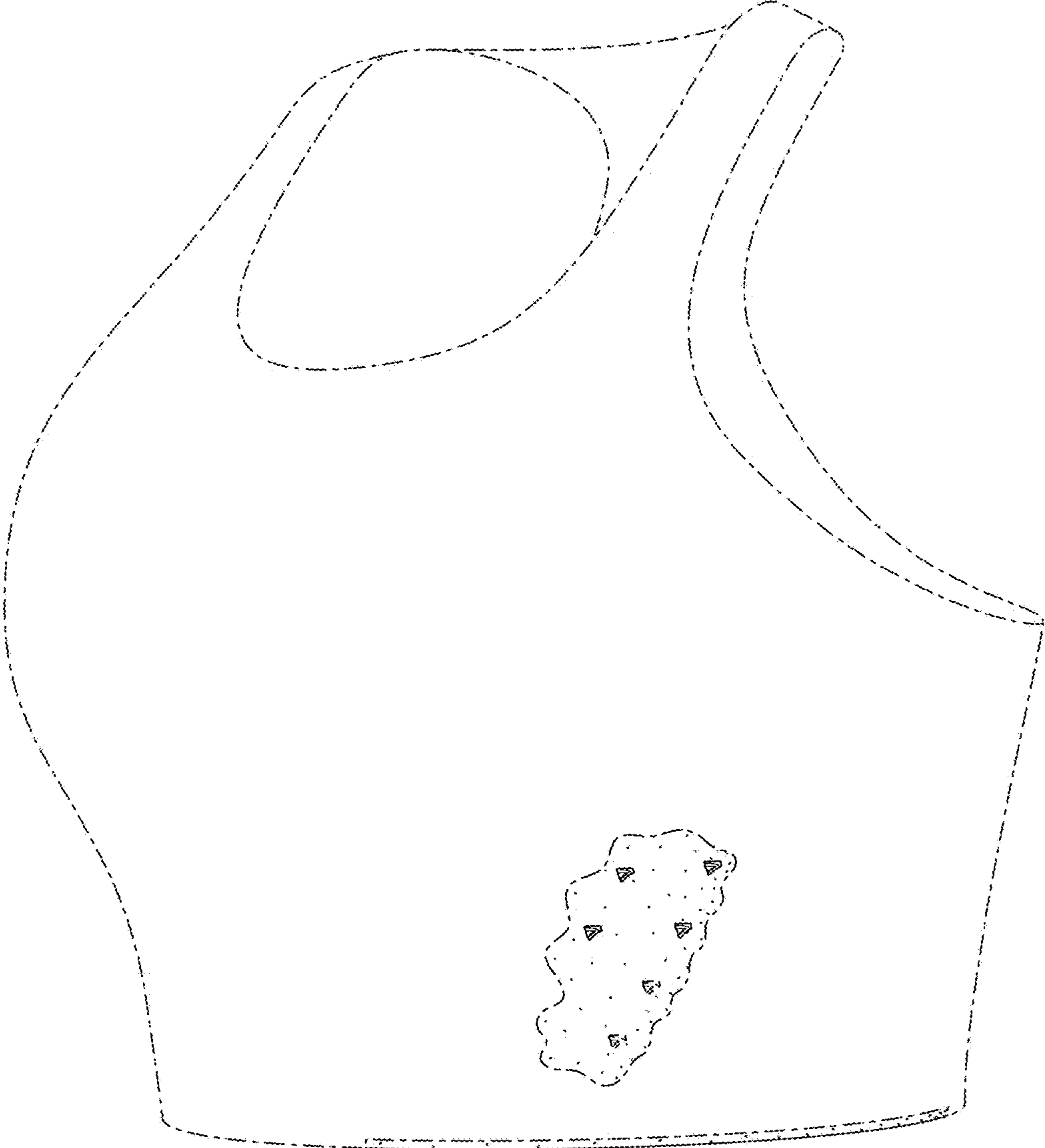

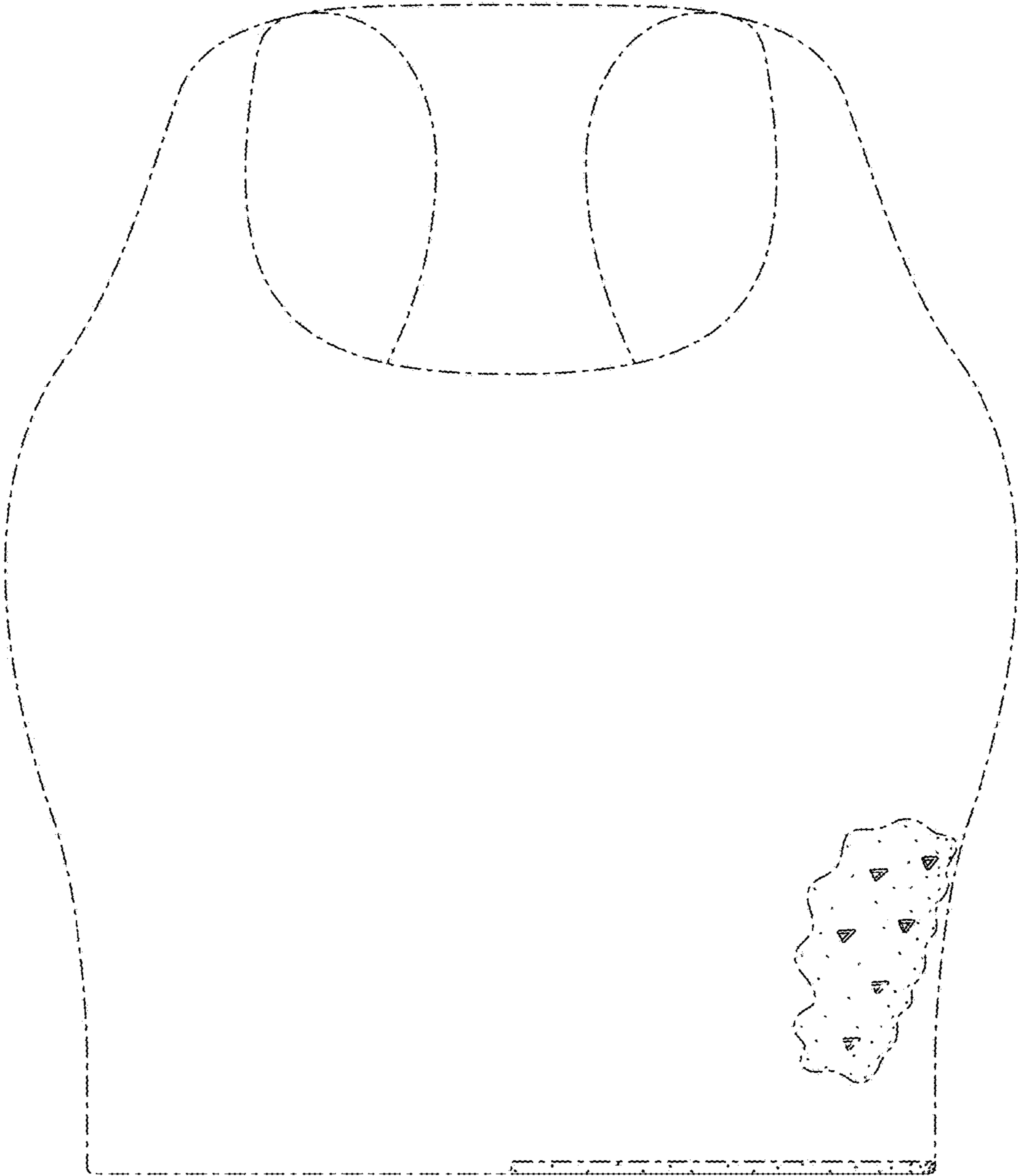

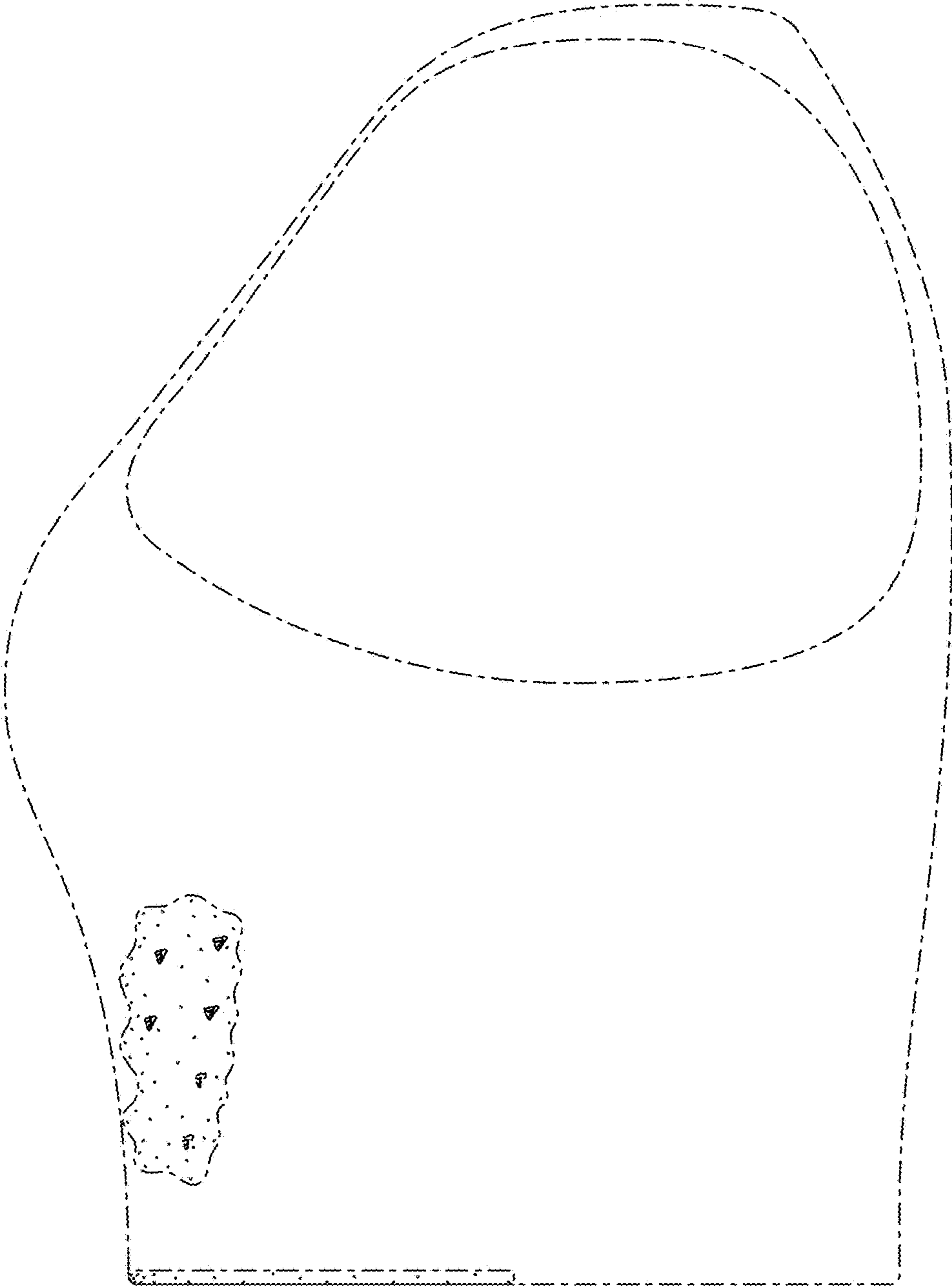

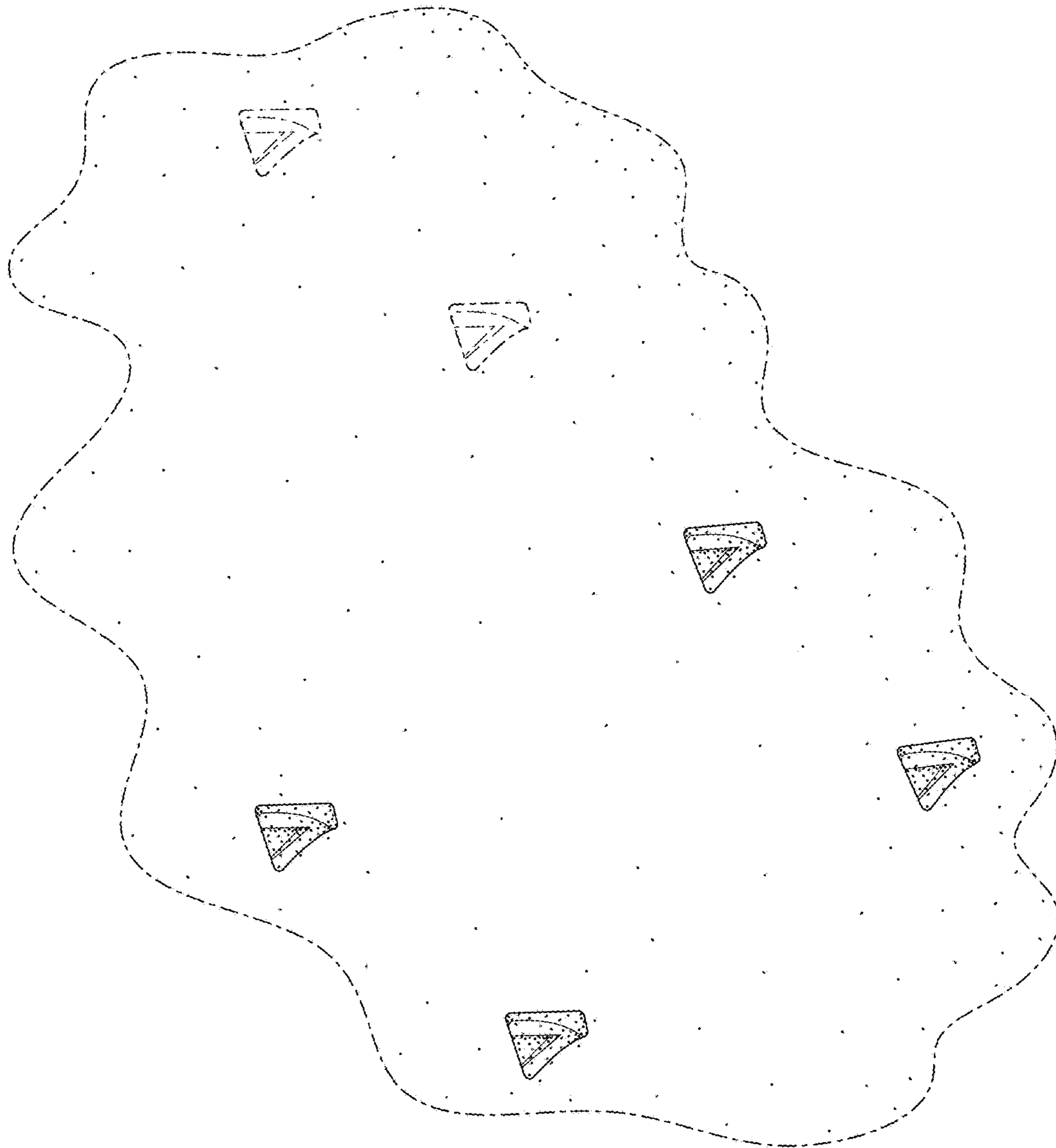

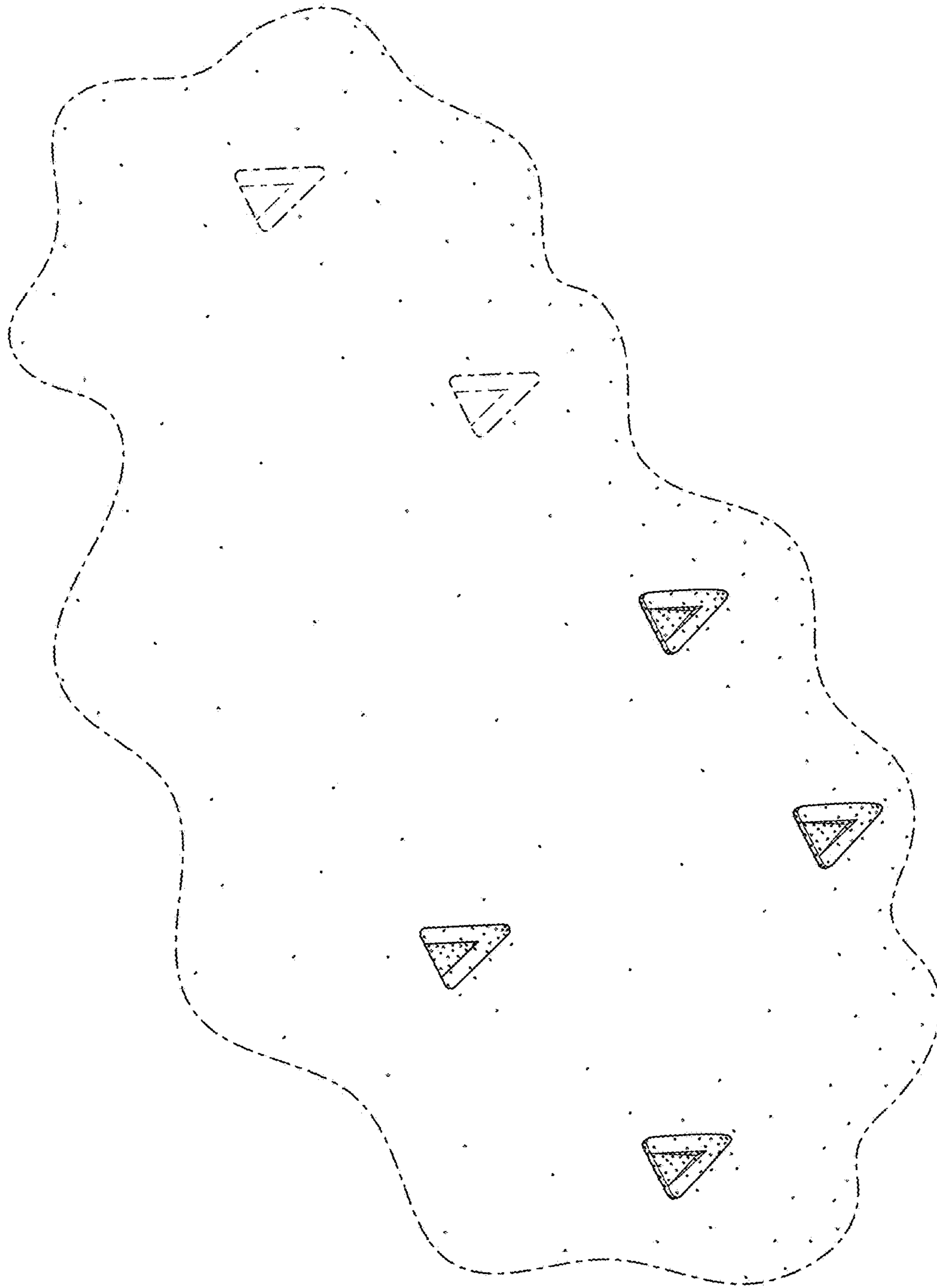

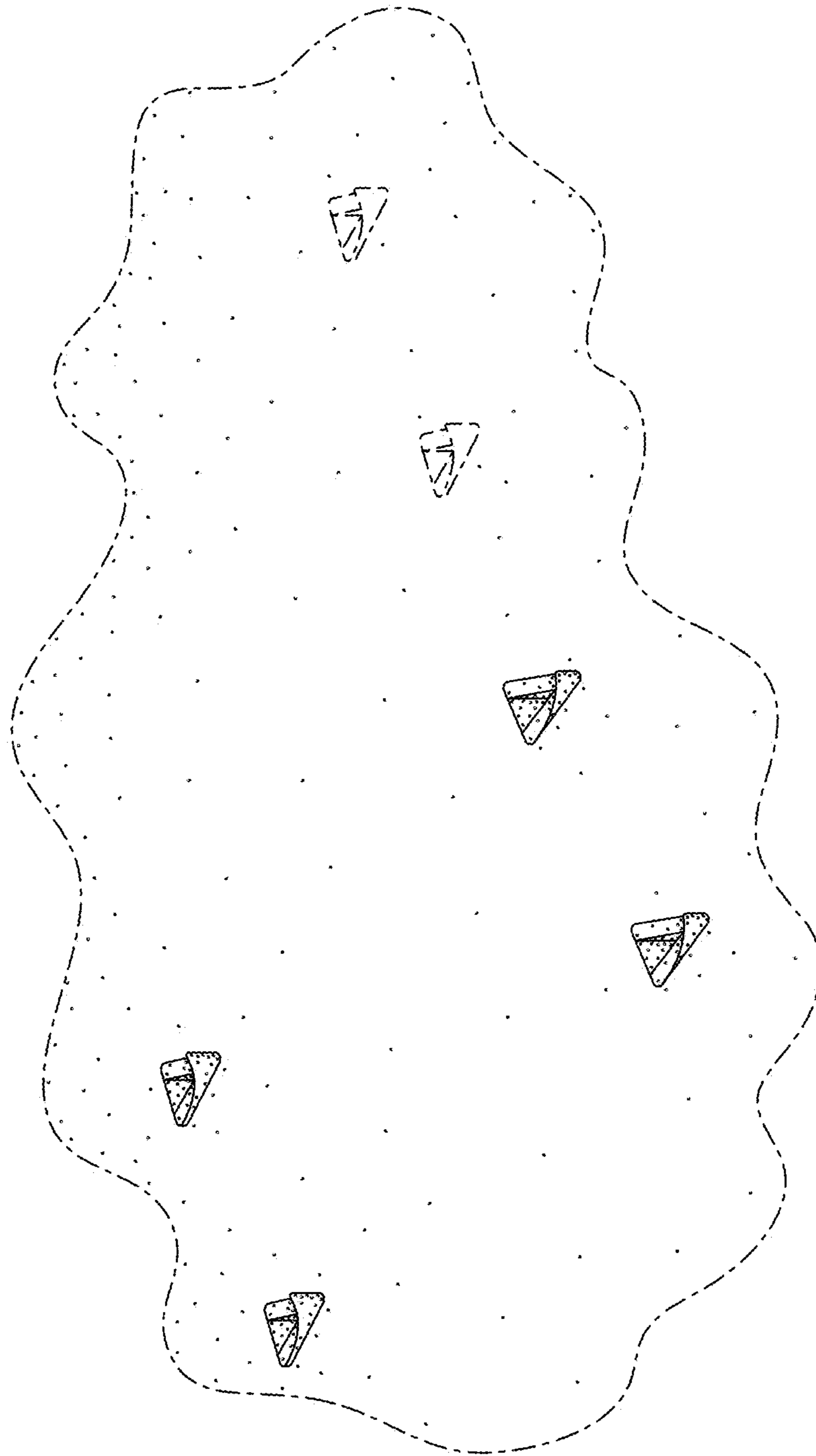

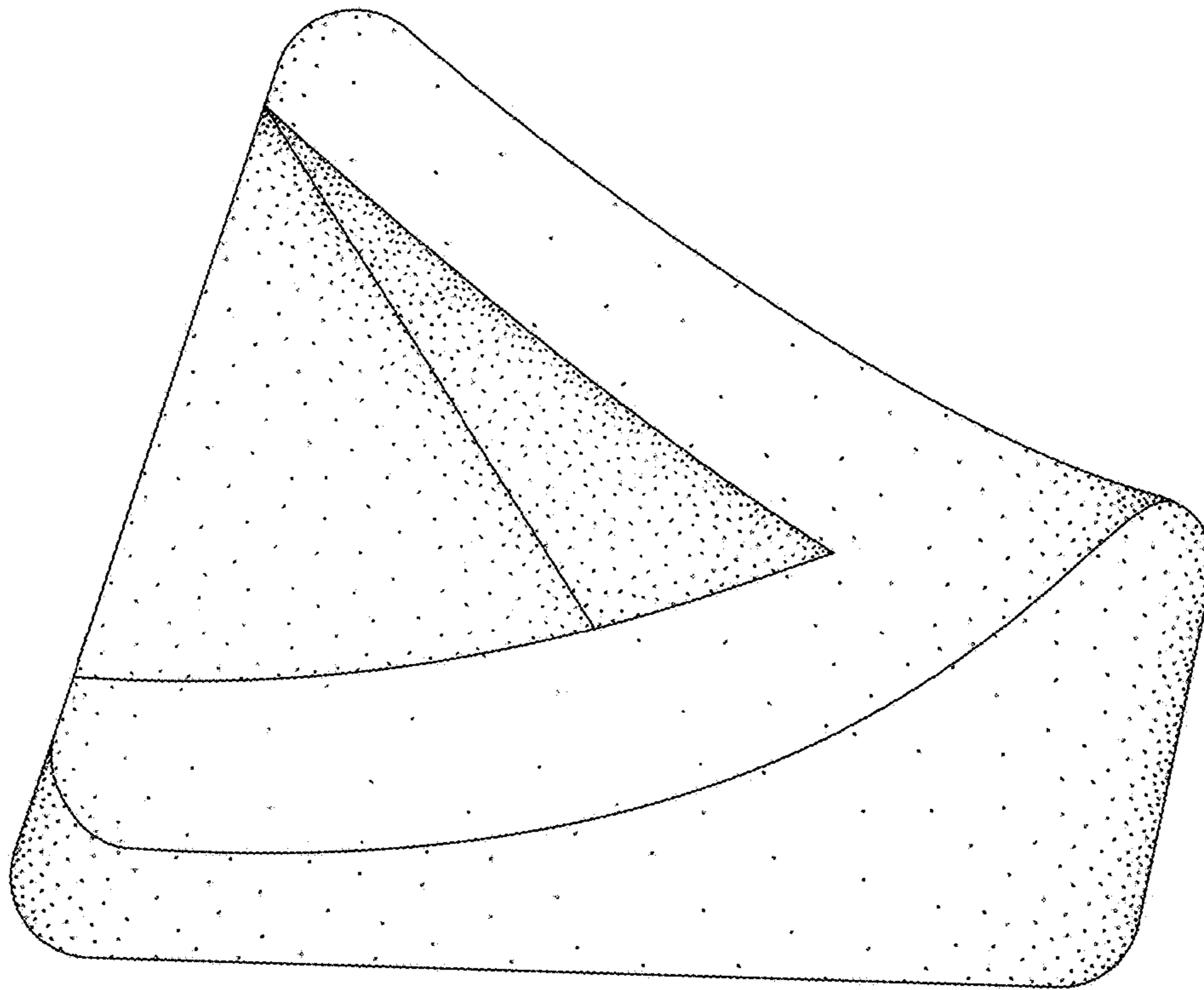

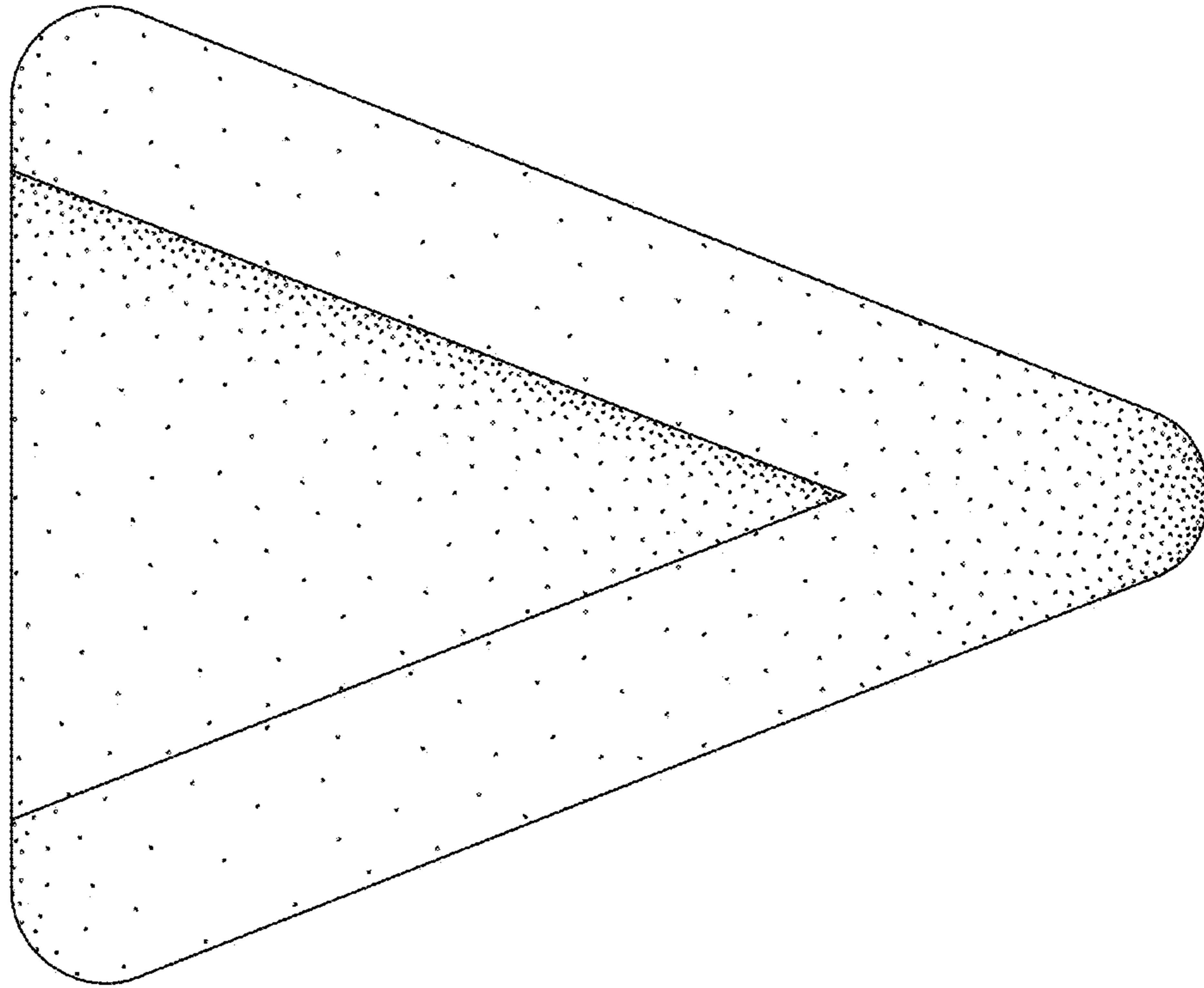

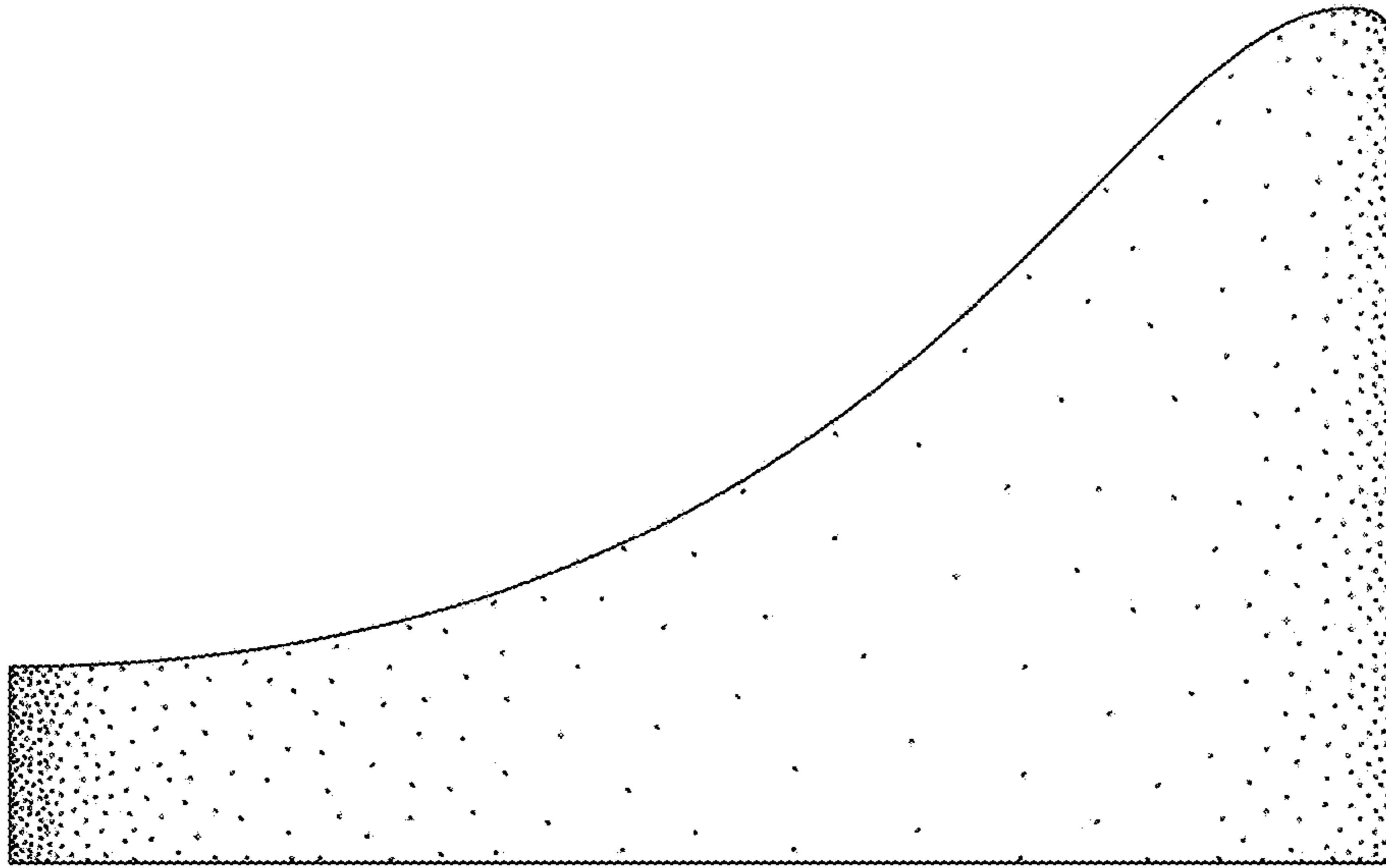

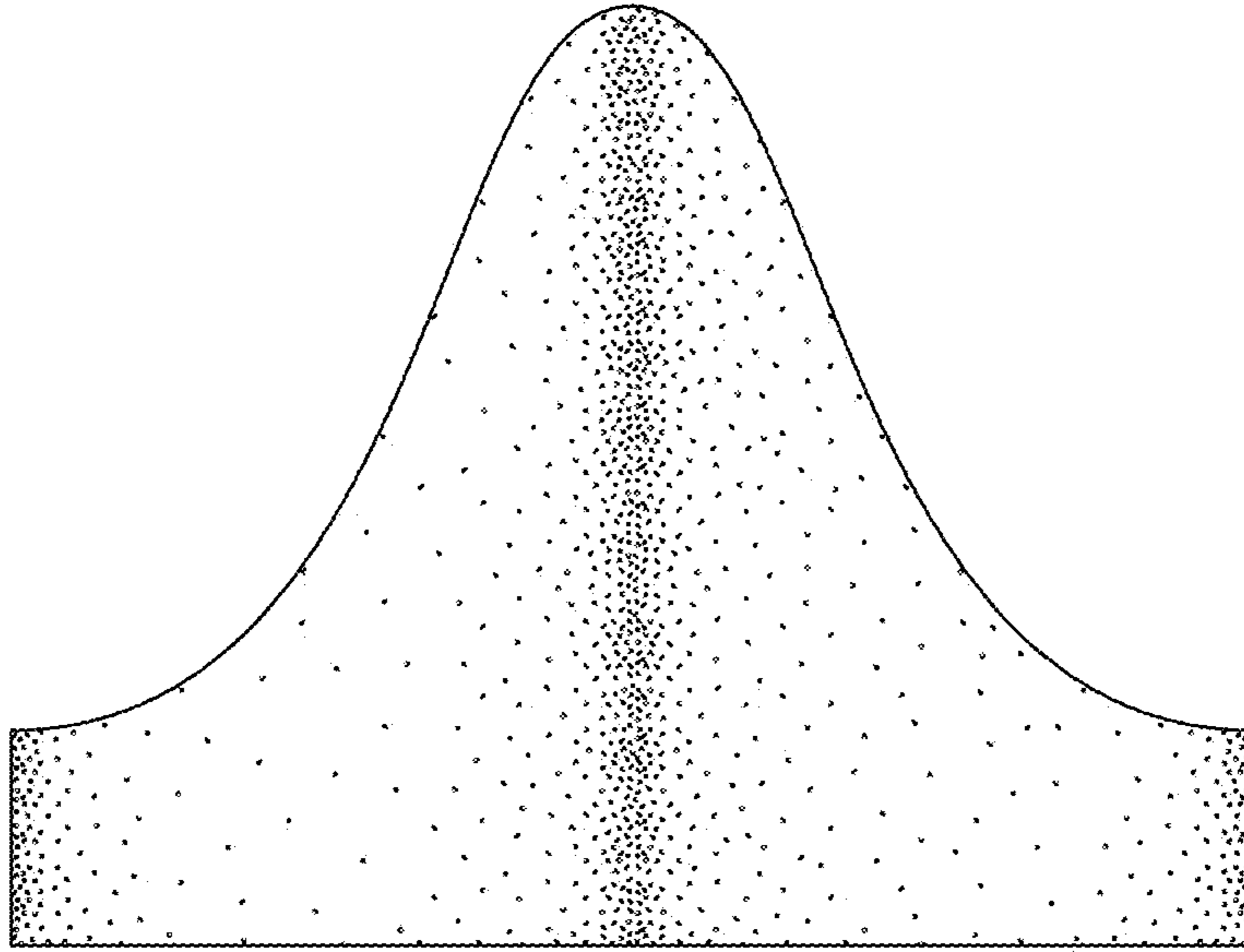

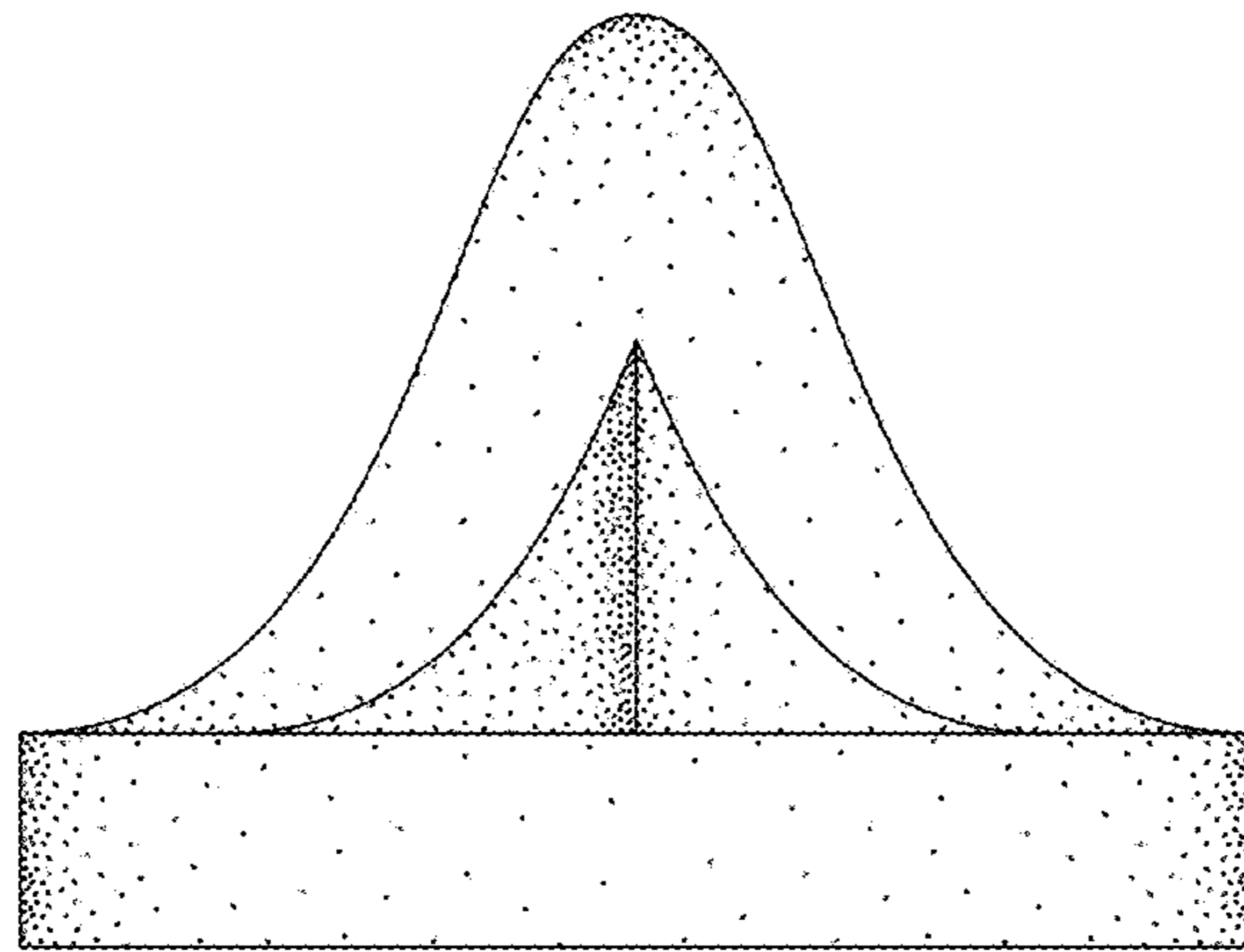
