(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective photographic view of a shoe outsole showing my new design in the environment of a shoe upper;

FIG. 2 is a bottom photographic view thereof;

FIG. 3 is a rear perspective photographic view thereof;

FIG. 4 is a top lateral perspective photographic view thereof;

FIG. 5 is a lateral side photographic view thereof;

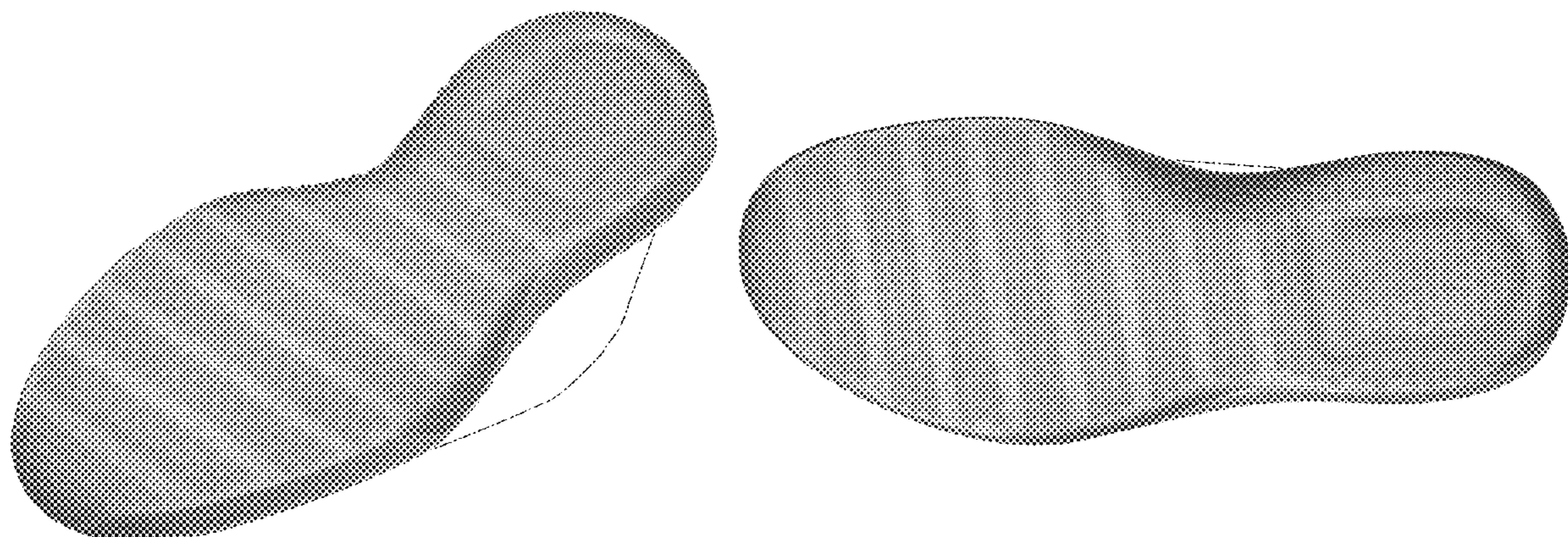
FIG. 6 is a medial side photographic view thereof;

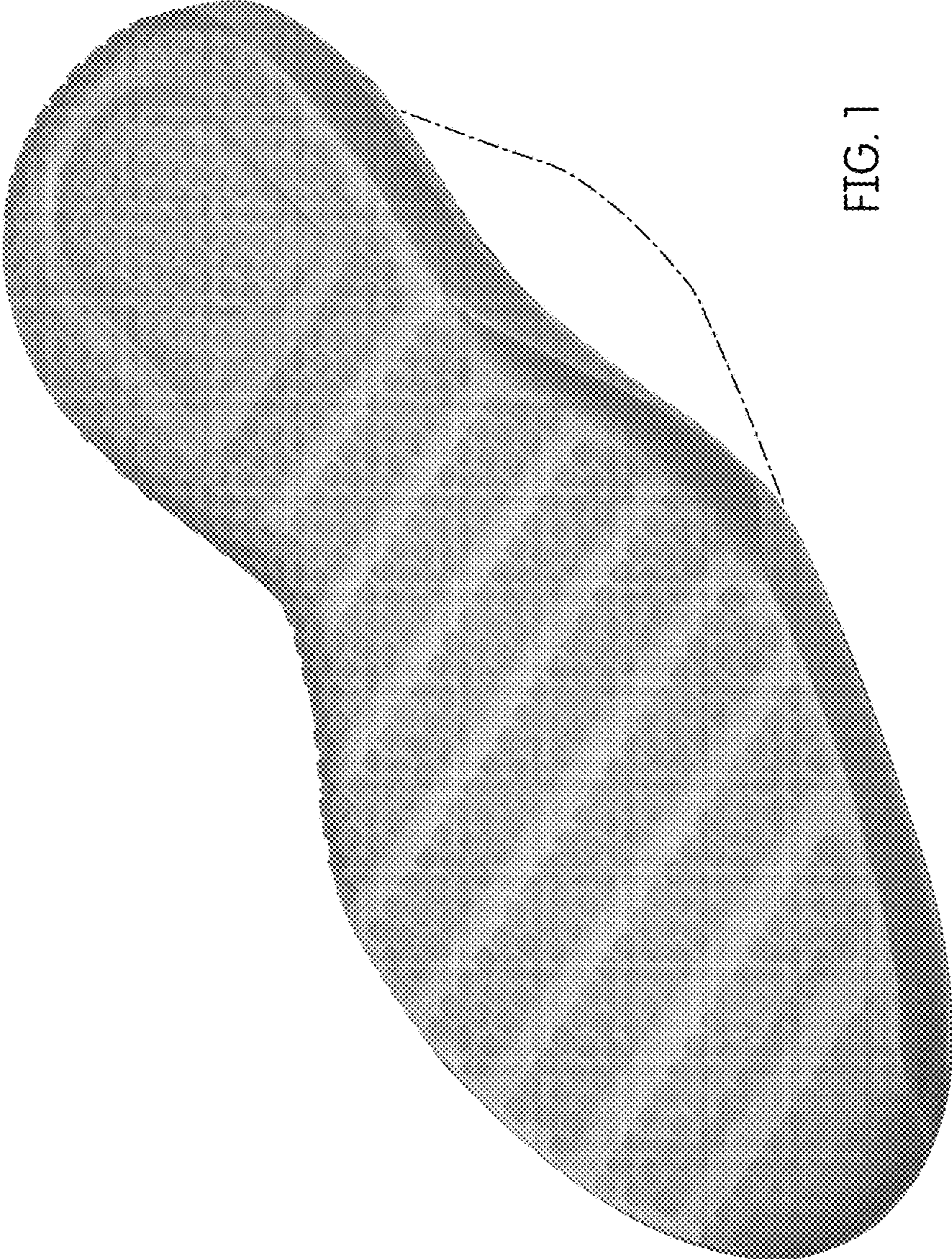

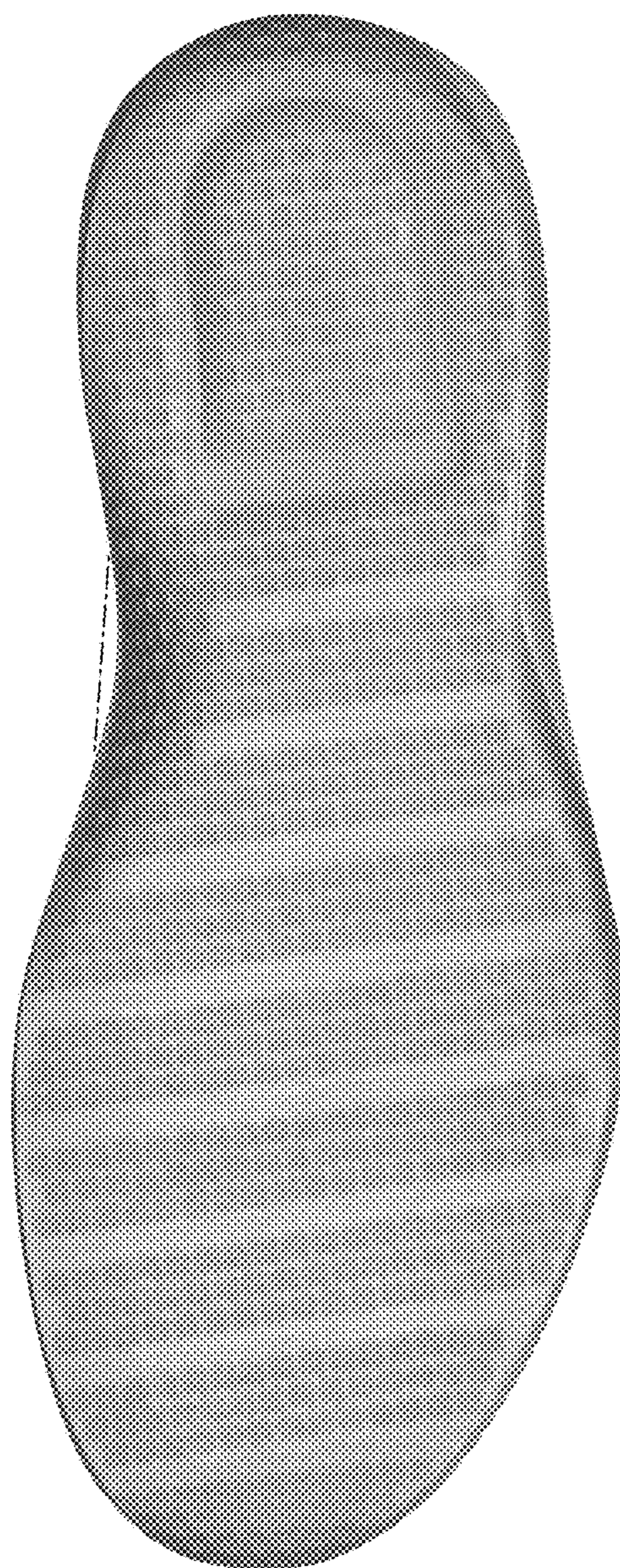

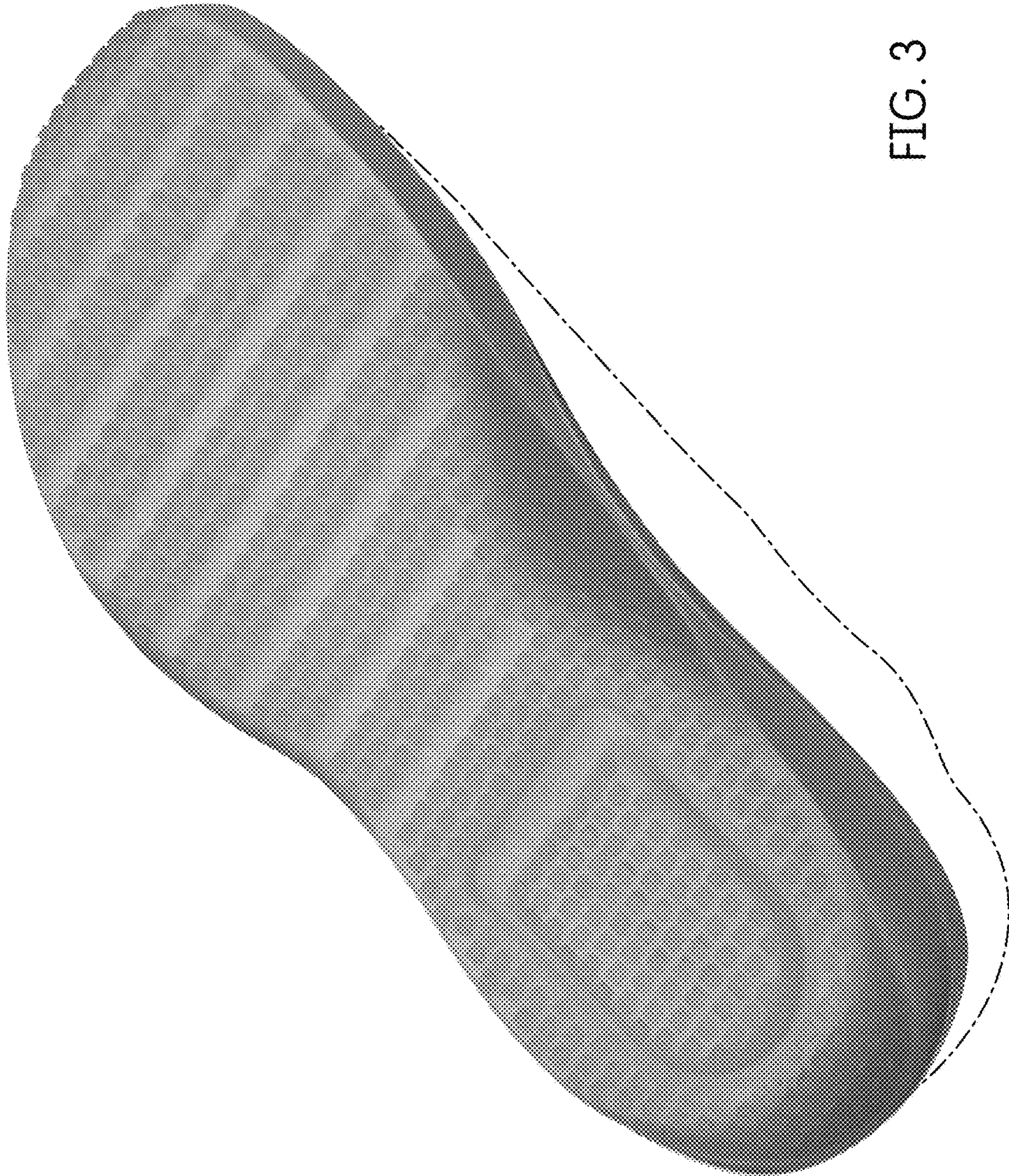

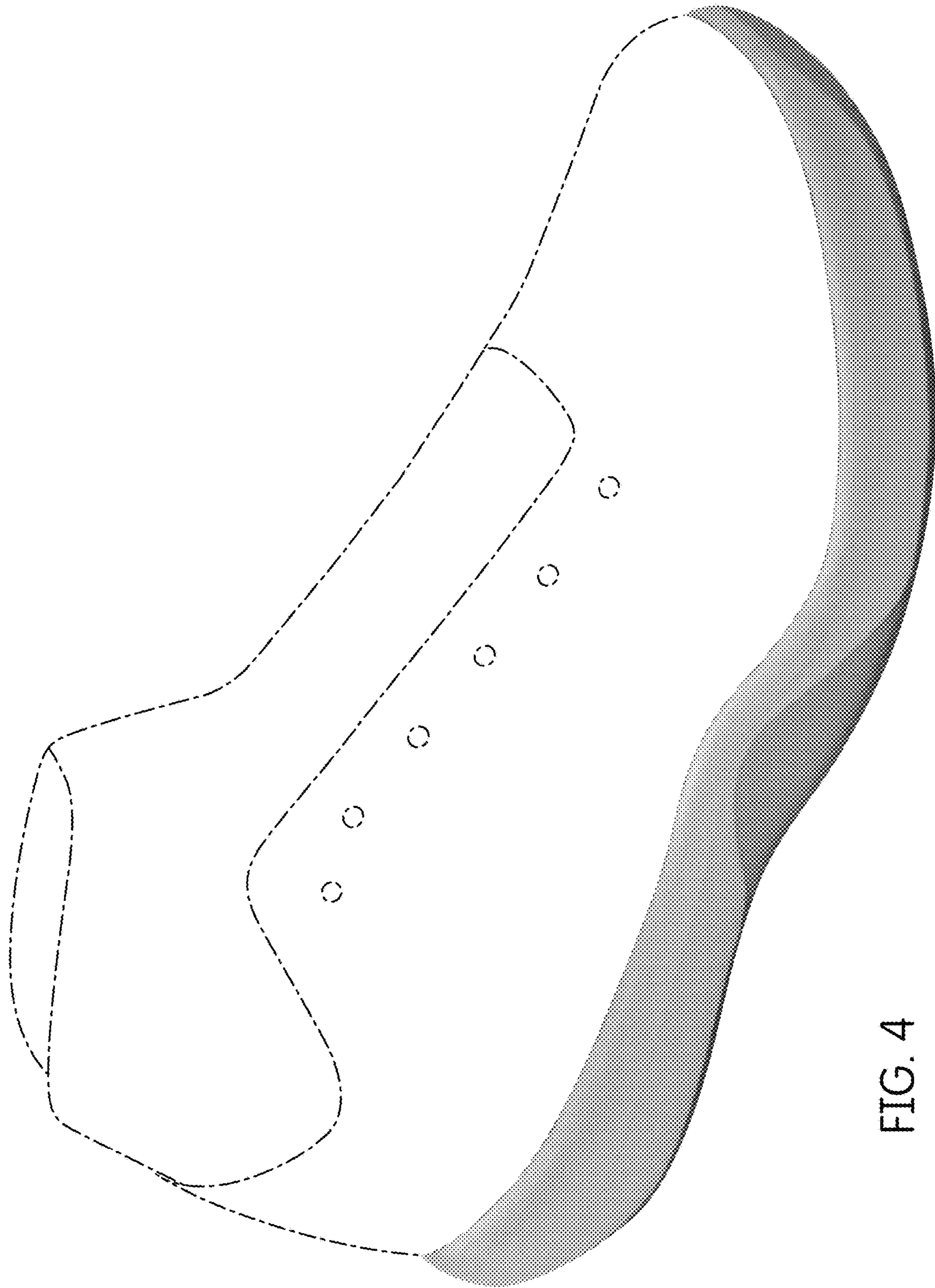

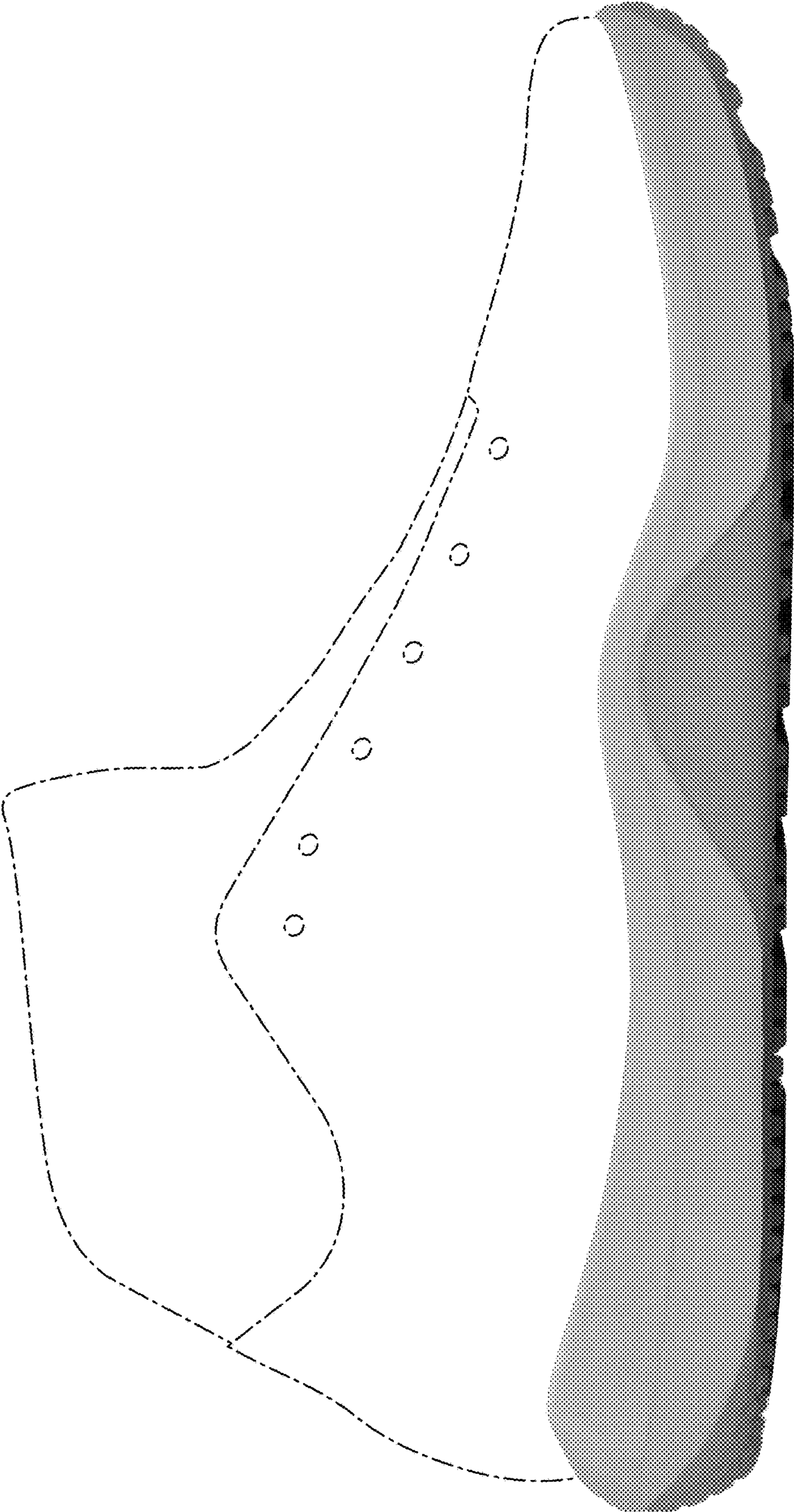

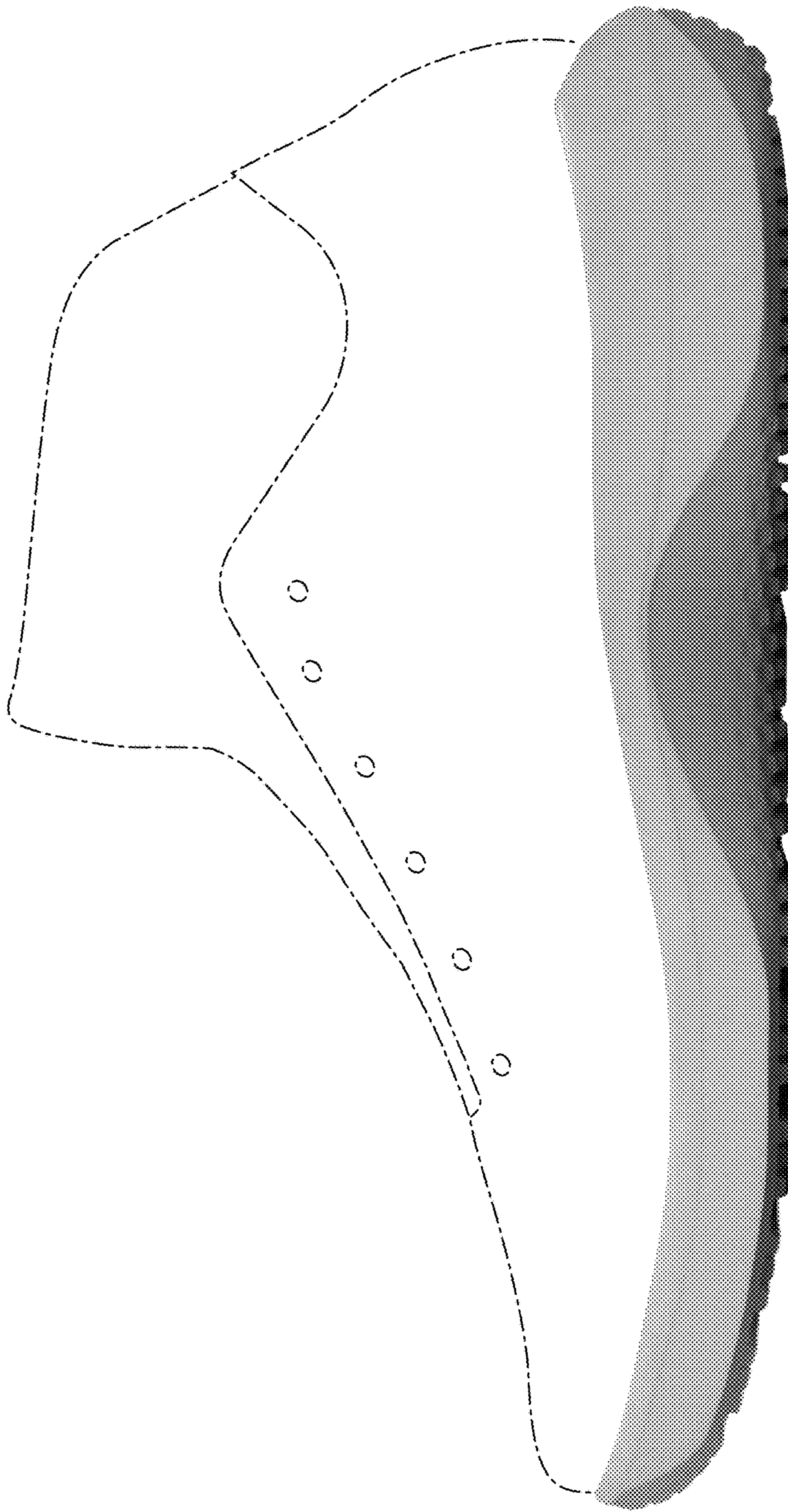

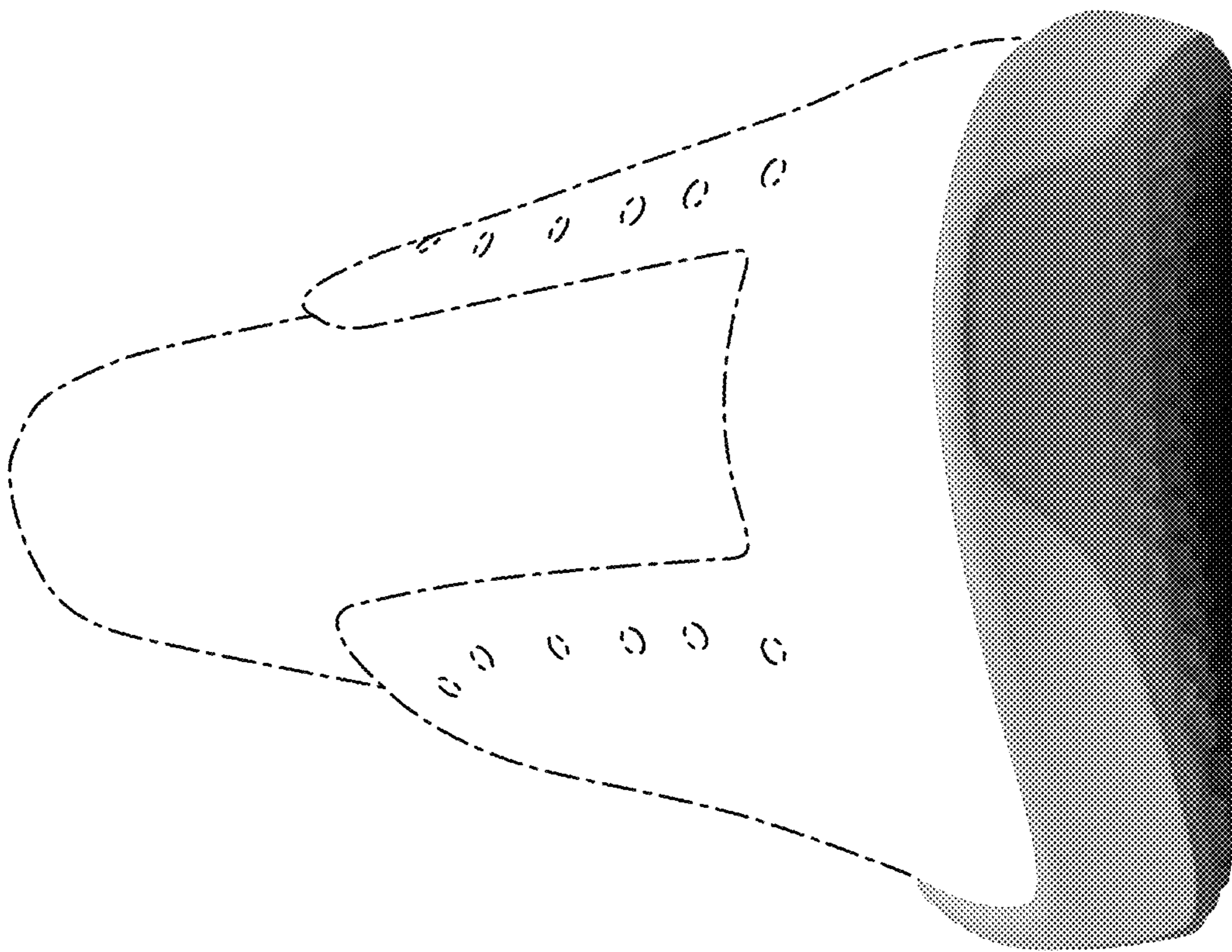

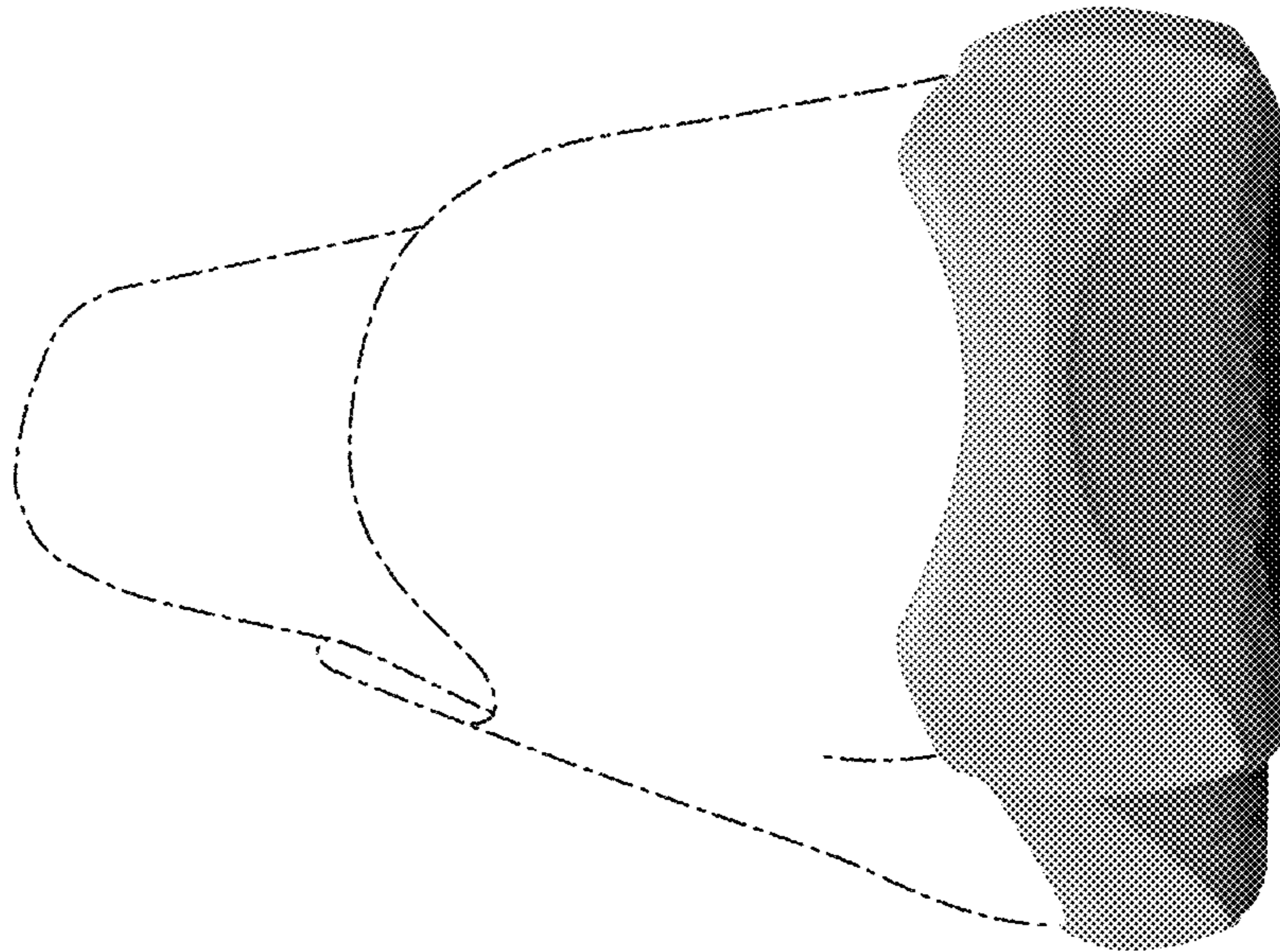
