**DESCRIPTION**

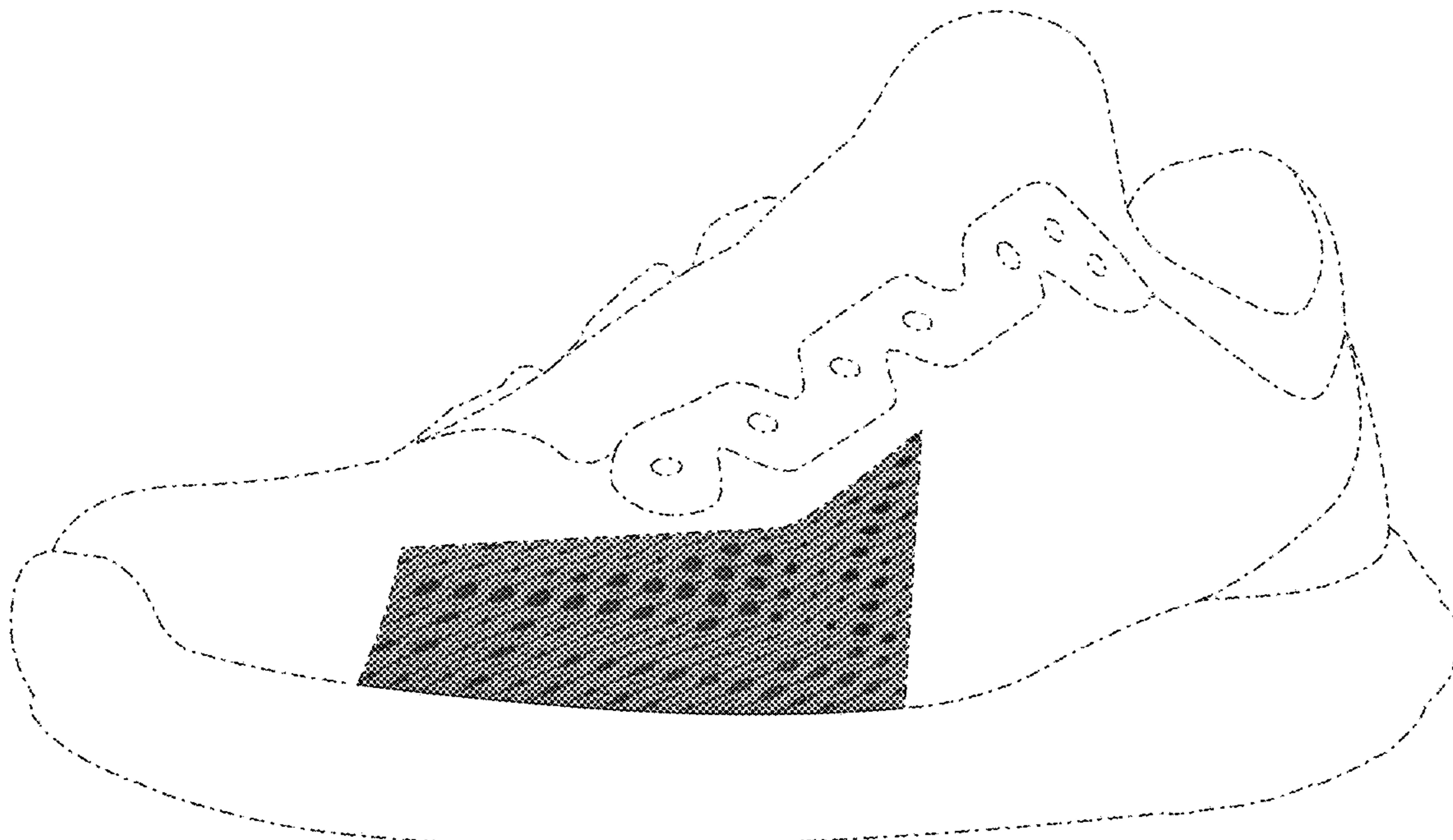
FIG. 1 is a front perspective photographic view of a shoe upper showing our new design;

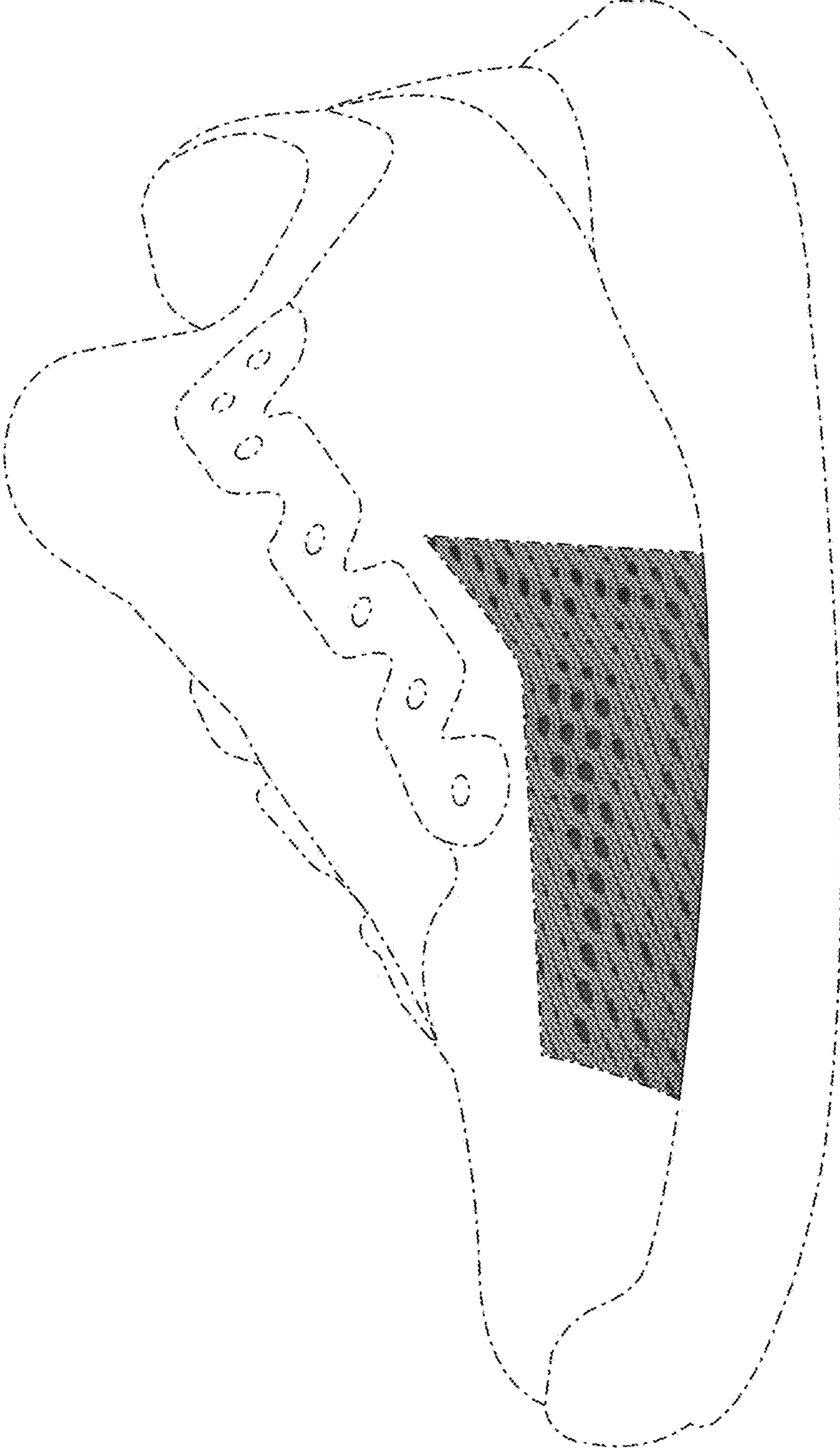
FIG. 2 is a side view thereof; and,

FIG. 3 is a rear perspective view thereof.

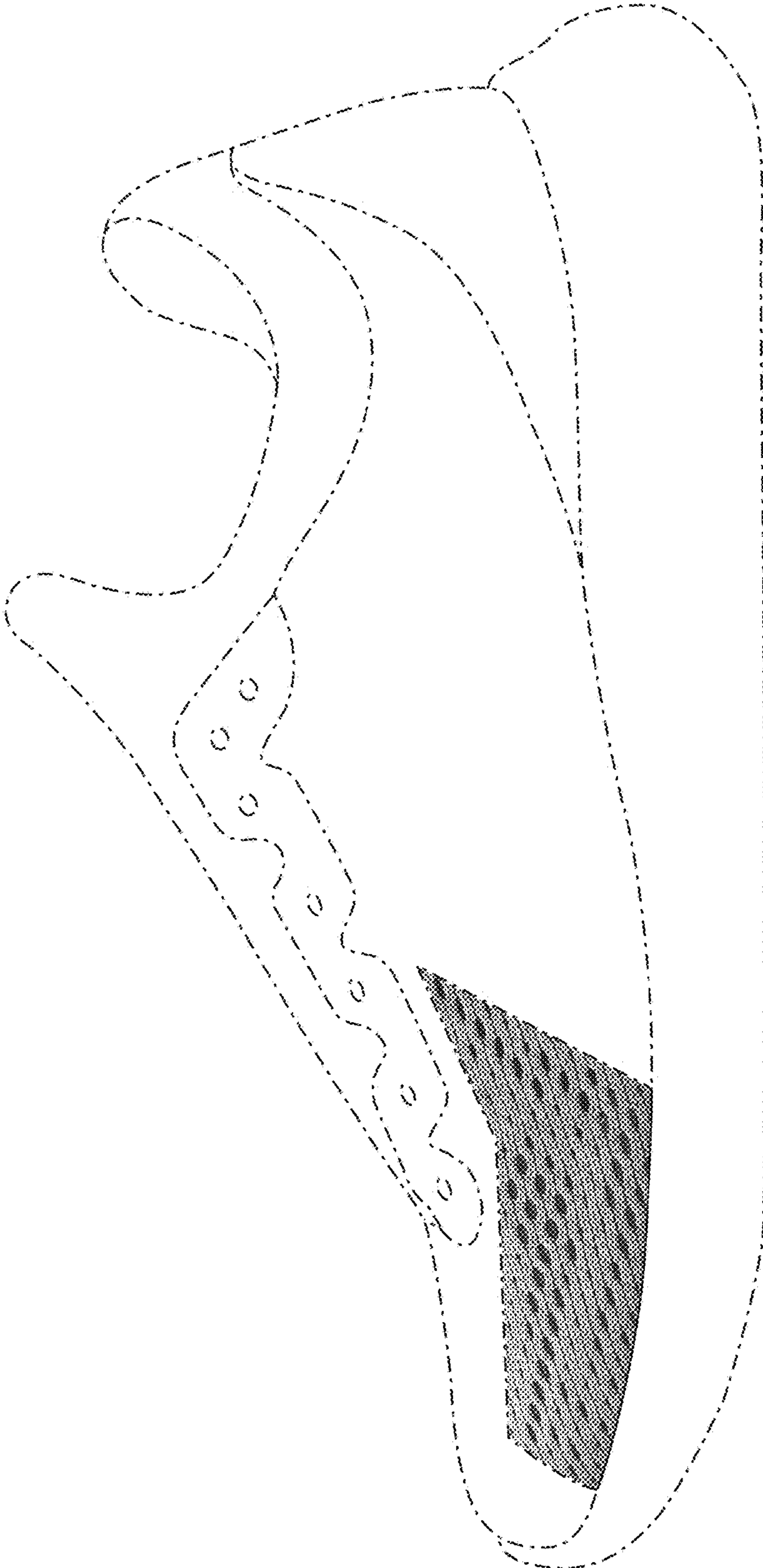

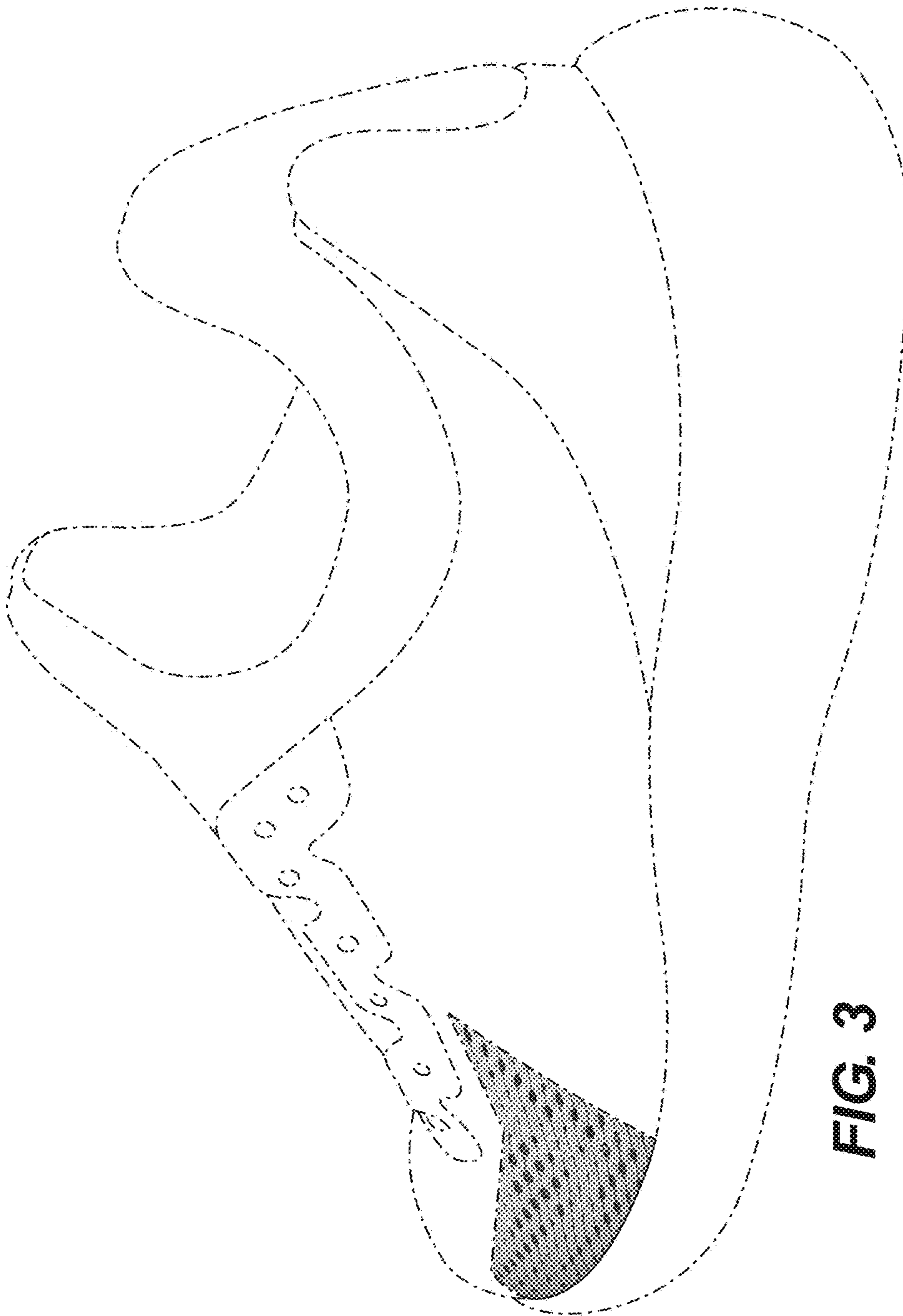
