I claim the ornamental design for a makeup brush easel, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a makeup brush easel
showing my new design in an open state;
FIG. 2 is a perspective view thereof, in a closed state;
FIG. 3 is a front elevational view thereof, in an open and flat
state;
FIG. 4 is a rear elevational view thereof, in an open and flat
state;
FIG. 5 is a left side elevational view thereof, in an open and
flat state;
FIG. 6 is a right side elevational view thereof, in an open and
flat state;
FIG. 7 is a top plan view thereof, in an open and flat state;
and,
FIG. 8 is a bottom plan view thereof, in an open and flat
state.

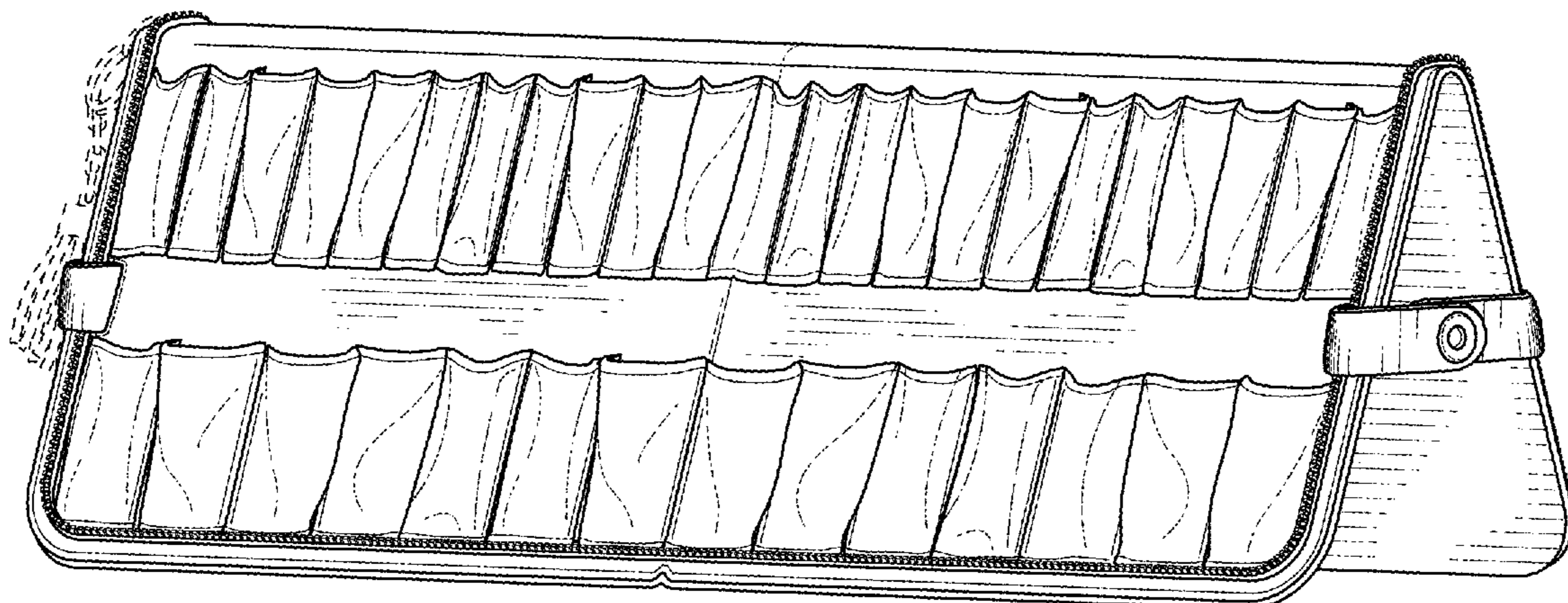
The tassel and the hardware connecting it to the exterior

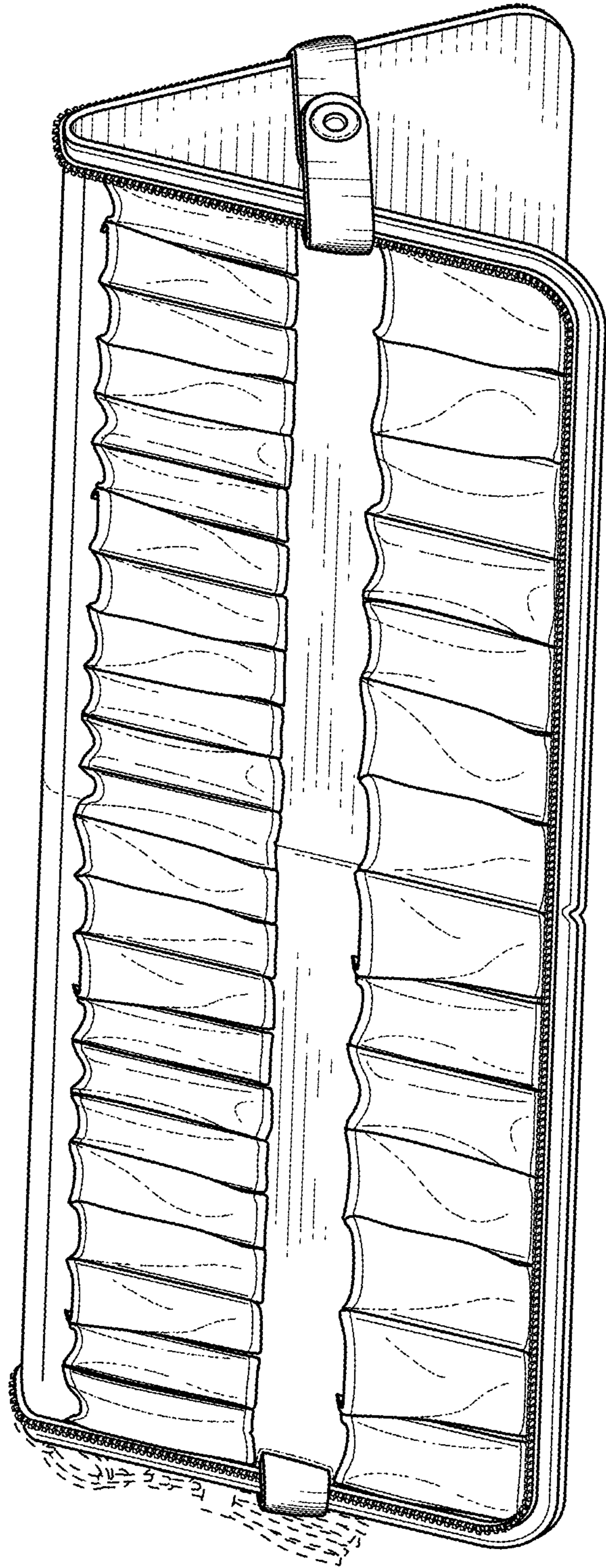

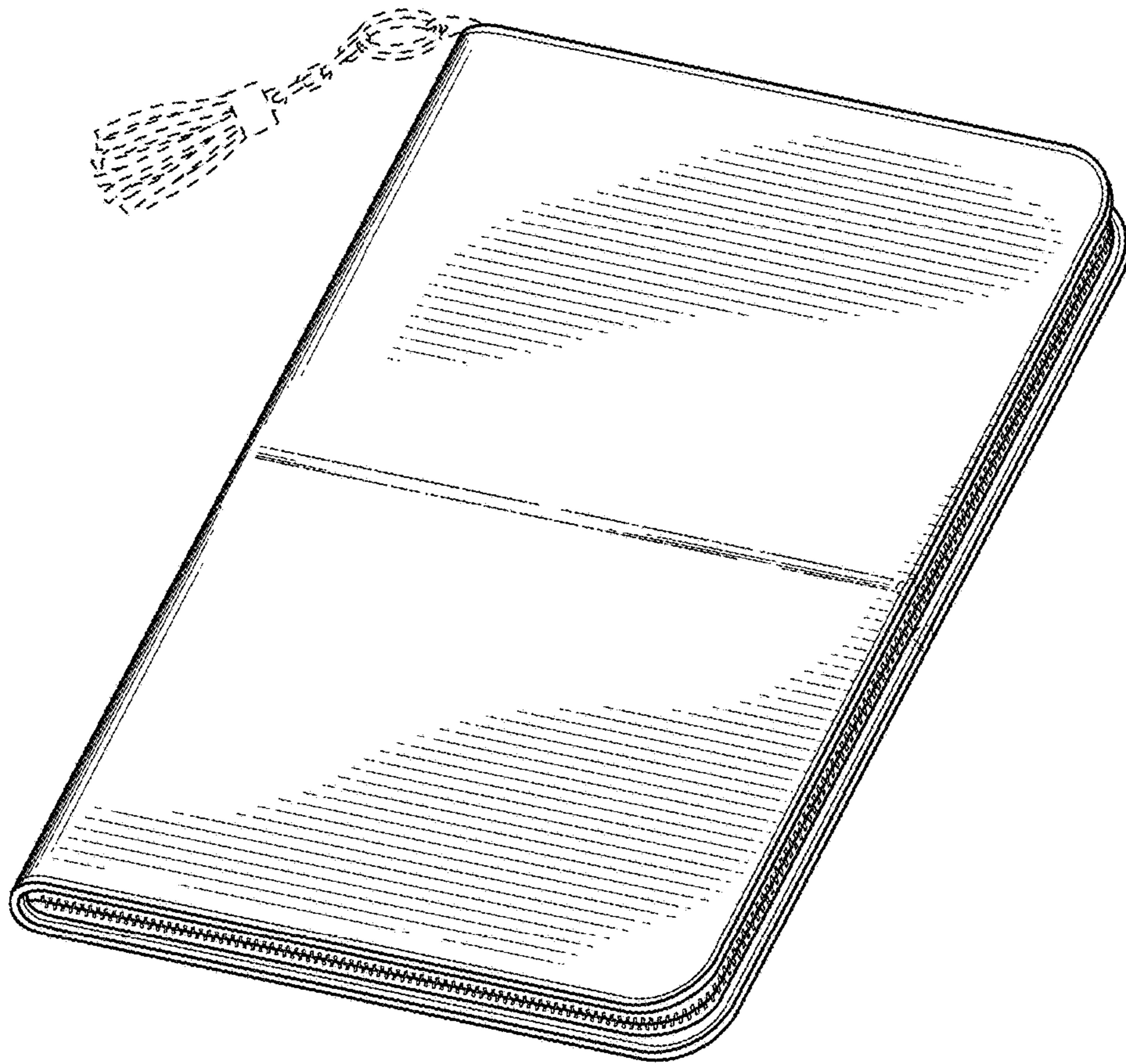

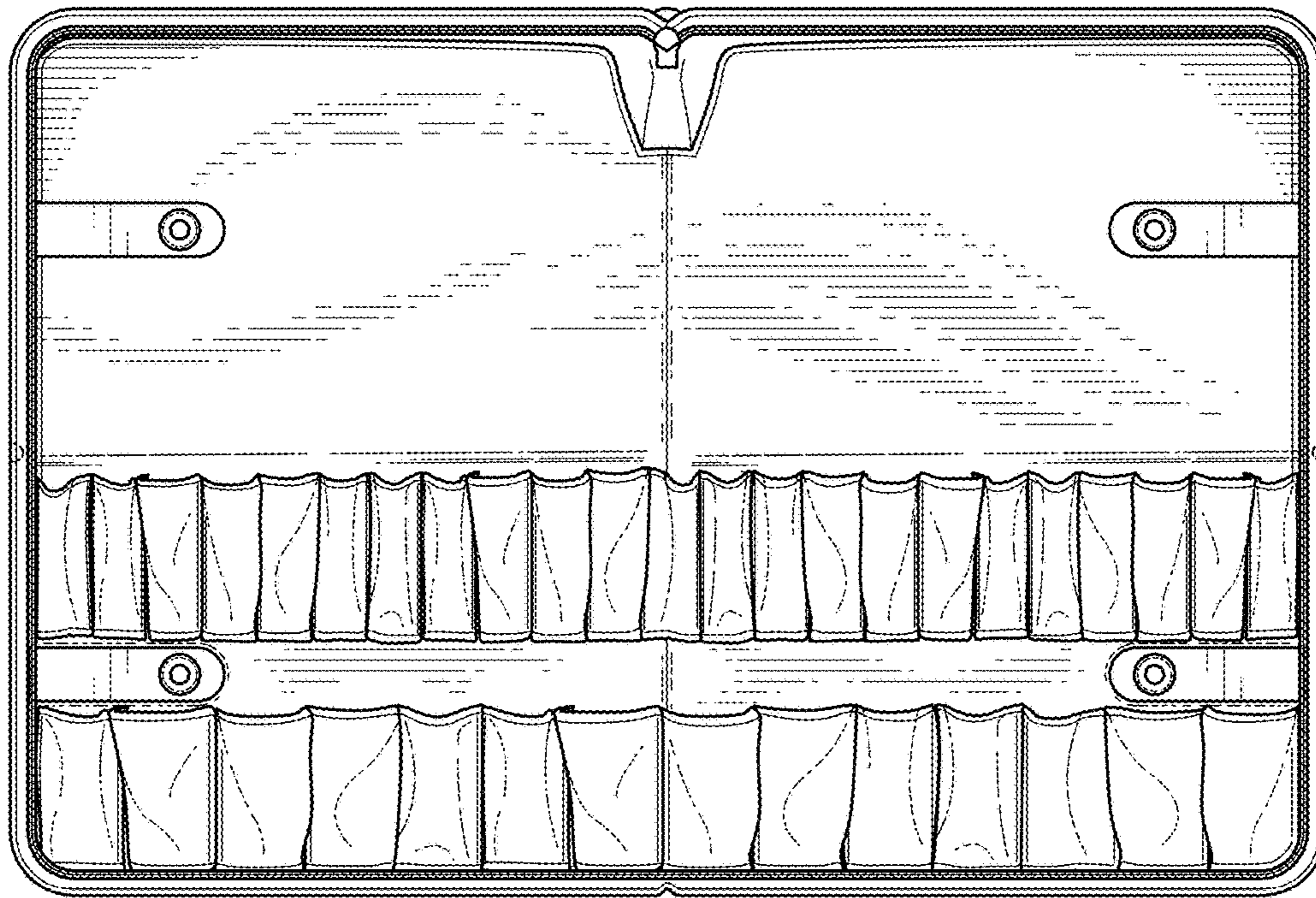

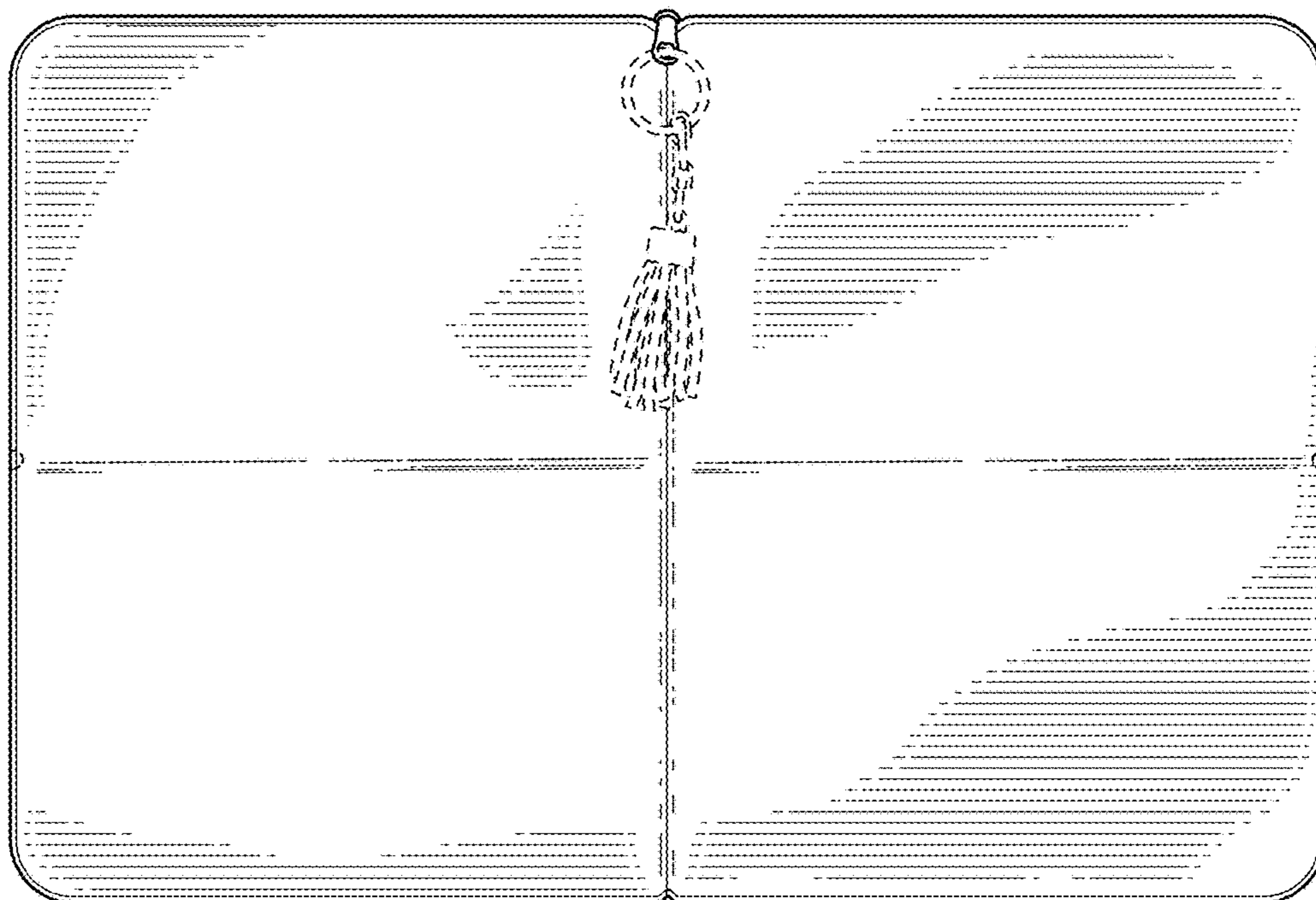

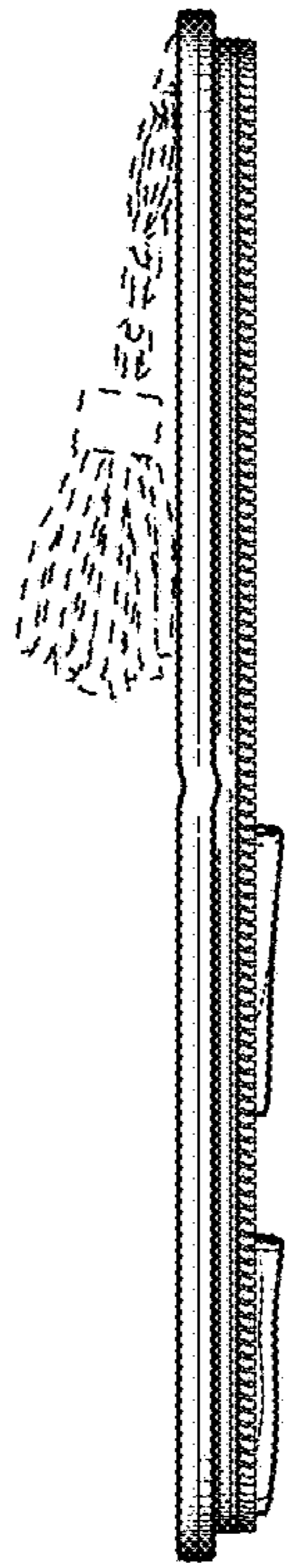

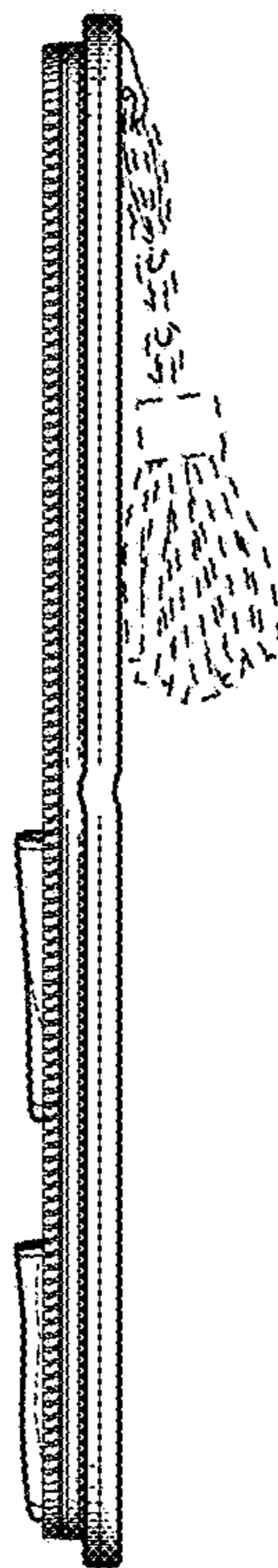

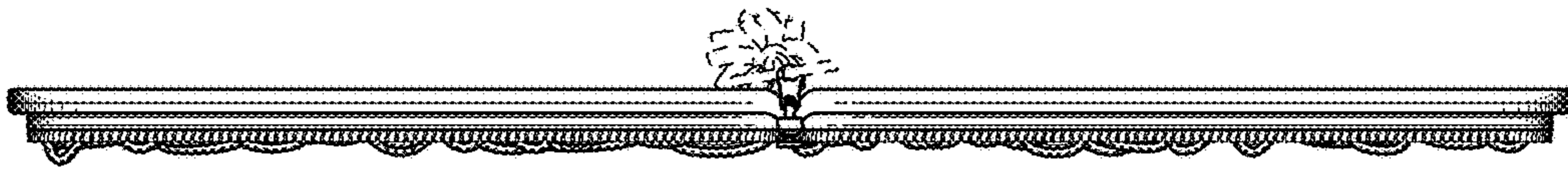
