(57) **CLAIM**

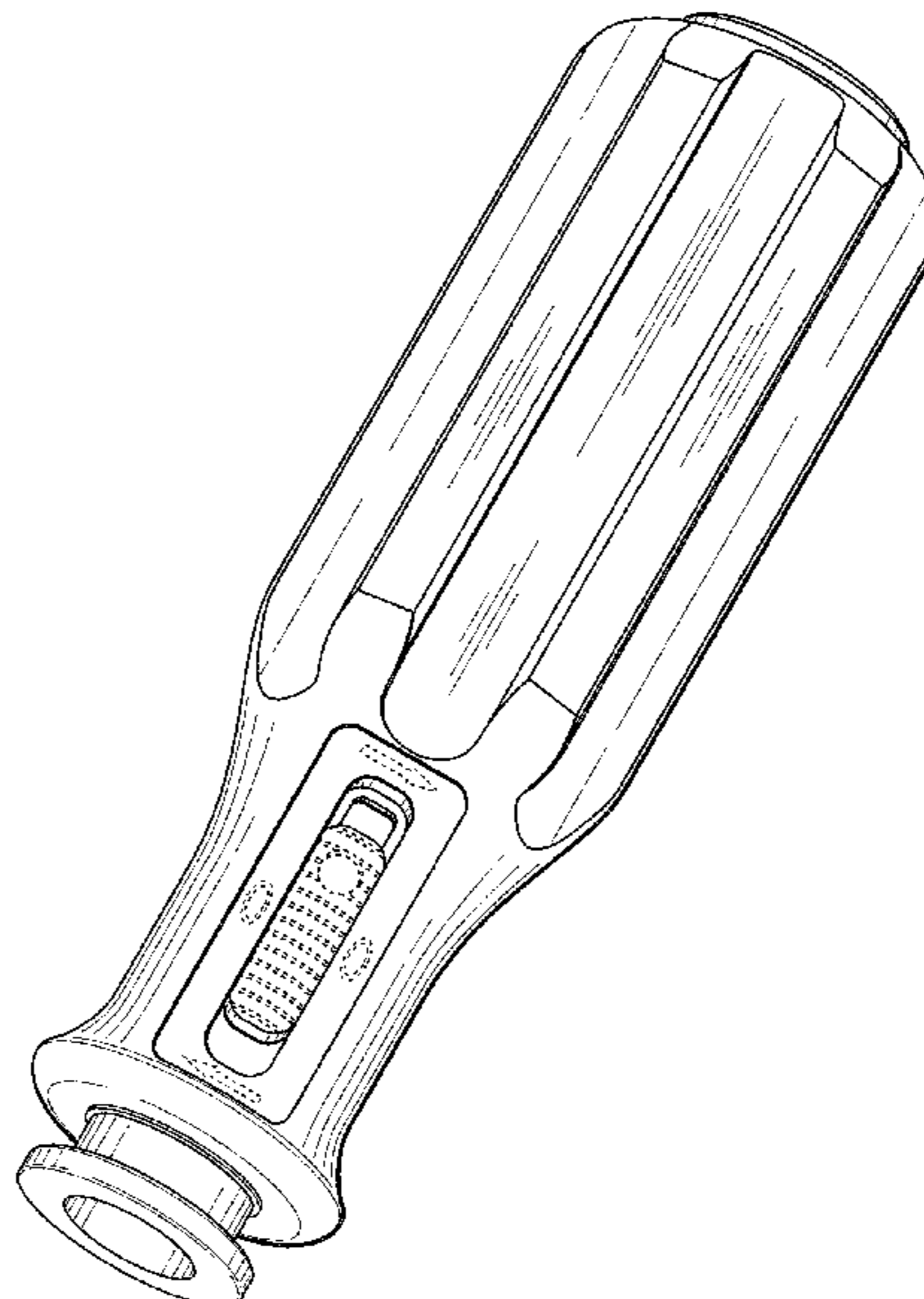
The ornamental design for a drive handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a drive handle in accordance with the new design;  
FIG. 2 is a rear perspective view of the drive handle of FIG. 1;  
FIG. 3 is a front view of the drive handle of FIG. 1;  
FIG. 4 is a rear view of the drive handle of FIG. 1;  
FIG. 5 is a top plan view of the drive handle of FIG. 1;

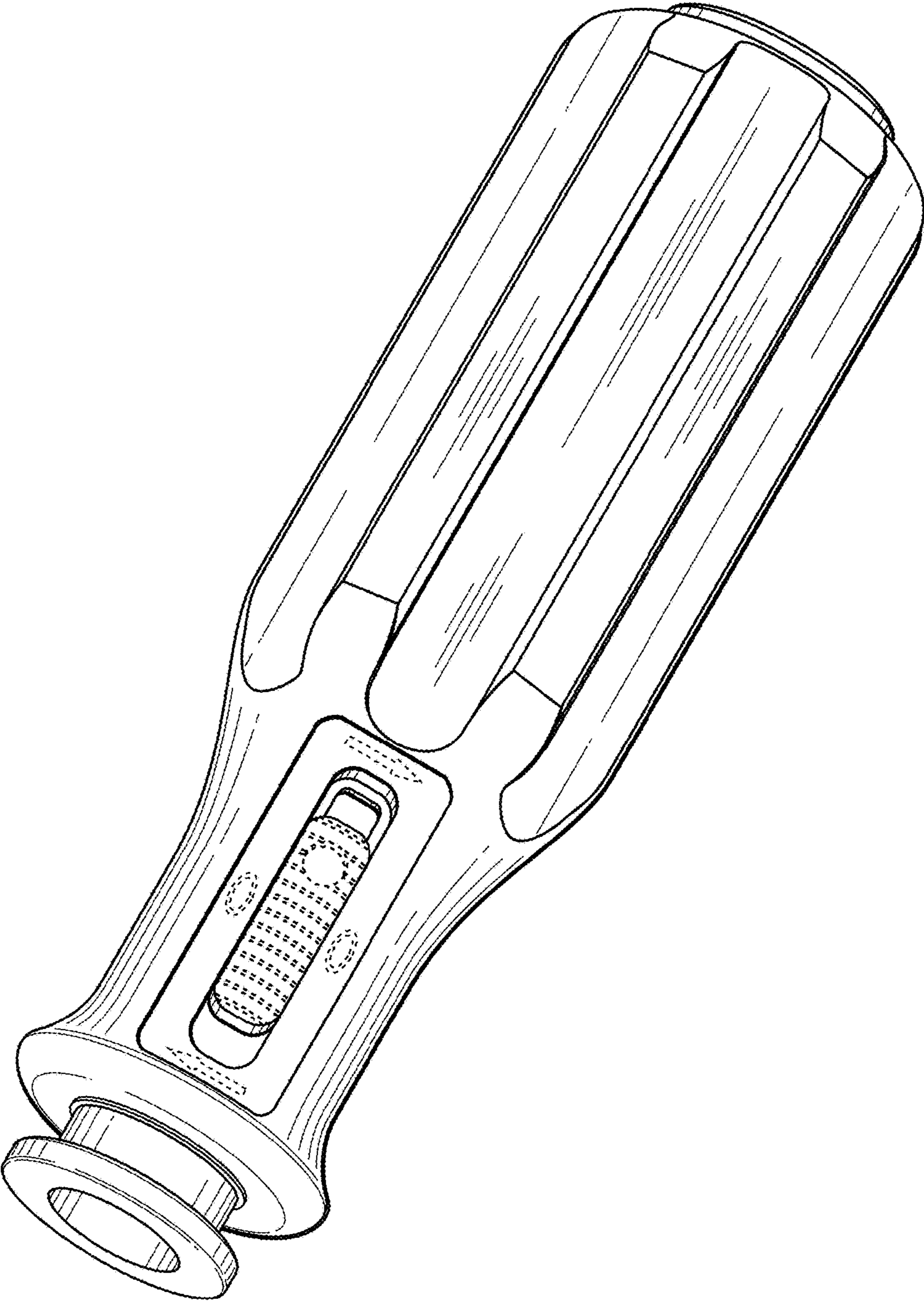

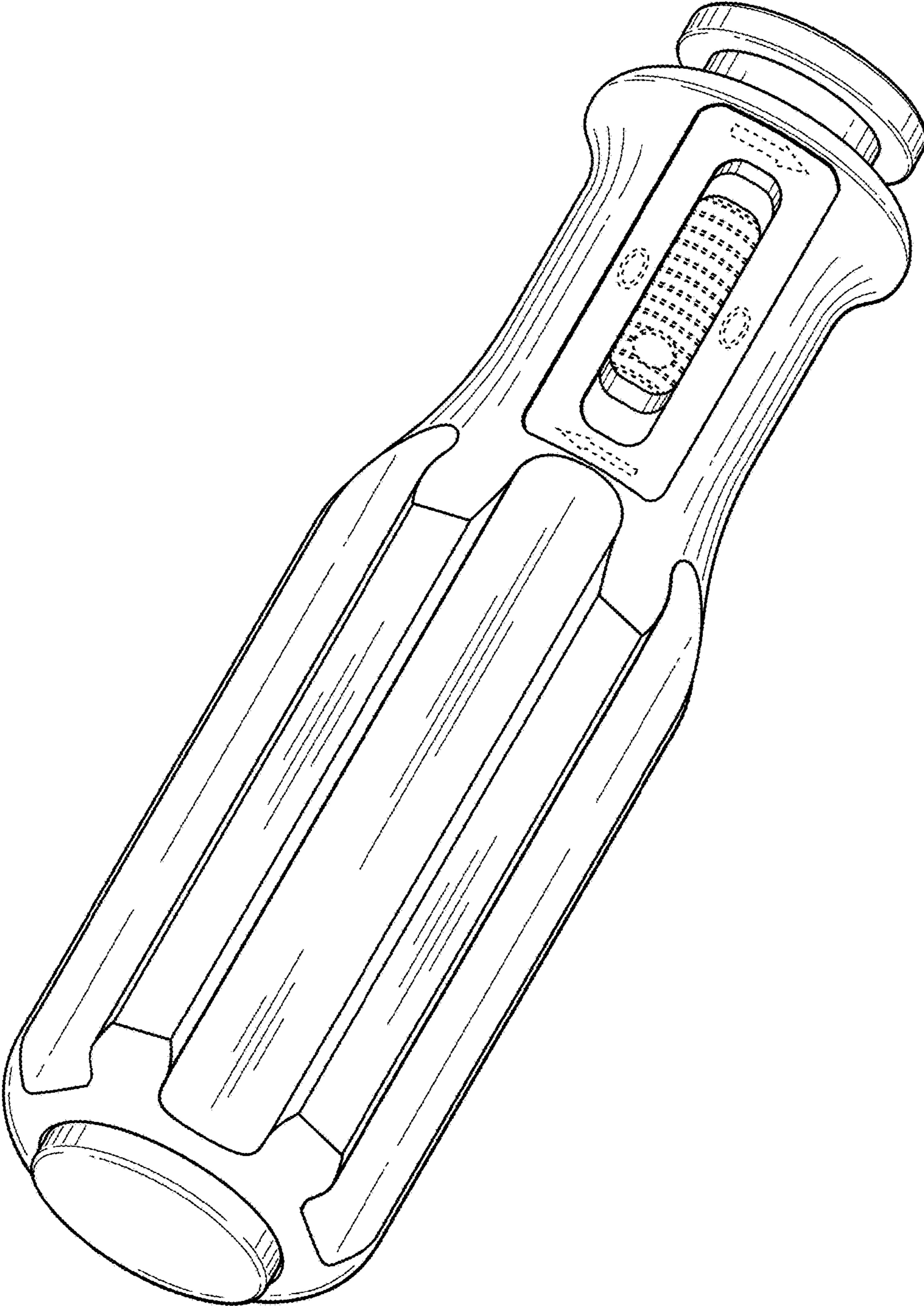

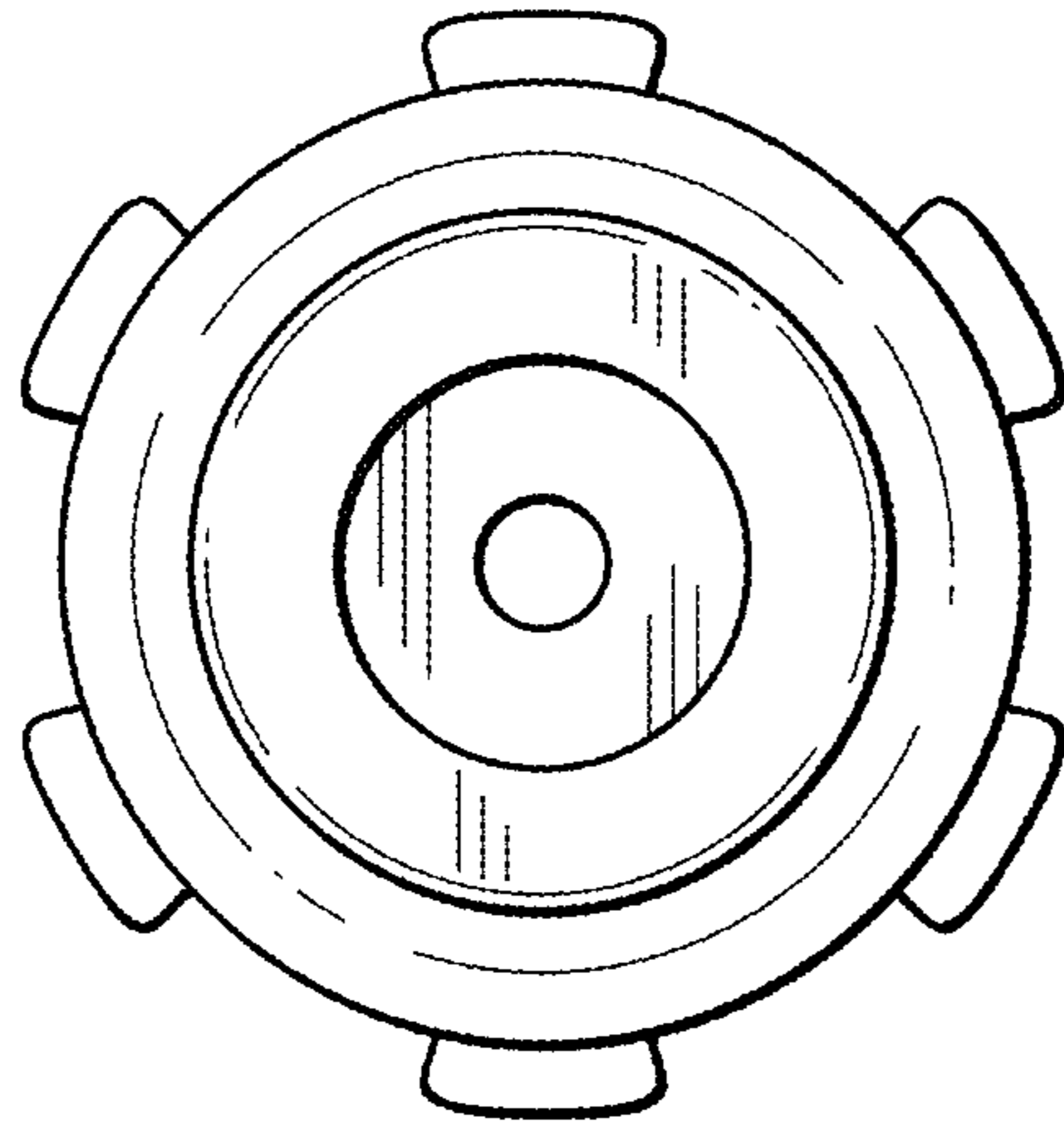

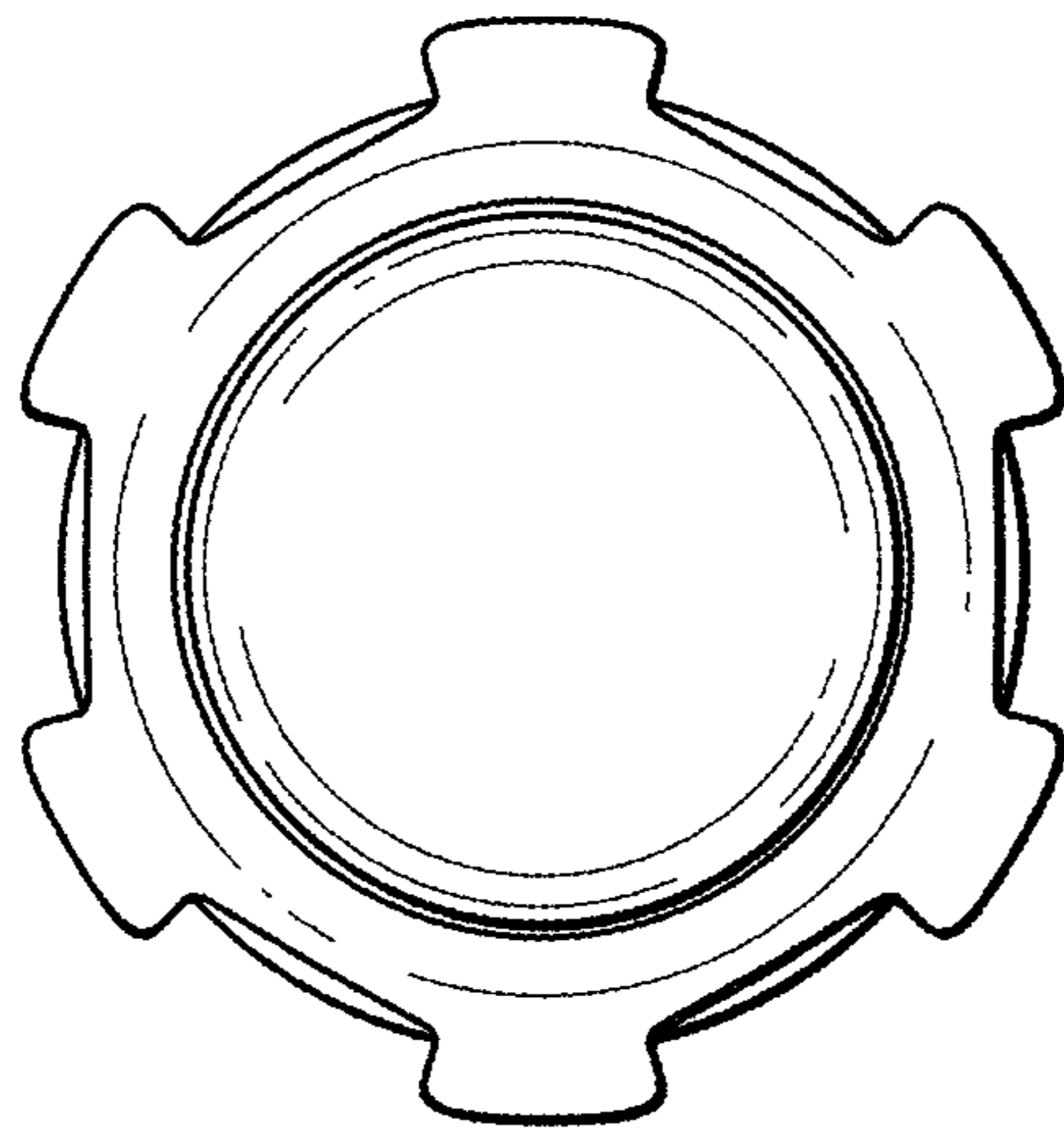

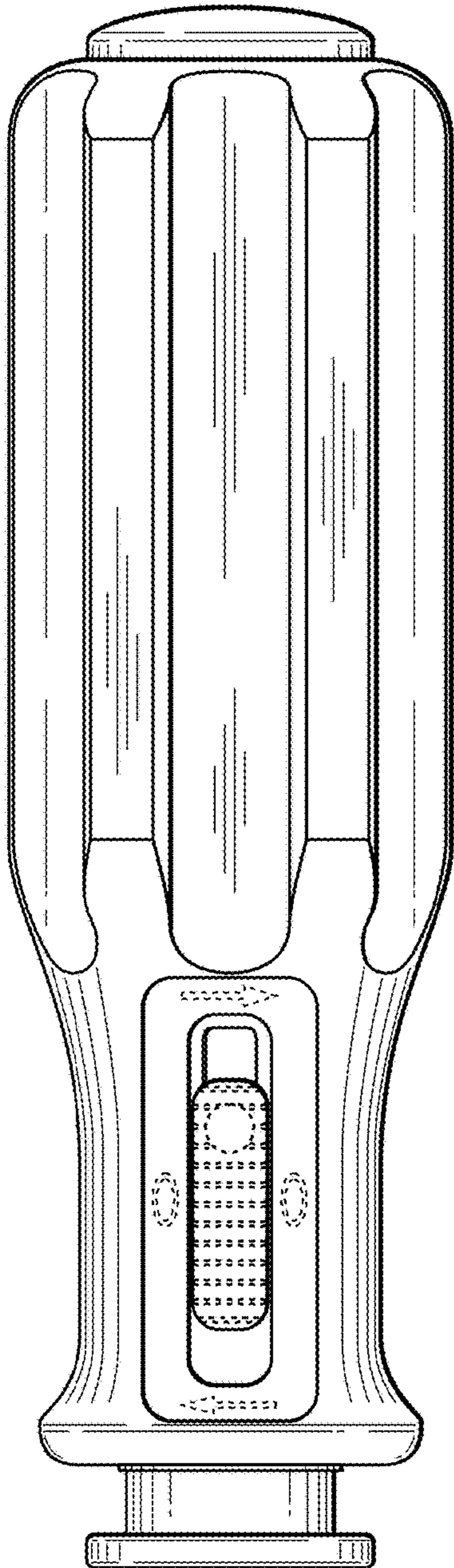

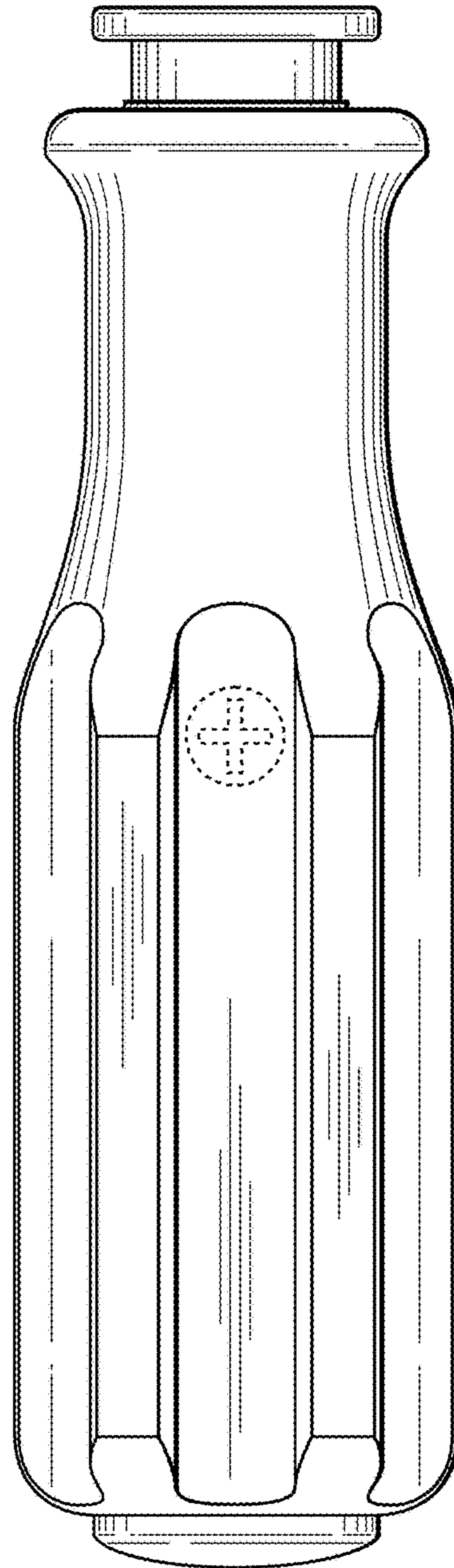

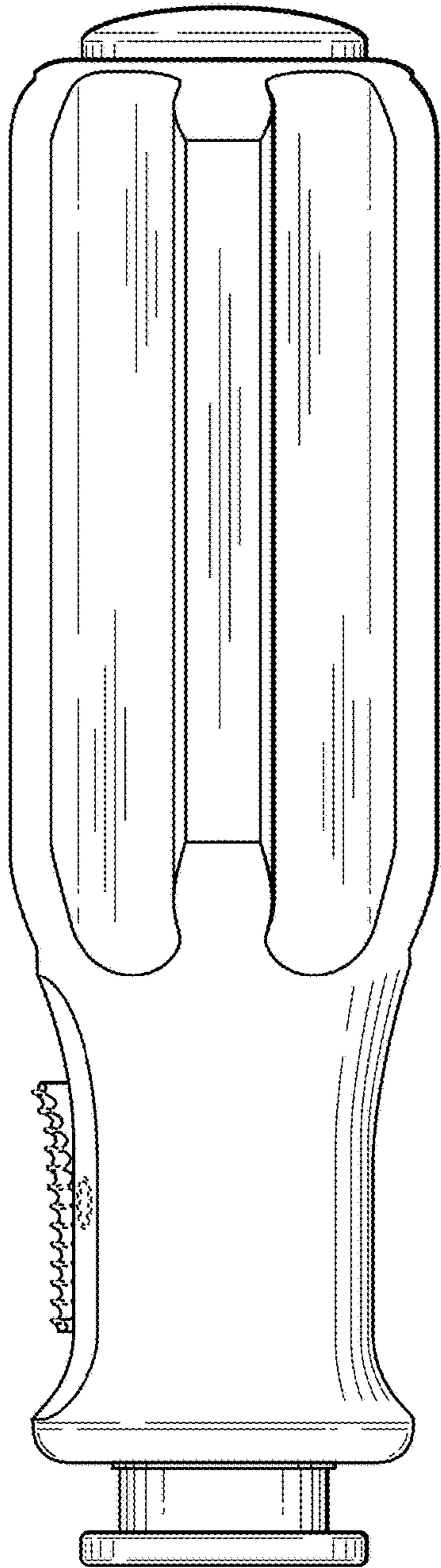

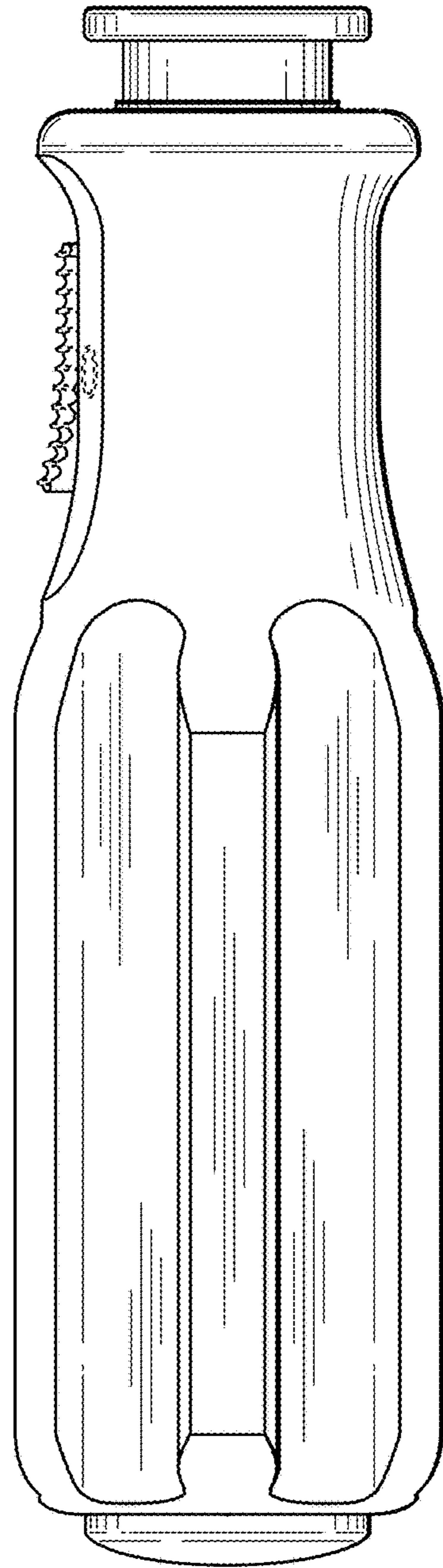
