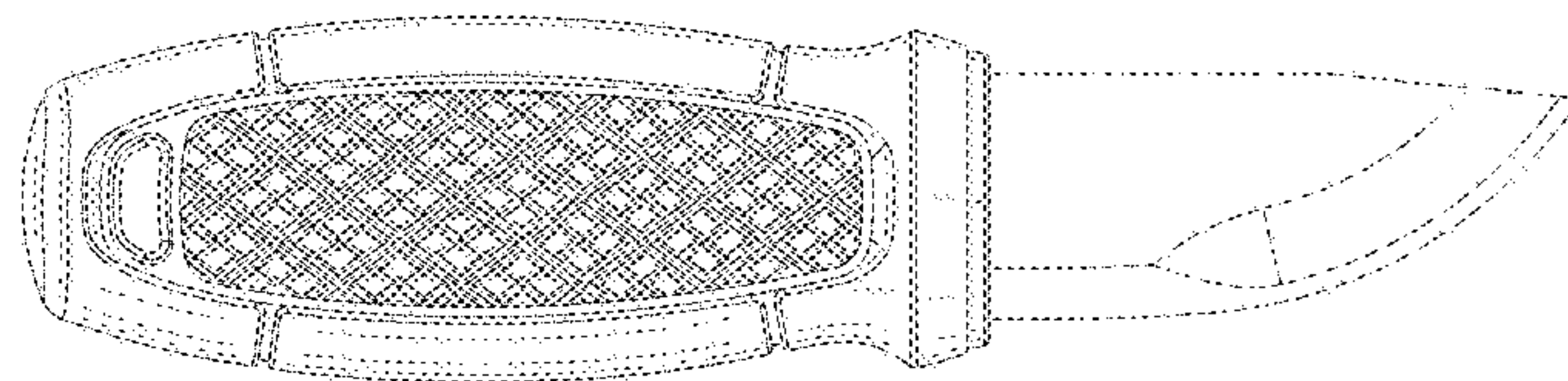
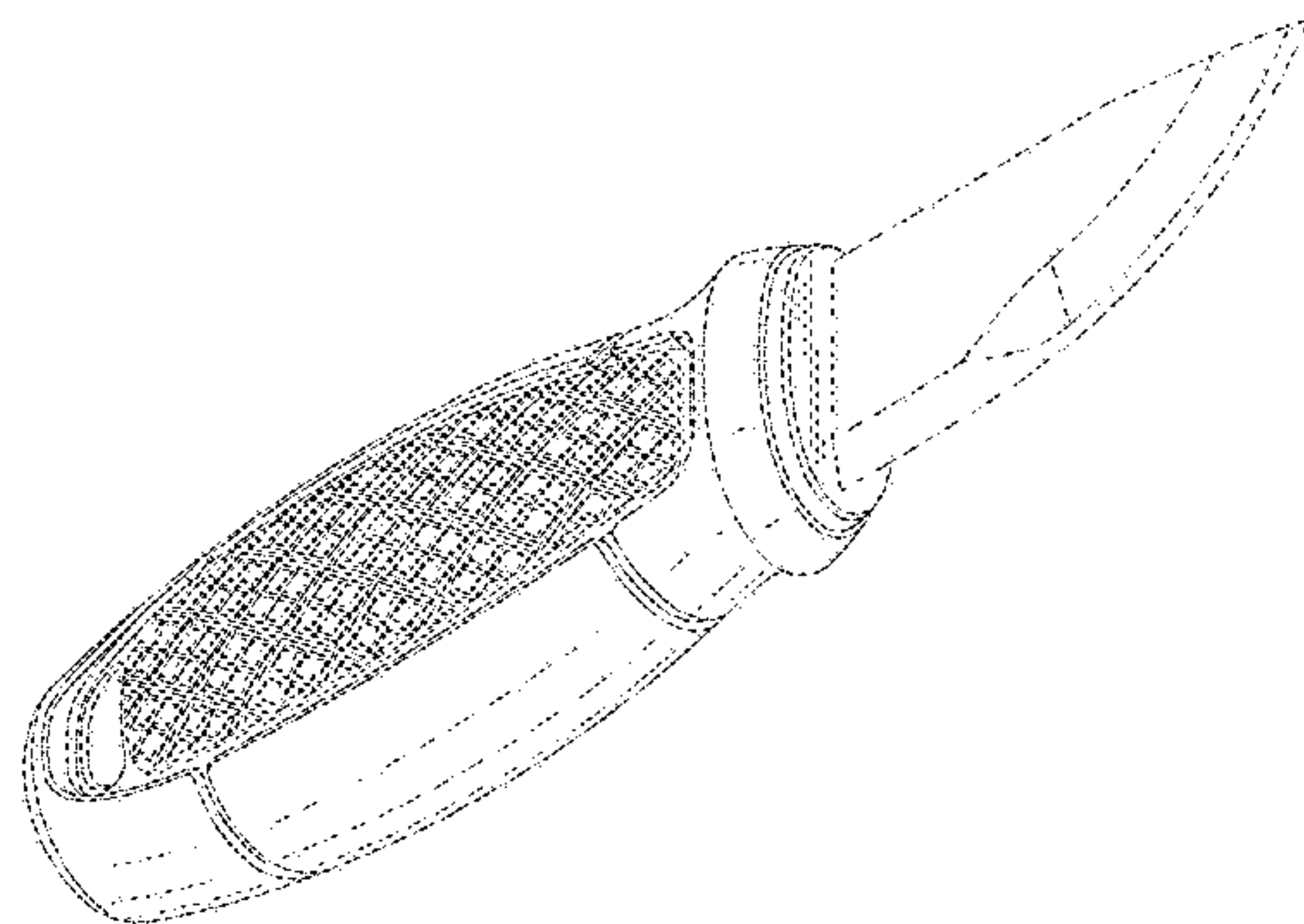
(57) **CLAIM**

The ornamental design for a knife shaft, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of the knife shaft showing our new design;
FIG. 2 is a bottom left side perspective view thereof;
FIG. 3 is a left side elevational view thereof; and,
FIG. 4 is a right side elevational view thereof.
The broken lines in the drawings which define a knife blade form no part of the claimed design.

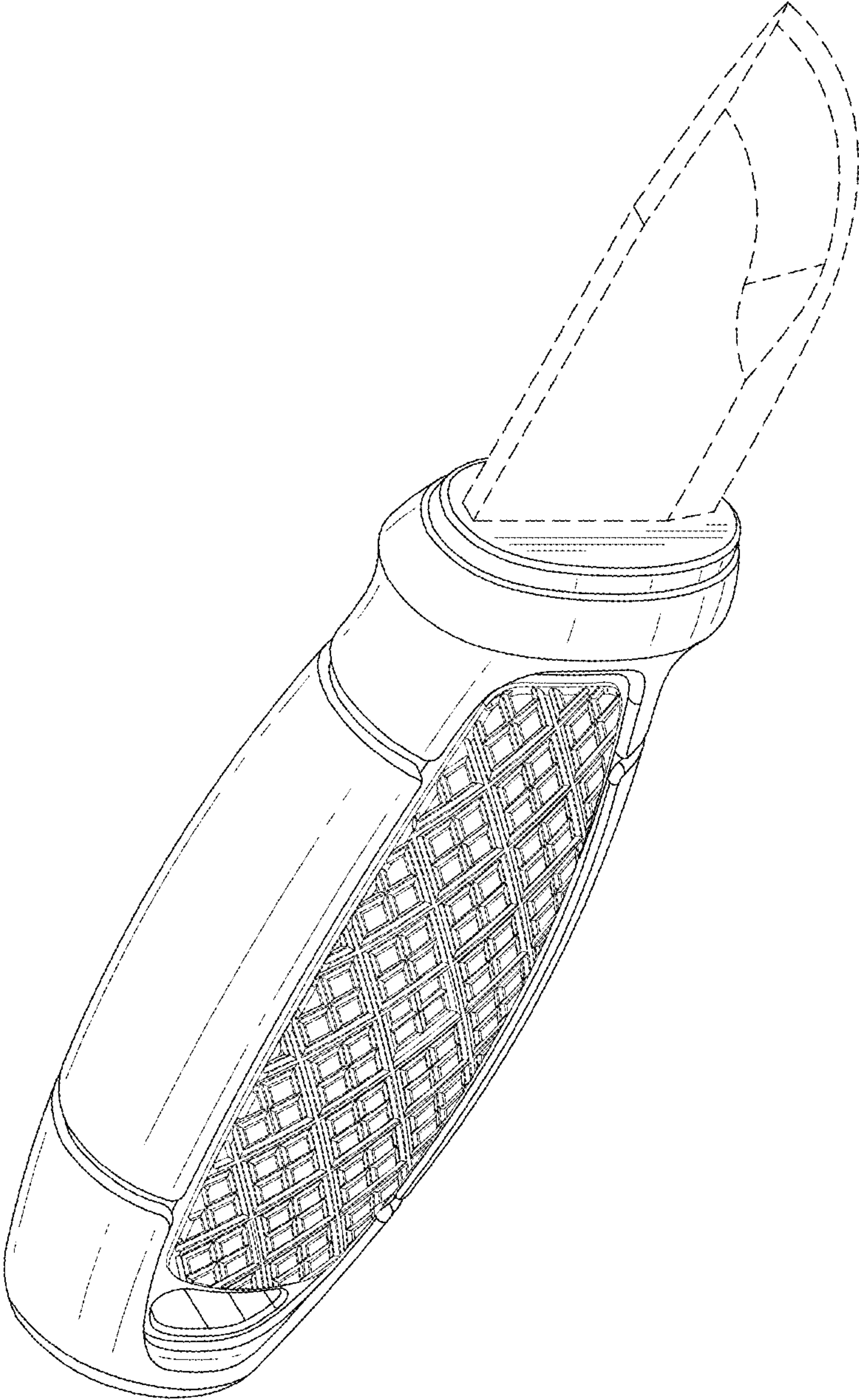

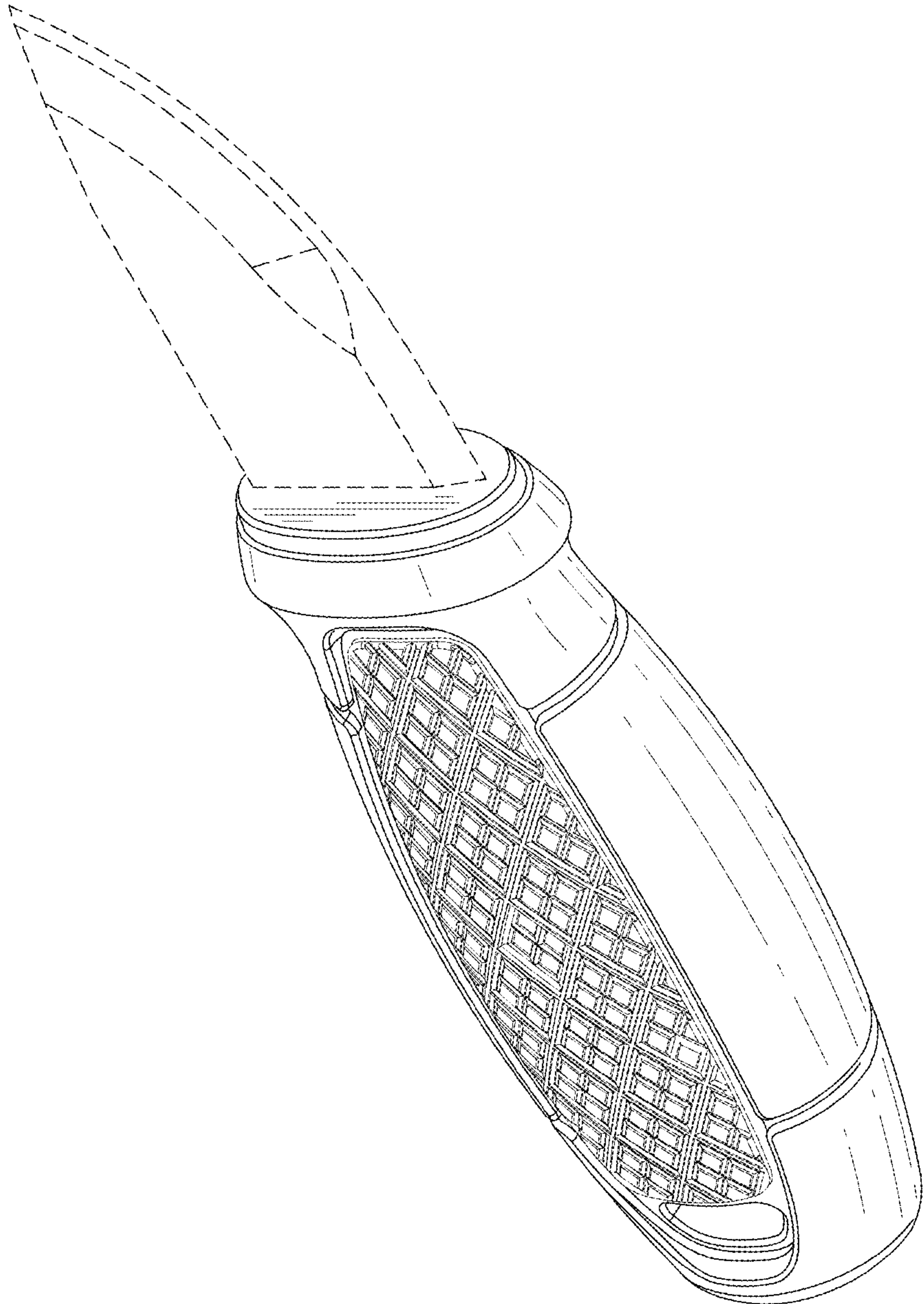

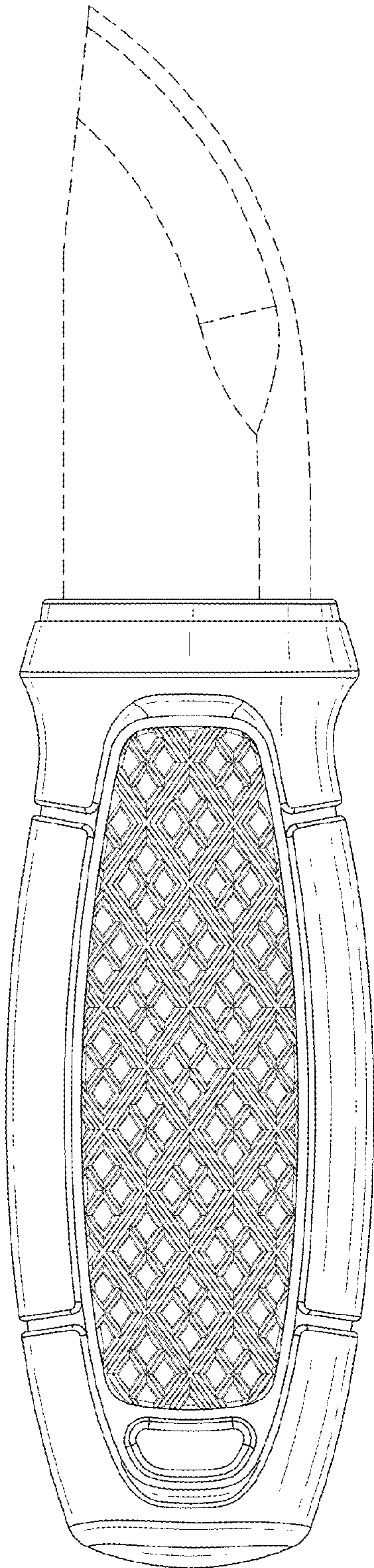

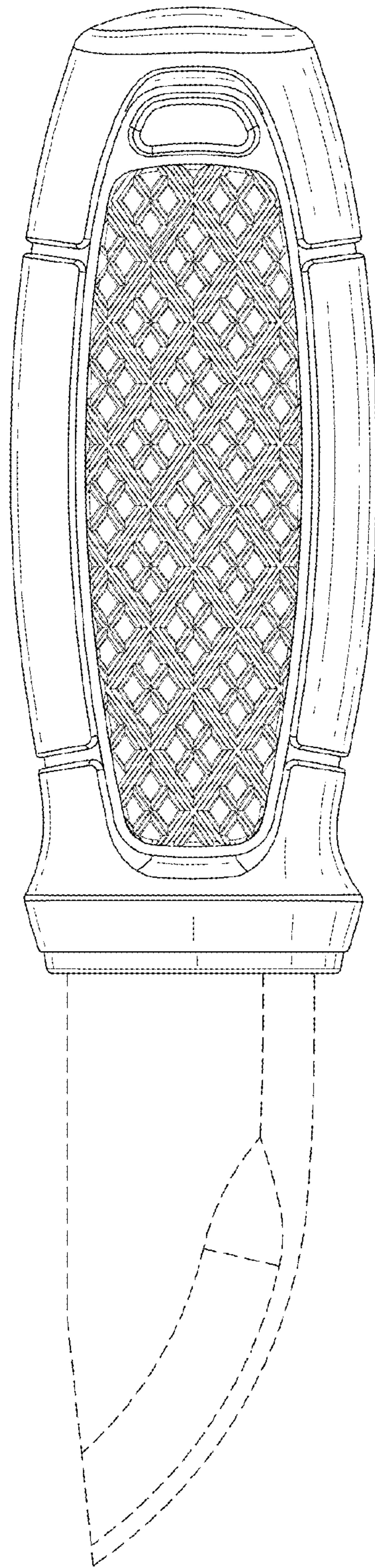
