DESCRIPTION

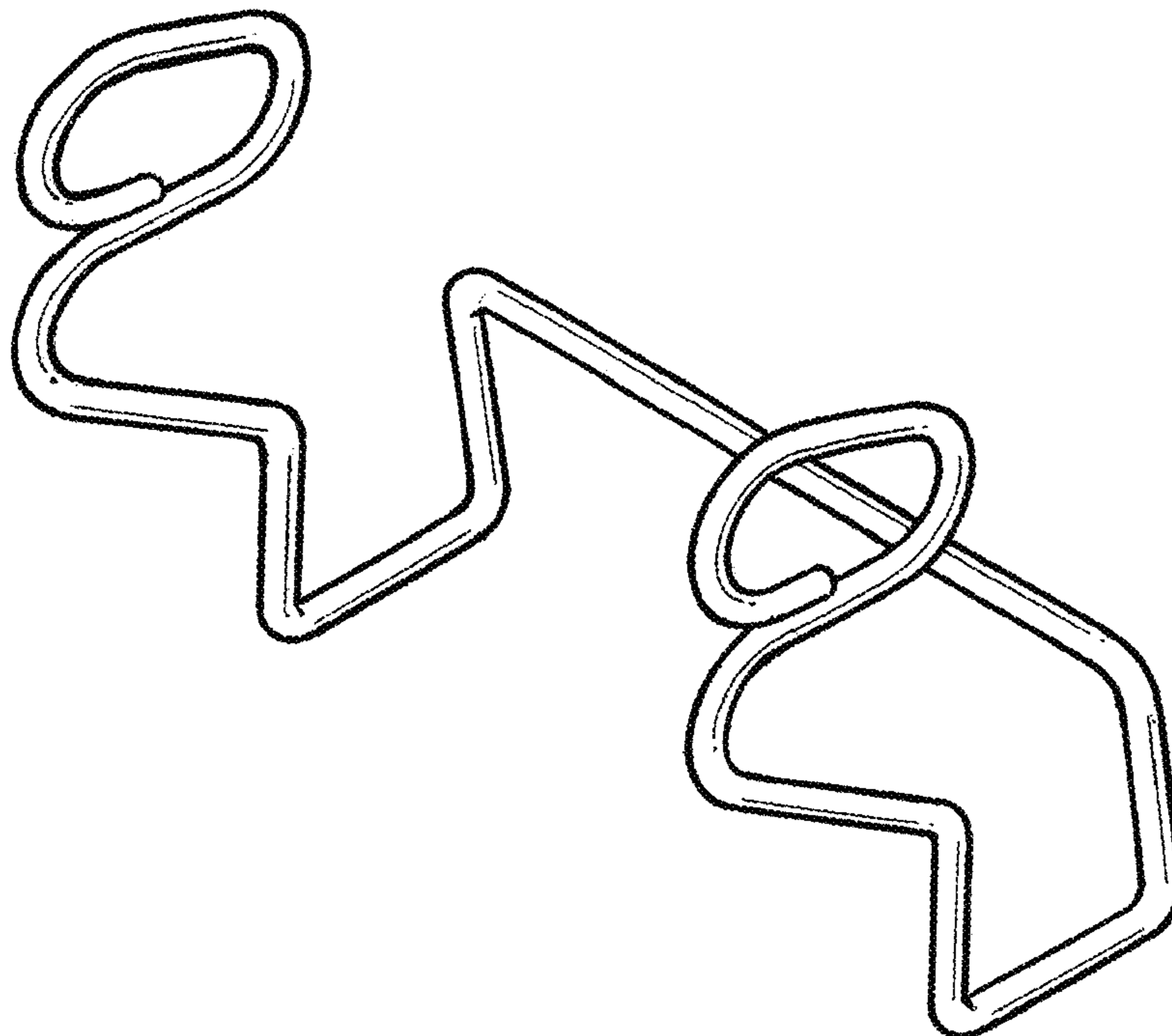
FIG. 1 is a perspective view of a wire management clip according to the design;

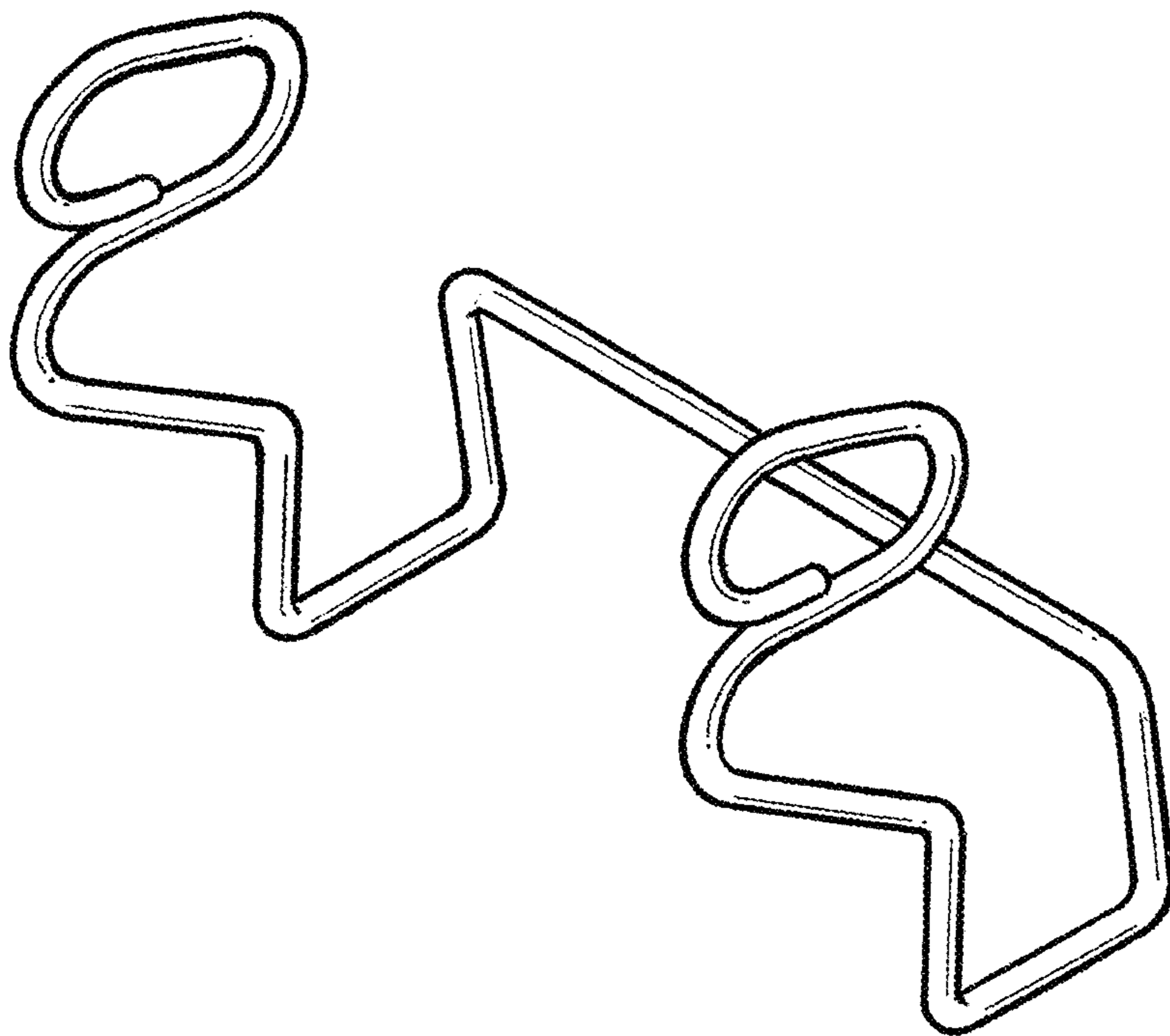

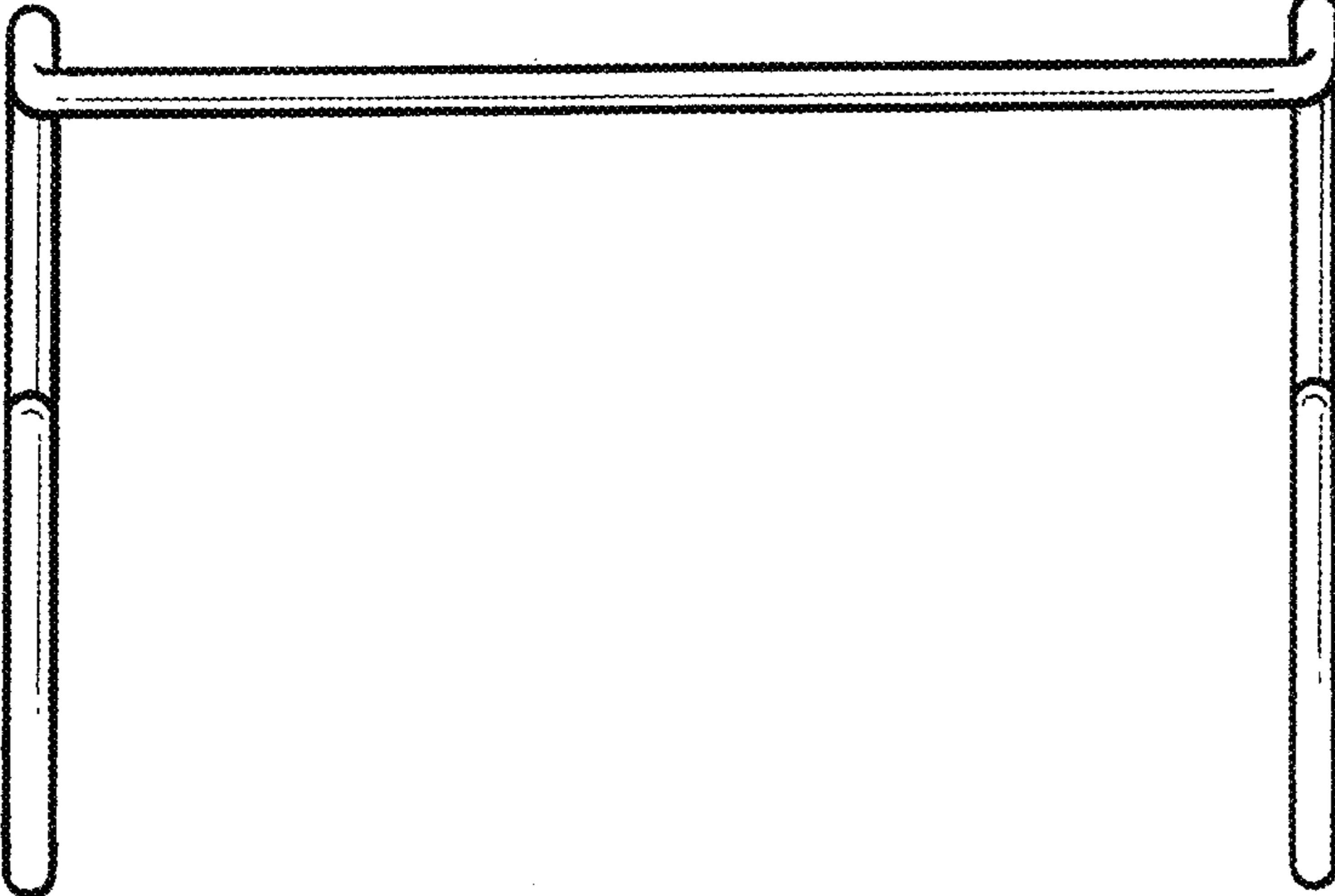

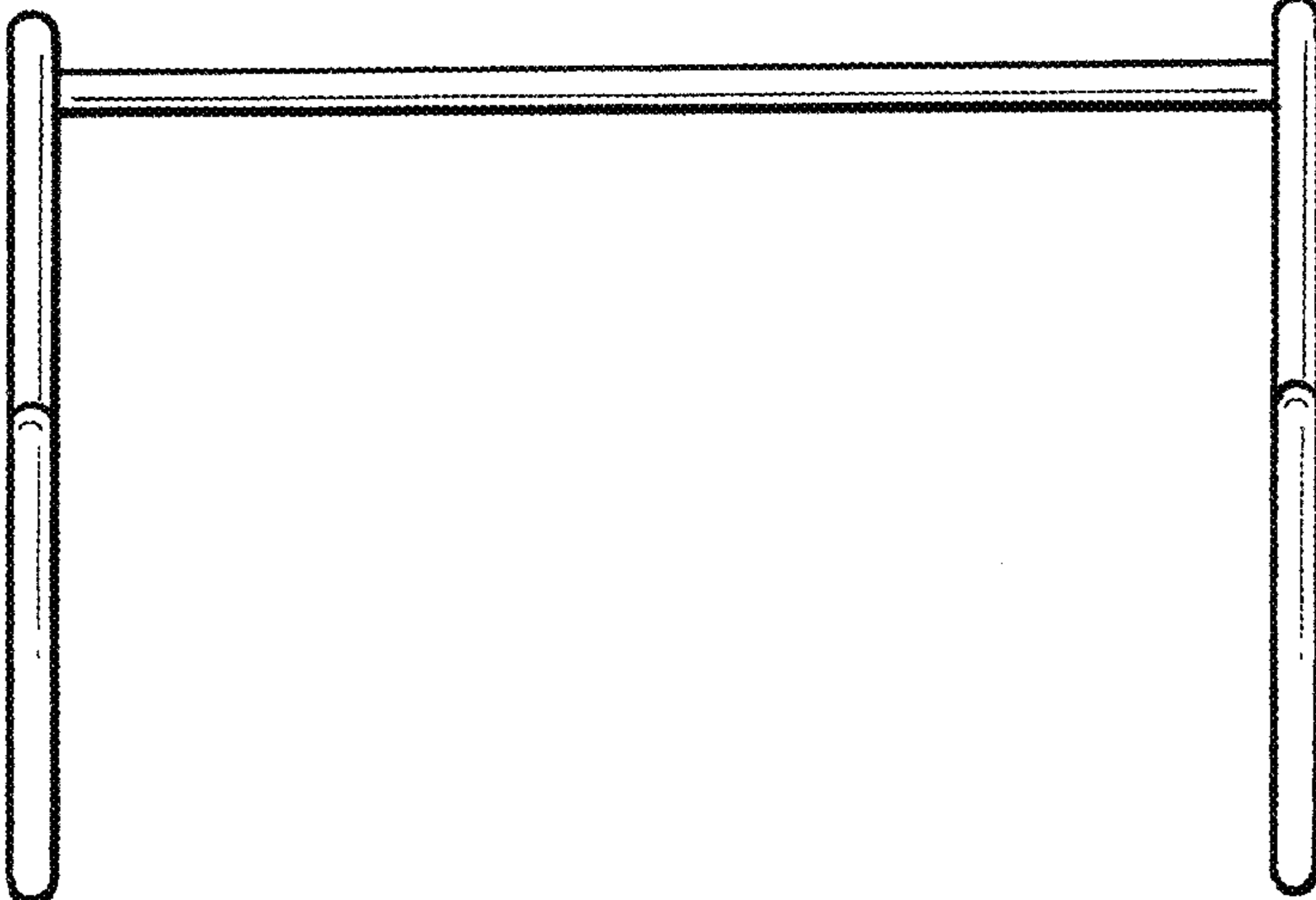

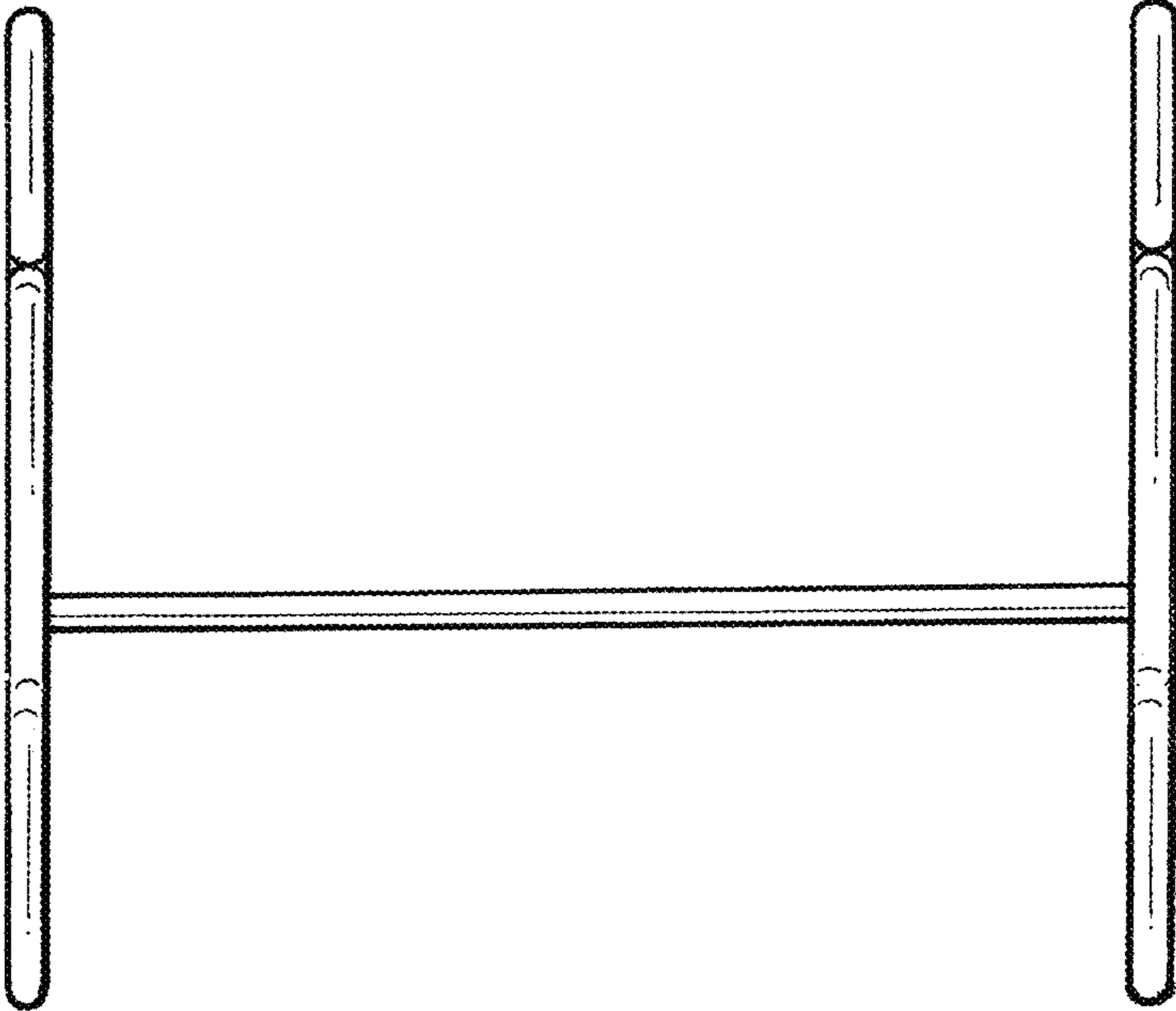

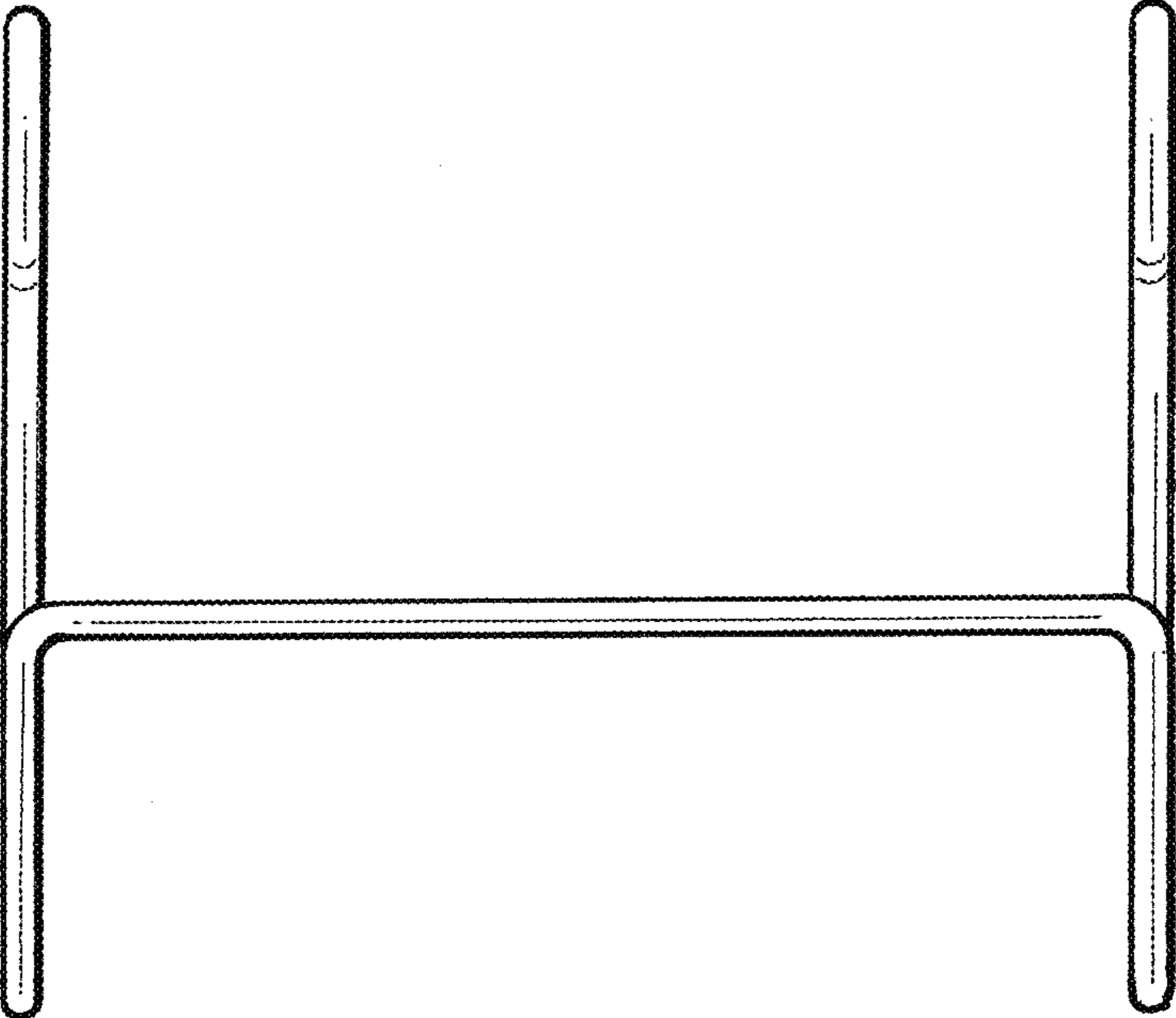

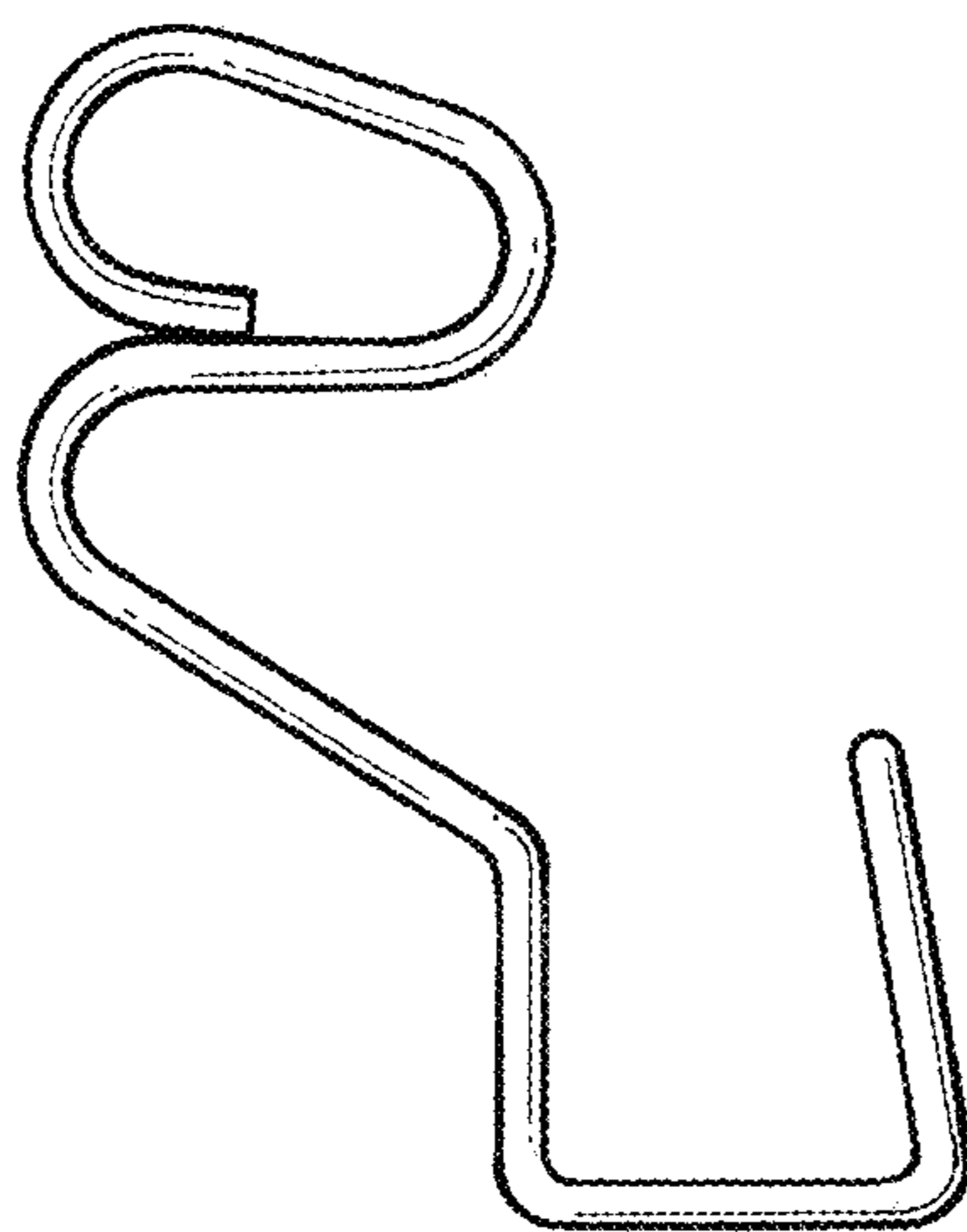

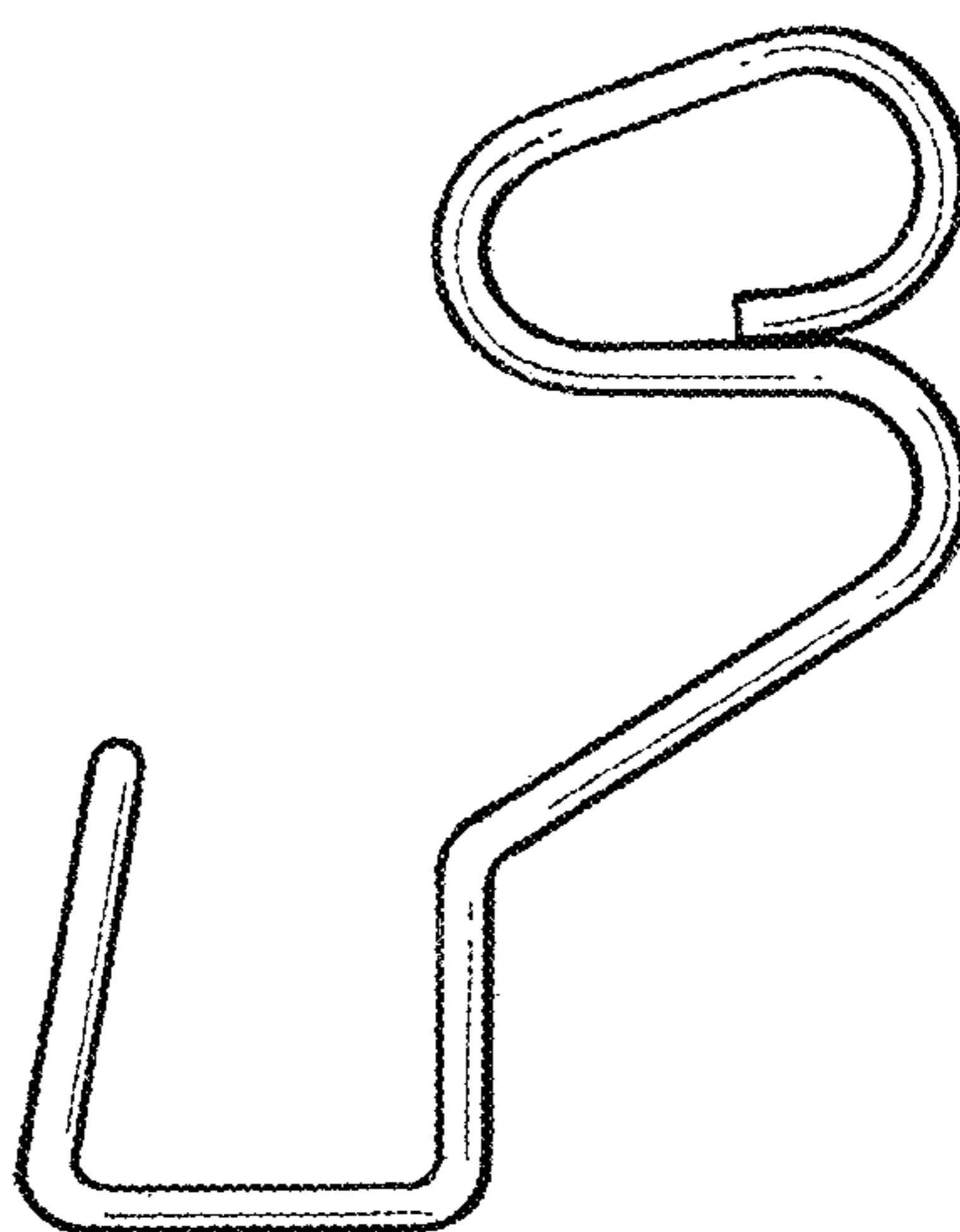
