(57) **CLAIM**

The ornamental design for a container with decorative label, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front from the left side of the container with decorative label showing my new design;

FIG. 2 is a second perspective view of the front from the right side thereof,

FIG. 3 is a front side elevation view thereof;

FIG. 4 is a back side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a left side elevation view thereof;

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

The dot-dash line in FIGS. 1-3, 5 and 6 represent the boundaries of the claim and form no part of the claimed design.

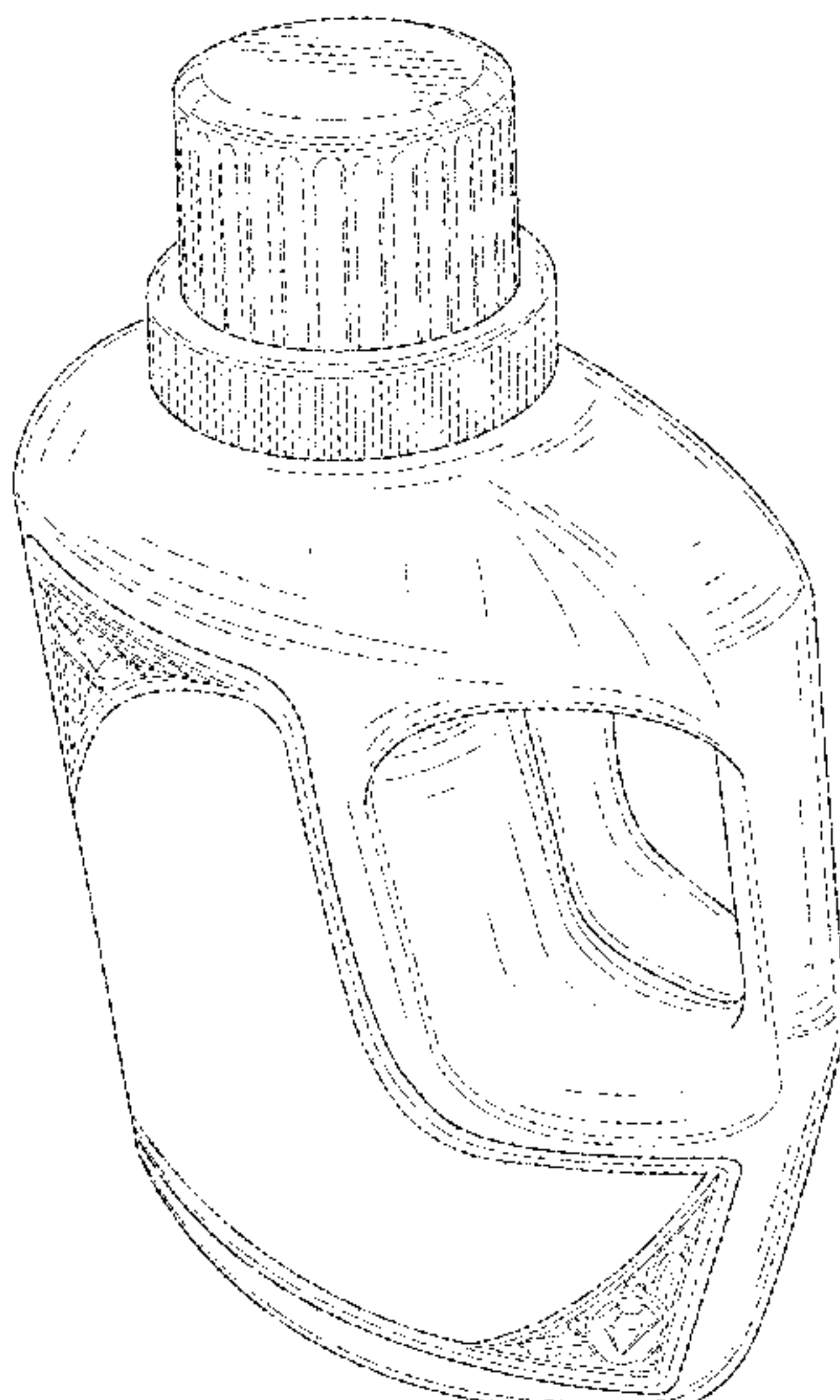

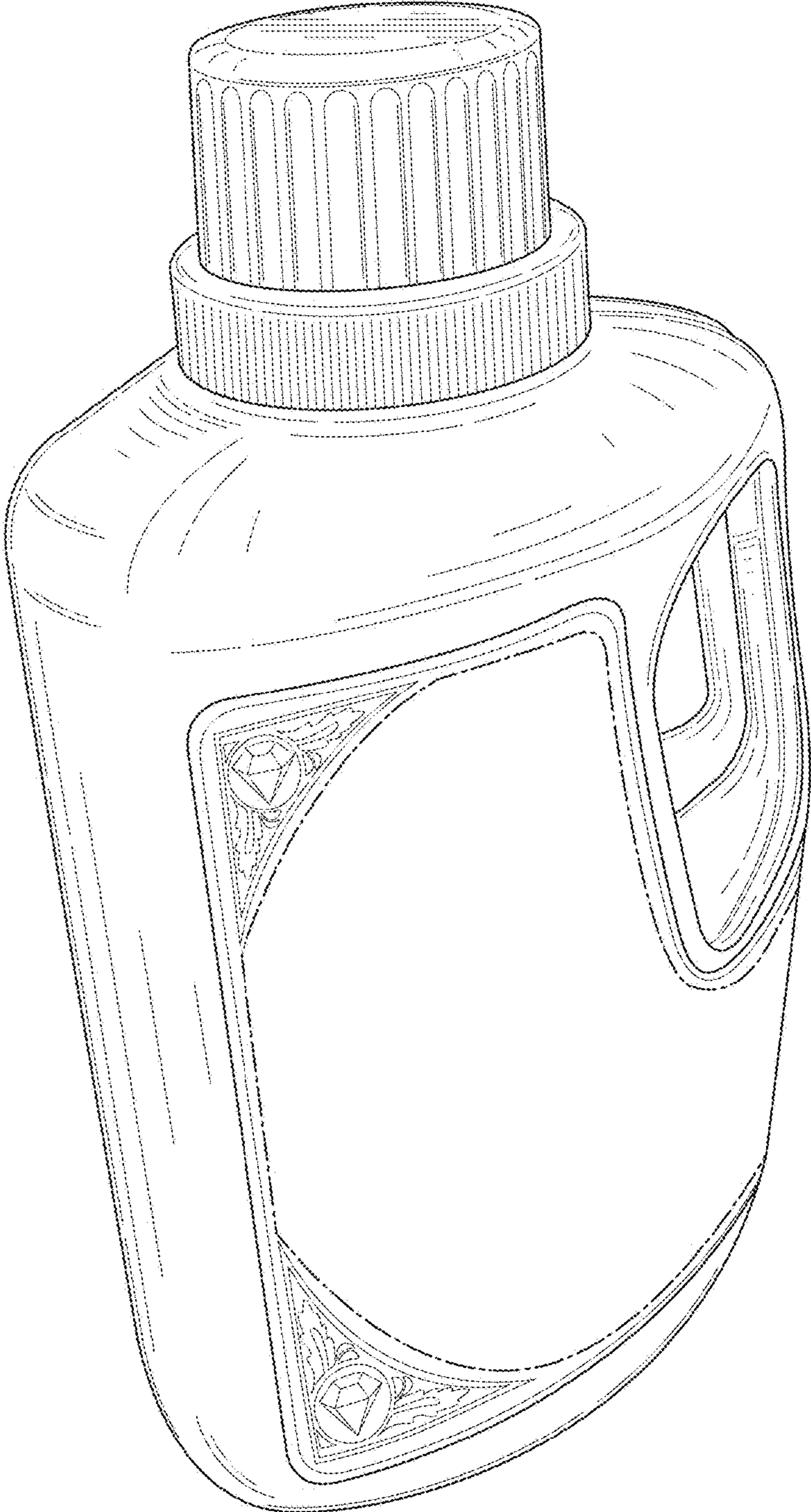

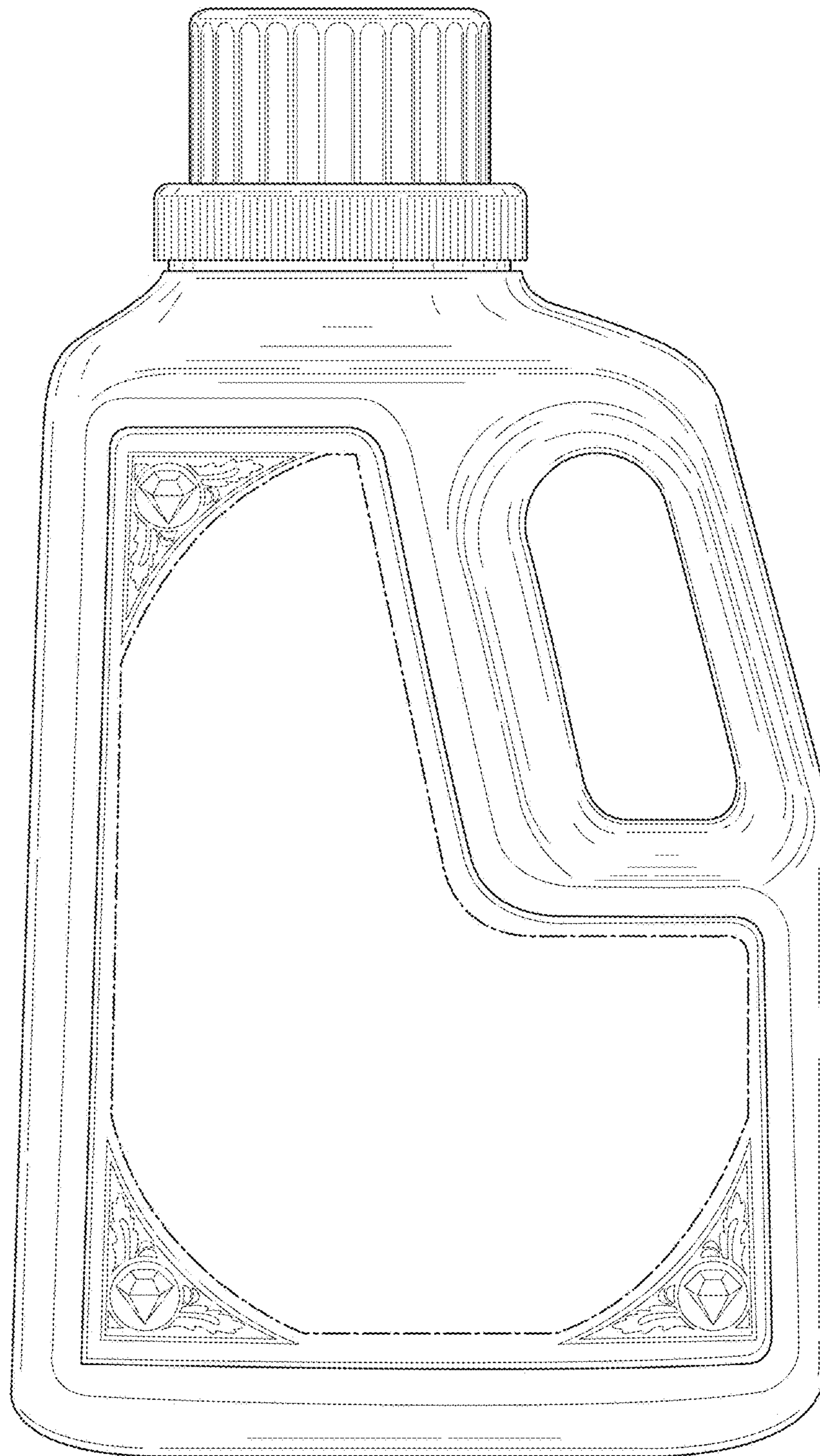

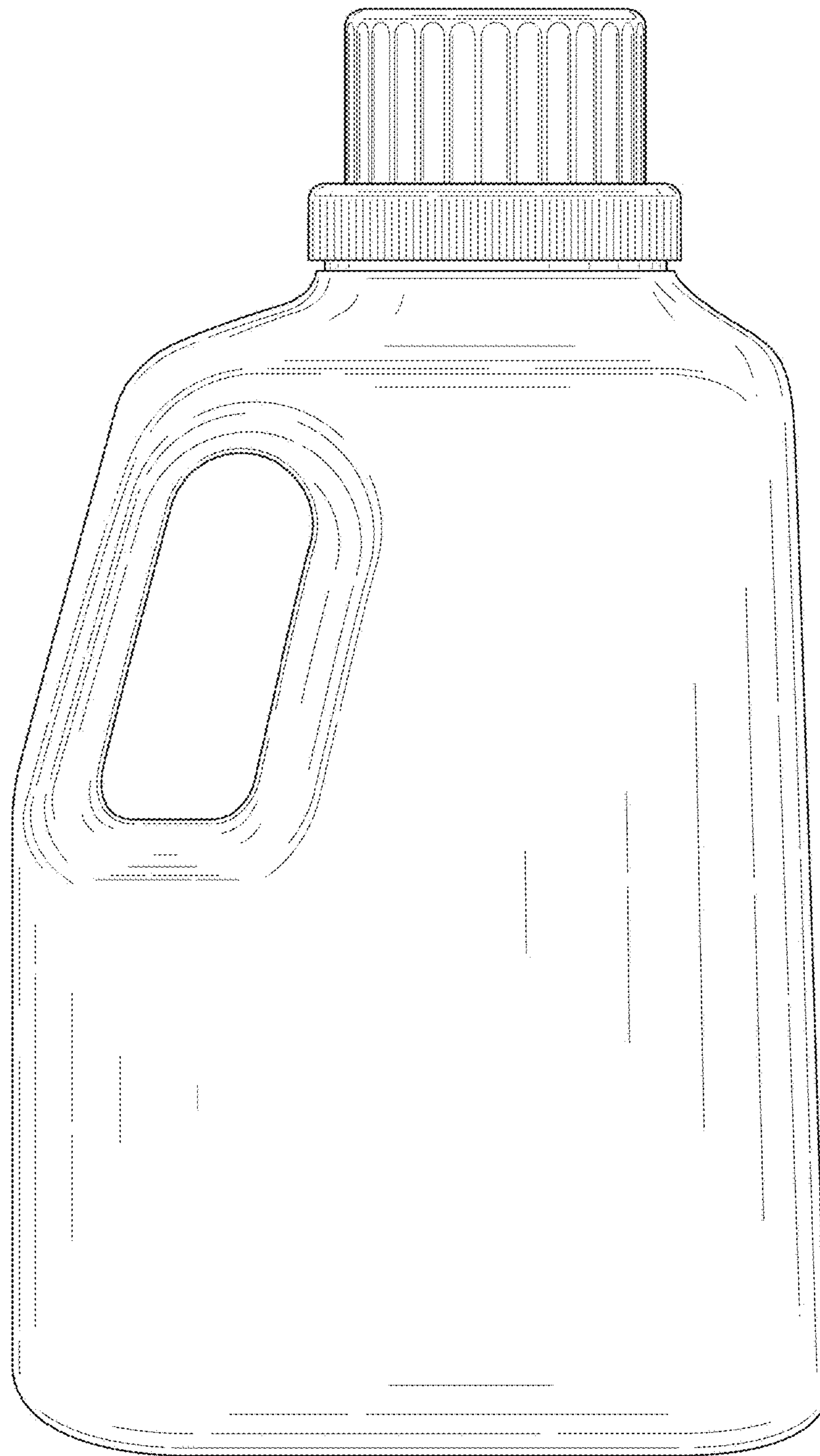

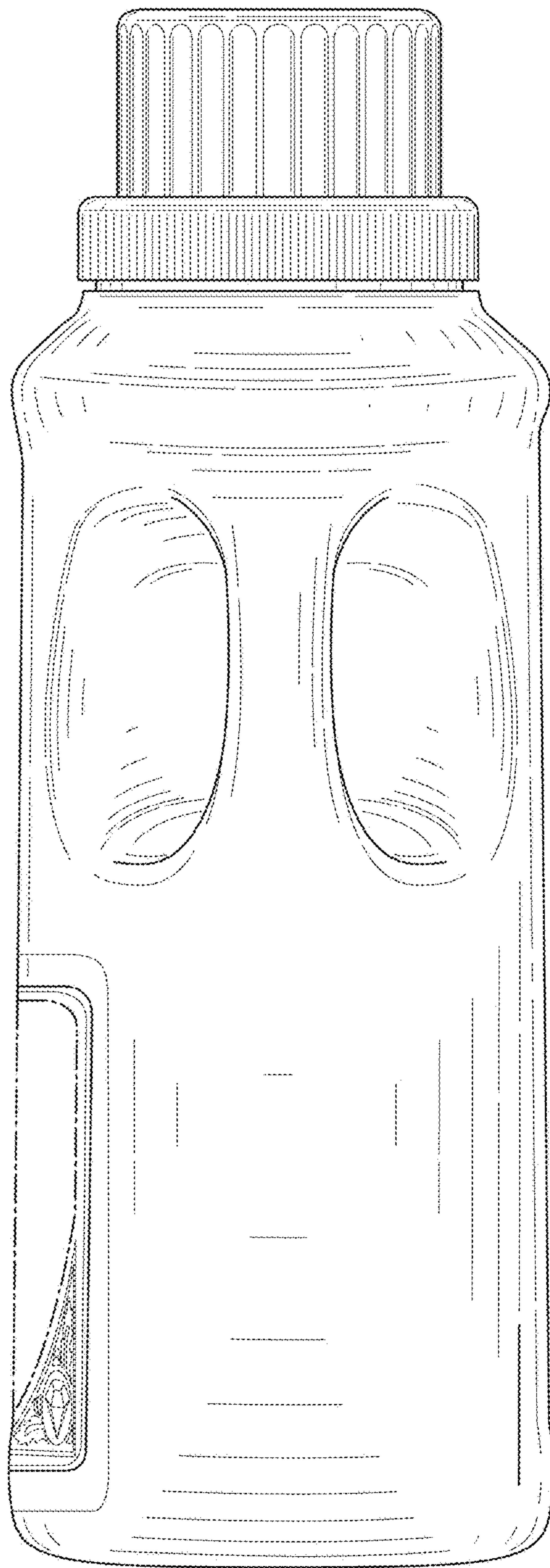

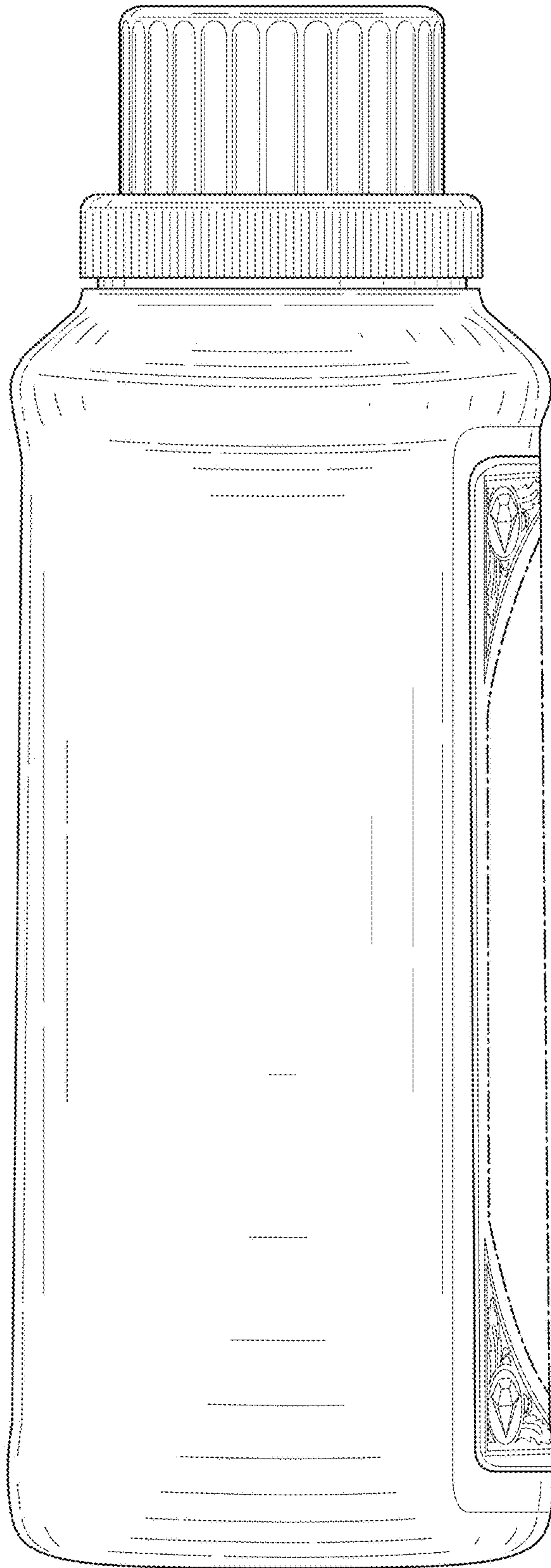

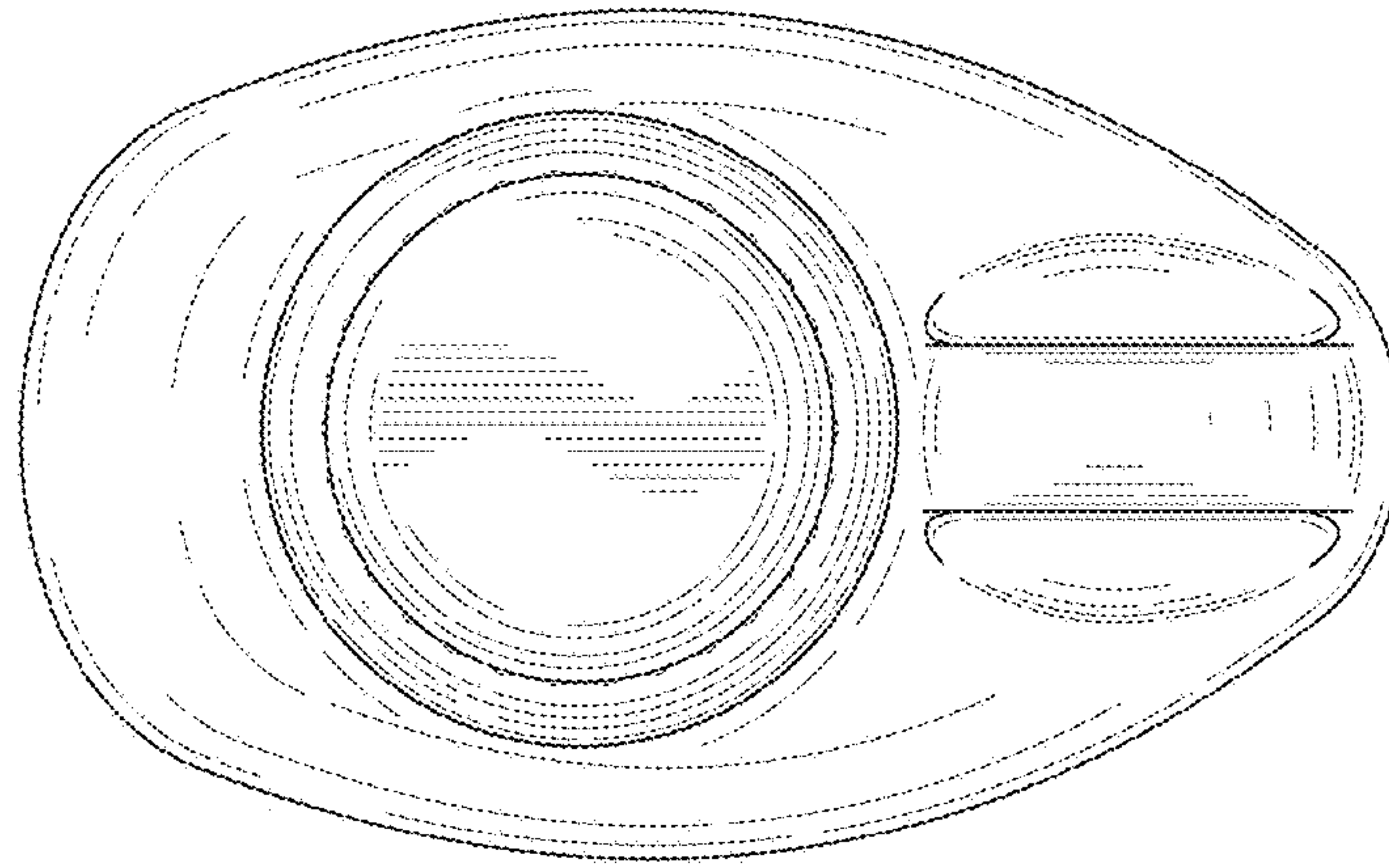

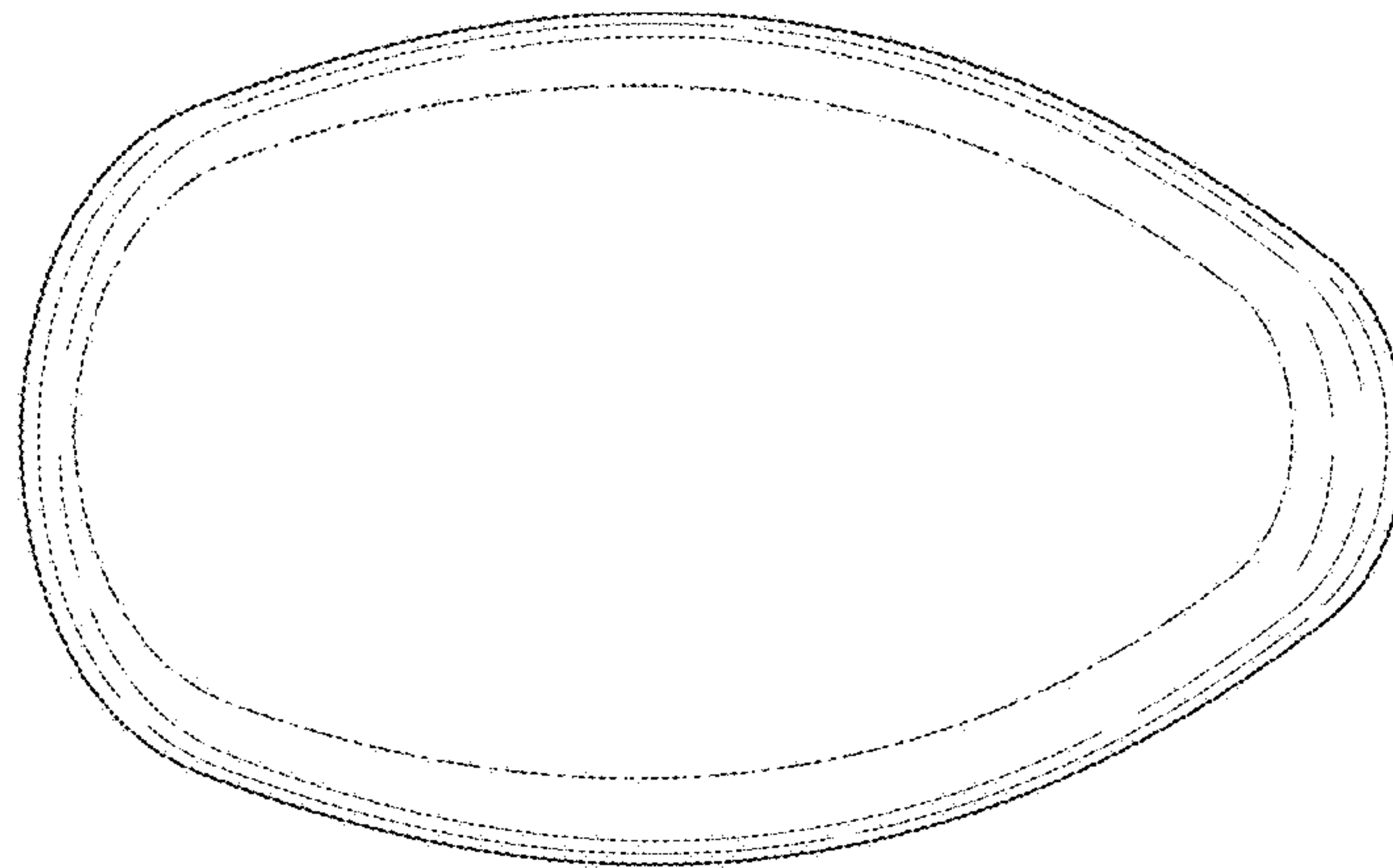
