FIG. 8 is a rear perspective view of the packing box of FIG. 1.

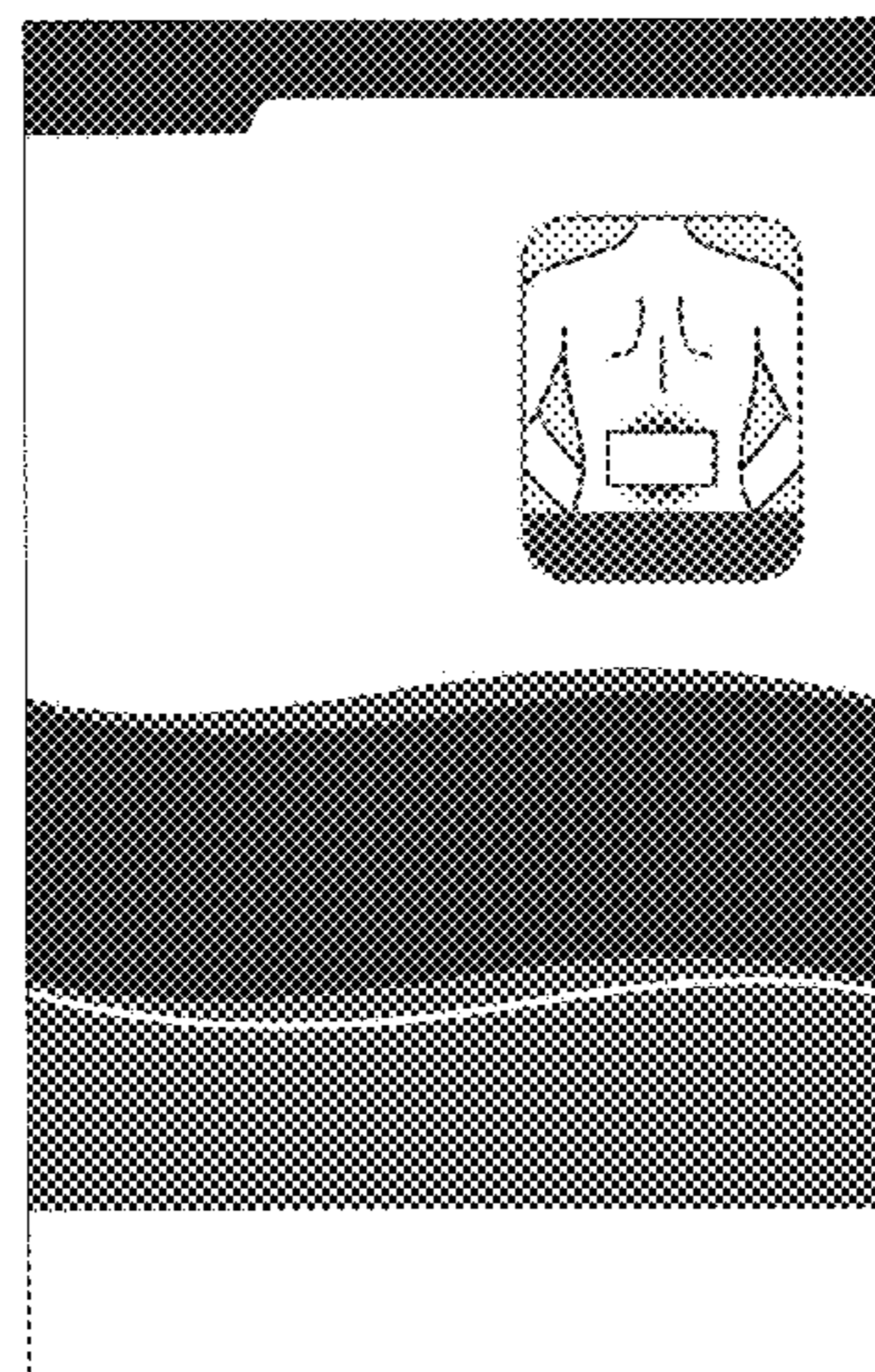

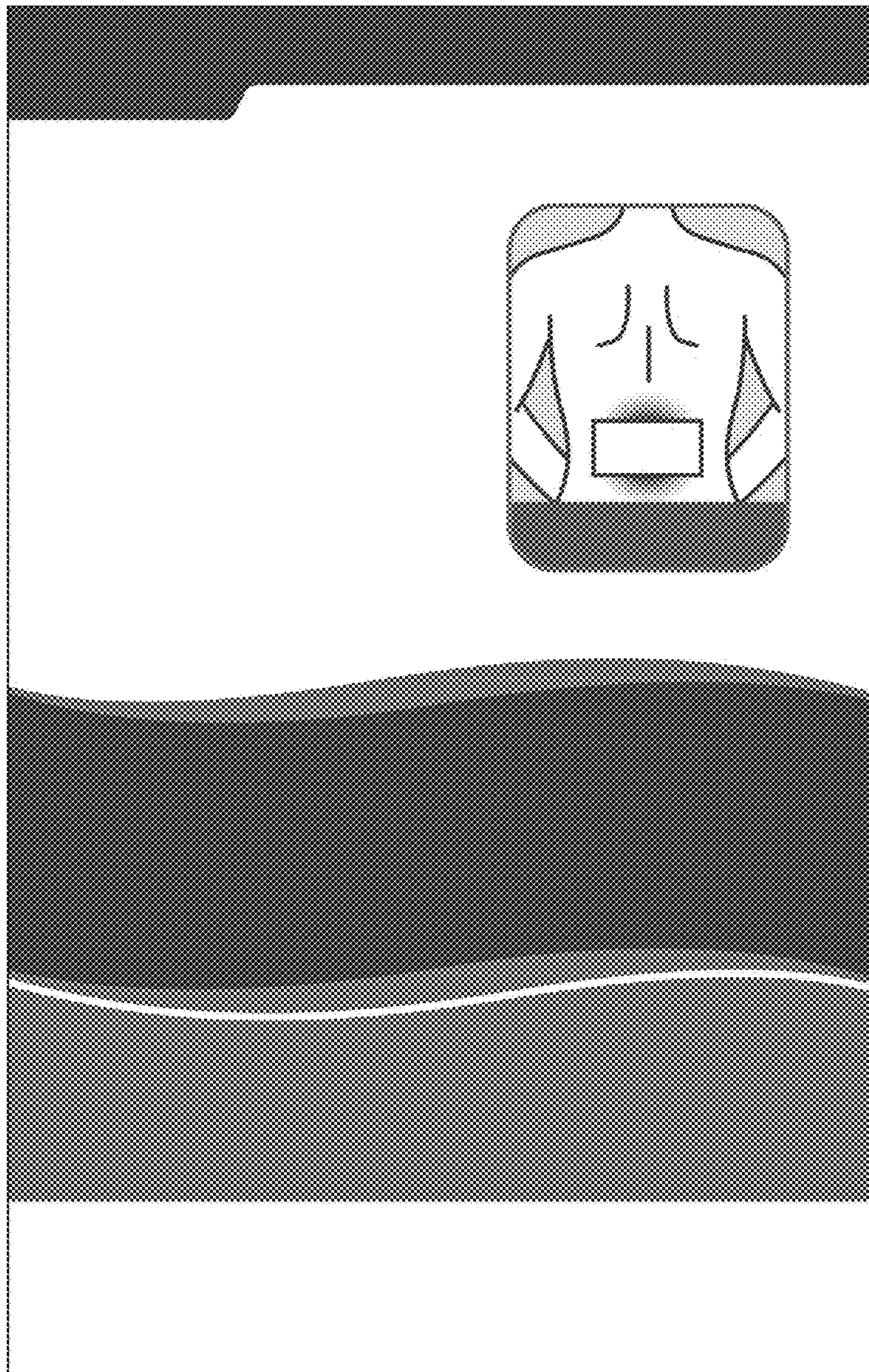

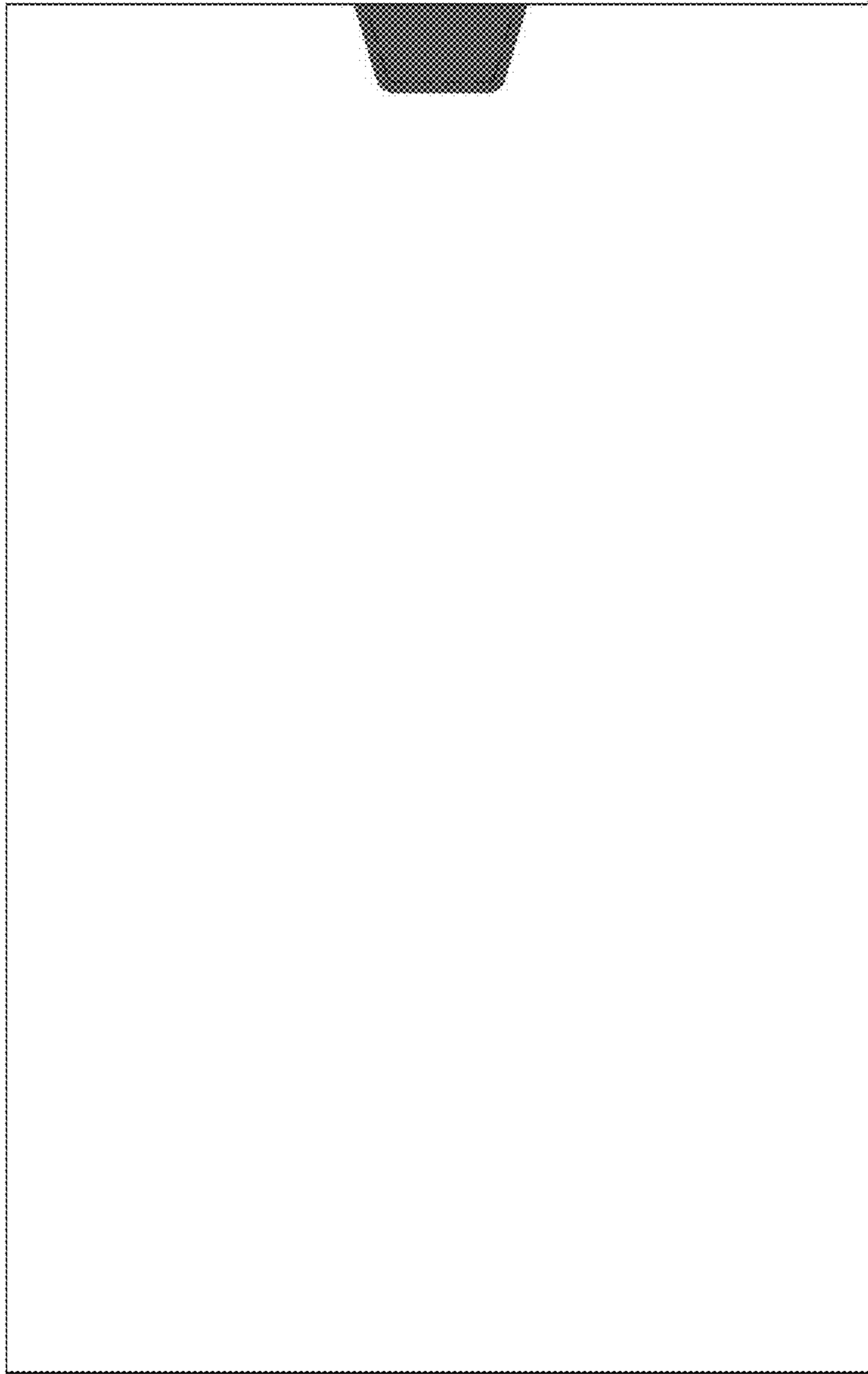

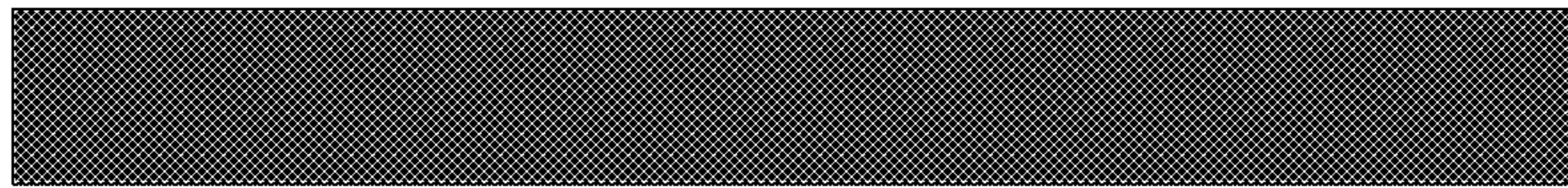

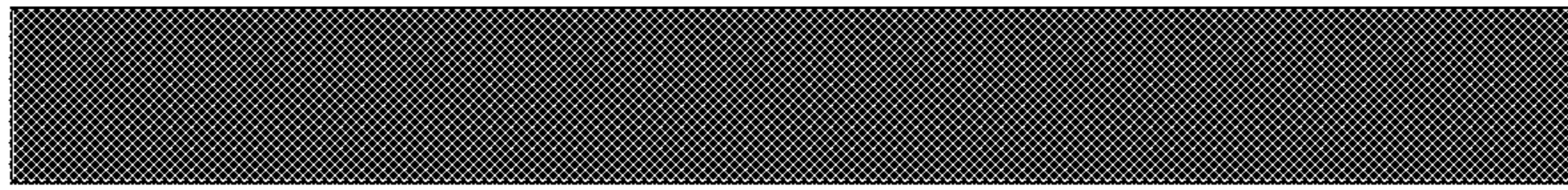

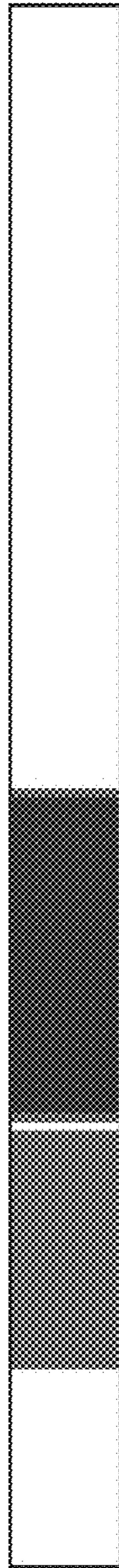

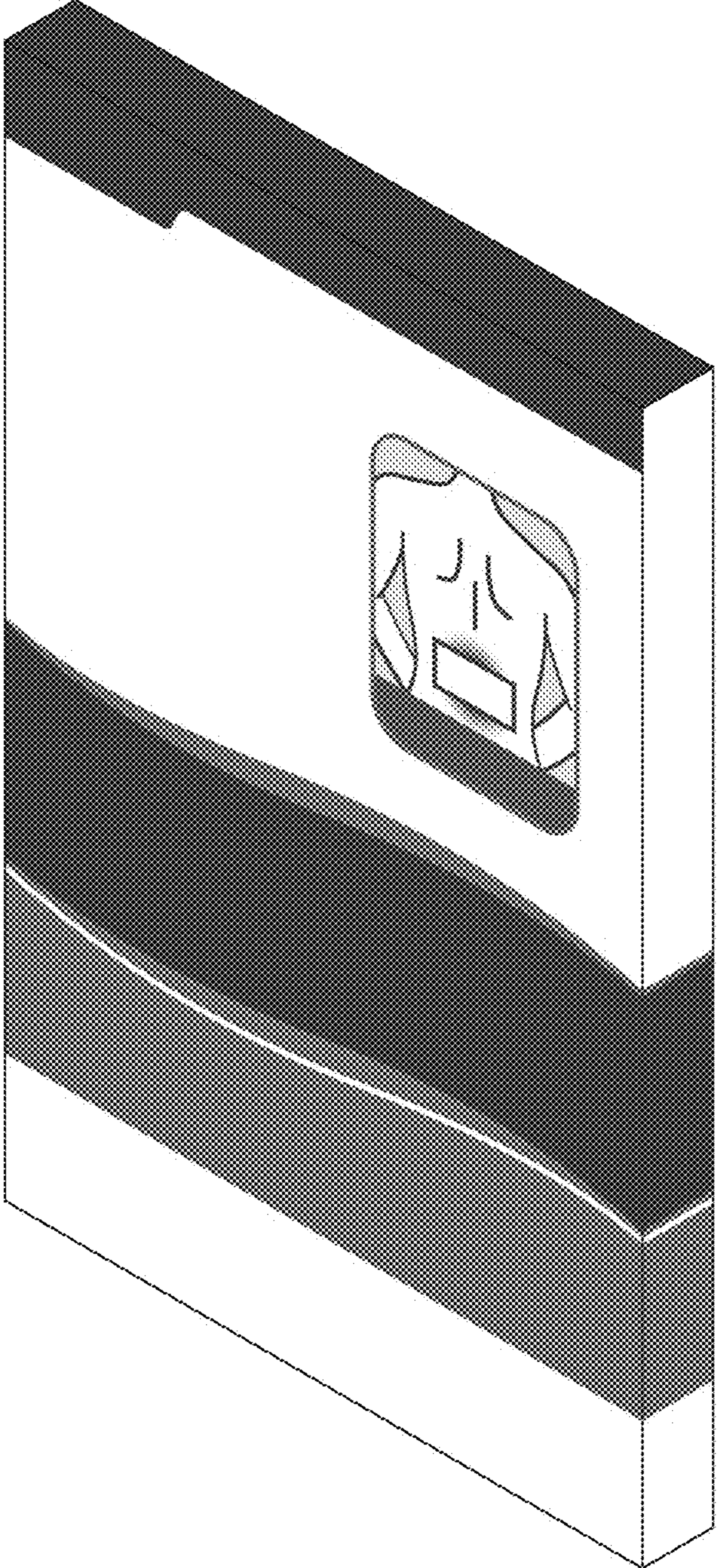

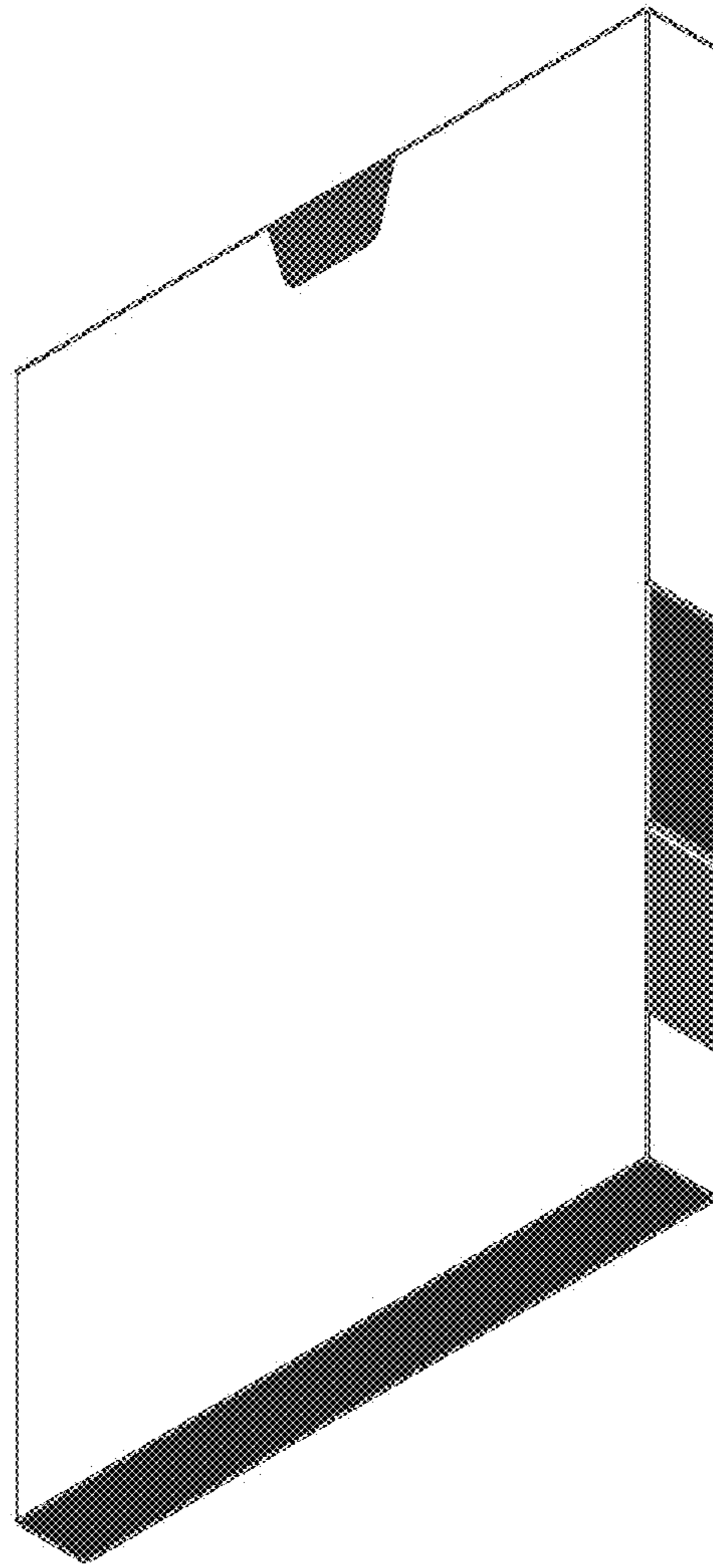
