(57) **CLAIM**

The ornamental design for a wearable sensor attachment apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a wearable sensor attachment apparatus showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a bottom perspective view thereof. The dashed broken lines in FIGS. 7 and 8 represent unclaimed portions of the wearable sensor attachment apparatus and form no part of the claimed design.
















