The ornamental design for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a right, front perspective view of a front end of an automobile showing our new design;
FIG. 2 is a left, rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a top view thereof.

The rhombus-shaped designs on the front grill and the rear door of the automobile are registered trademarks of Borgward Trademark Holdings GmbH and form no part of the claimed design.

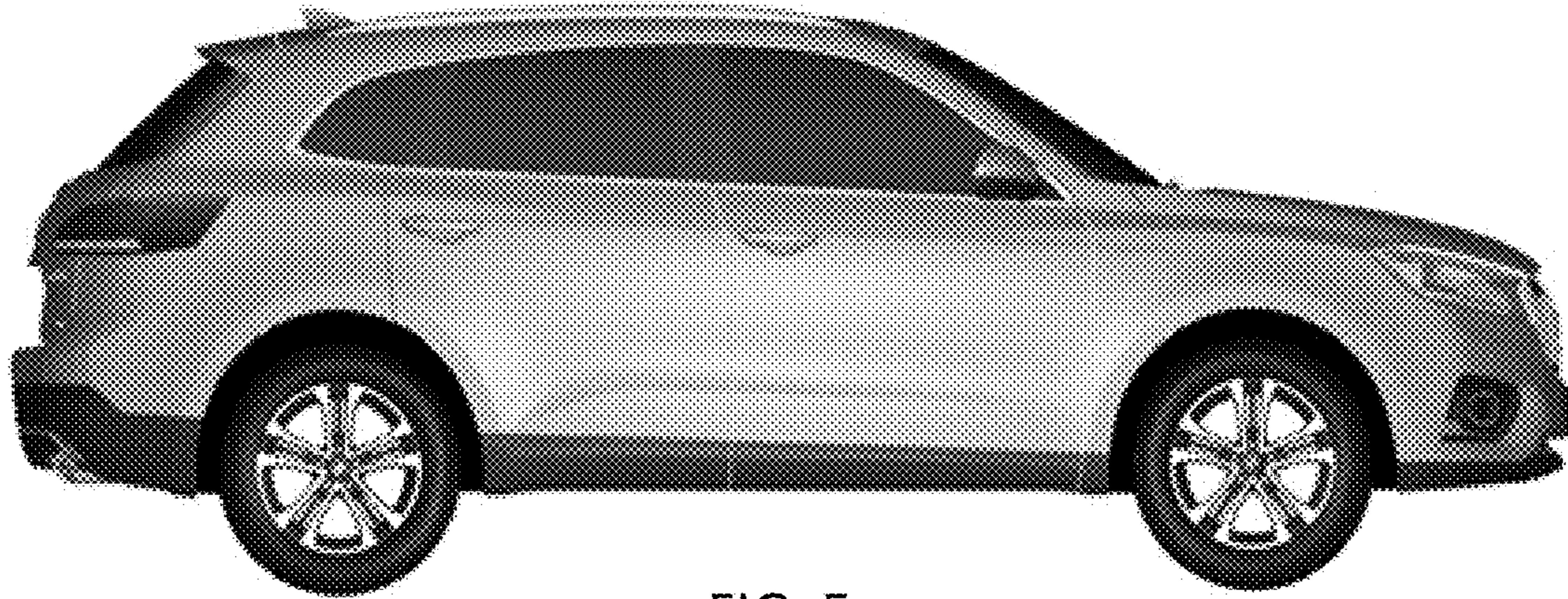

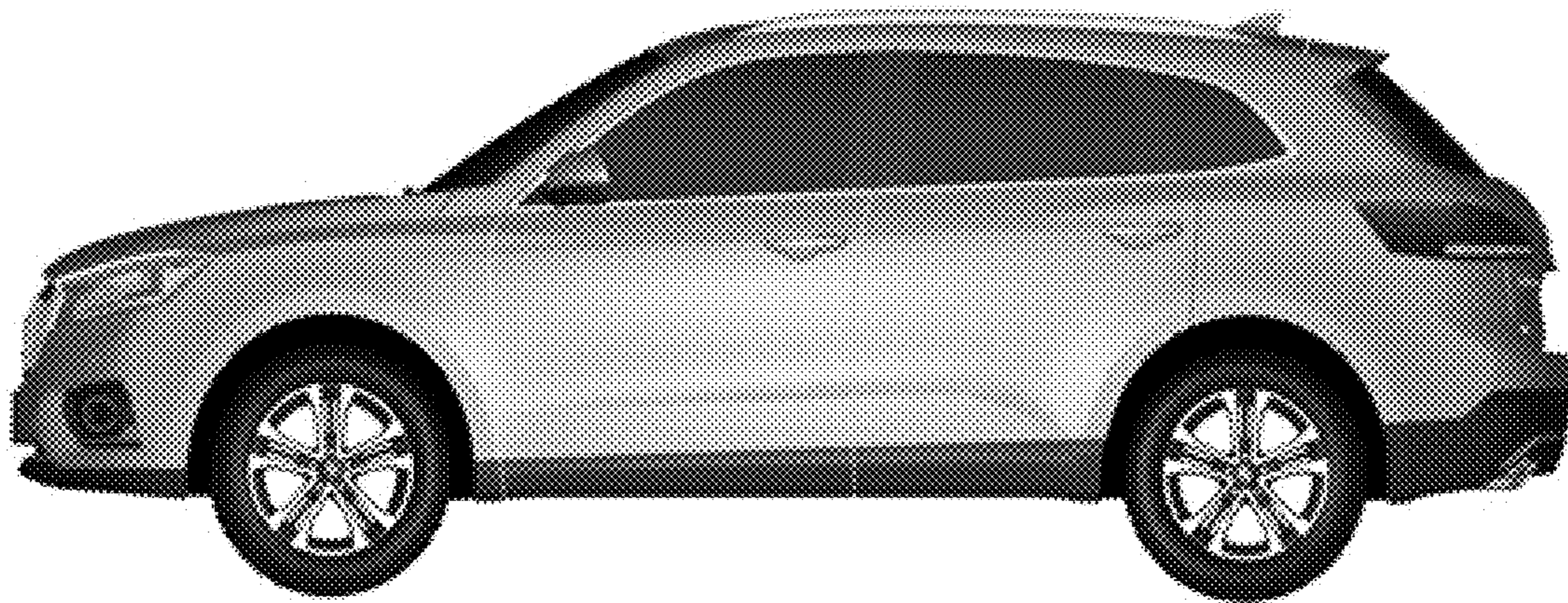
