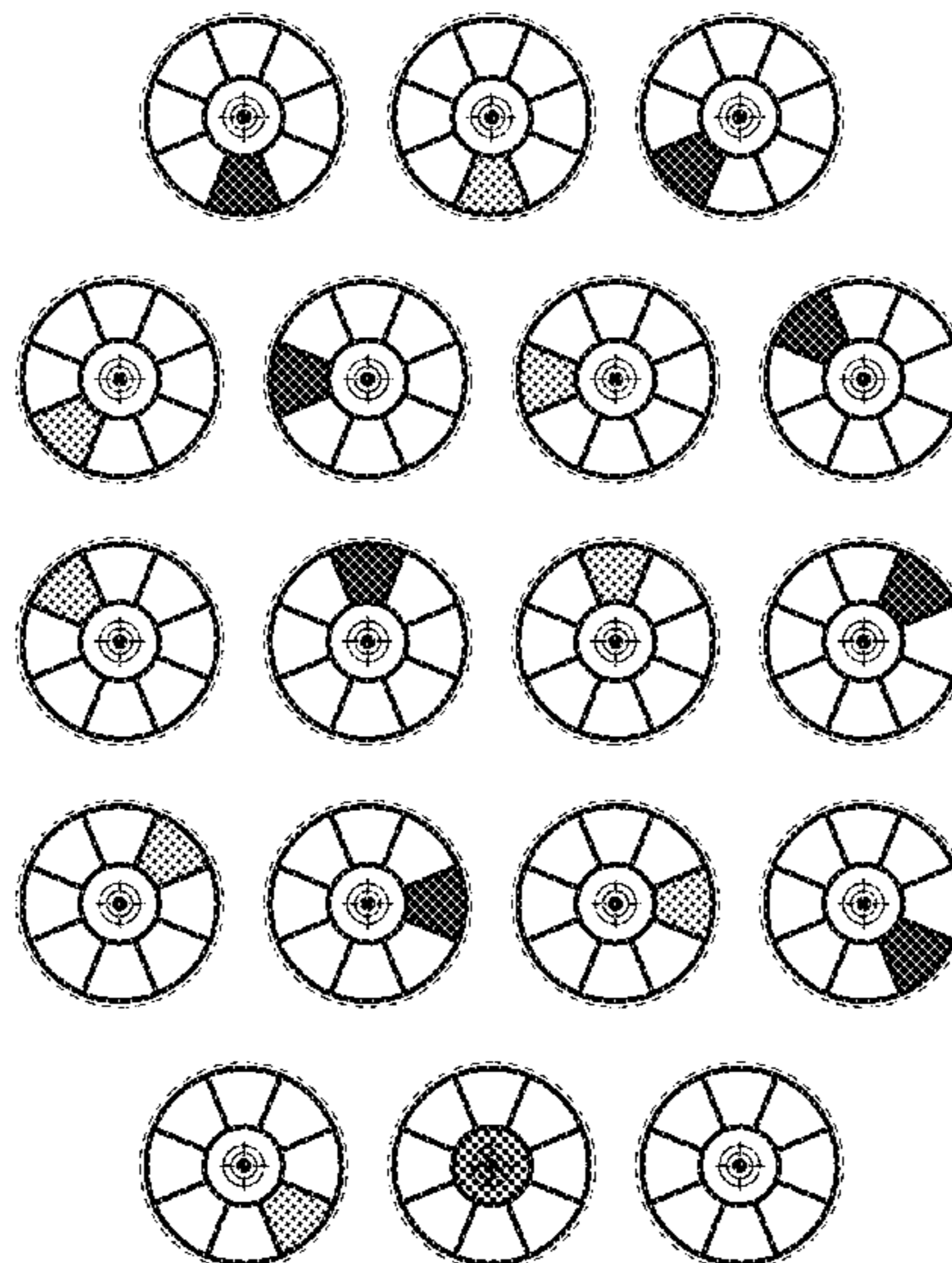
The ornamental design for a display screen or portion thereof with set of icons, as shown and described.
