FIG. 14 is the sixth image thereof;

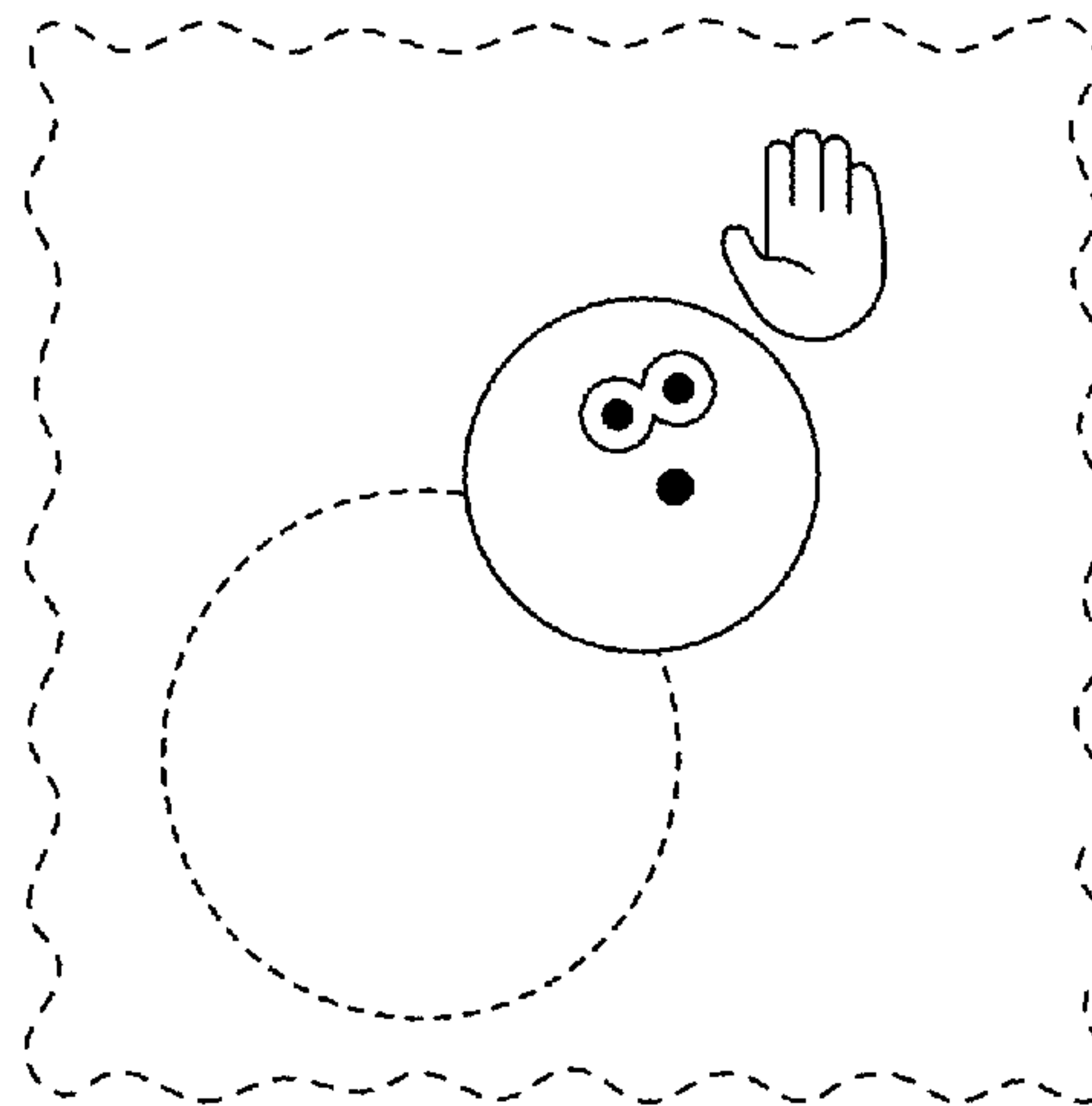
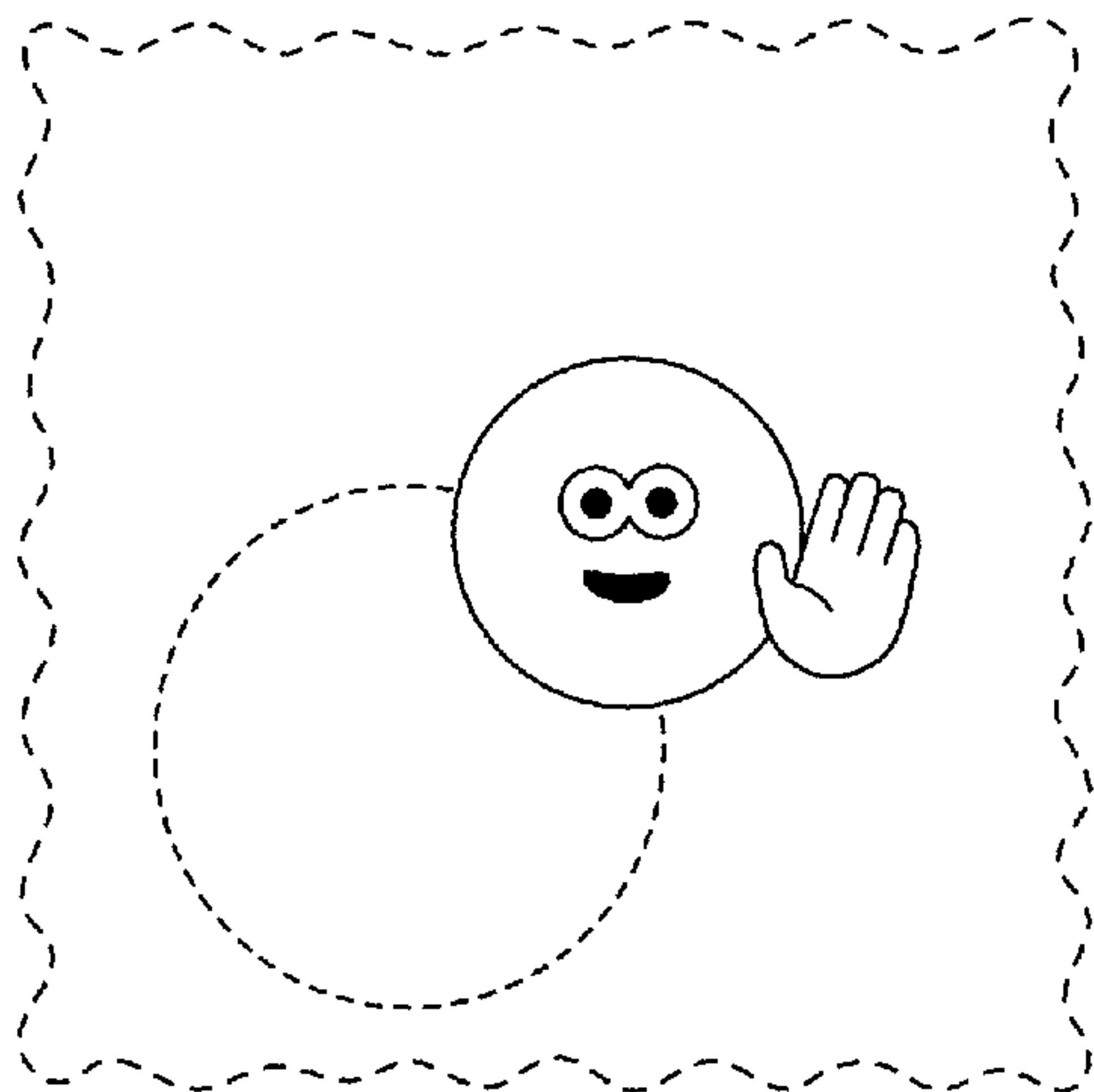
FIG. 15 is the seventh image thereof; and,

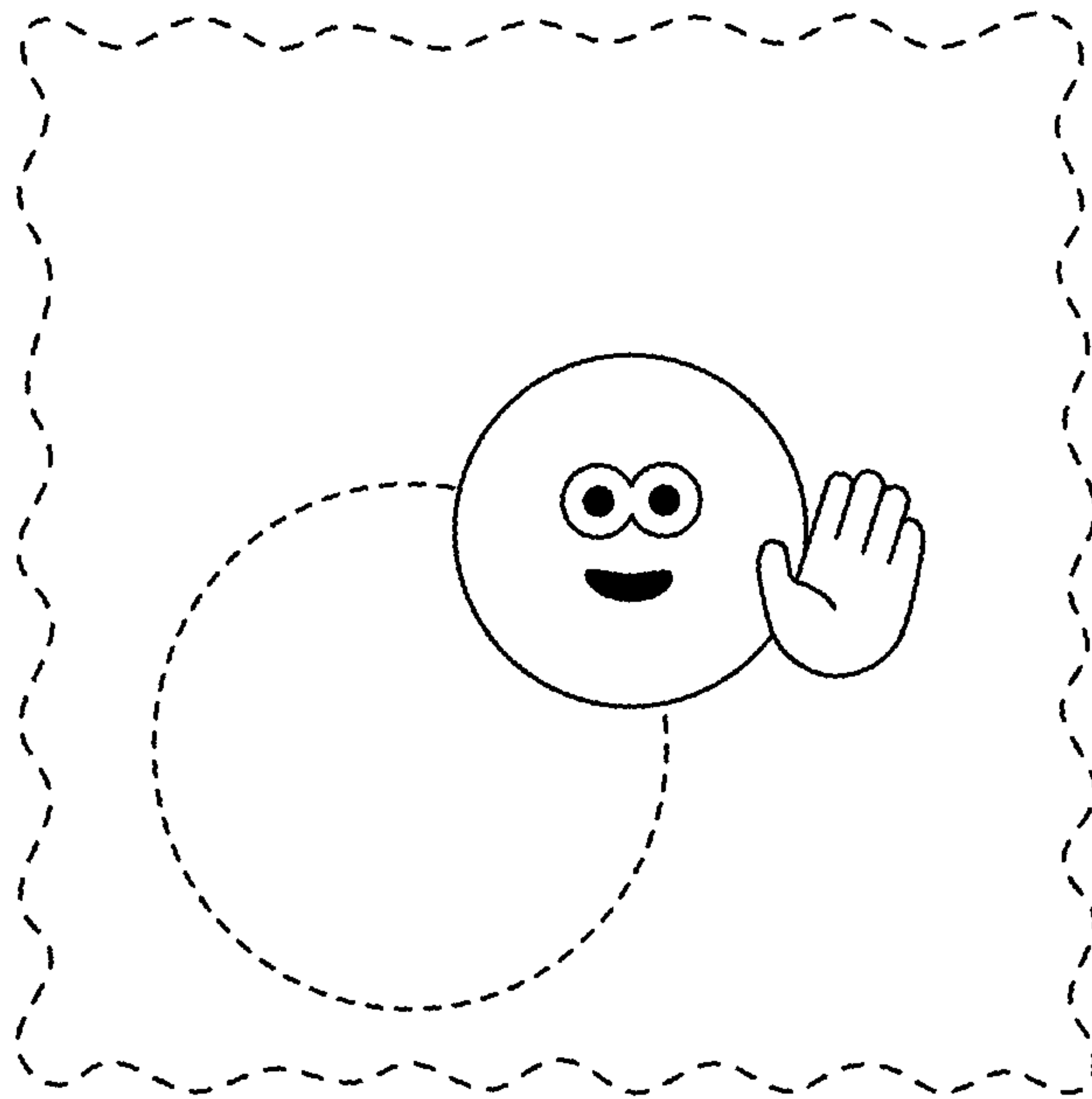

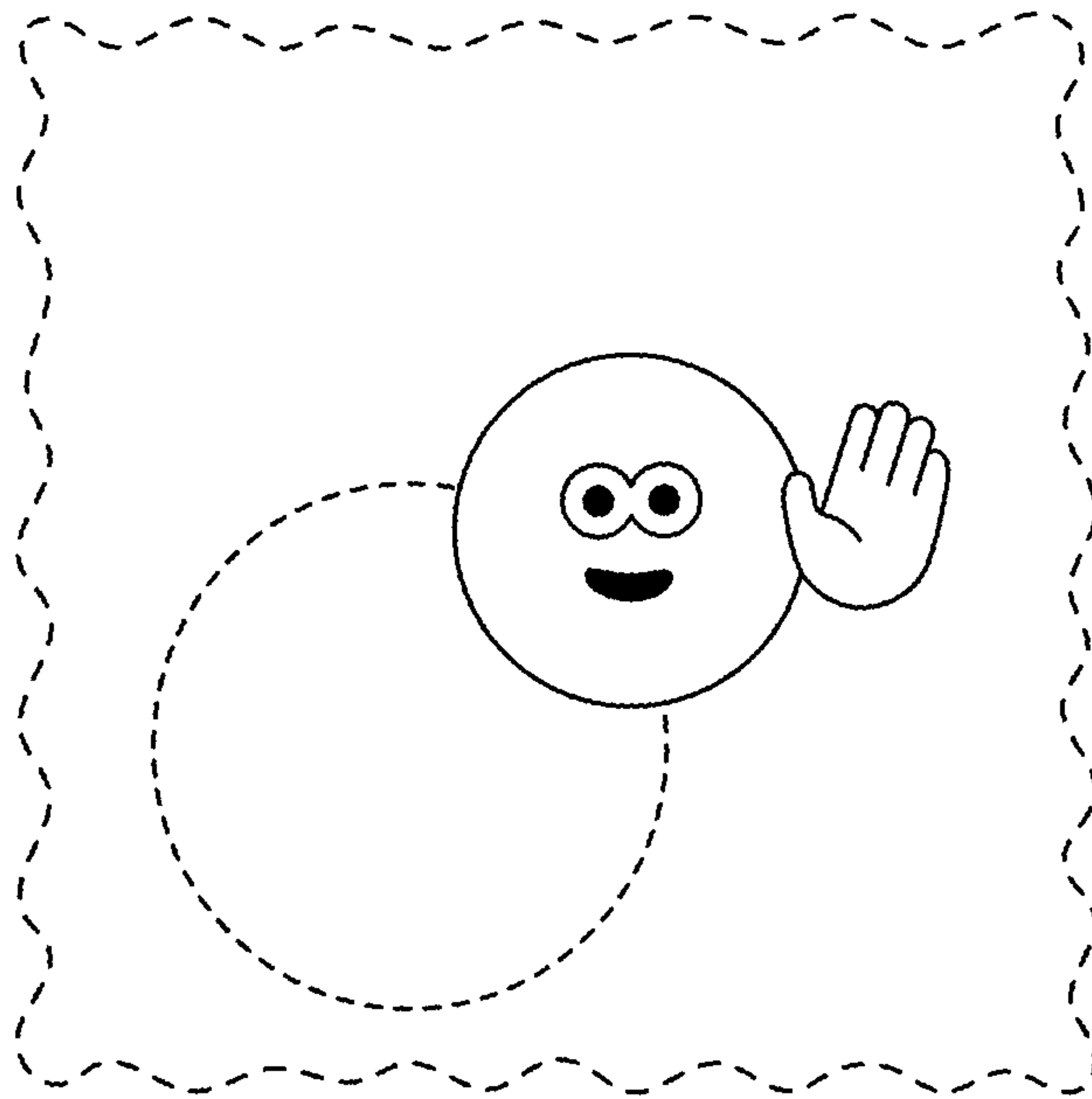

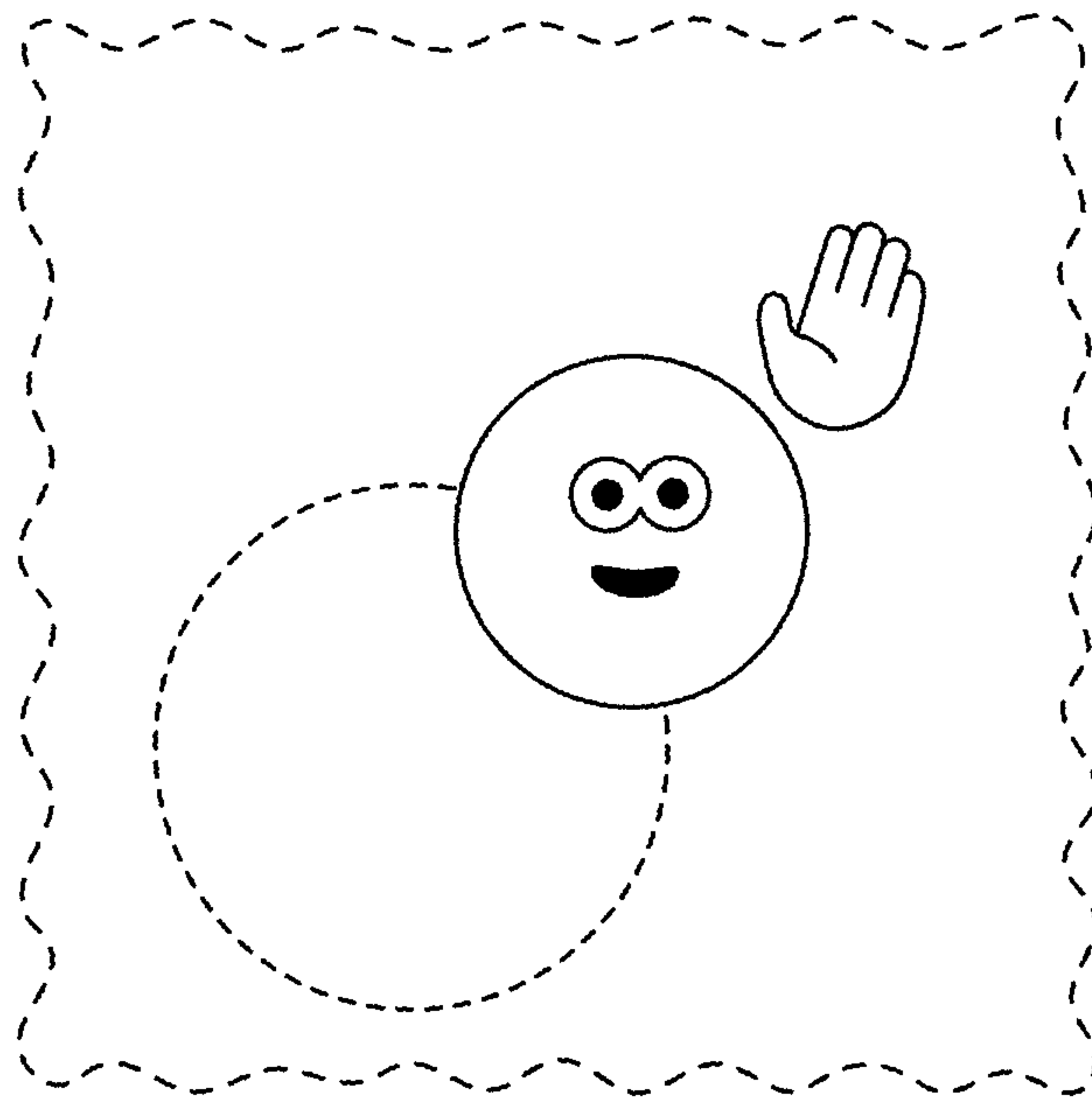

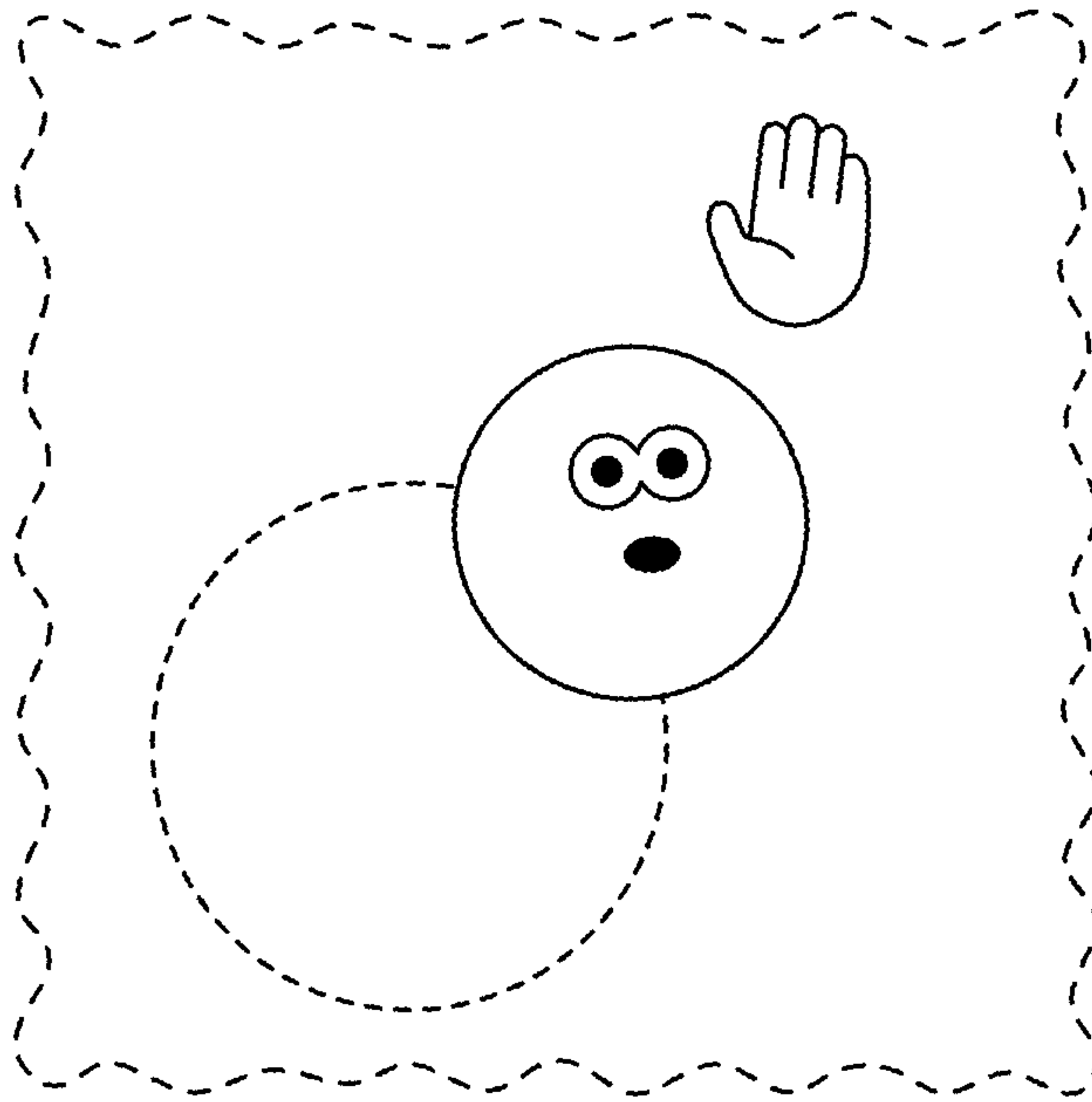

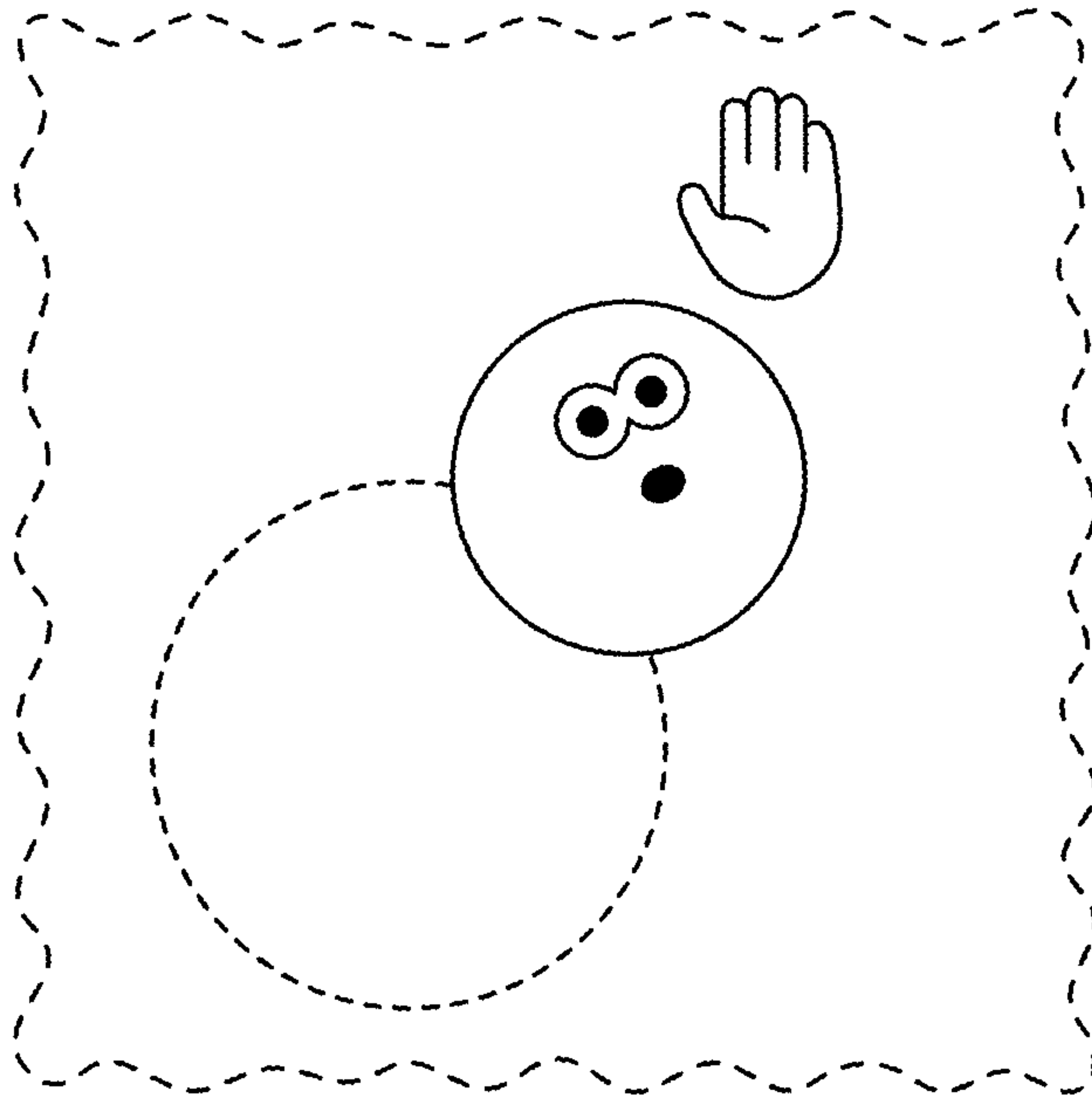

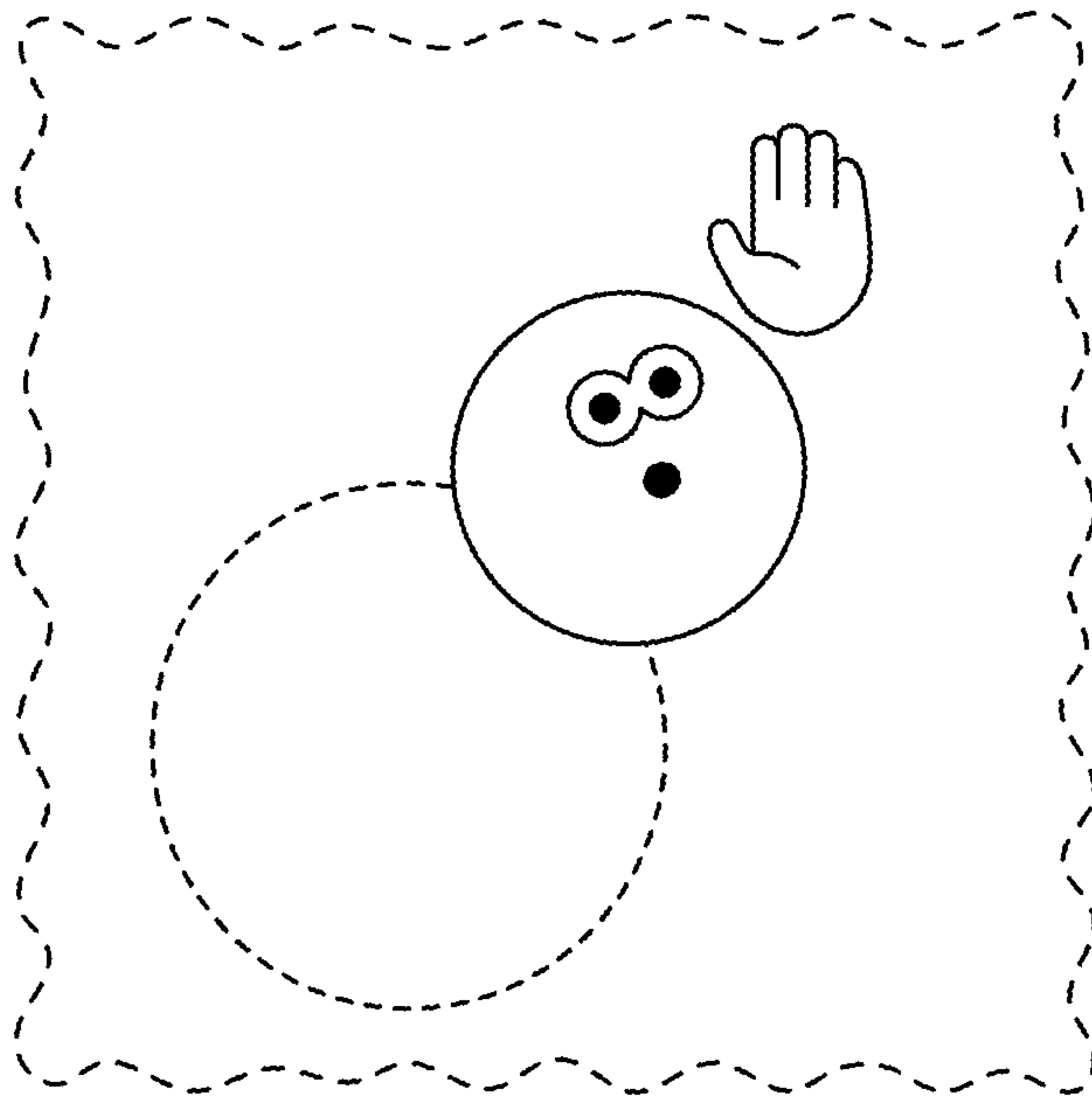

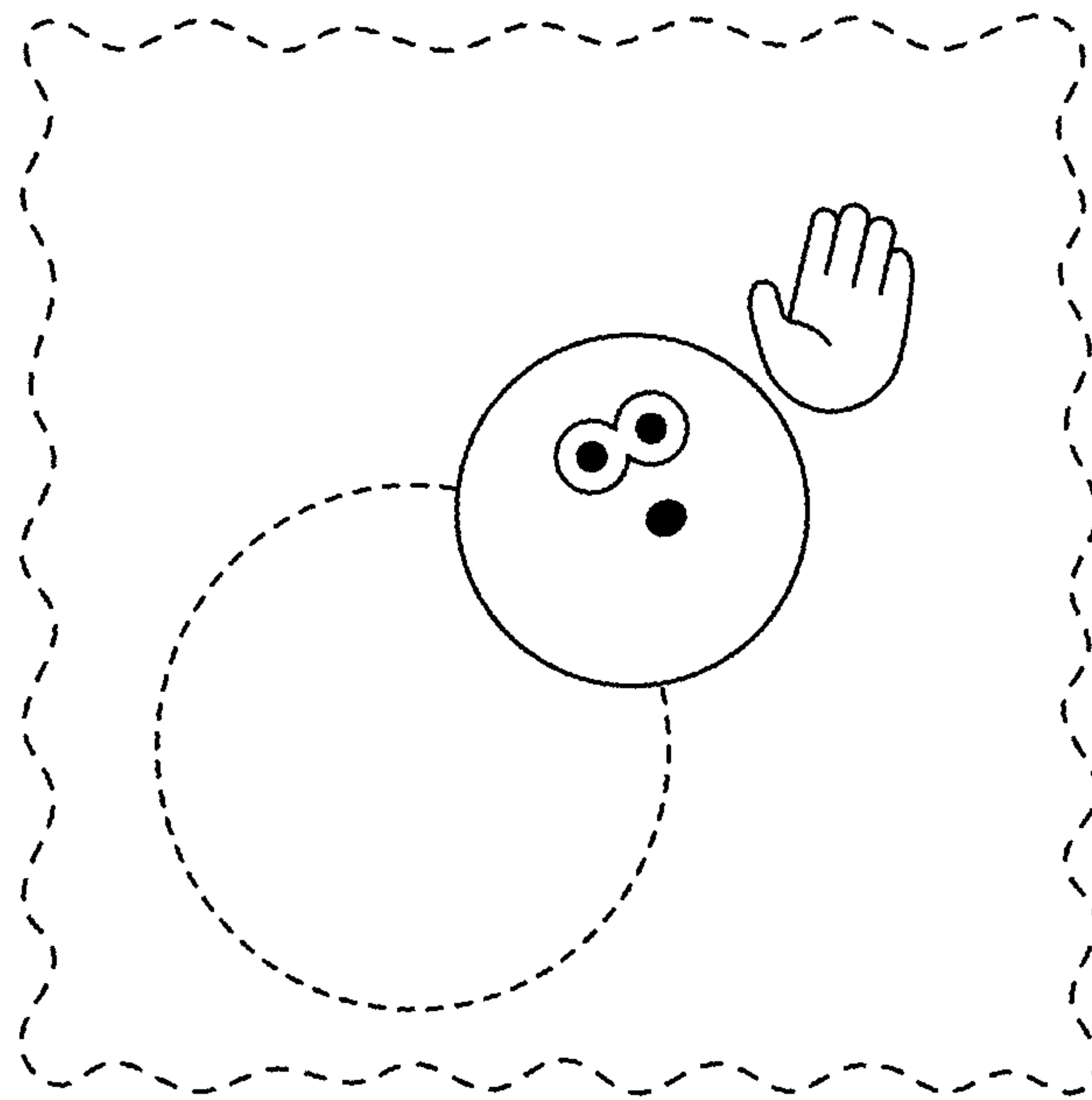

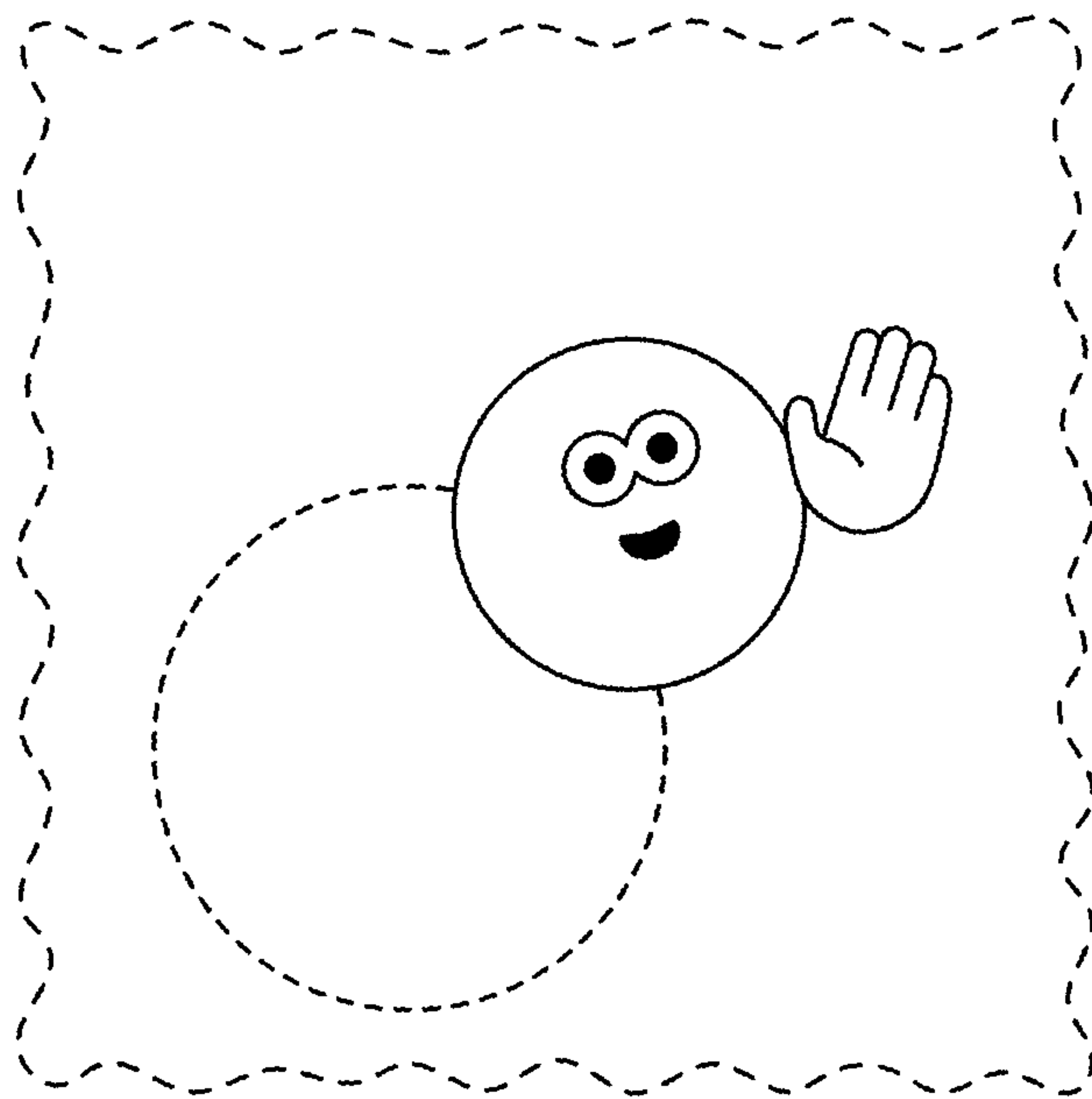

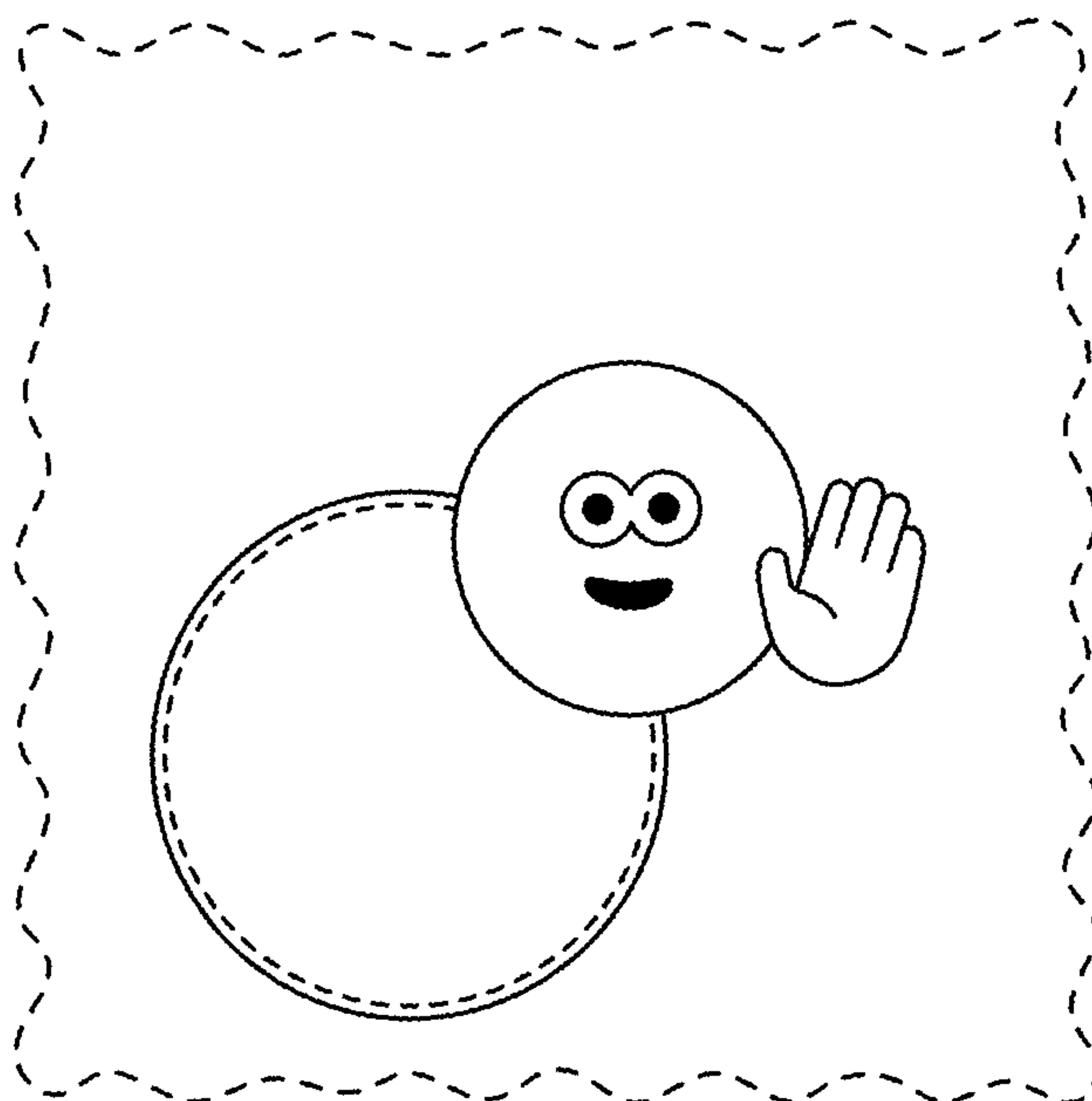

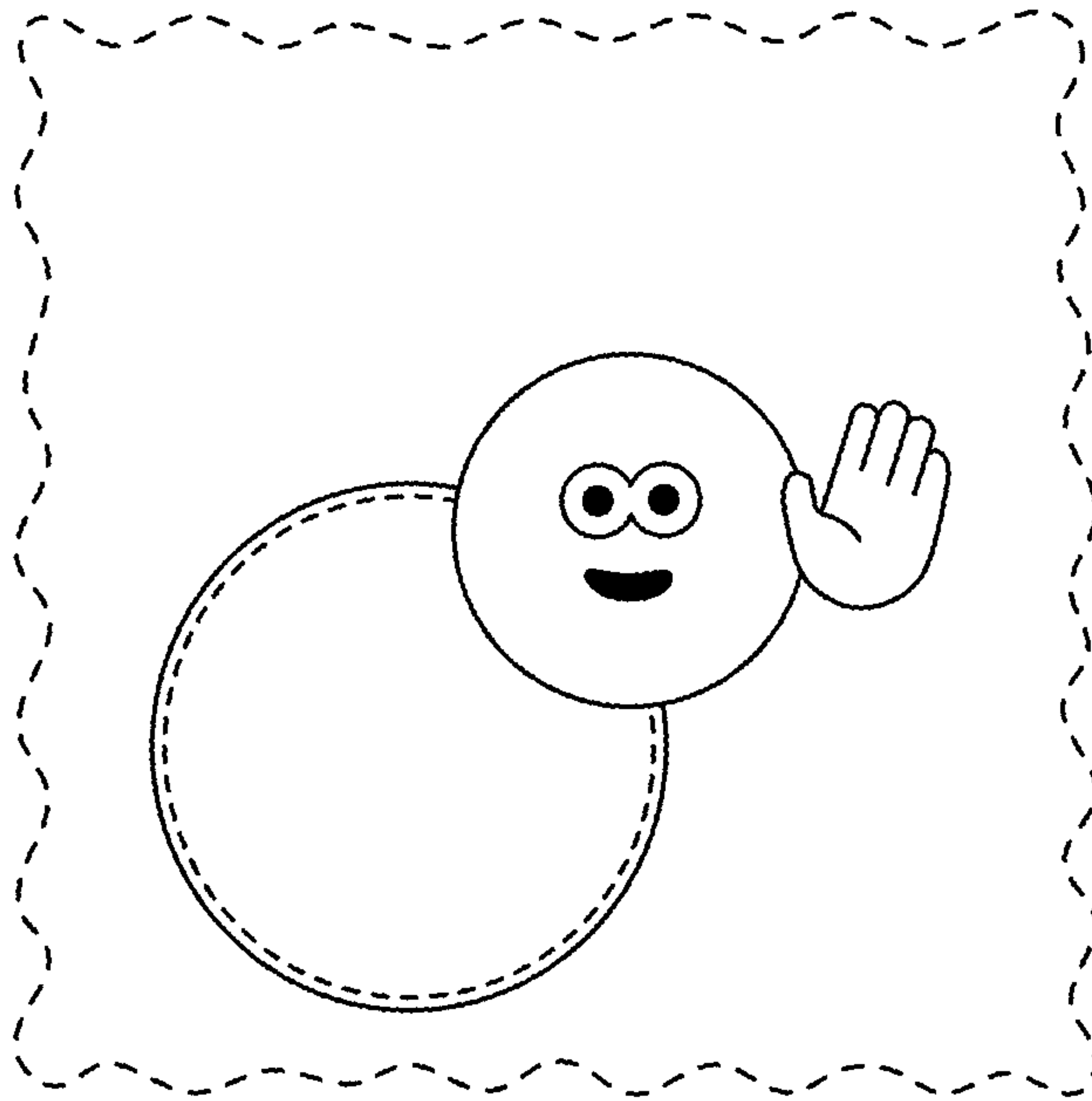

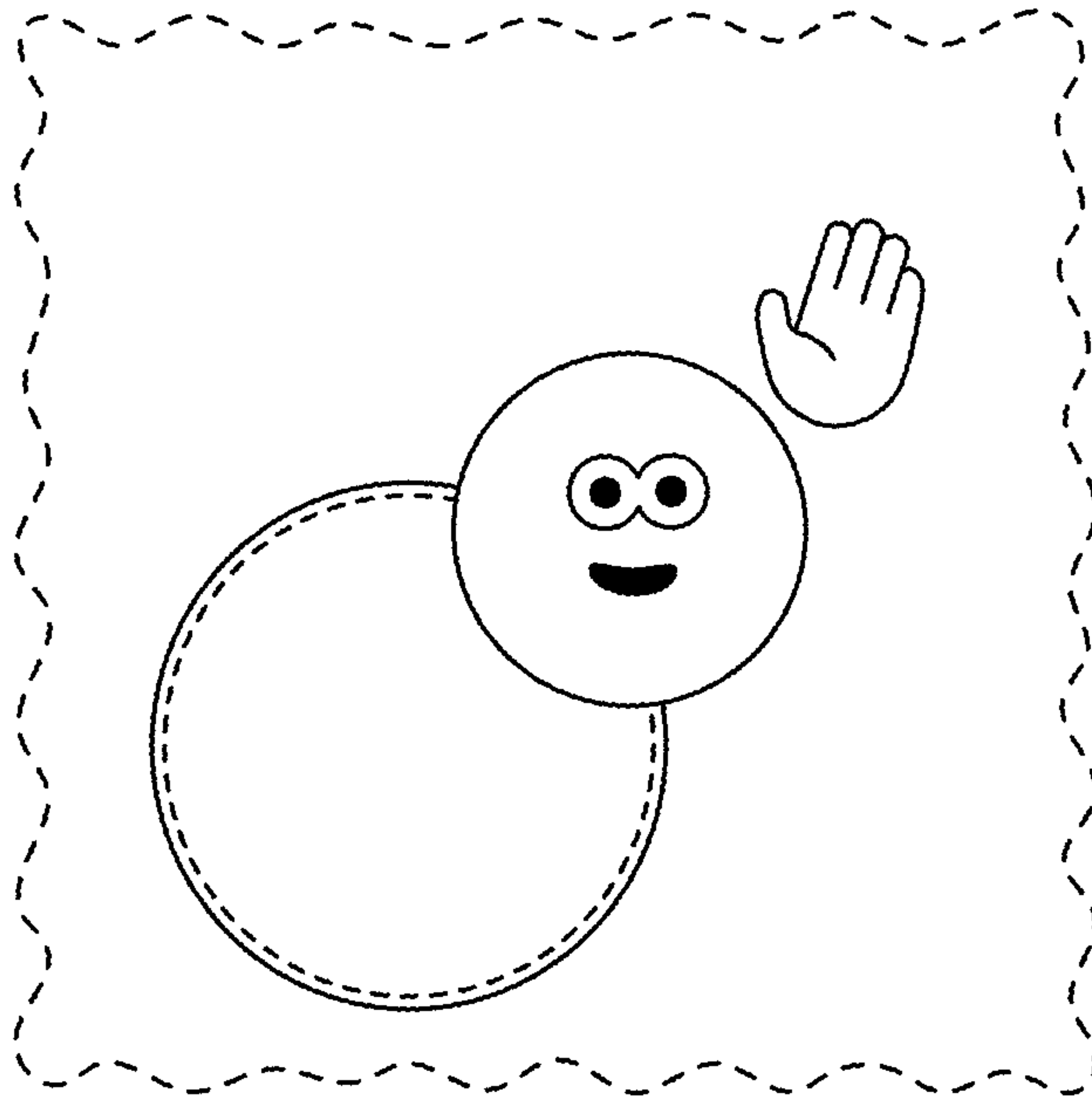

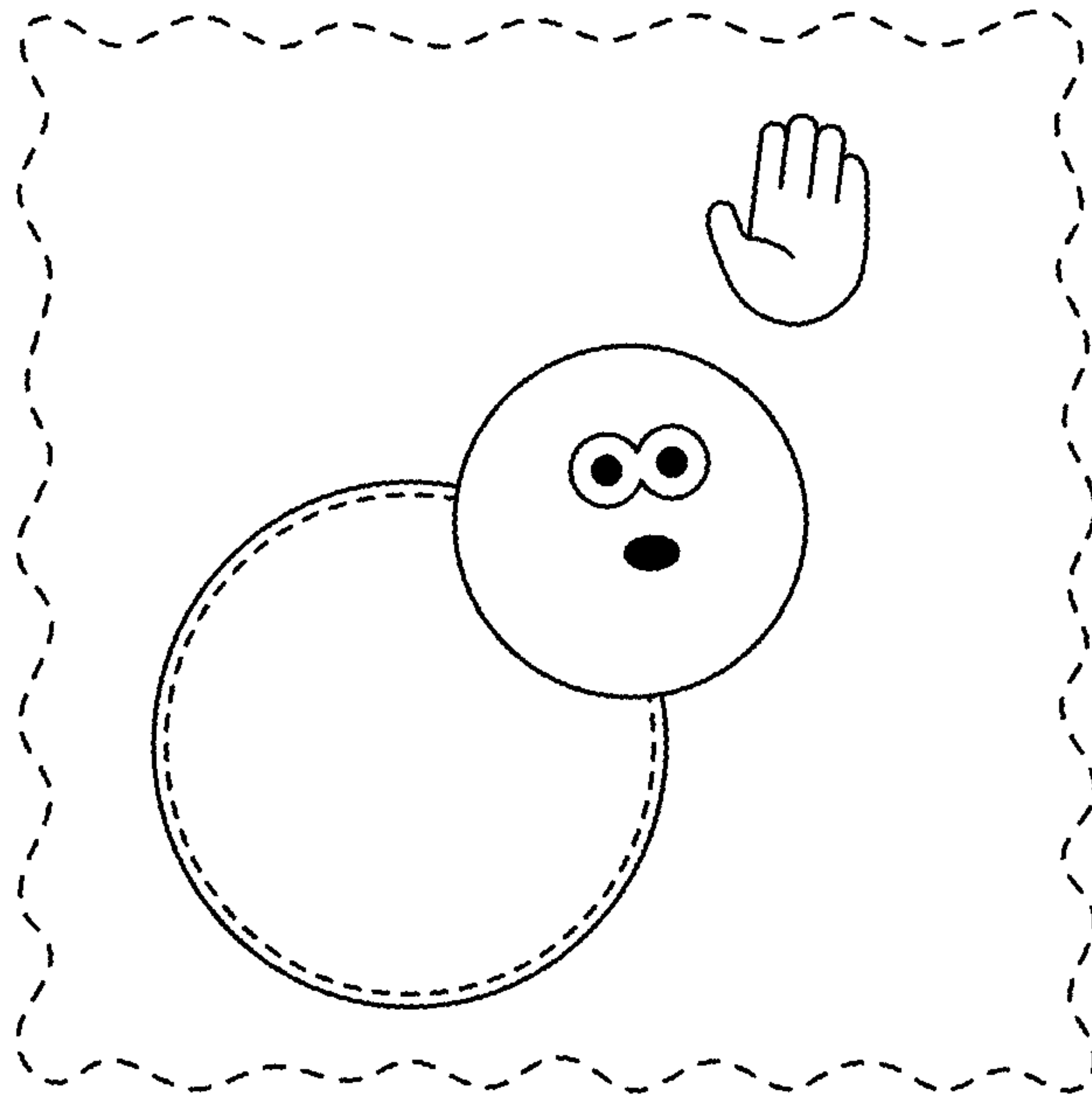

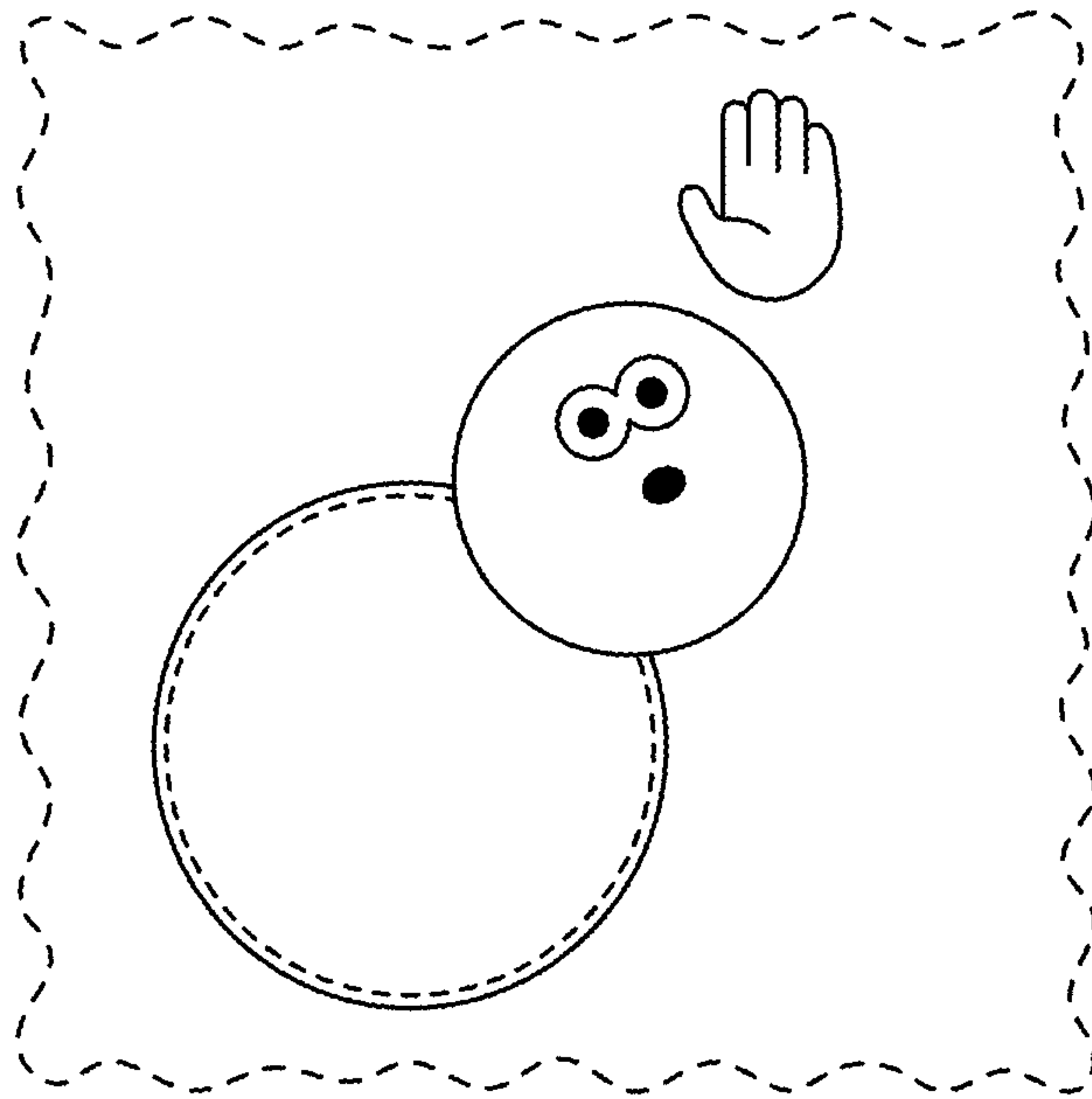

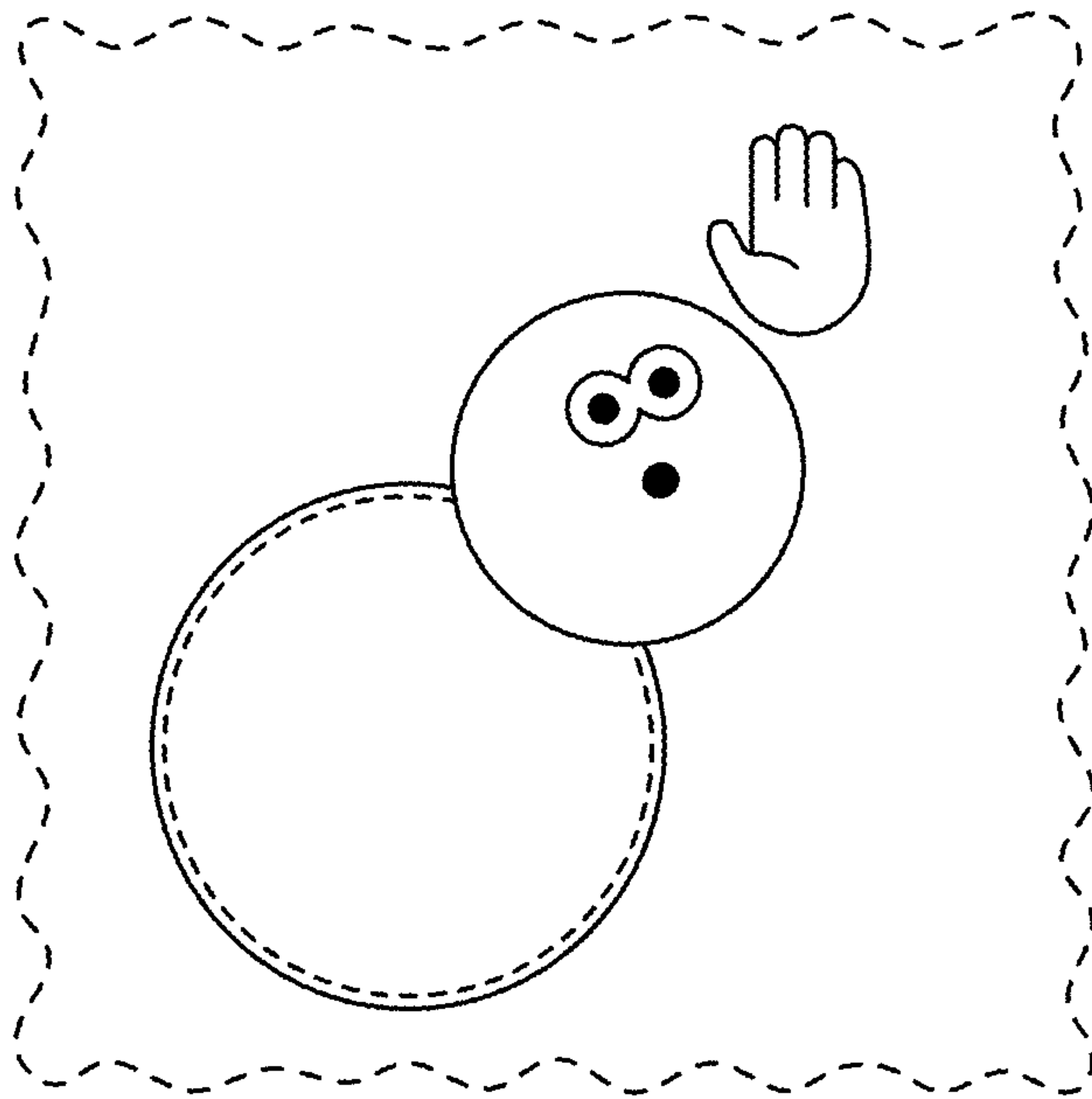

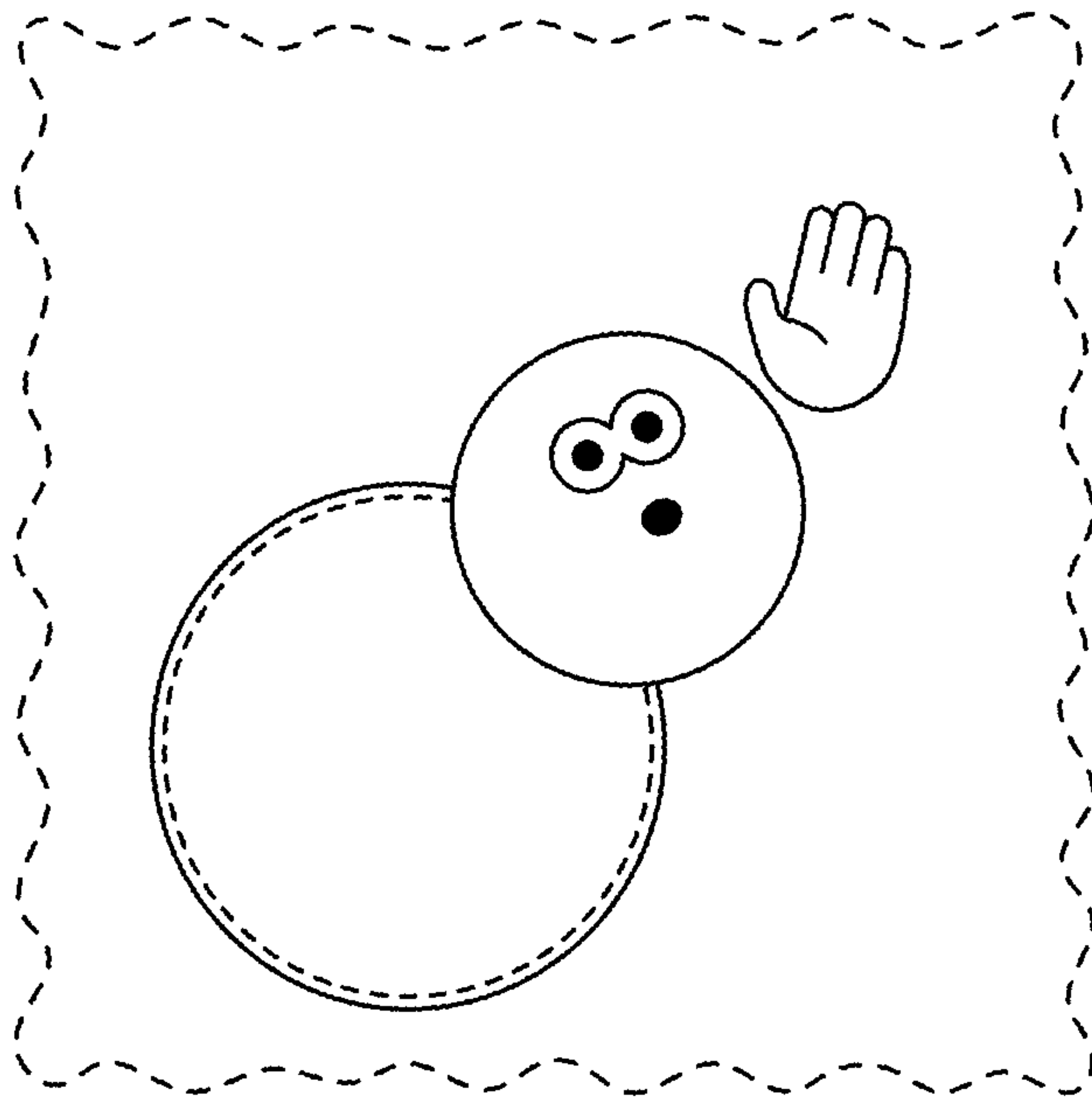

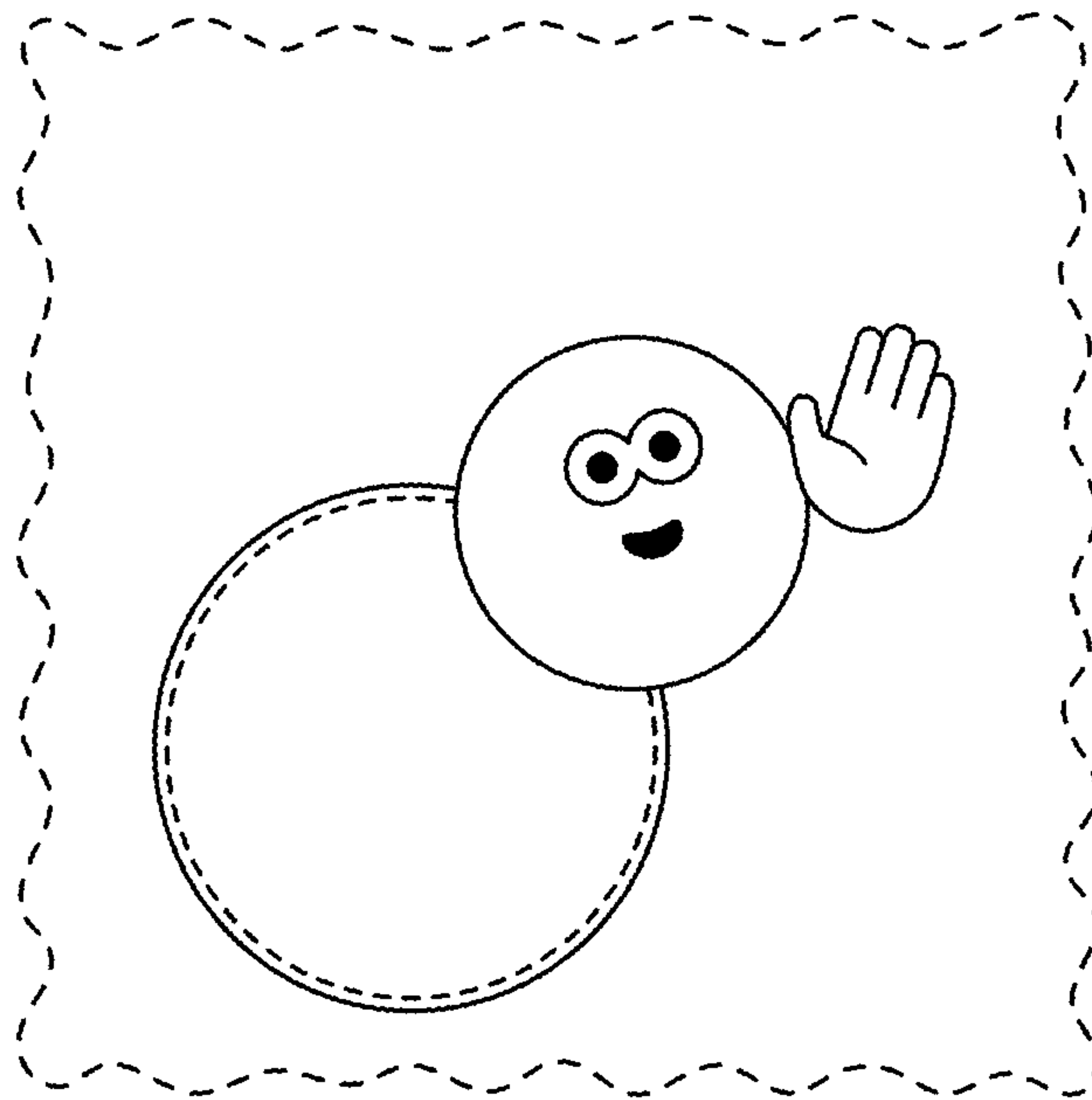
