The ornamental design for an educational board with slot and removable letters, as shown and described.

DESCRIPTION

FIG. 1 is an exploded stacked right side, front perspective view of an educational board with slot and removable letters showing our new design;

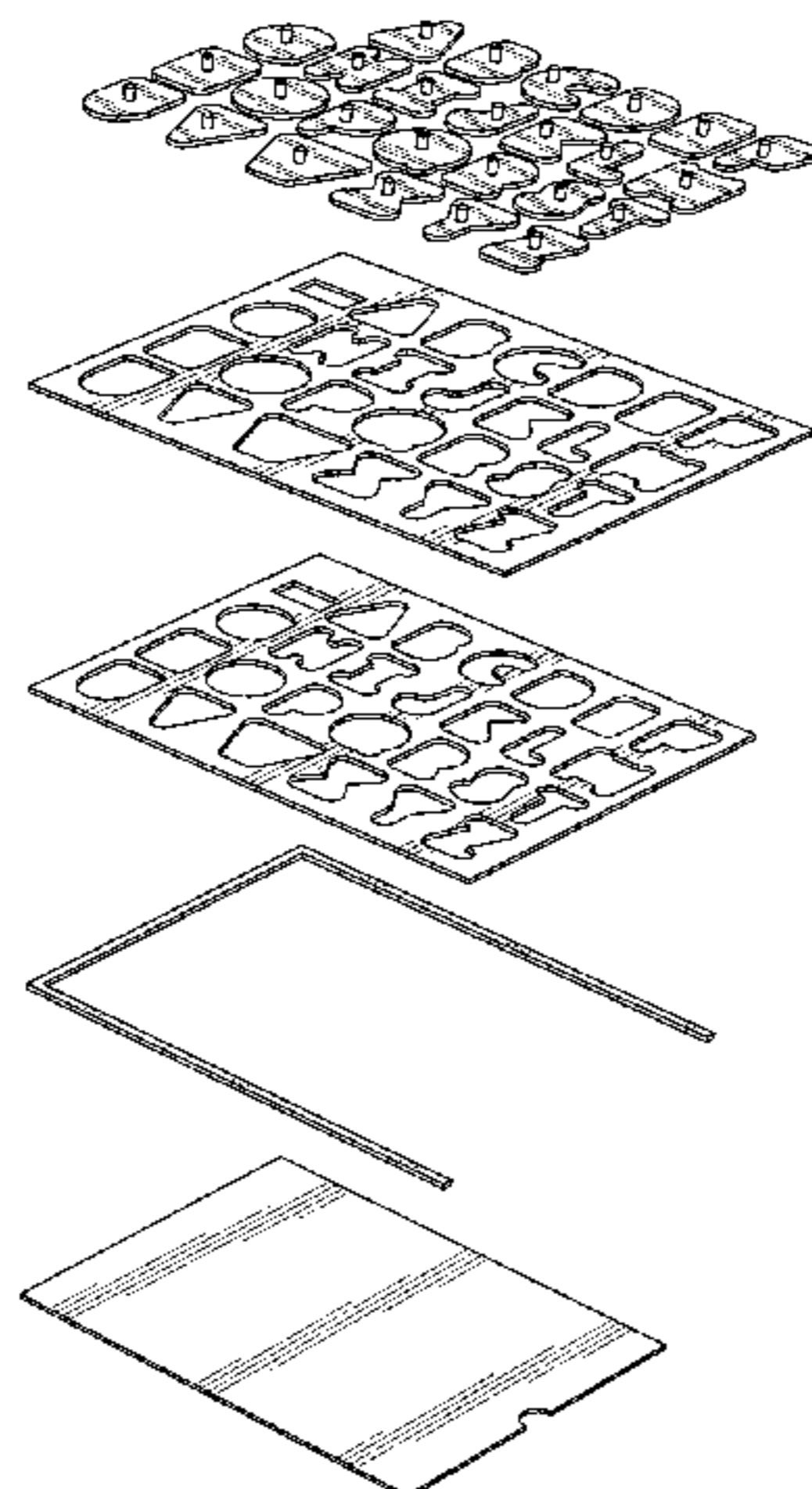
FIG. 2 is a top view of the educational board with slot and removable letters;

FIG. 3 is a right side perspective view with the letter pieces shown raised above the base of the educational board with slot and removable letters for clarity of illustration;

FIG. 5 is a bottom view of the educational board with slot and removable letters.

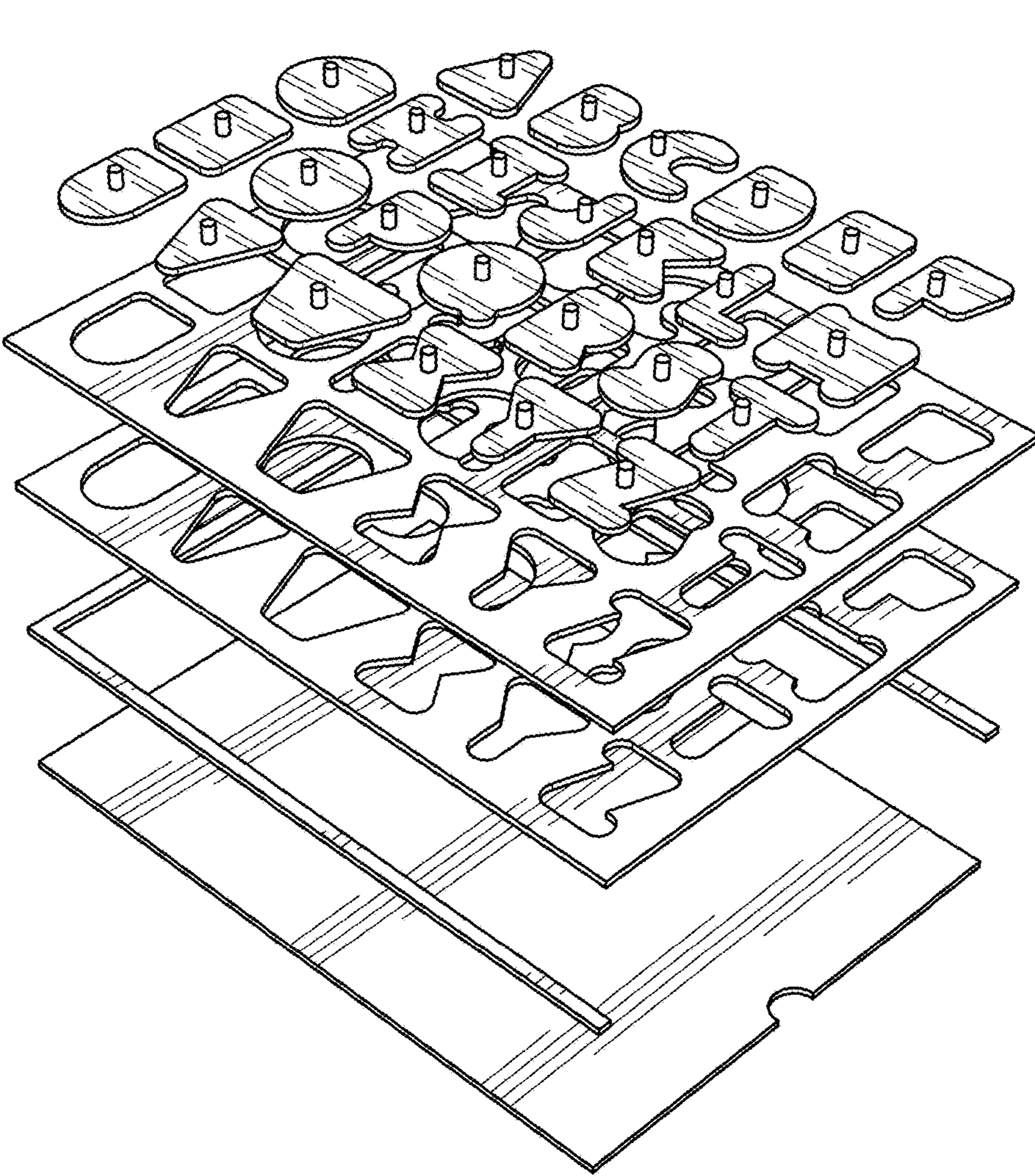

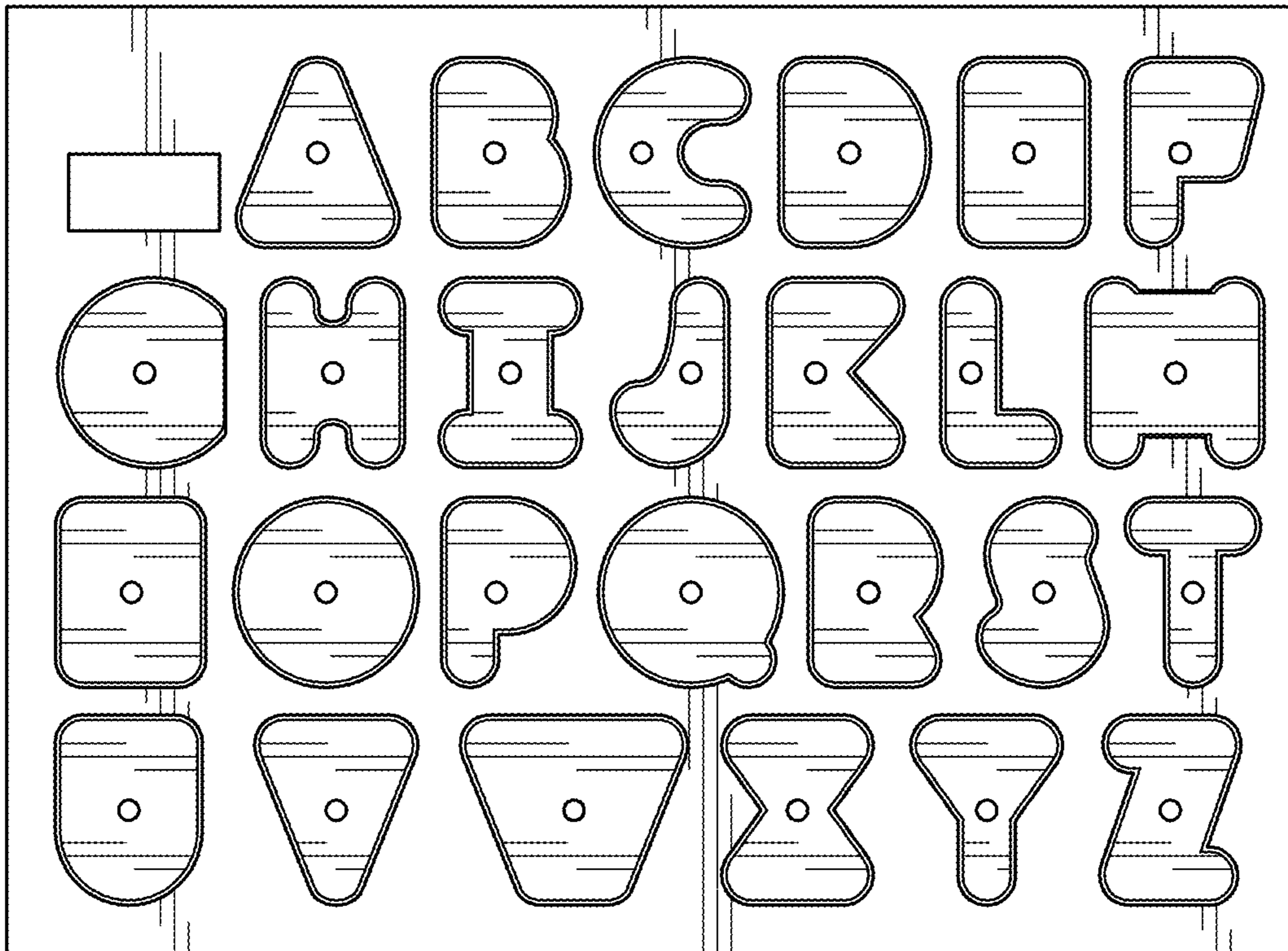

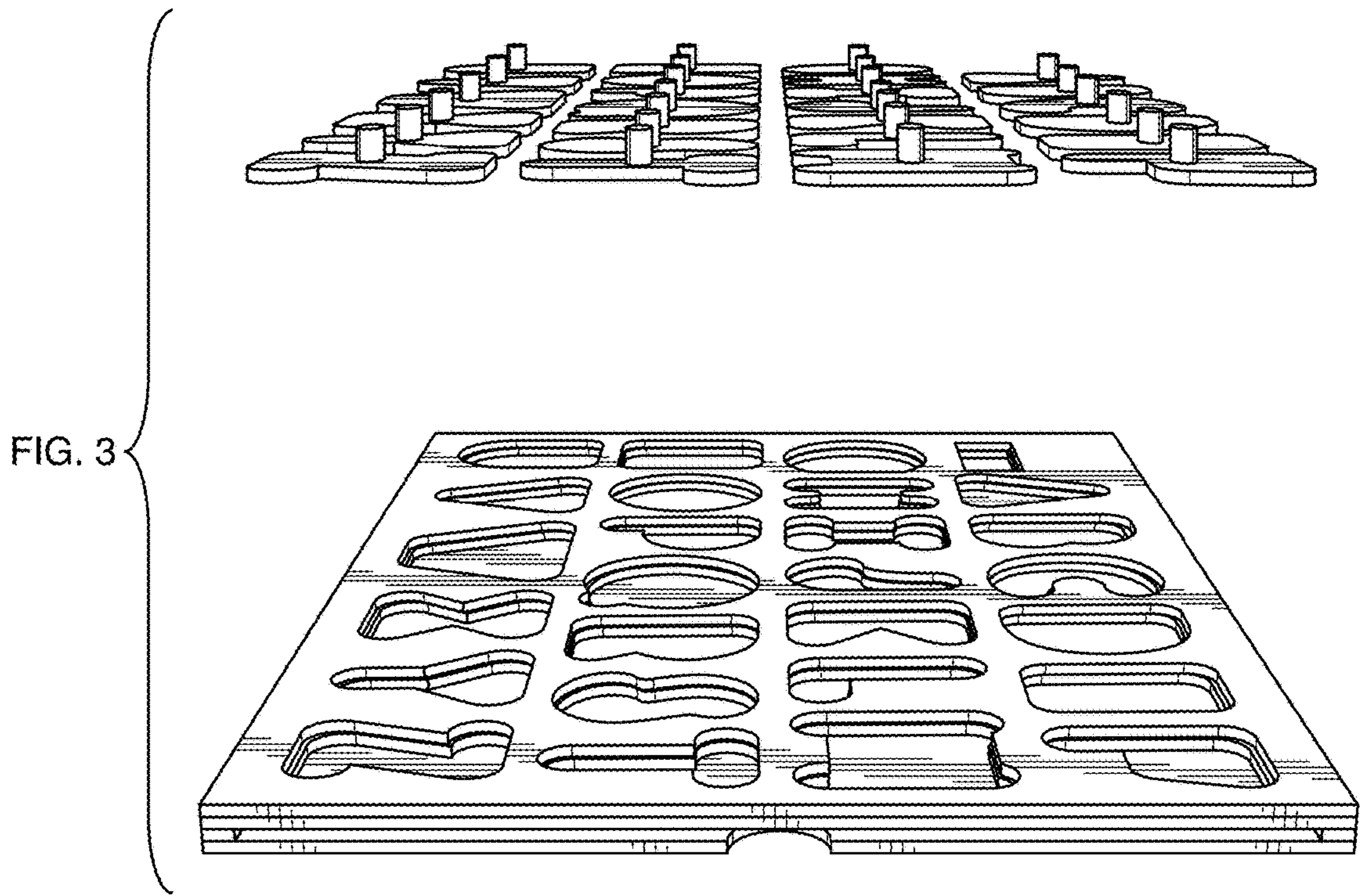
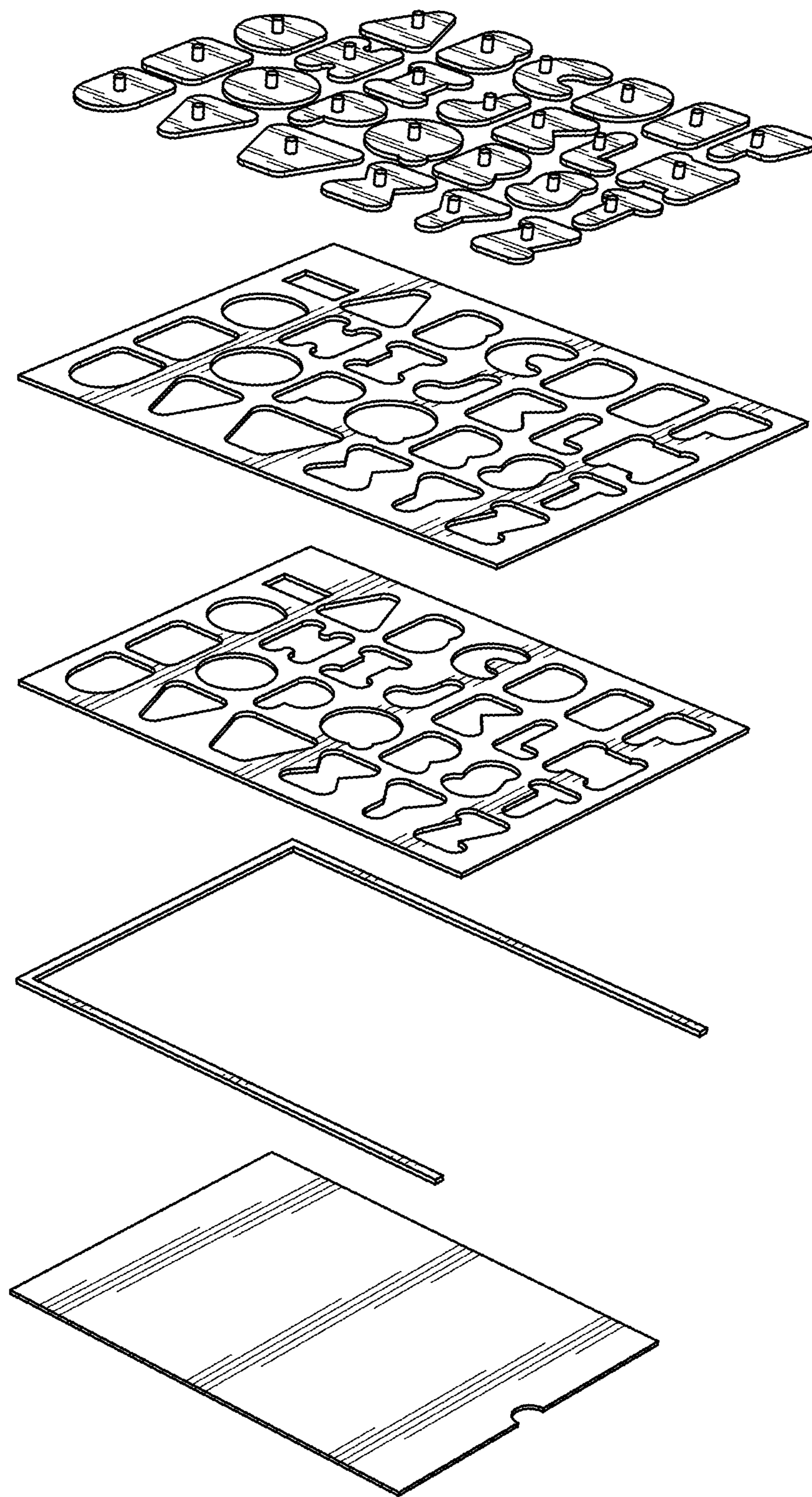

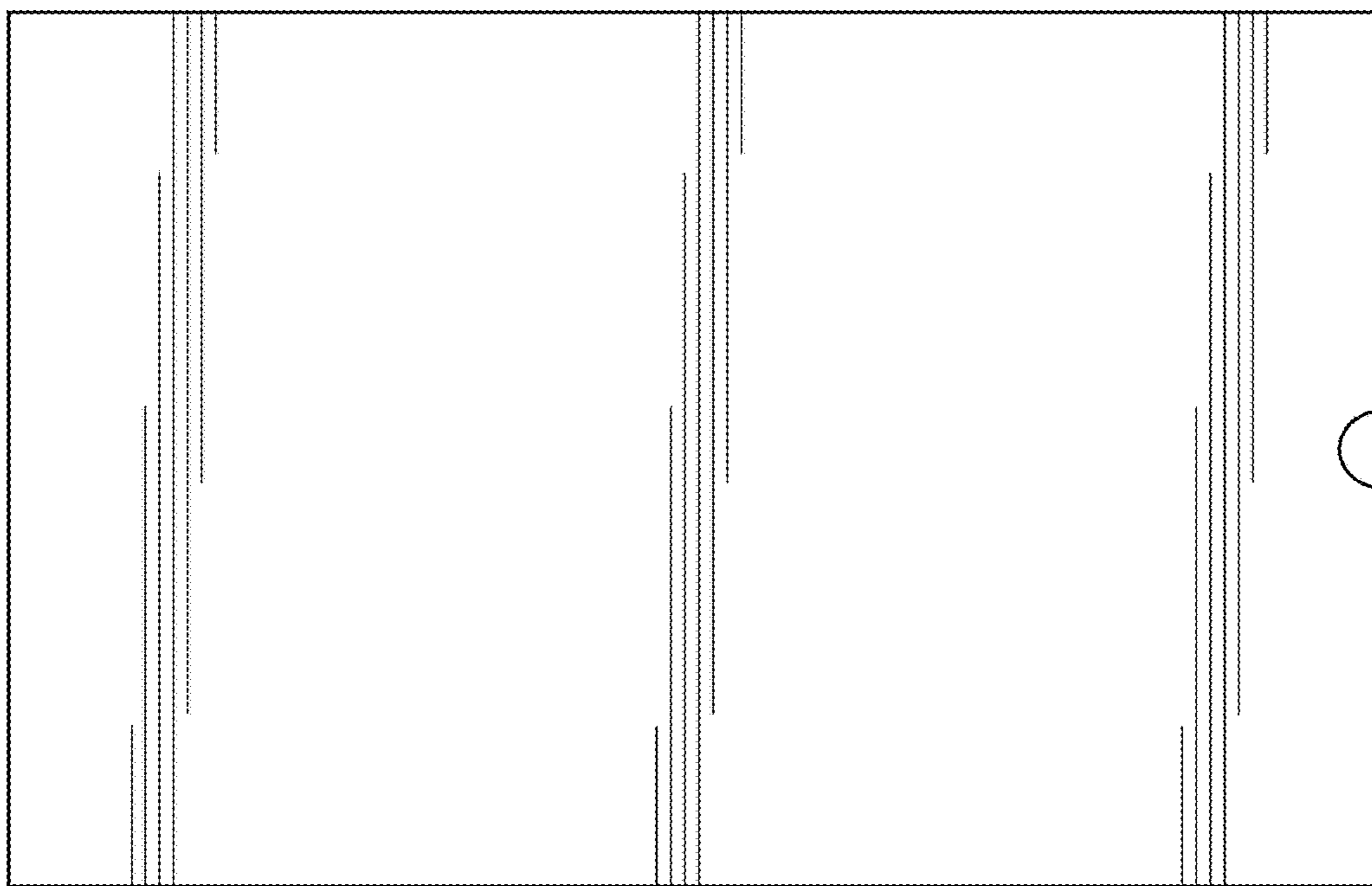
