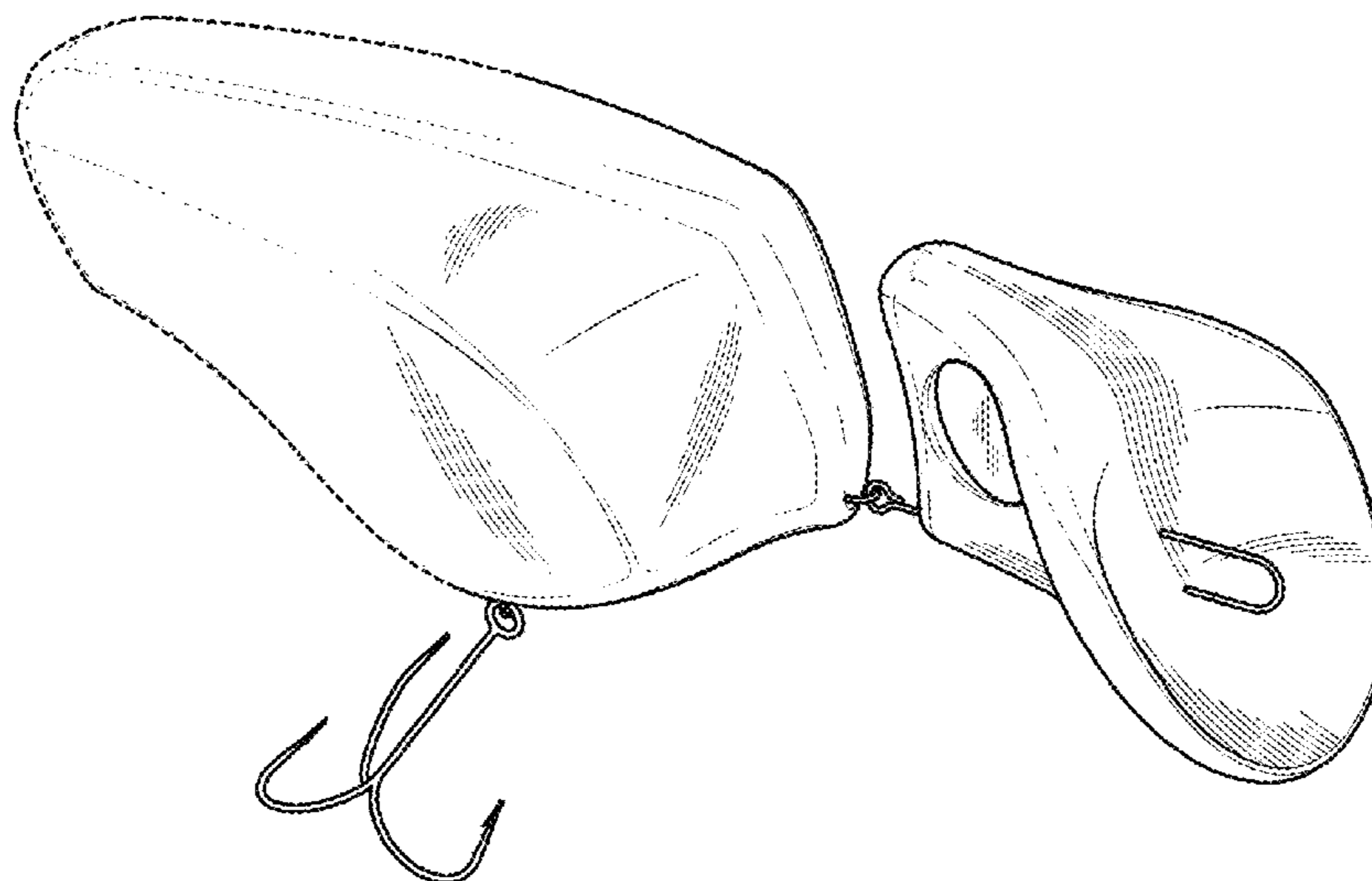
(57) **CLAIM**

The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the design of a fishing lure of the present application;
FIG. 2 is a bottom perspective view of the design in FIG. 1;
FIG. 3 is a side elevational view of the design in FIG. 1, with the opposite side at elevational view being a mirror image thereof;
FIG. 4 is a front elevational view of the design in FIG. 1;
FIG. 5 is a rear elevational view of the design in FIG. 1;
FIG. 6 is a top view of the design in FIG. 1;
FIG. 7 is a bottom view of the design in FIG. 1;
FIG. 8 is a top perspective view of a second embodiment of the design of a fishing lure of the present application;
FIG. 9 is a bottom perspective view of the design in FIG. 8;
FIG. 10 is a side elevational view of the design in FIG. 8, with the opposite side at elevational view being a mirror image thereof;
FIG. 11 is a front elevational view of the design in FIG. 8;
FIG. 12 is a rear elevational view of the design in FIG. 8;
FIG. 13 is a top view of the design in FIG. 8; and,
FIG. 14 is a bottom view of the design in FIG. 8.

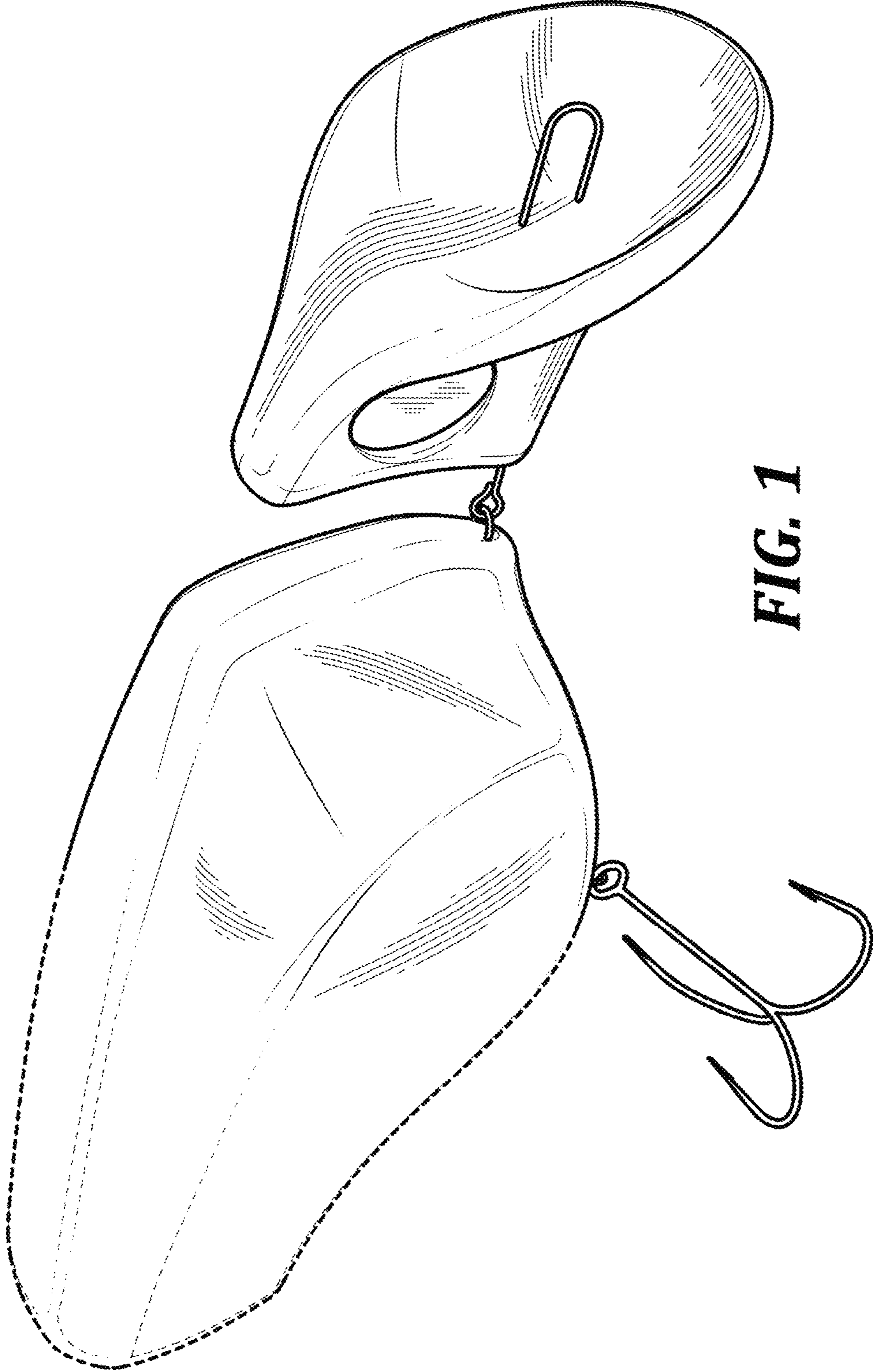

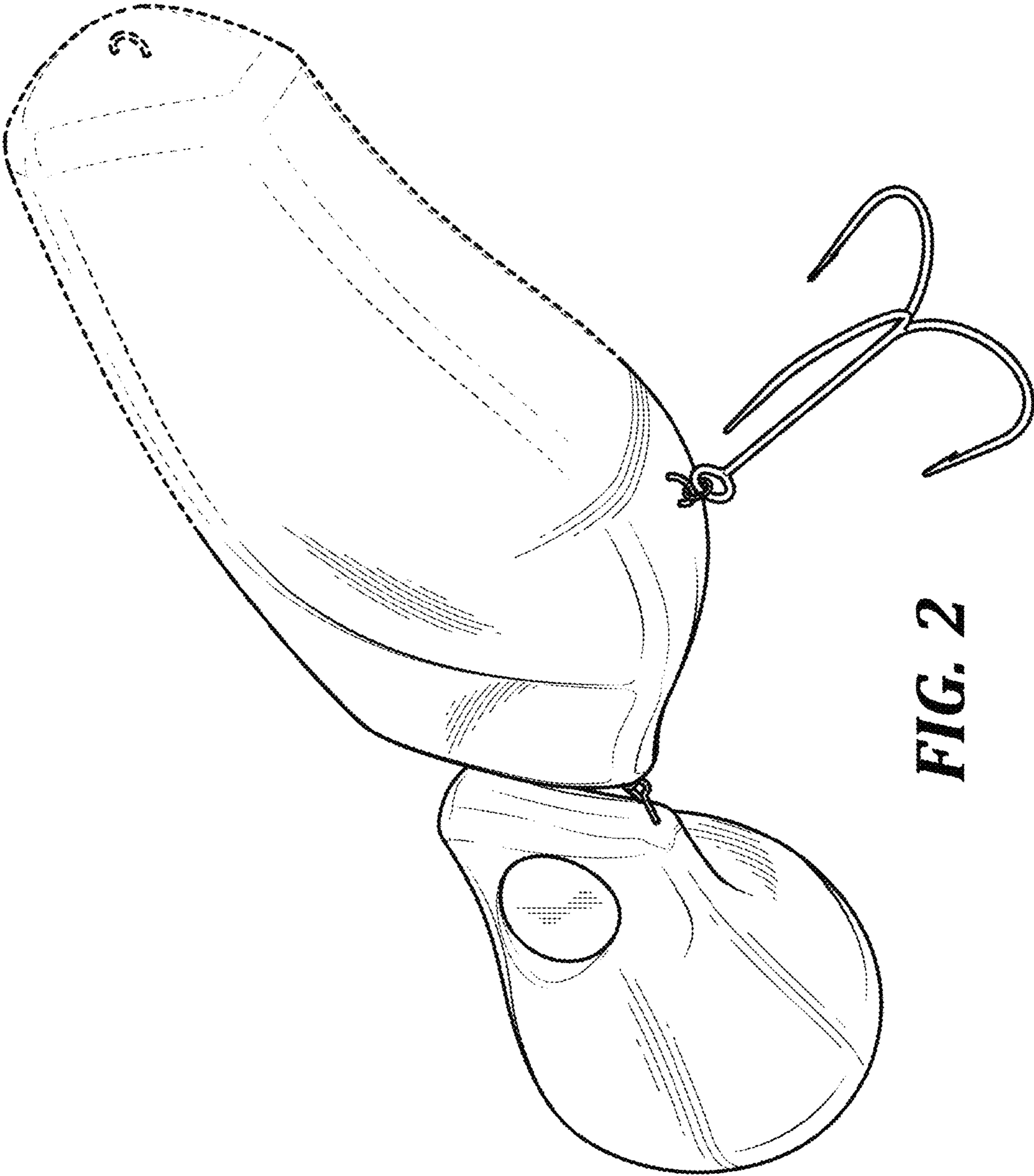

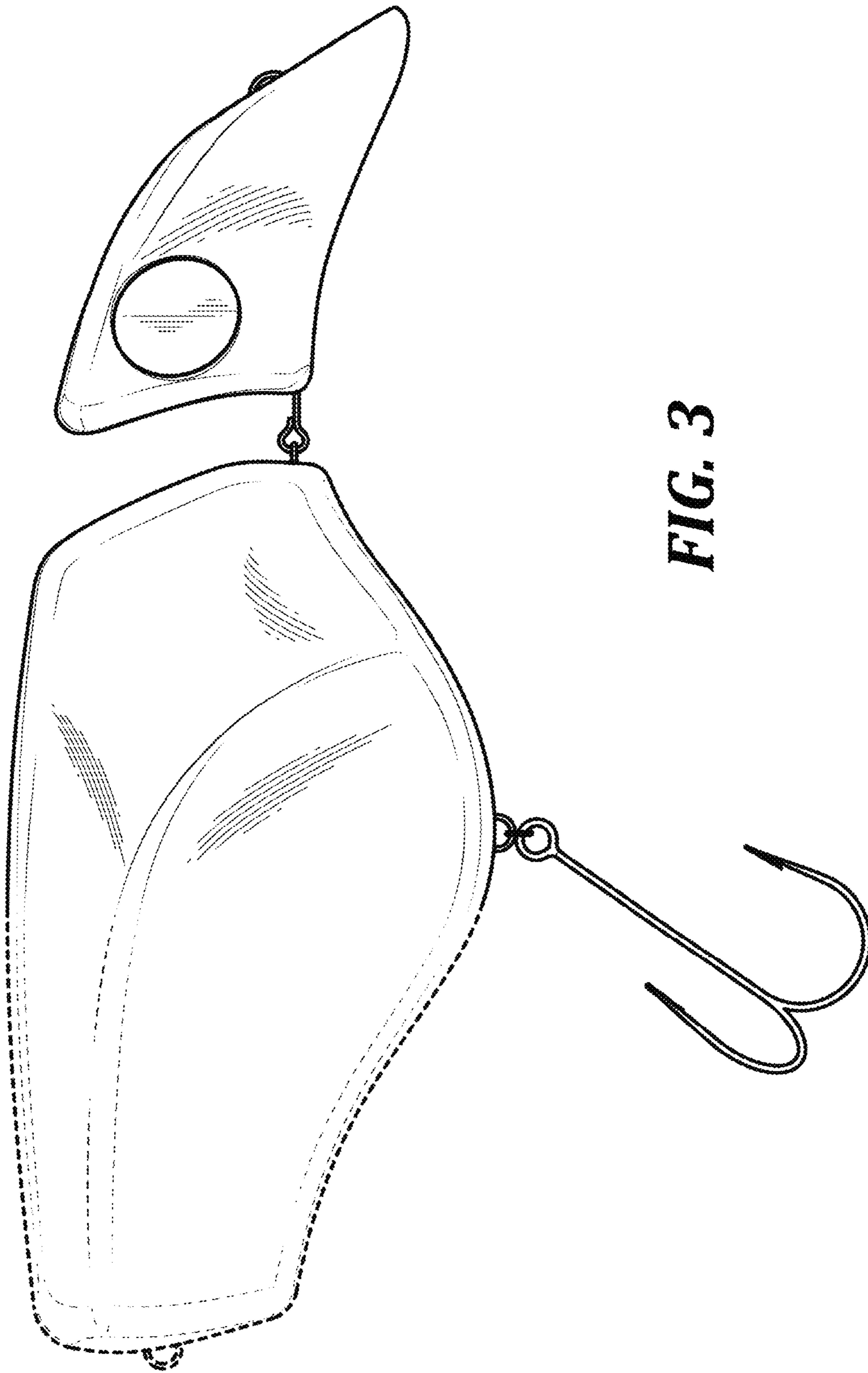

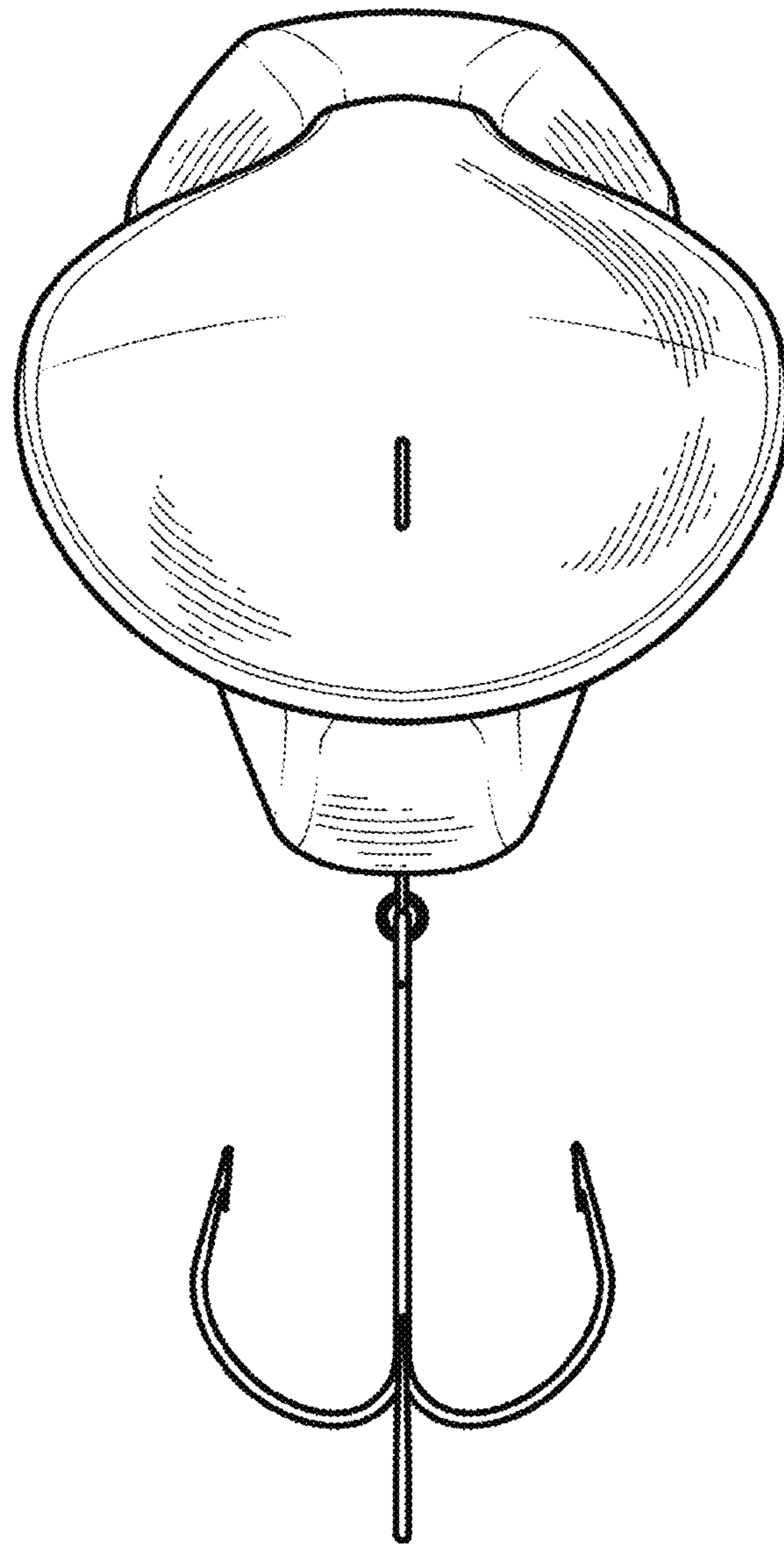

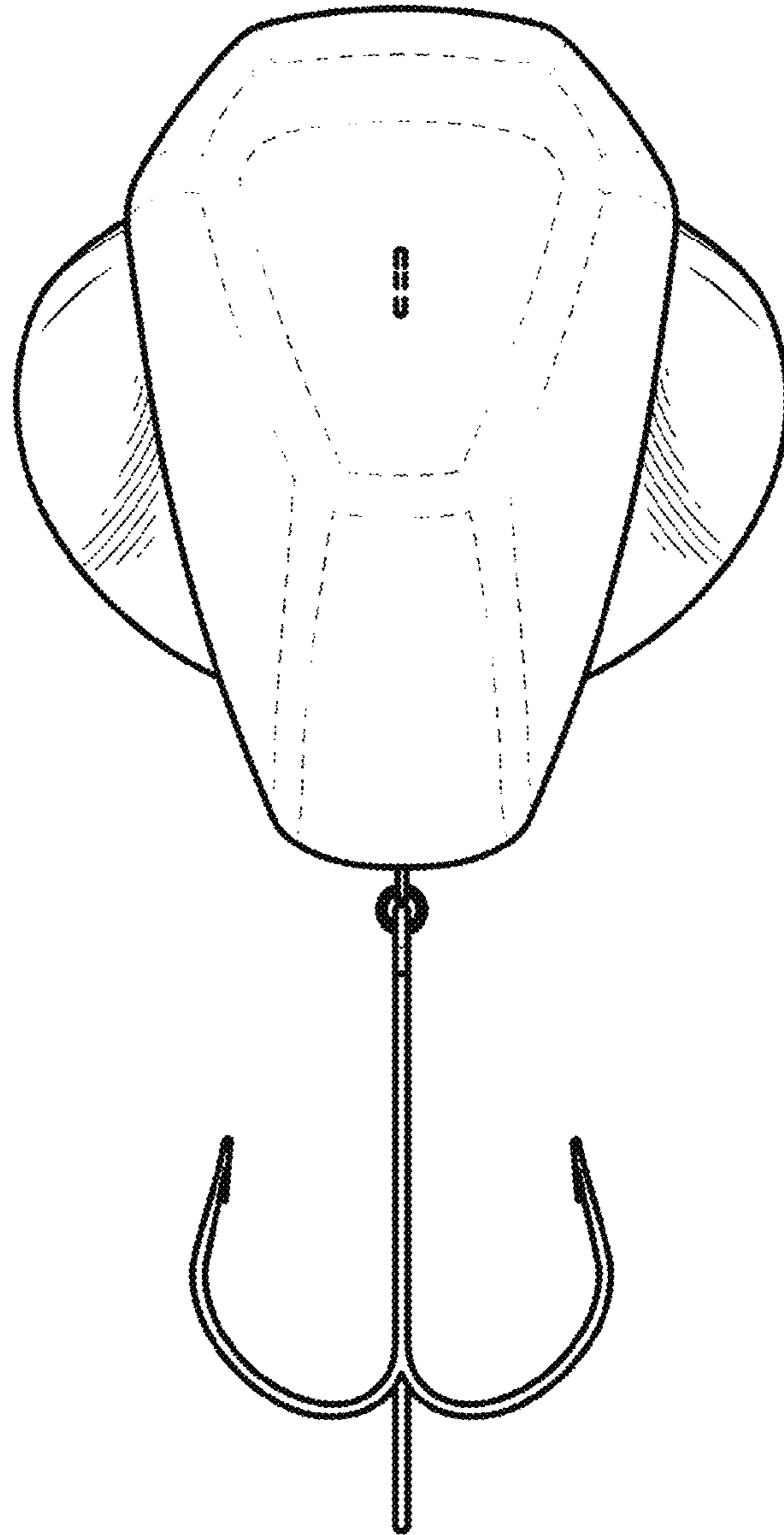

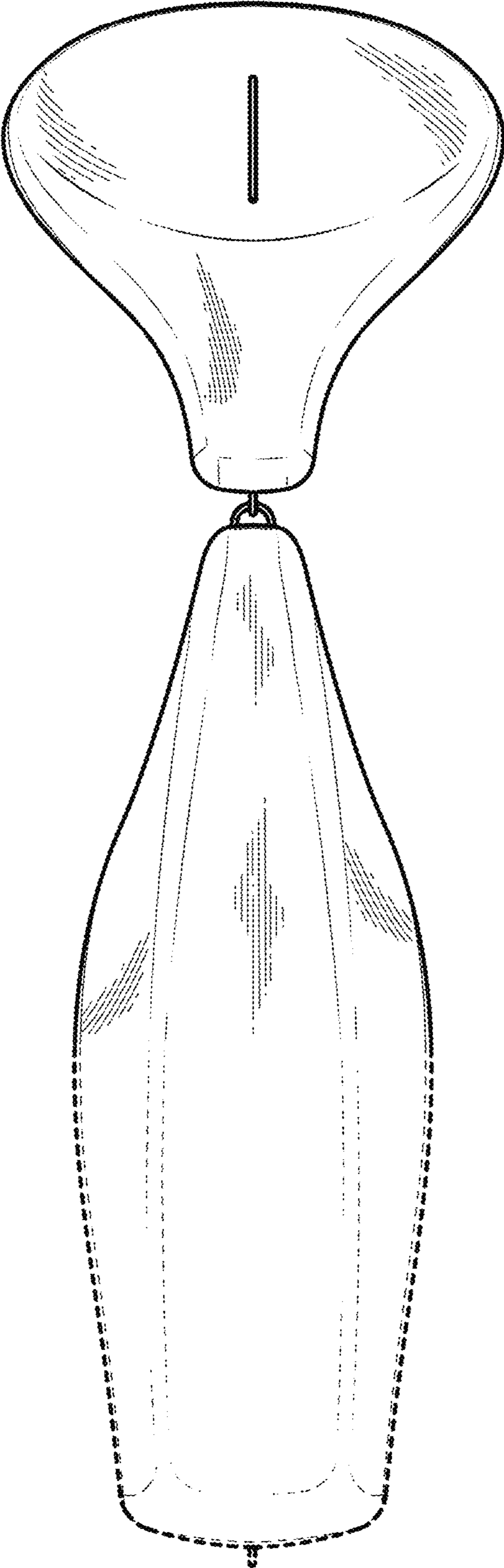

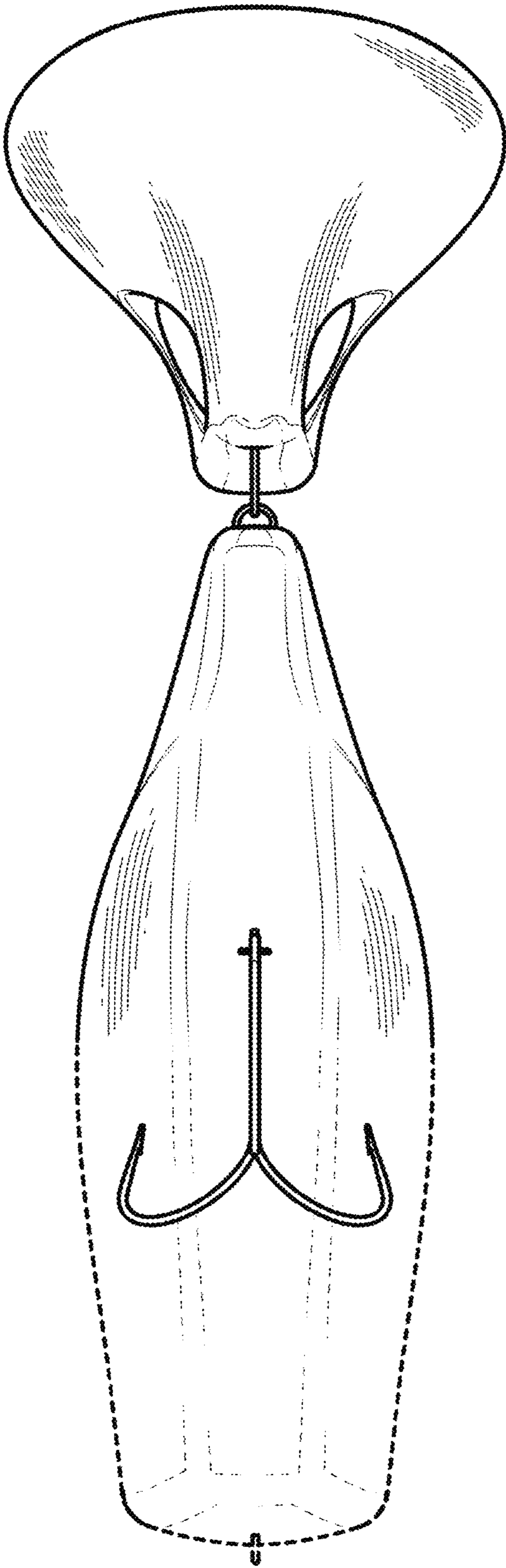

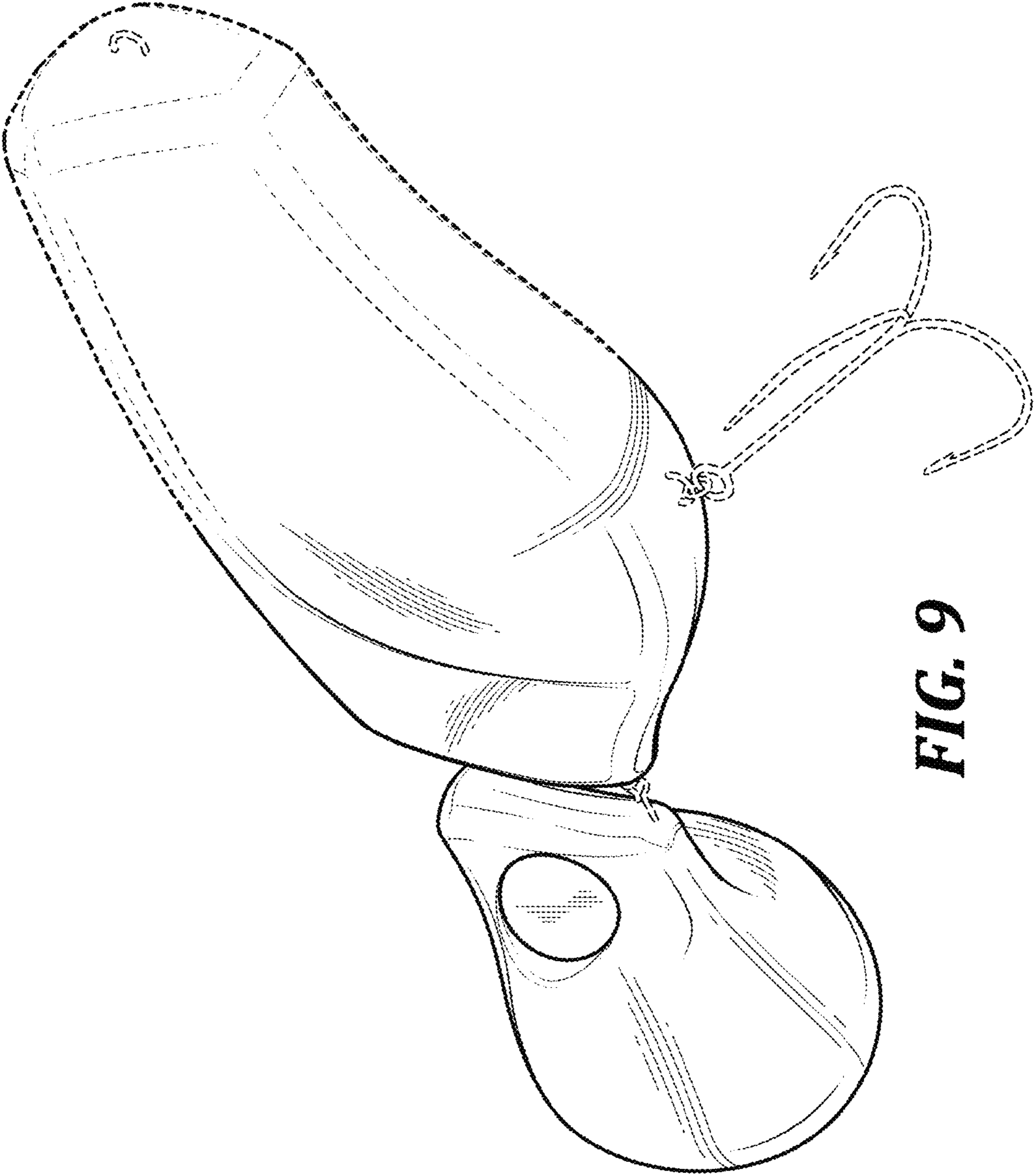

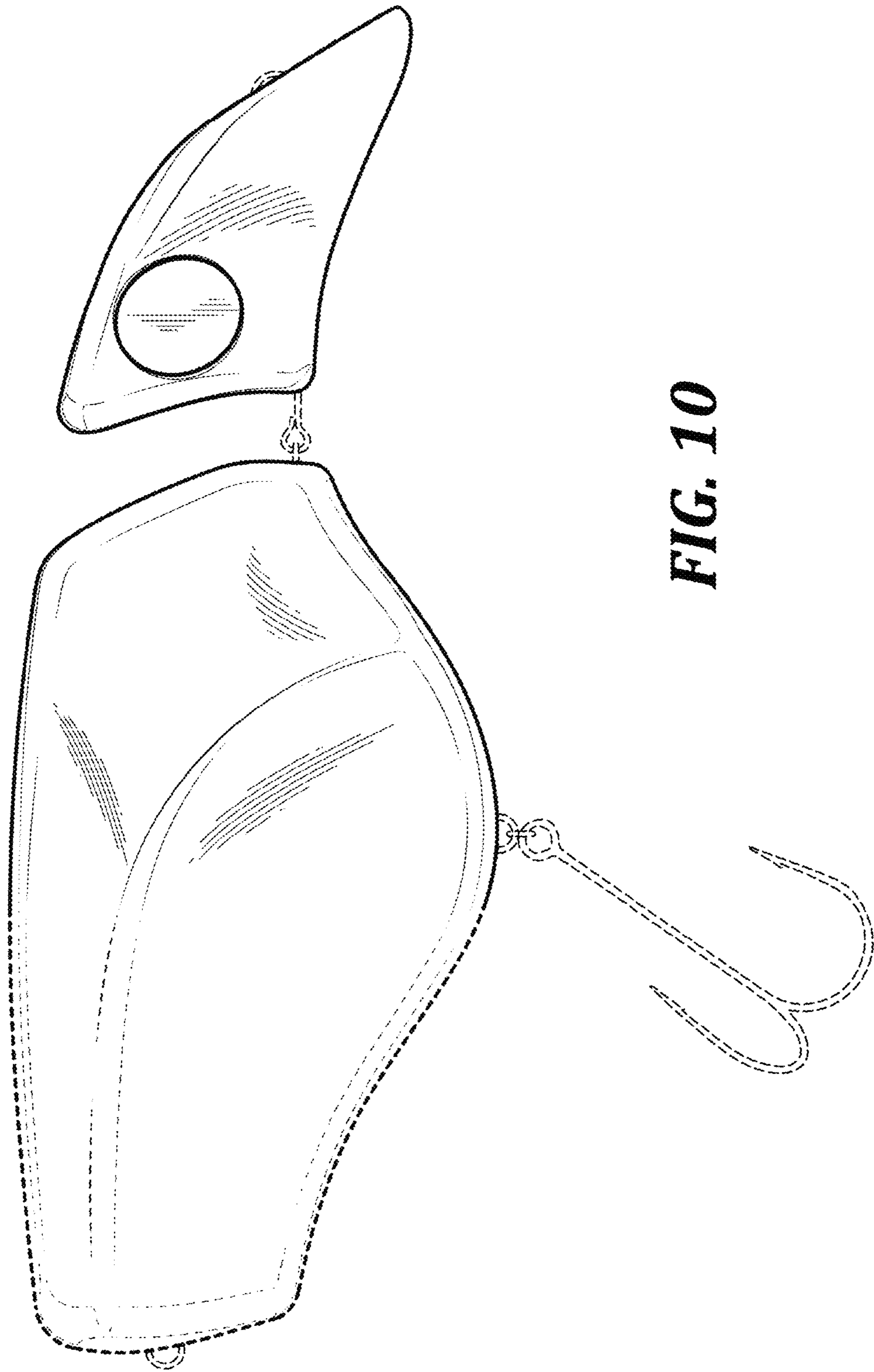

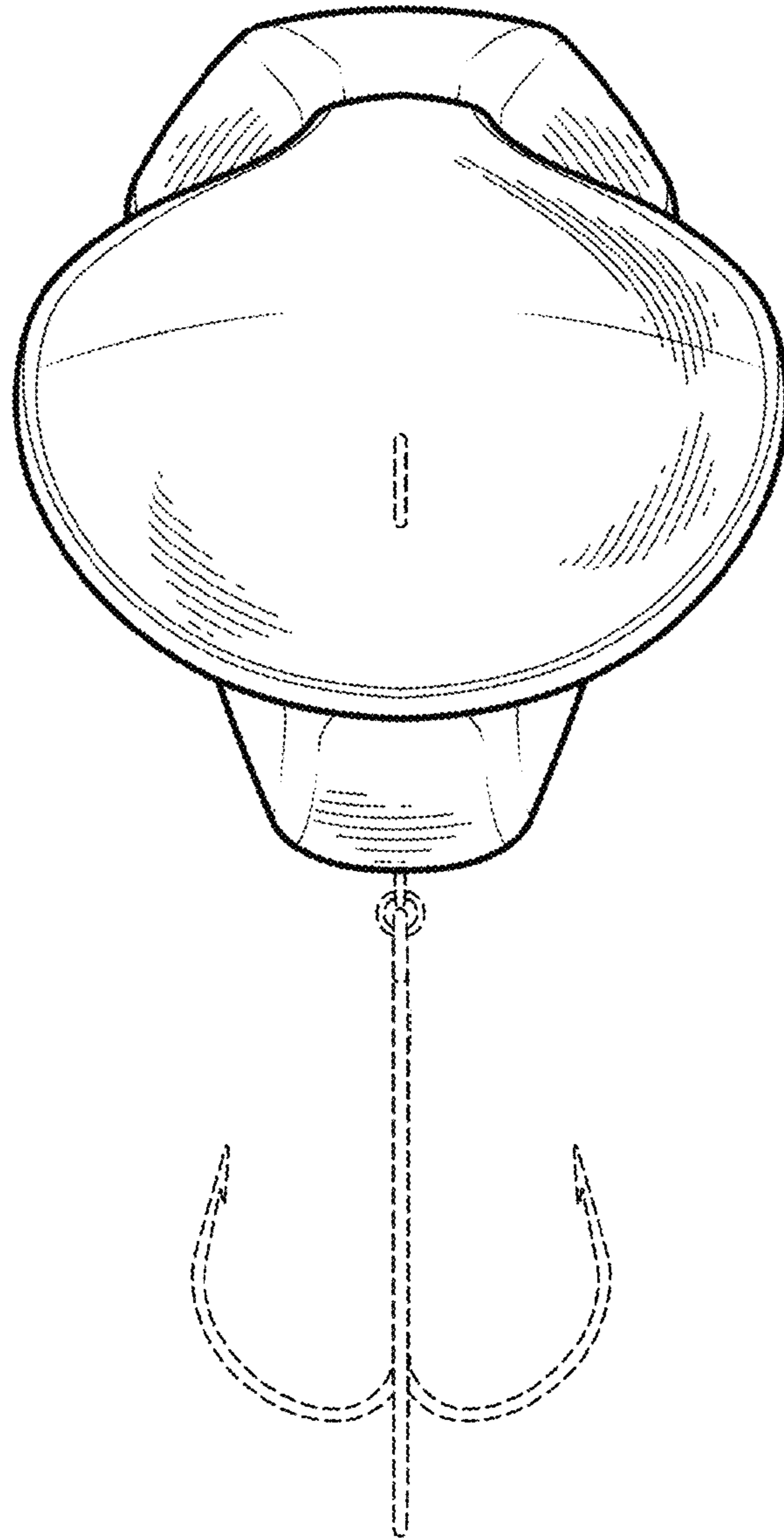

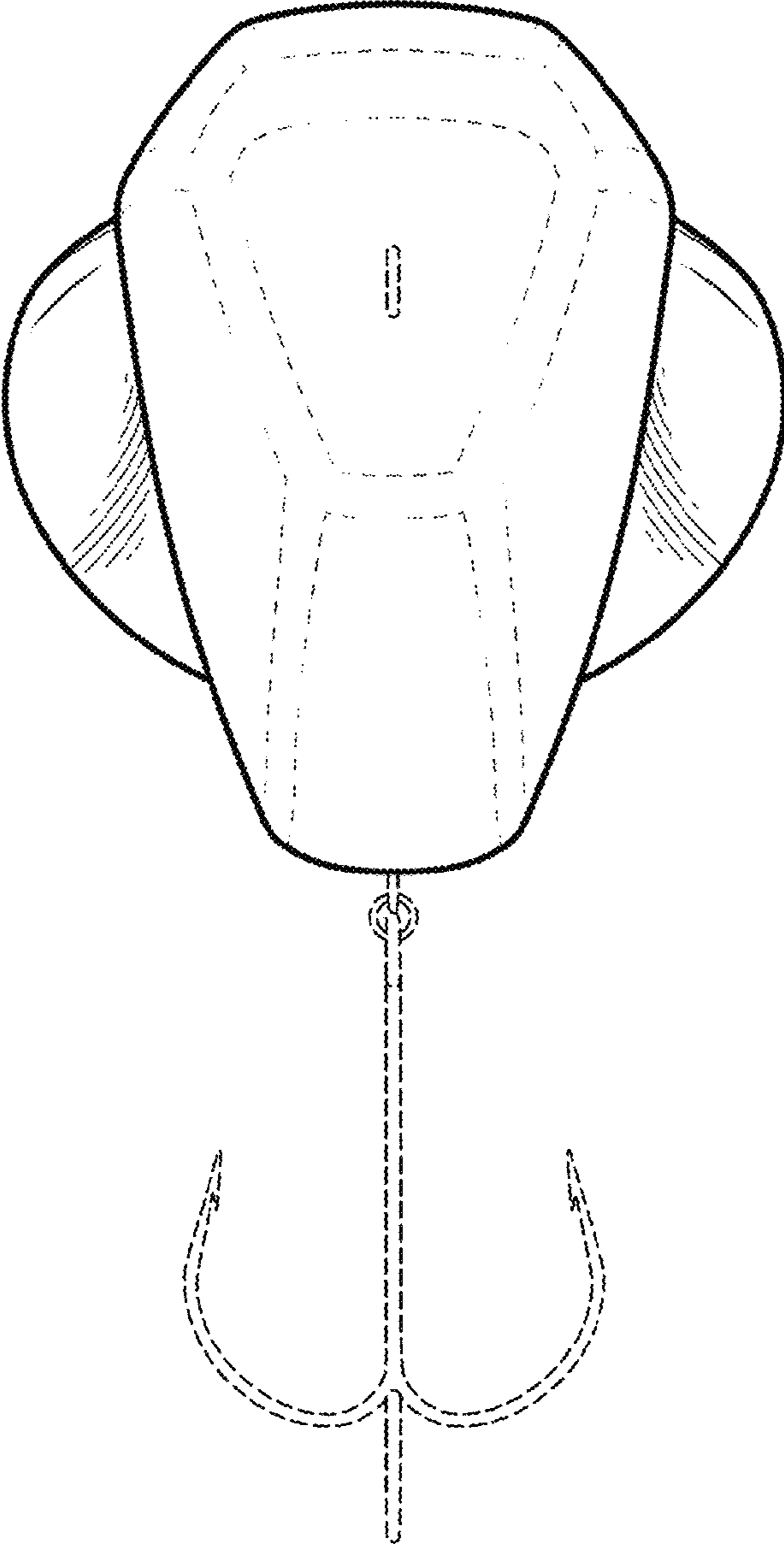

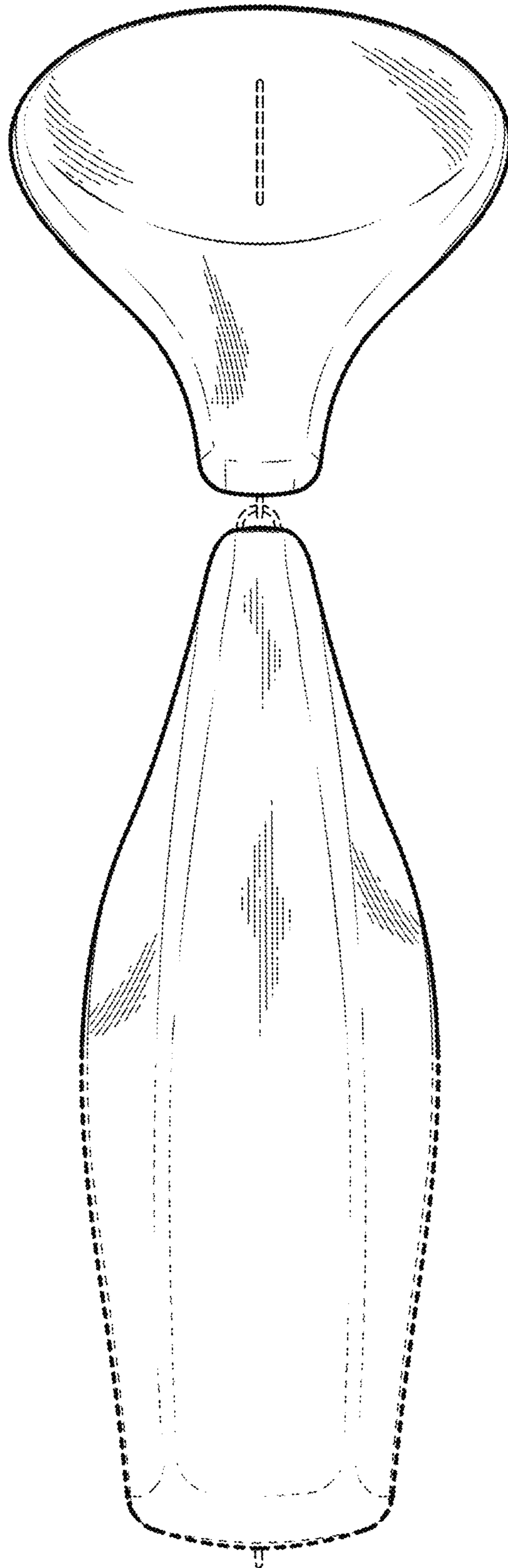

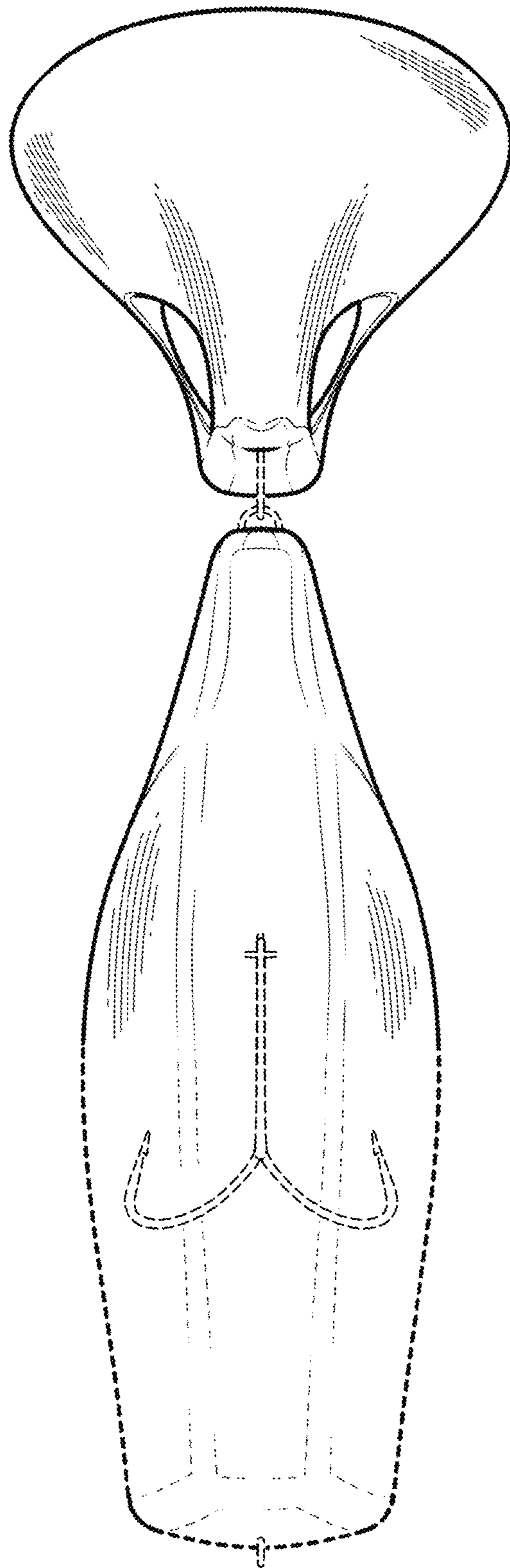
