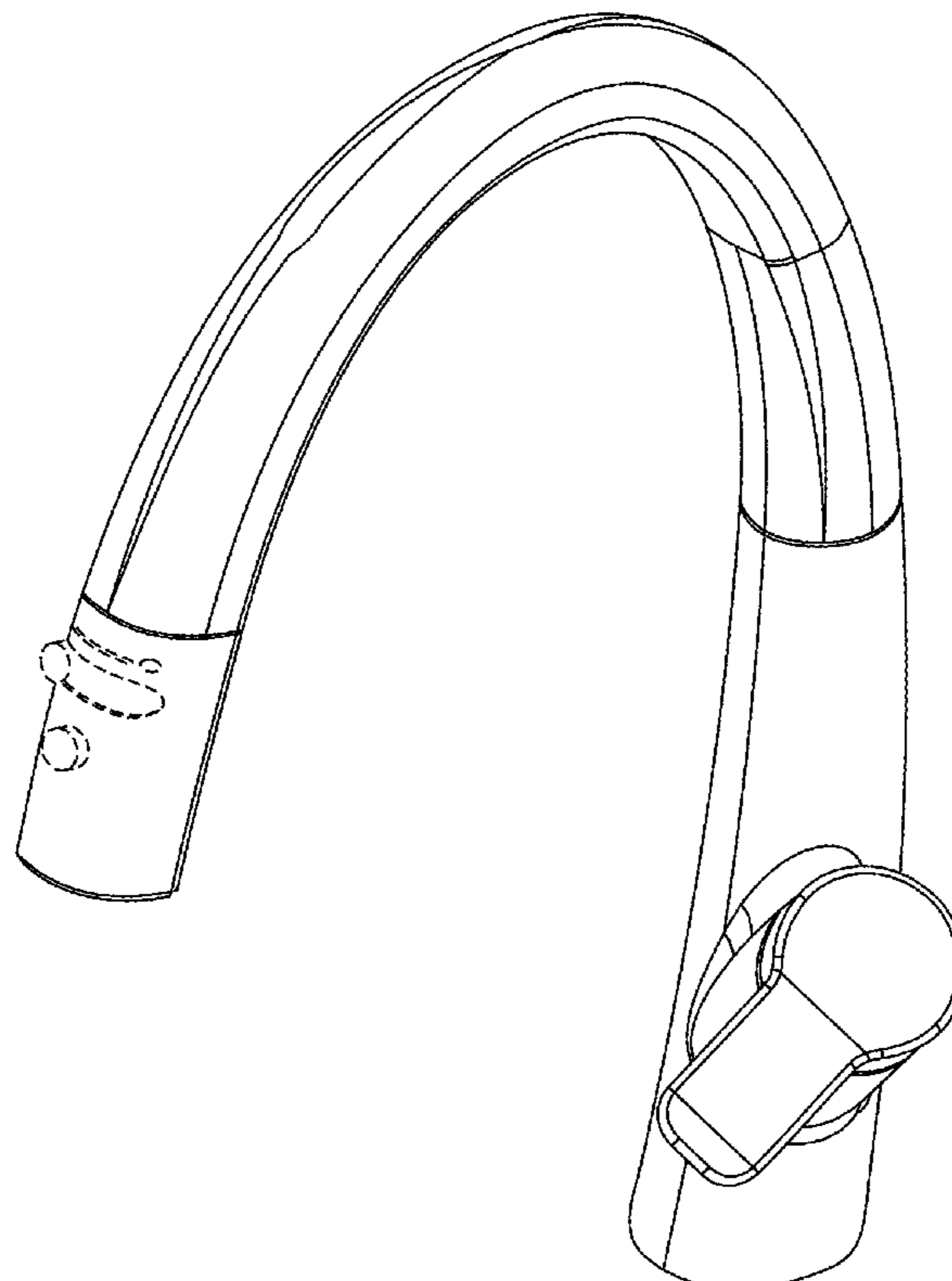
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a faucet in accordance with the present design;
FIG. 2 is a front elevational view thereof;

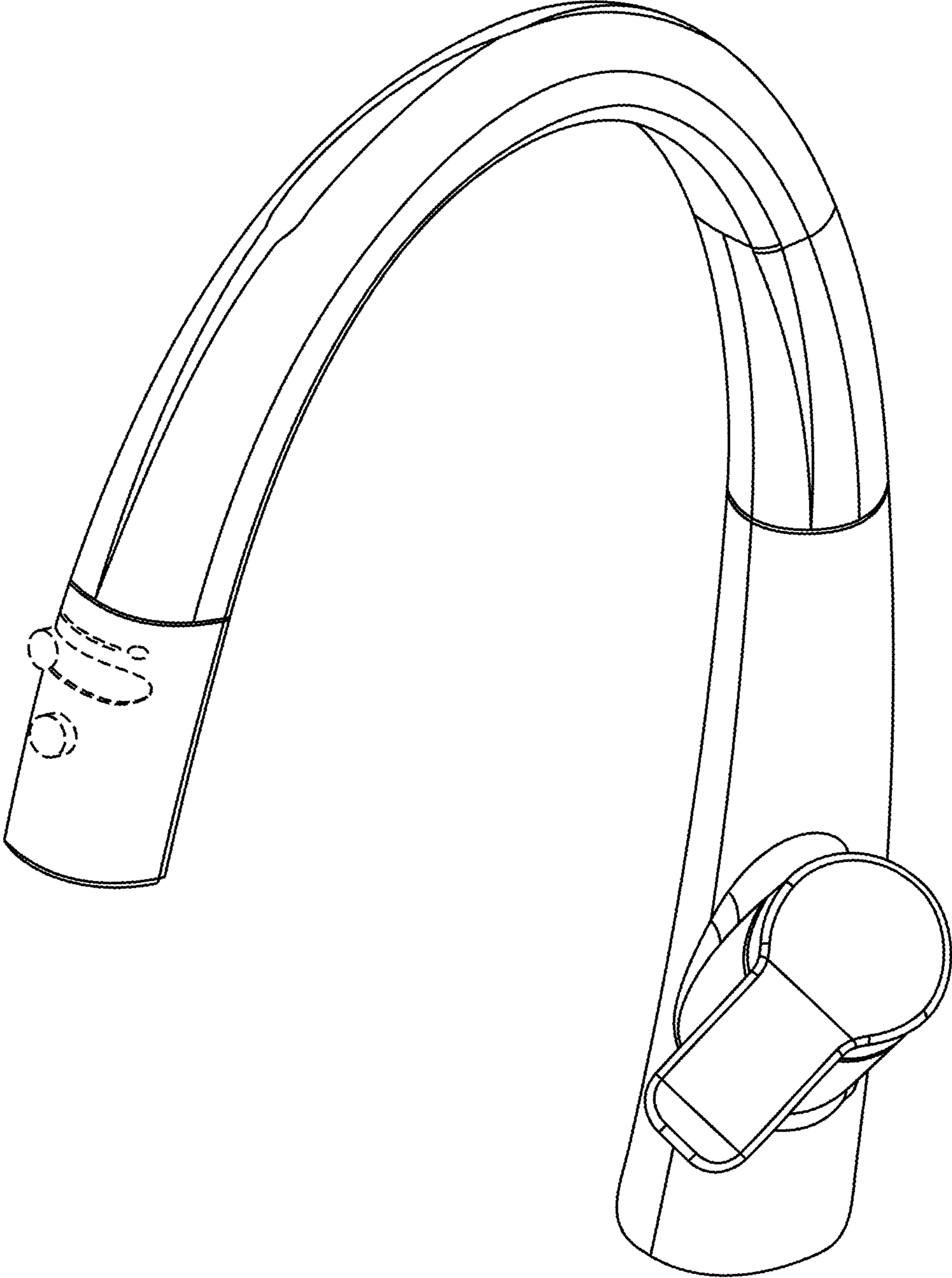

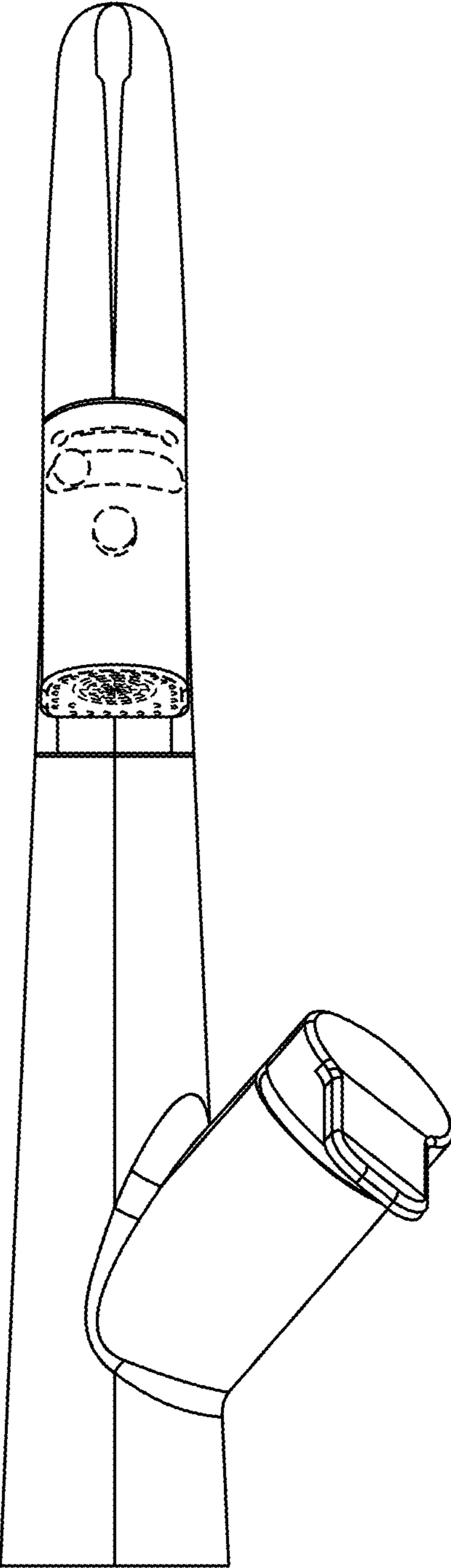

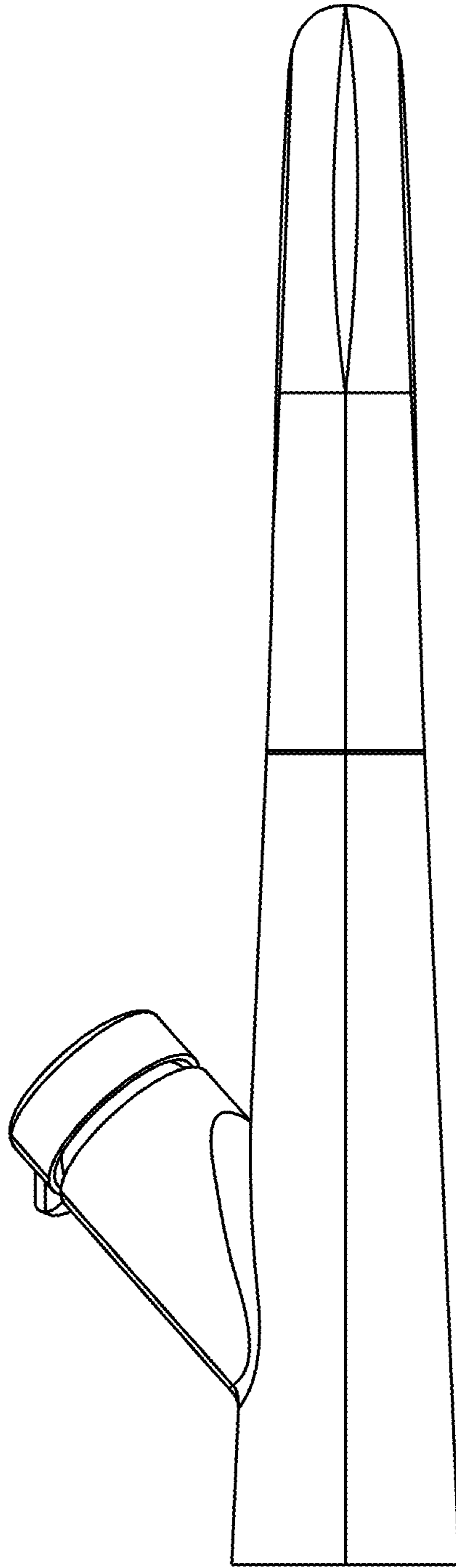

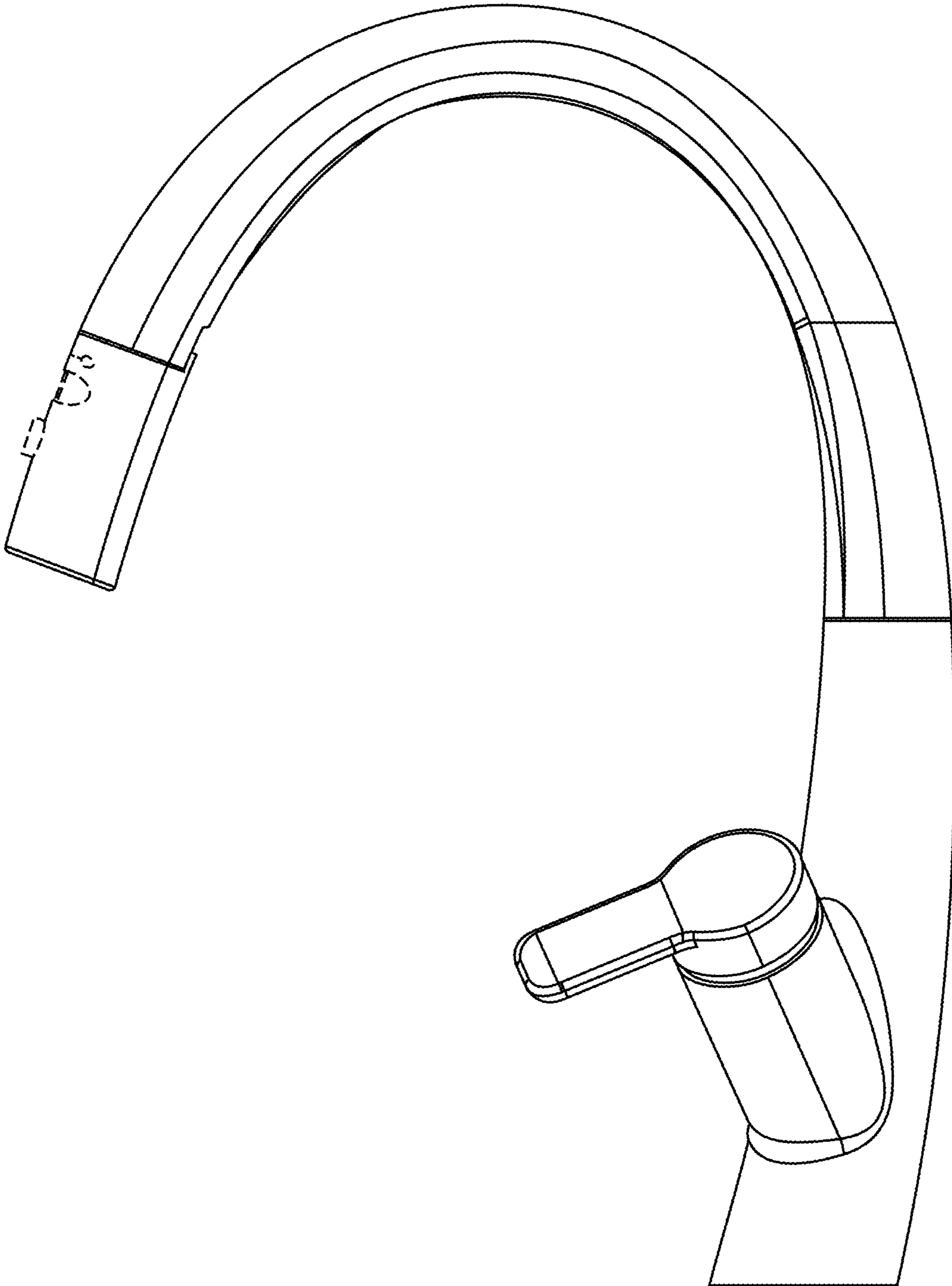

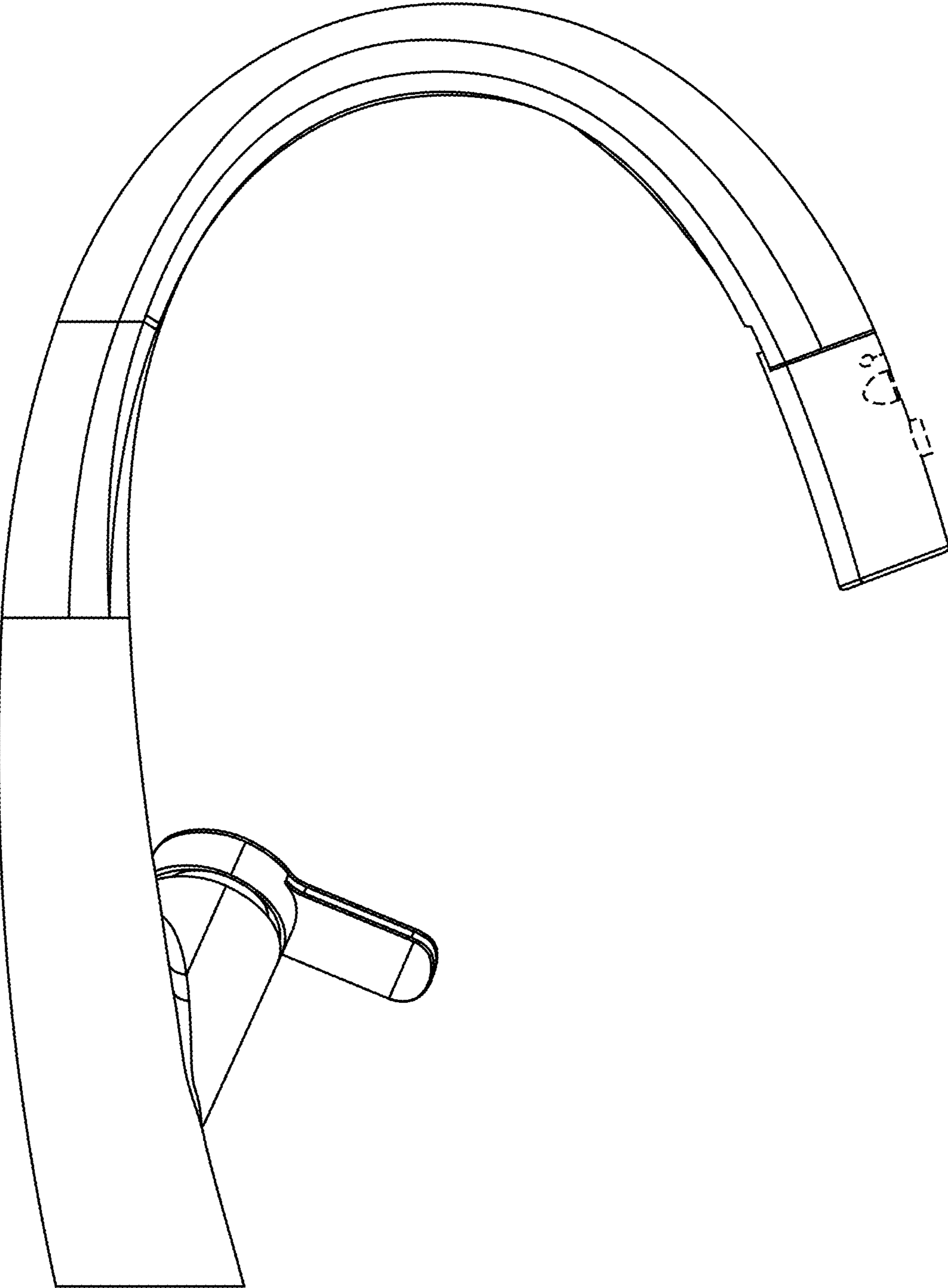

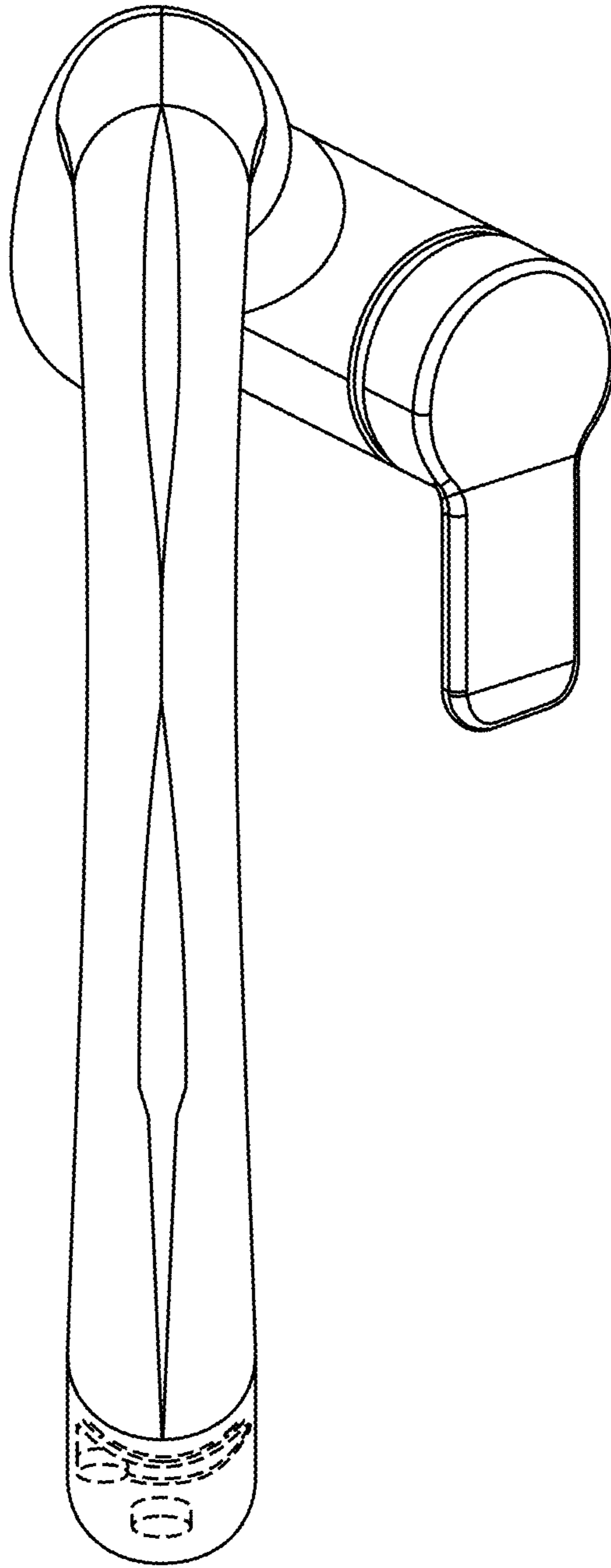

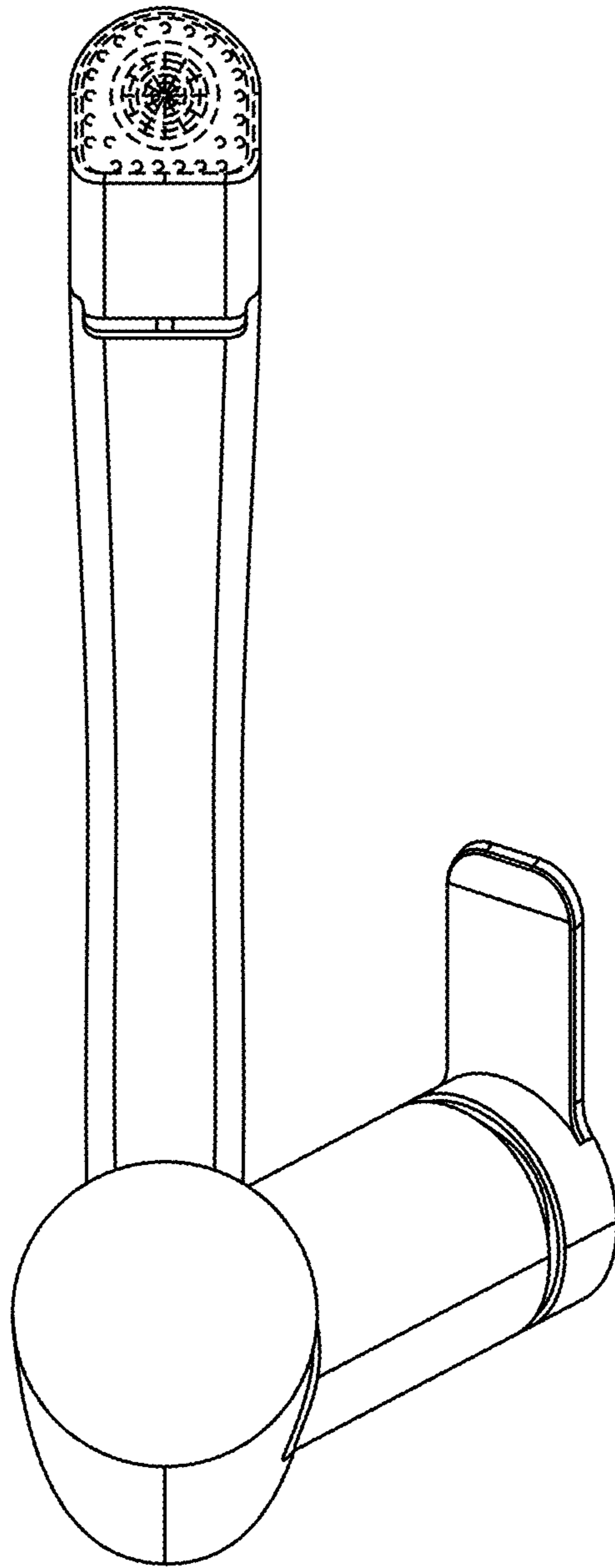
