**DESCRIPTION**

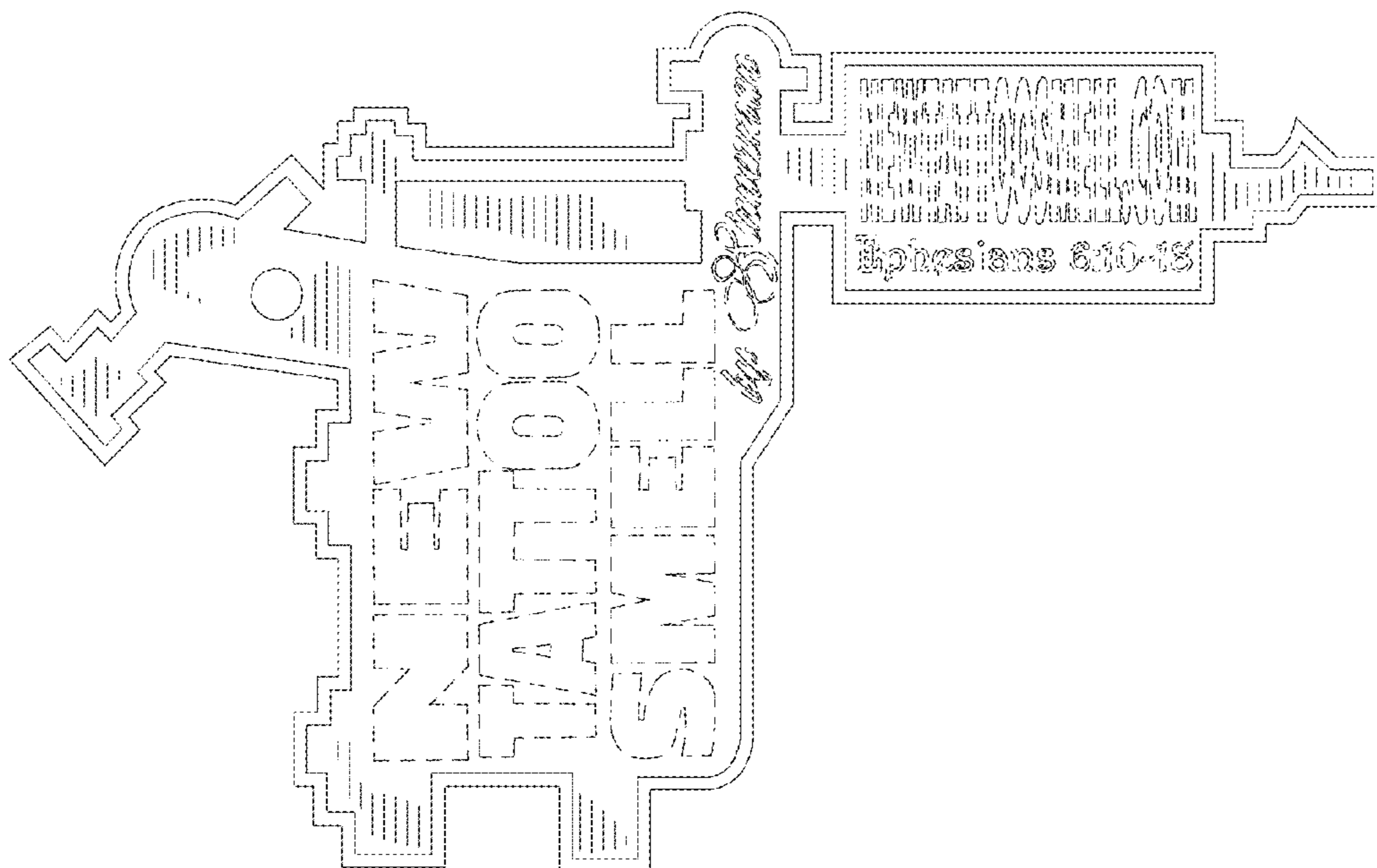
FIG. 1 is a top front elevation view of the air freshener card showing my new design;

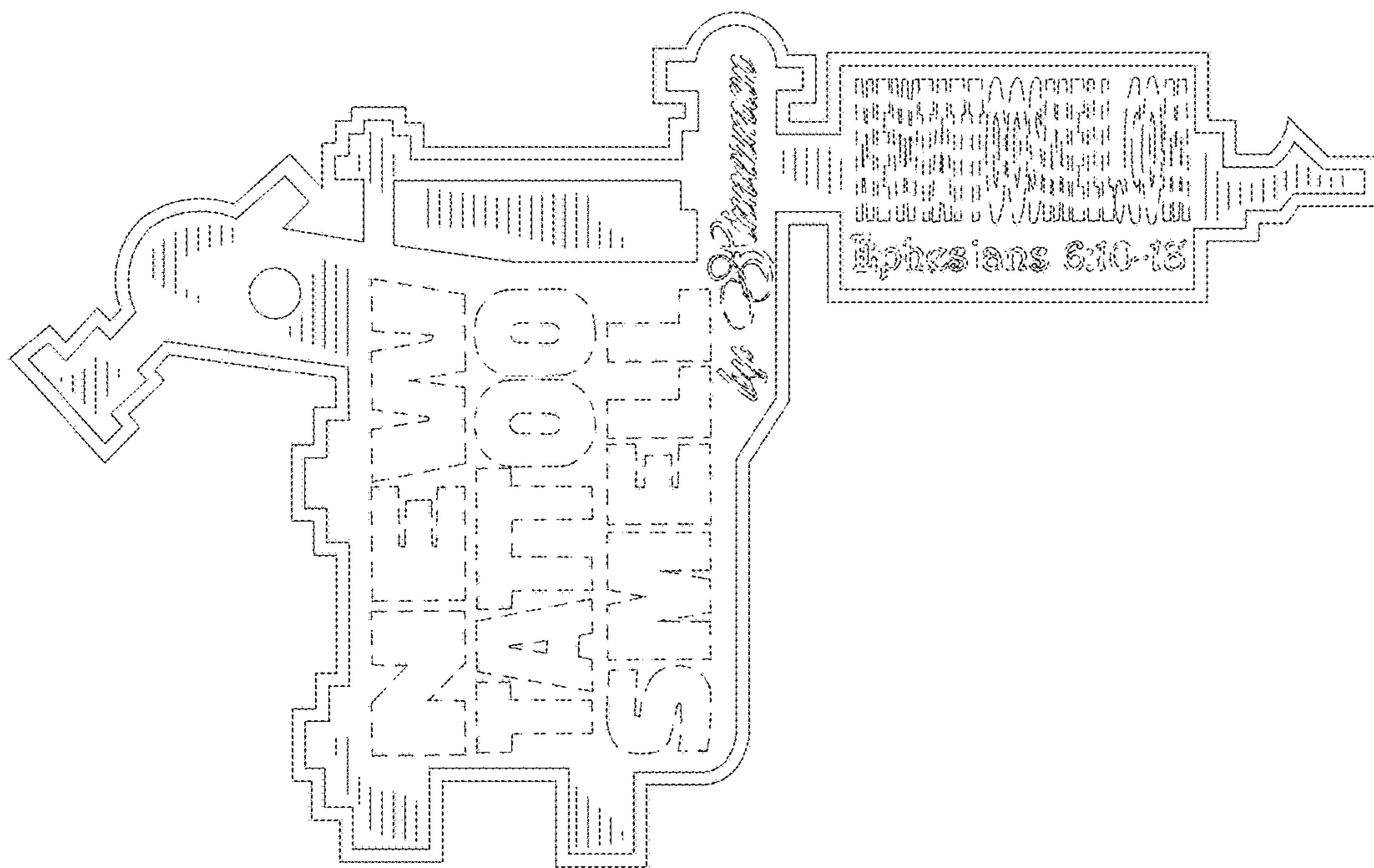

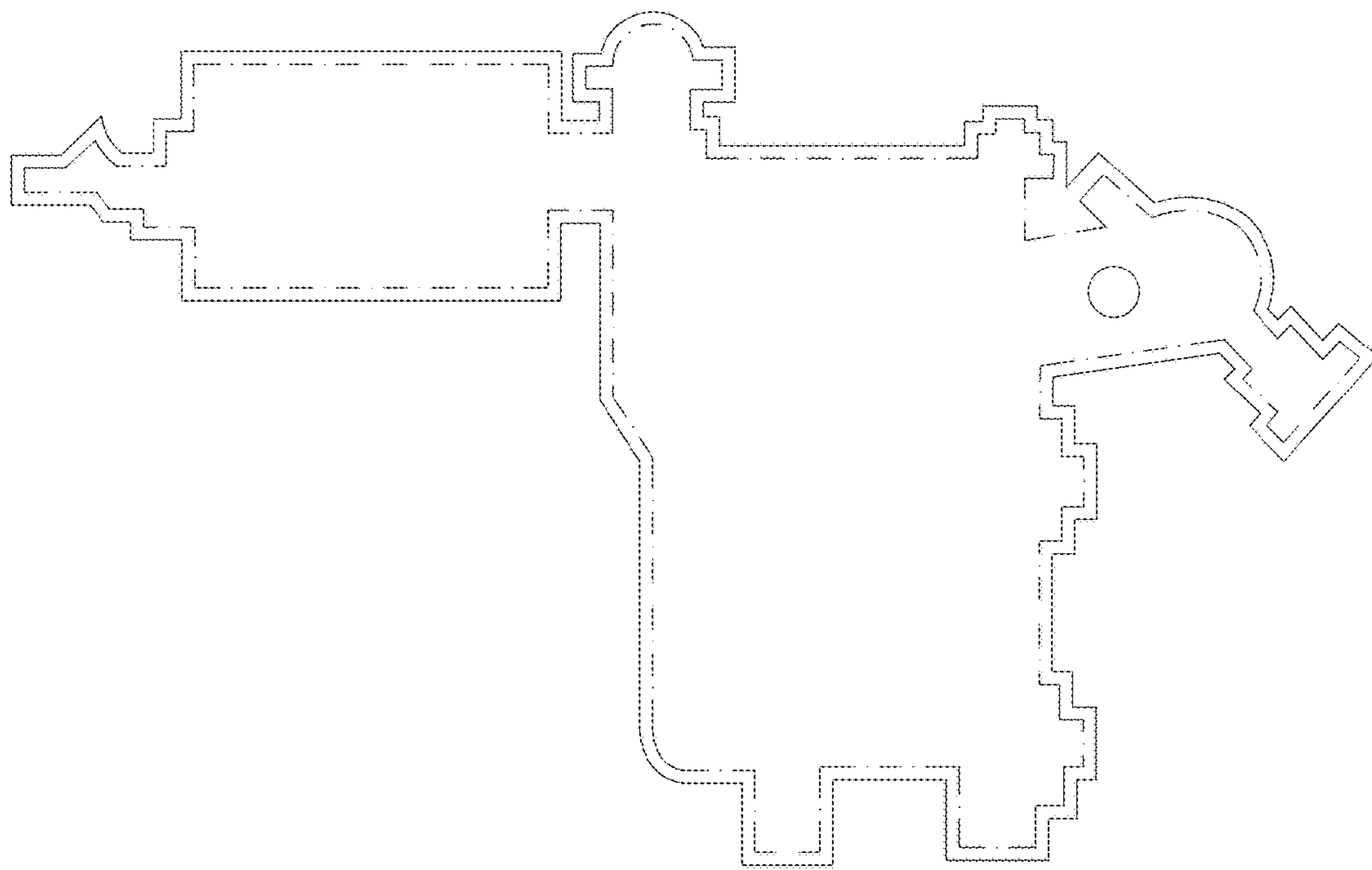

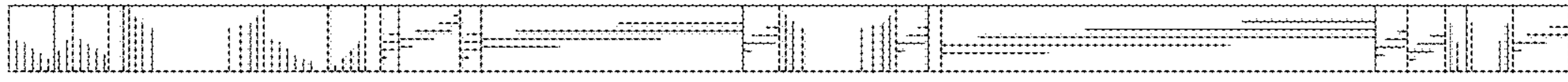

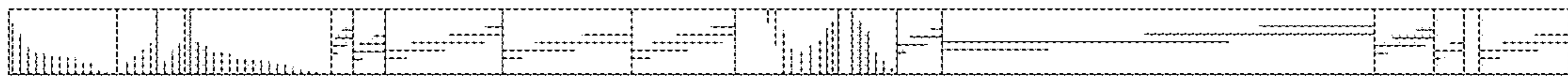

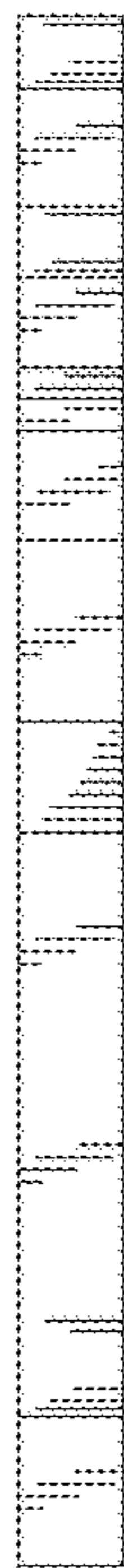

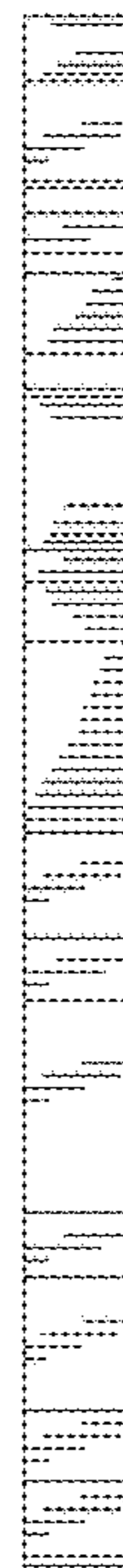

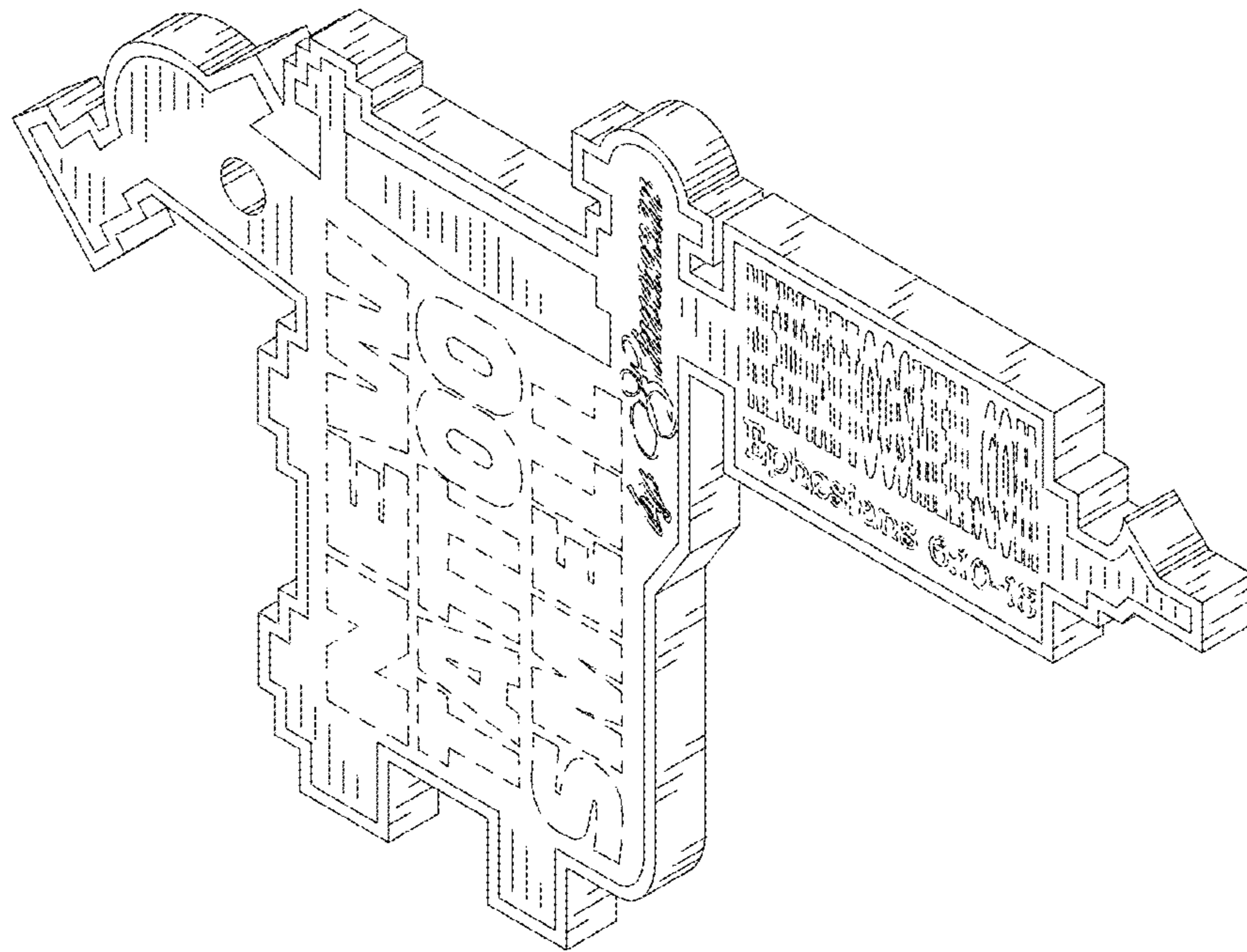
