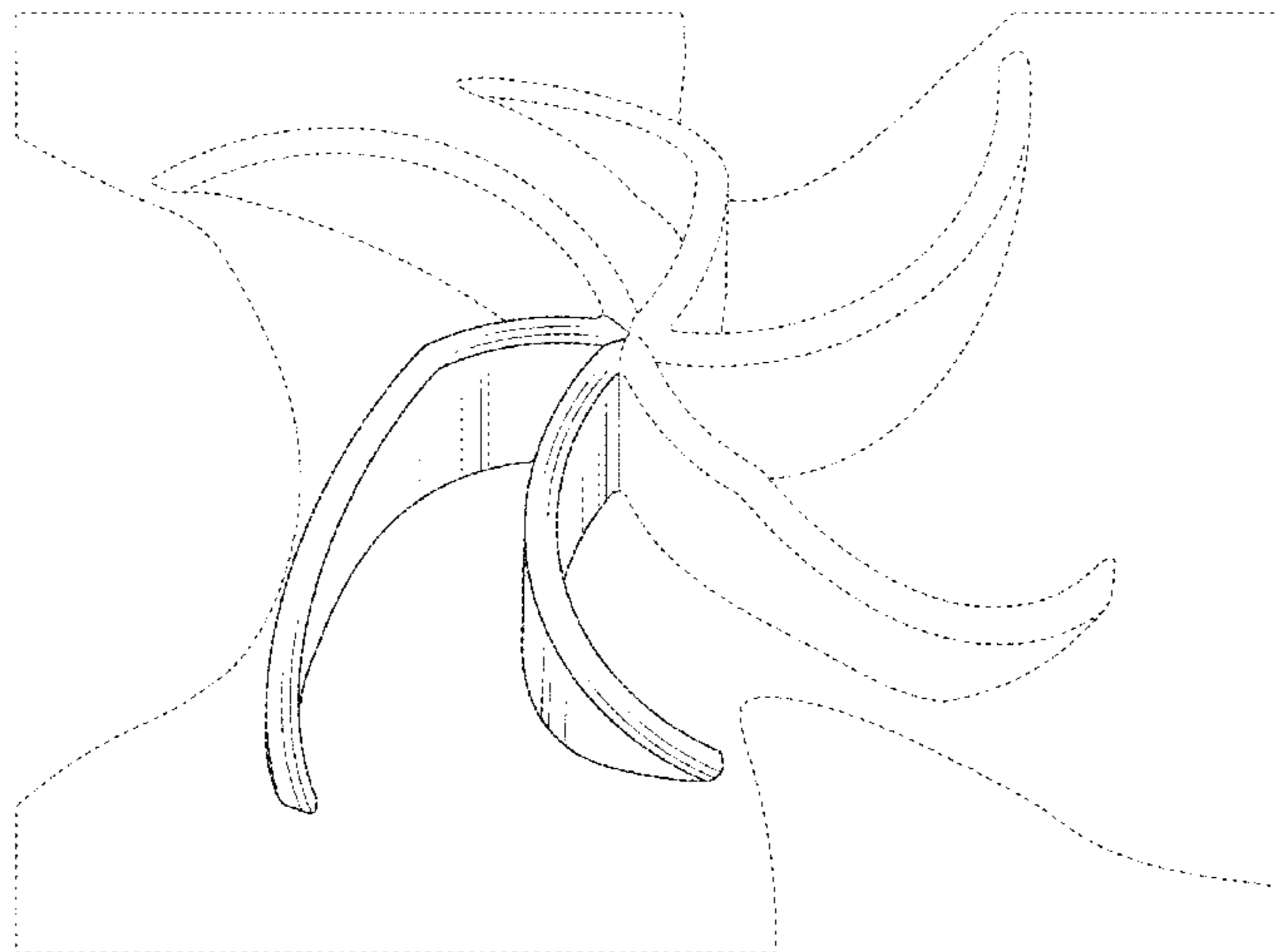
FIG. 1. is a front perspective view of the front, right, and bottom sides of a propeller fan showing an initial embodiment of our new design;

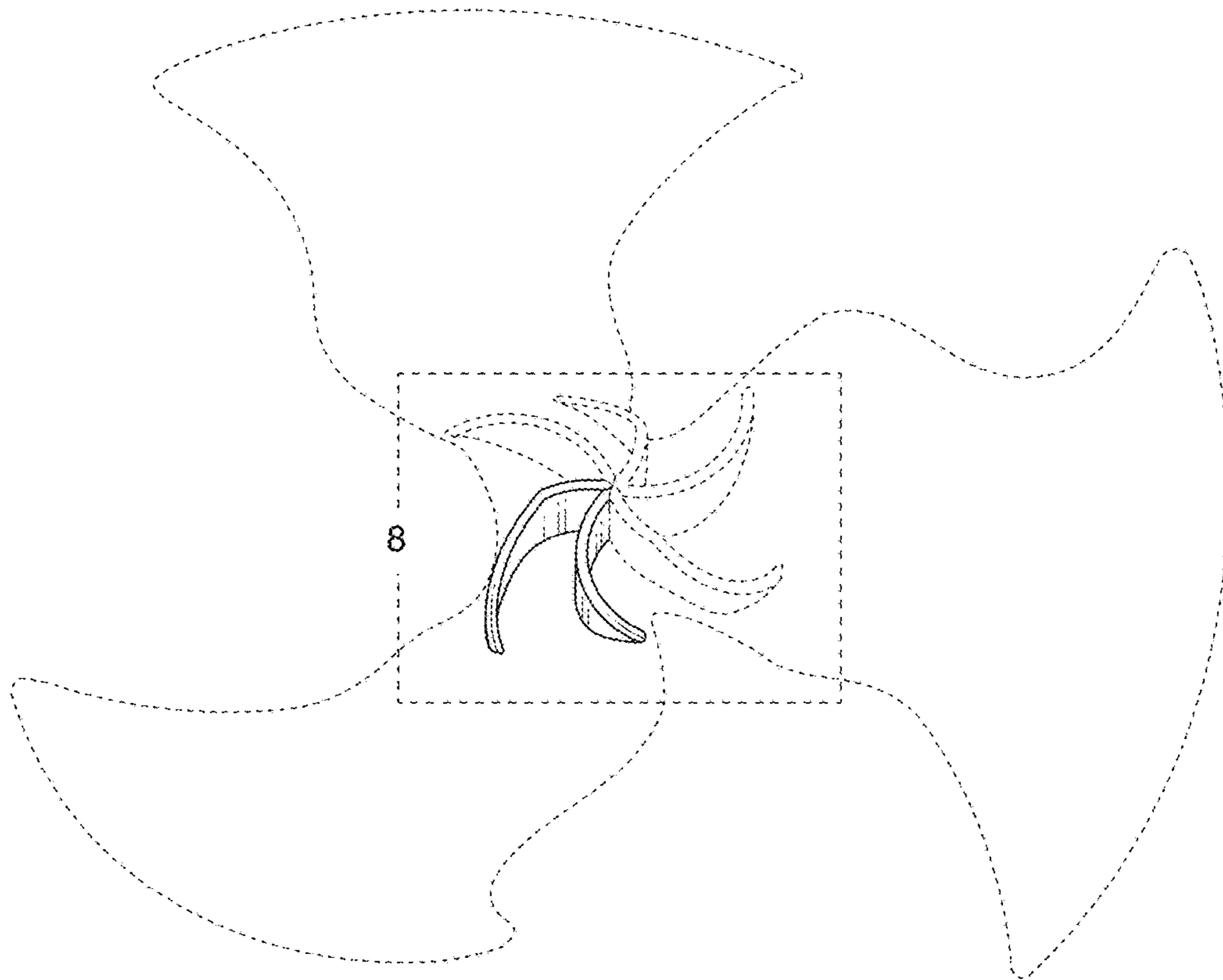

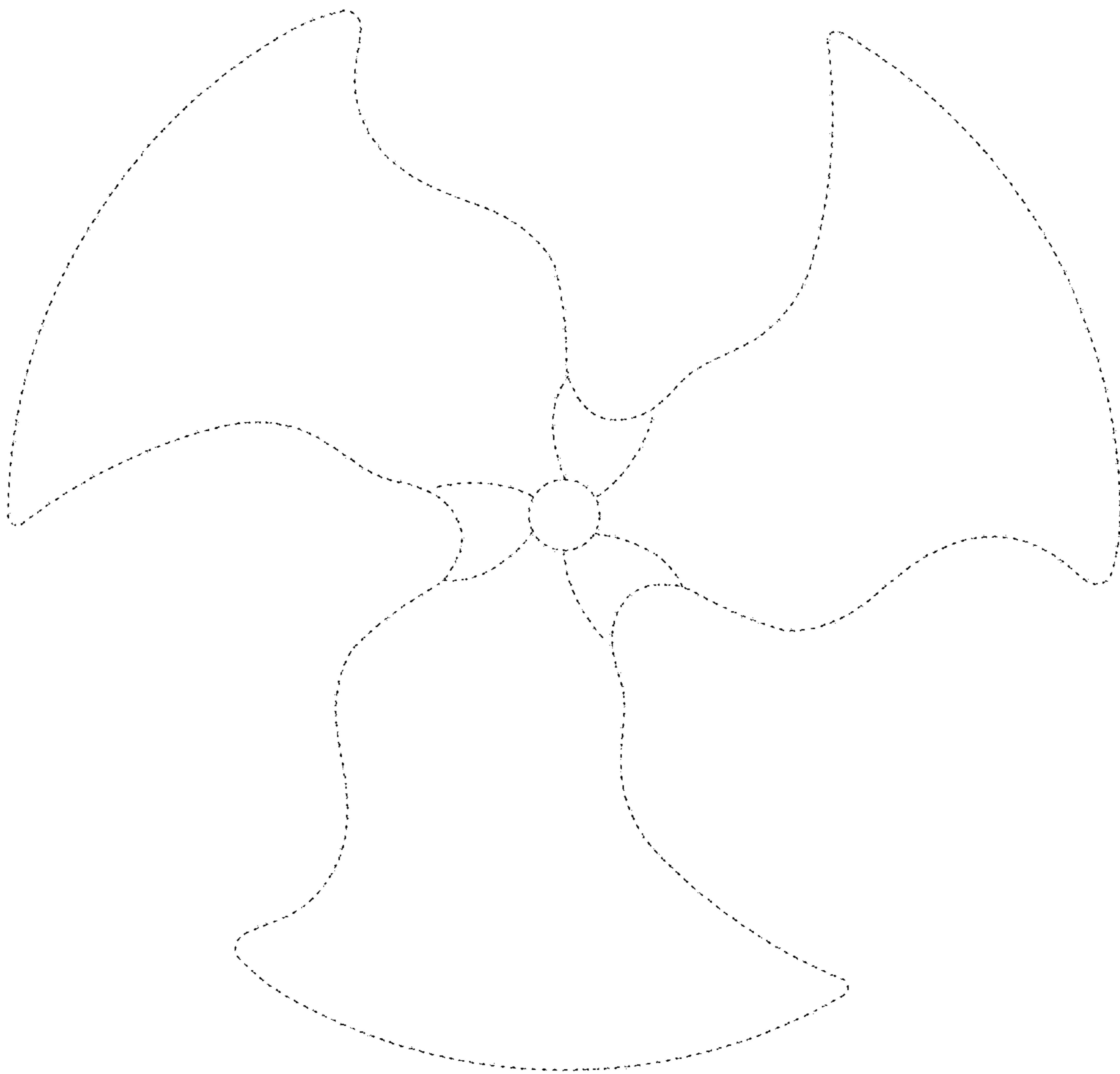

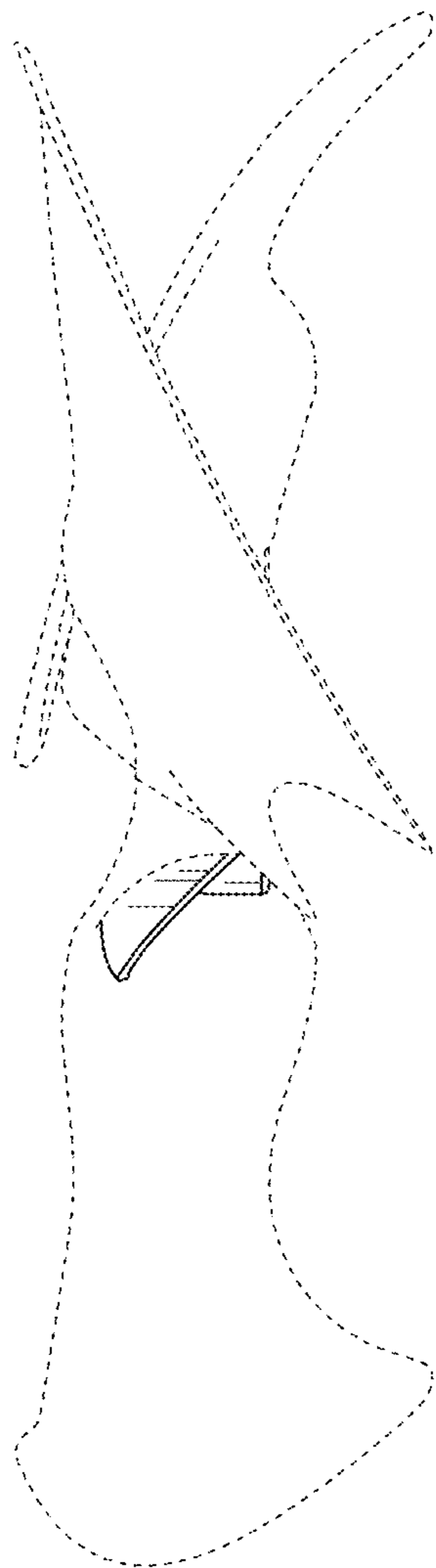

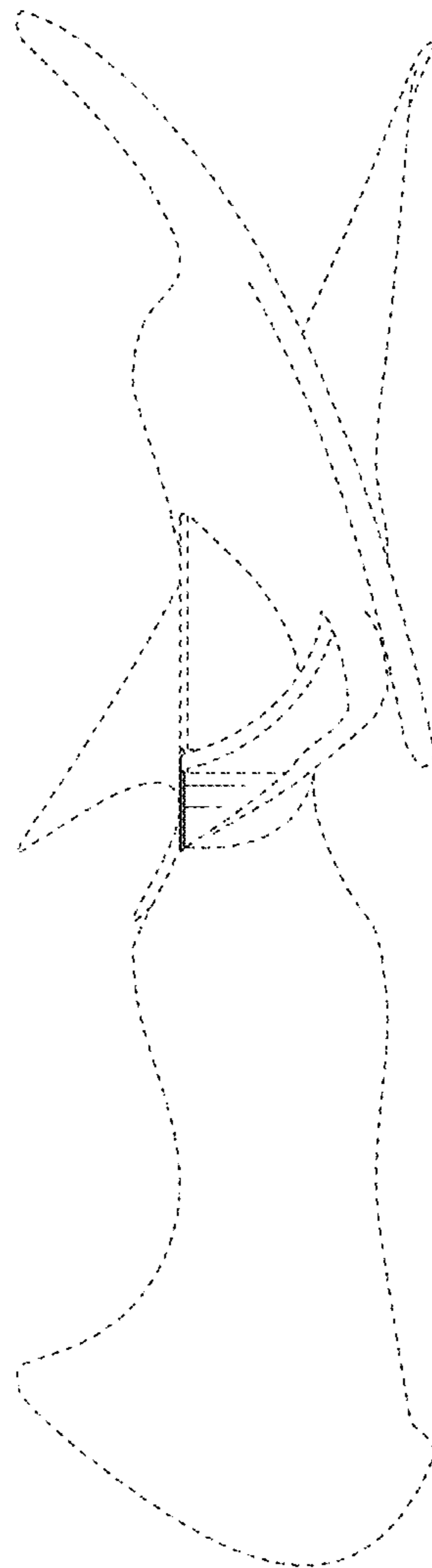

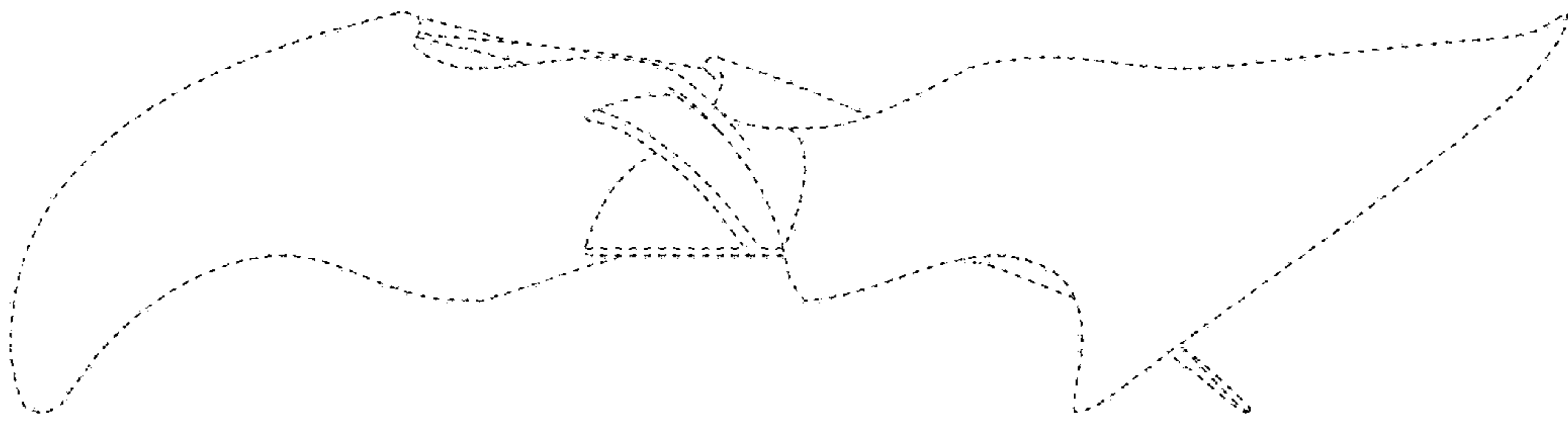

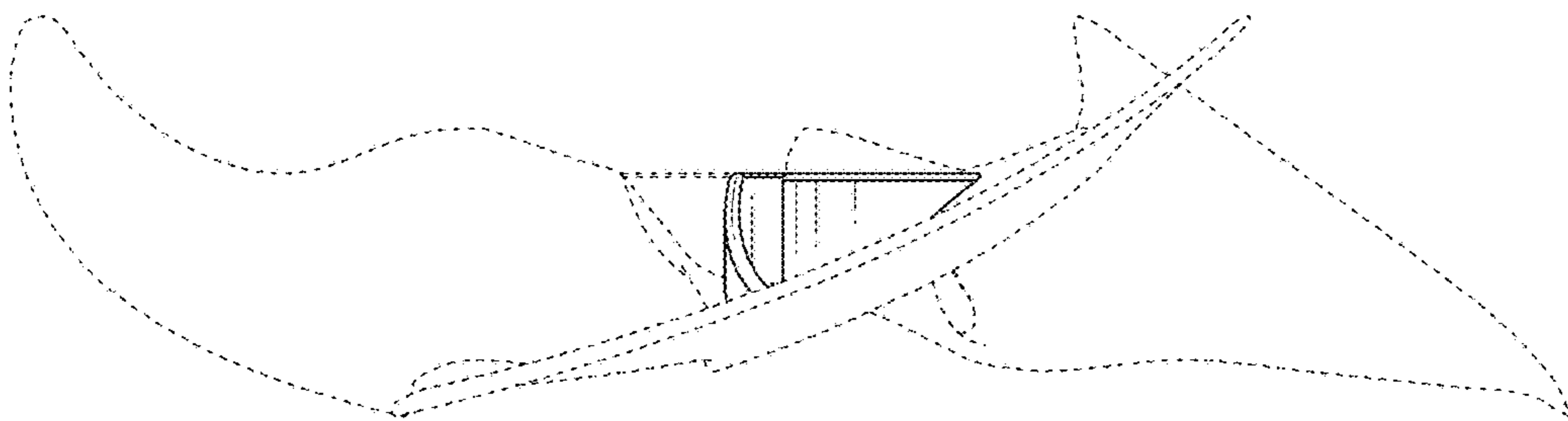
