DESCRIPTION

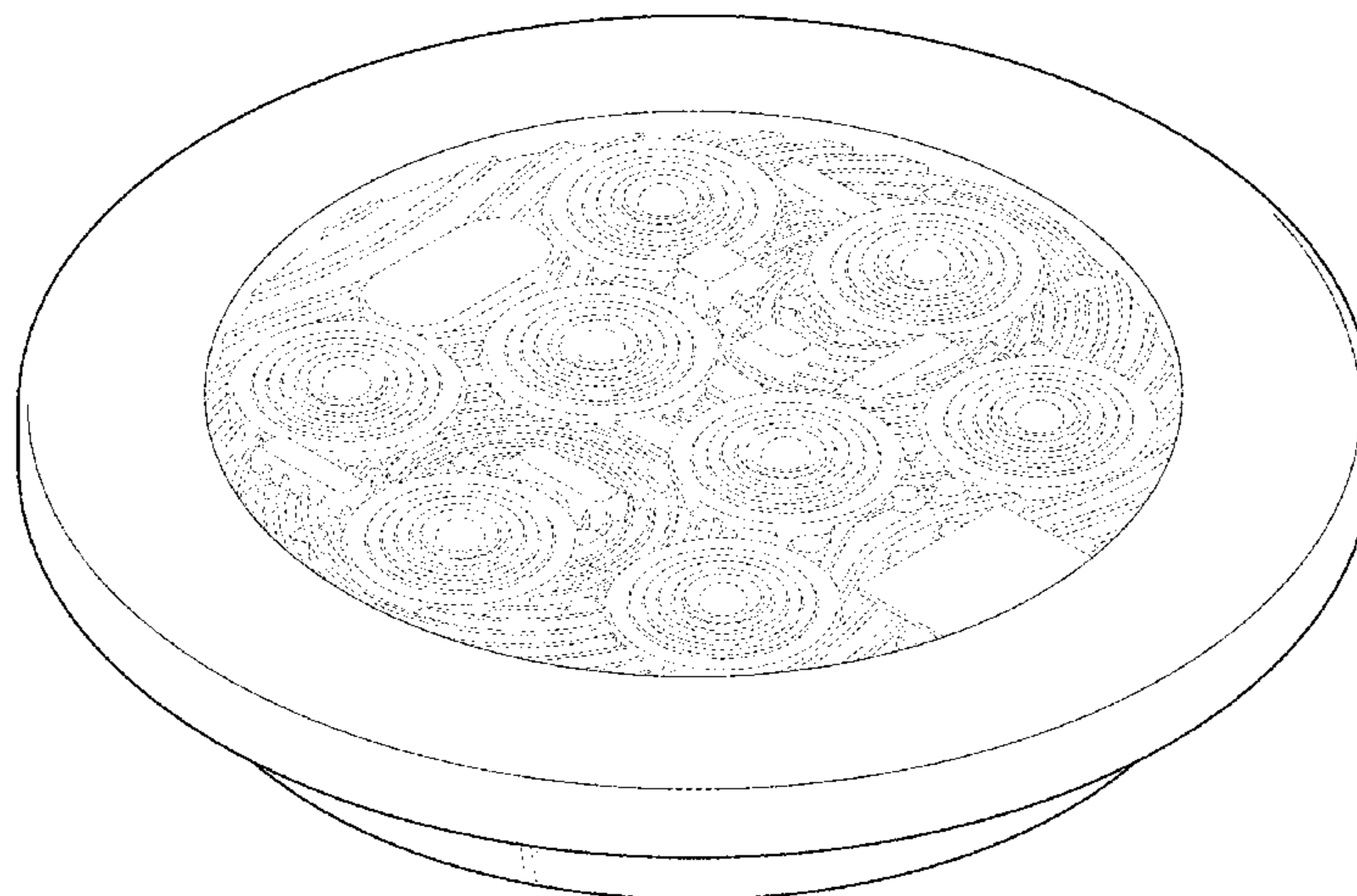
FIG. 1 is a perspective view of a vehicle lamp embodying the design.

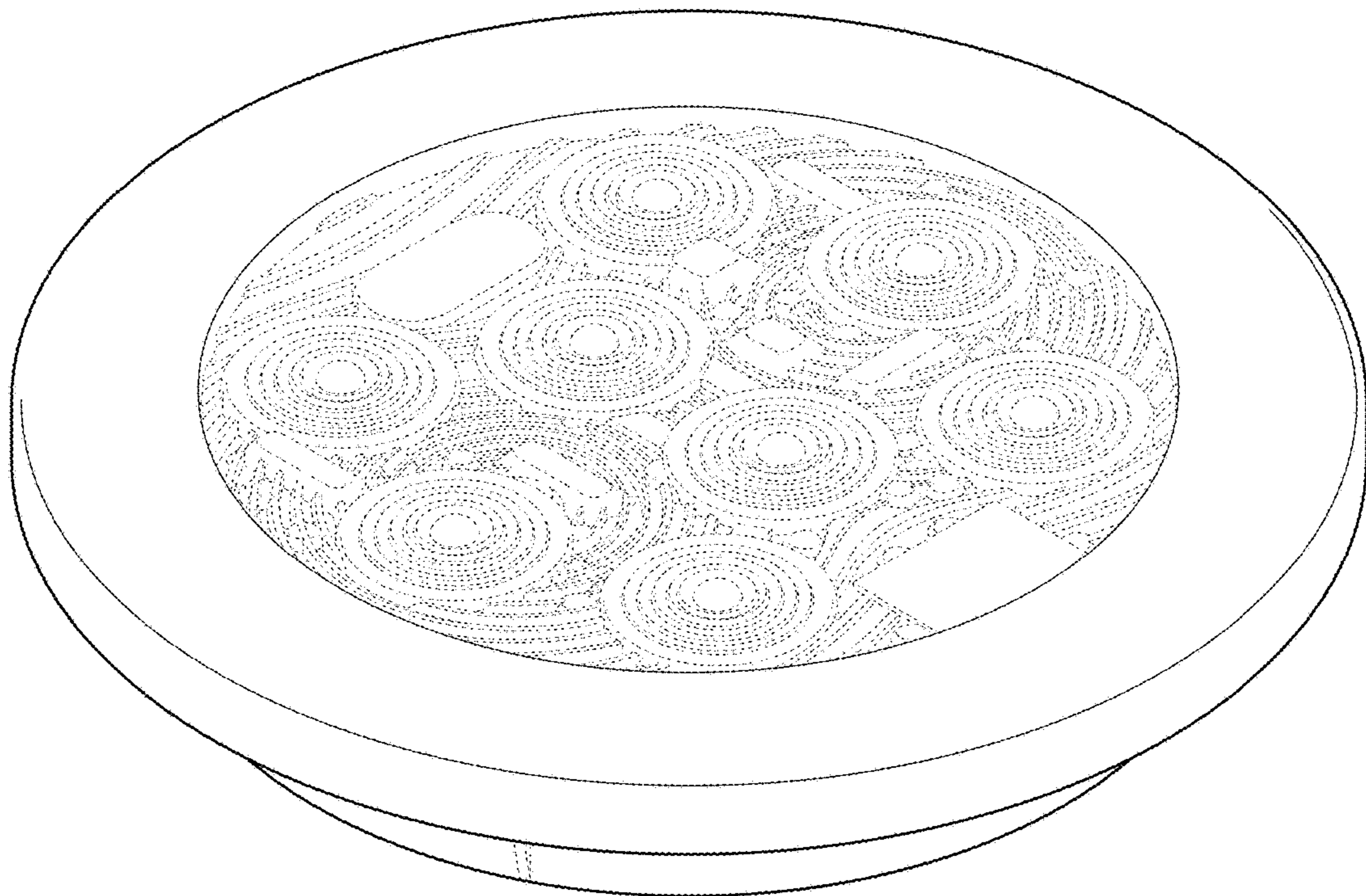

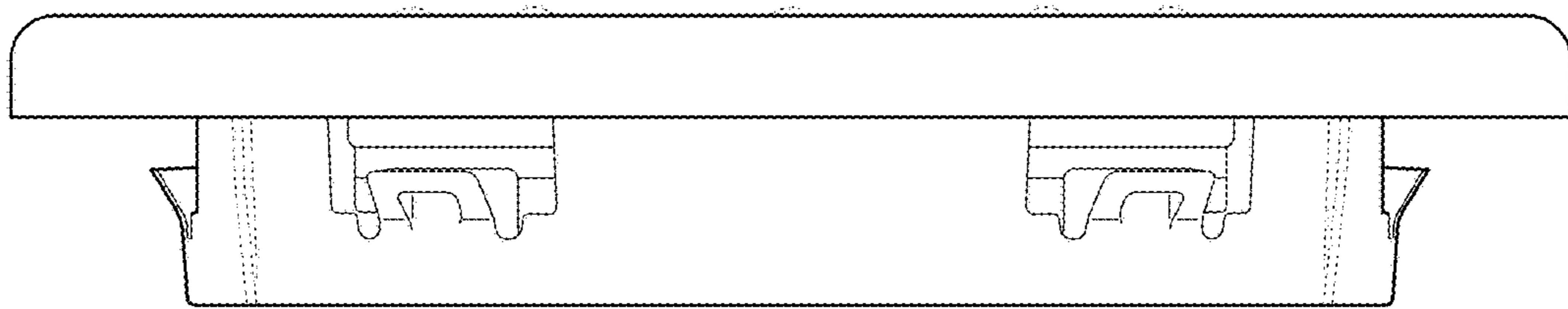

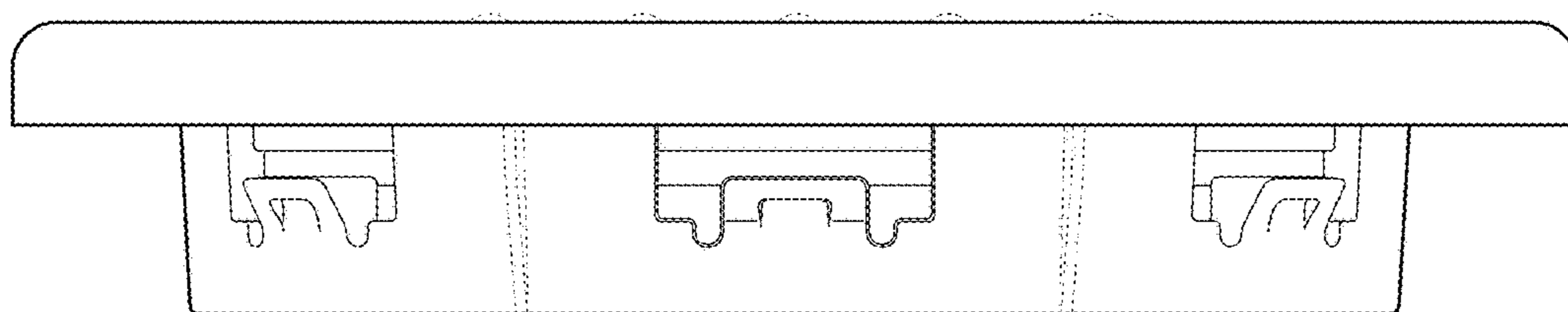

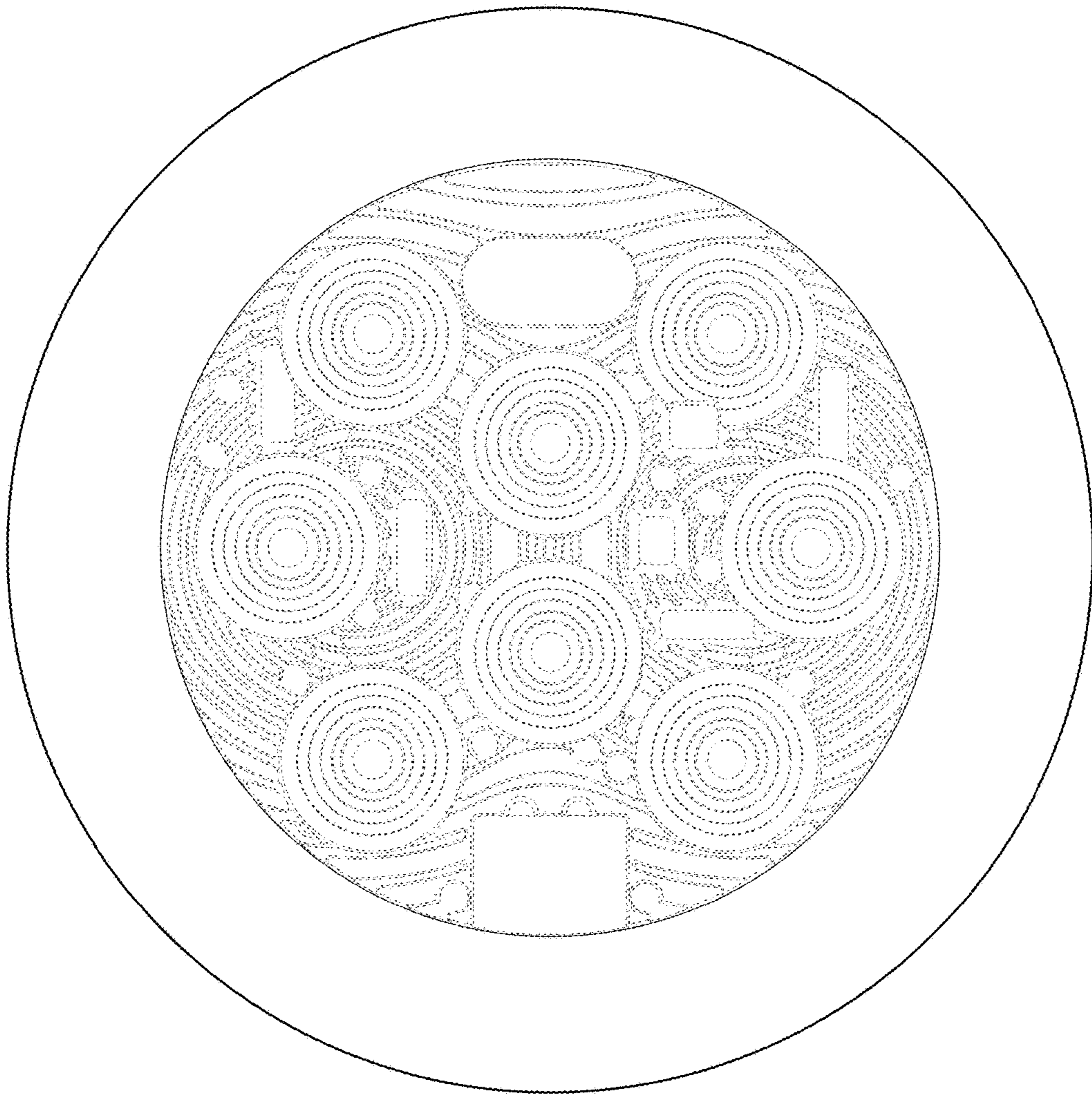

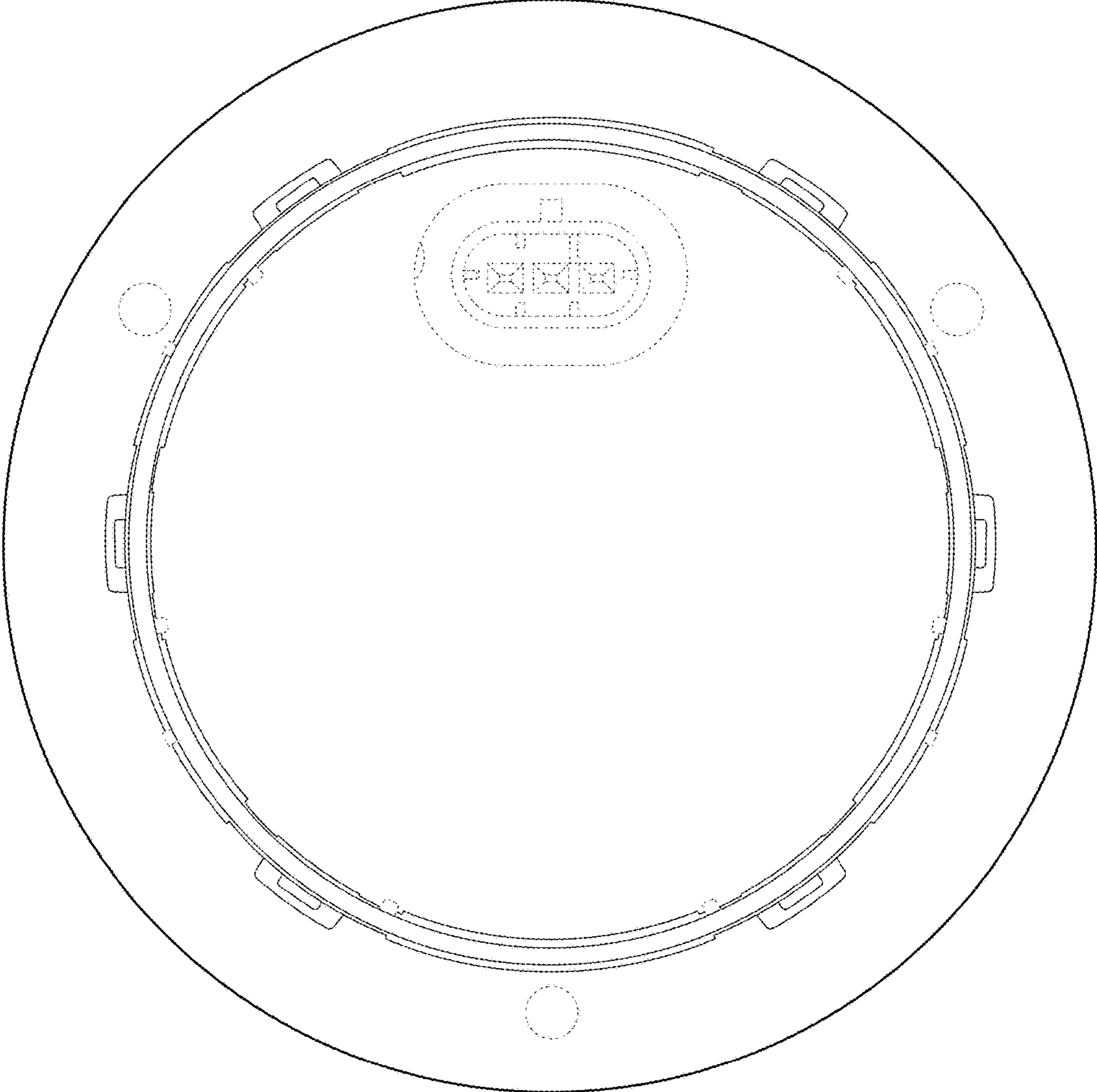
