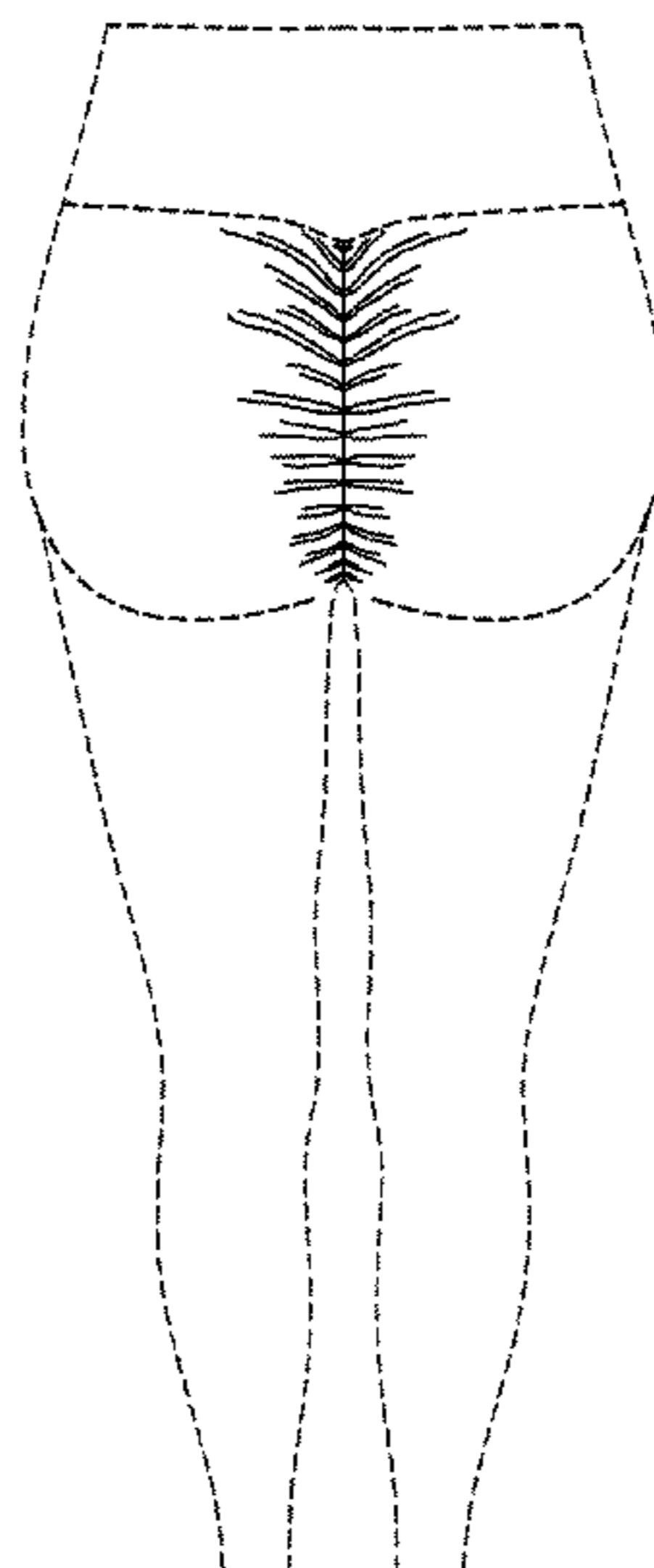
(57) **CLAIM**

The ornamental design for leggings, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the leggings showing the new design;
FIG. 2 is a rear view of the leggings; and,
FIG. 3 is a left side view of leggings, with the right side view being a mirror image of the left side view.
The broken lines shown in the drawings represent portions of the leggings that form no part of the claimed design. The front of the leggings which is not shown forms no part of the claimed design.

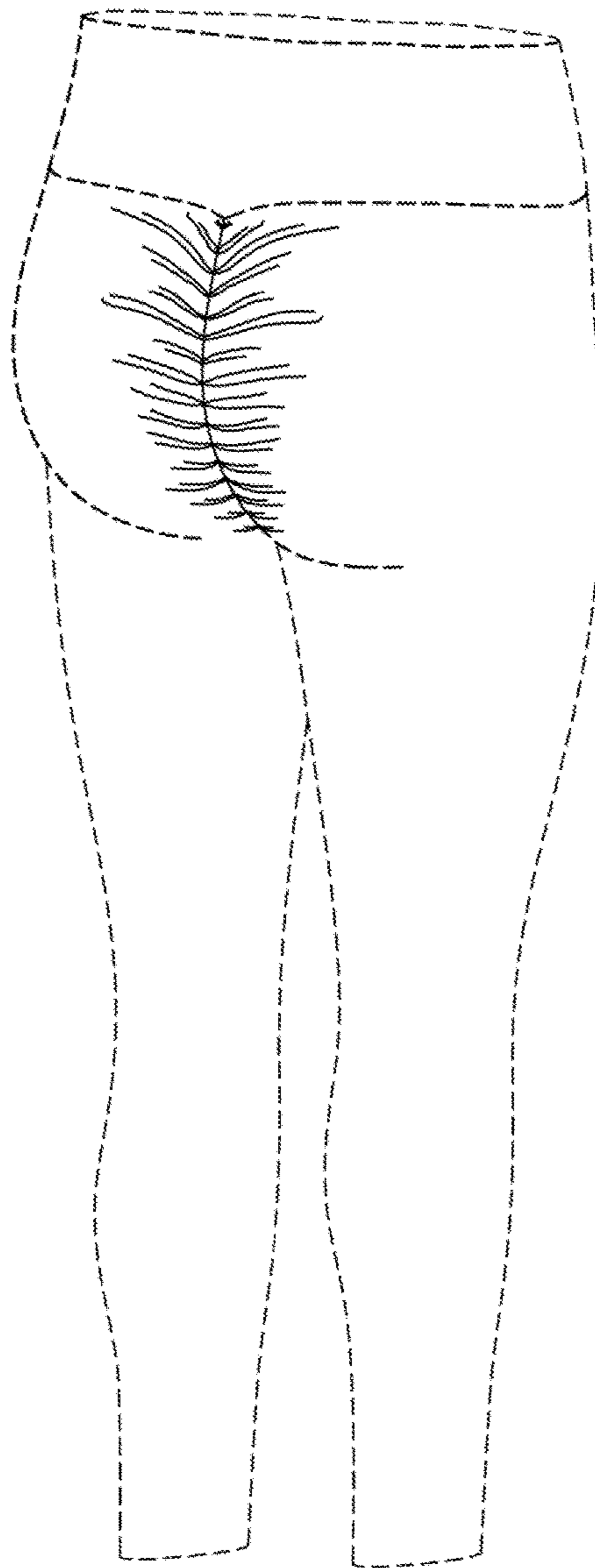

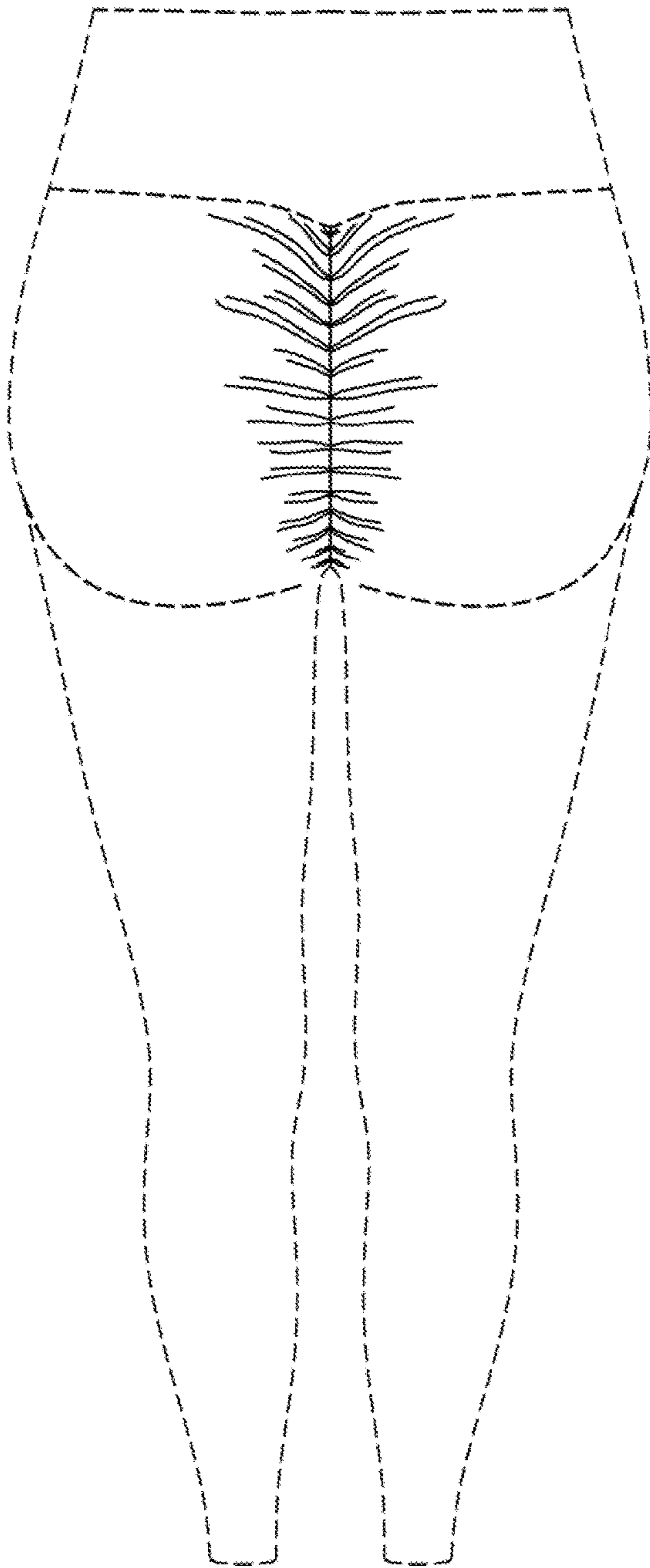

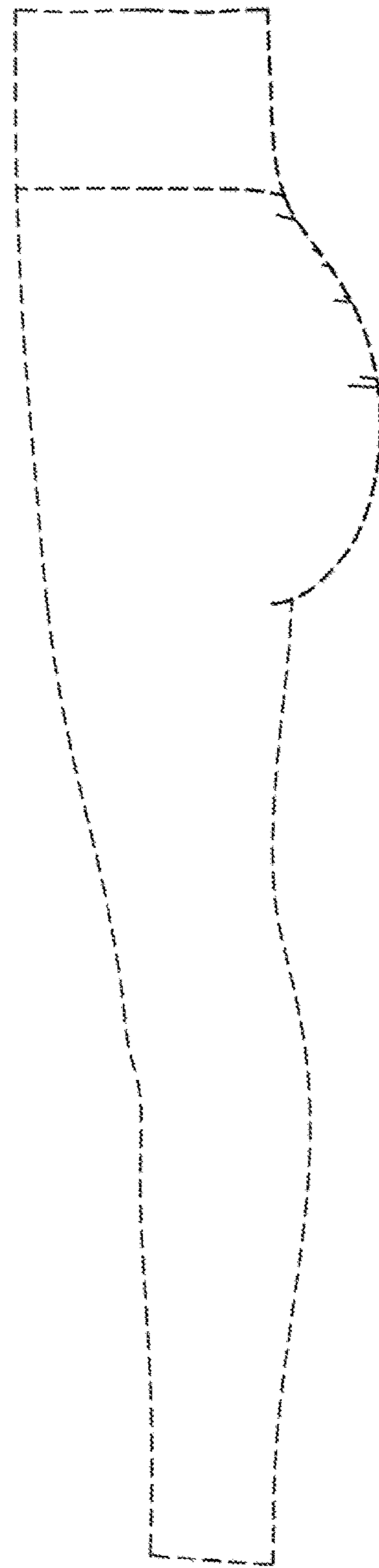
