The ornamental design for a hooded cape wrap, as shown and described.

**DESCRIPTION**

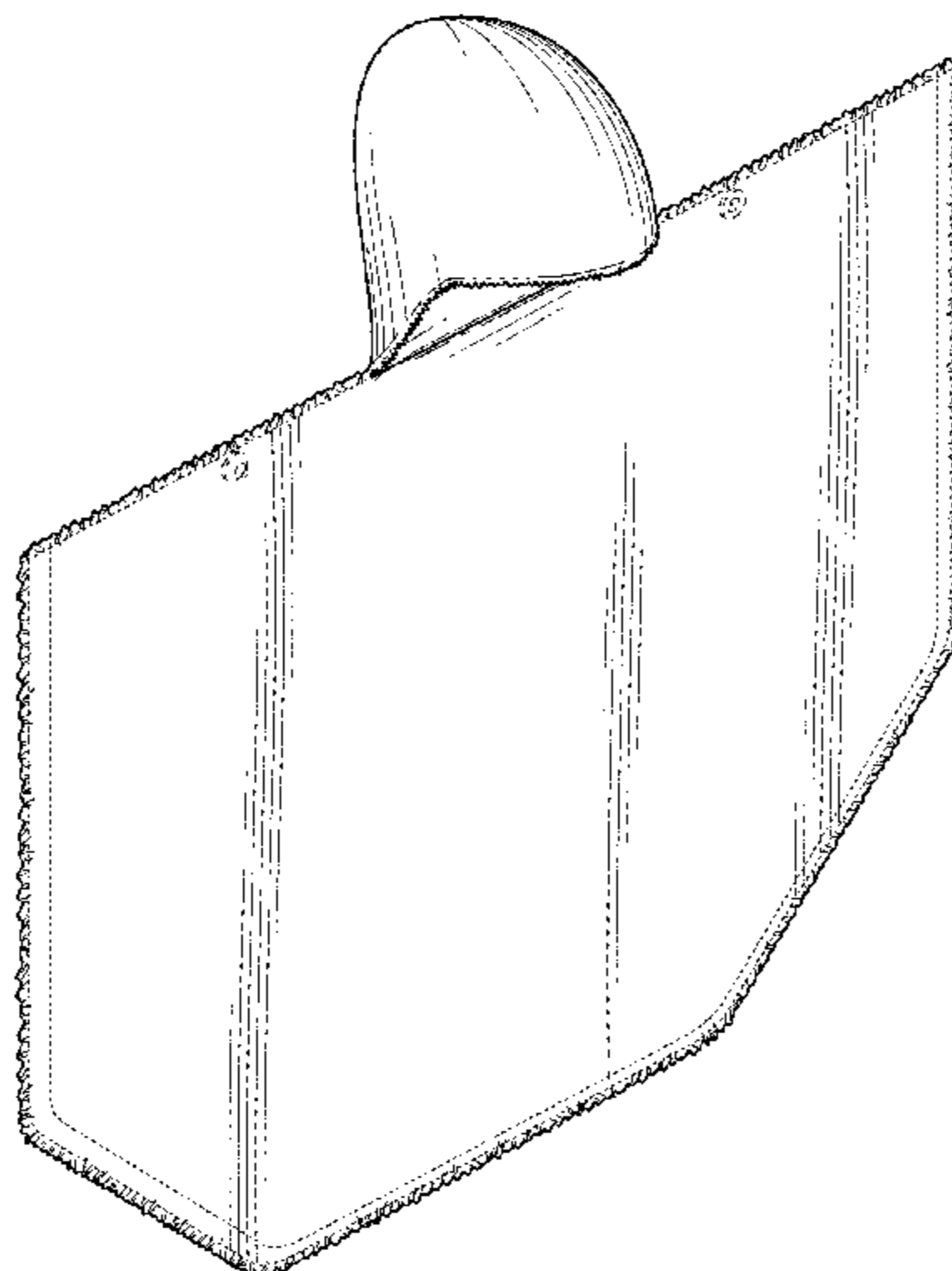
FIG. 1 is a perspective view of a hooded cape wrap showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The short broken lines that are adjacent to outer edges of the article, as illustrated in FIGS. 1-7, represent stitching and are part of the claimed design. The circular broken lines located at the upper edge of the article, as illustrated in FIGS. 1-3, illustrate environmental matter and form no part of the claimed design.

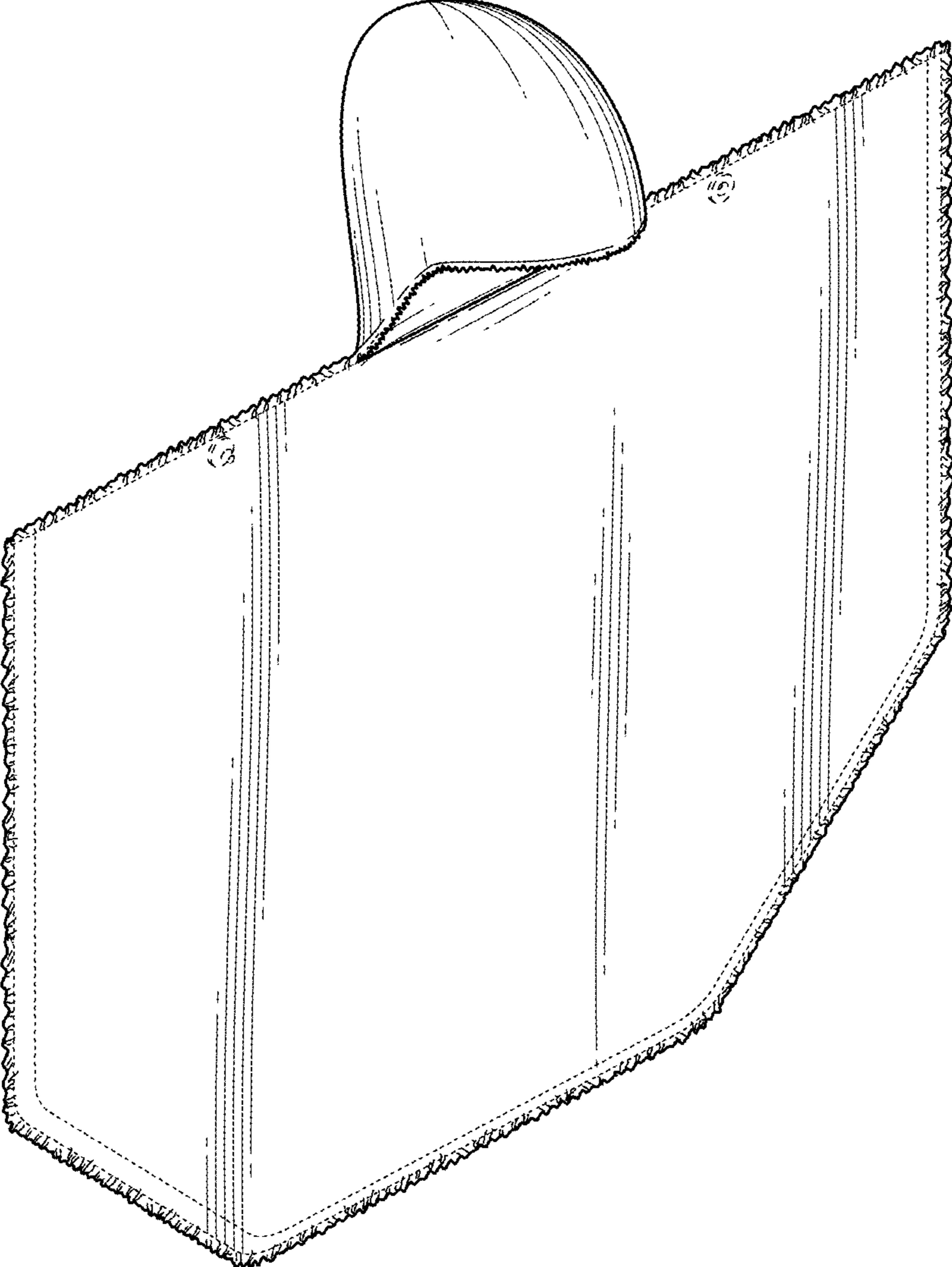

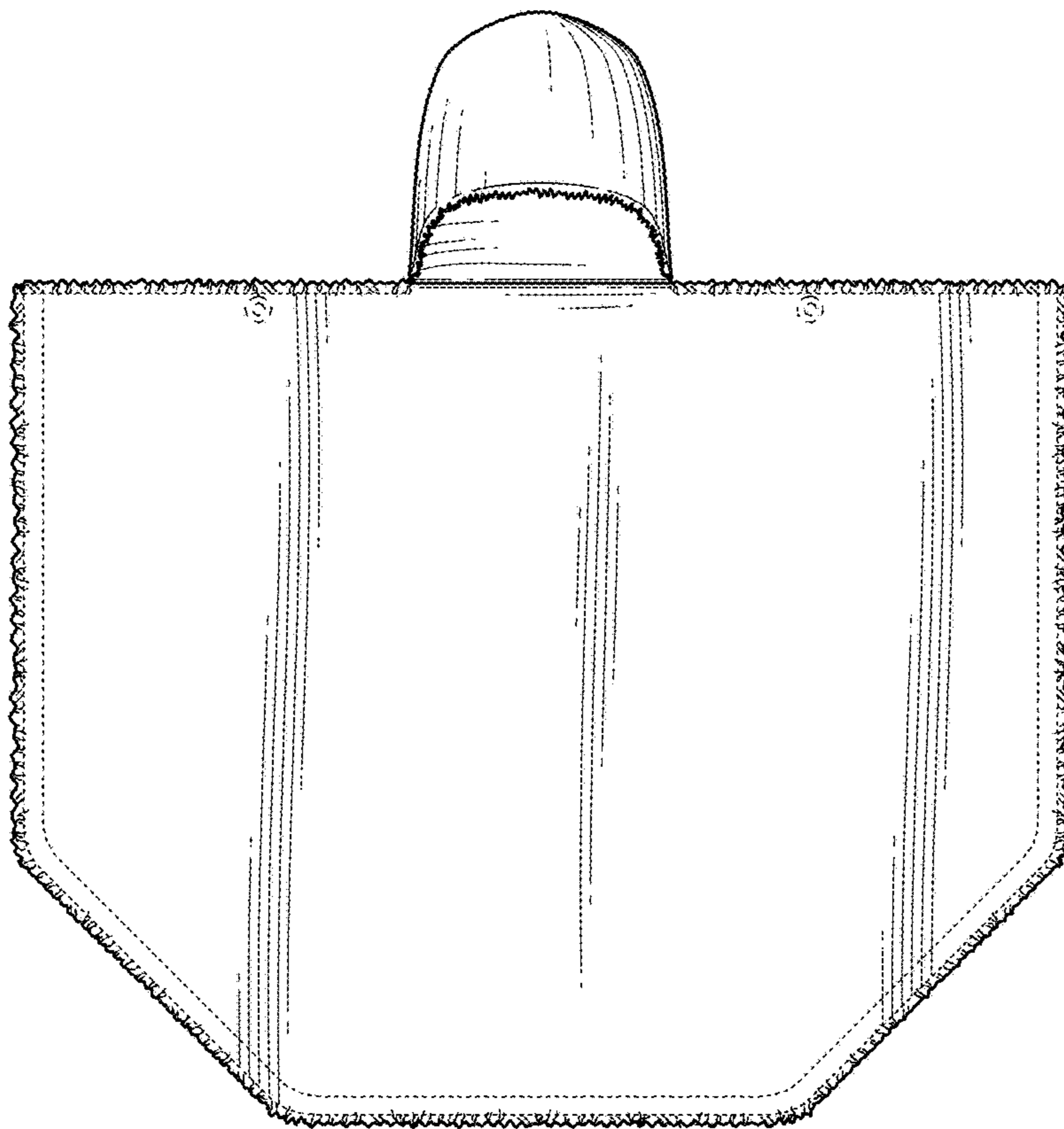

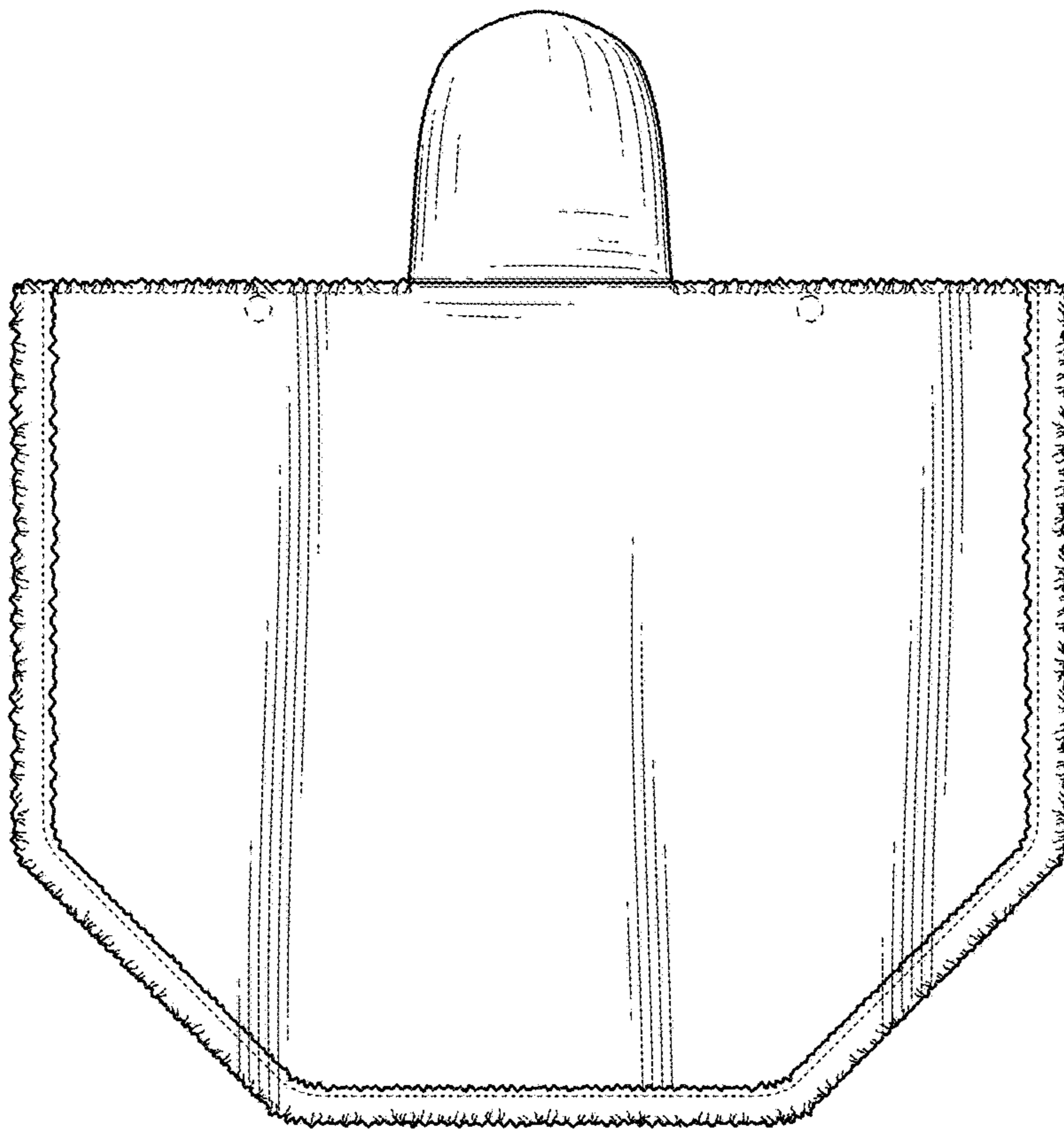

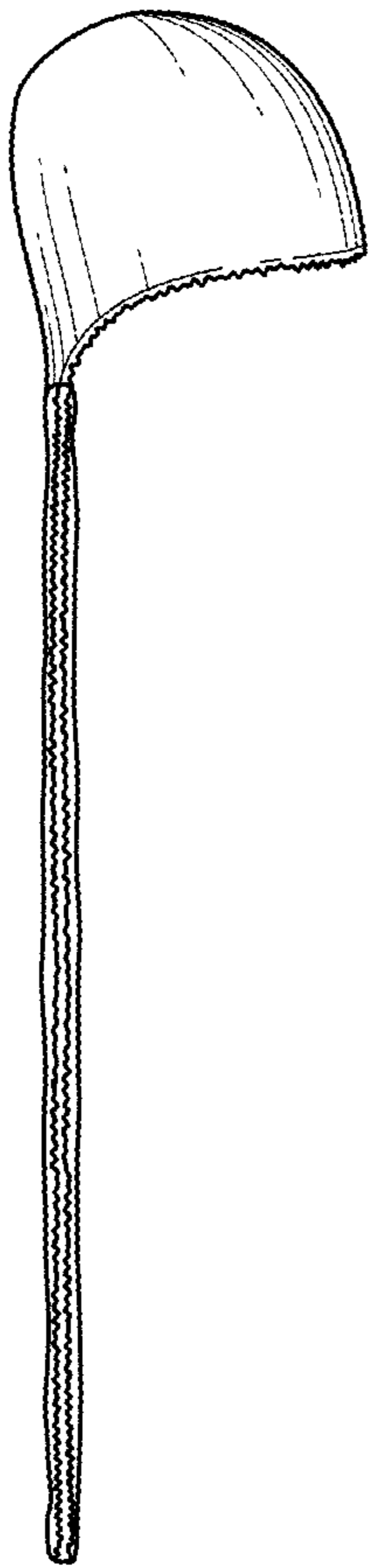

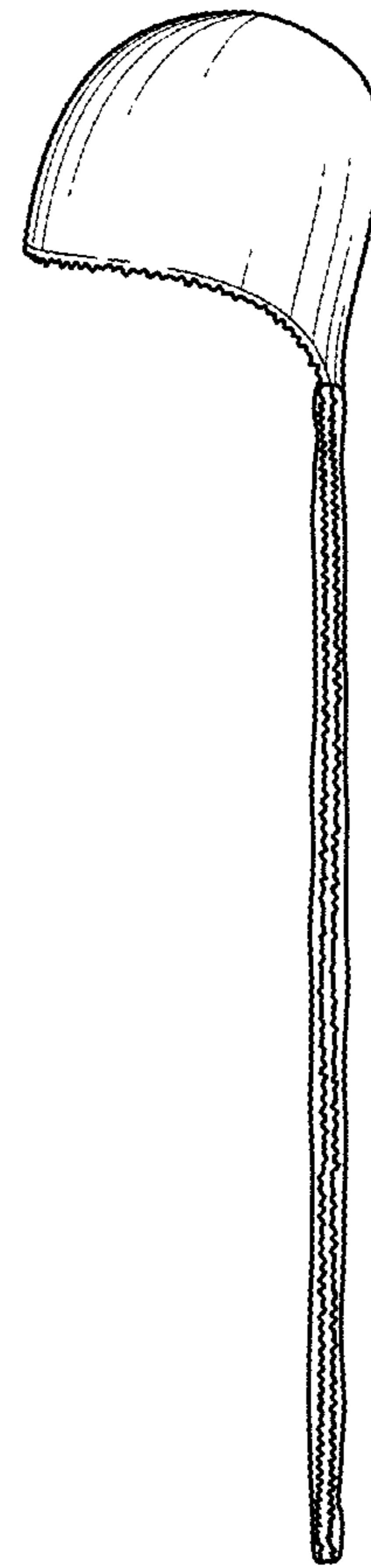

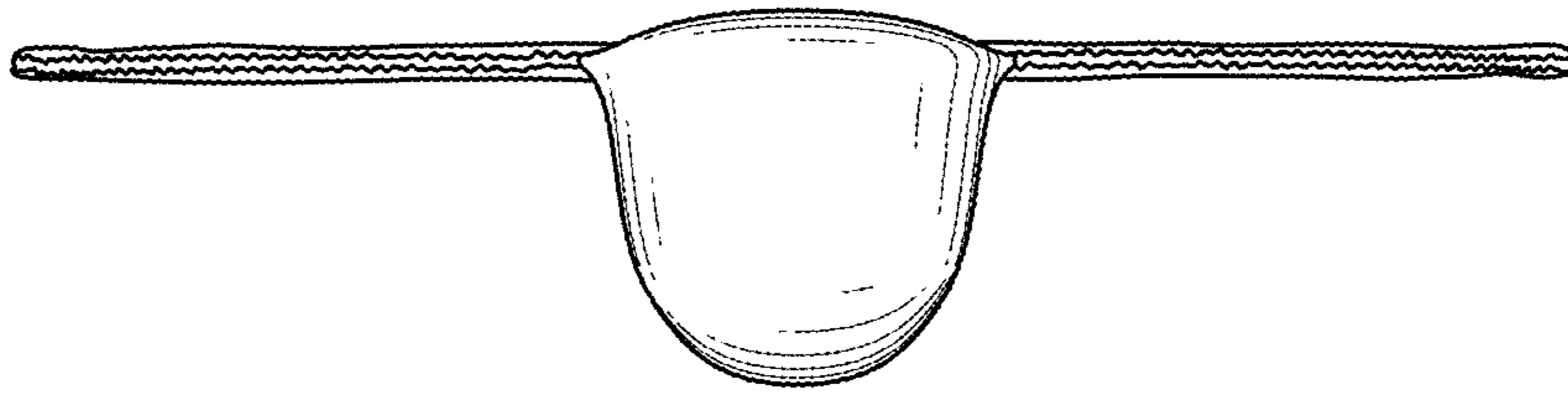

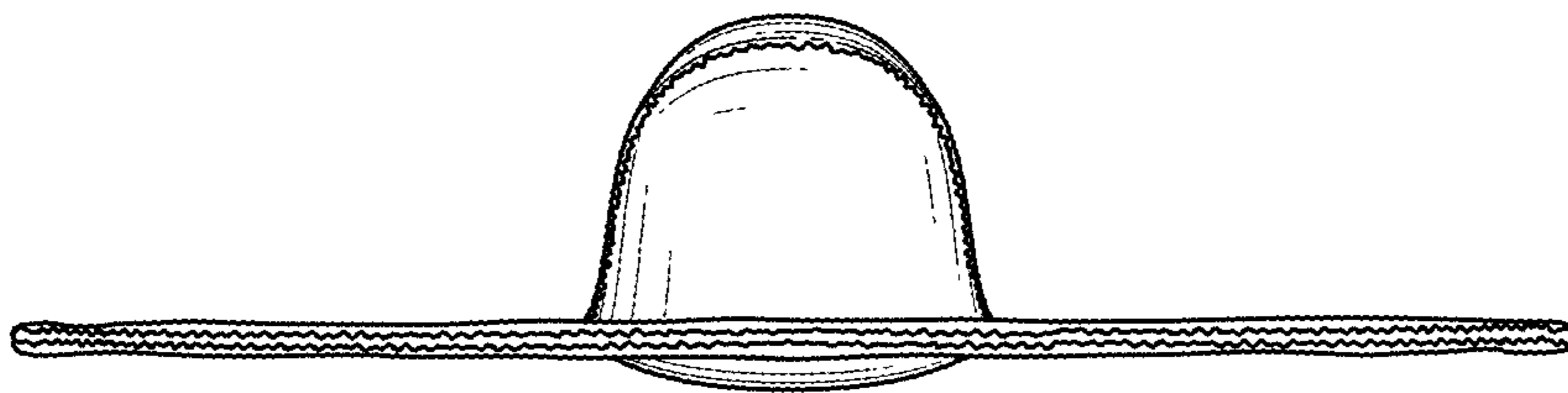
