(57) **CLAIM**

The ornamental design for a hood, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, perspective view of a hood in accordance with the present design.

FIG. 2 is a front, right side, perspective view of the hood of FIG. 1.

FIG. 3 is a front view of the hood of FIG. 1.

FIG. 4 is a left side view of the hood of FIG. 1.

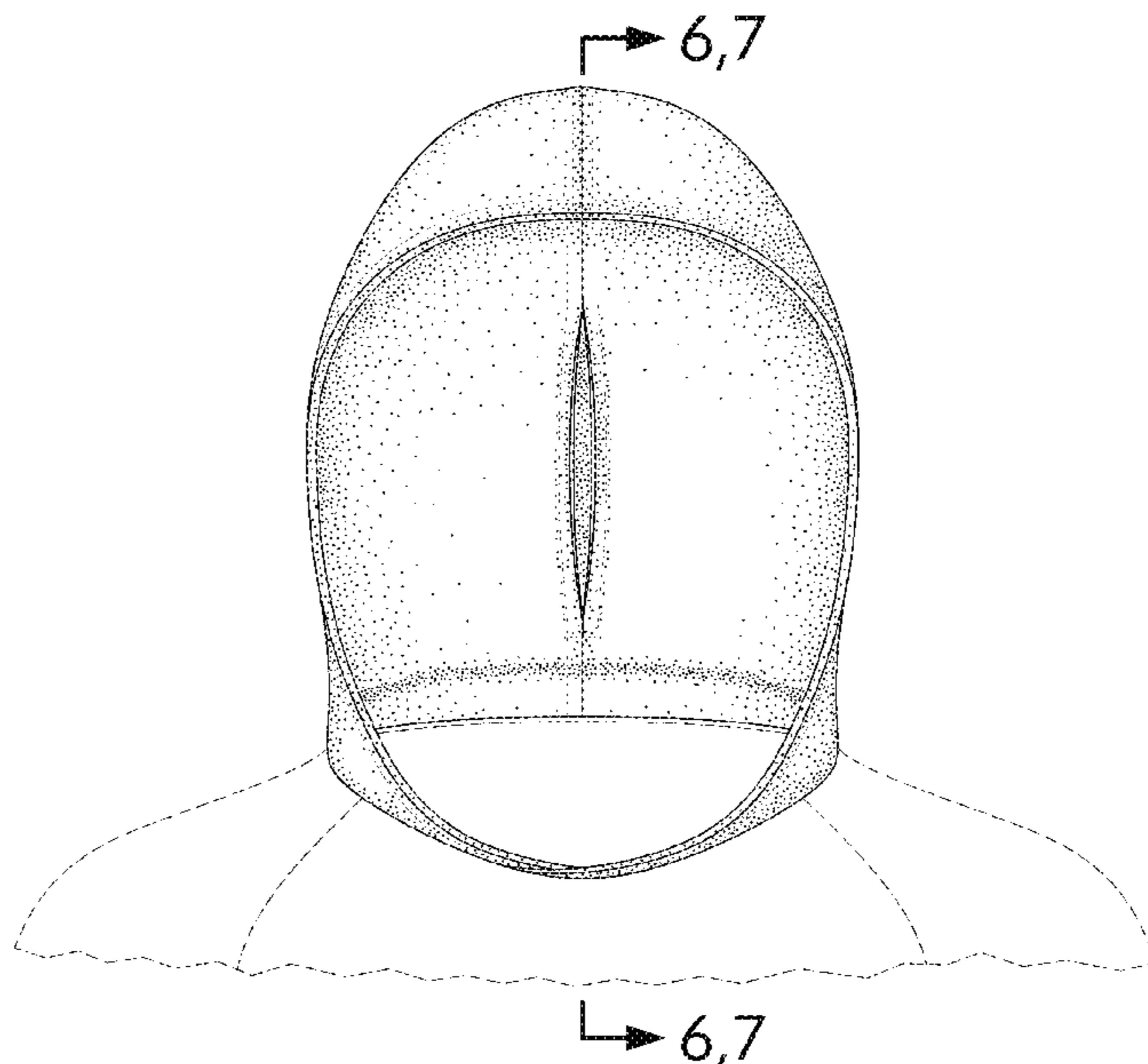
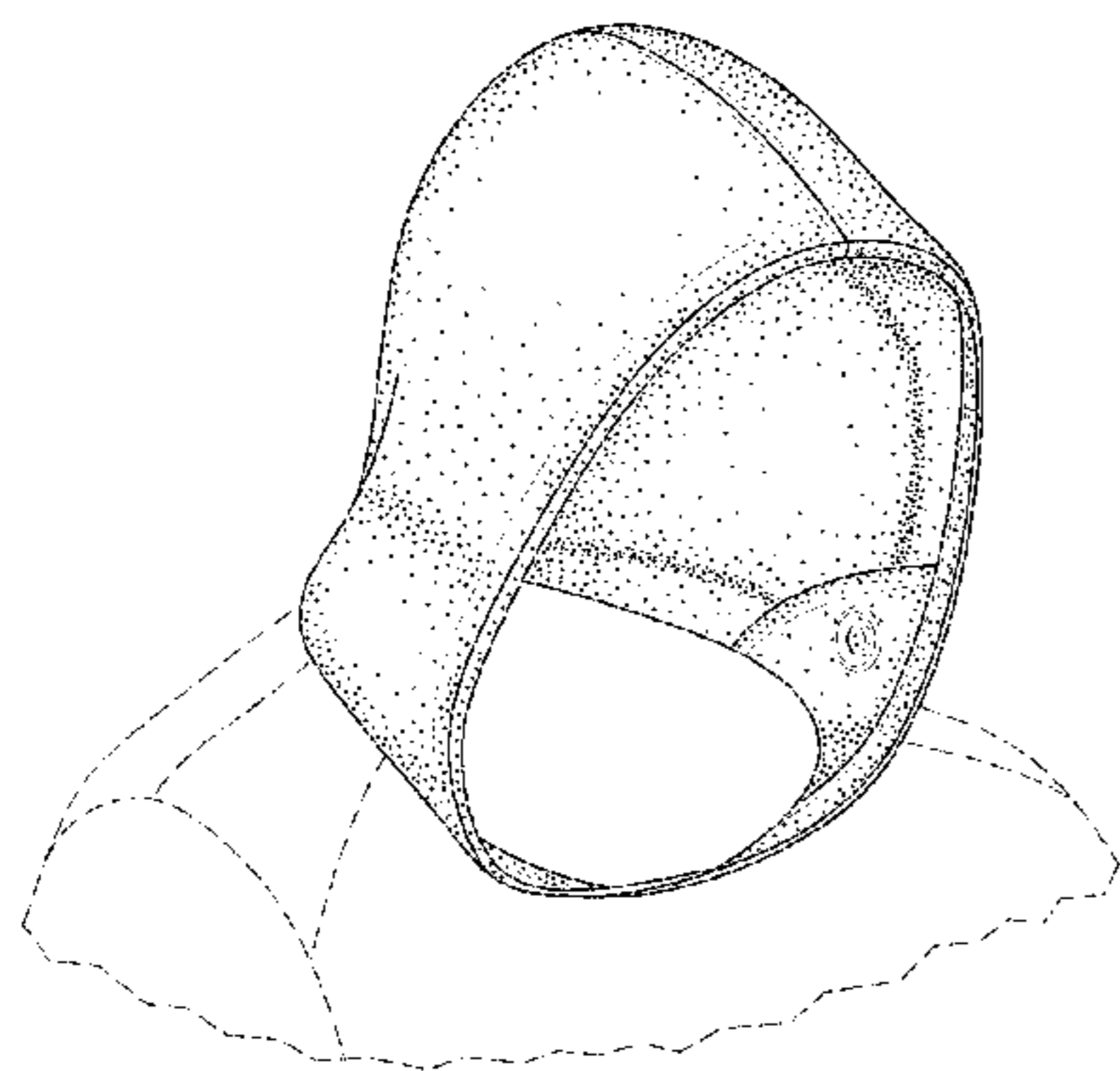
FIG. 5 is a right side view of the hood of FIG. 1.

FIG. 6 is a sectional view thereof, taken along line 6-6 of FIG. 3; and,

FIG. 7 is a sectional view thereof, taken along line 7-7 of FIG. 3, with the inside flap shown in the open position.

The broken lines shown in the drawings are included for the purpose of illustrating environmental structure and form no part of the claimed design. The dashed lines shown on the hood represent stitching in the fabric.

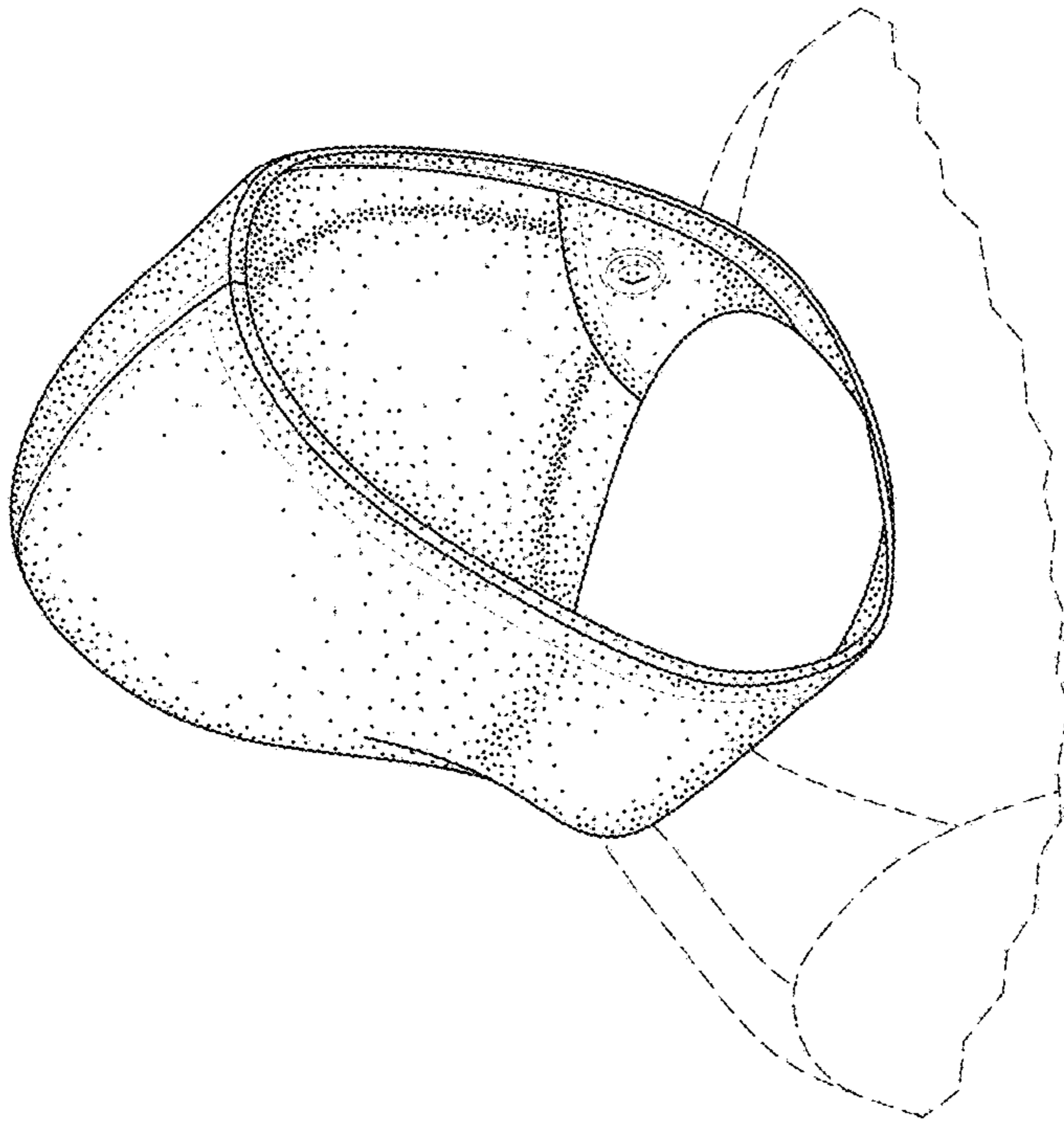

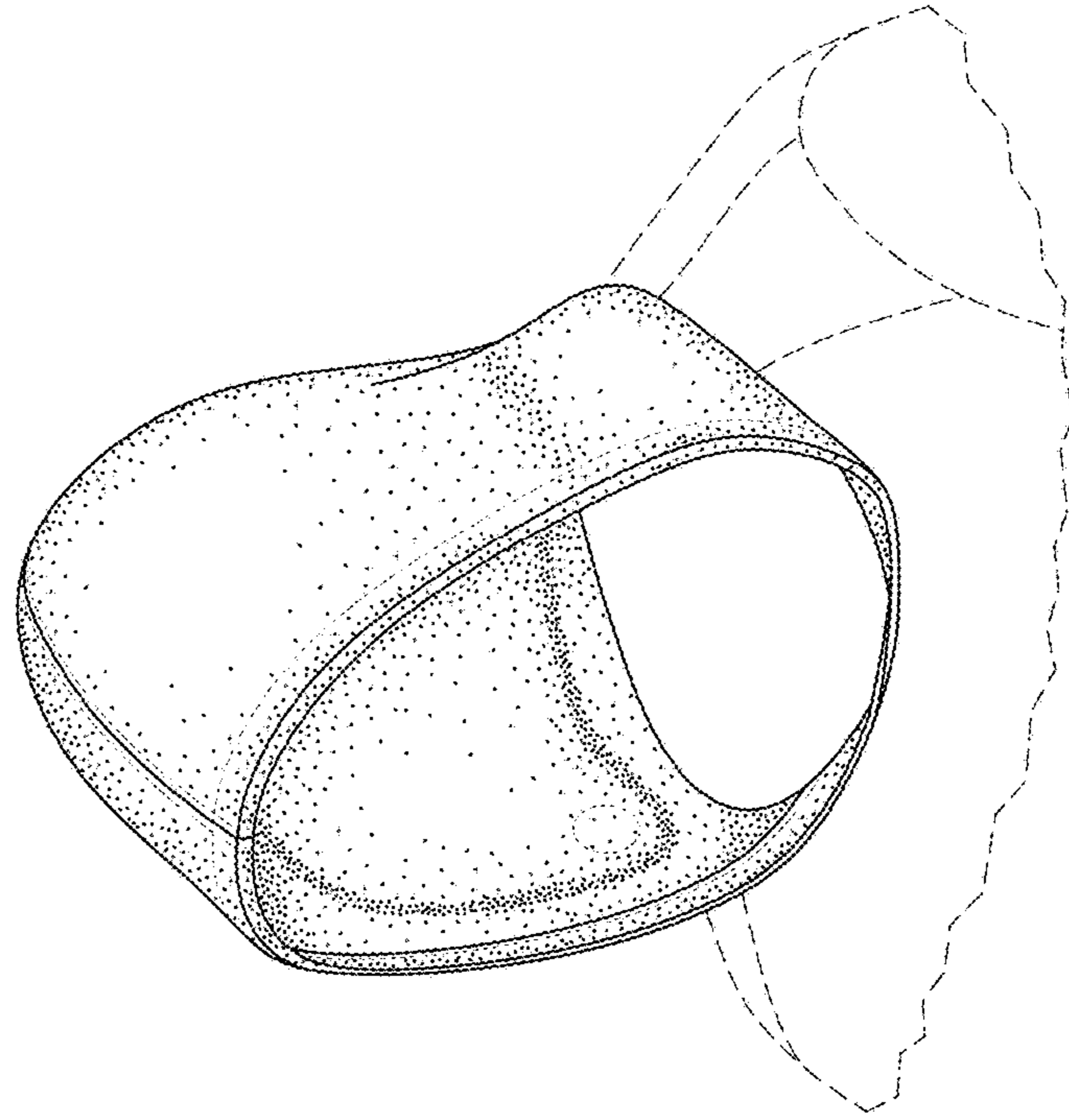

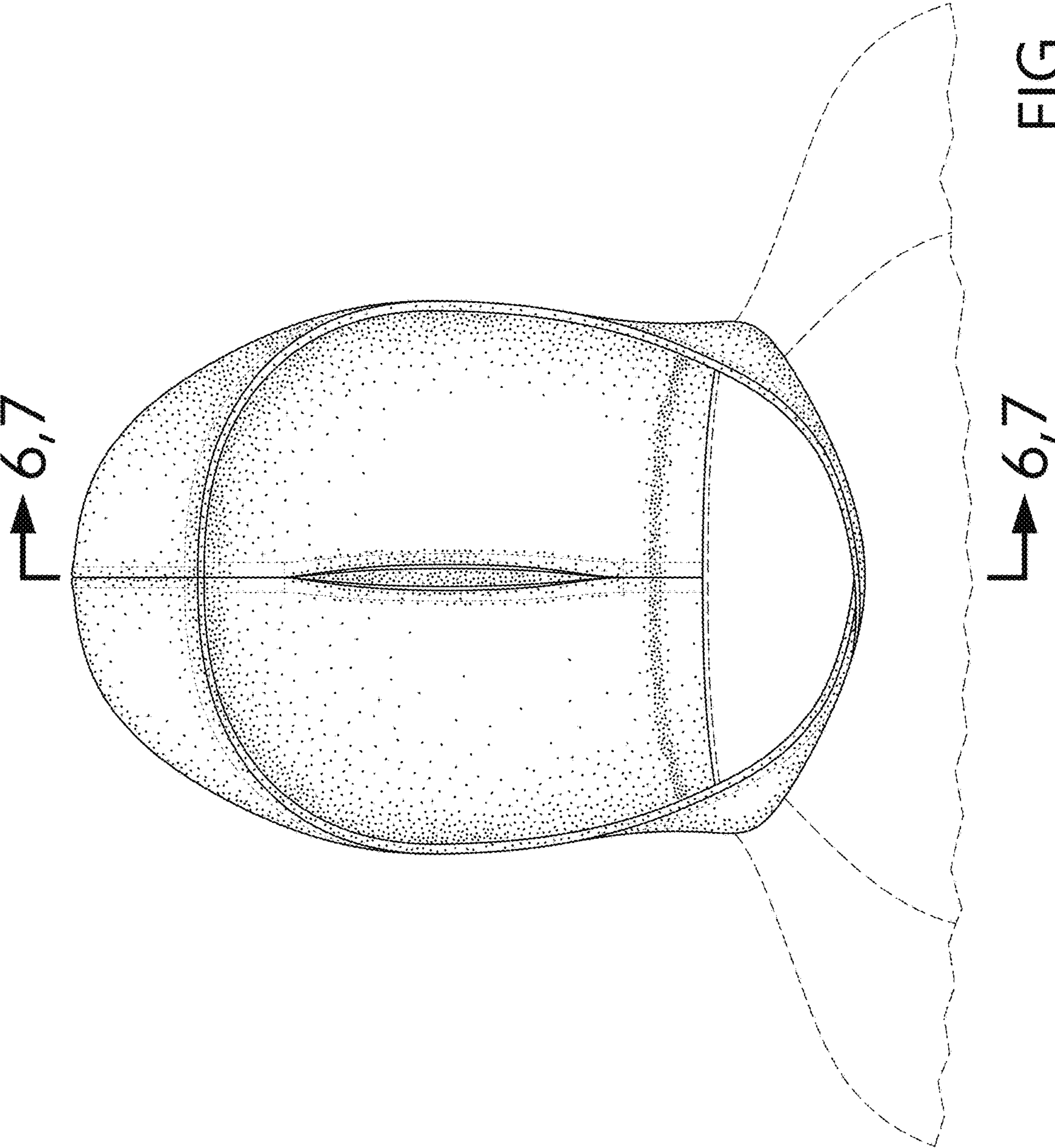

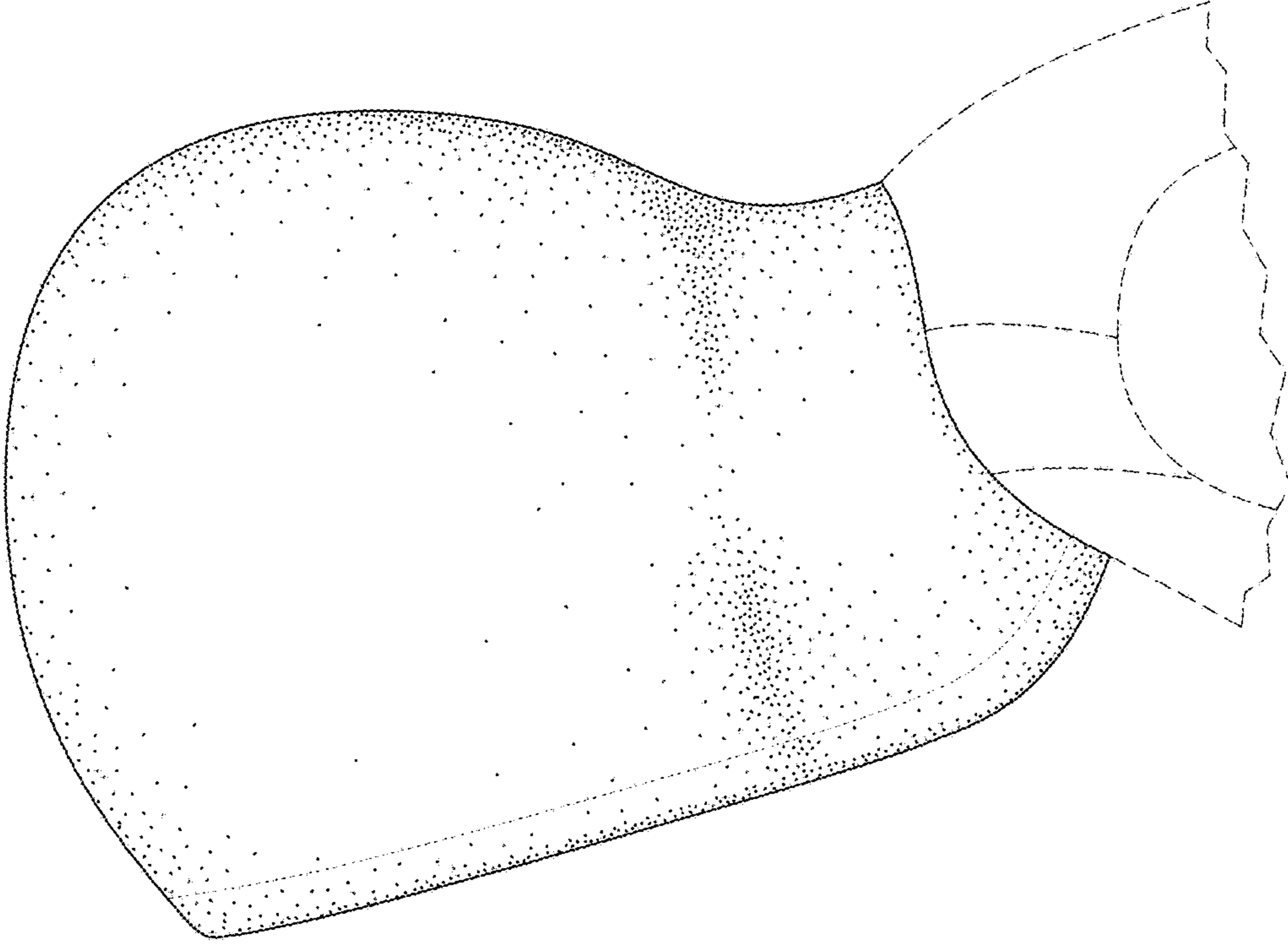

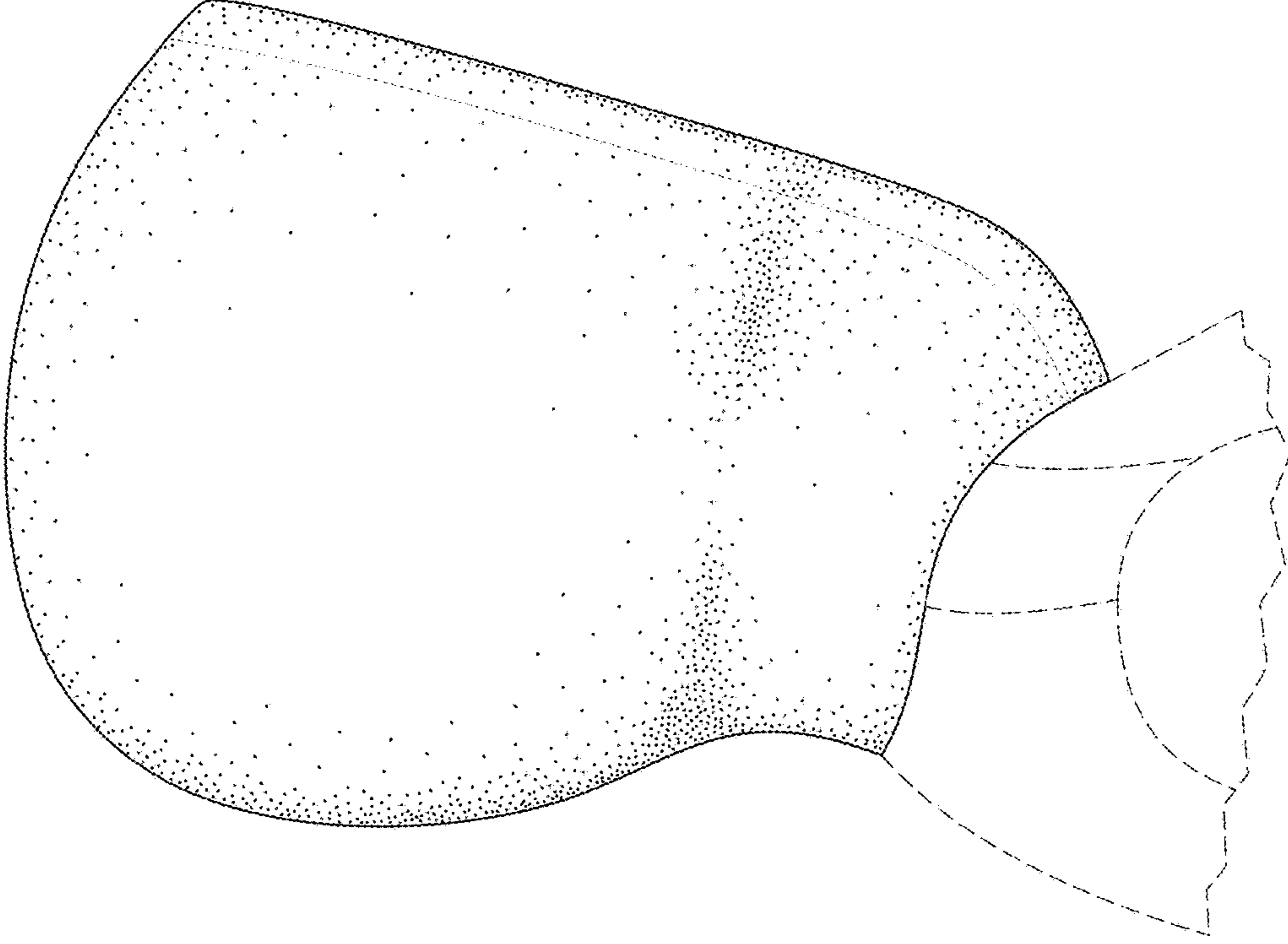

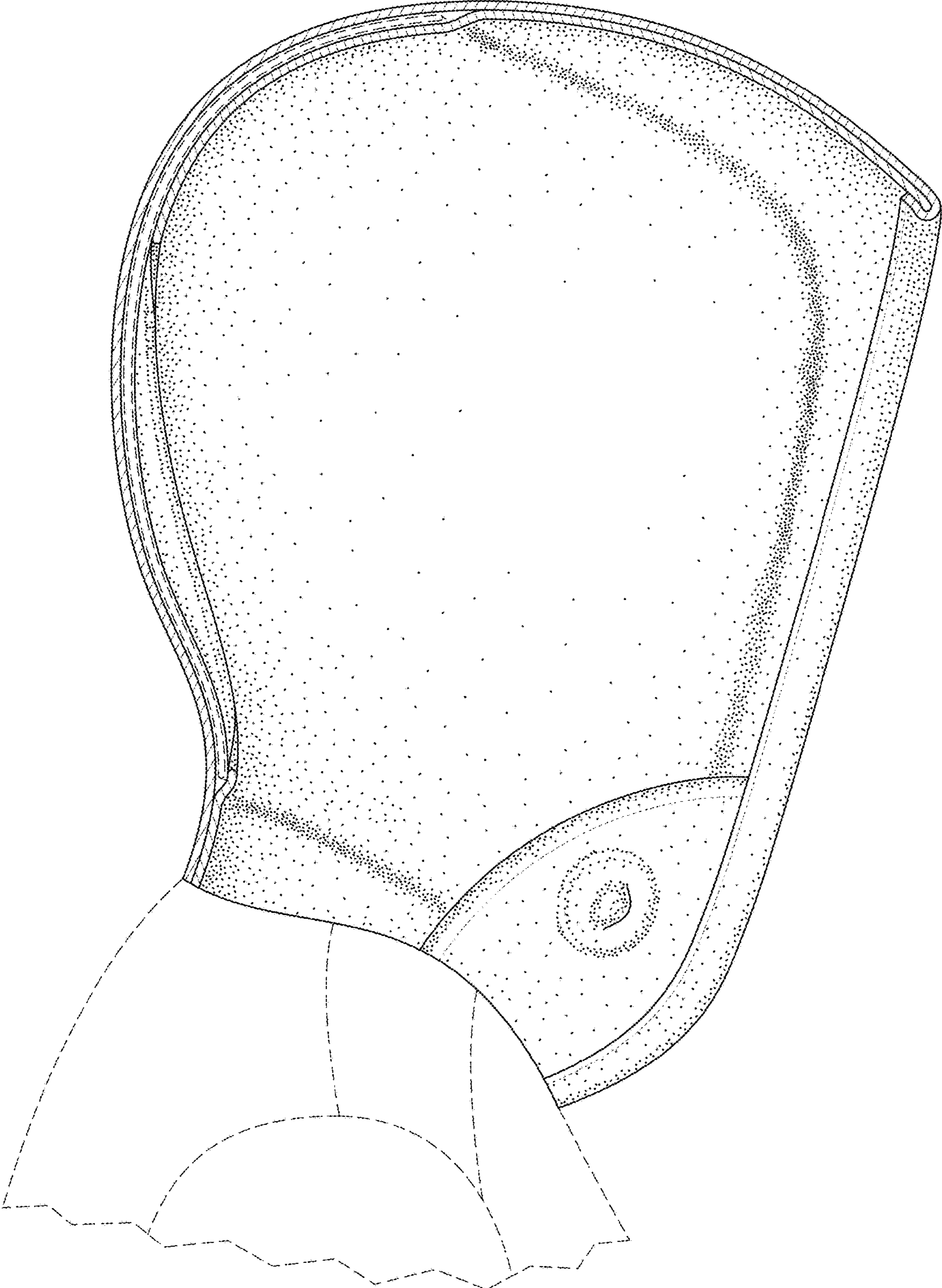

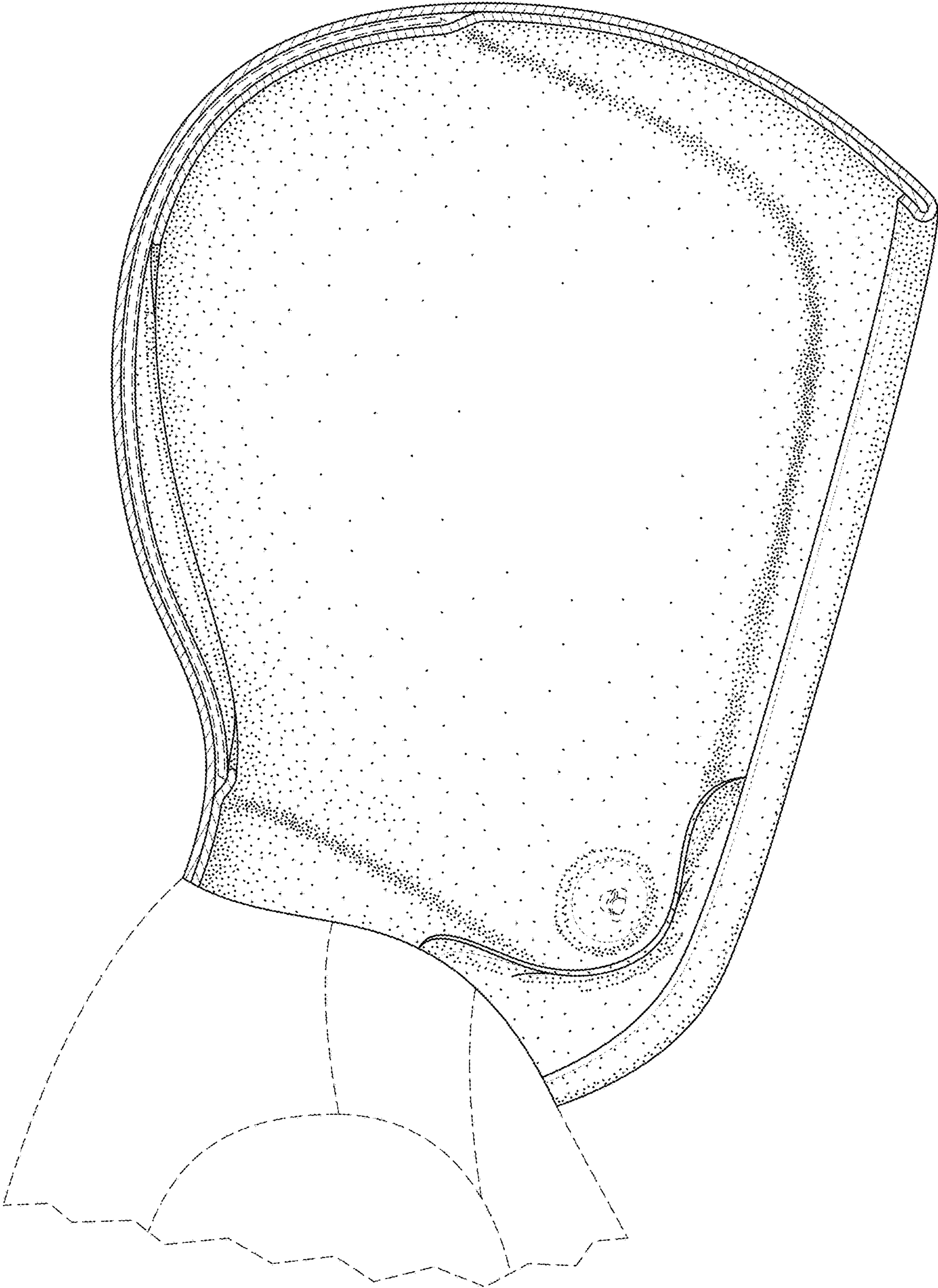
