FIG. 2 is a second front perspective view thereof;

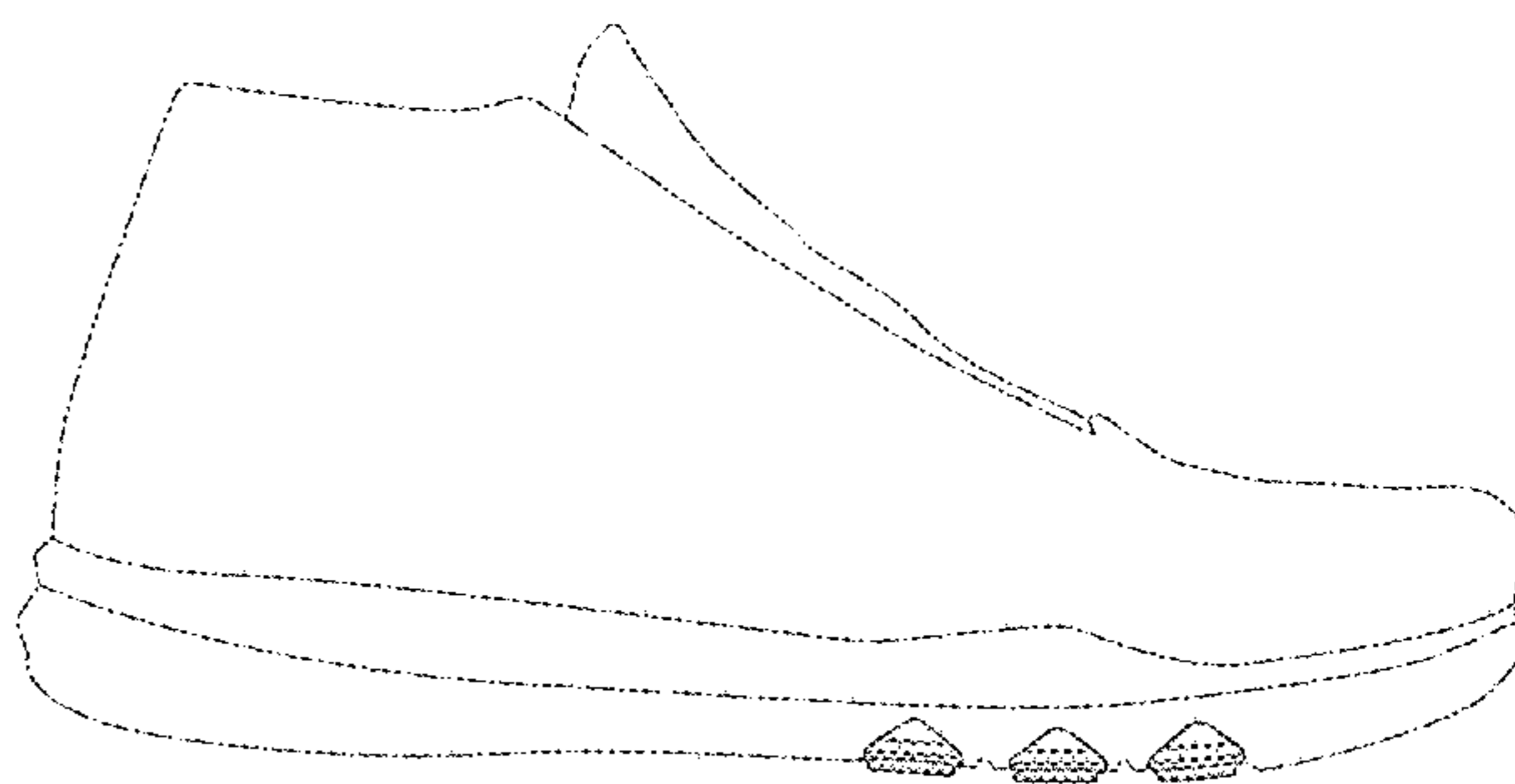
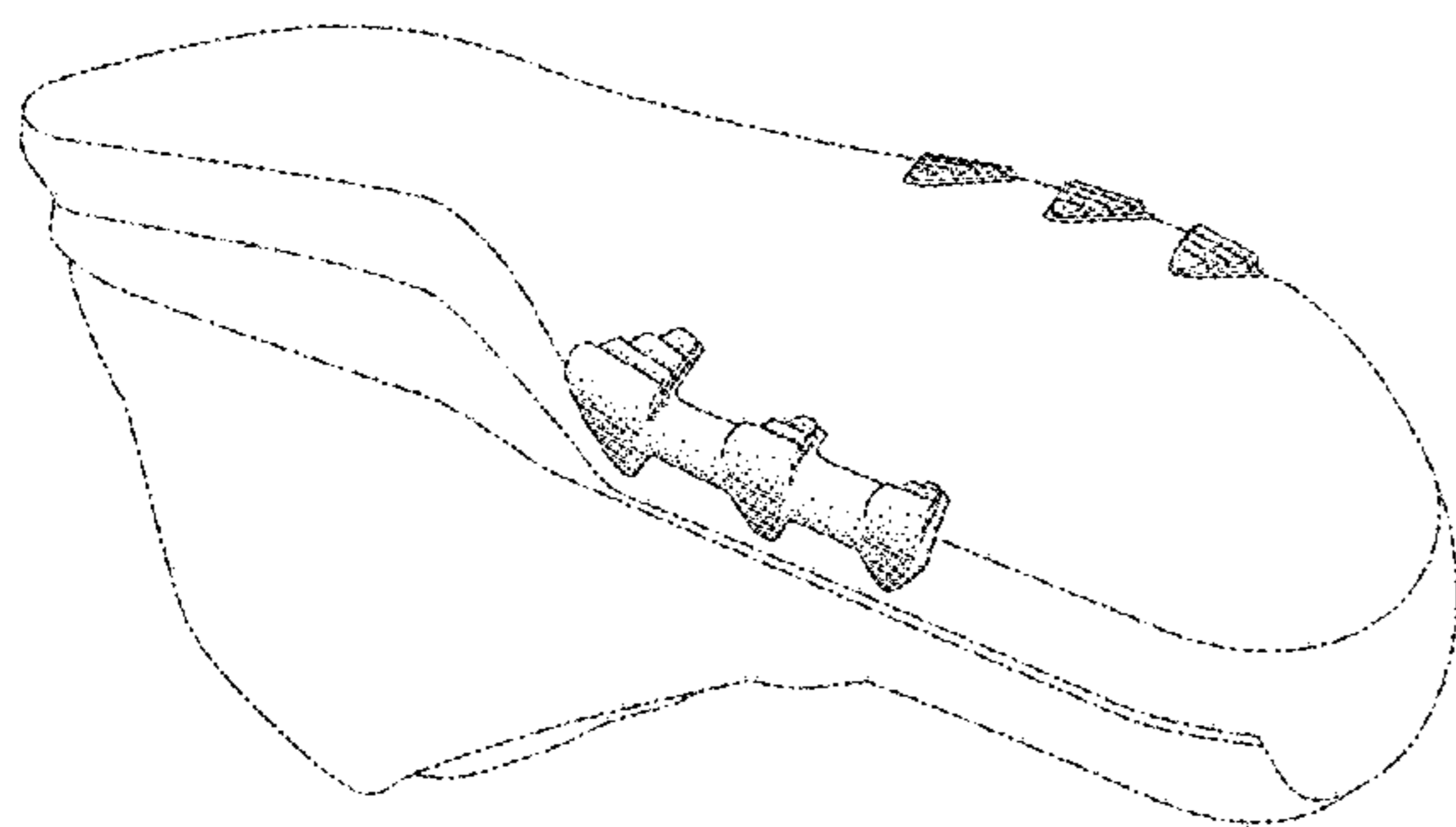
FIG. 3 is a side view thereof;

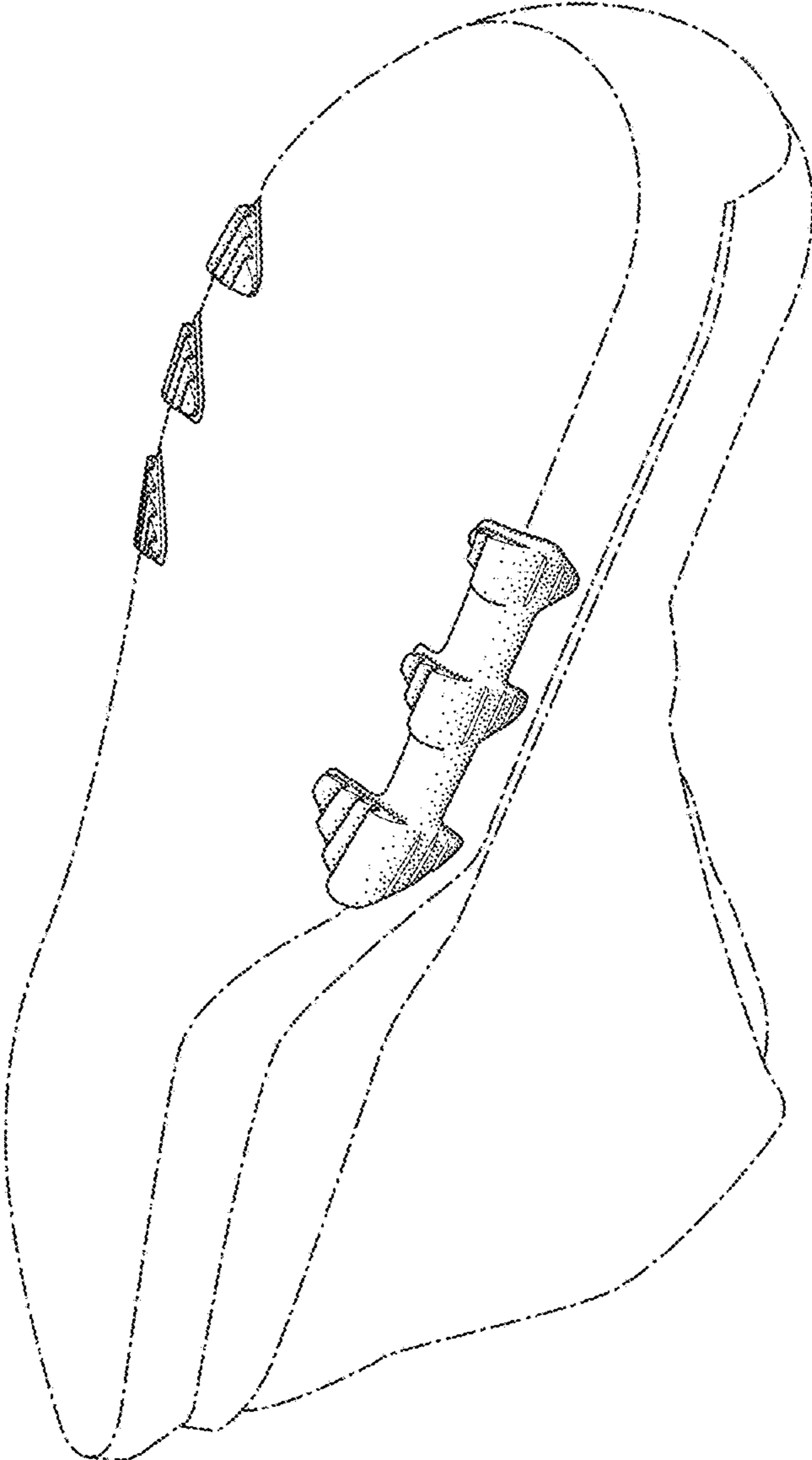

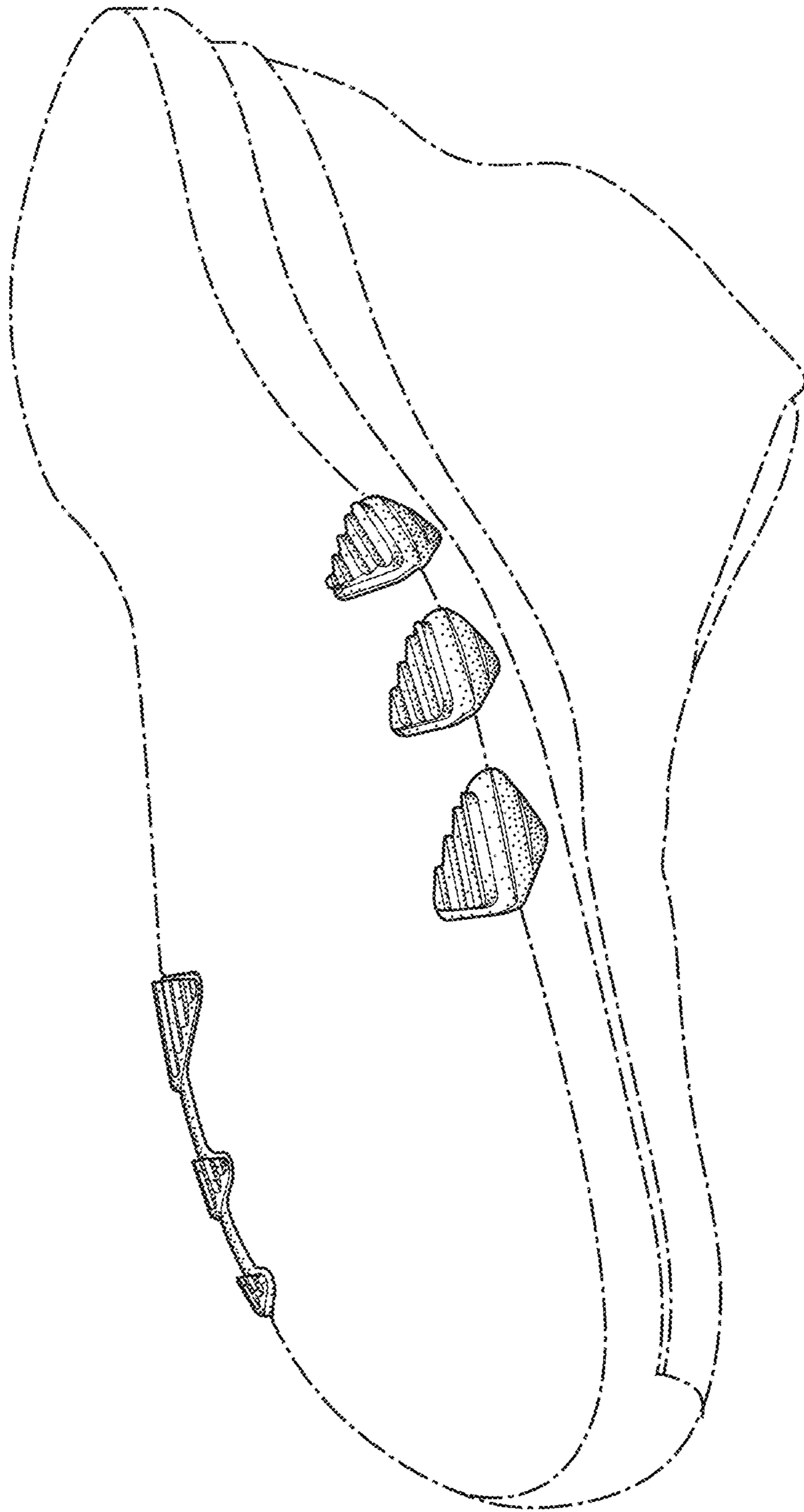

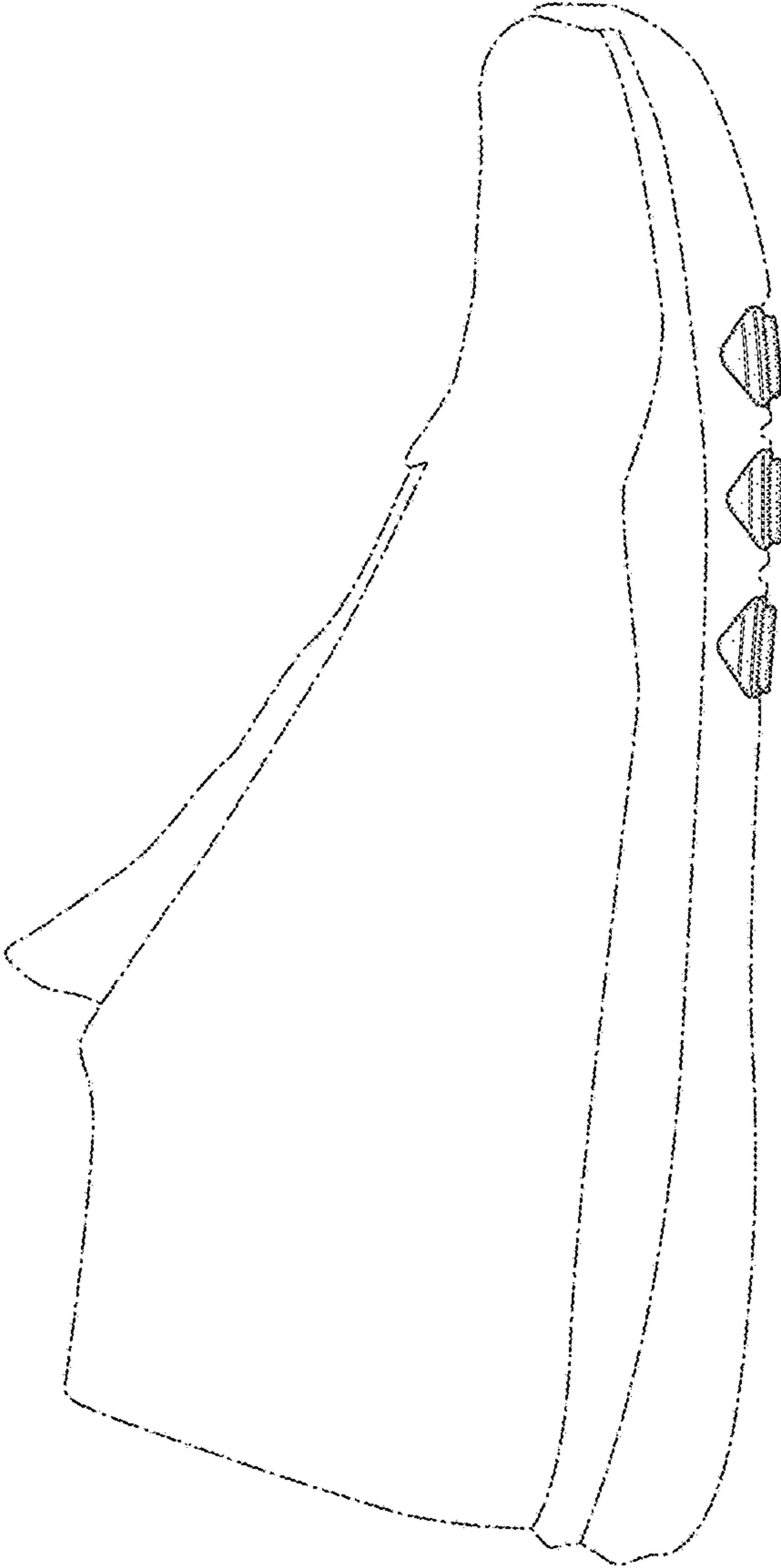

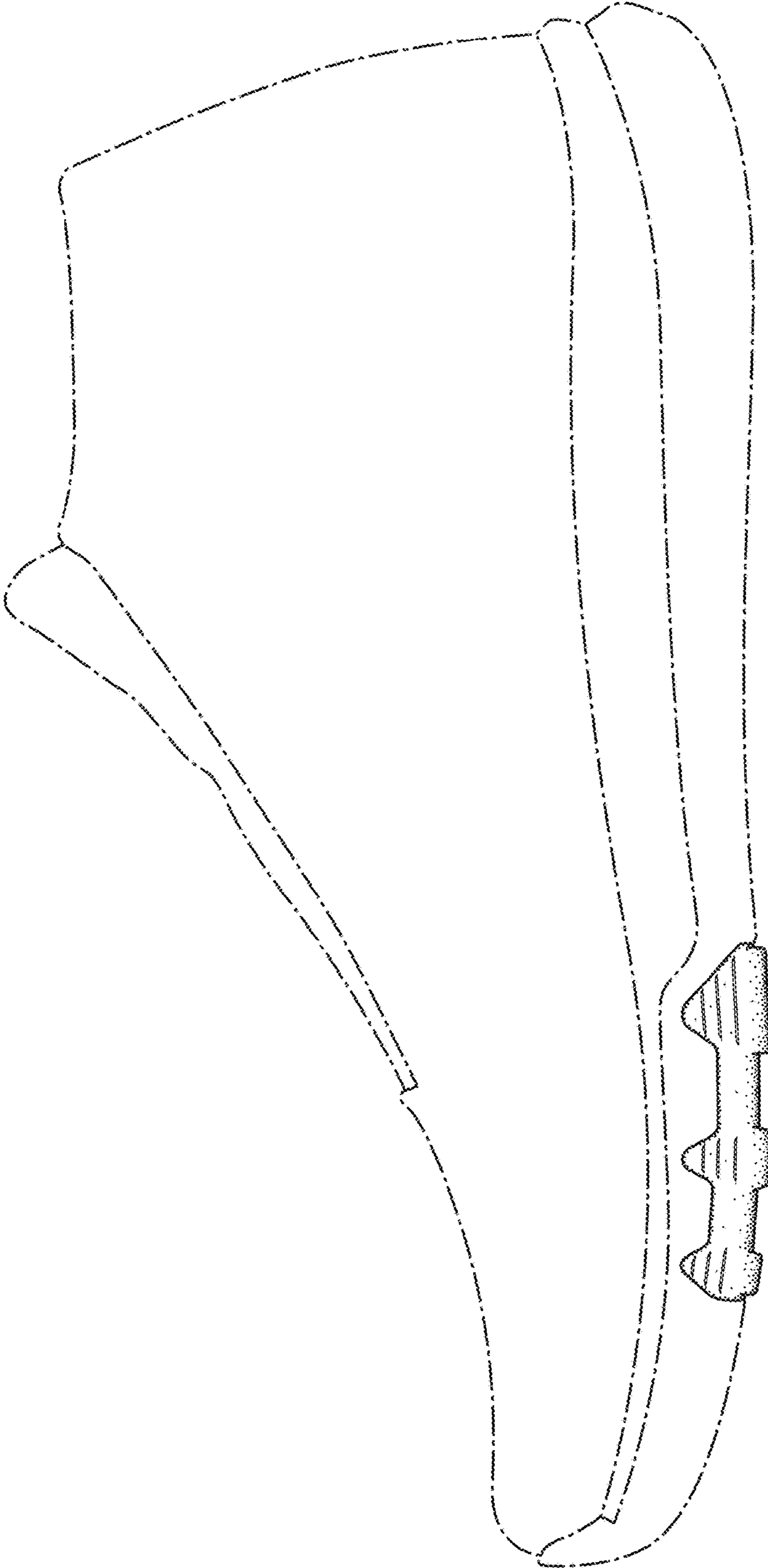

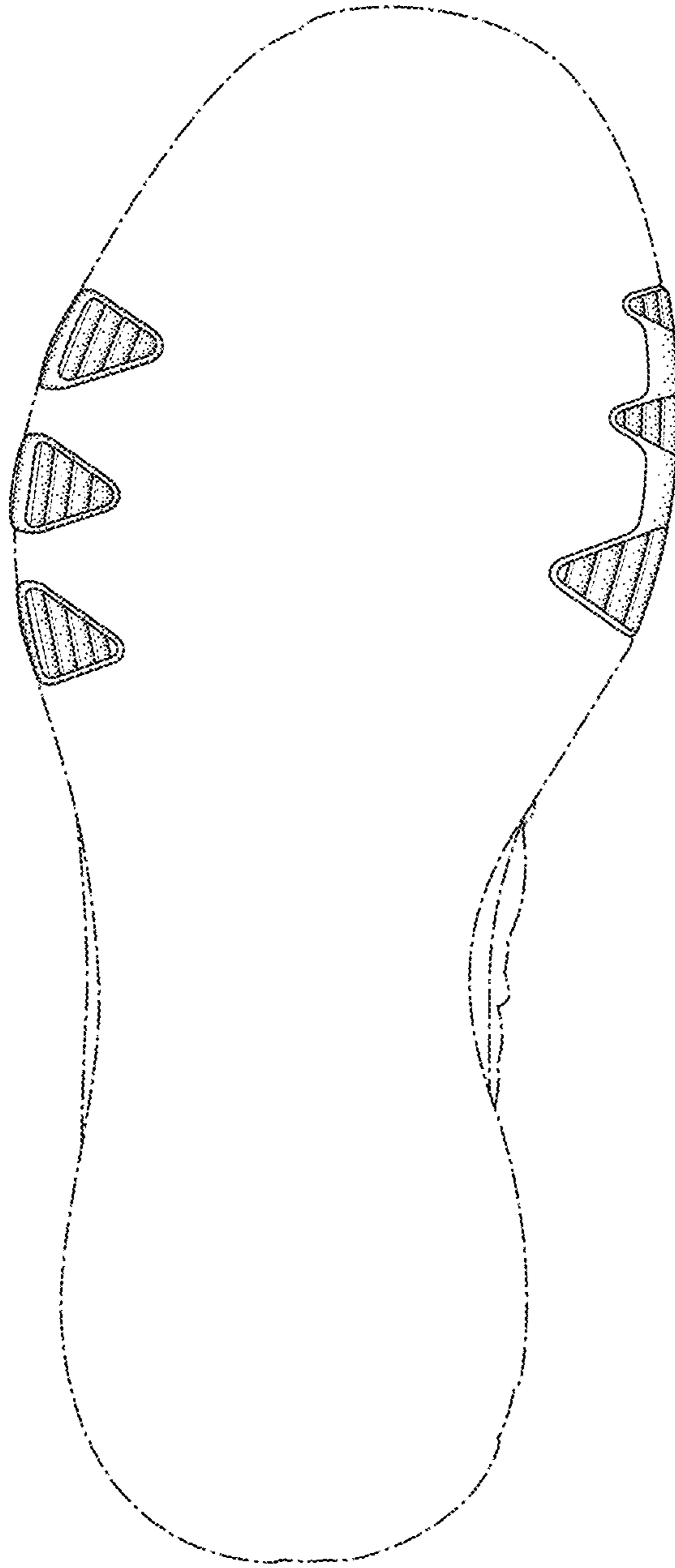
