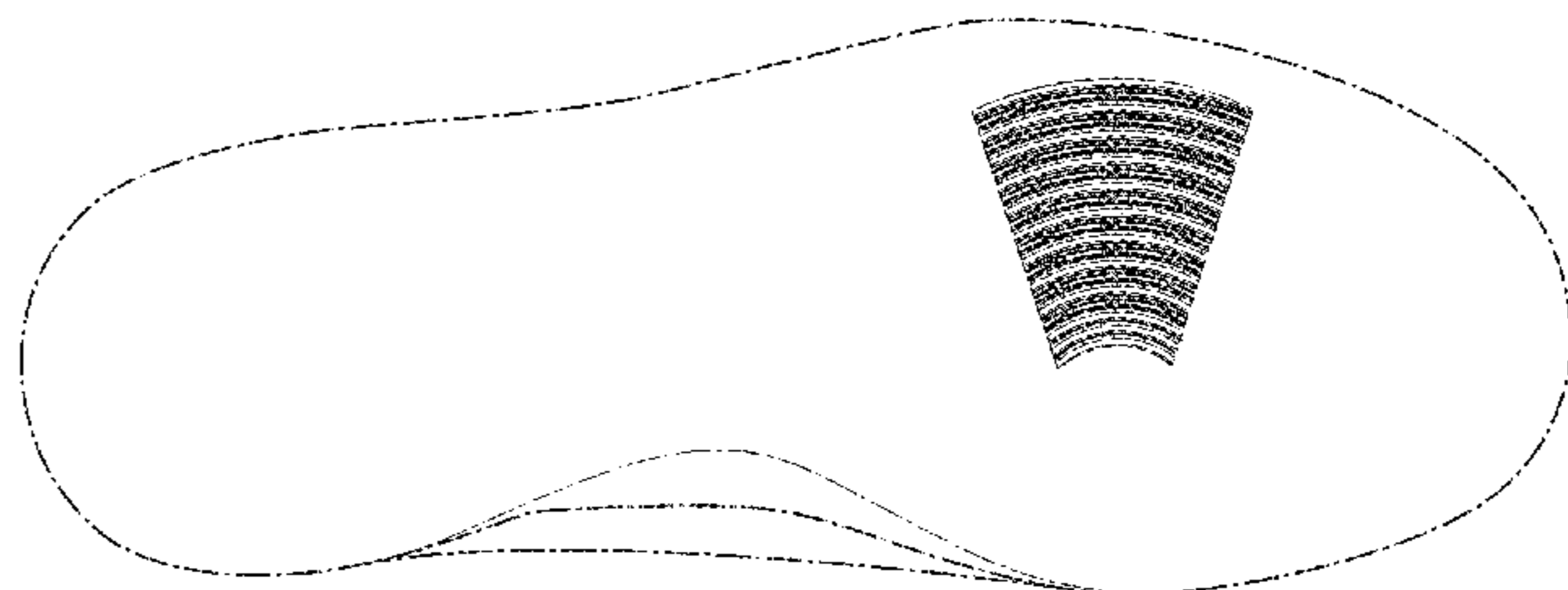
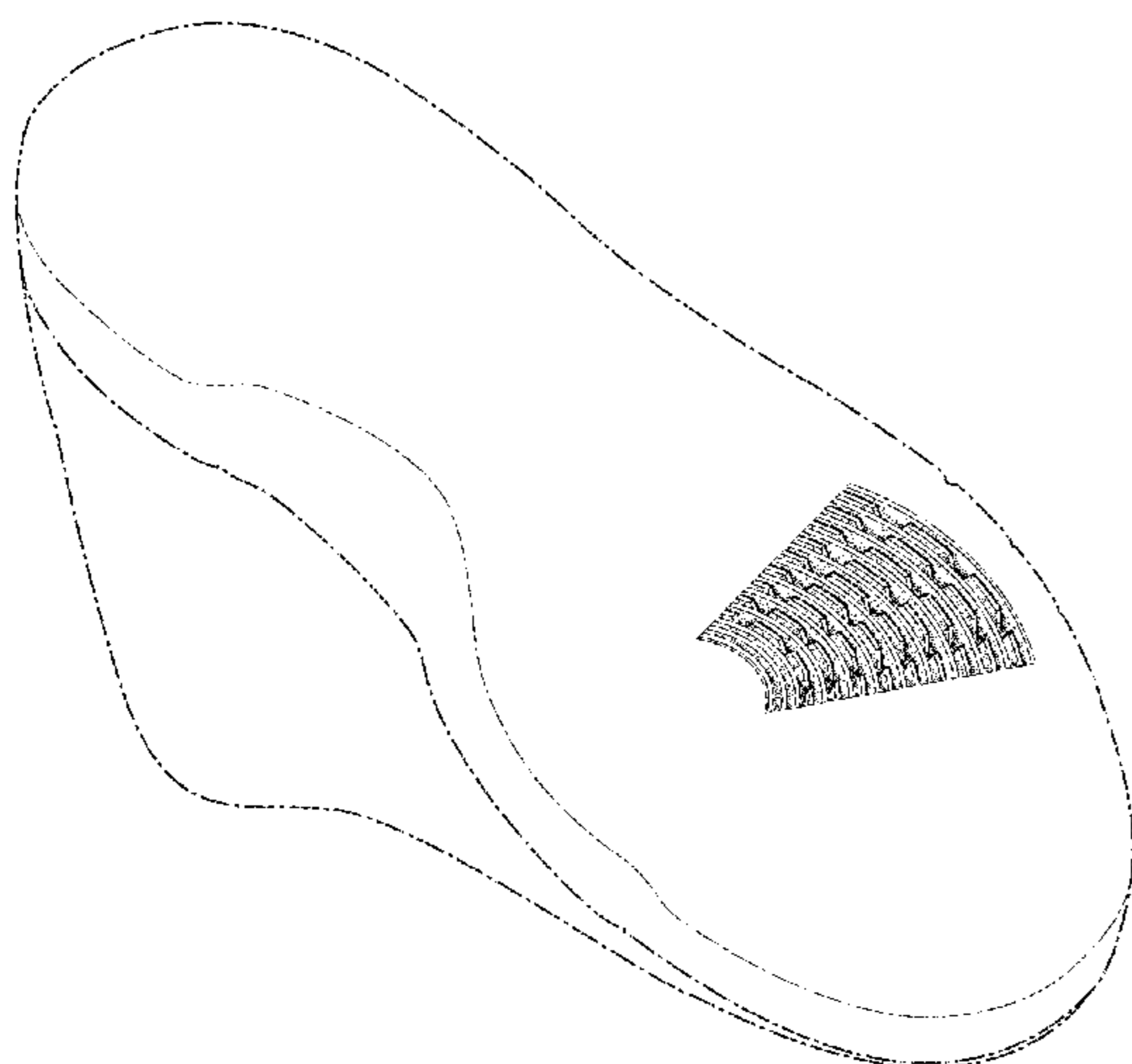

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing  
my new design;  
FIG. 2 is a second front perspective view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a rear perspective view thereof; and,  
FIG. 5 is an enlarged view of FIG. 4 with unclaimed subject  
matter omitted.  
The broken lines immediately adjacent to the shaded area  
represent unclaimed boundaries of the design. The broken  
lines showing the remainder of the shoe represent unclaimed  
subject matter and form no part of the claimed design.

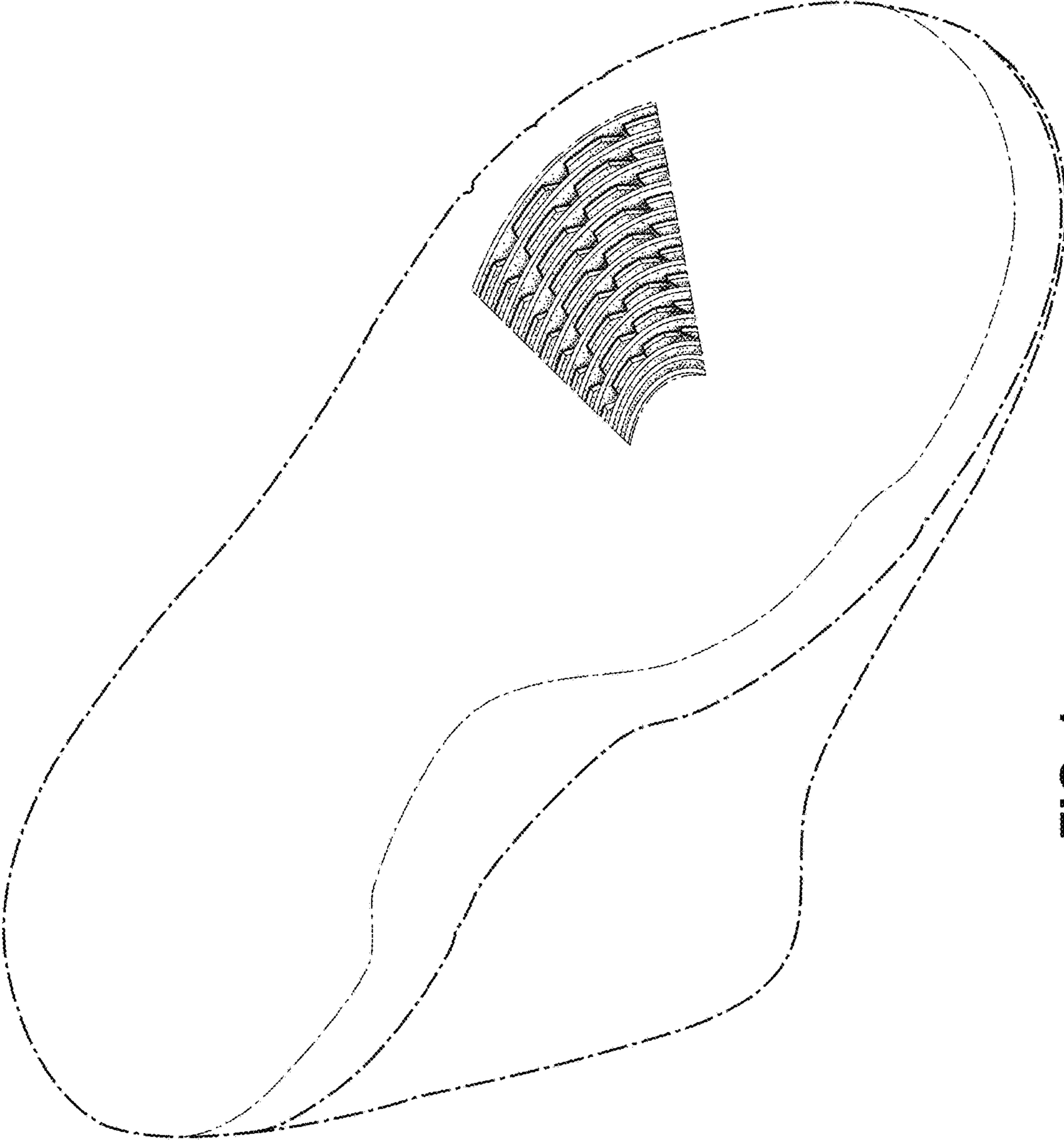

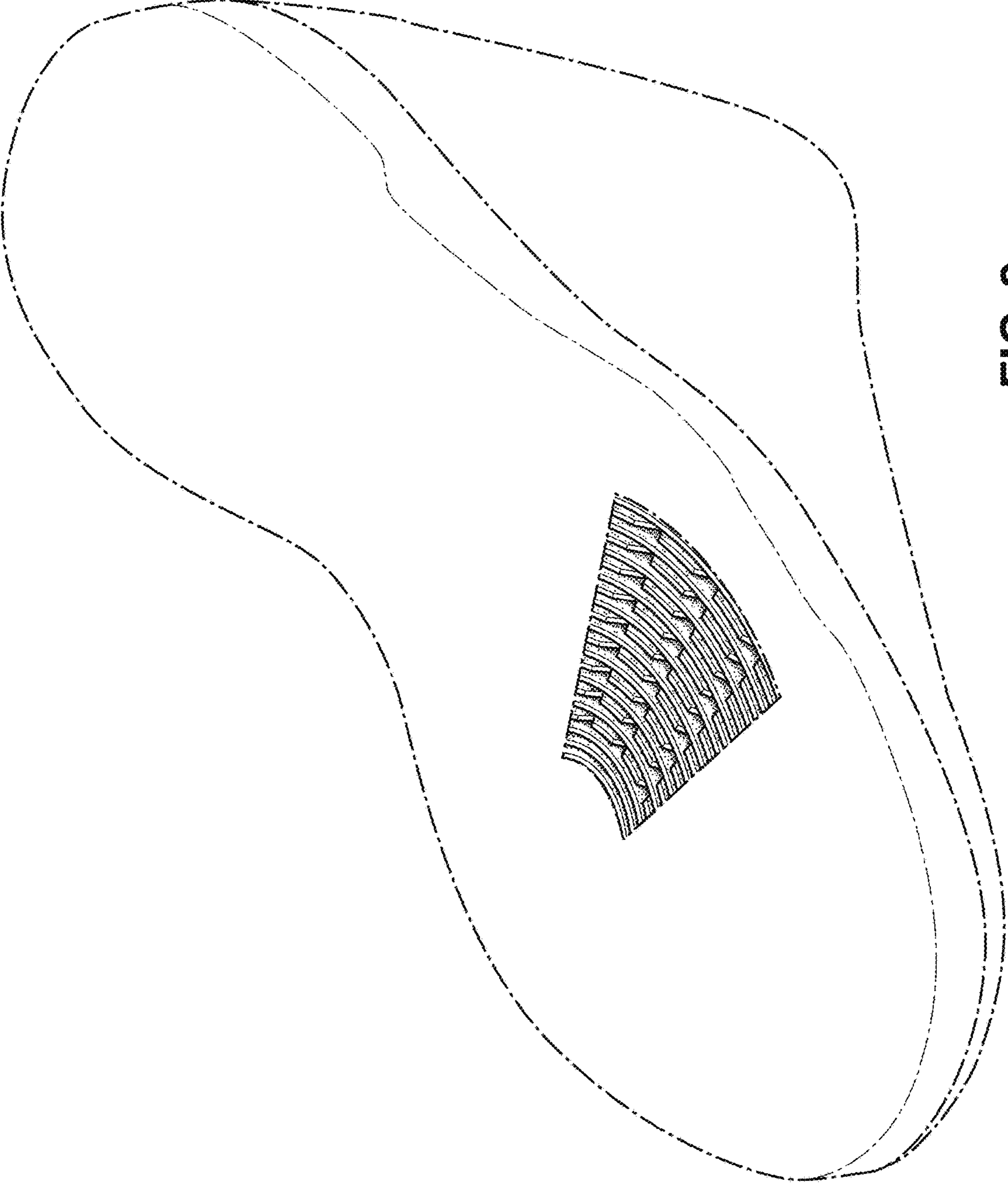

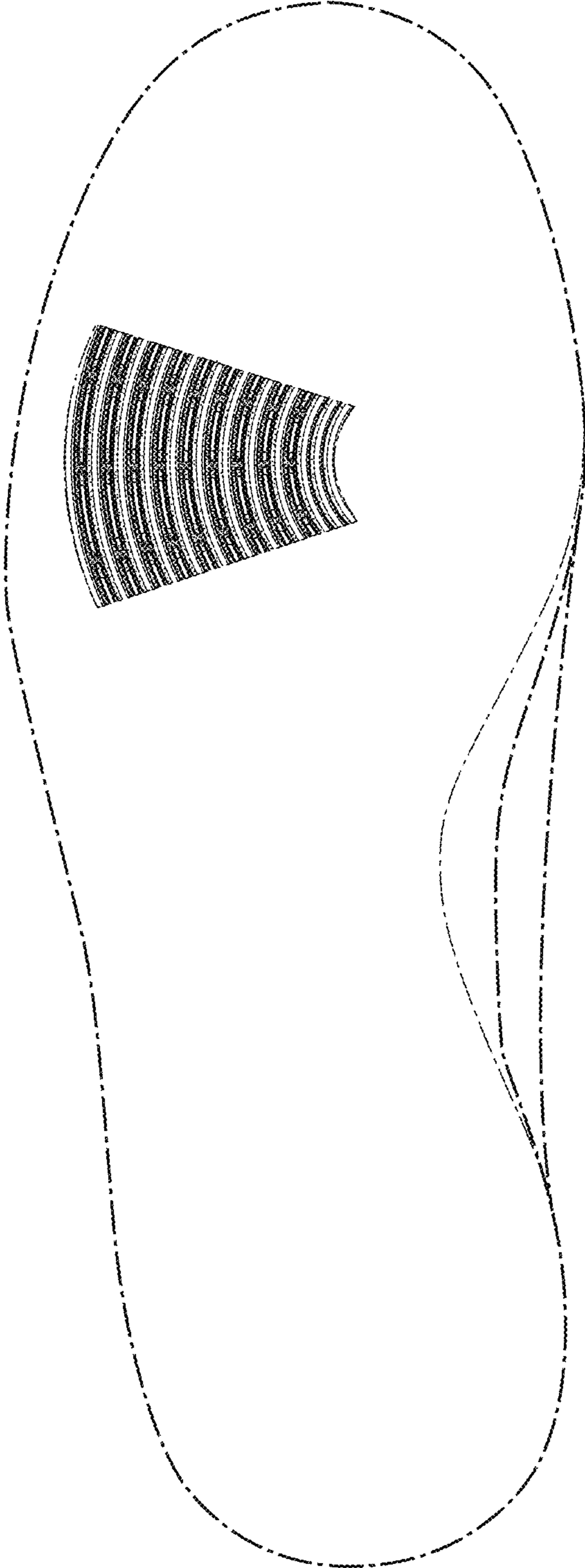

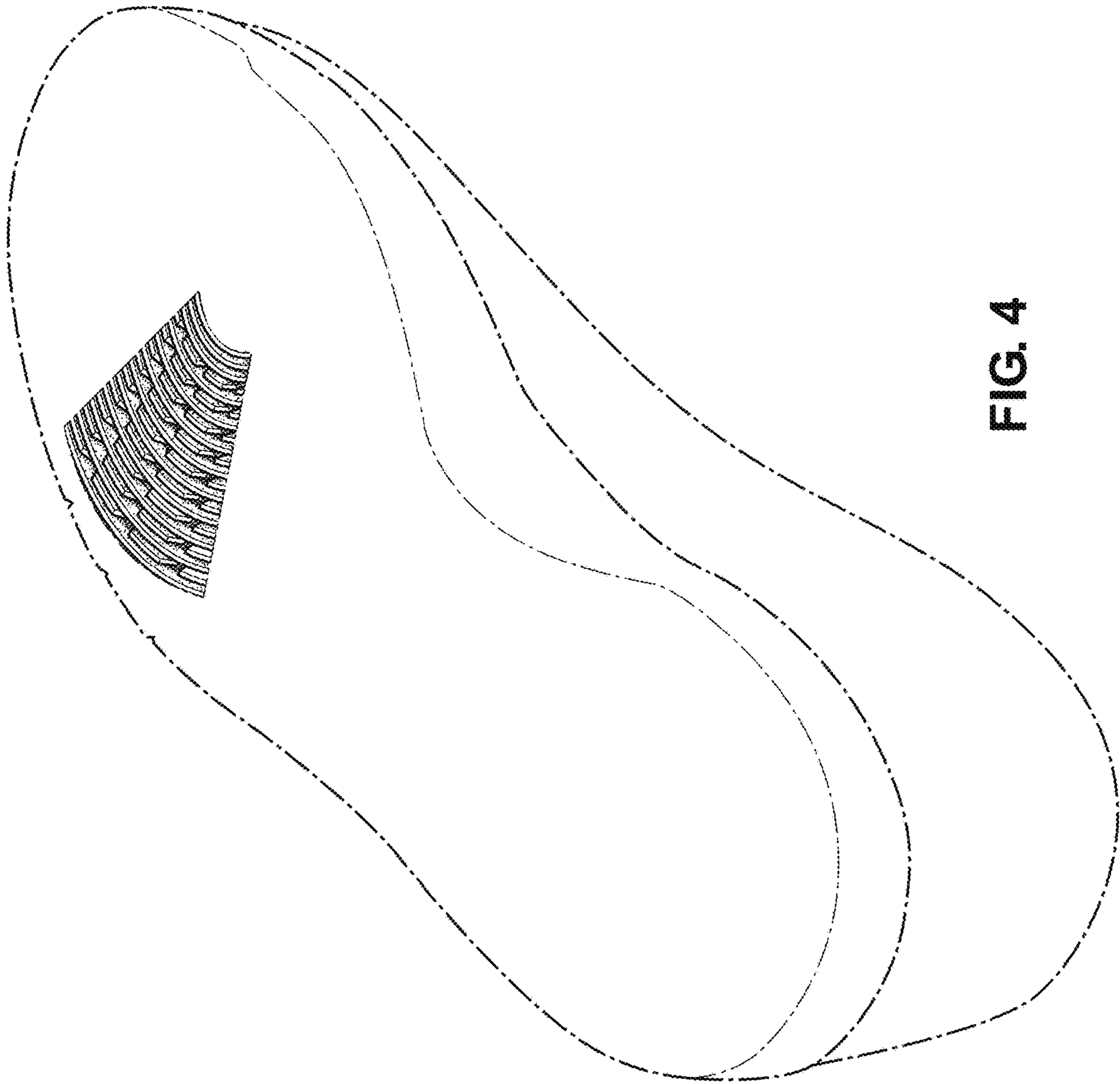

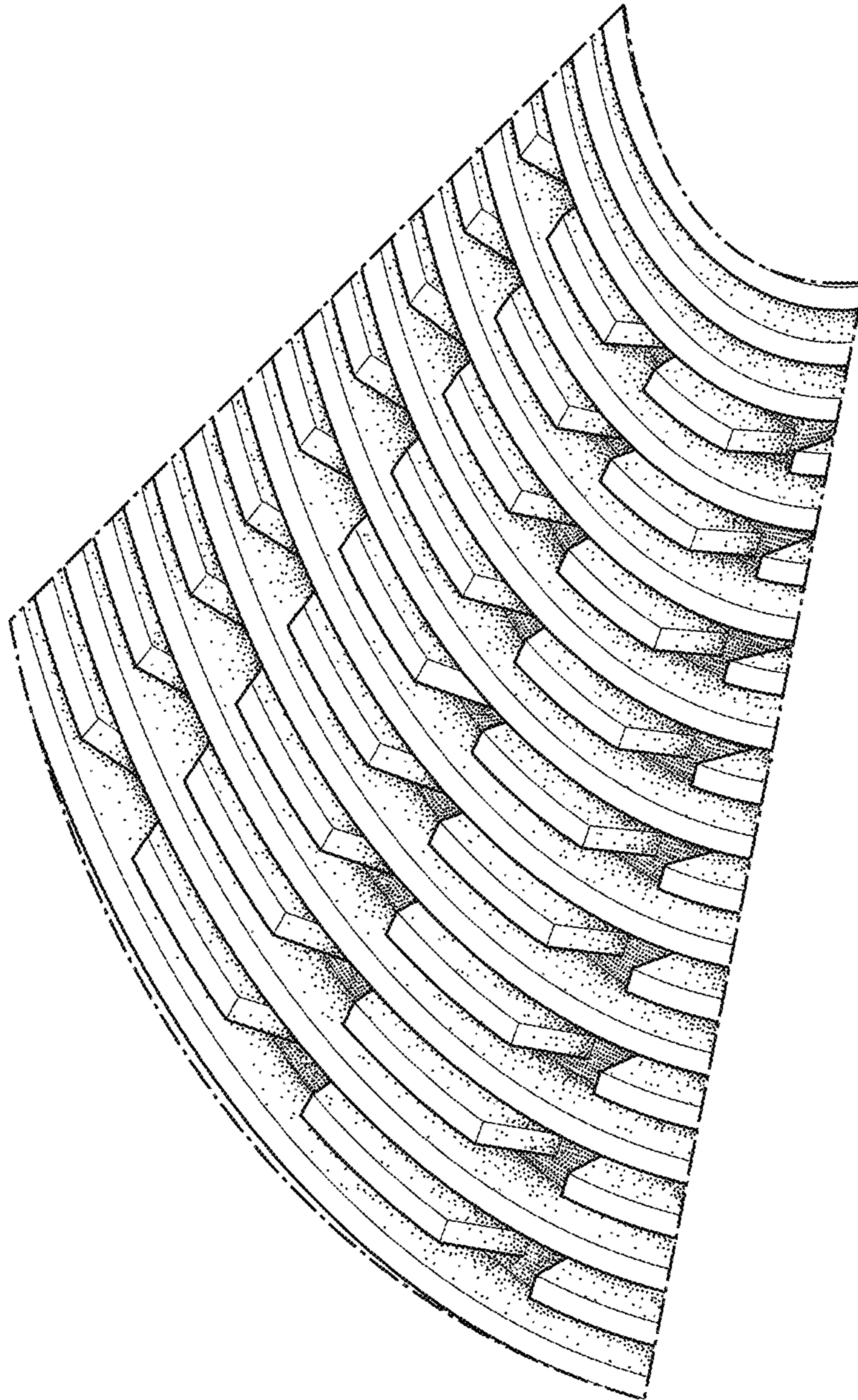
