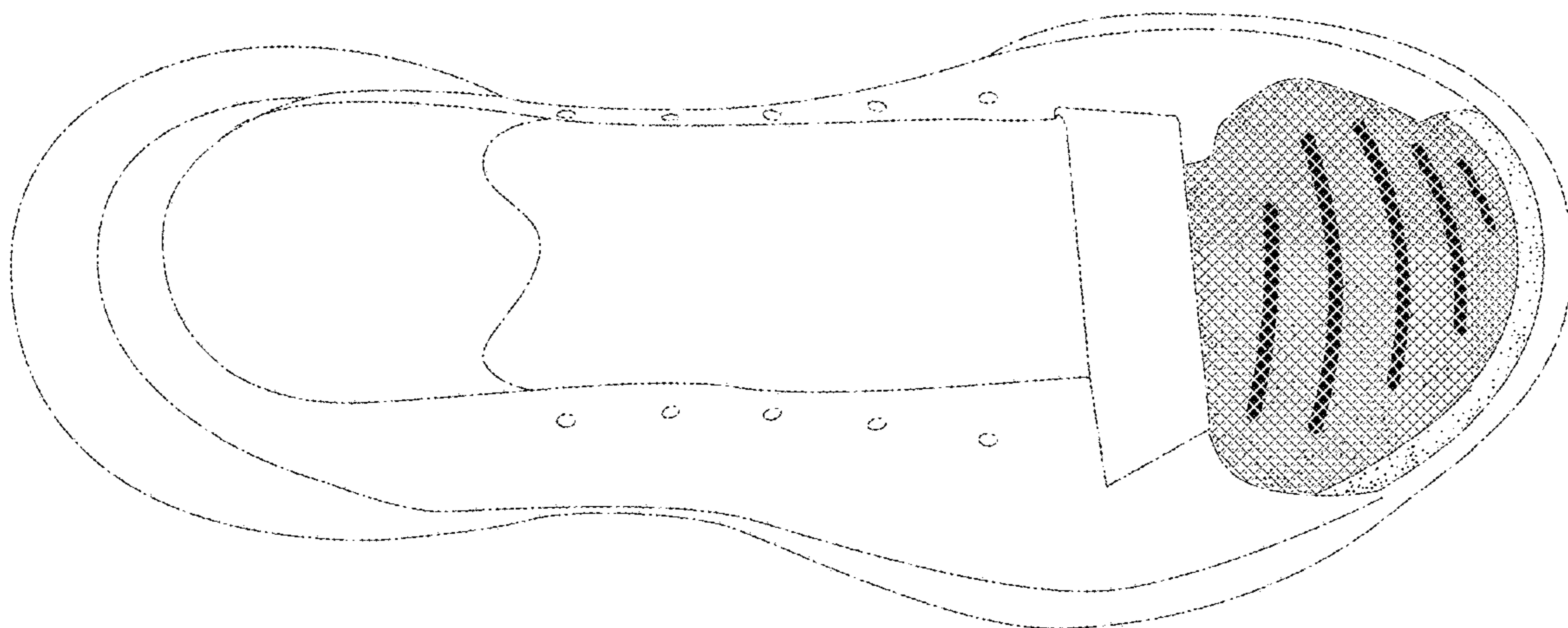
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a shoe upper showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; and, FIG. 4 is an opposite side view thereof. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. 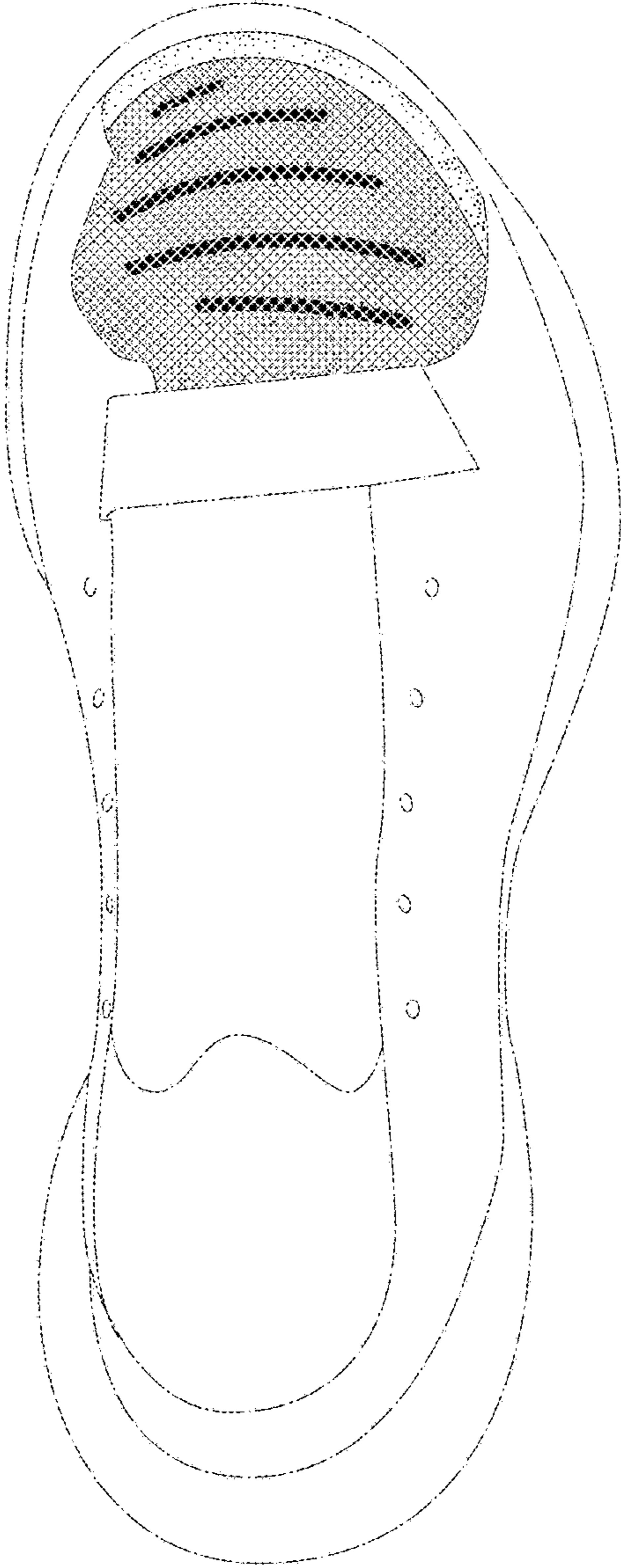

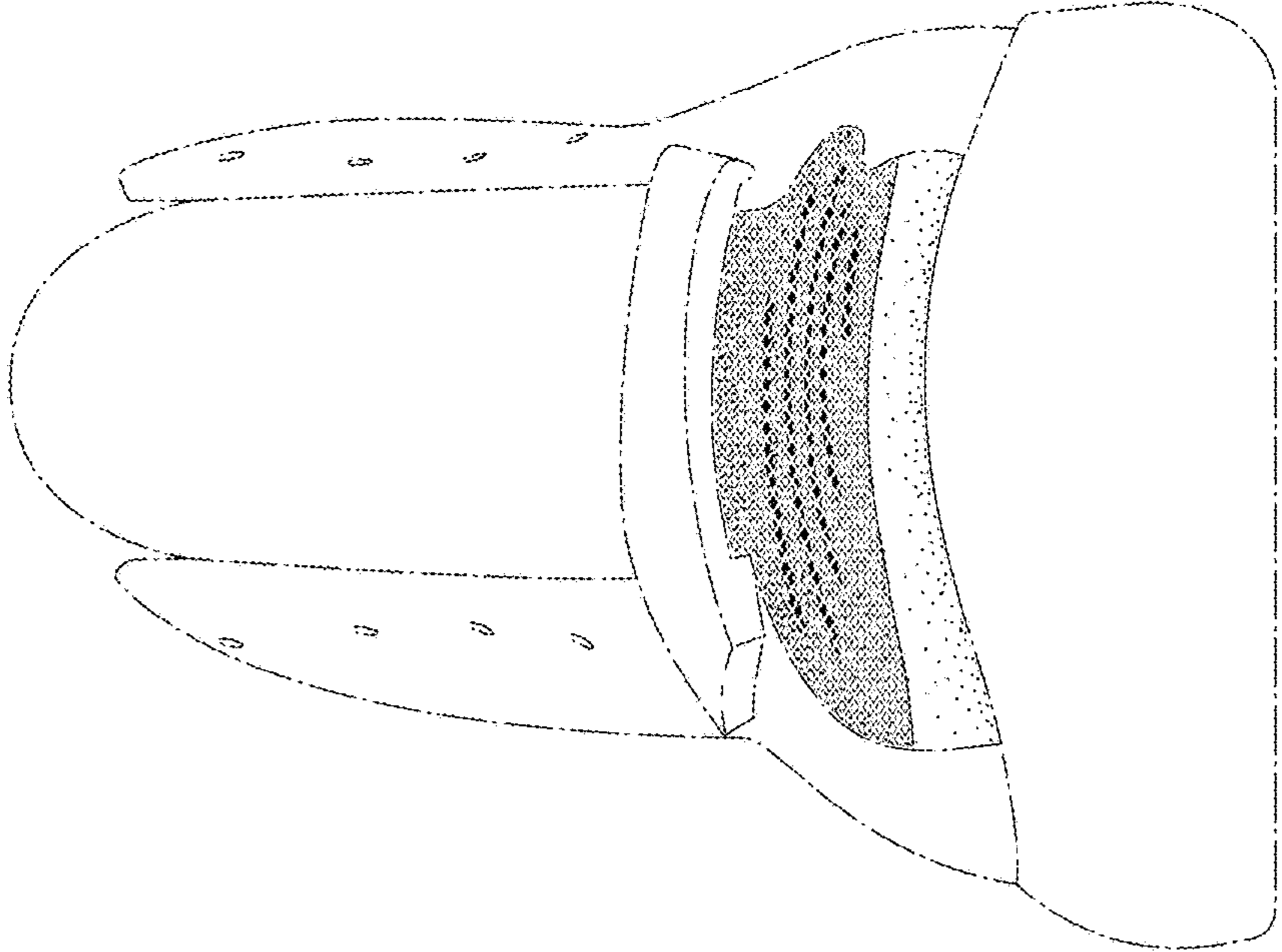

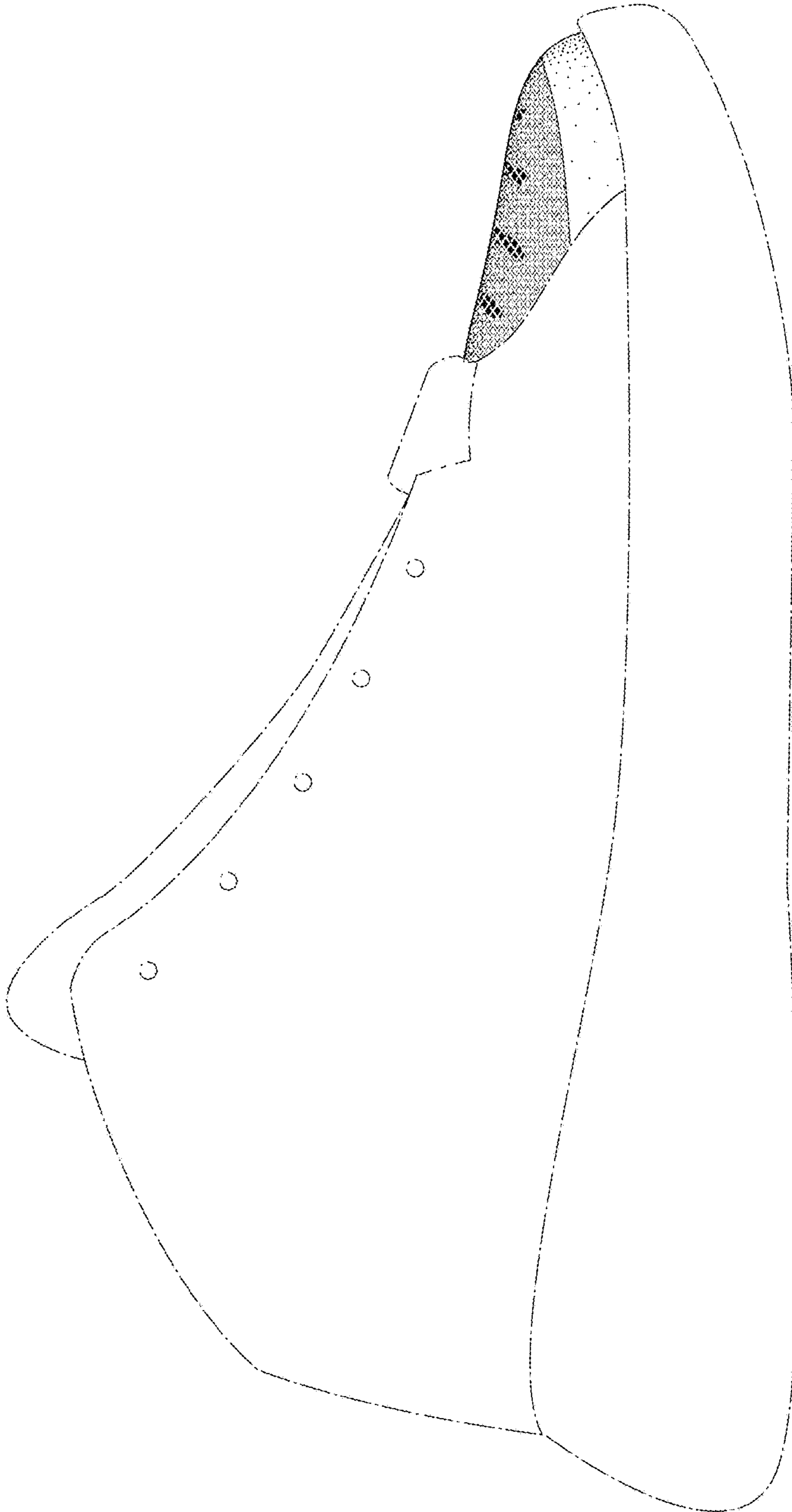

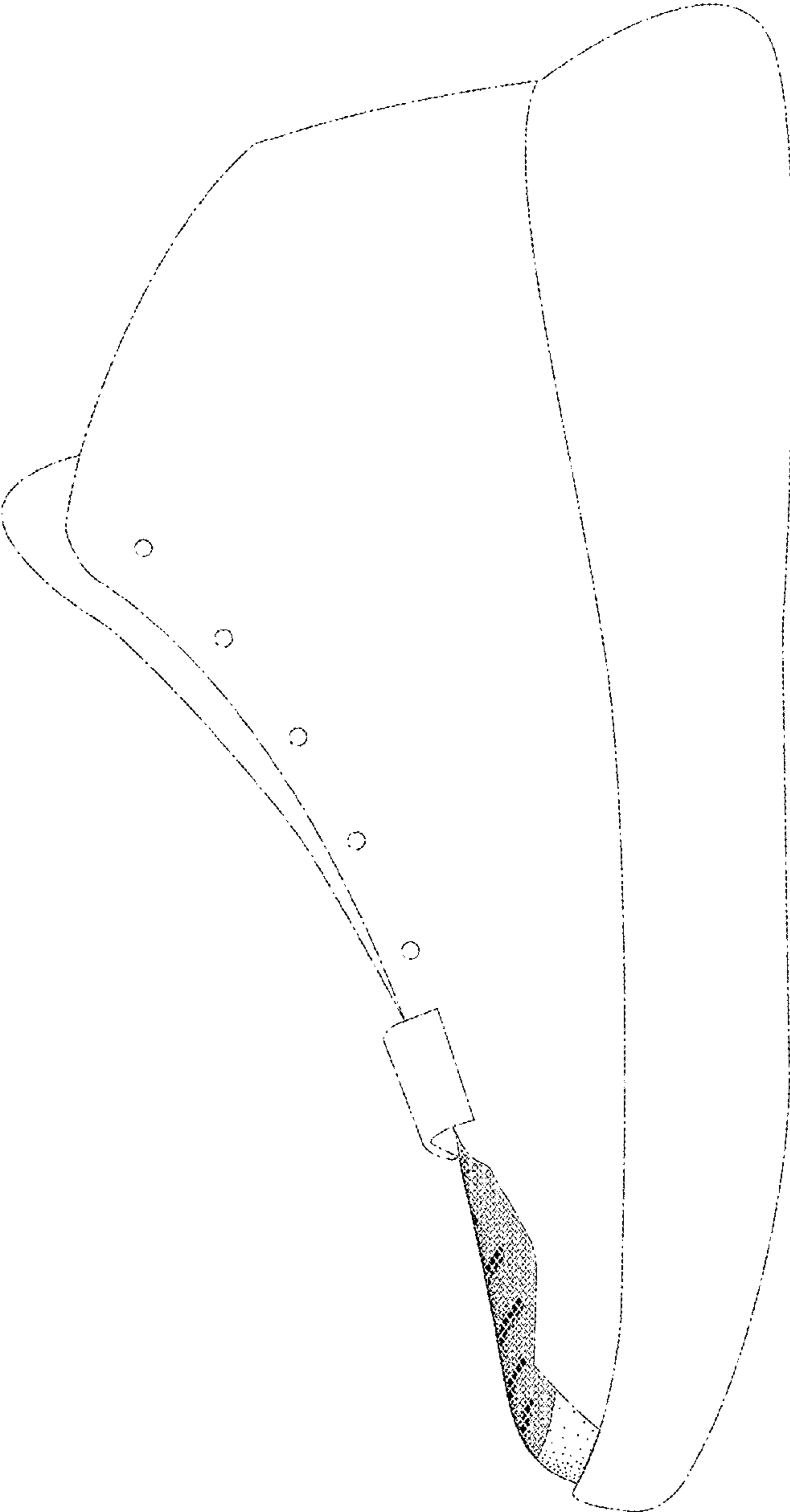
