(57) **CLAIM**

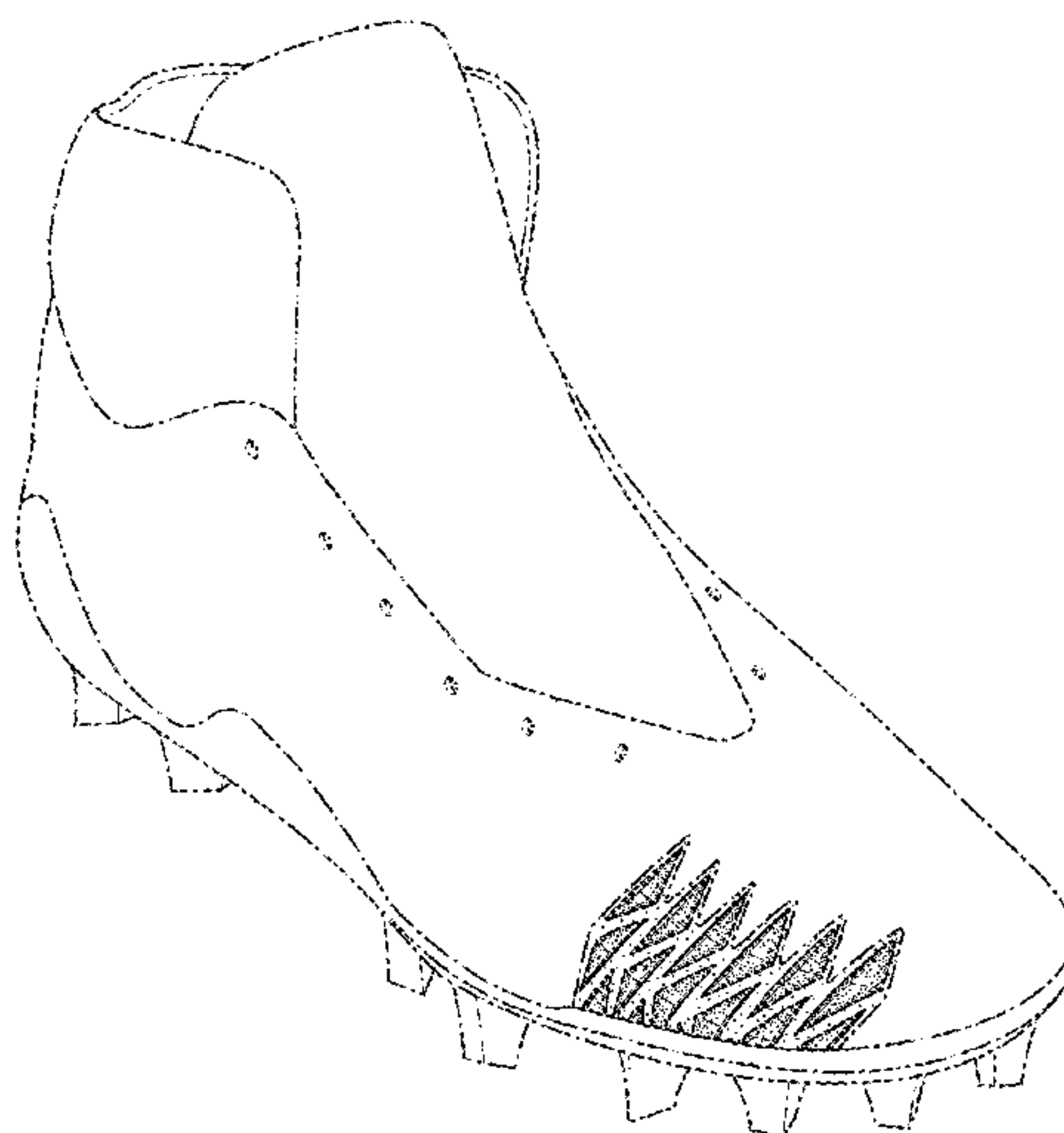
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper showing my new design;  
 FIG. 2 is a side view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is an enlarged view of the FIG. 1 perspective view, shown isolated from the environment; and,  
 FIG. 5 is an enlarged view of the FIG. 3 front view, shown isolated from the environment.

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

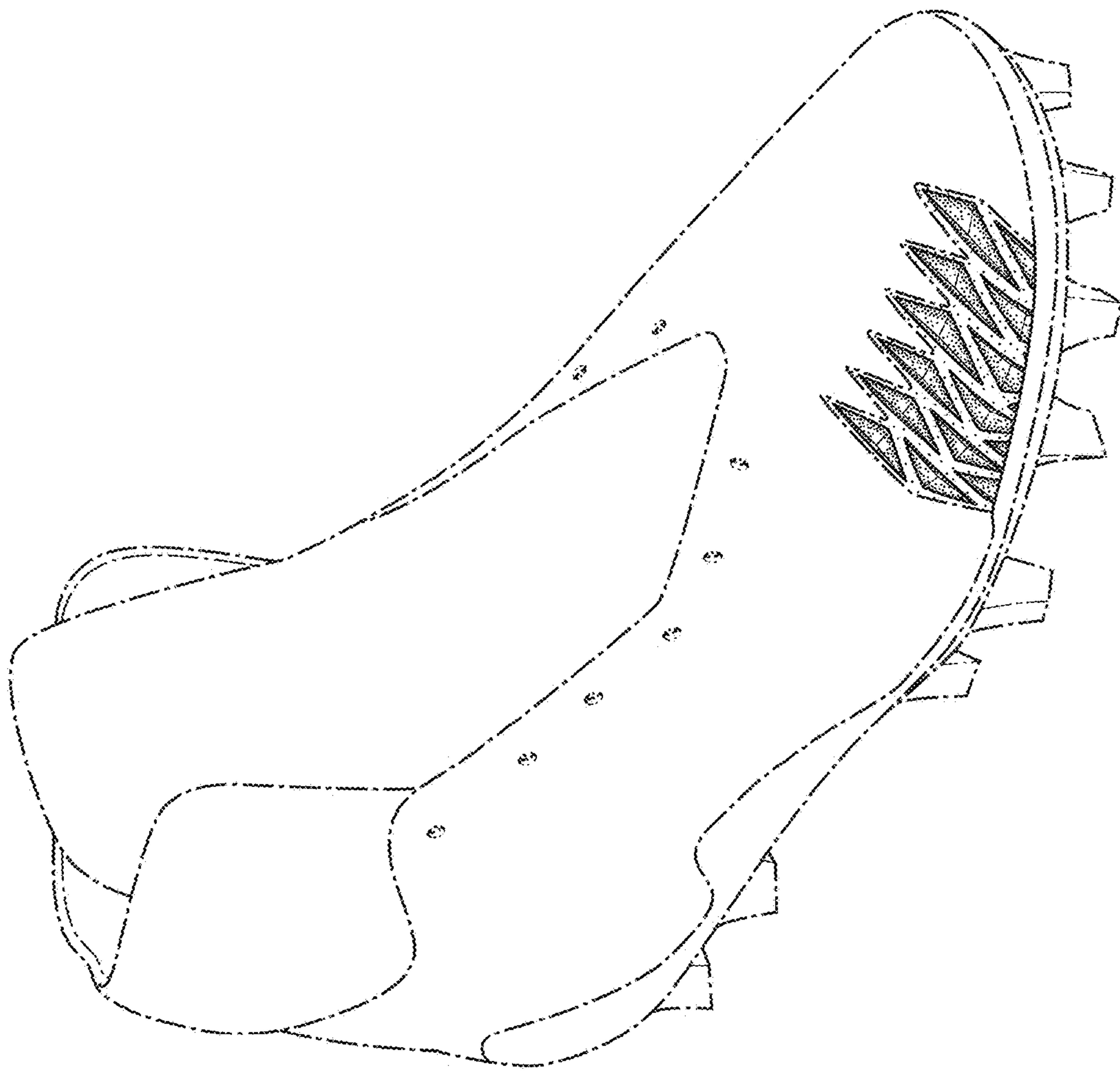

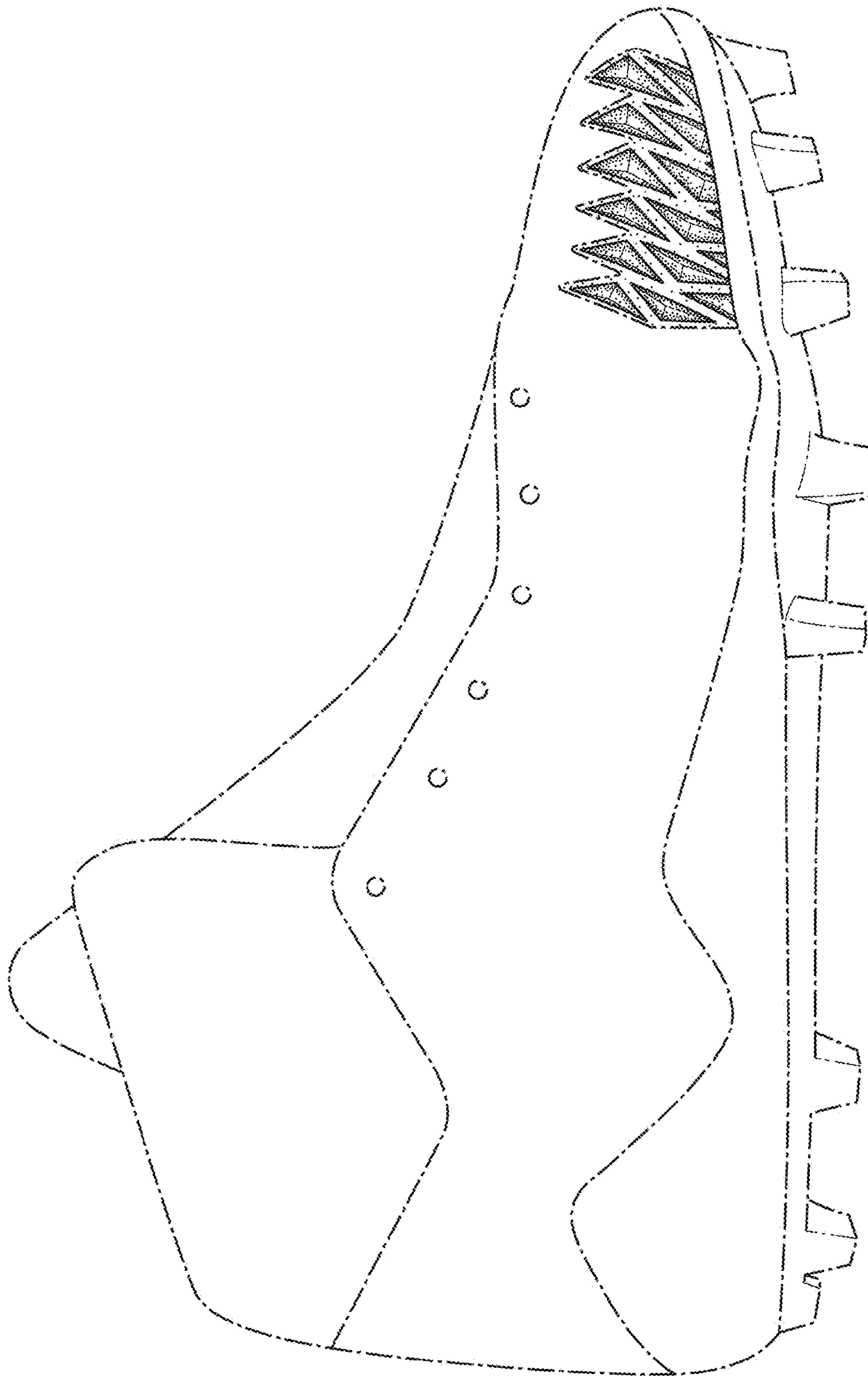

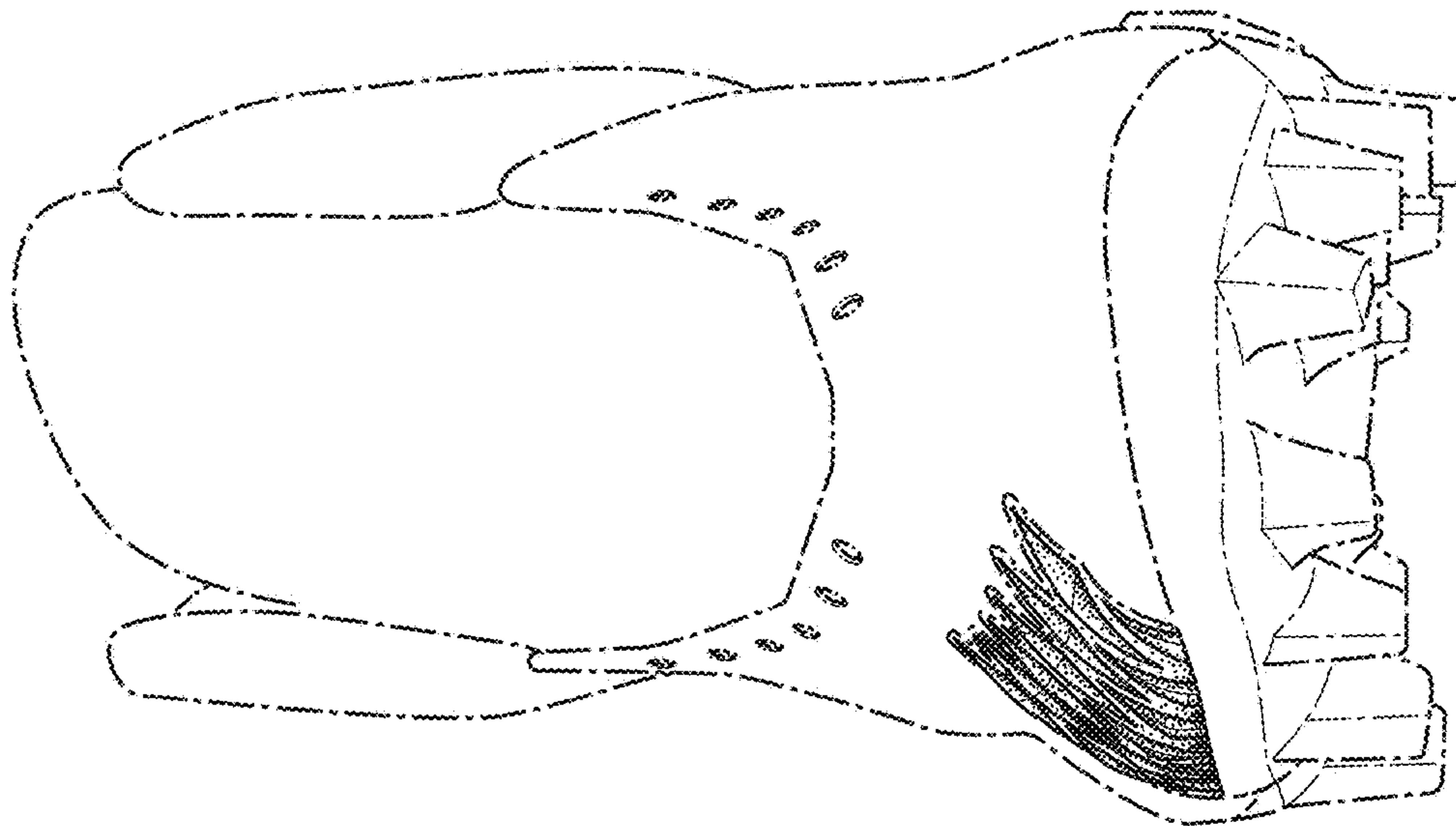

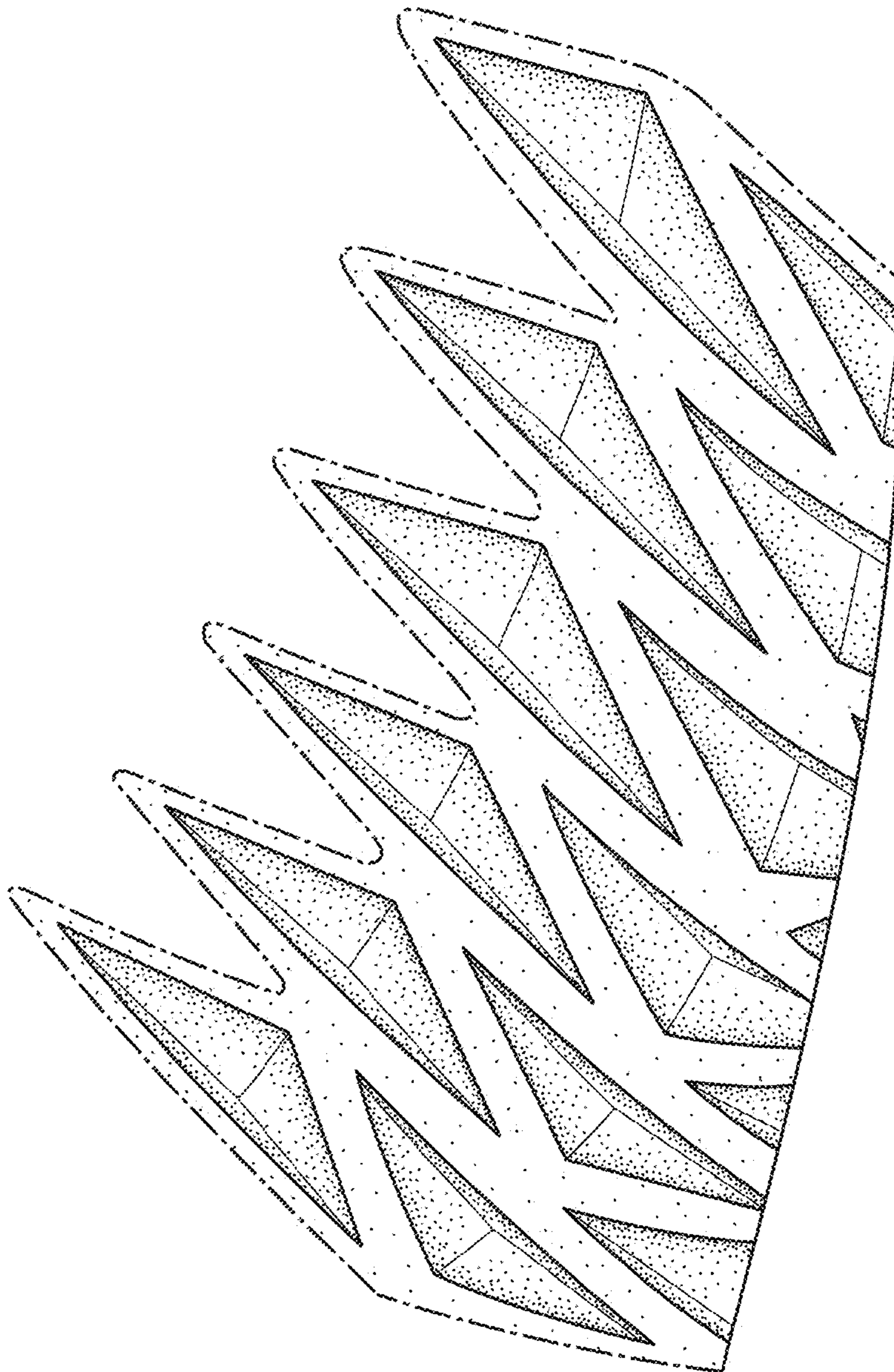

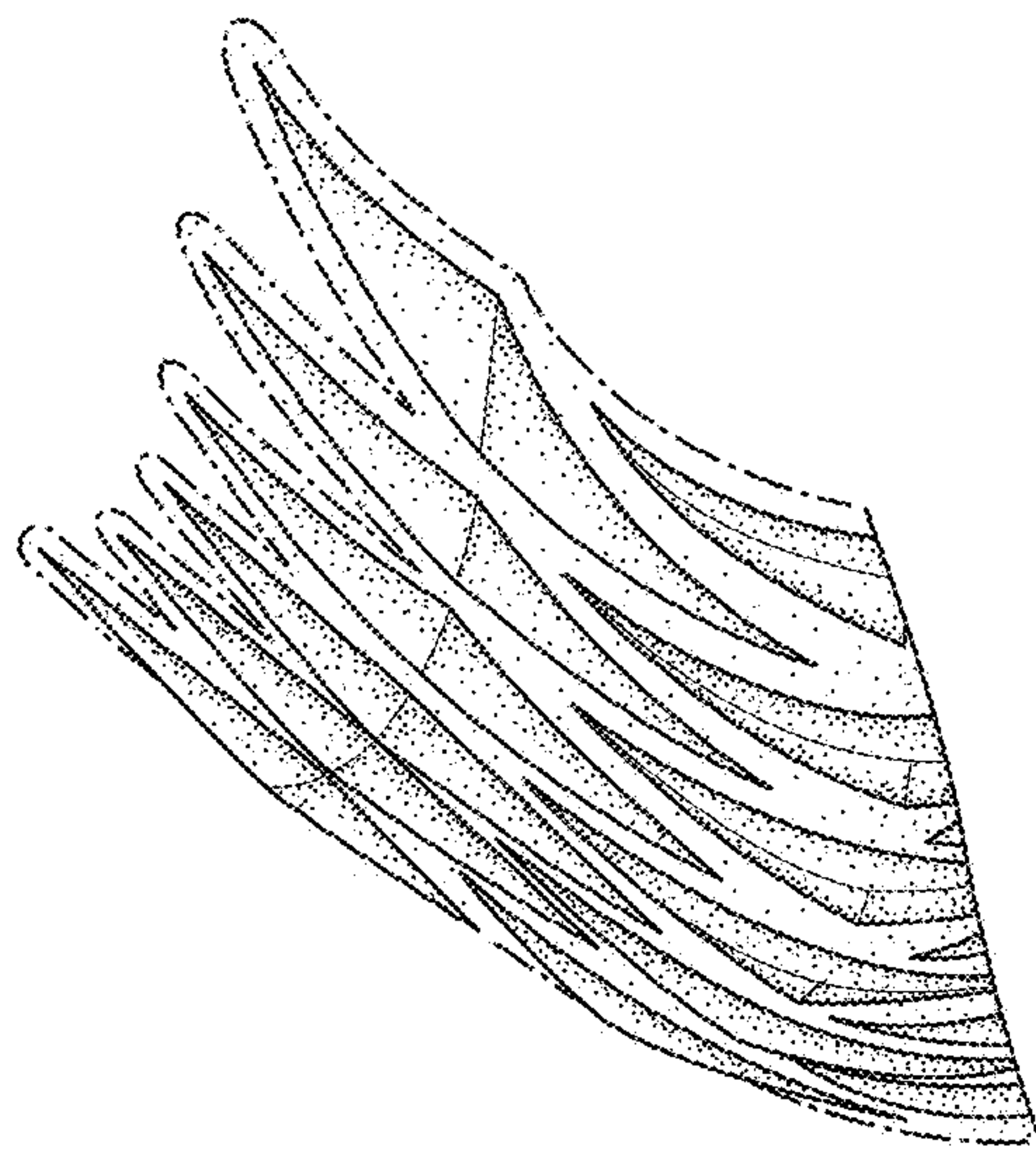
