**DESCRIPTION**

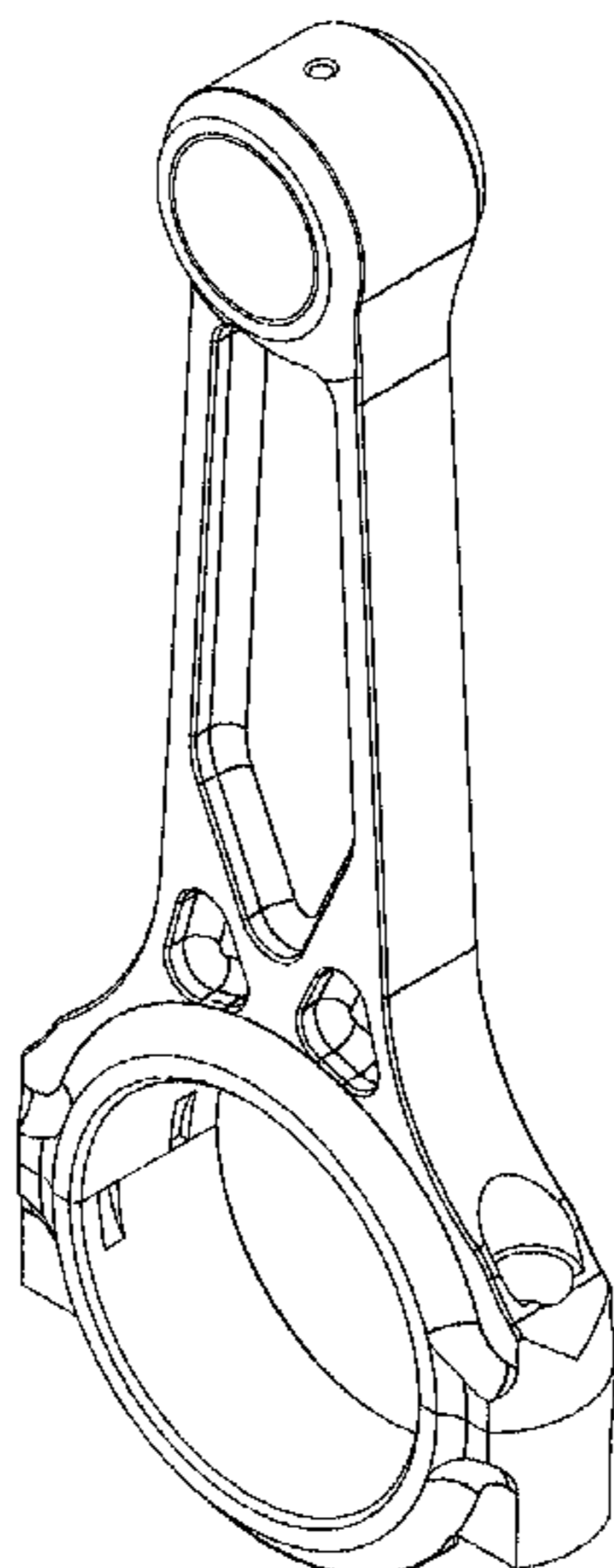
FIG. 1 is a perspective view of the I-beam connecting rod of the present invention.

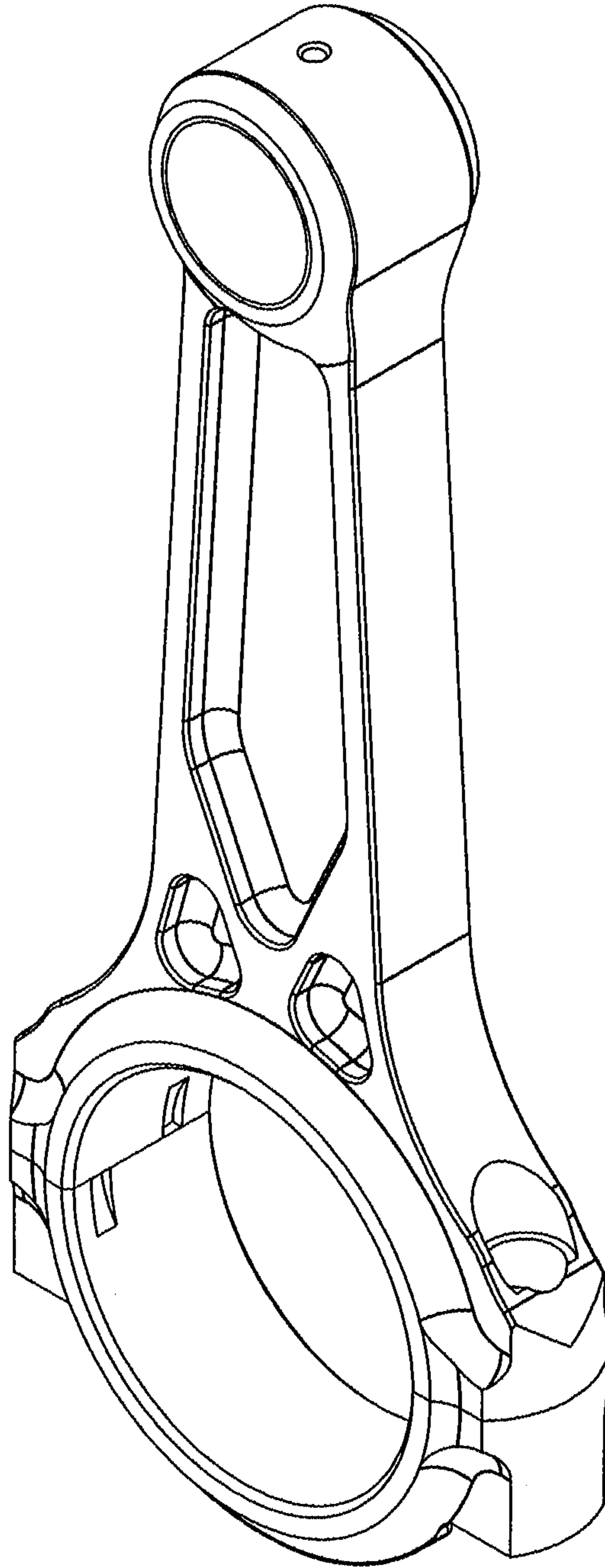

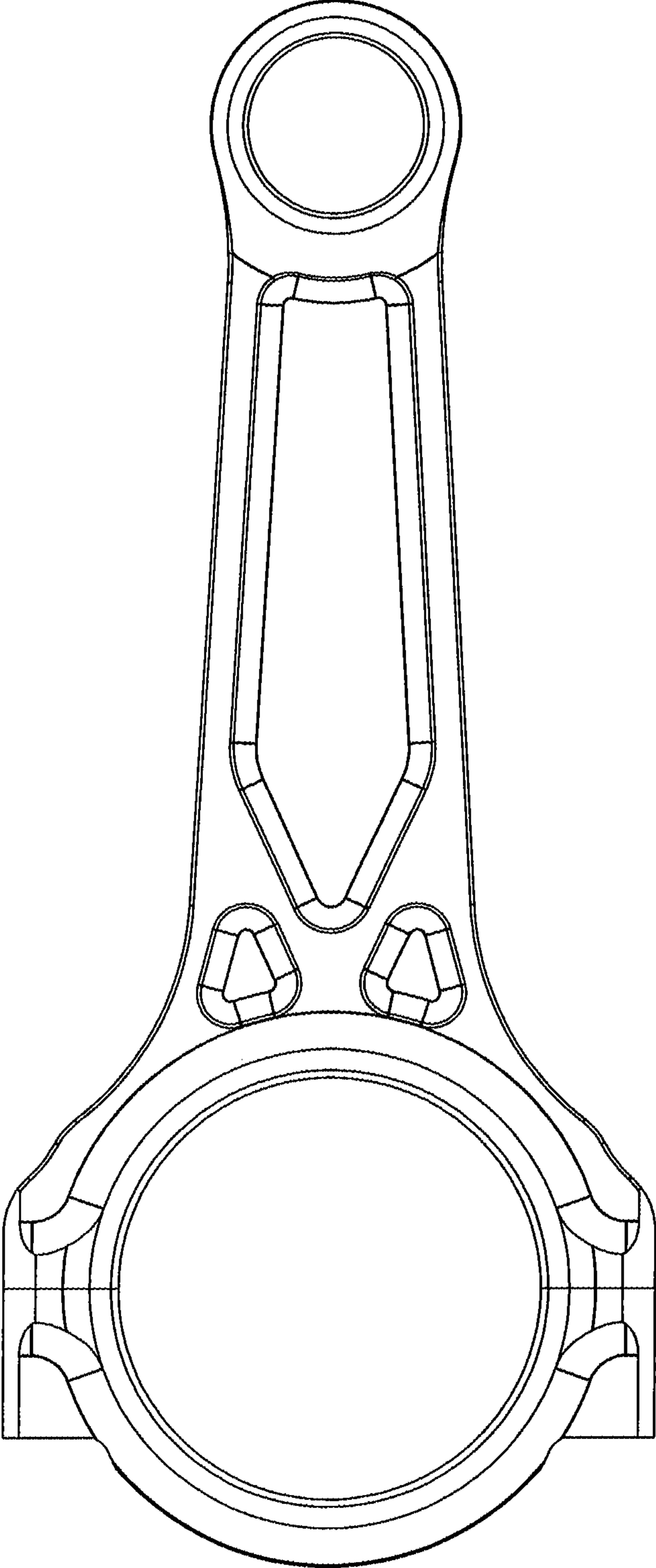

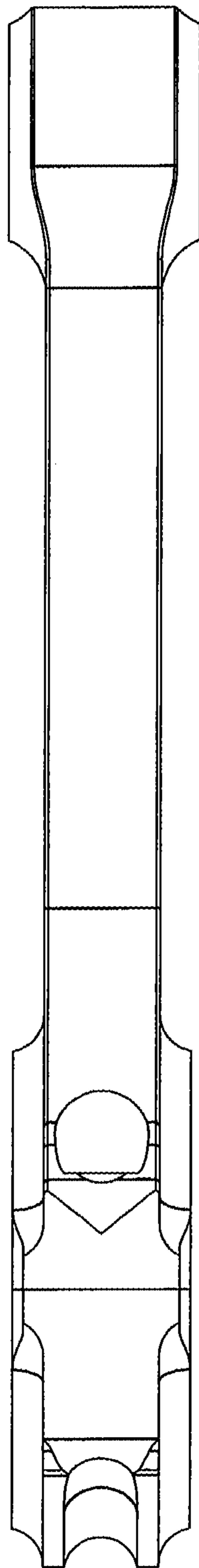

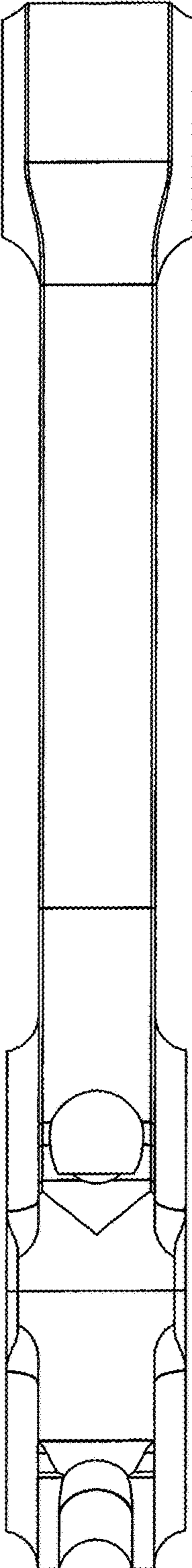

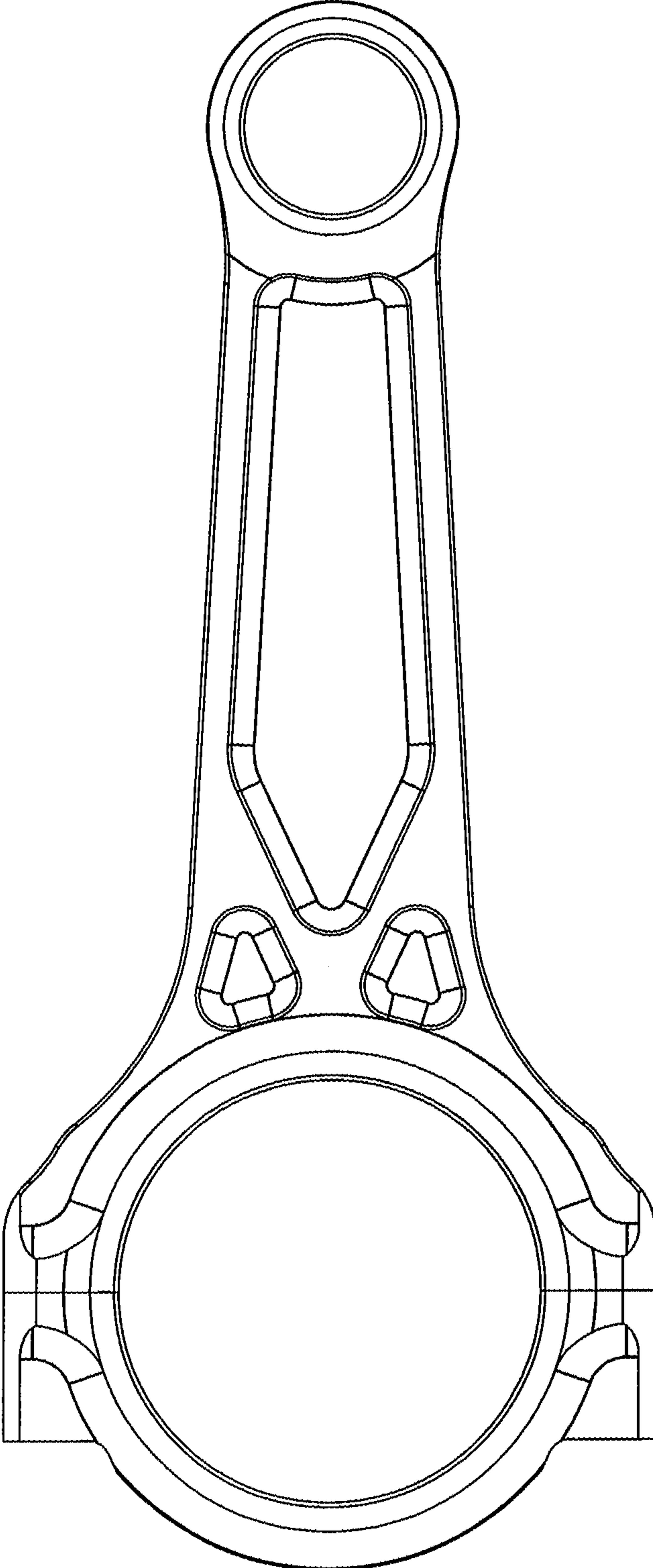

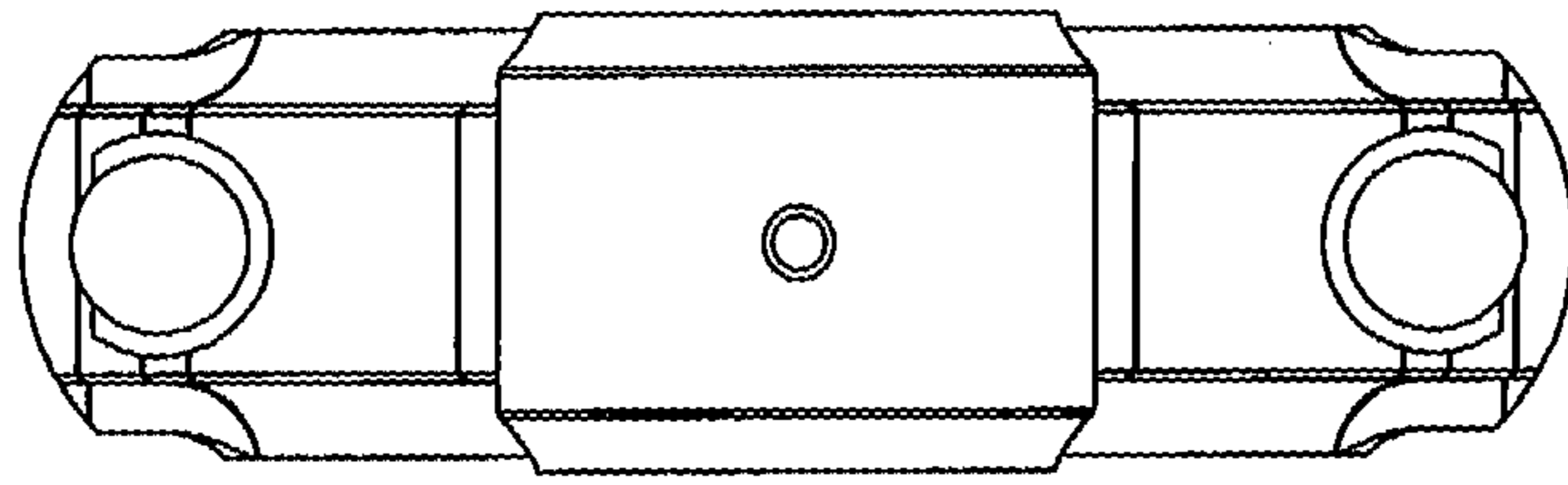

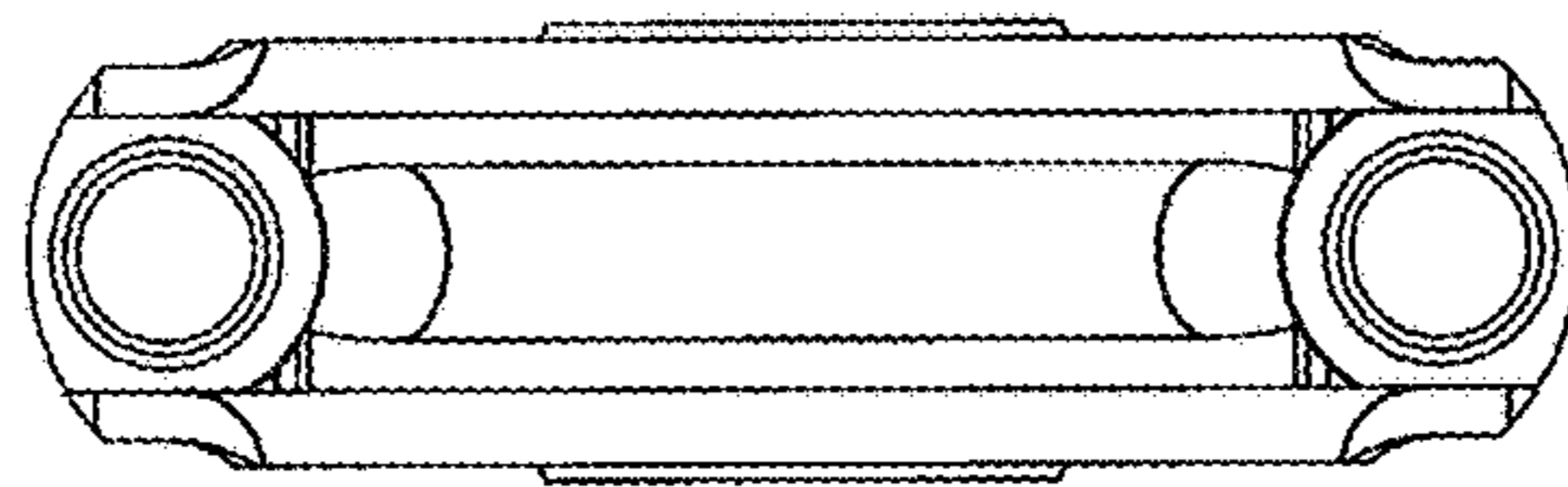
