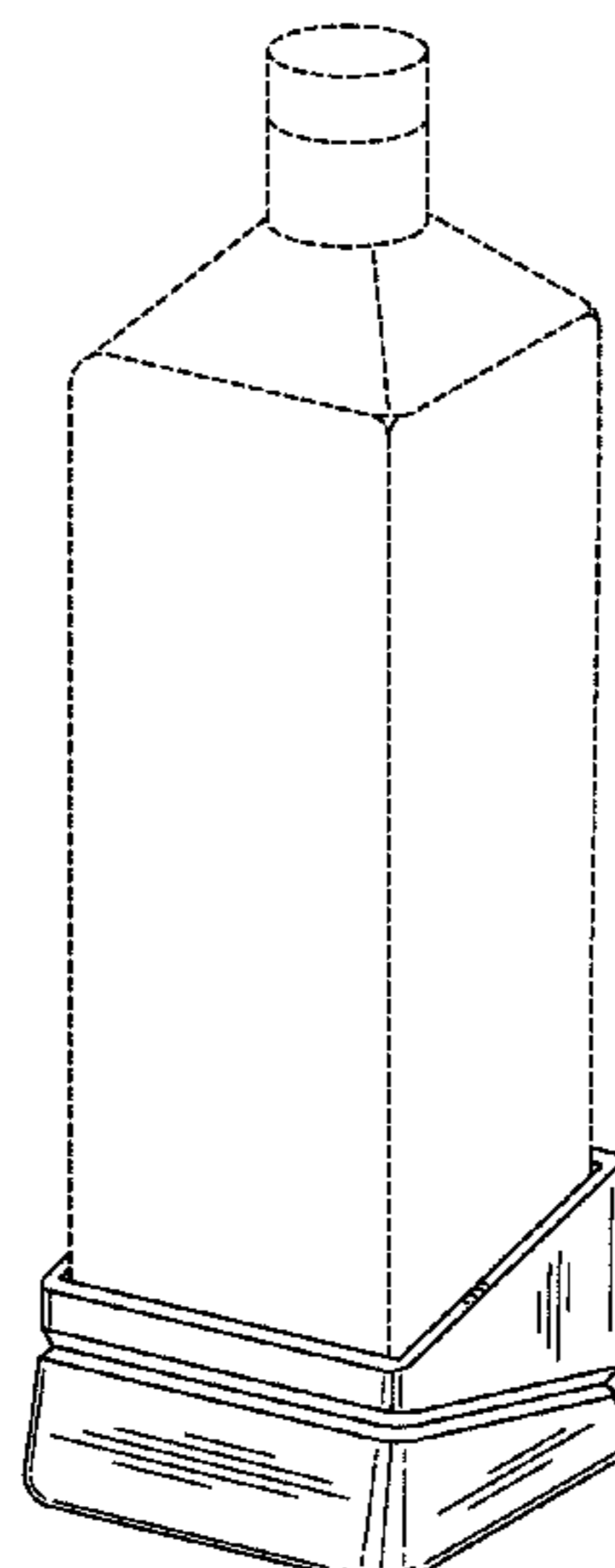
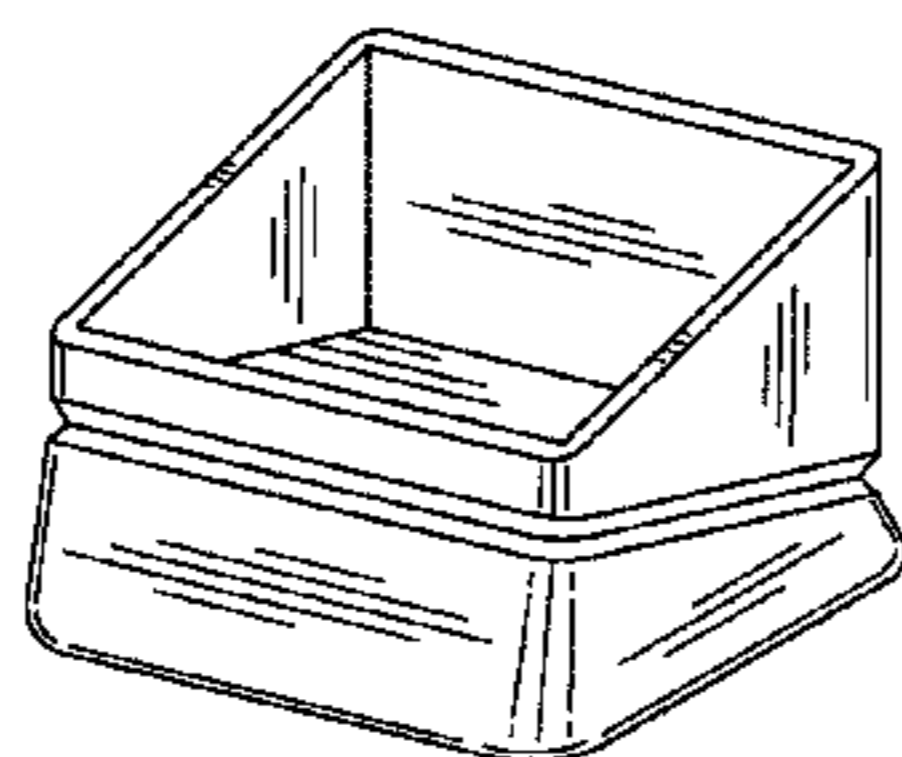
(57) **CLAIM**

The ornamental design for a stand, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a stand, with the material of the stand being opaque; FIG. 2 is a top plan view of the stand of FIG. 1; FIG. 3 is a bottom plan view of the stand of FIG. 1; FIG. 4 is a front elevational view of the stand of FIG. 1; FIG. 5 is a rear elevational view of the stand of FIG. 1; FIG. 6 is a right elevational view of the stand of FIG. 1; FIG. 7 is a left elevational view of the stand of FIG. 1; FIG. 8 is a front perspective view of the stand of FIG. 1 shown in a position of use with a container drawn in broken lines placed inside of the stand; FIG. 9 is a front perspective view of a second embodiment of a stand, with the material of the stand being translucent; FIG. 10 is a top plan view of the stand of FIG. 9; FIG. 11 is a bottom plan view of the stand of FIG. 9; FIG. 12 is a front elevational view of the stand of FIG. 9; FIG. 13 is a rear elevational view of the stand of FIG. 9; FIG. 14 is a right elevational view of the stand of FIG. 9; FIG. 15 is a left elevational view of the stand of FIG. 9; and, FIG. 16 is a front perspective view of the stand of FIG. 9 shown in a position of use with a container drawn in broken lines placed inside of the stand. The broken lines in FIGS. 8 and 16 depict environment and form no part of the claimed design.

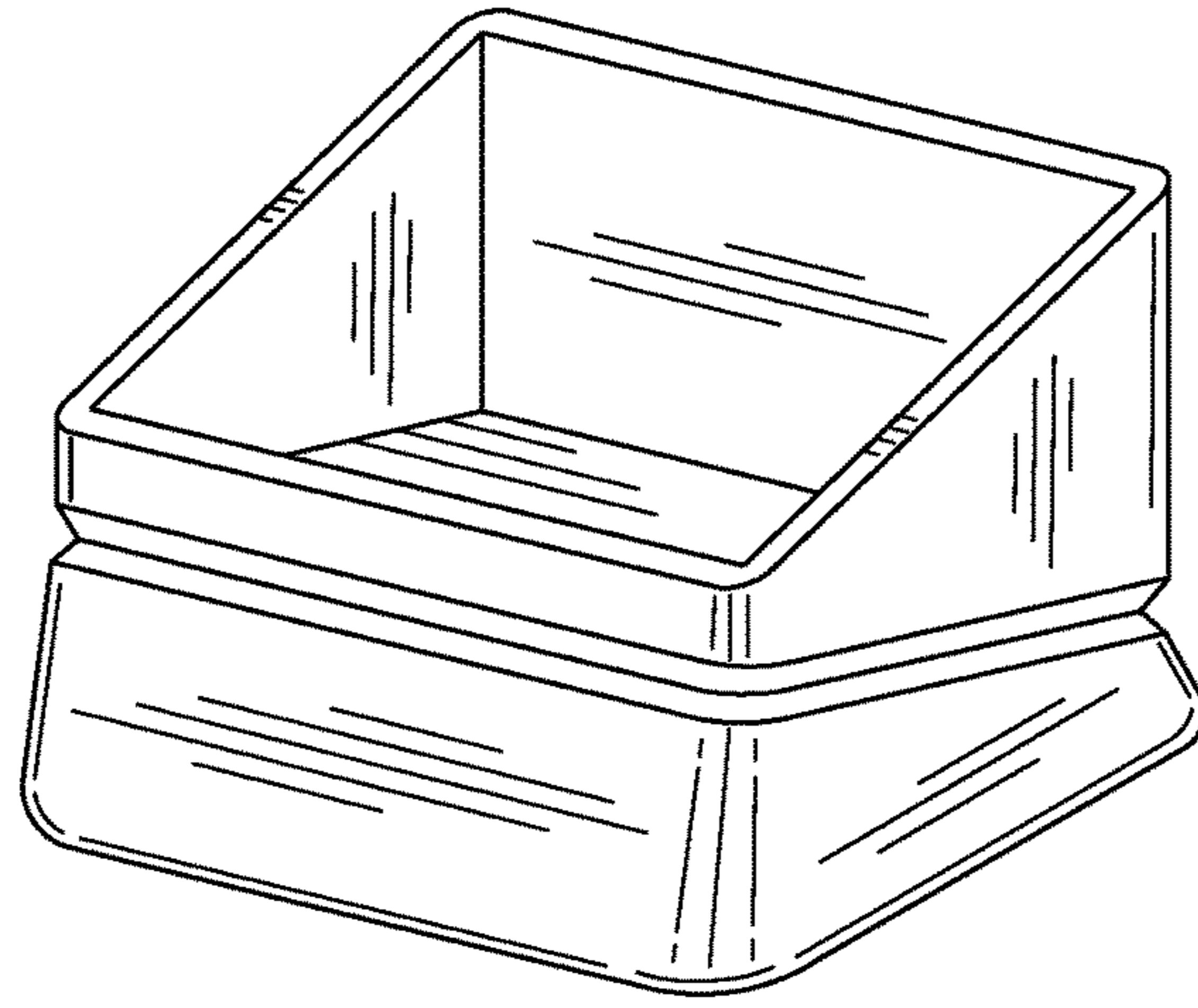

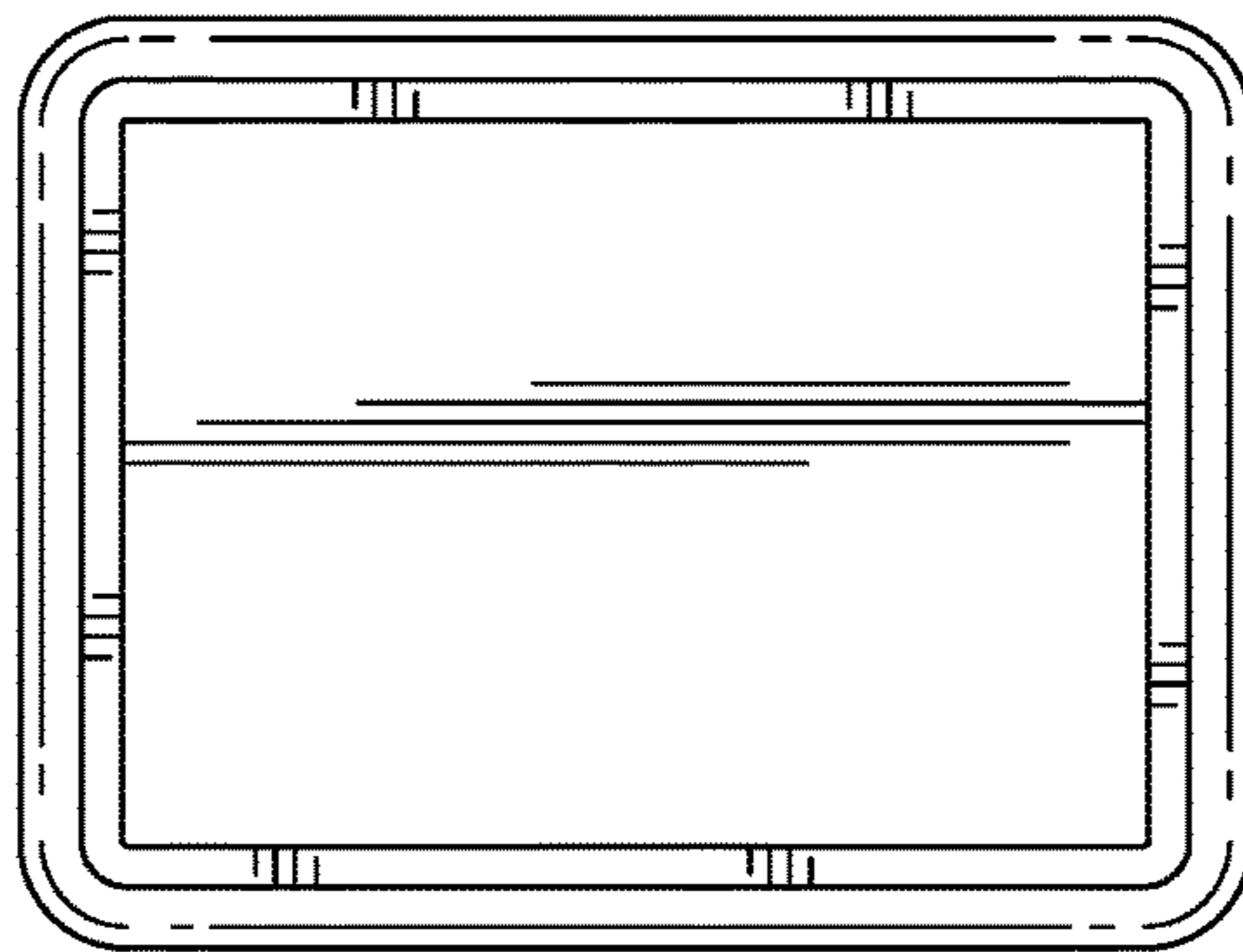

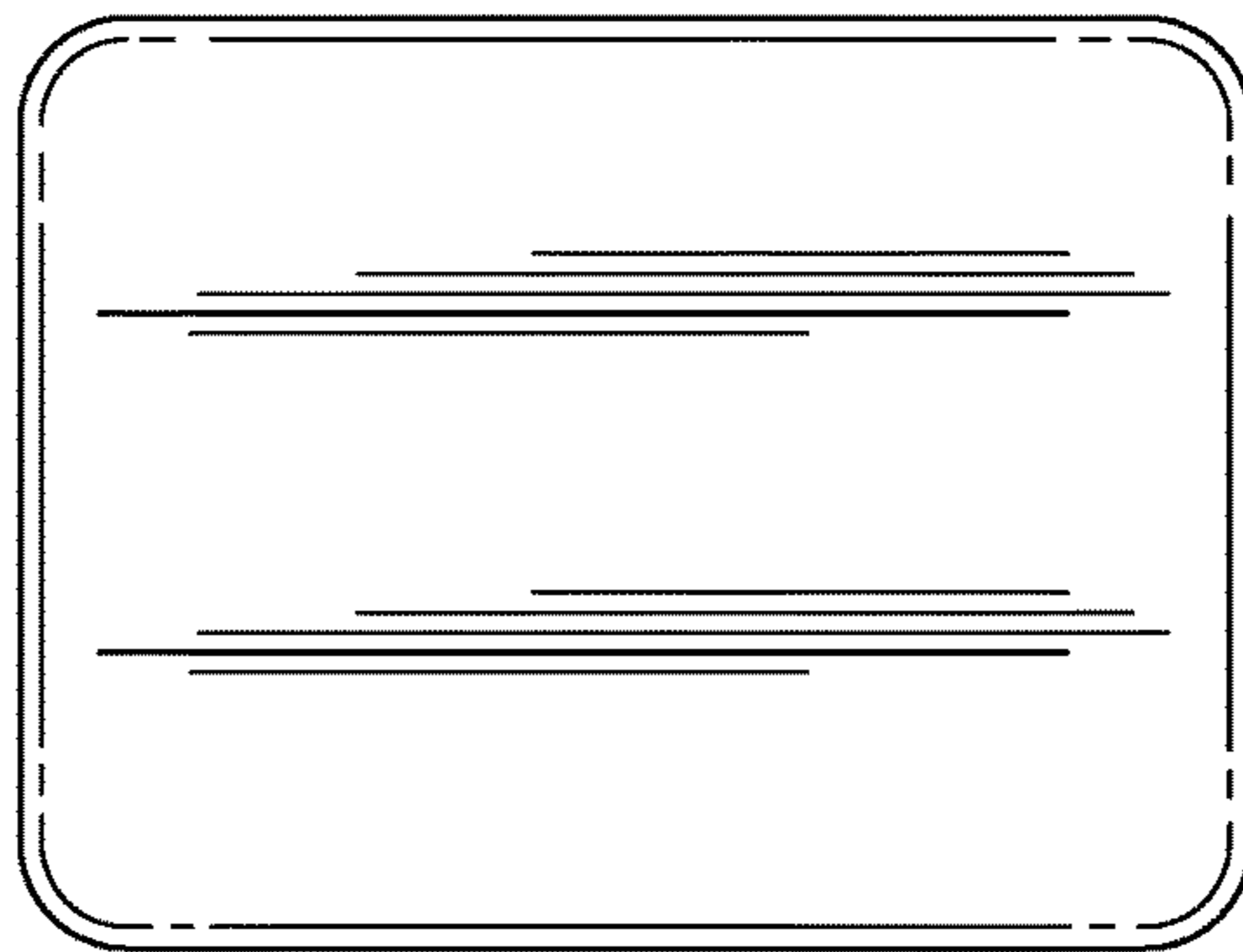

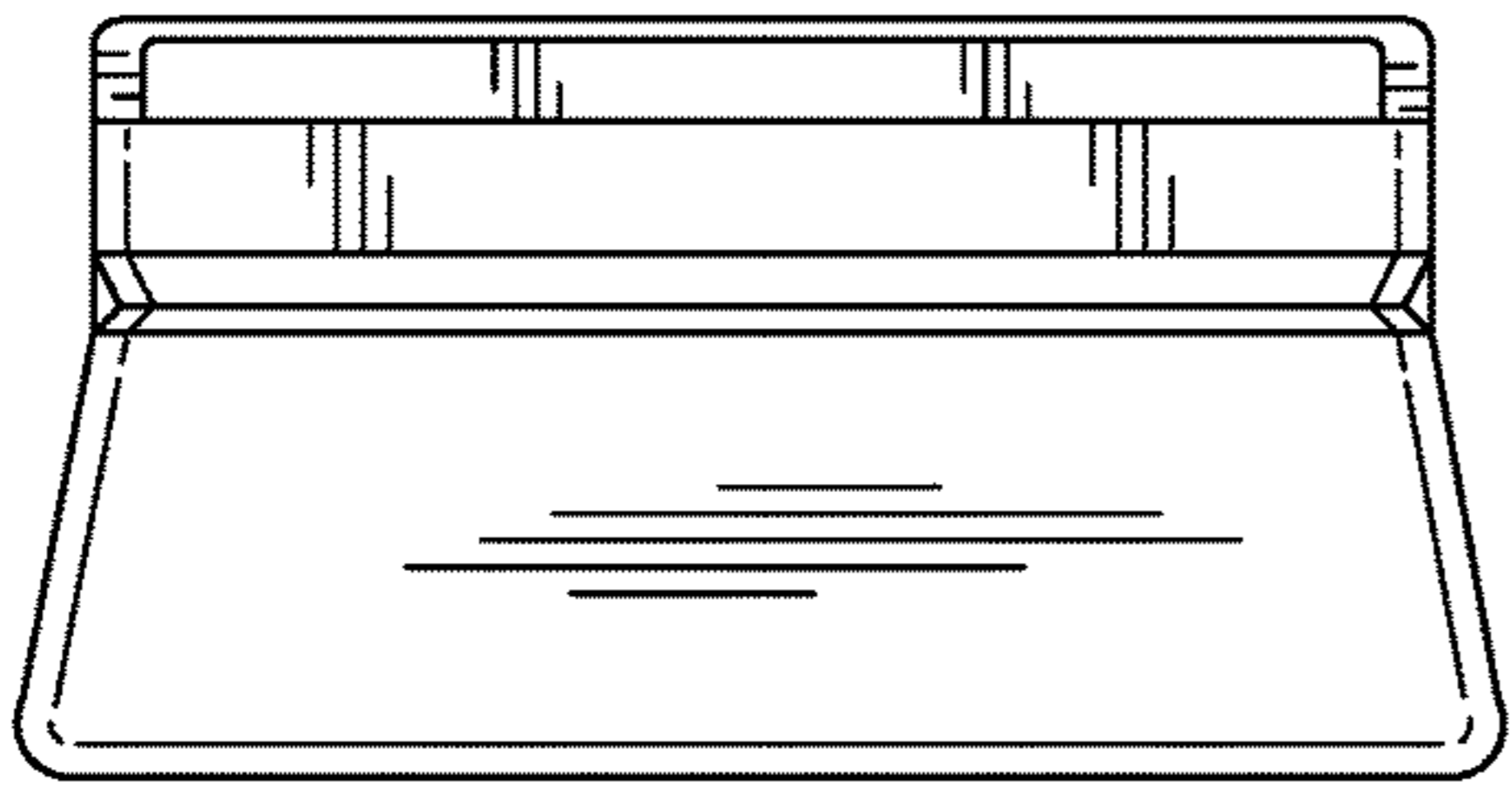

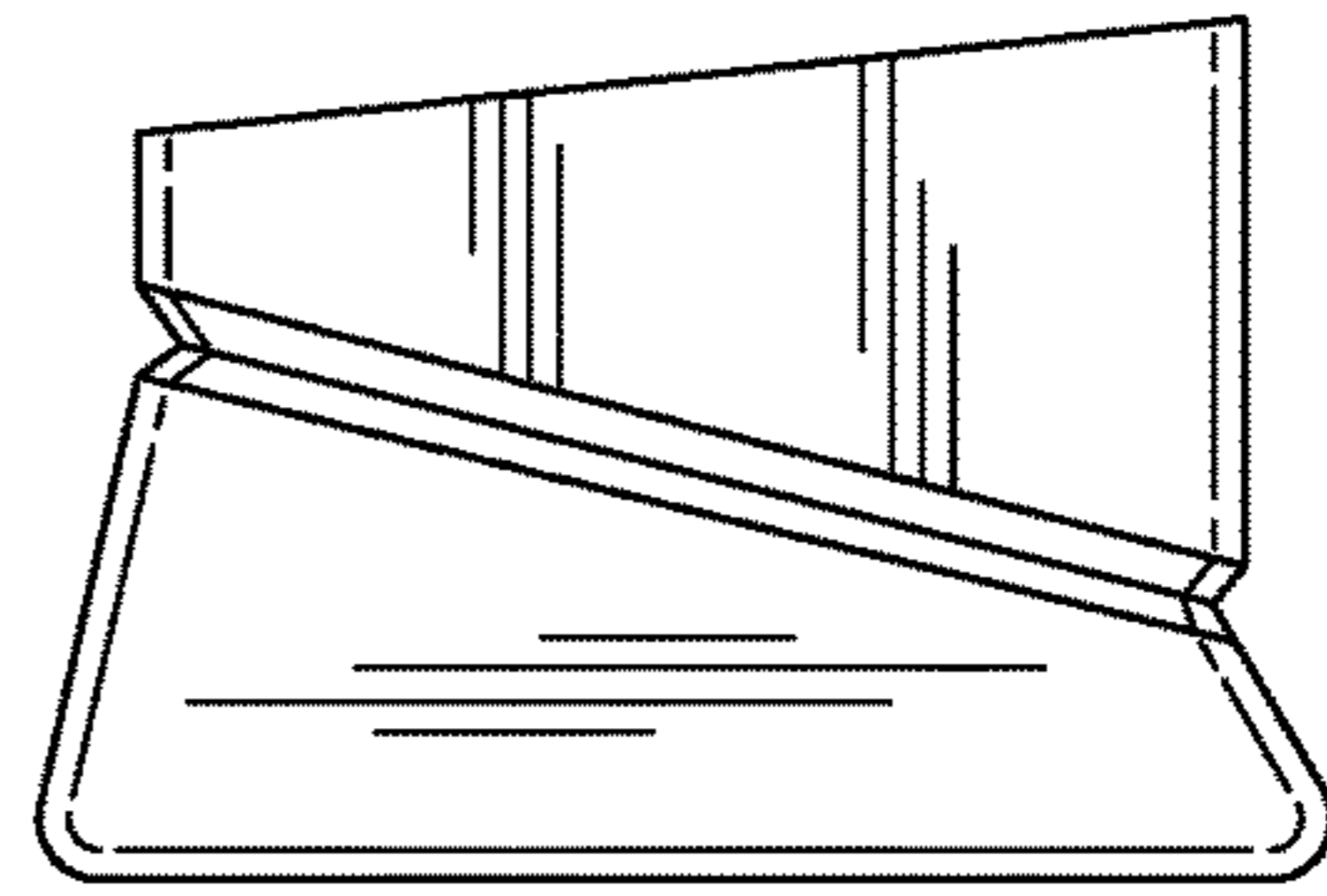

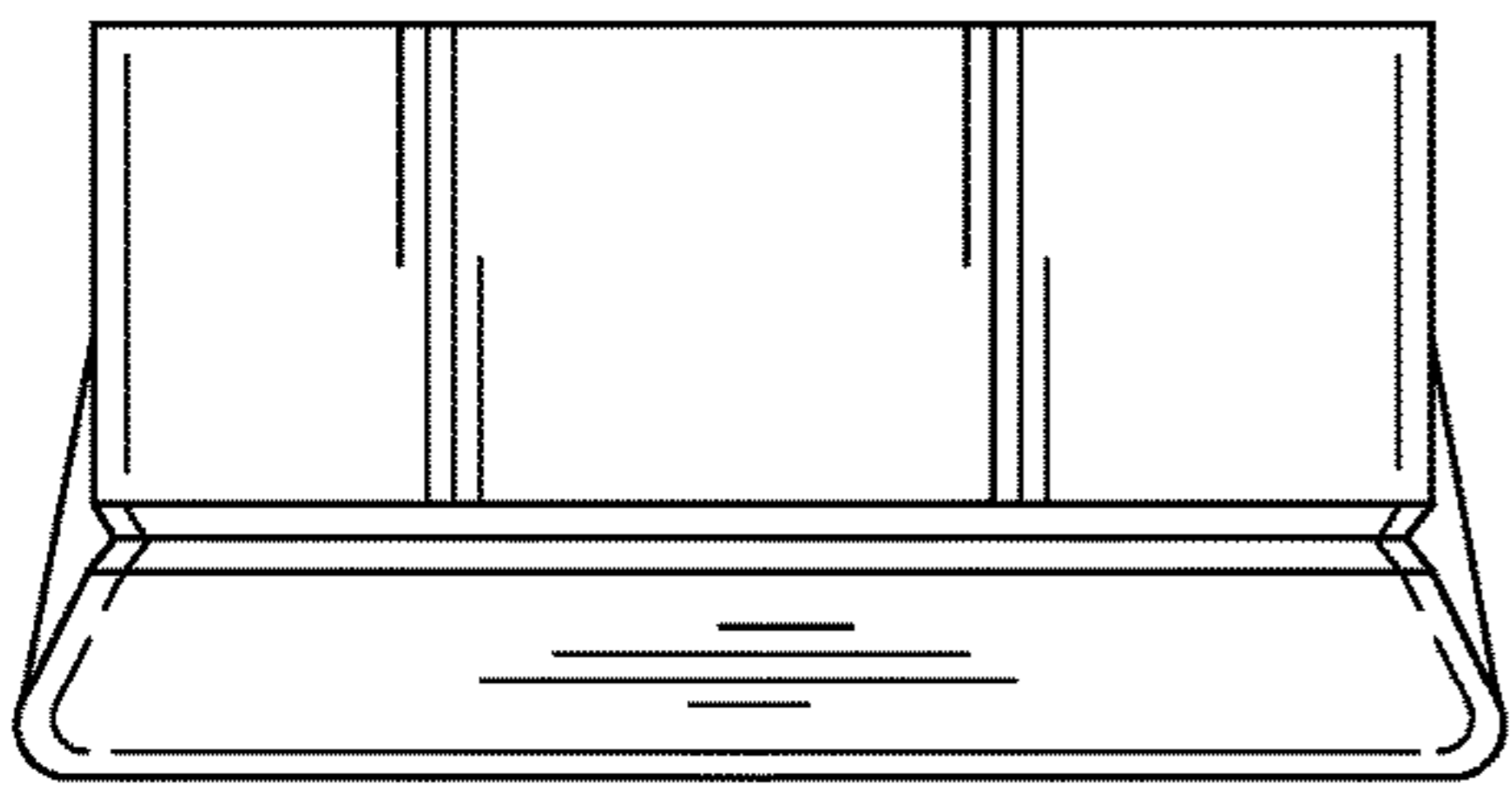

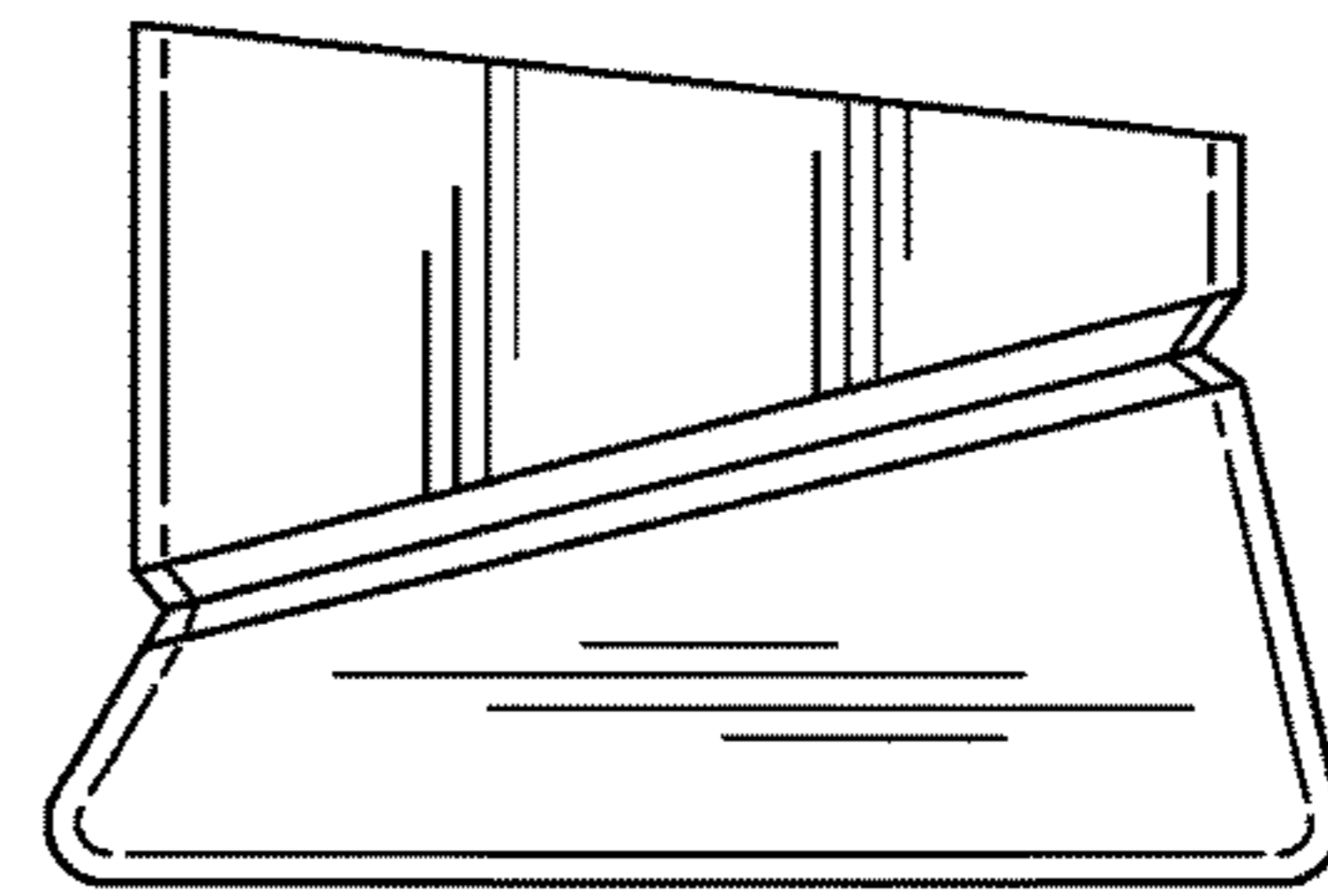

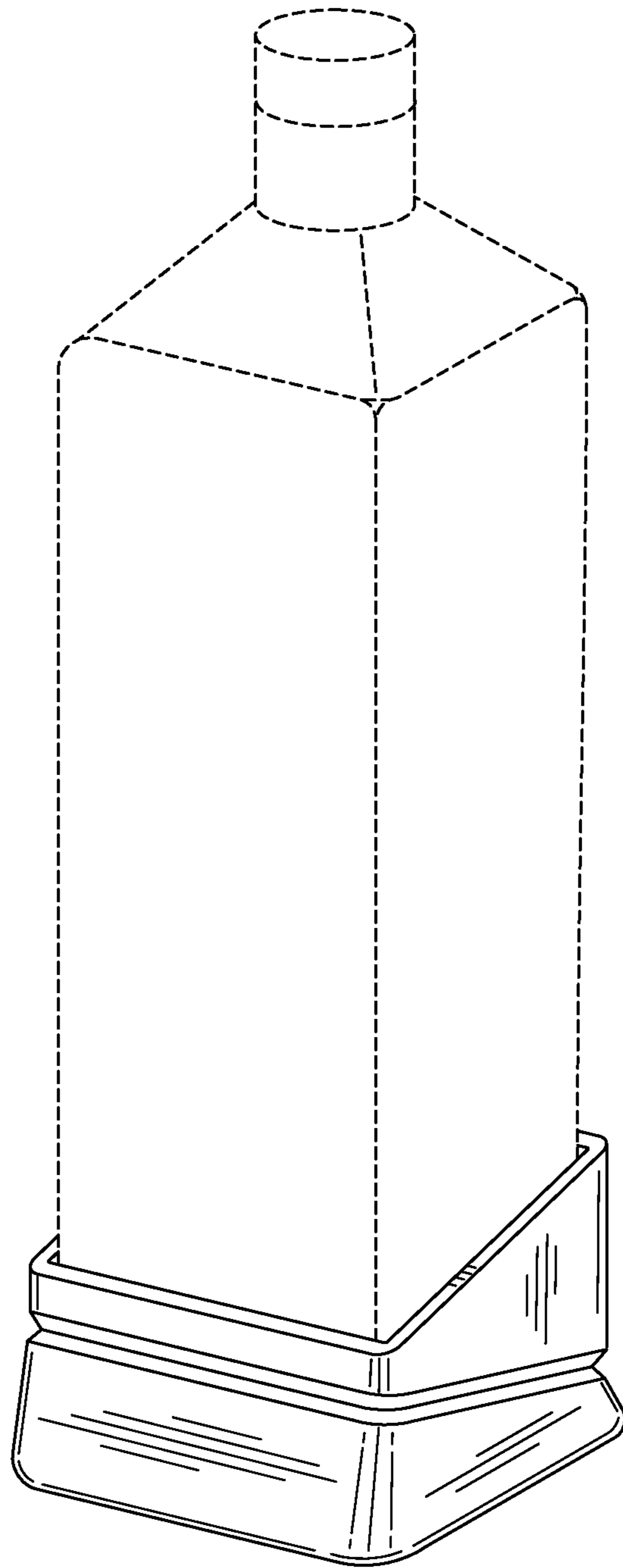

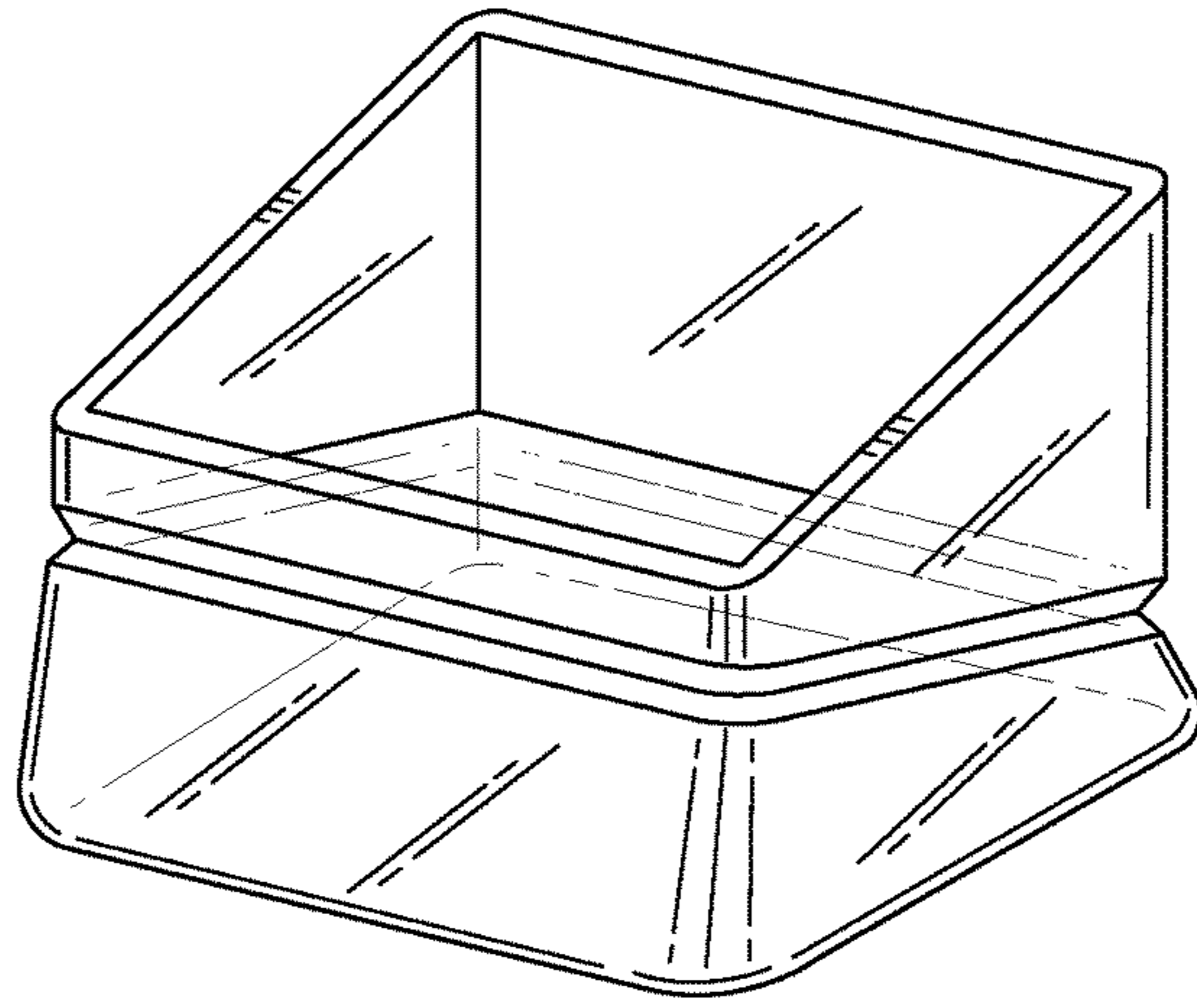

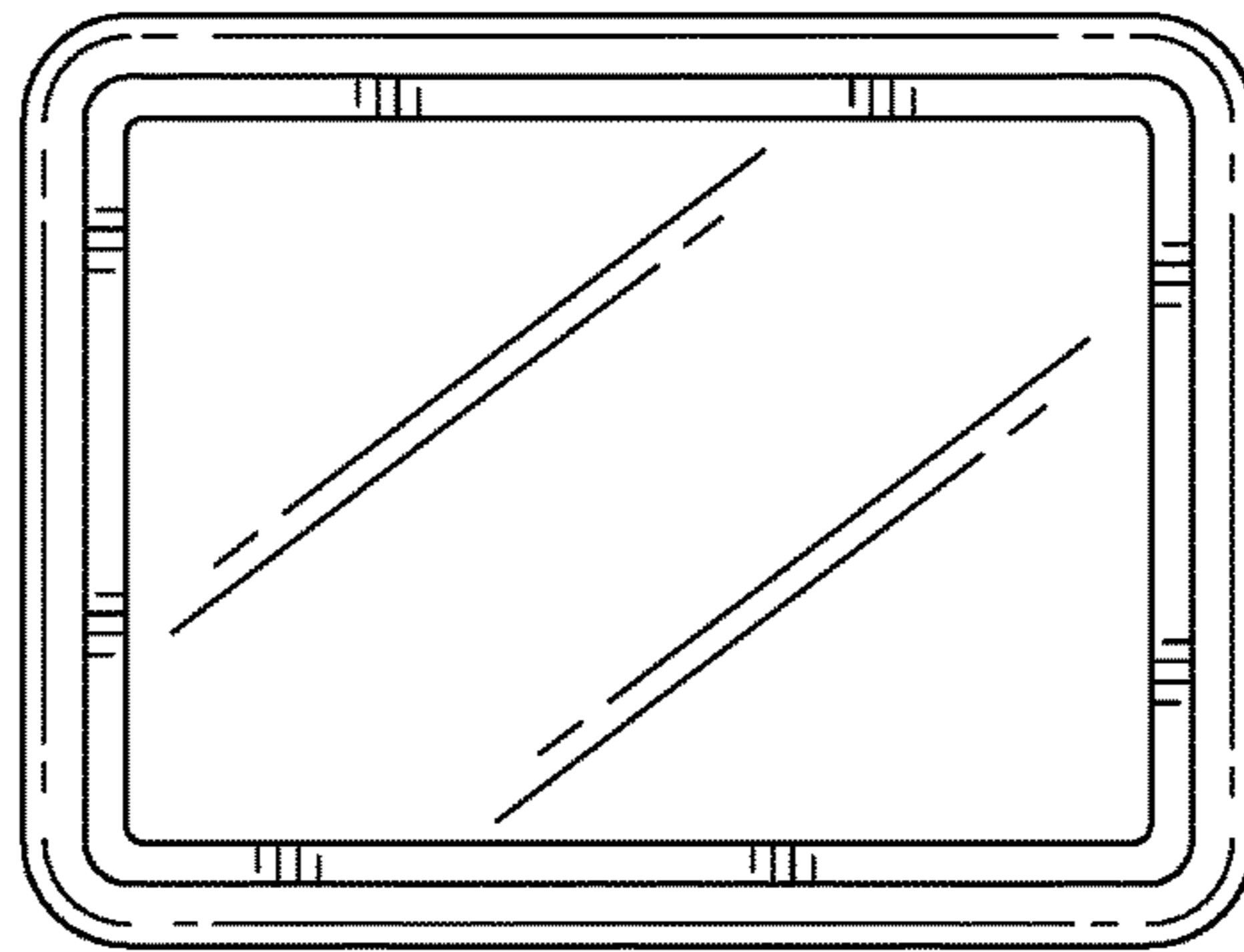

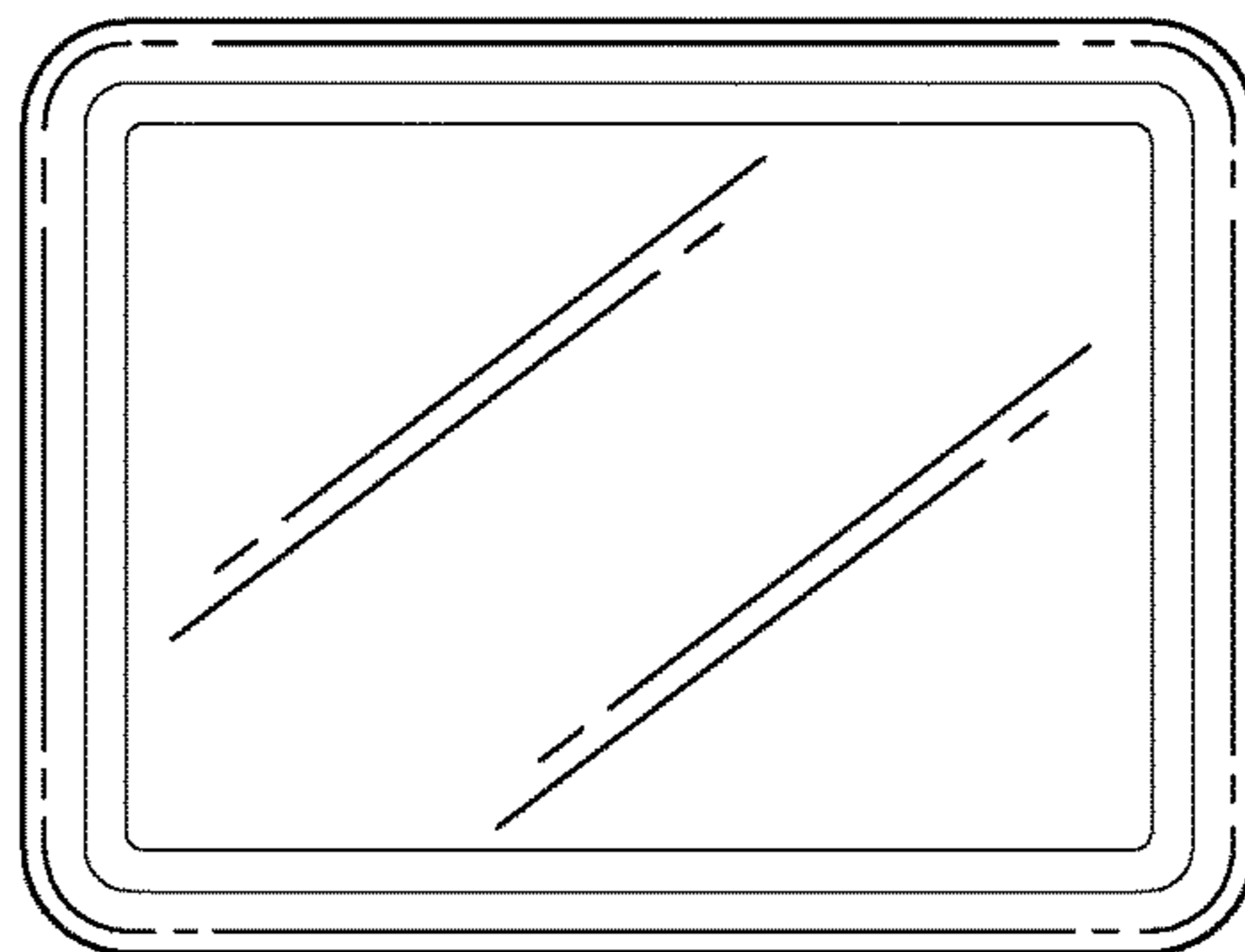

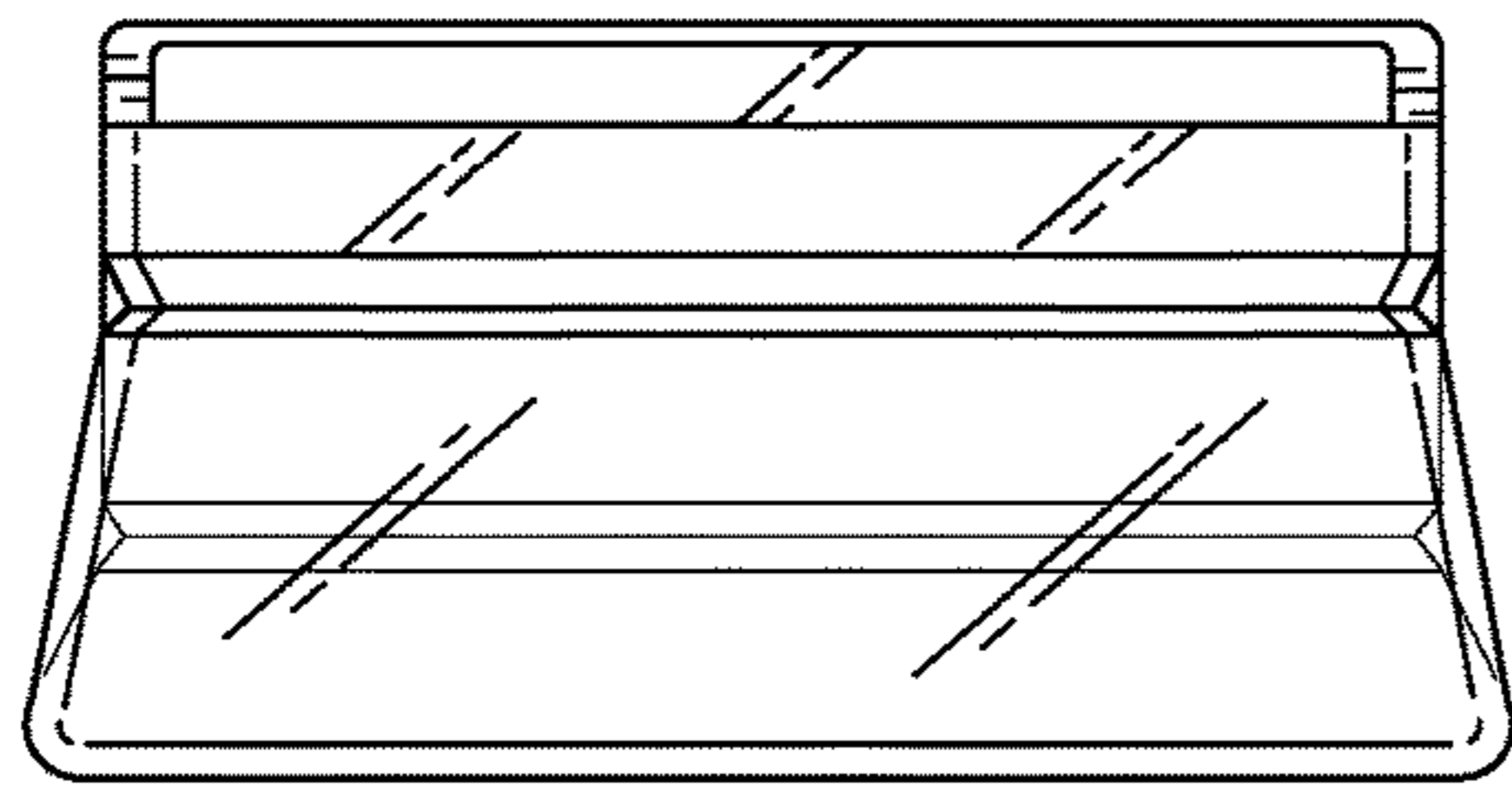

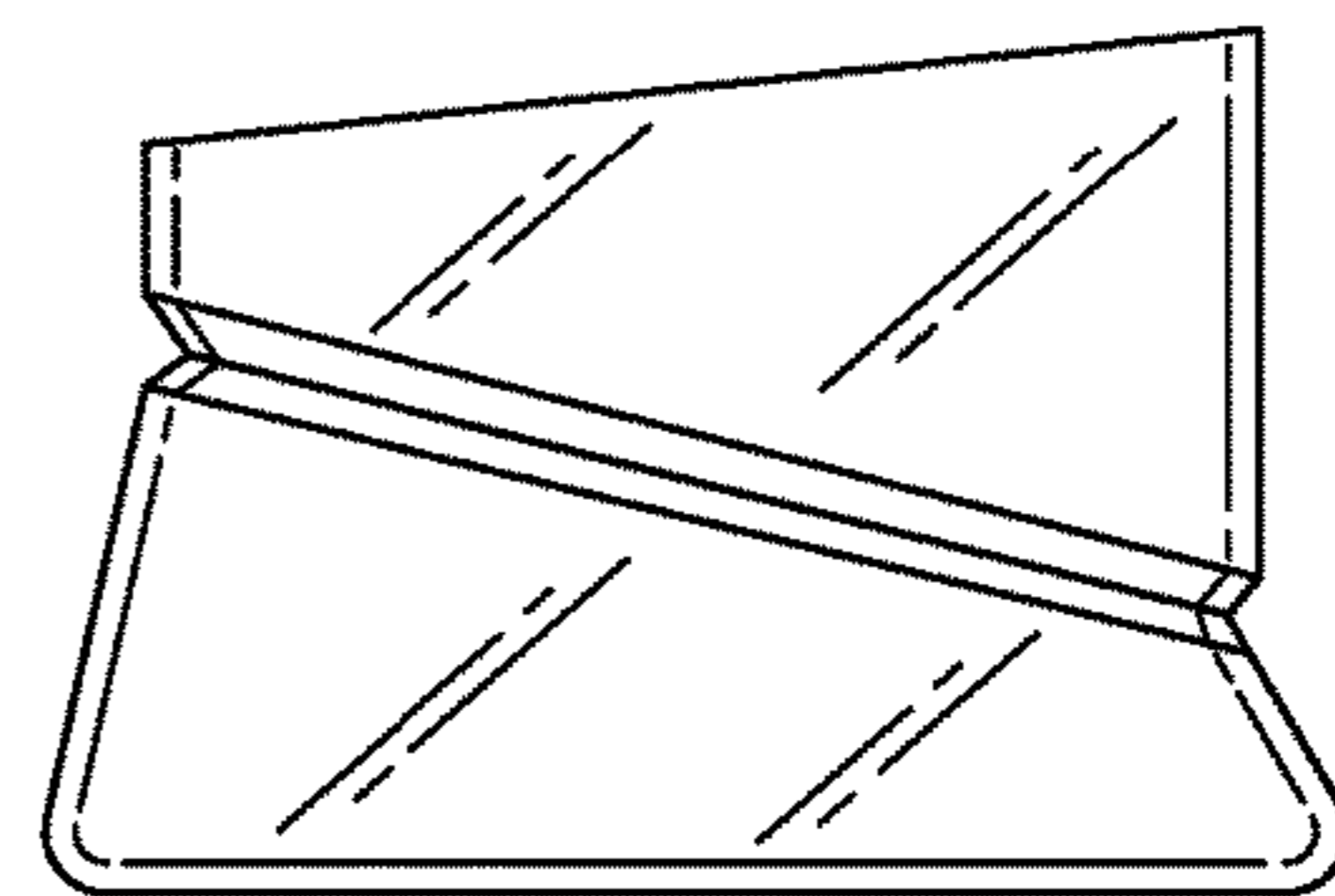

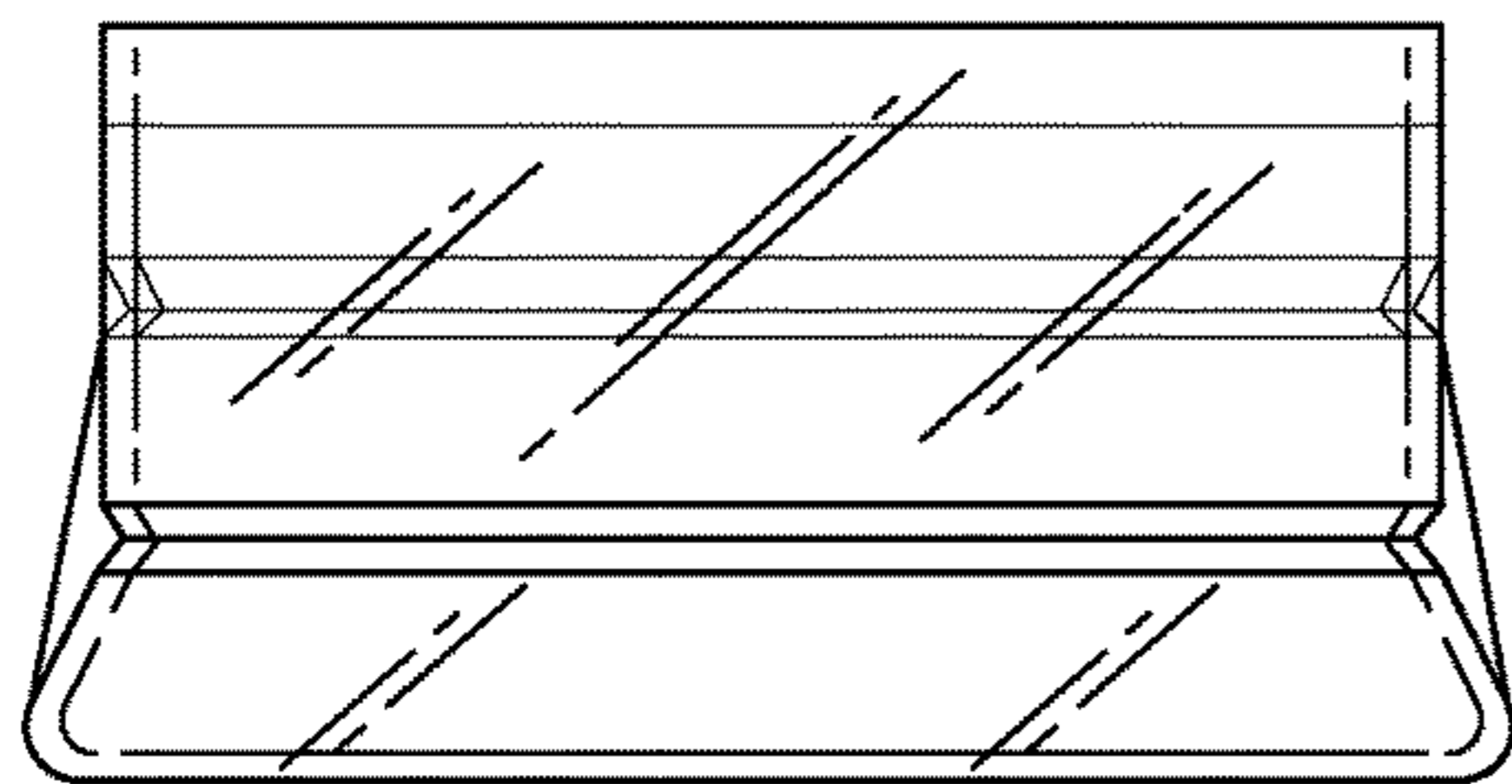

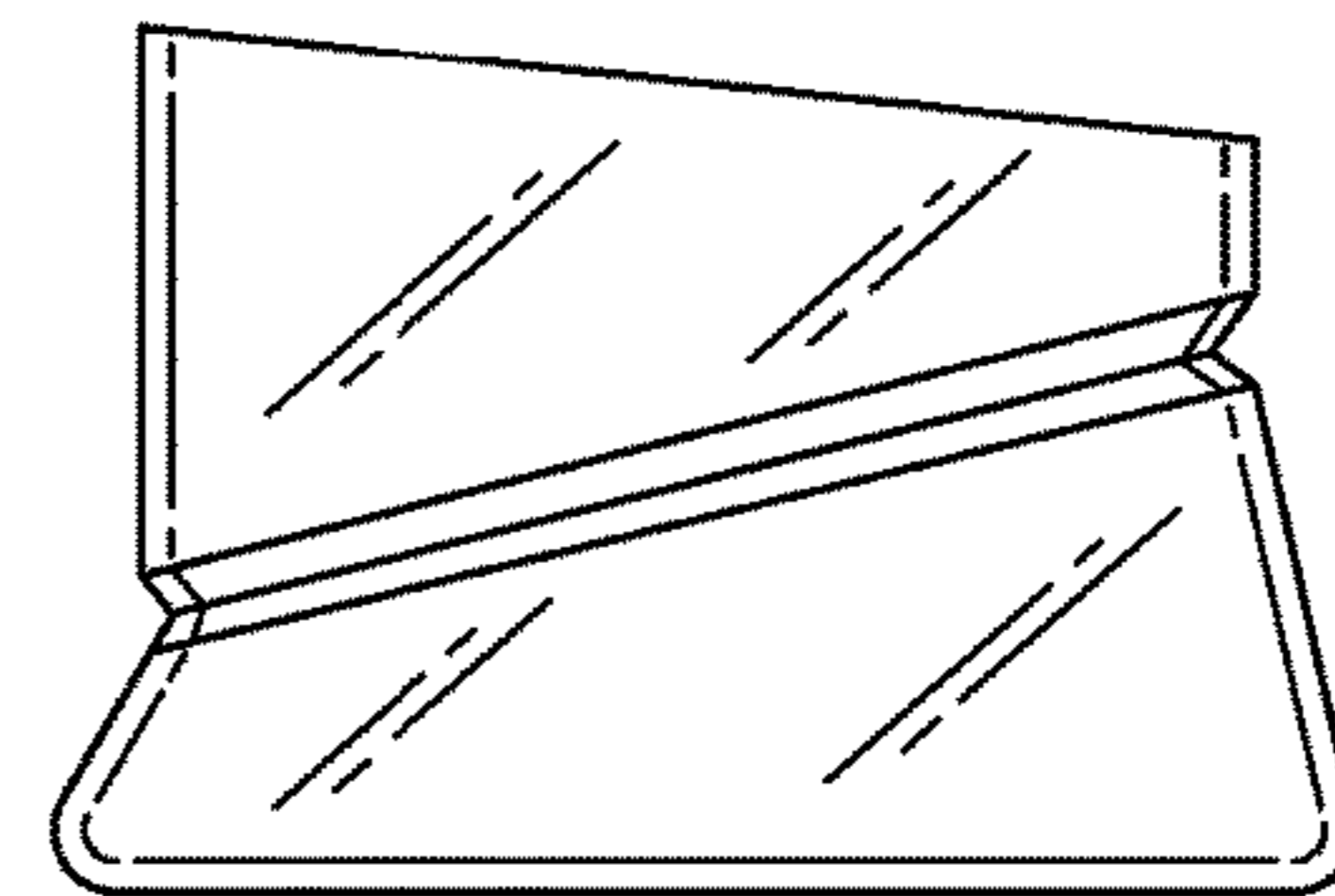

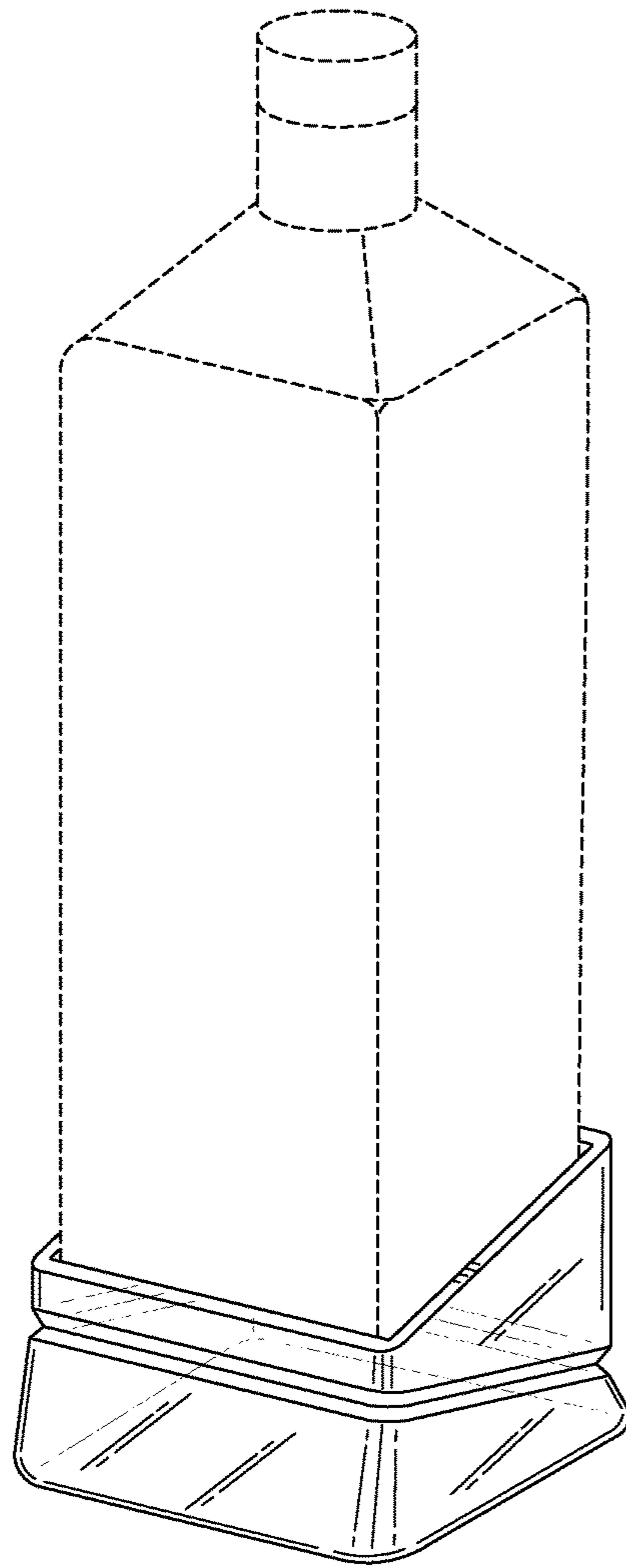
