The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and left perspective view of a bottle showing our new design, with an unclaimed cap on the bottle;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

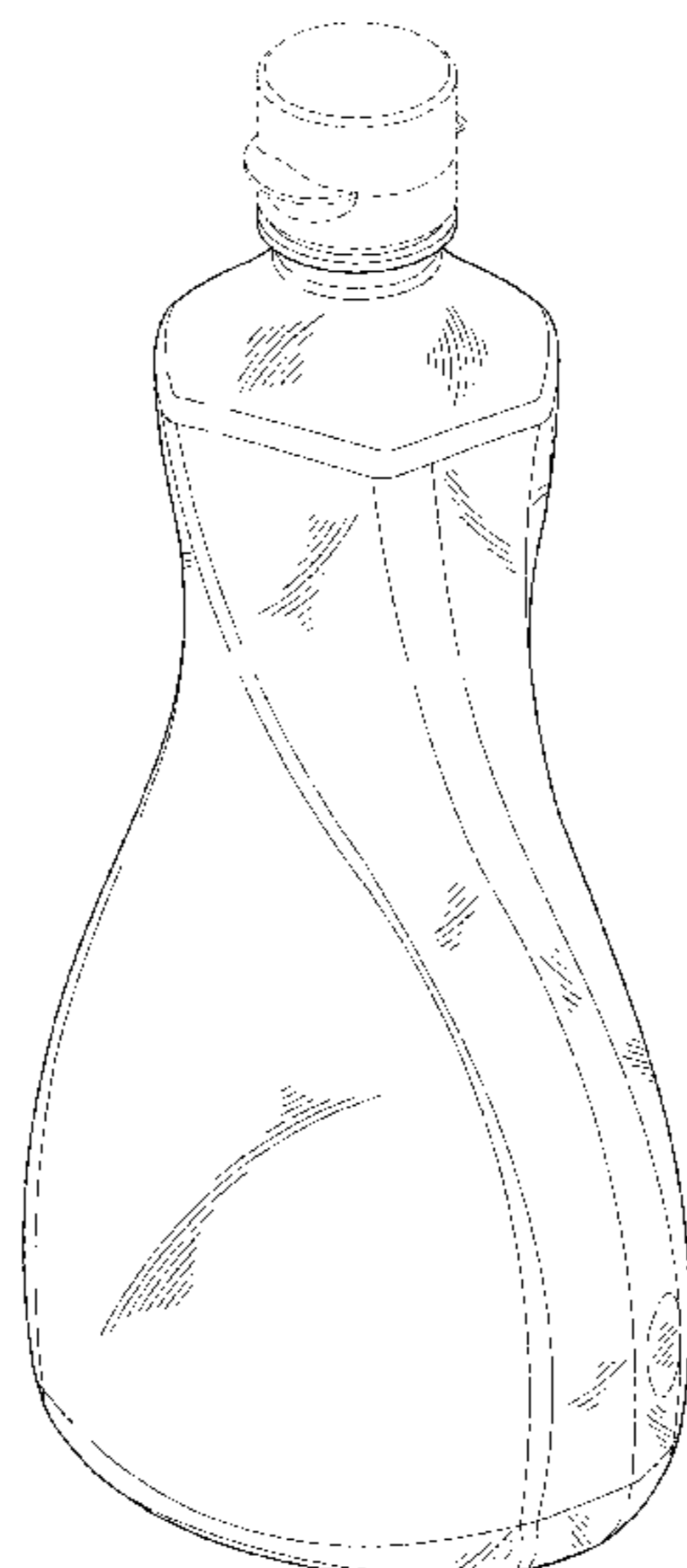
FIG. 5 is a right side view thereof;

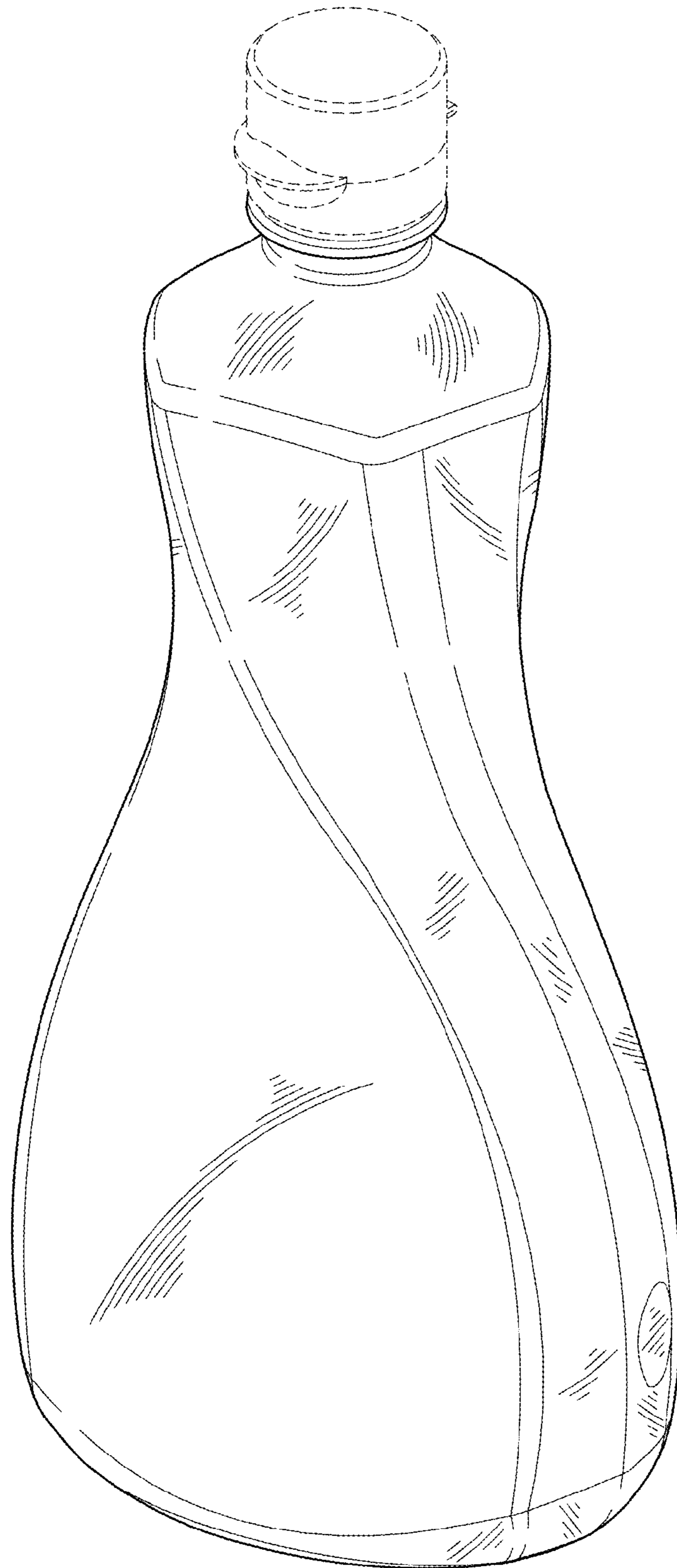

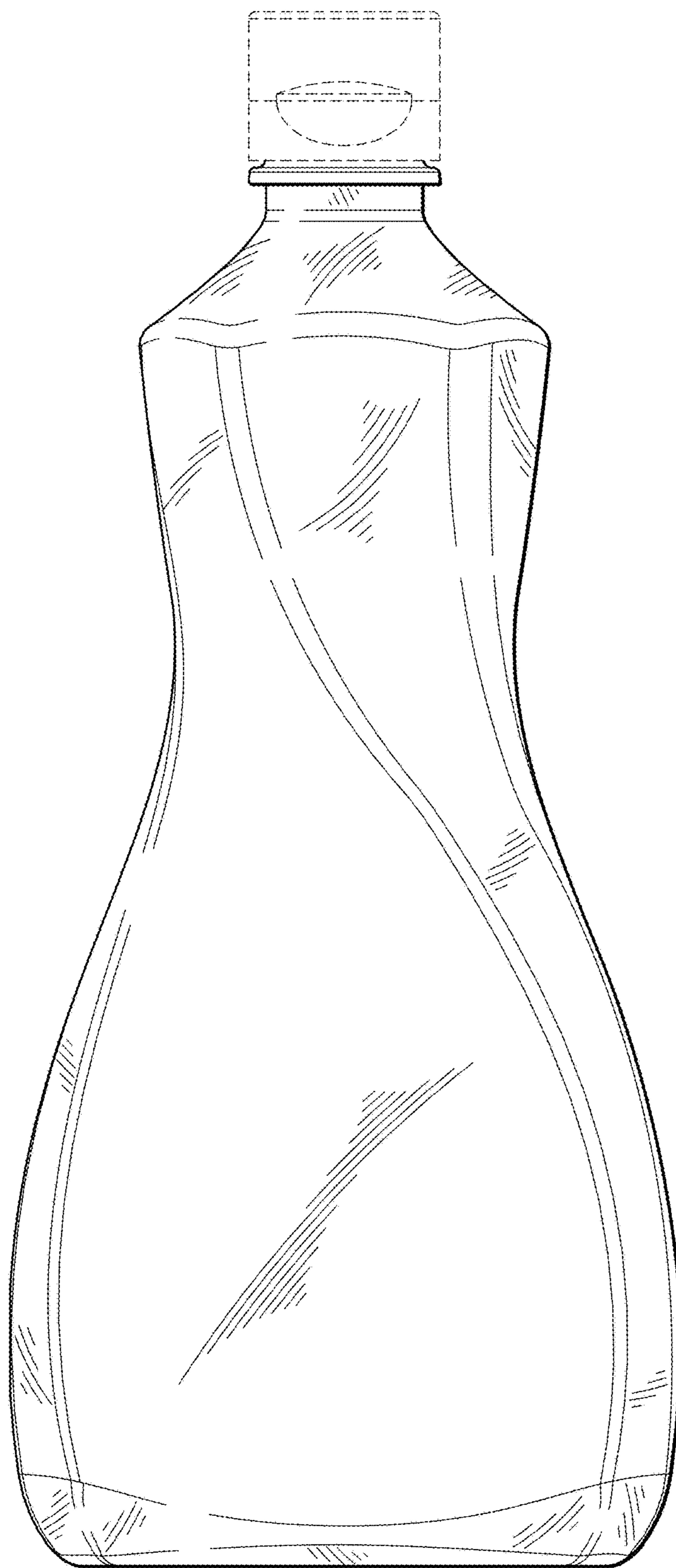

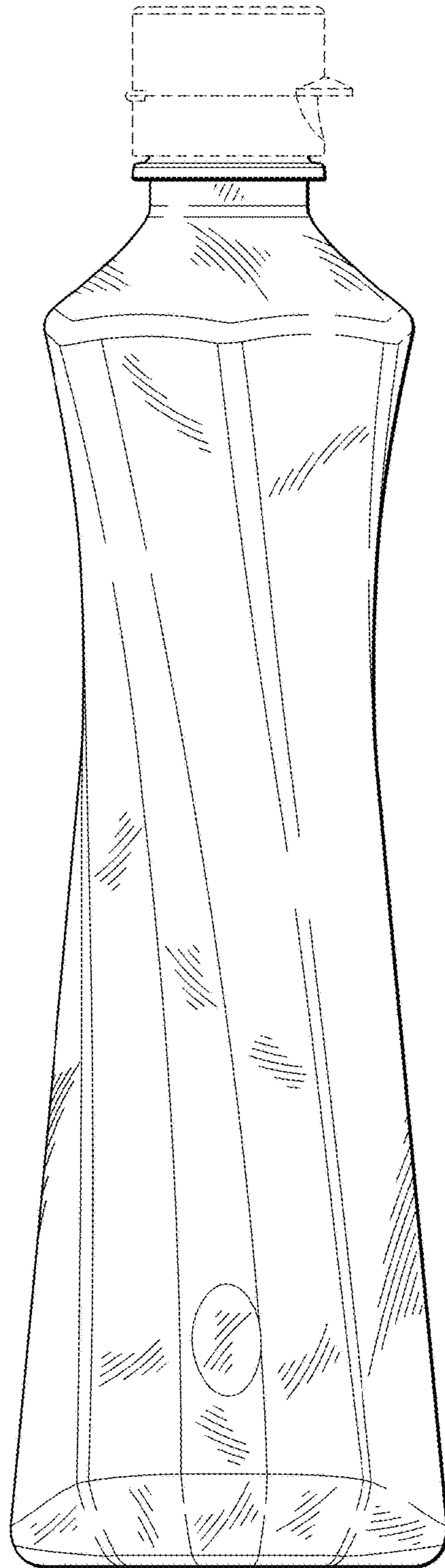

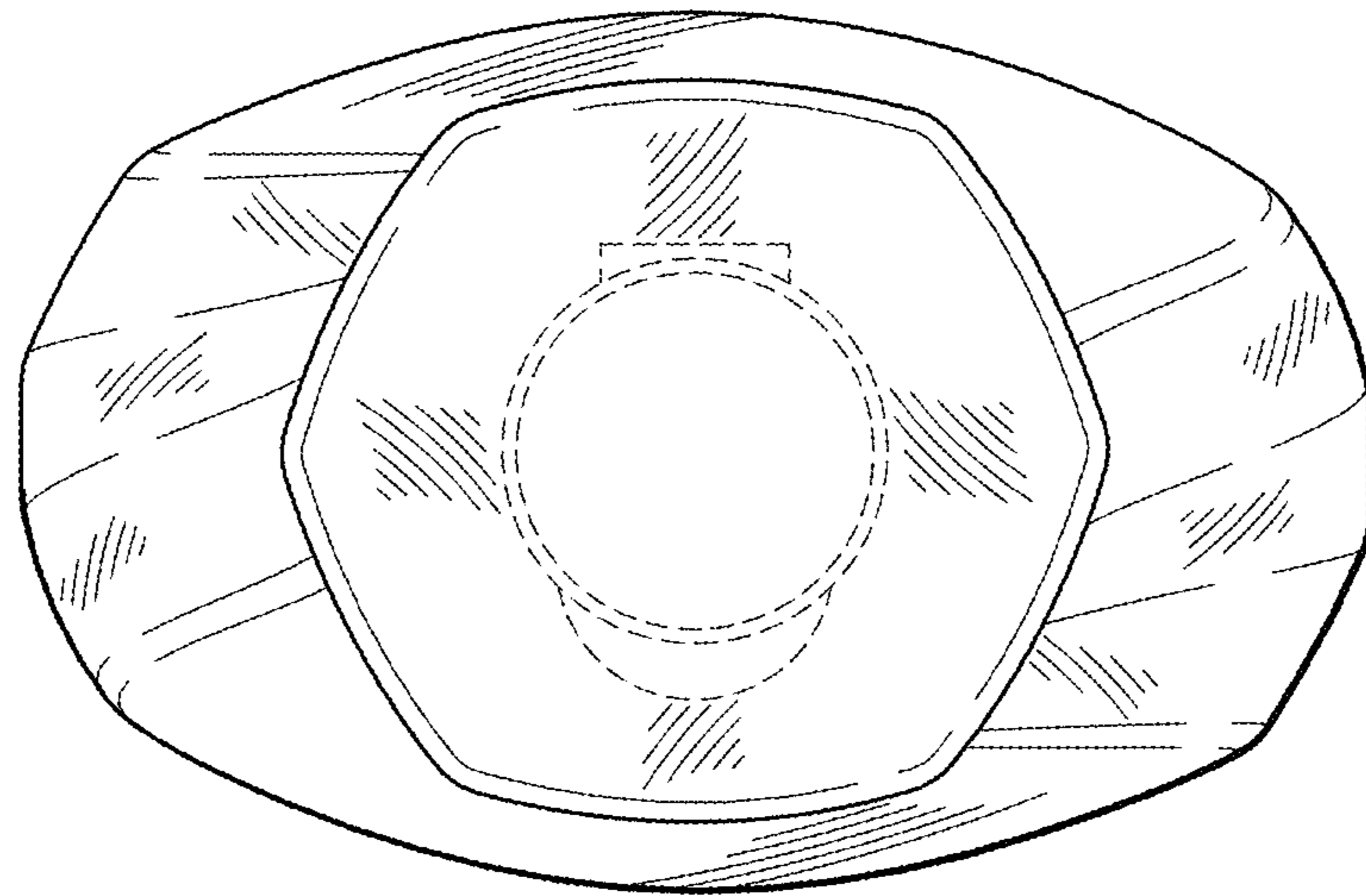

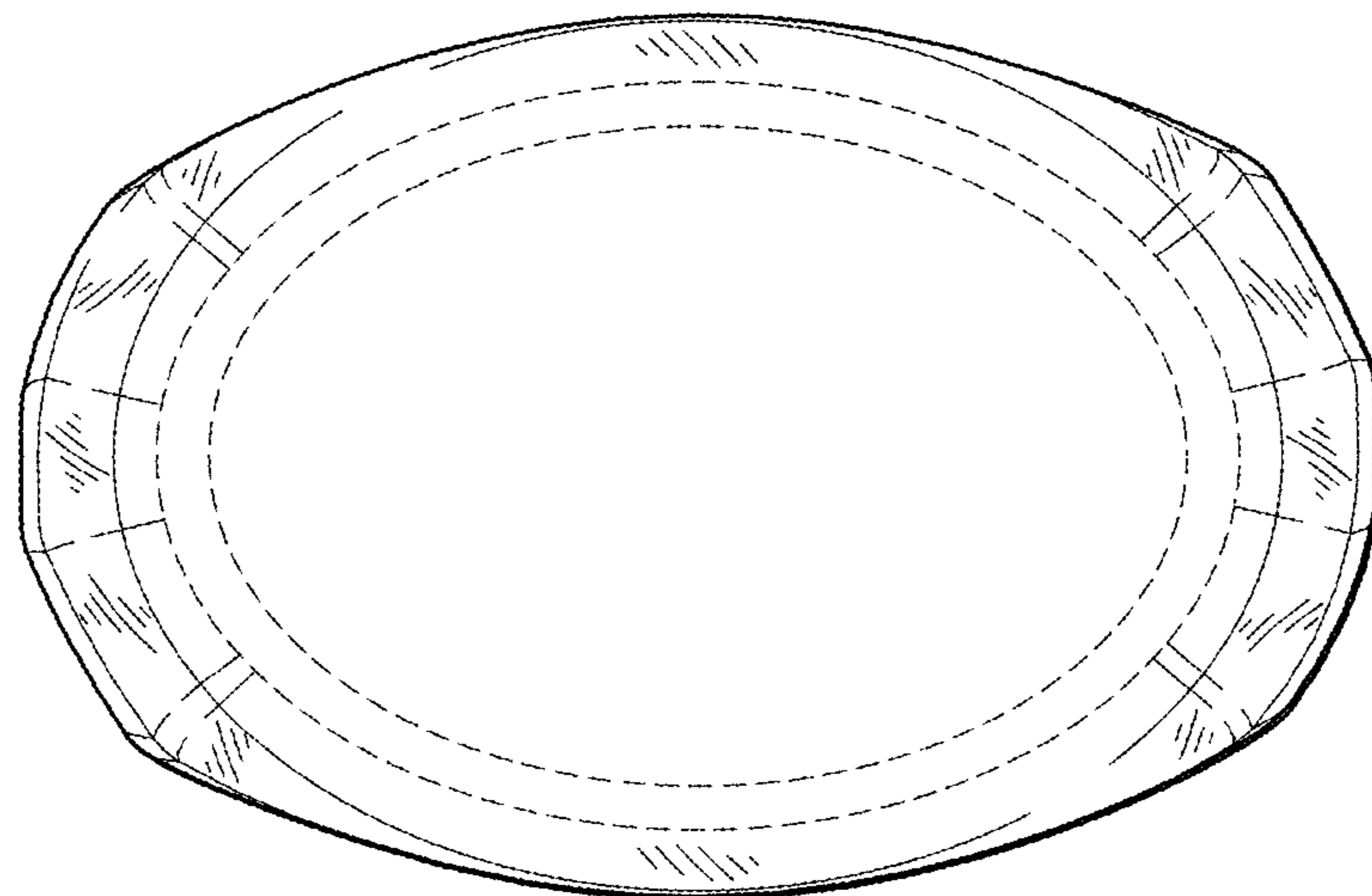
