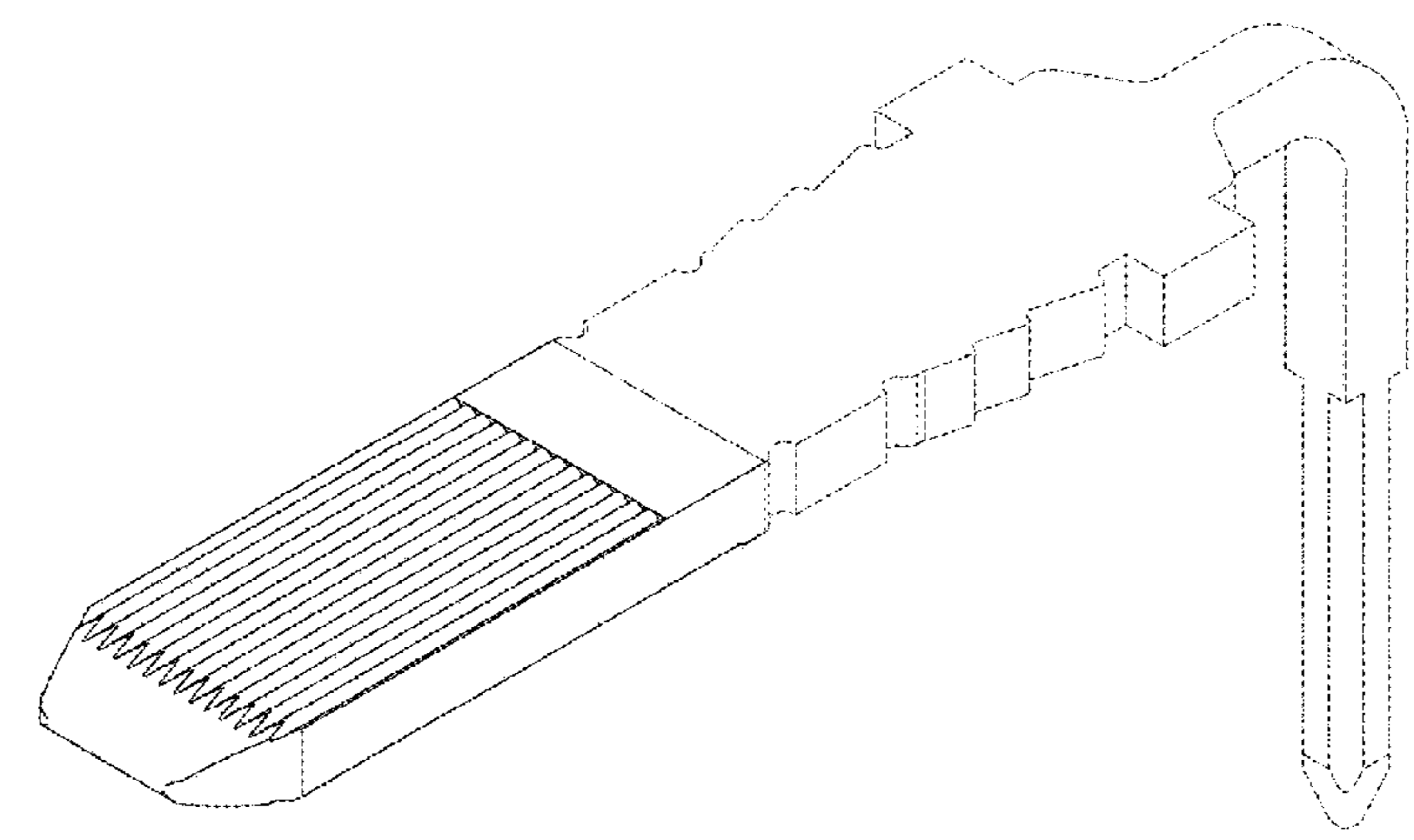

 The ornamental design for a terminal metal fitting, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a terminal metal fitting showing our new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a left side elevation view thereof;
 FIG. 7 is a right side elevation view thereof; and,
 FIG. 8 is an enlarged cross-sectional view thereof, taken along line 8-8 of FIG. 4.
 The broken lines shown represent unclaimed subject matter only and form no part of the claimed design. The dot-dash broken lines represent an unclaimed boundary between claimed and unclaimed surfaces. None of the broken lines form any part of the claimed design.

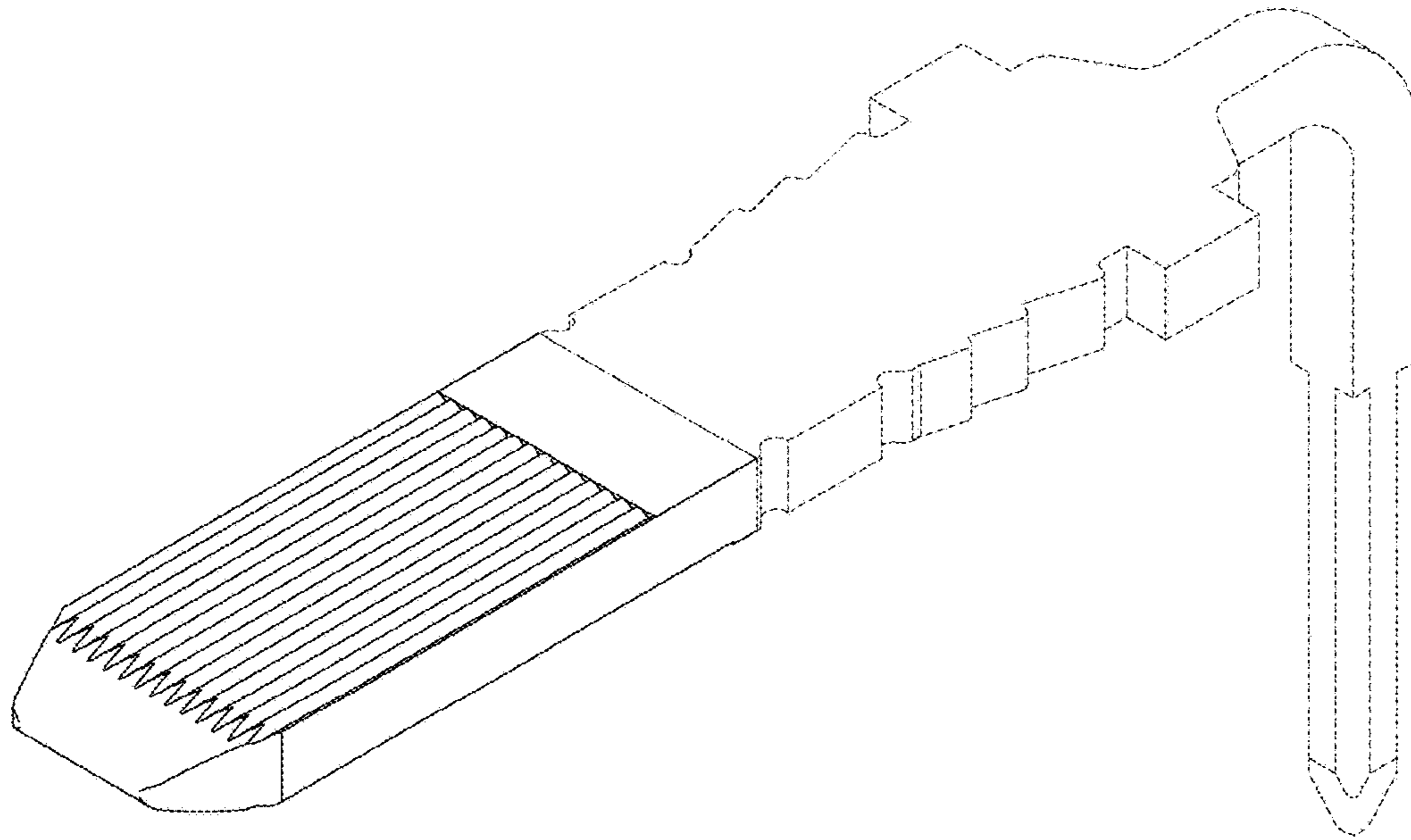

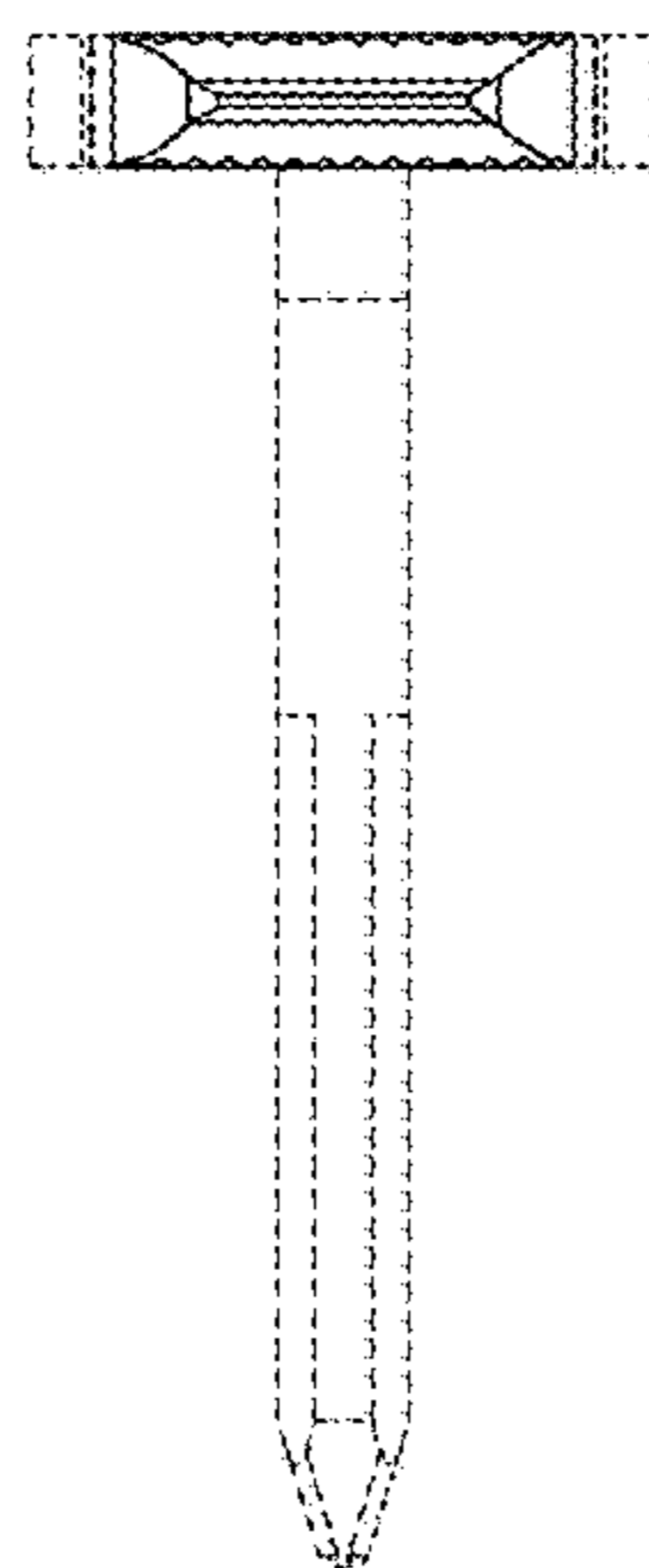

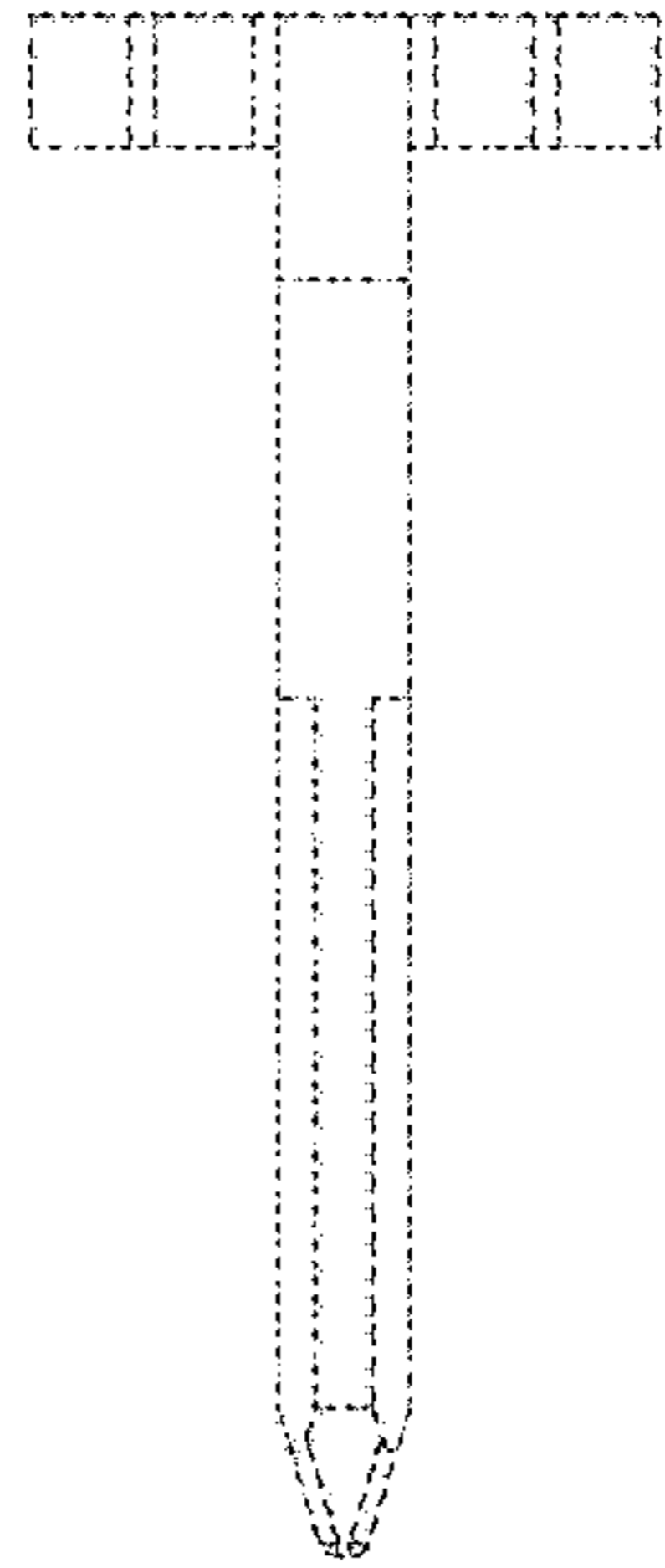

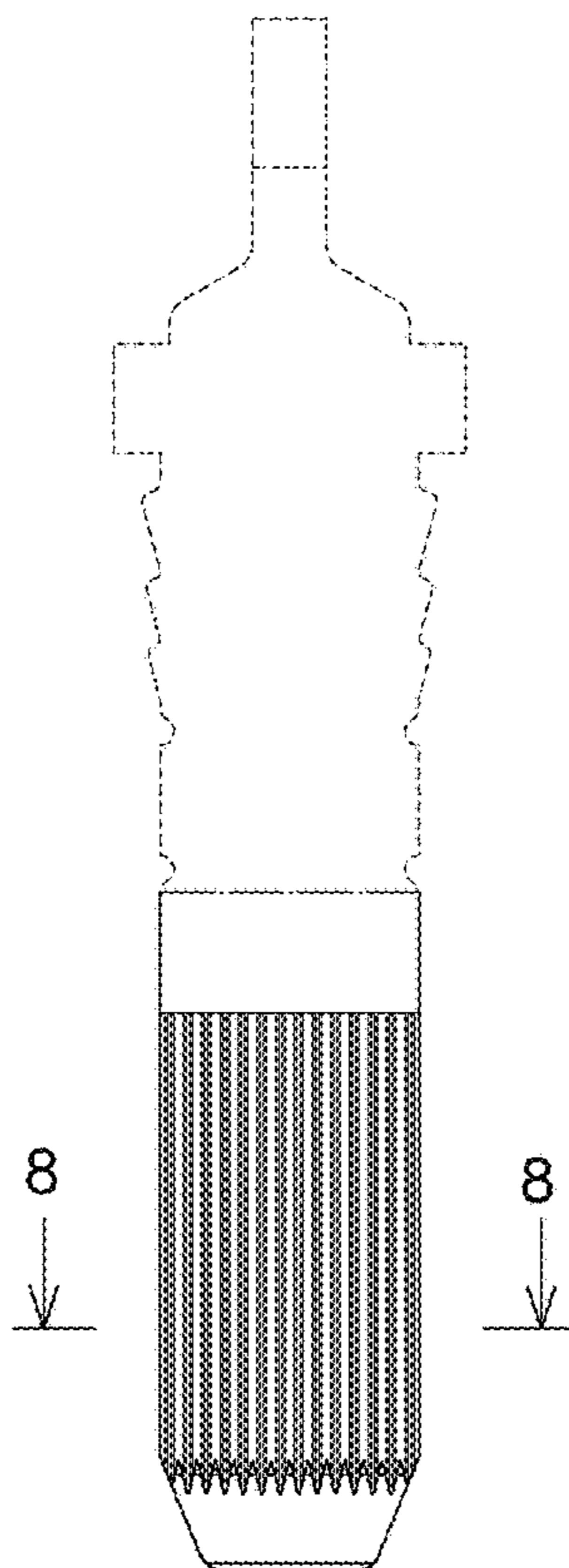

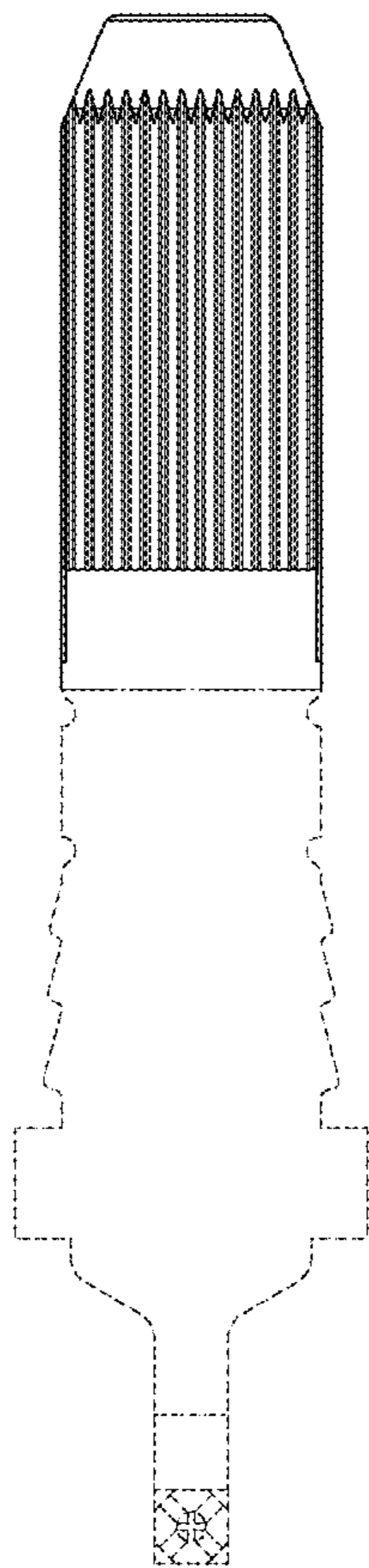

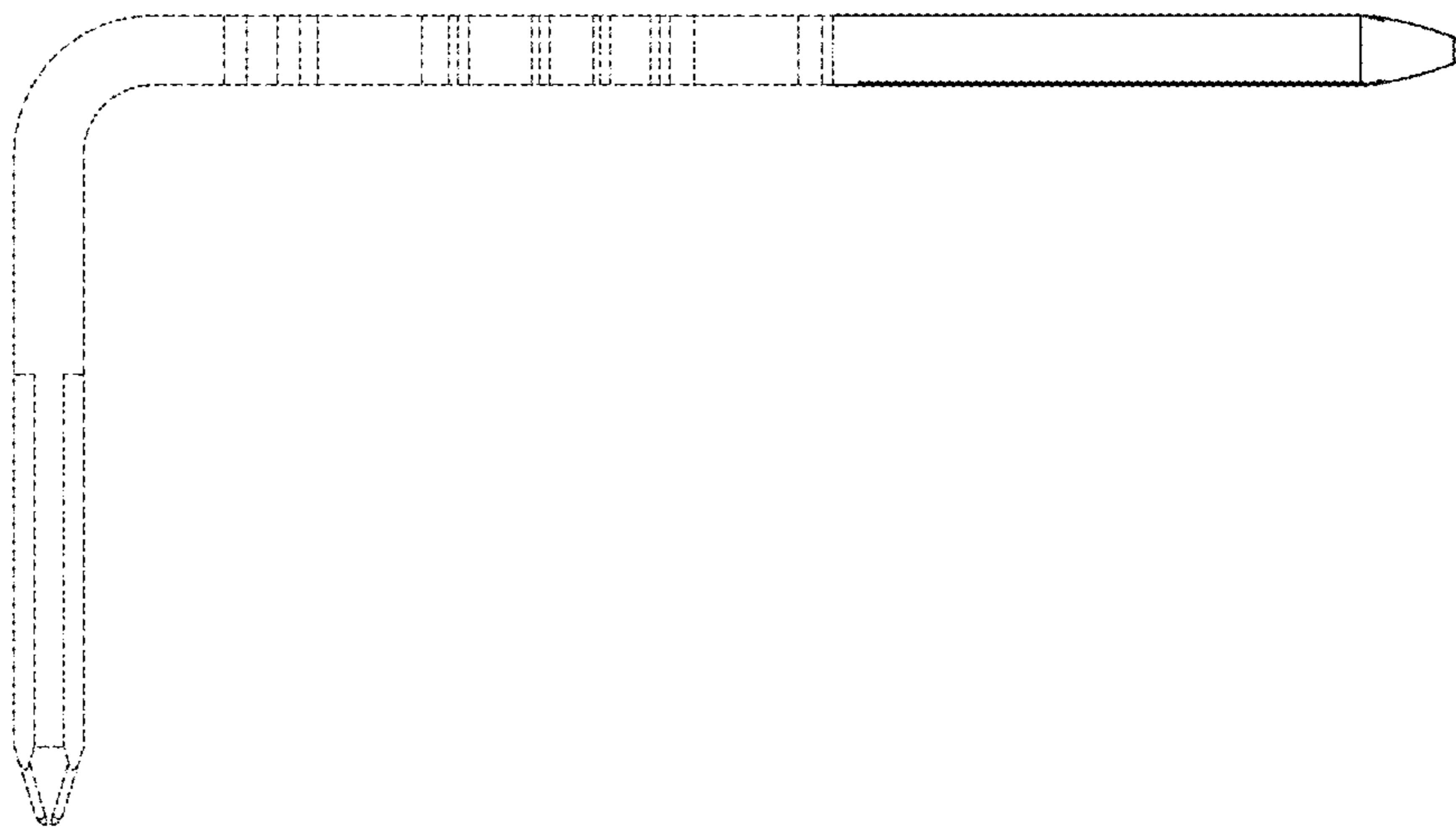

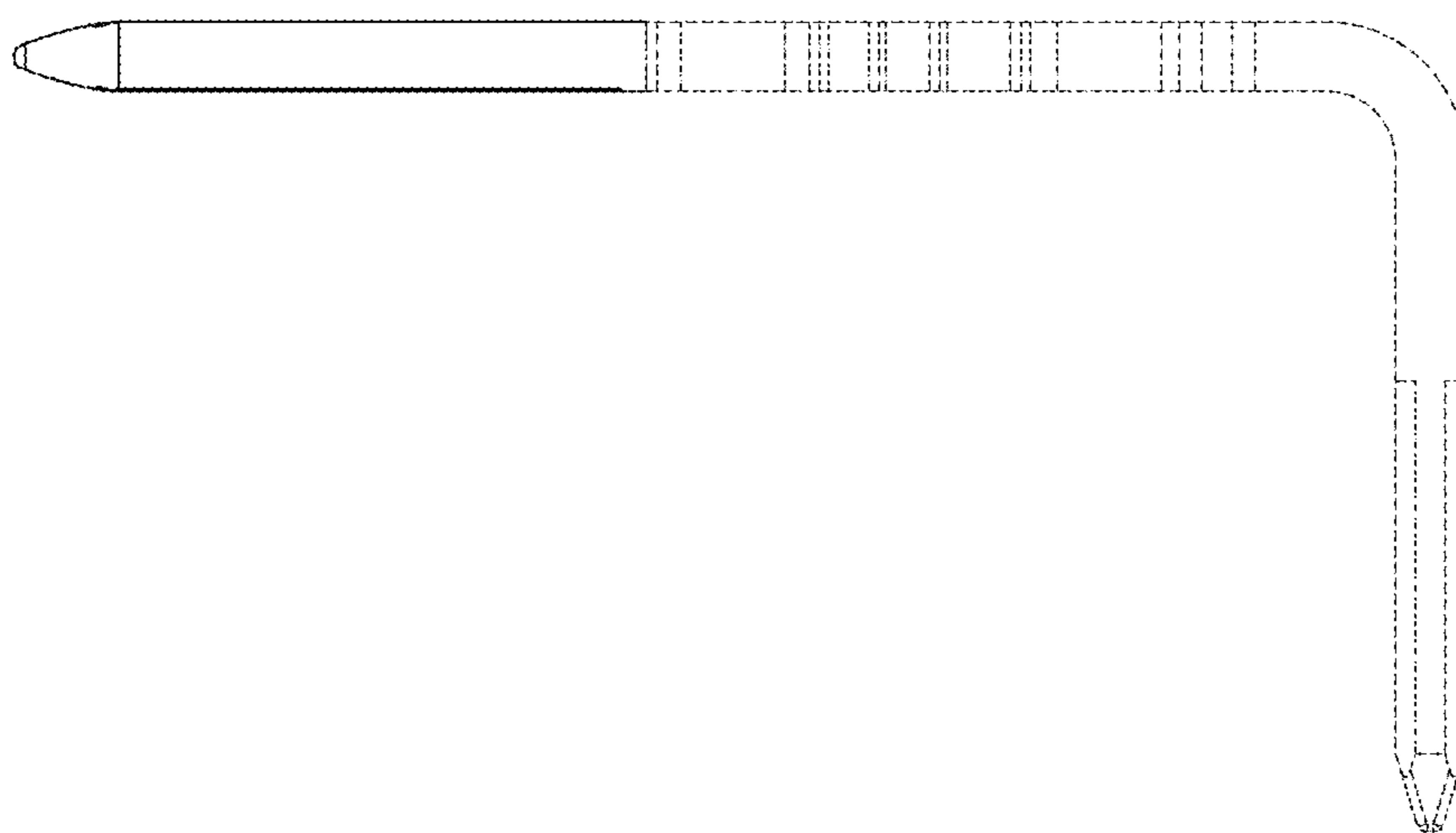
