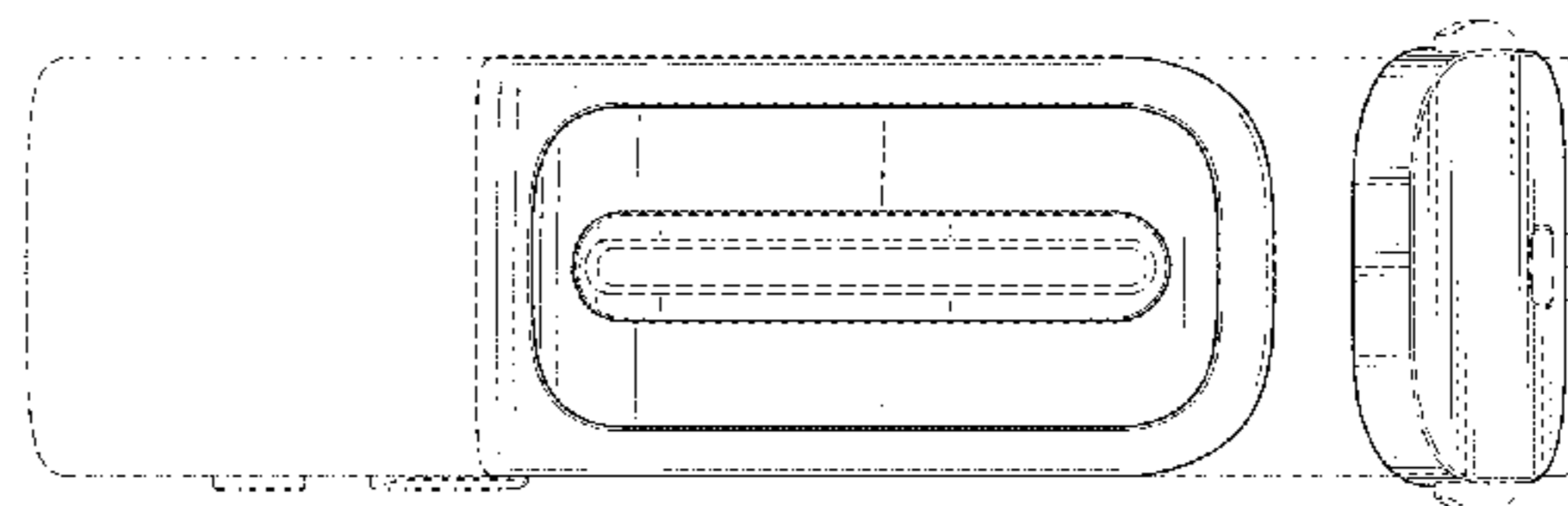
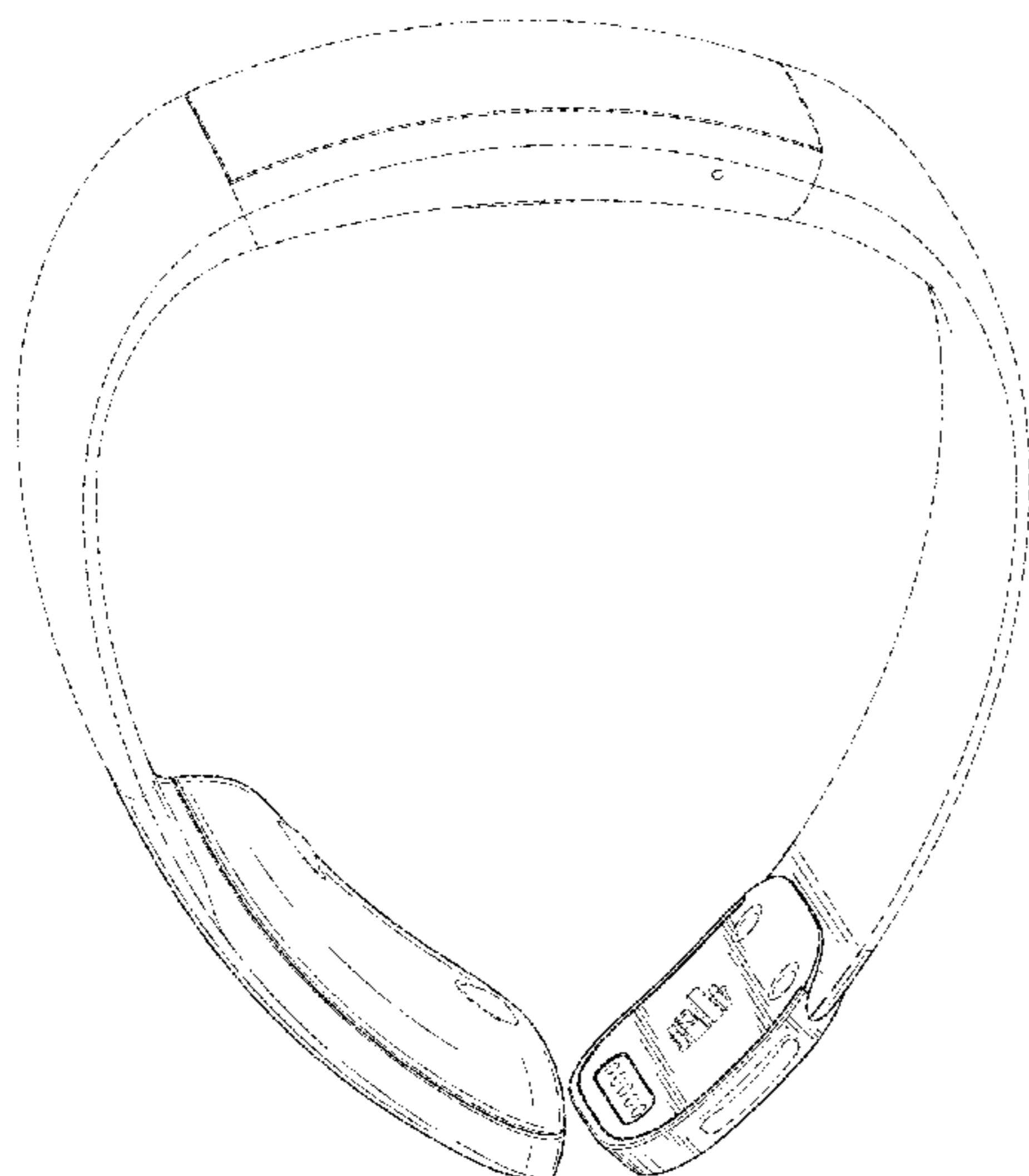

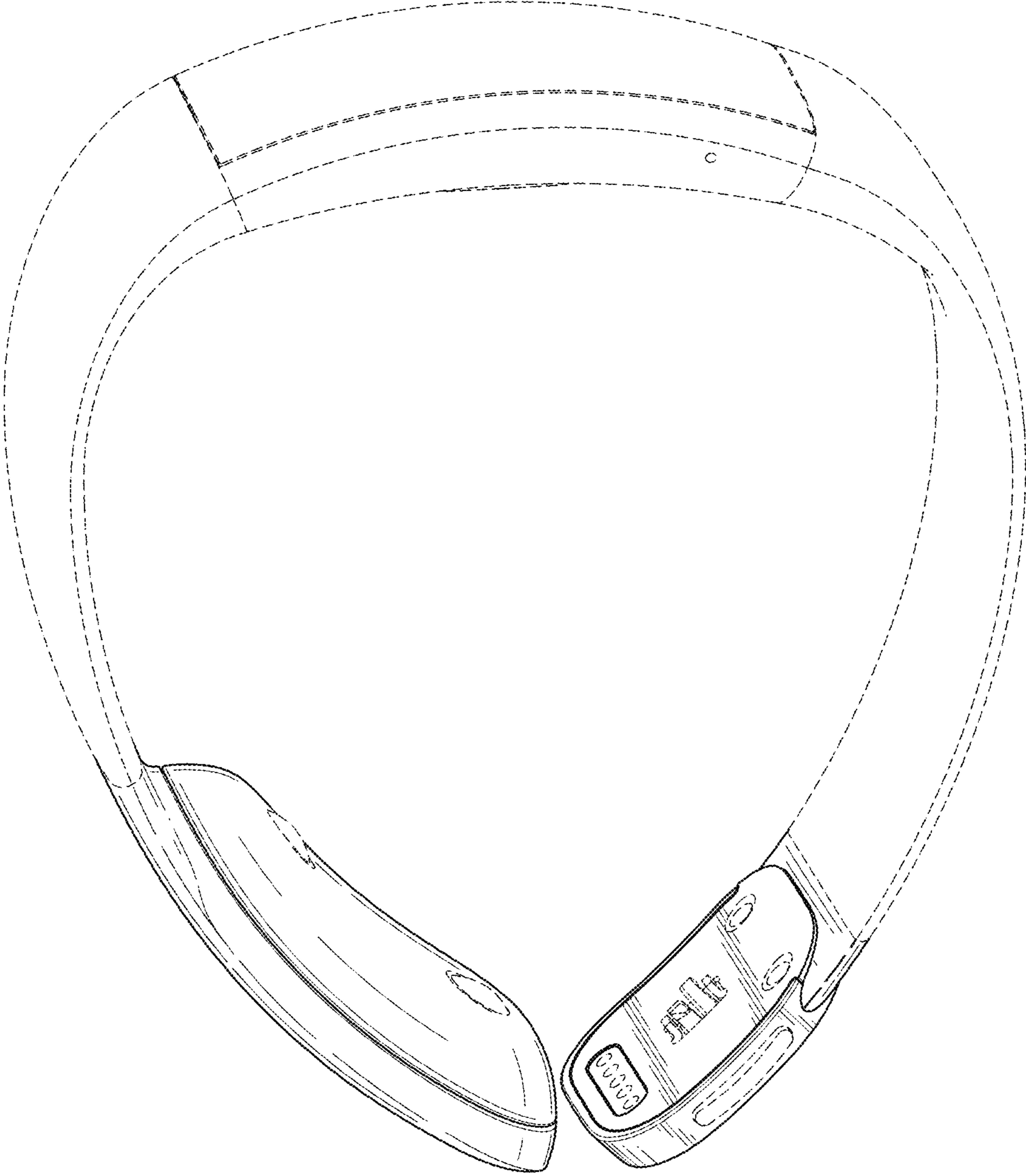
The ornamental design for a wearable electronic device, as shown and described.

**DESCRIPTION**

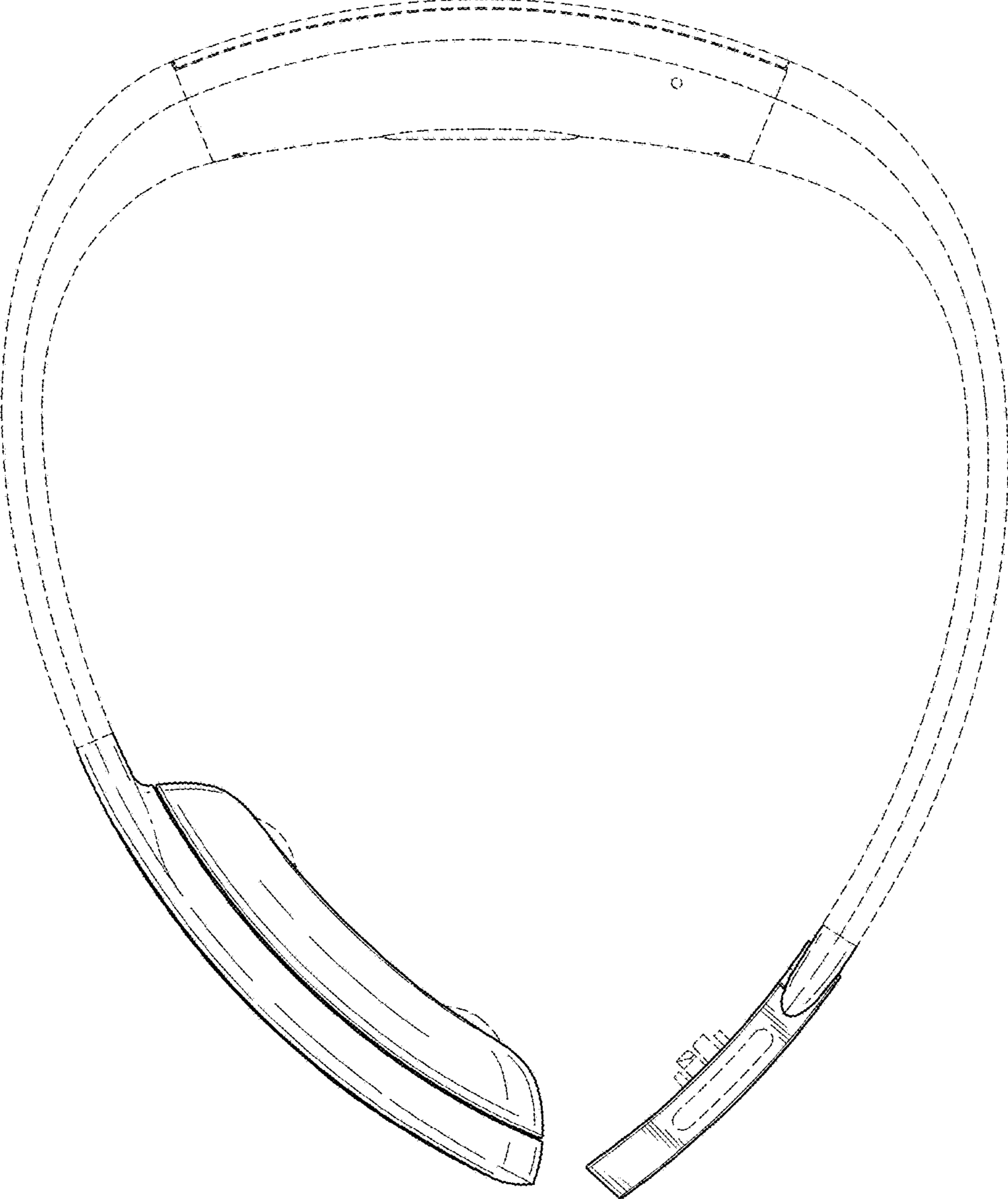

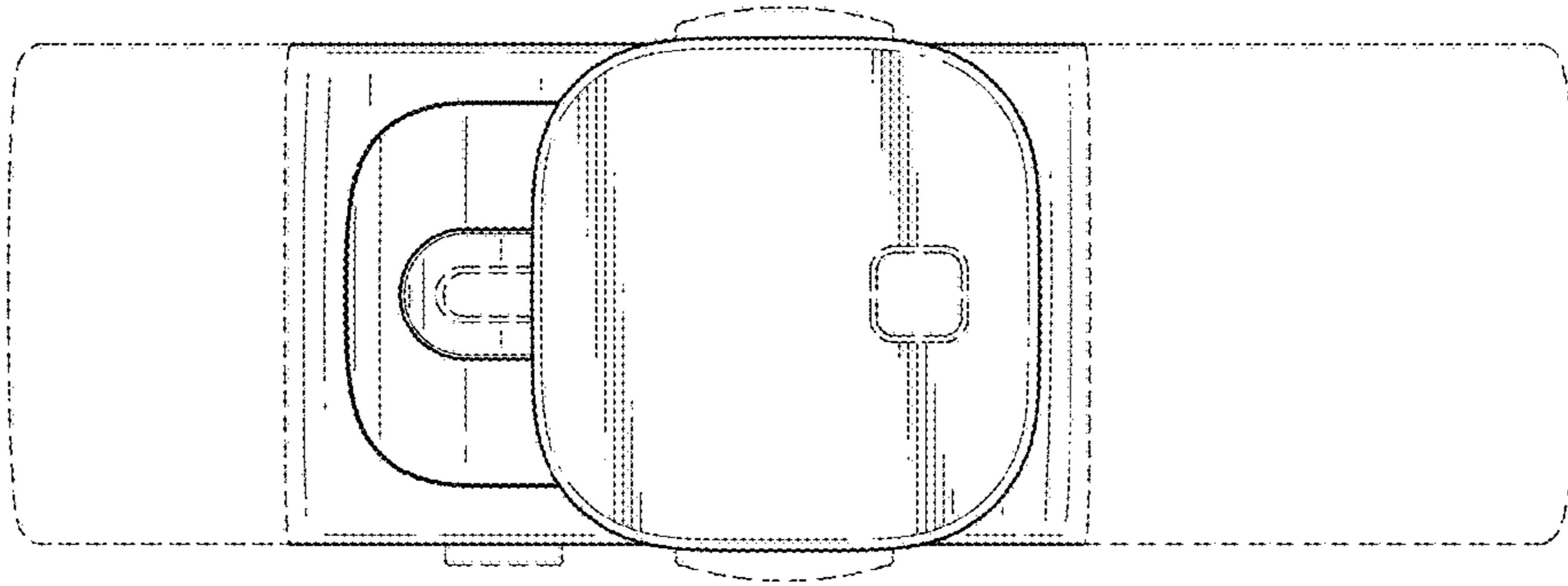




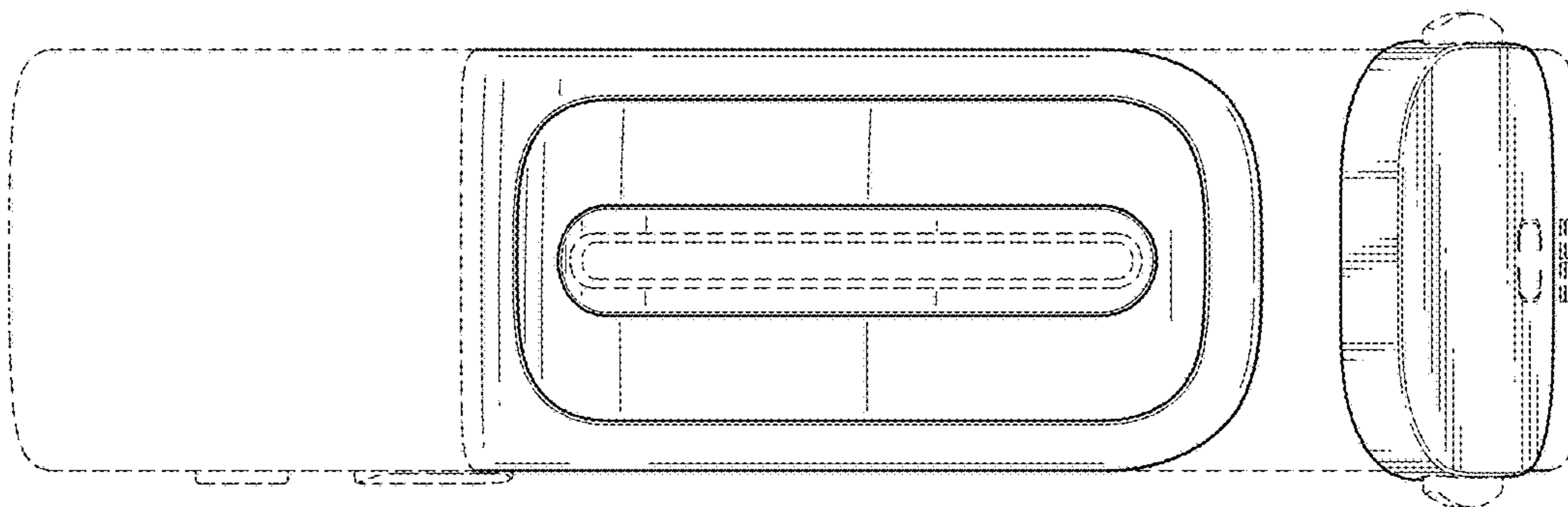

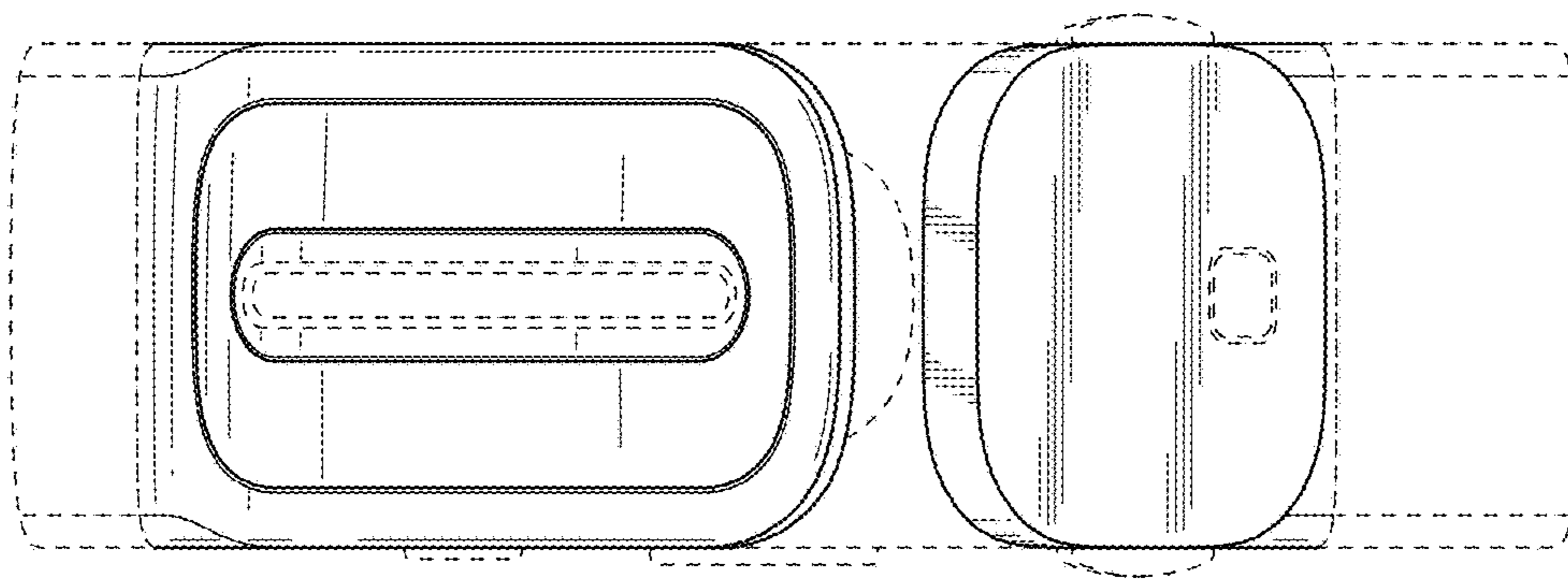
