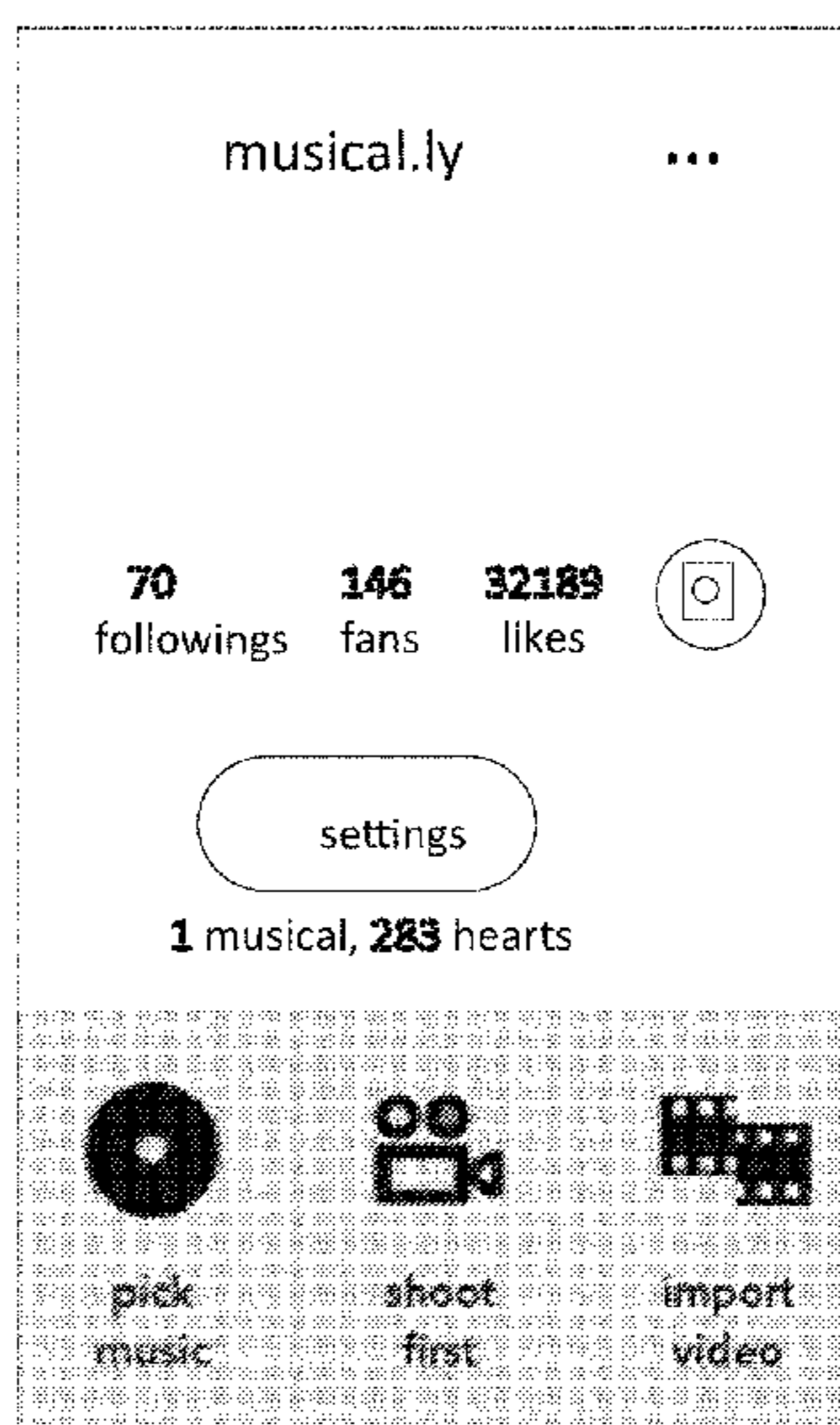
The ornamental design for display screen with a graphical user interface for a sound added video making and sharing app, as shown and described.
